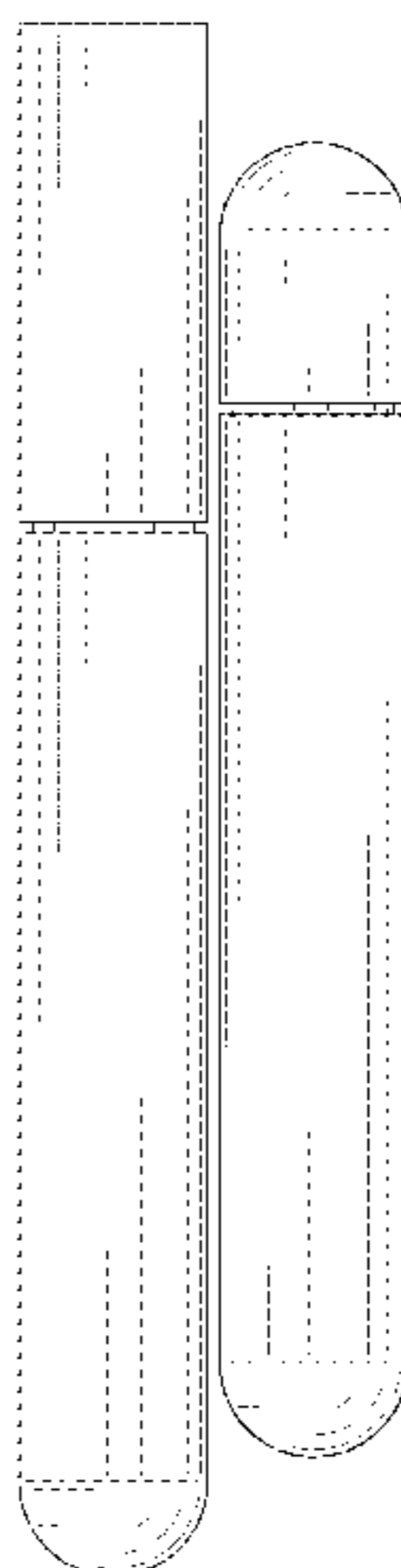

(57) CLAIM

The ornamental design for an tube with closure, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an tube with closure in a closed condition in accordance with the present teachings. FIG. 2 is a bottom perspective view of the tube with closure of FIG. 1.

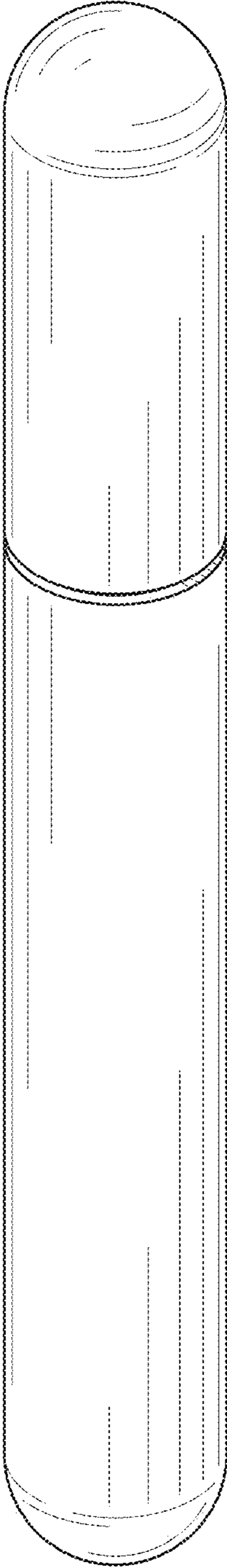

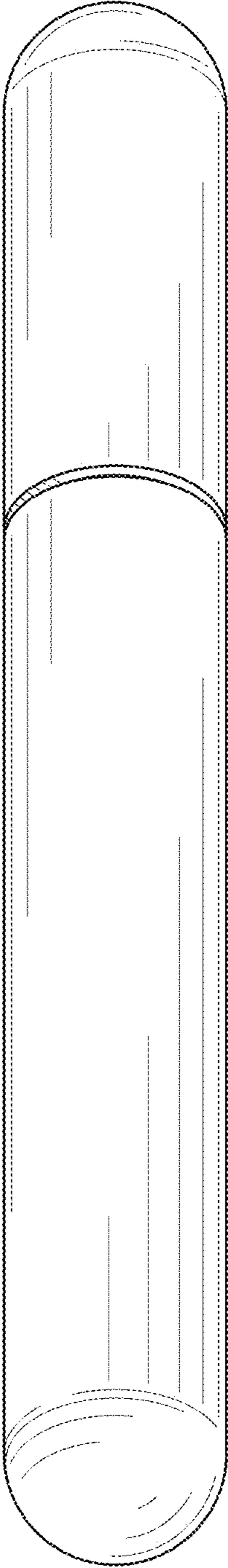

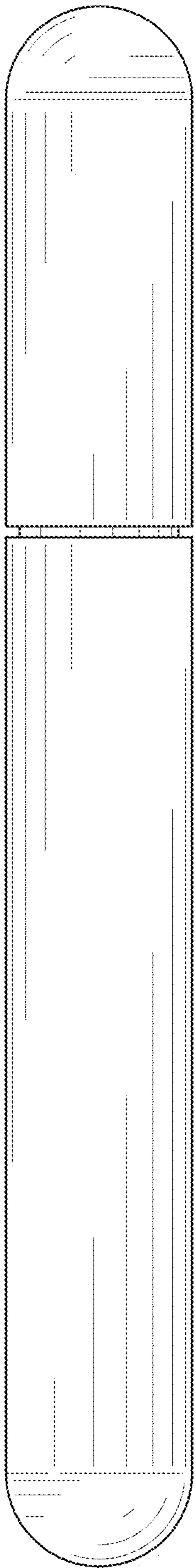

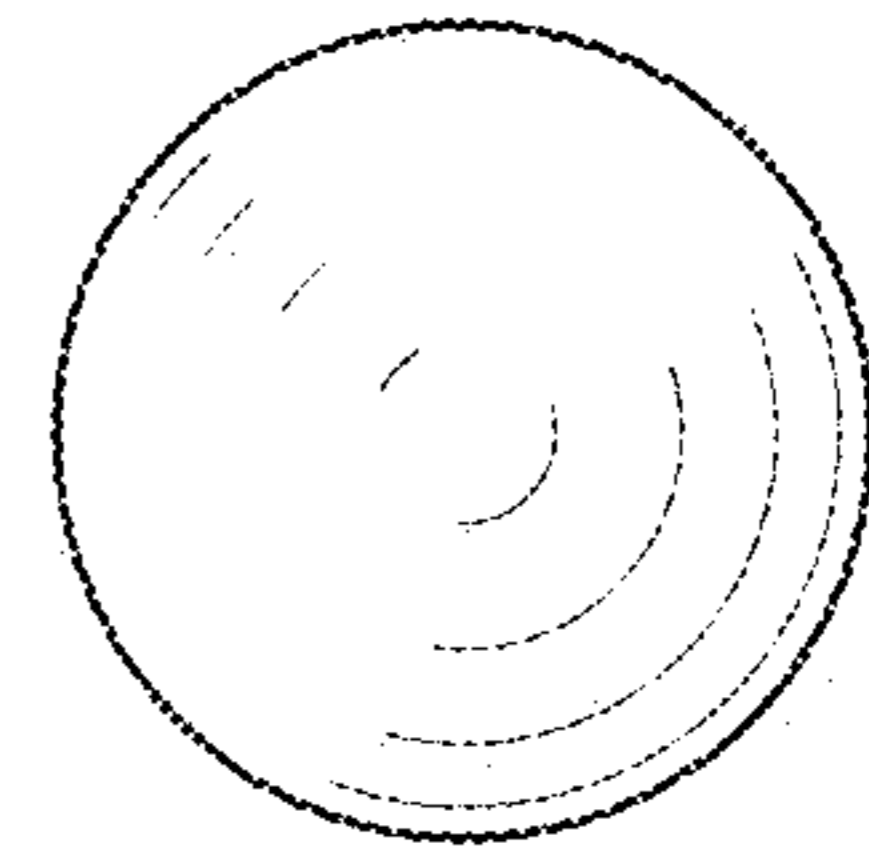

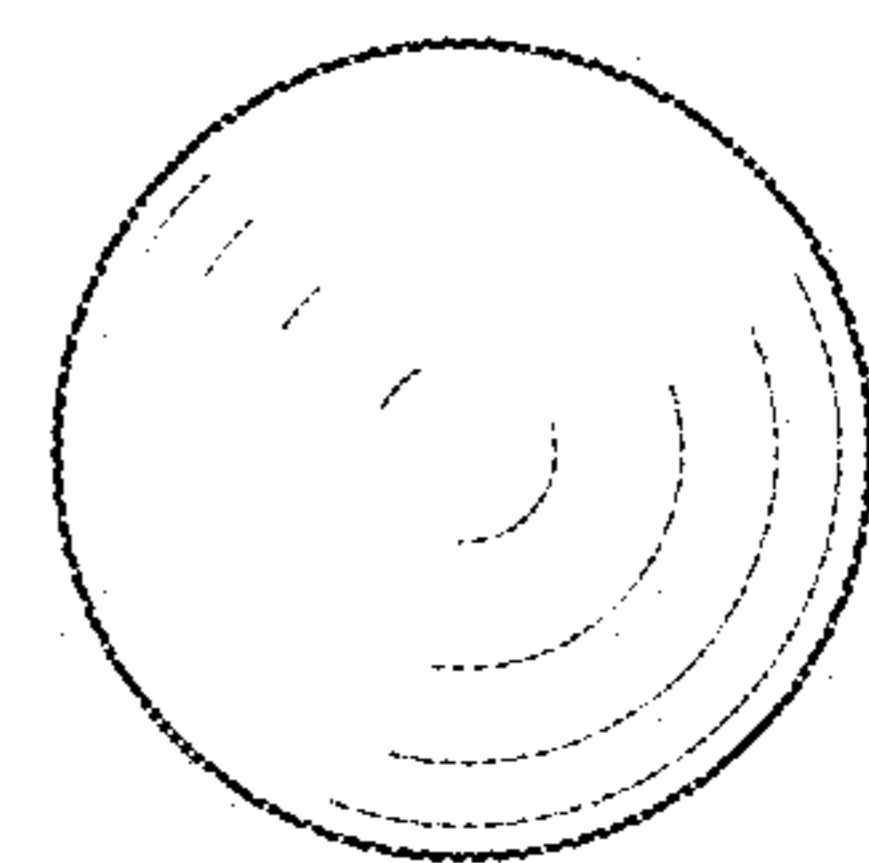

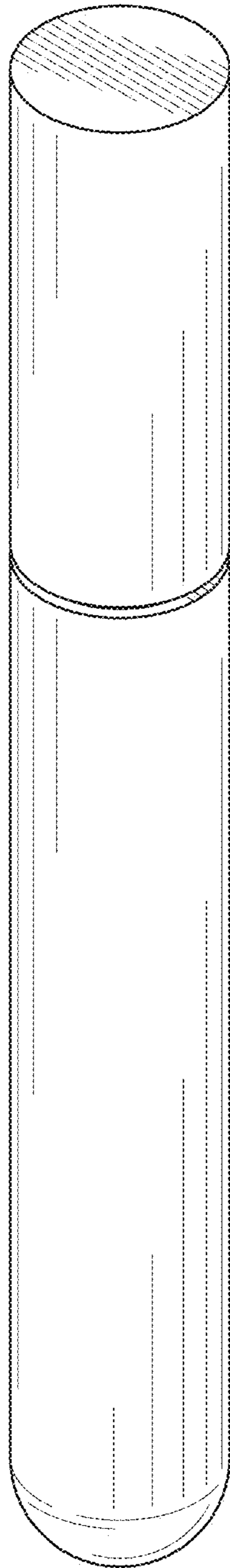

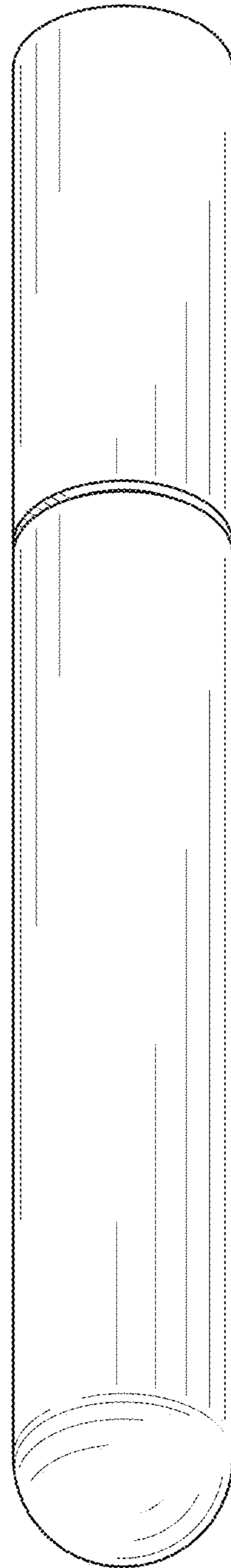

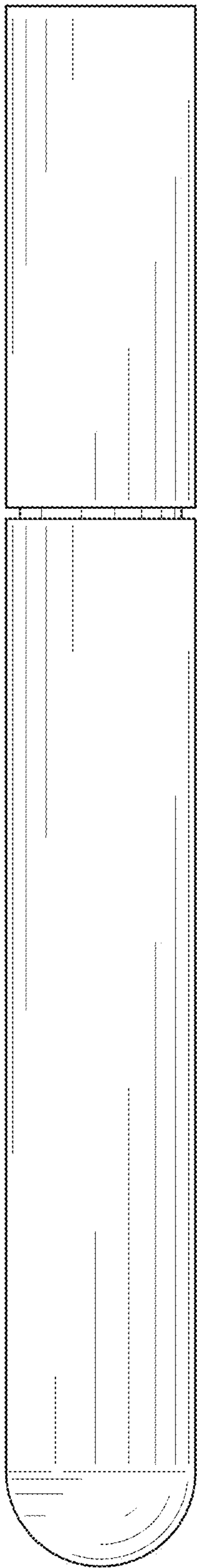

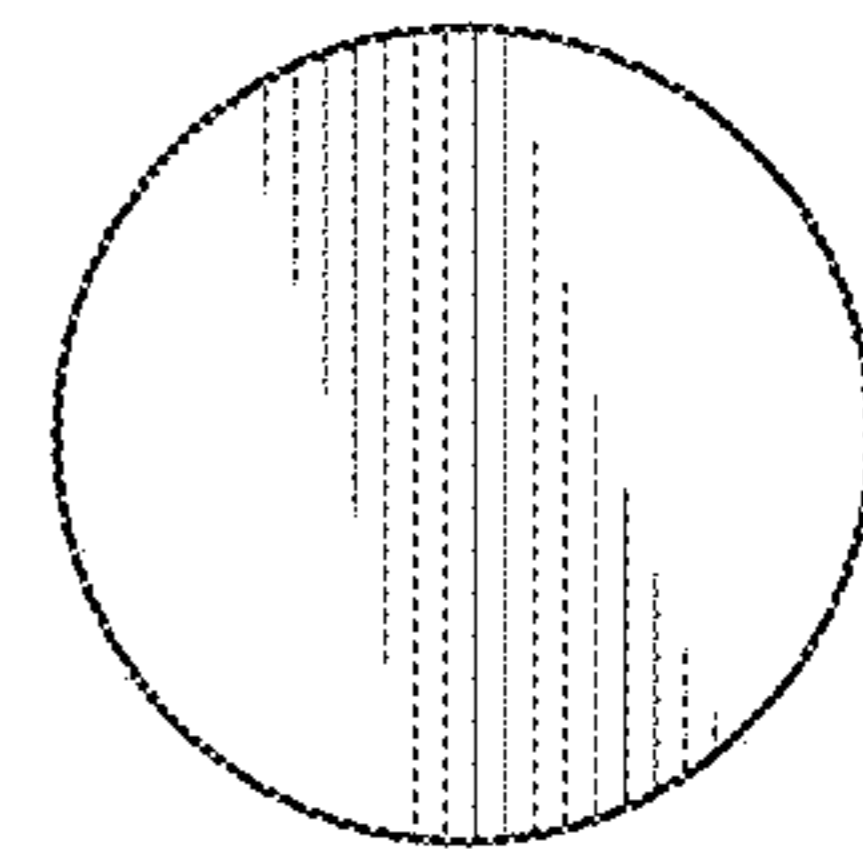

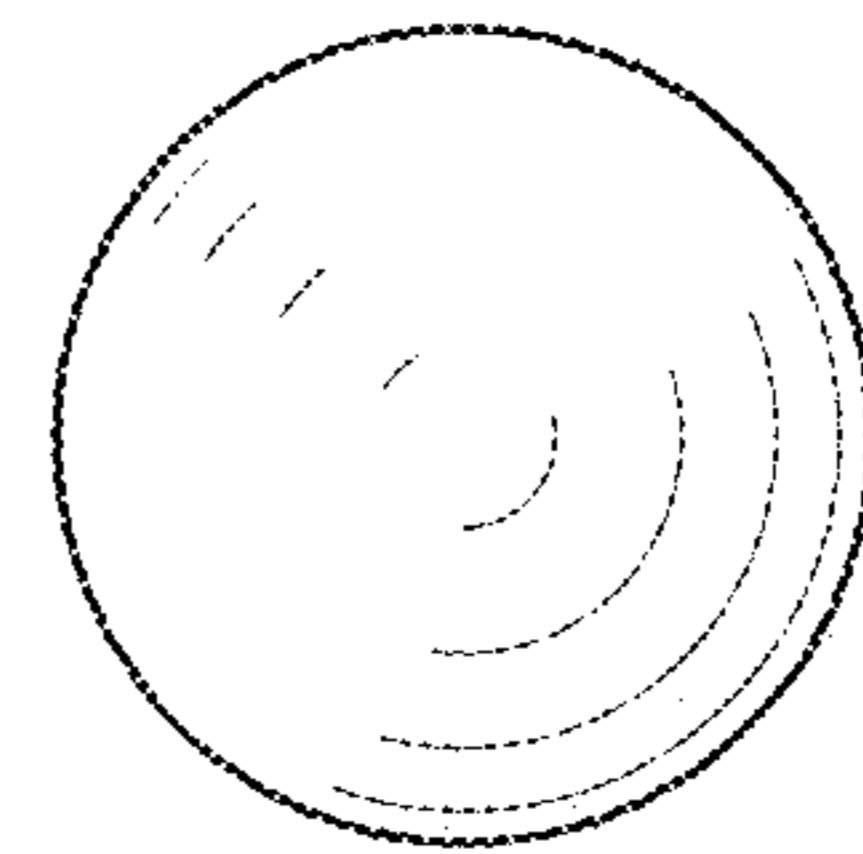

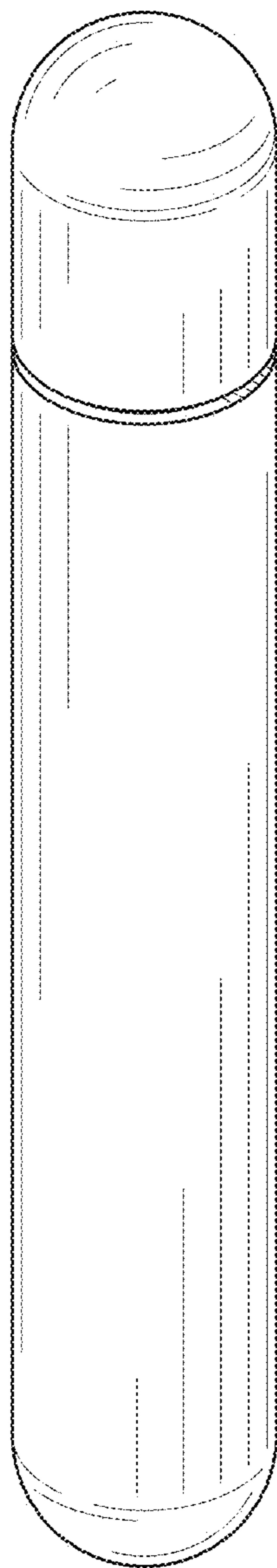

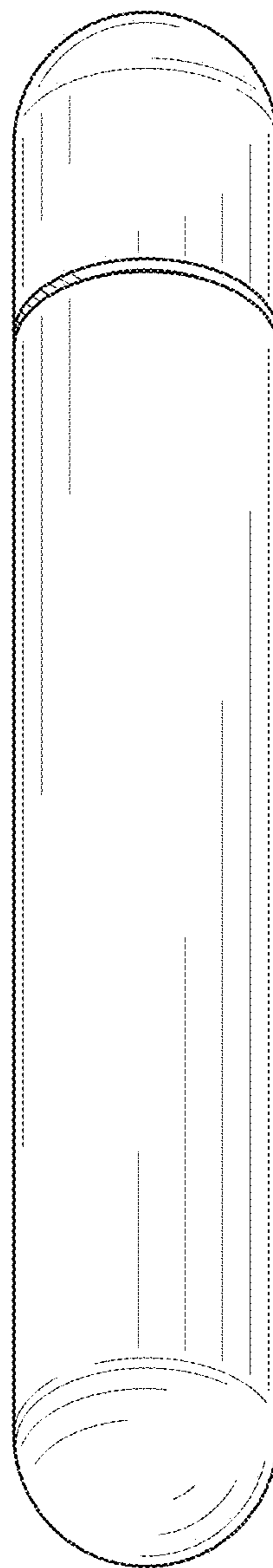

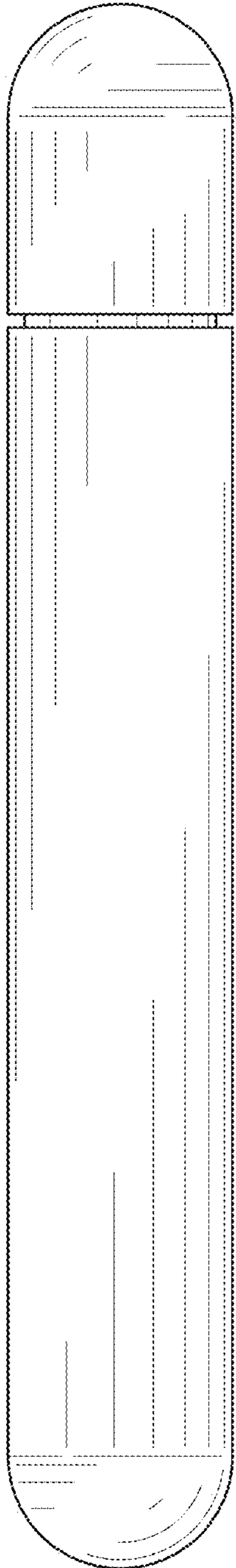

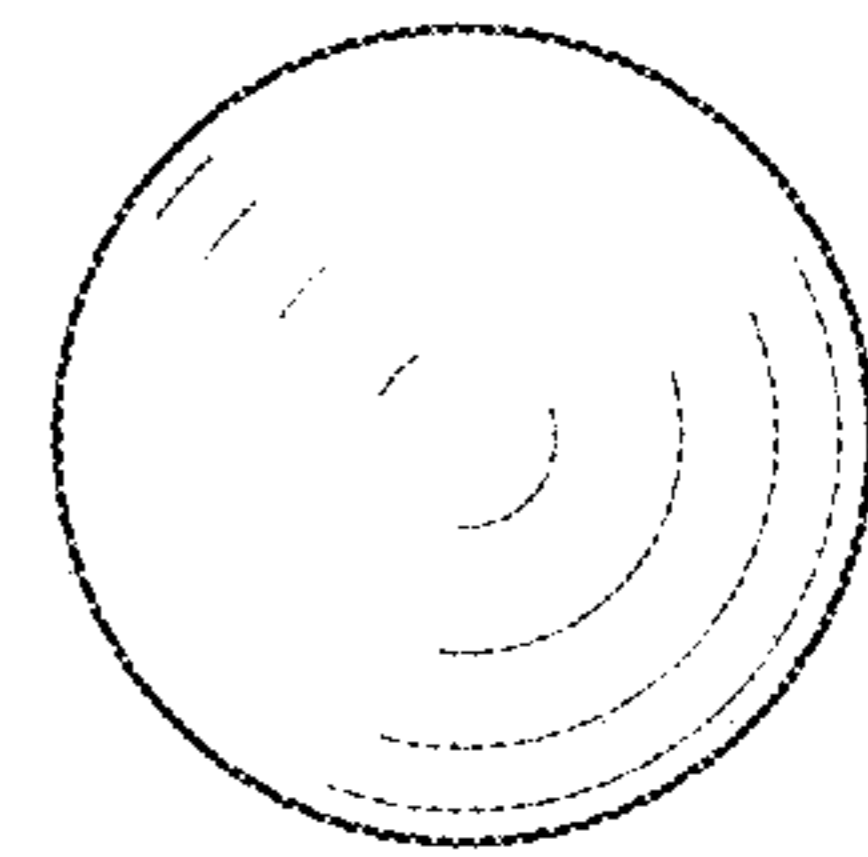

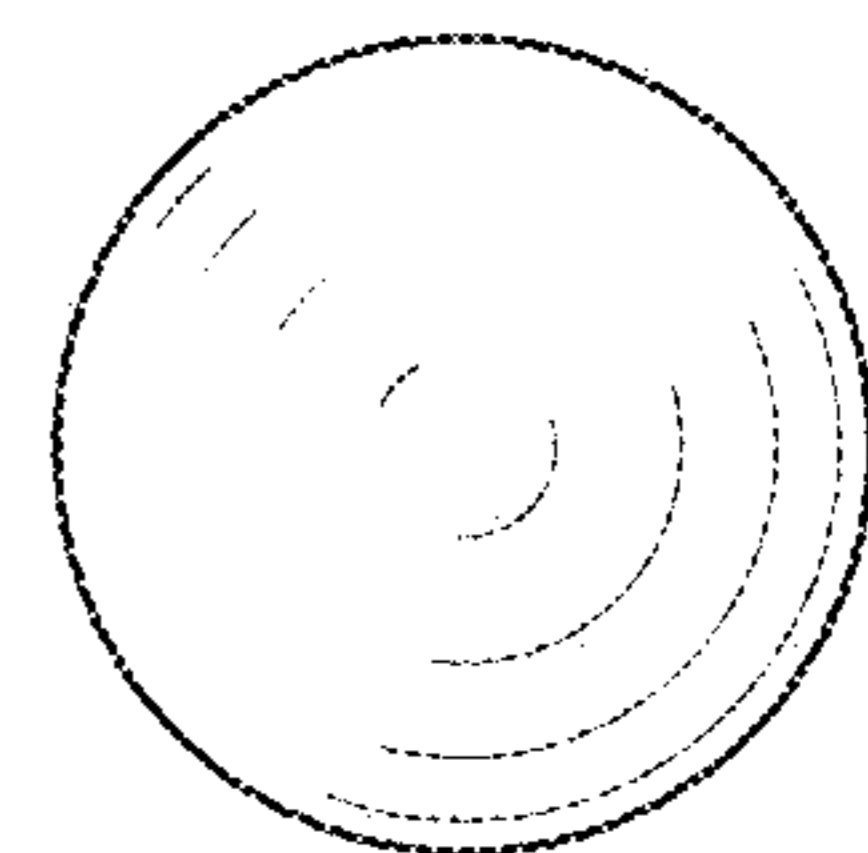

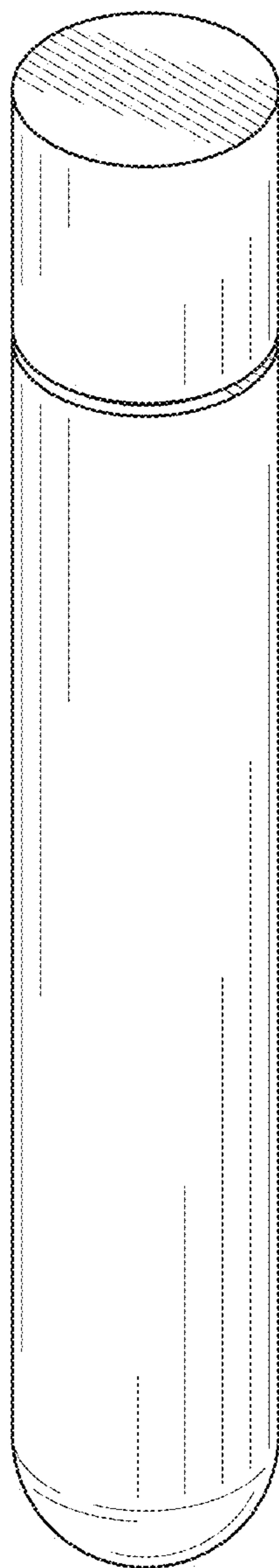

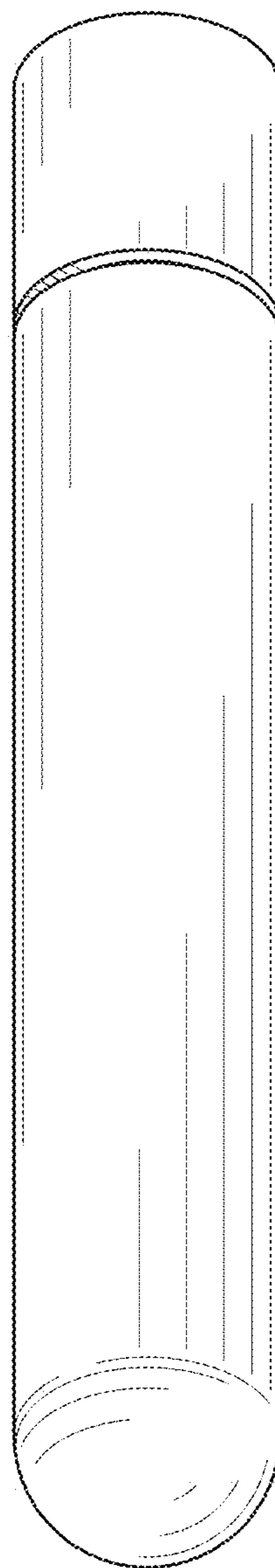

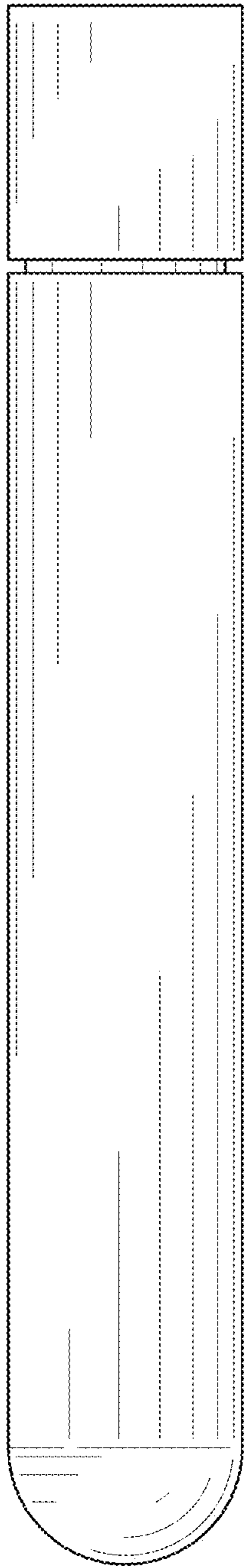

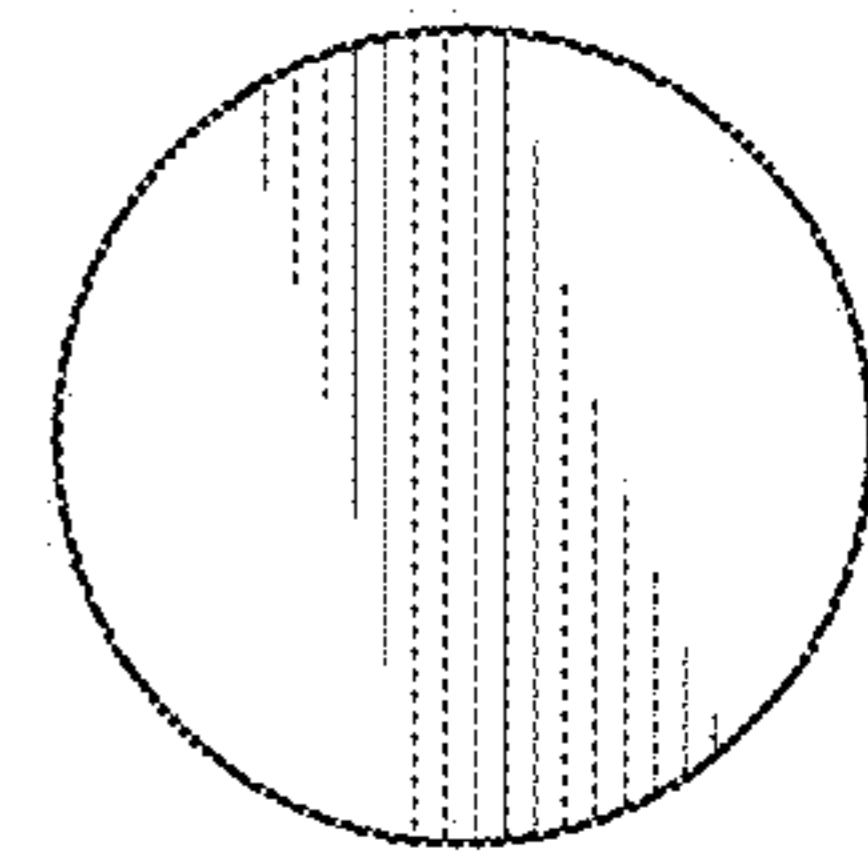

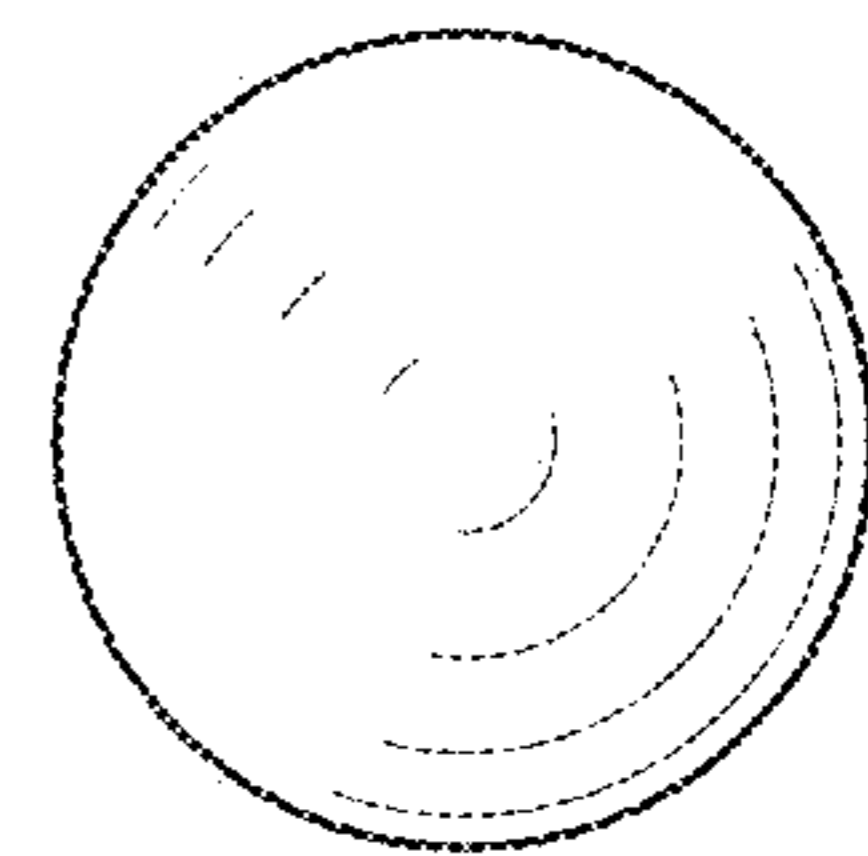
