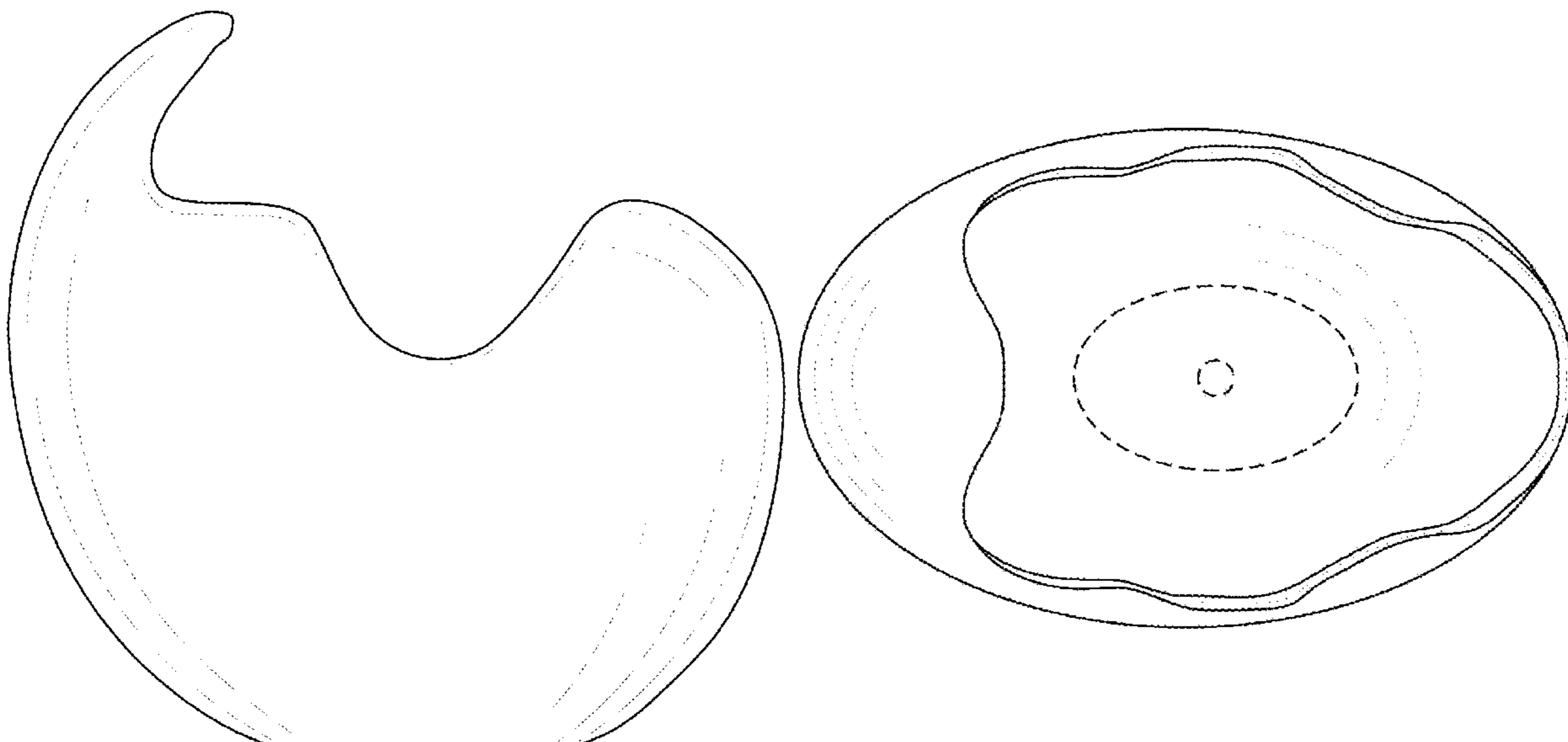

(57) **CLAIM**
The ornamental design for an eggshell vase, as shown and described.

DESCRIPTION
FIG. 1 is a front elevational view of an eggshell vase showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a perspective view thereof.
The broken lines in the drawings of FIGS. 5 and 6 are included to show portions of the eggshell vase that form no part of the claimed design.

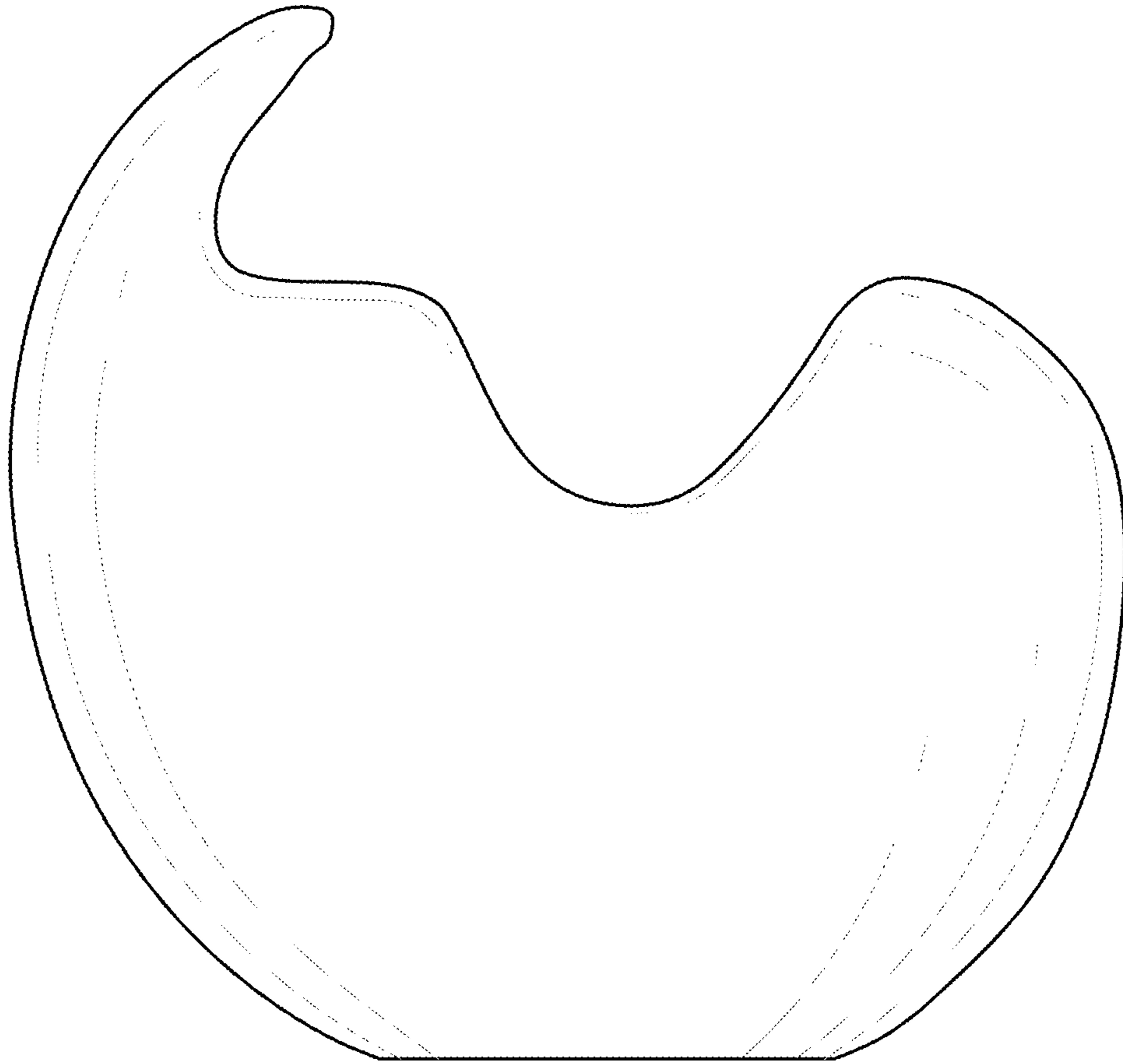

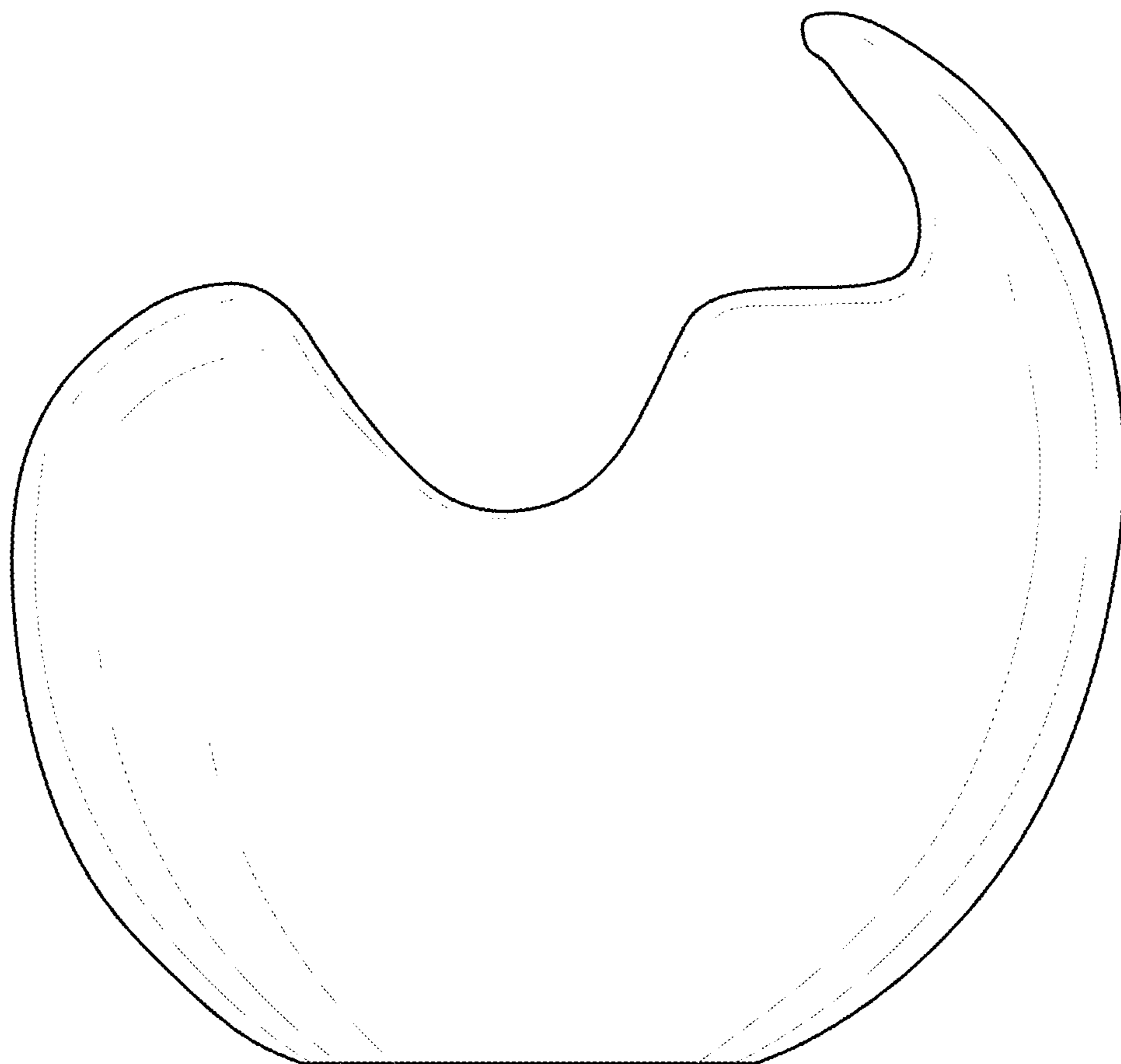

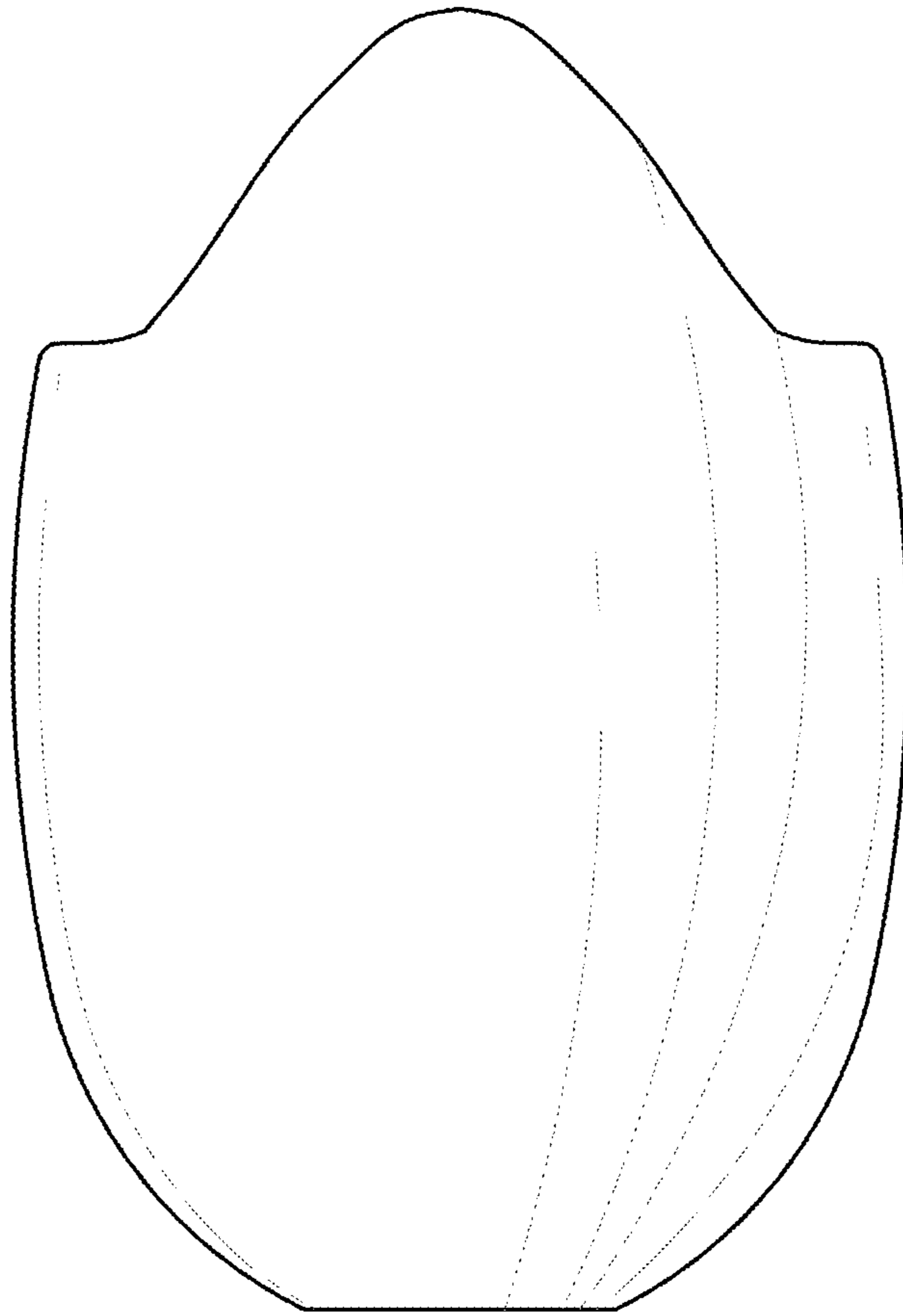

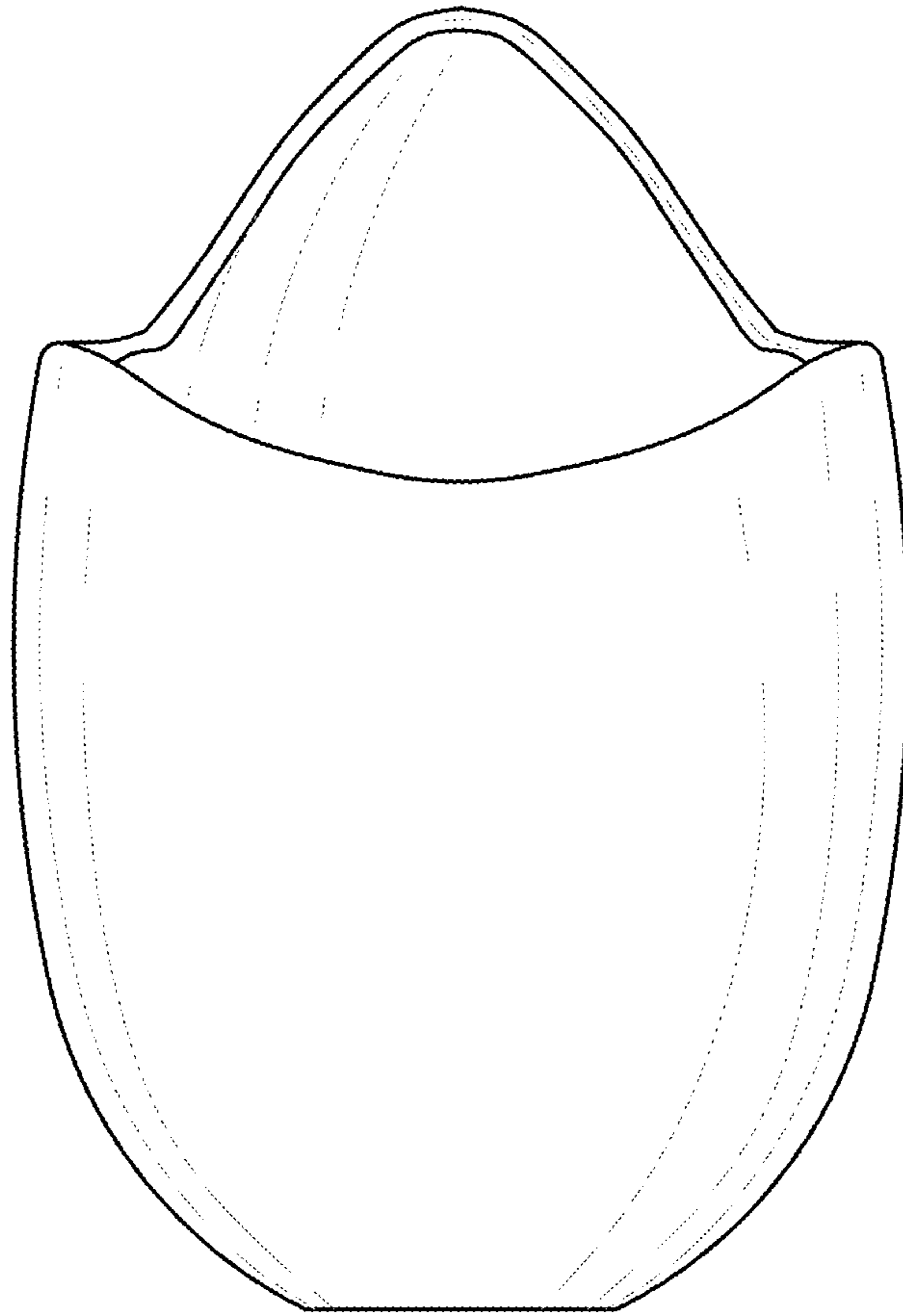

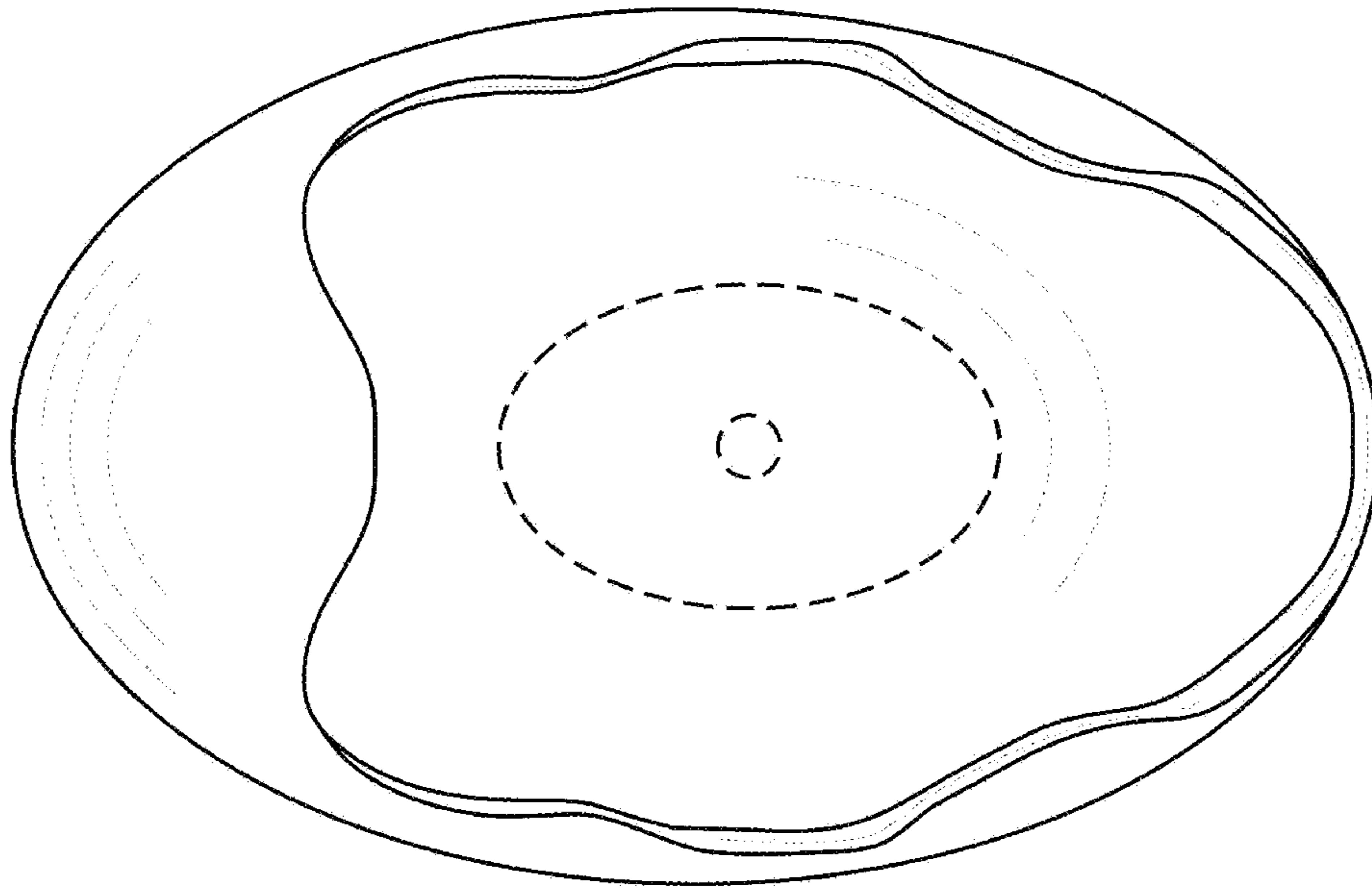

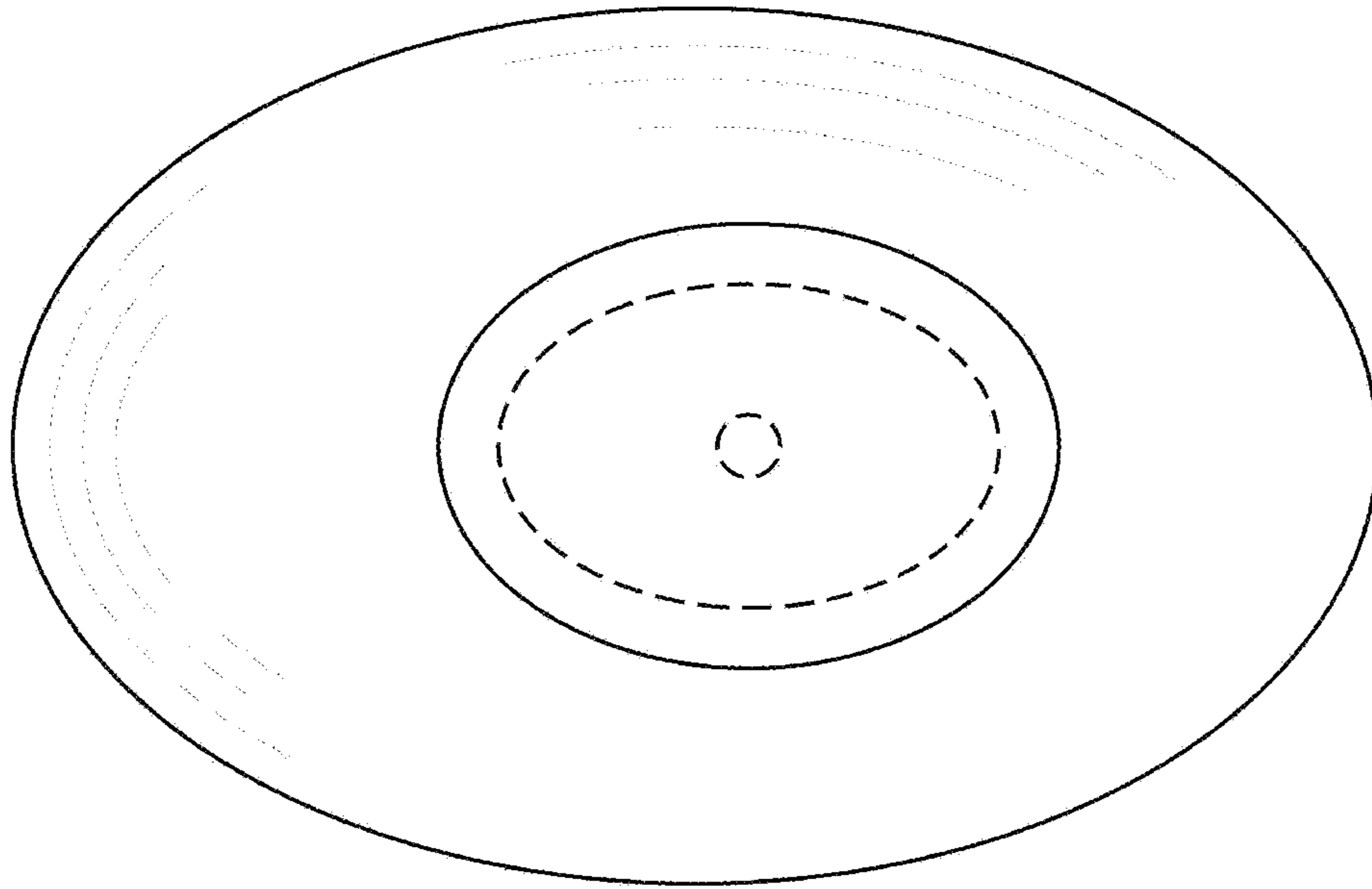

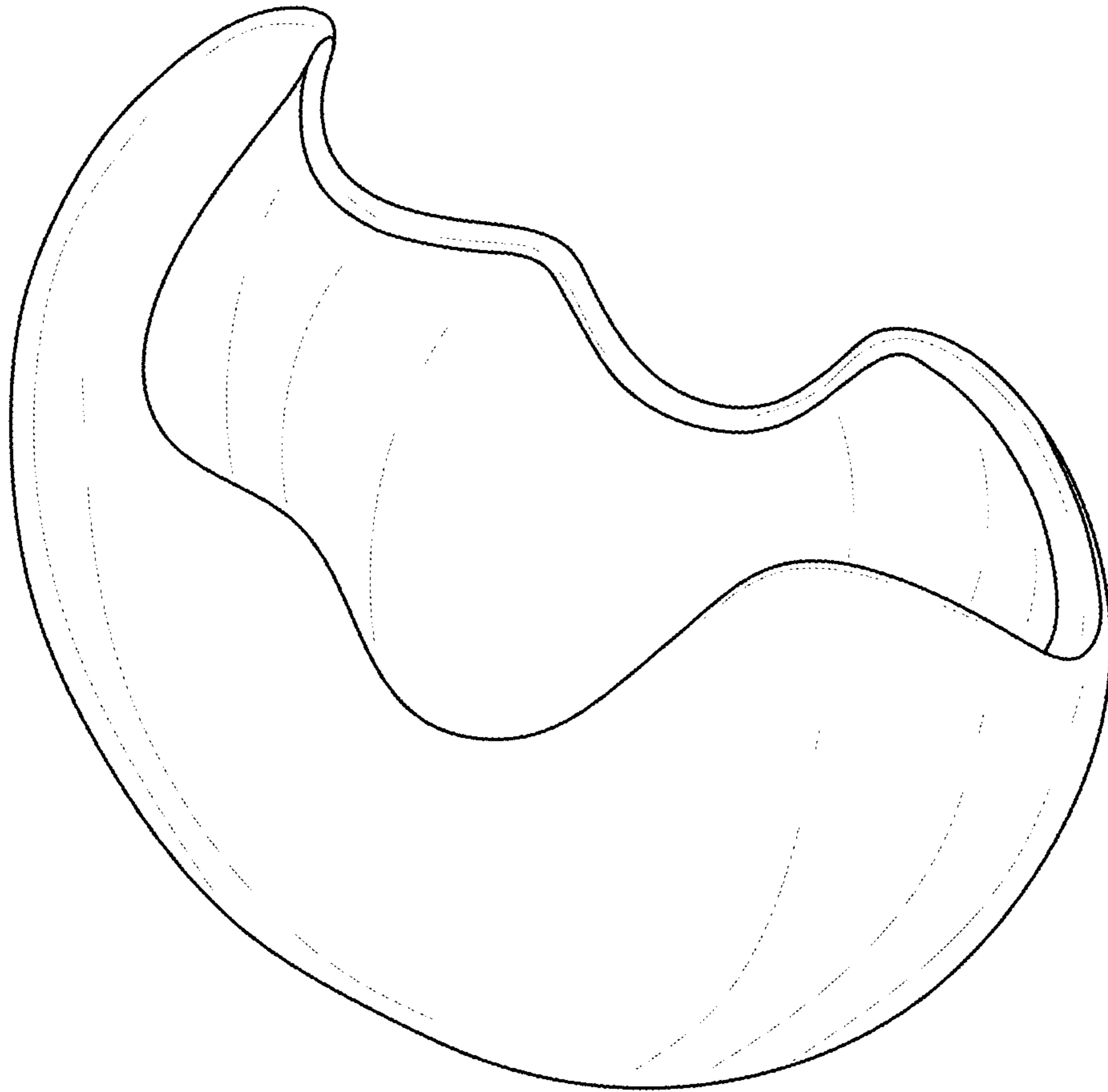
