FIG. 10 is an enlarged left elevational view thereof.

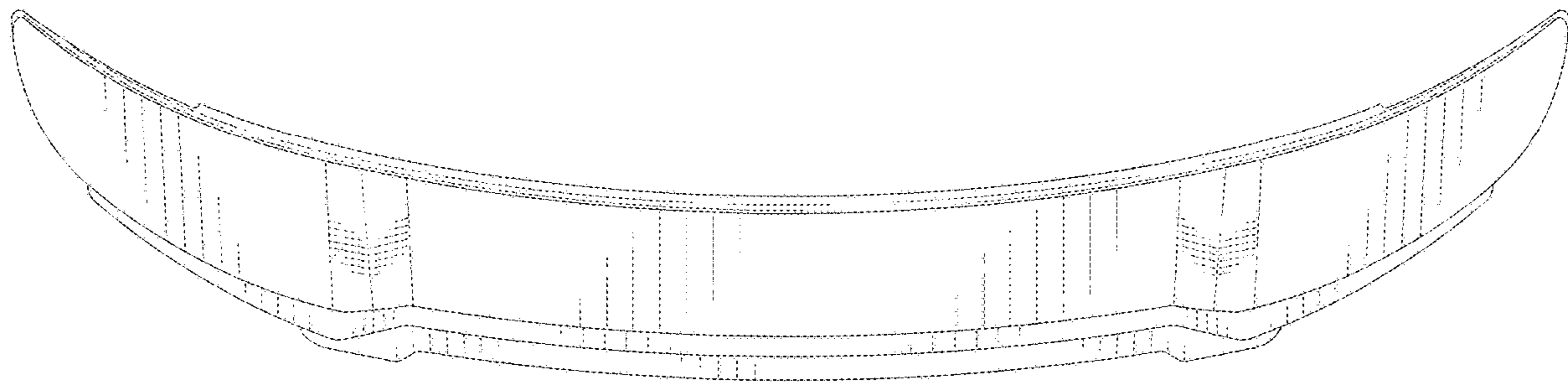

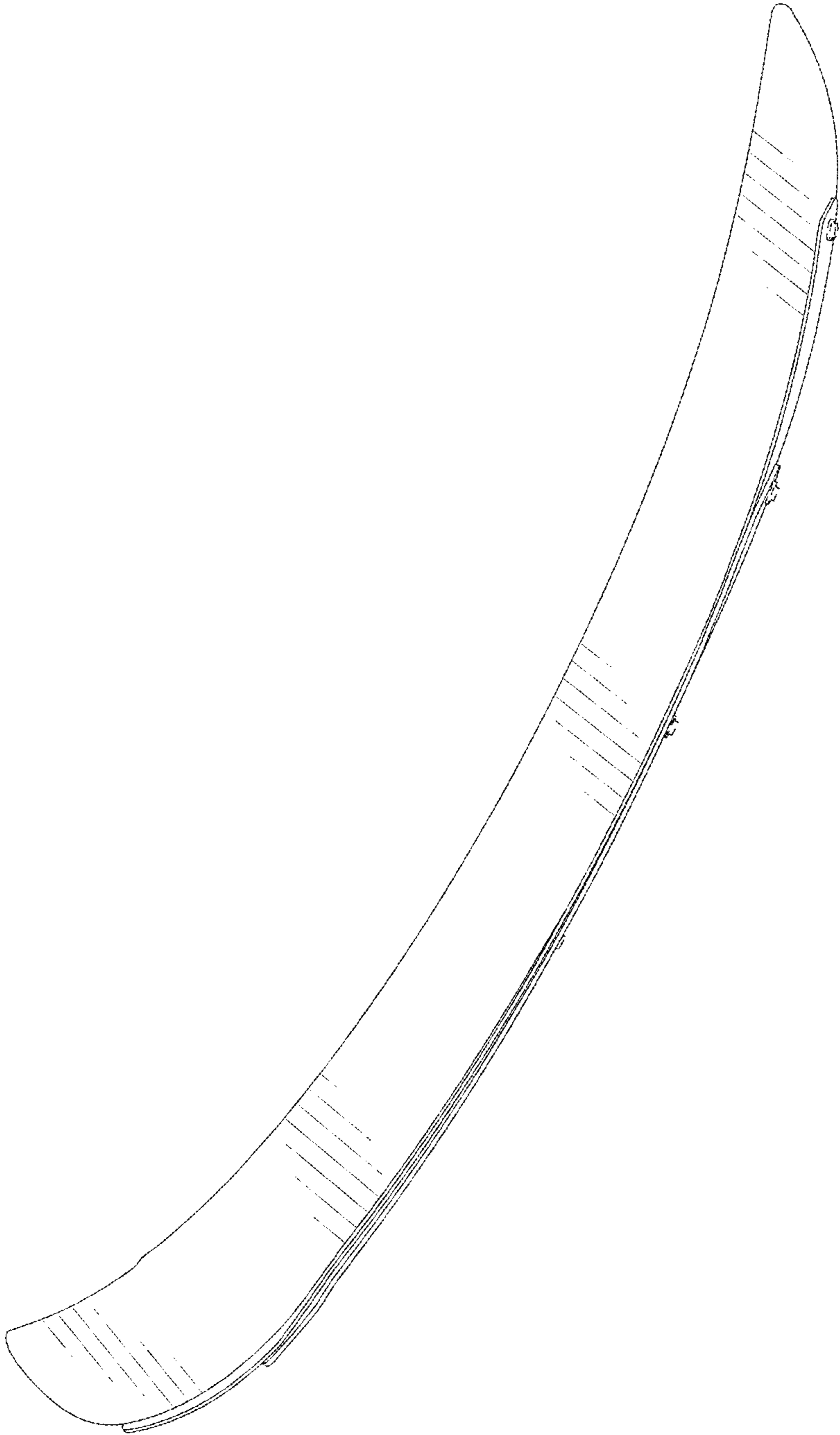

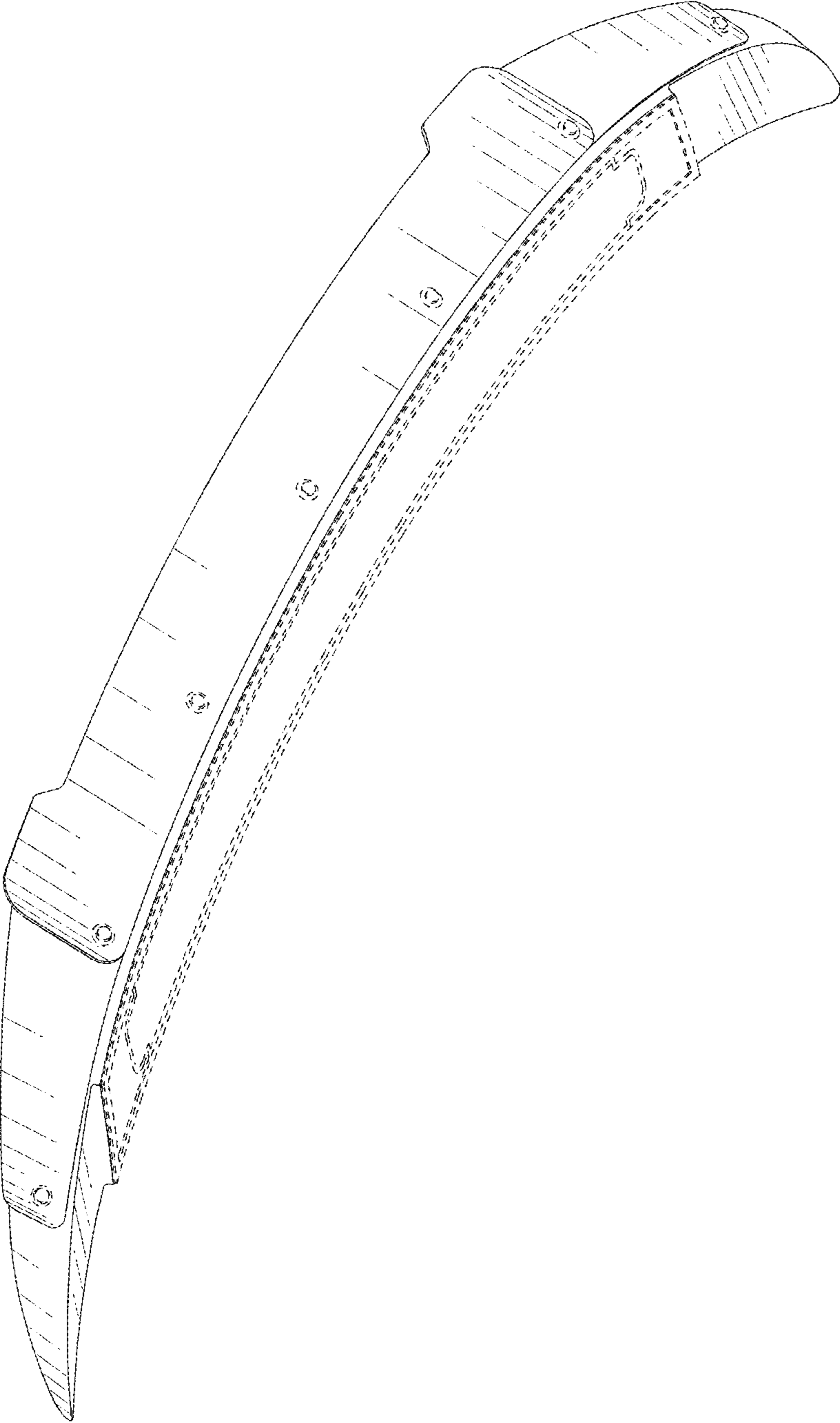

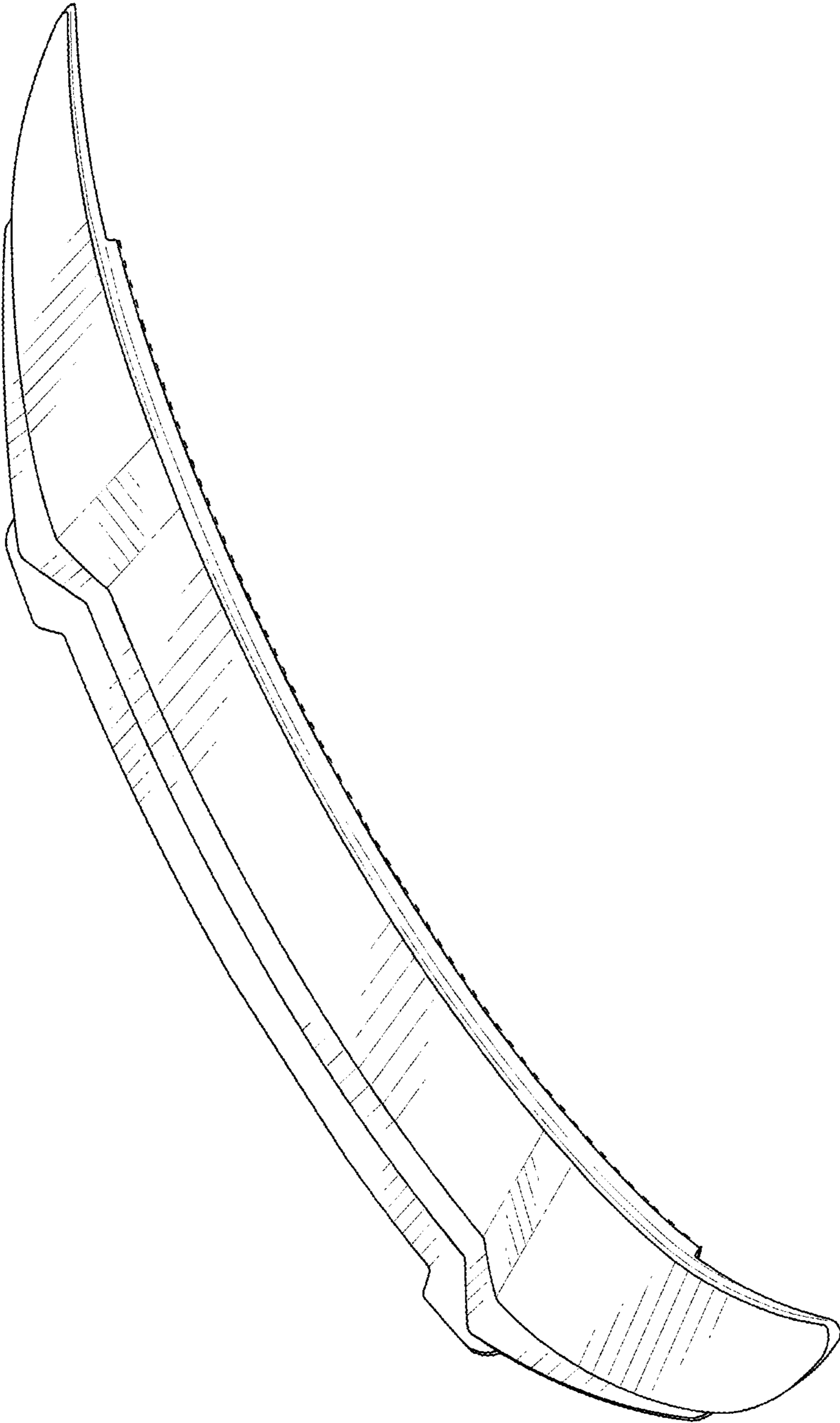

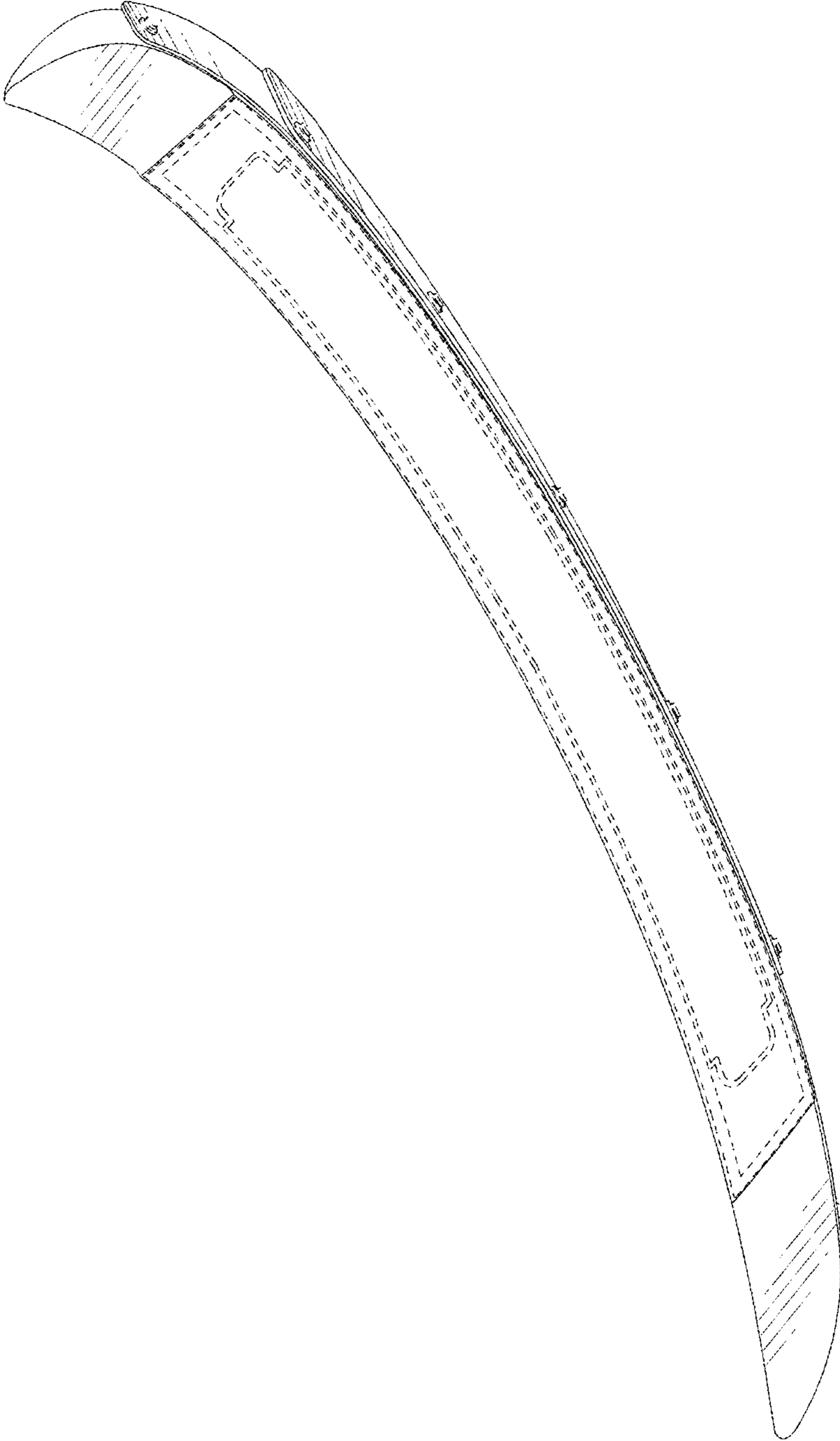

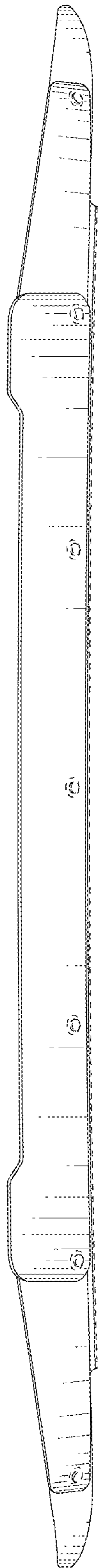

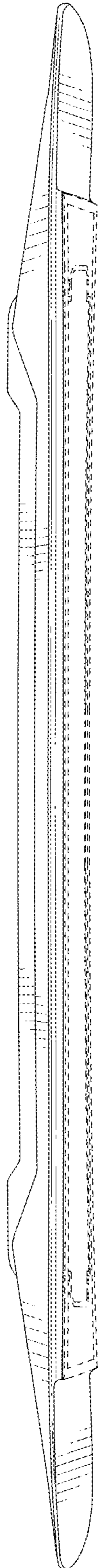

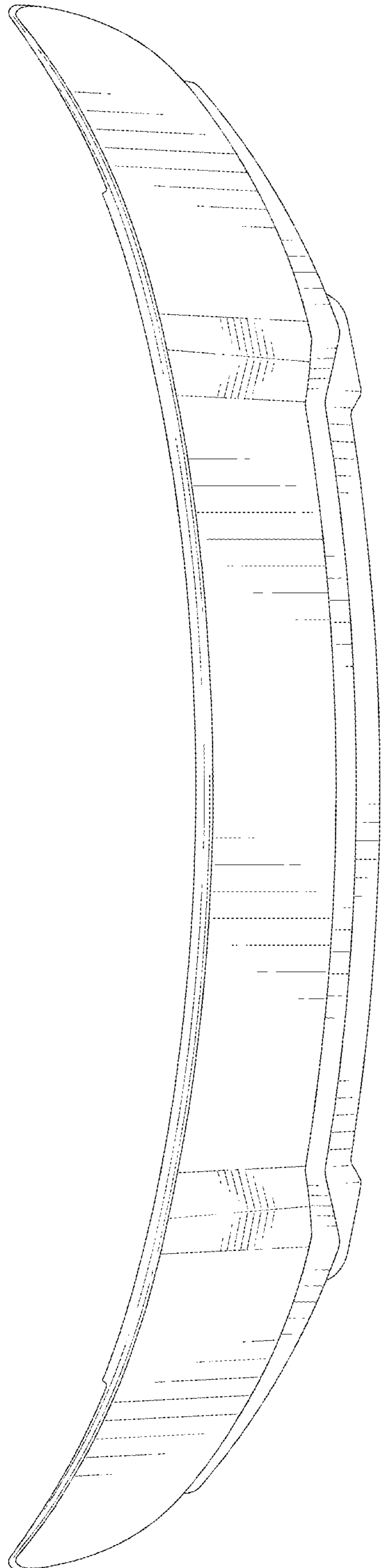

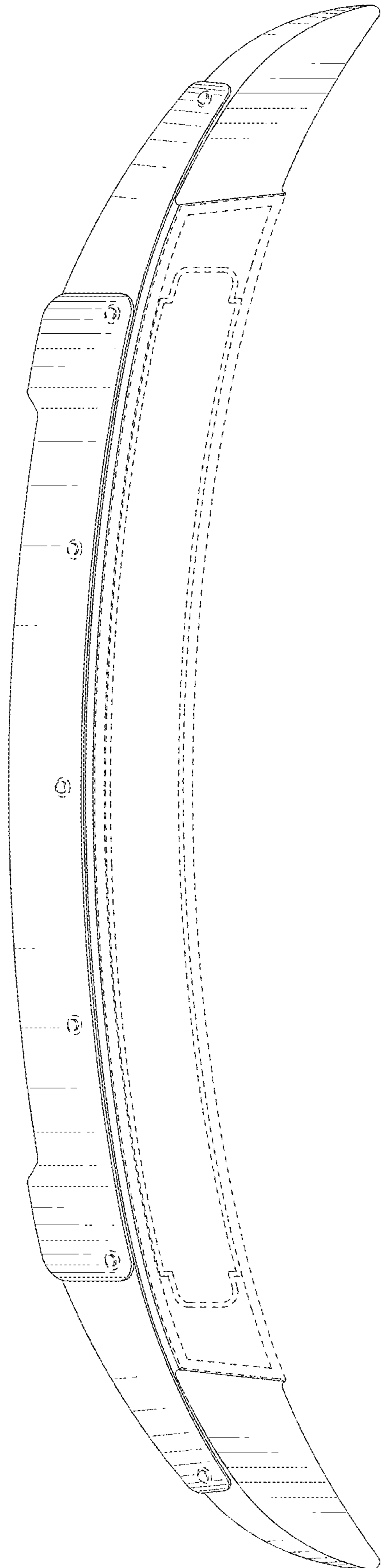

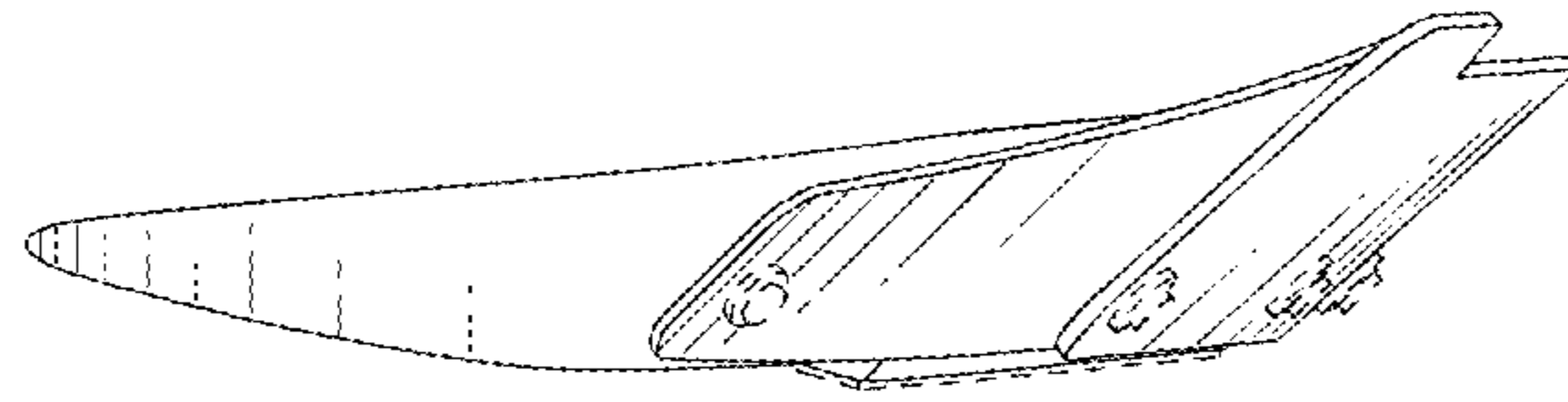

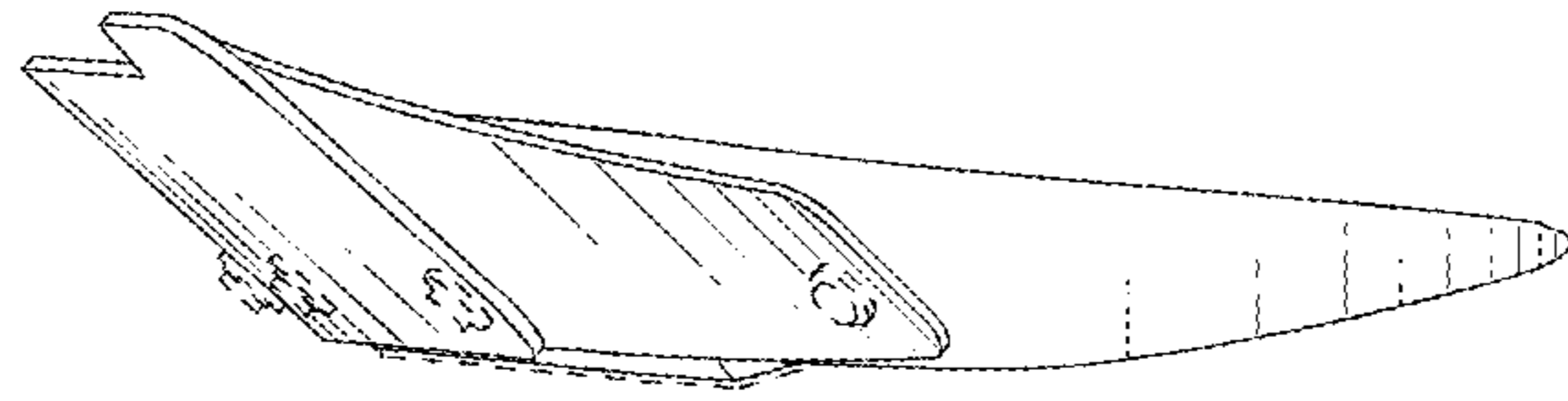
