(57) **CLAIM**

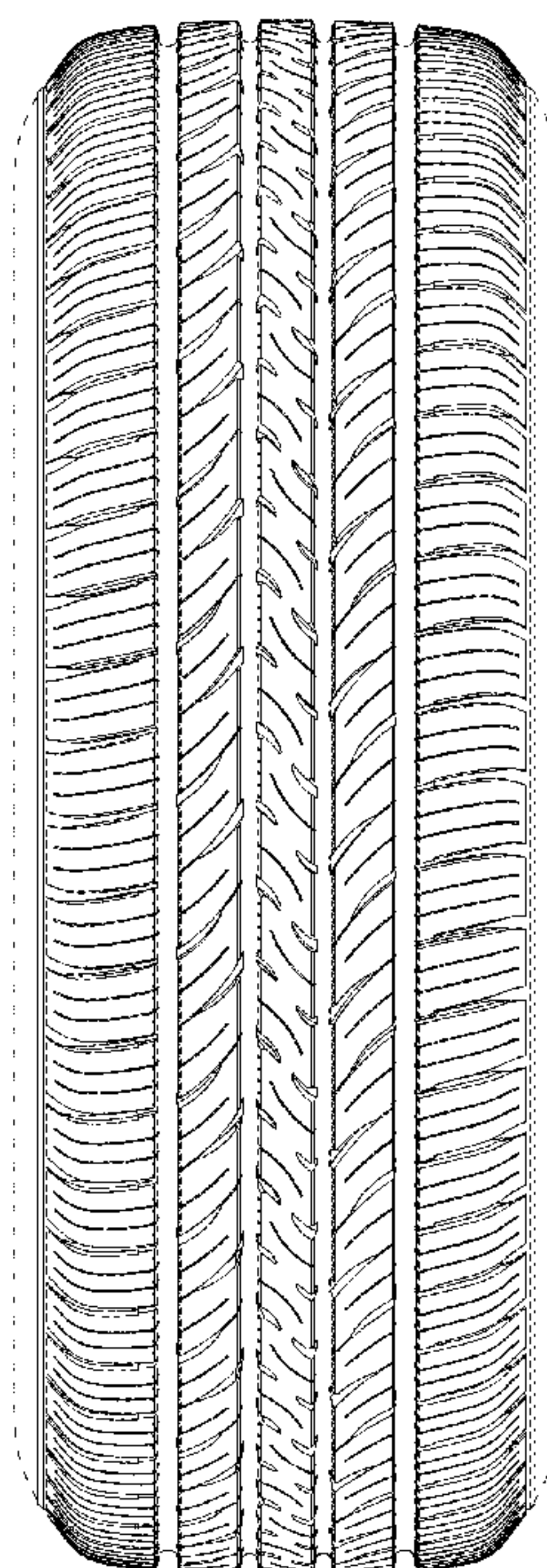
The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tire showing the claimed design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a left side view thereof;

FIG. 9 is an enlarged view of the portion 9-9 in FIG. 2; and,
FIG. 10 is a cross-sectional view taken along line 10-10 in FIG. 9.

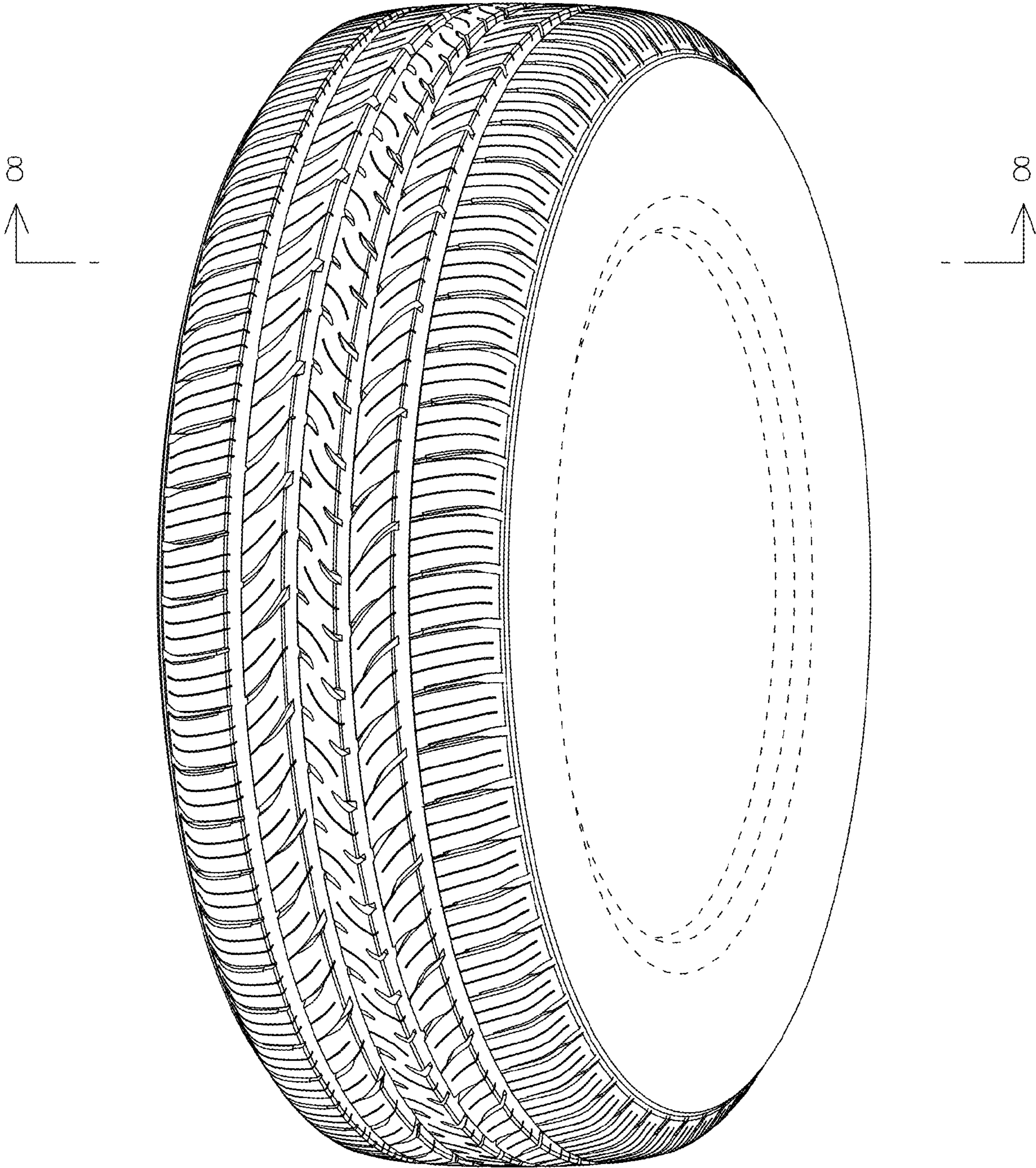

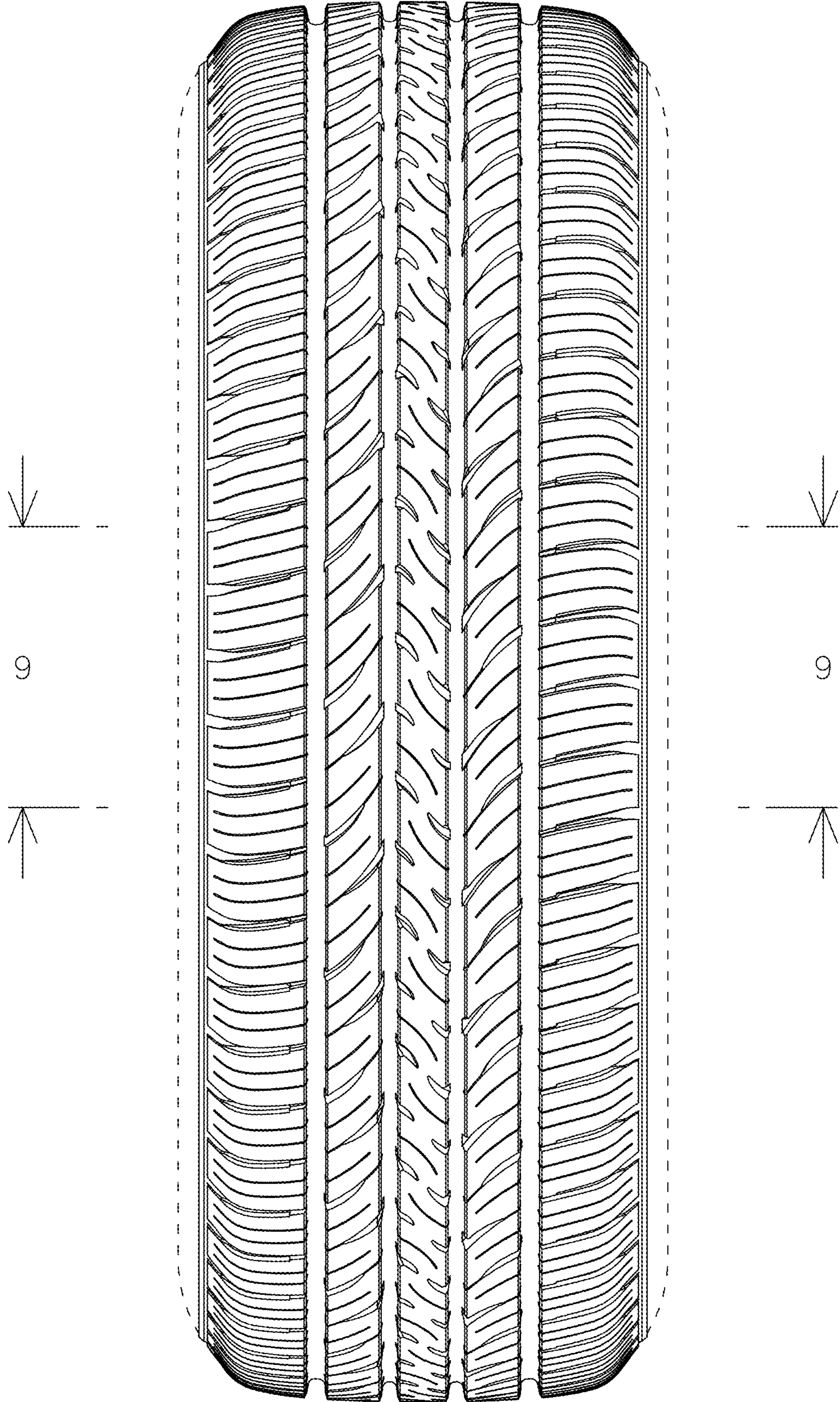

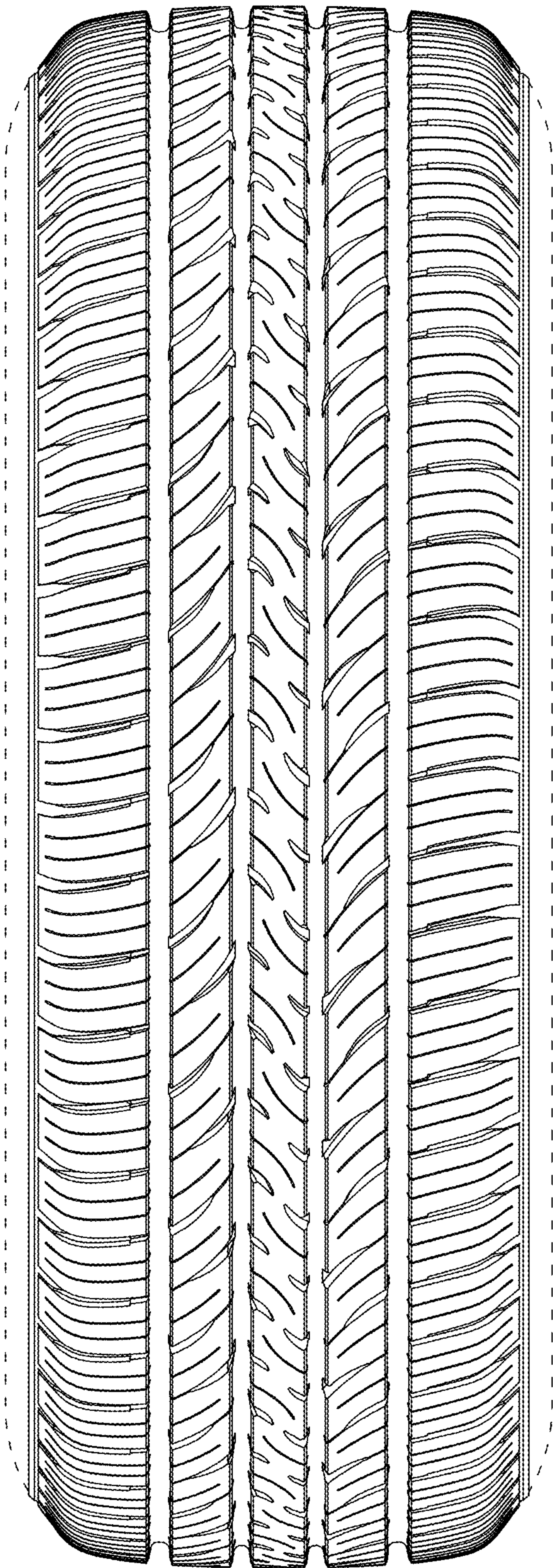

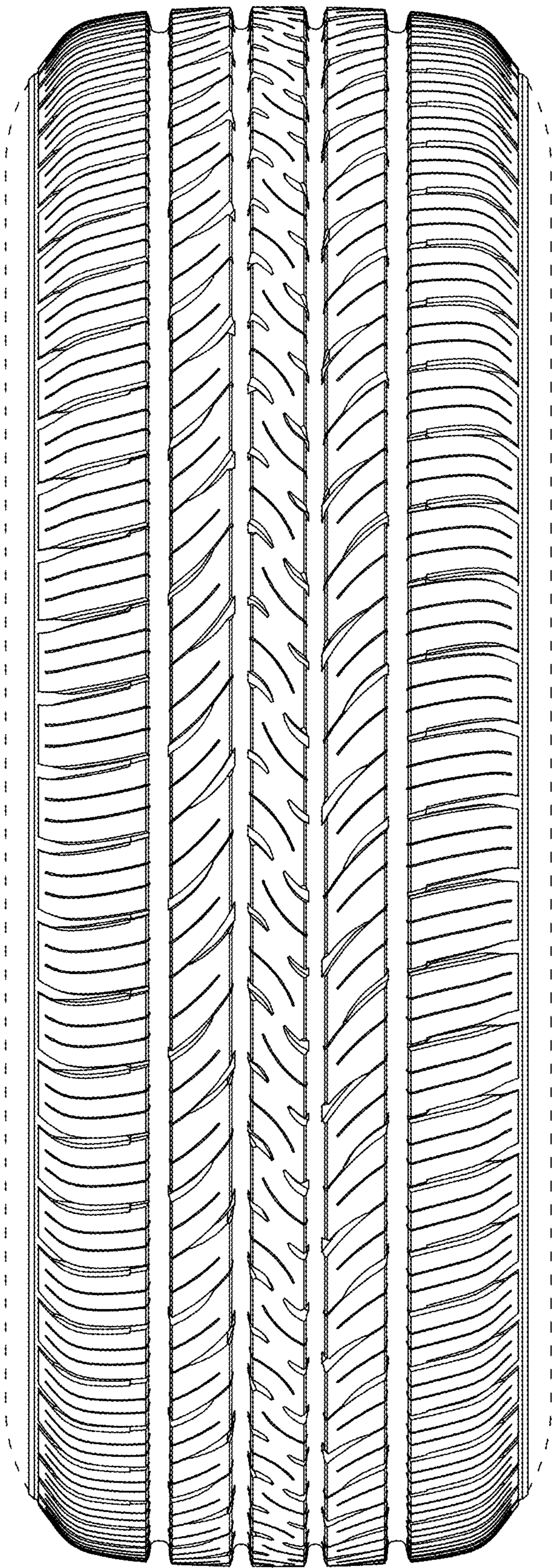

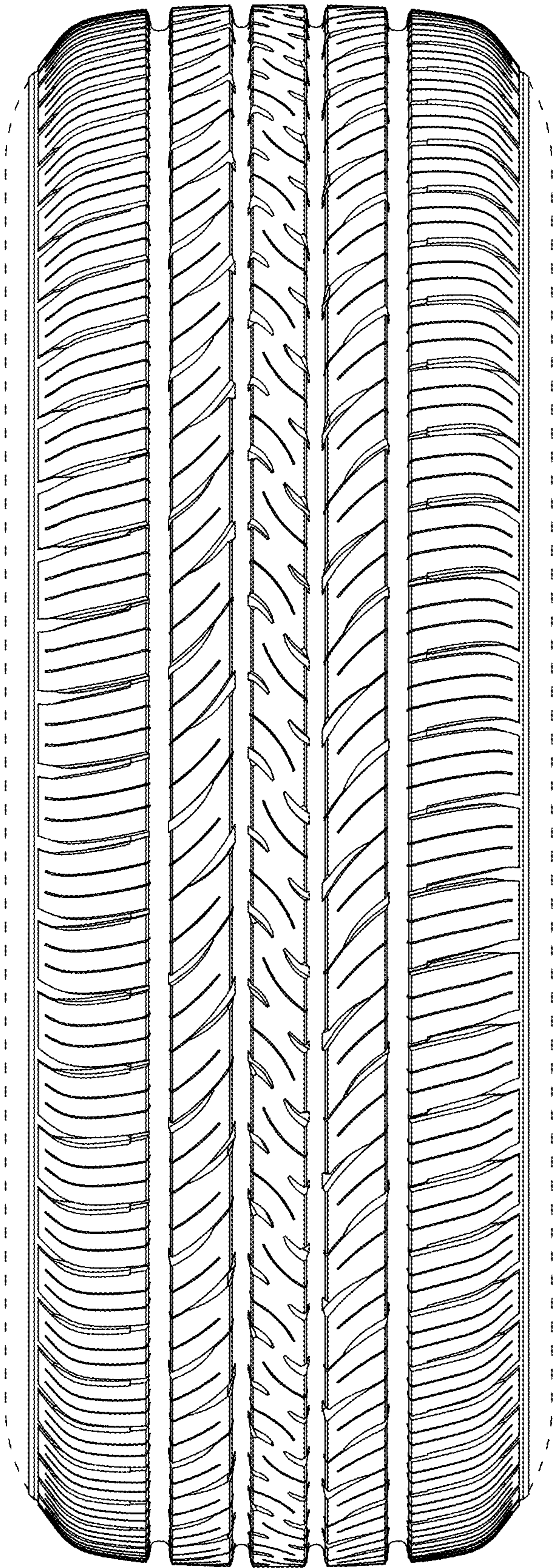

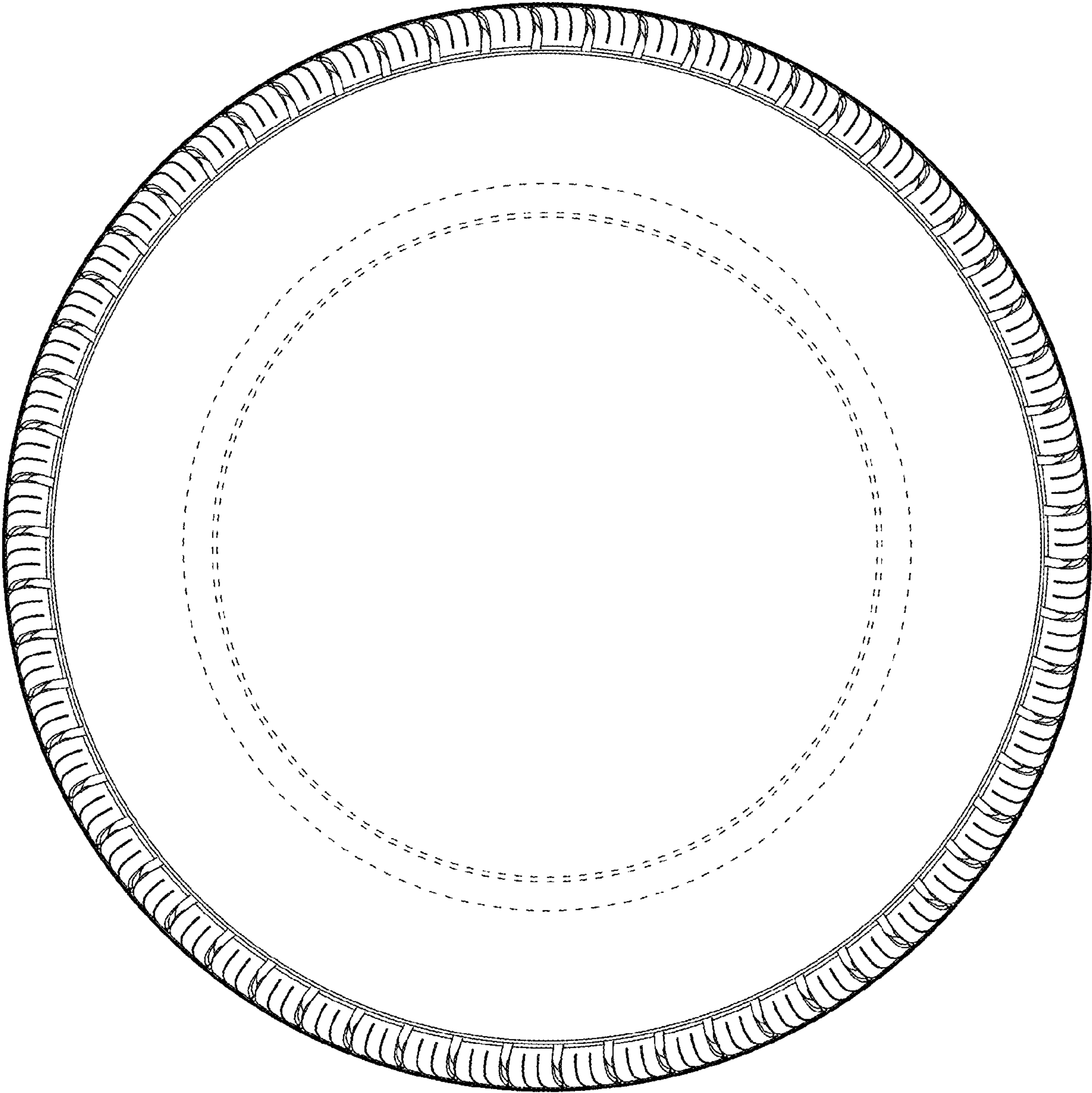

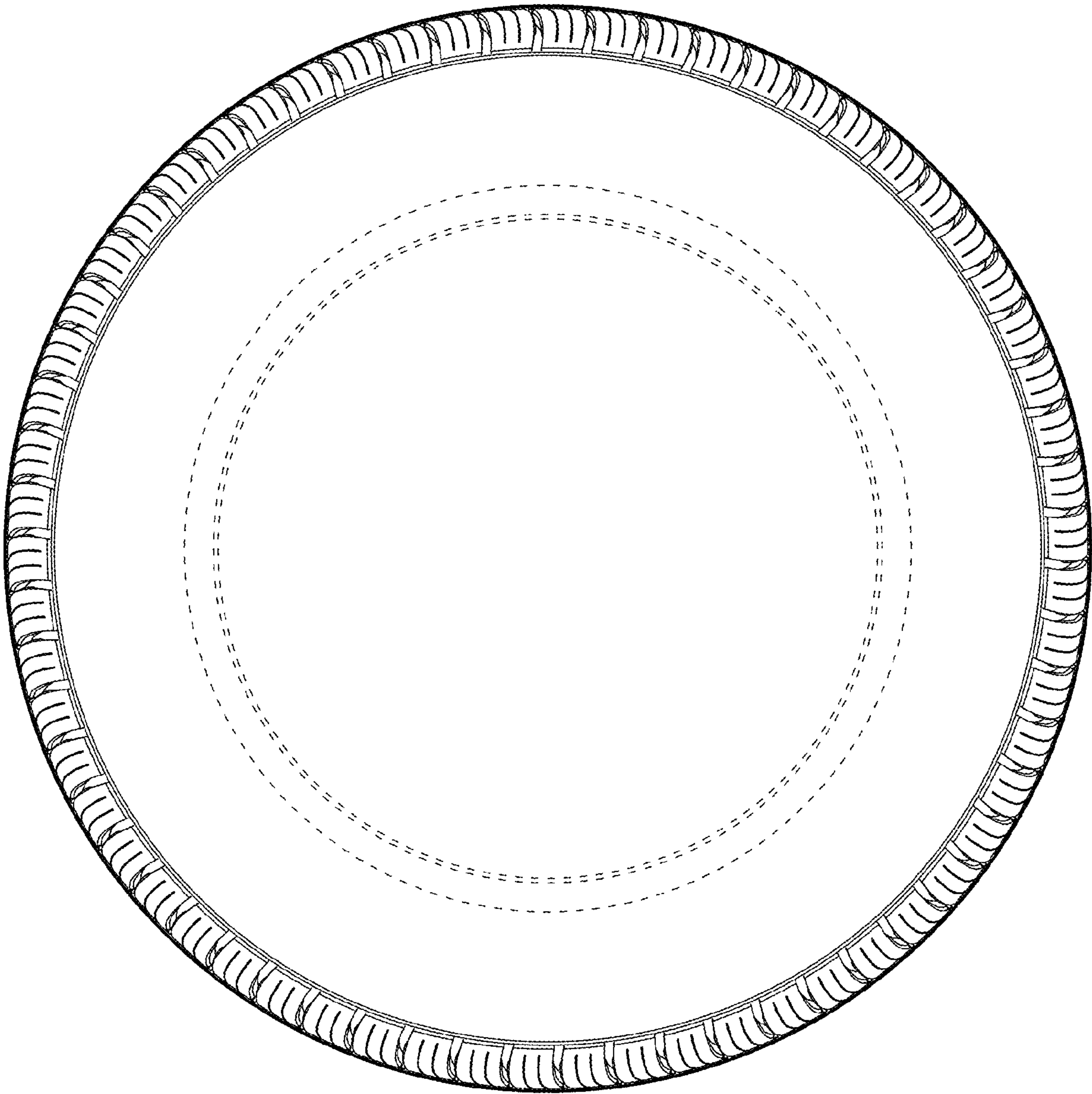

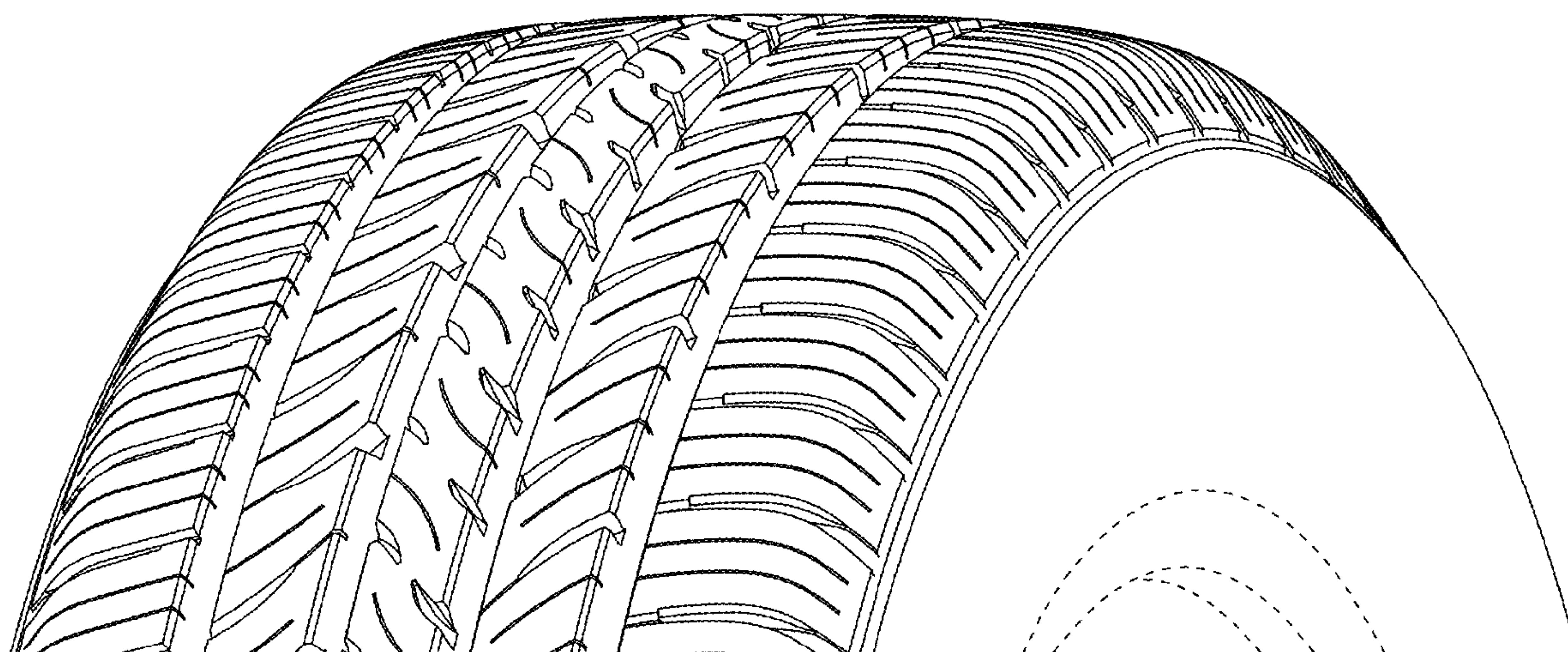

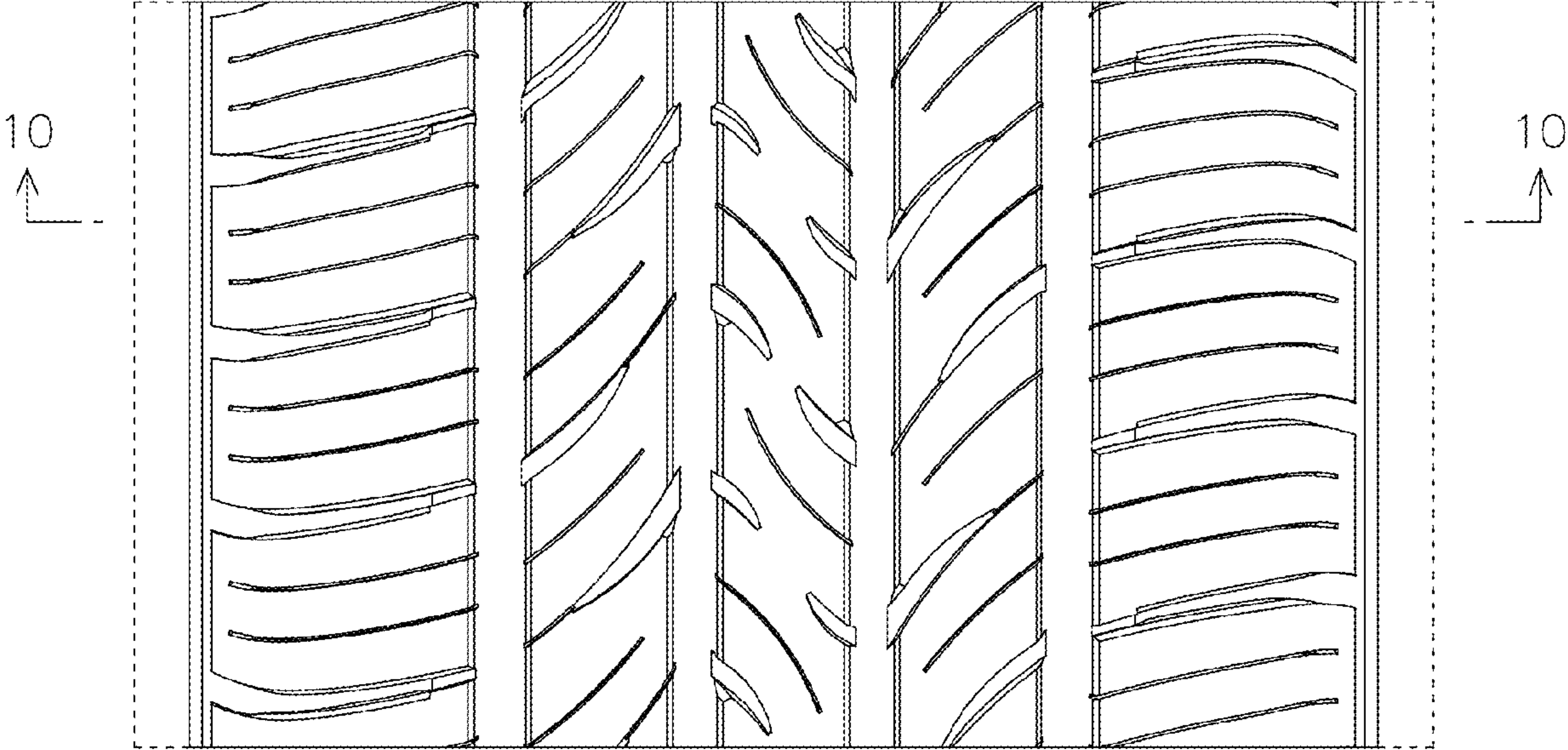

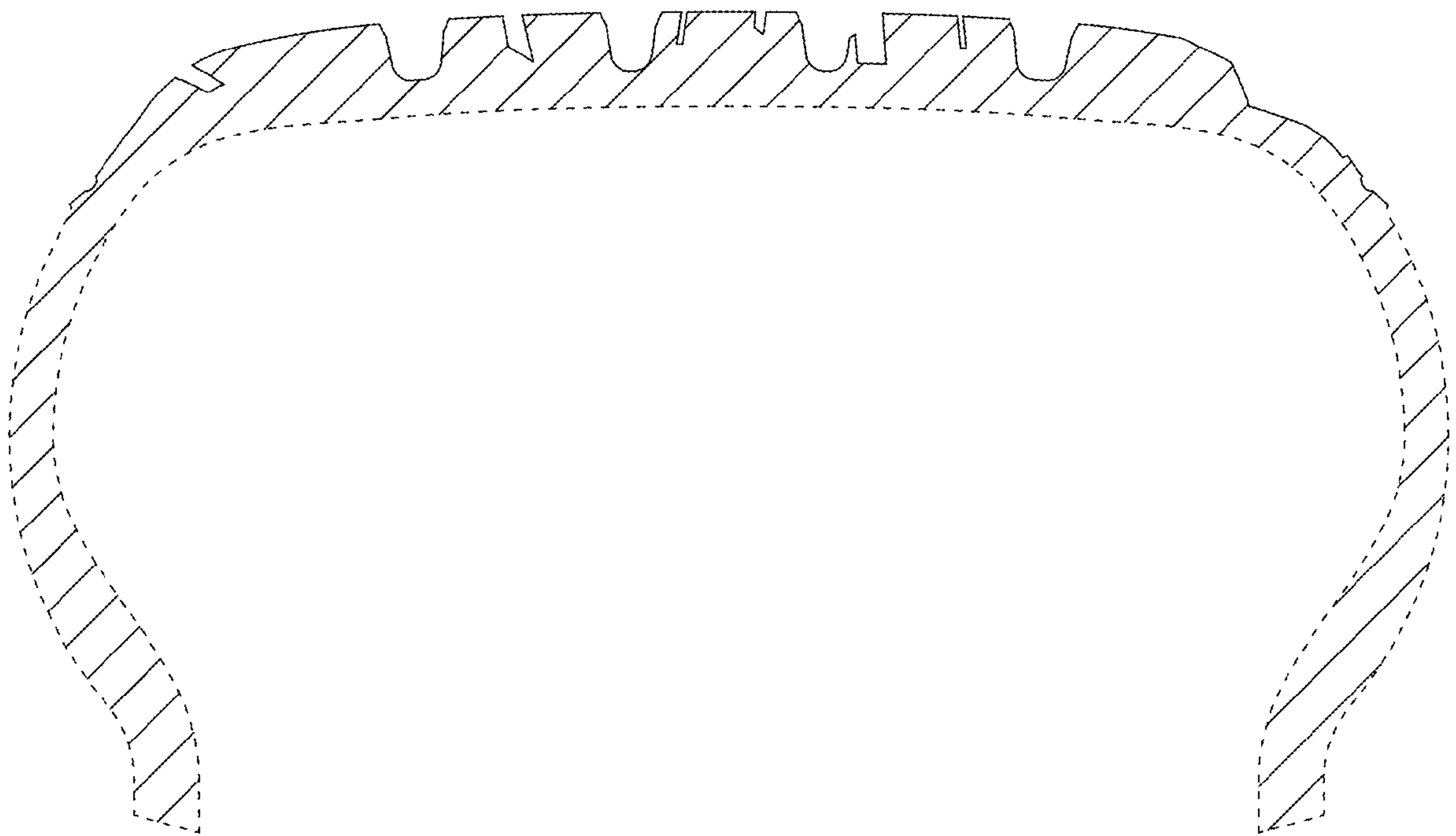
