

**CLAIM**

The ornamental design for an integral DC charging point, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of an integral DC charging point showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is an enlarged view of portion A in FIG. 1;  
FIG. 9 is an enlarged view of portion B in FIG. 1; and,  
FIG. 10 is an enlarged view of portion C in FIG. 1.  
The broken lines in the drawings illustrate portions of the integral DC charging point which form no part of the claimed design. The oblique shade lines in the drawings represent reflective surfaces.



















