CLAIM

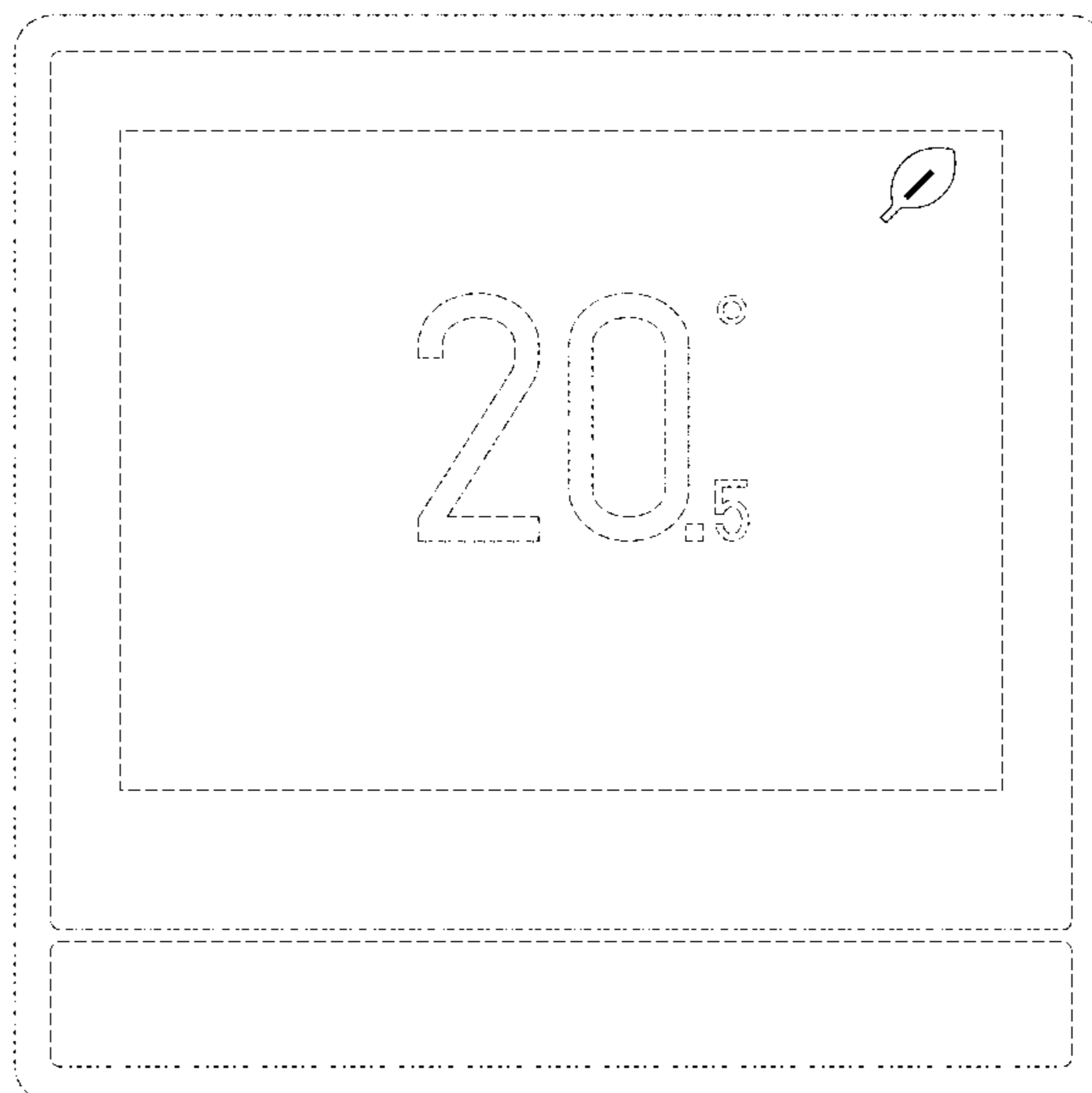
The ornamental design for a display screen with graphical user interface or portion thereof, as shown and described.
