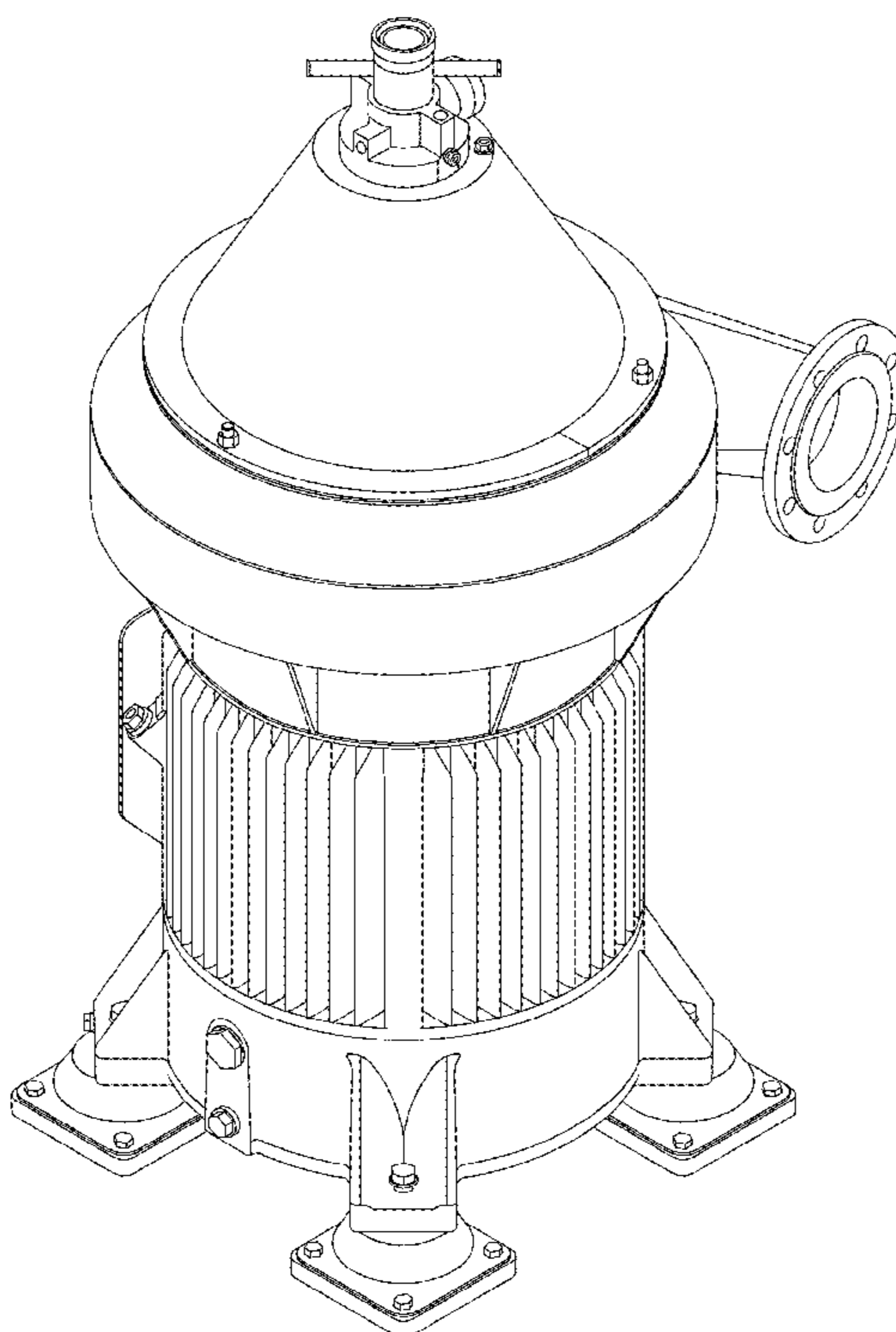
The ornamental design for a centrifugal separator, substantially as shown and described.

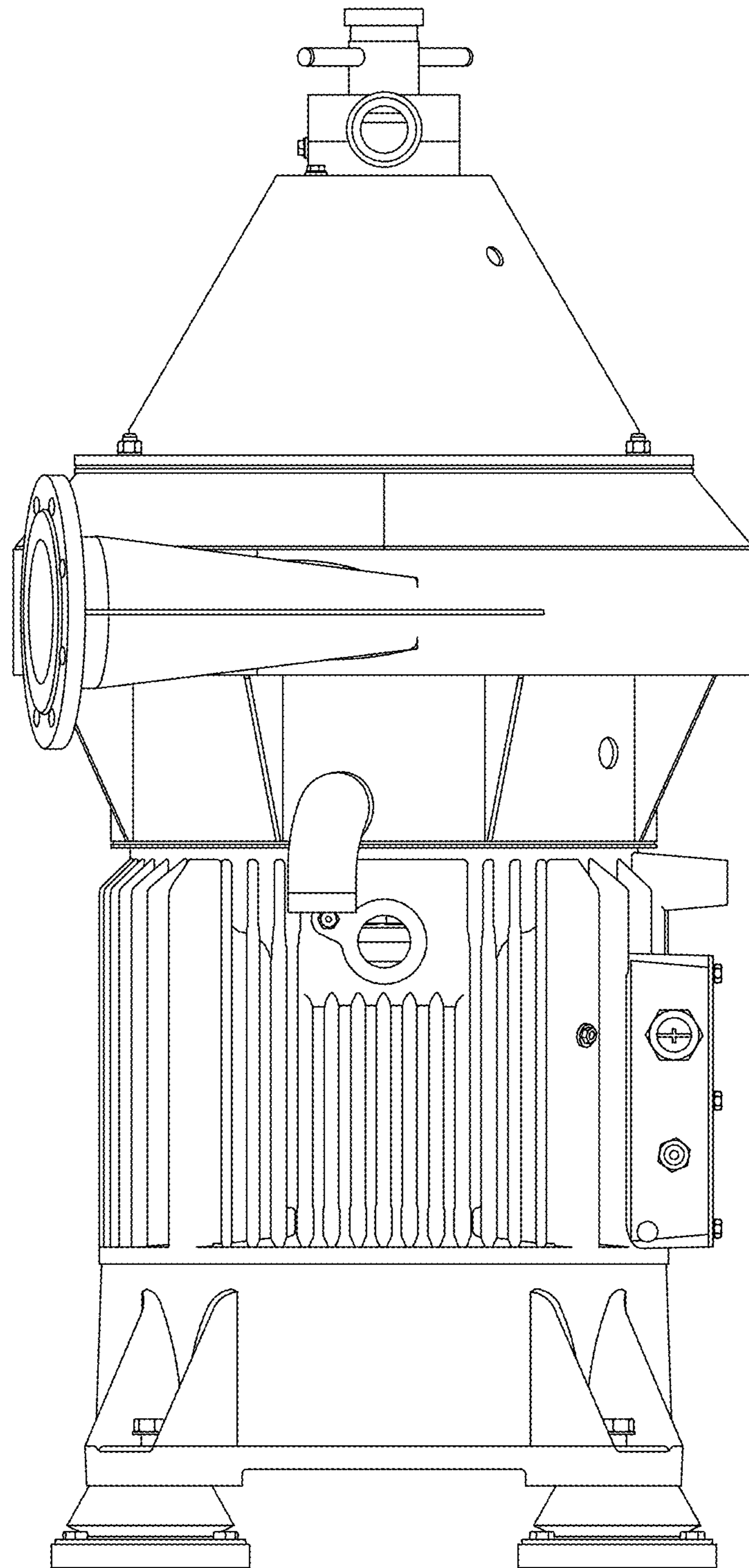

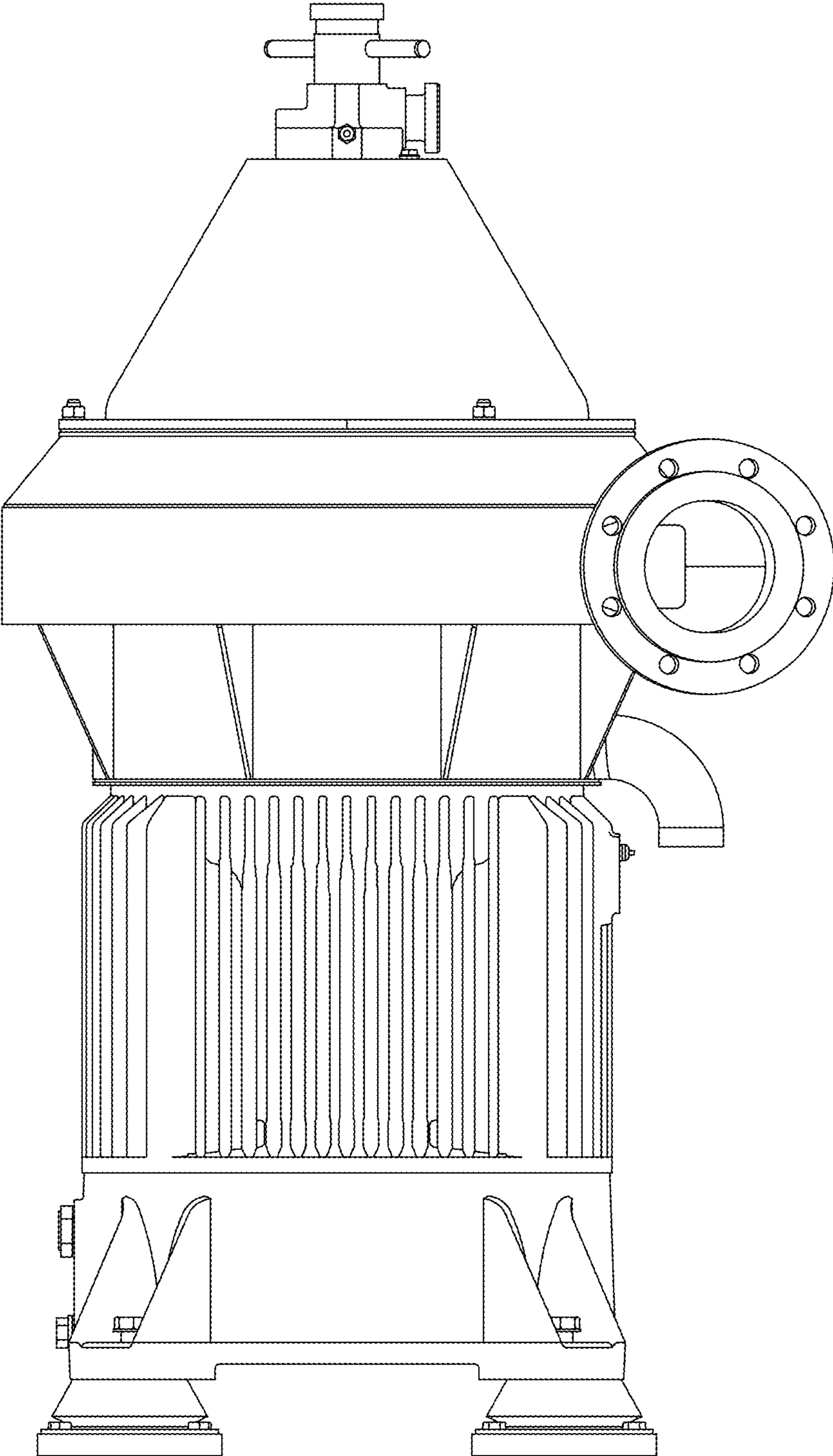

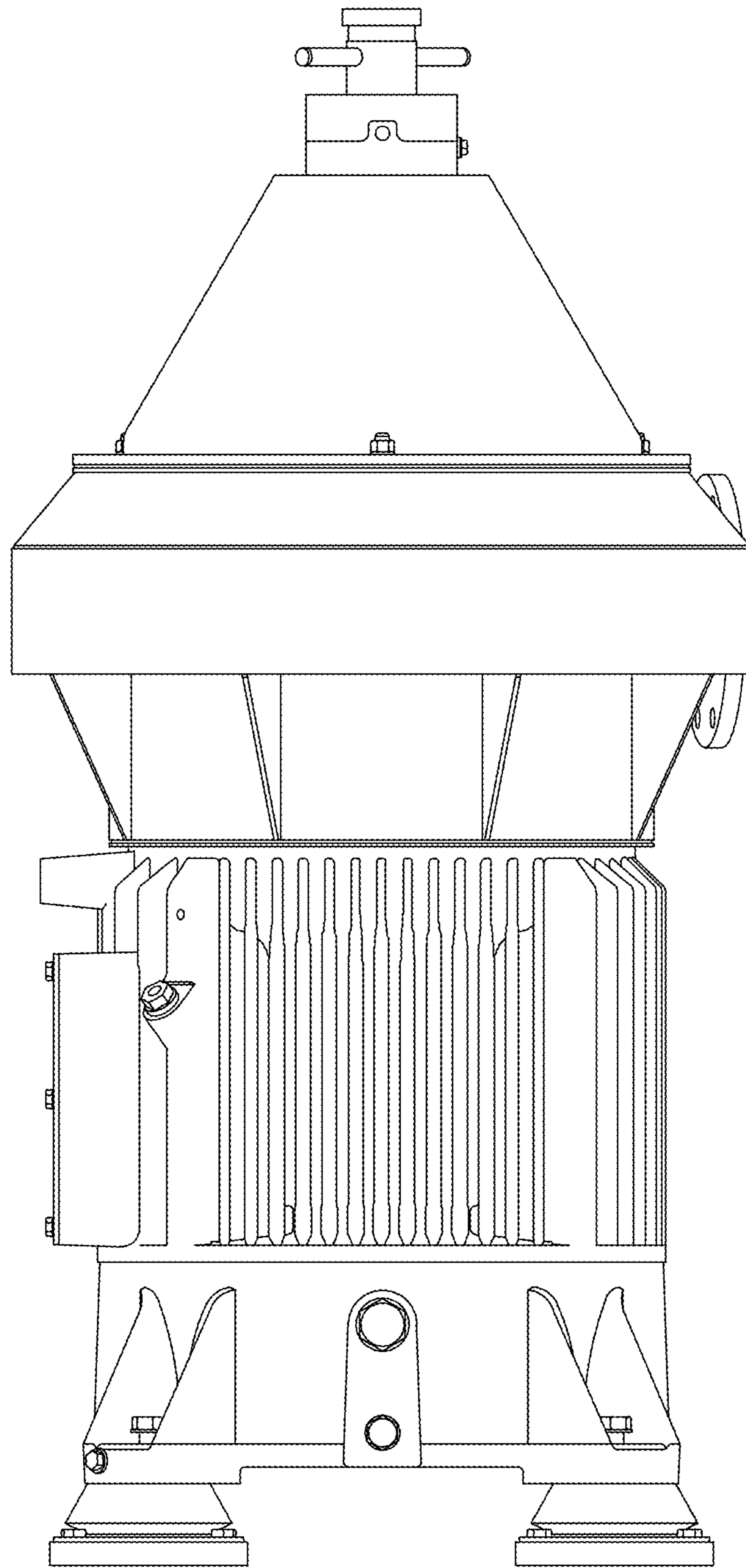

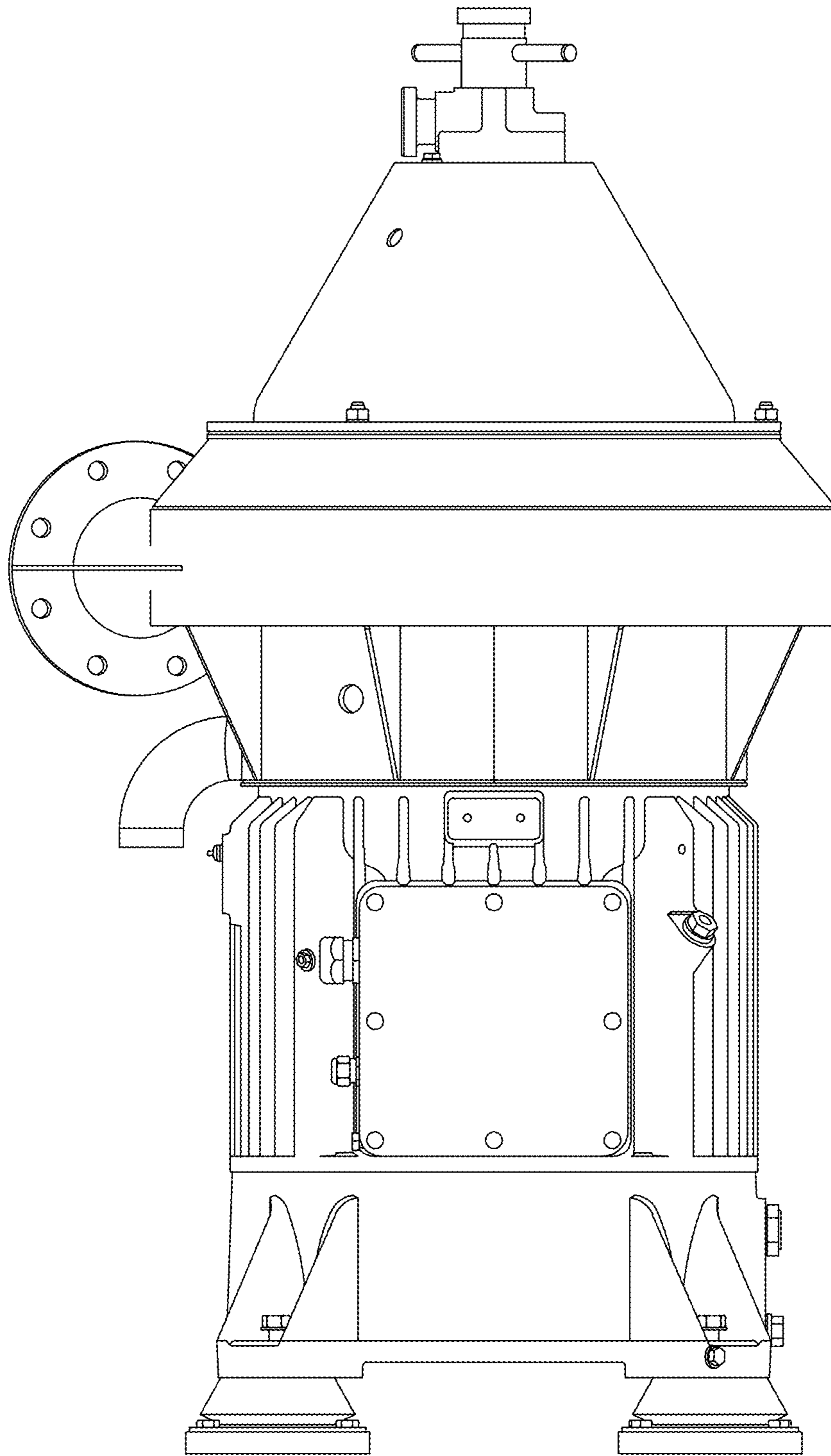

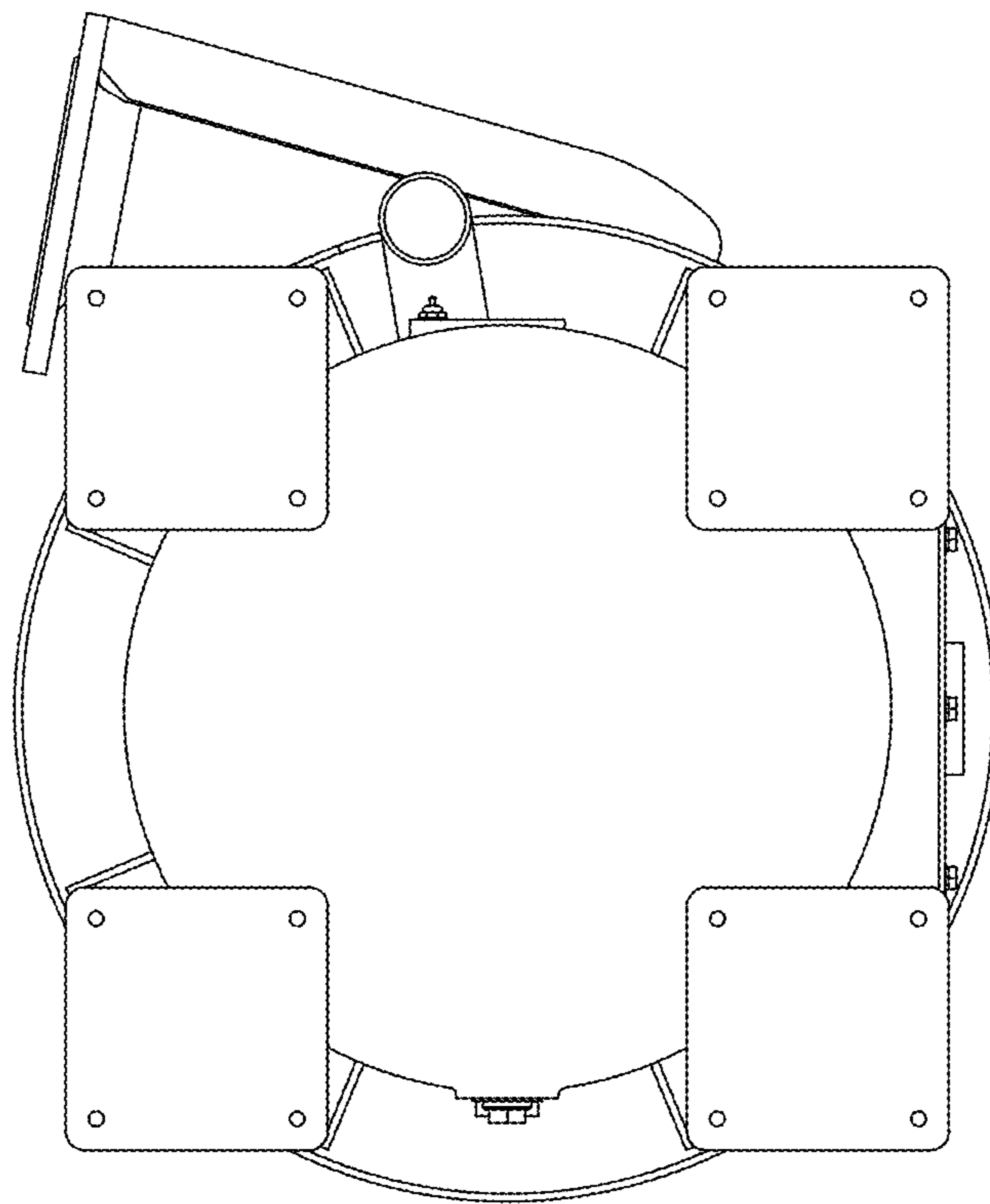

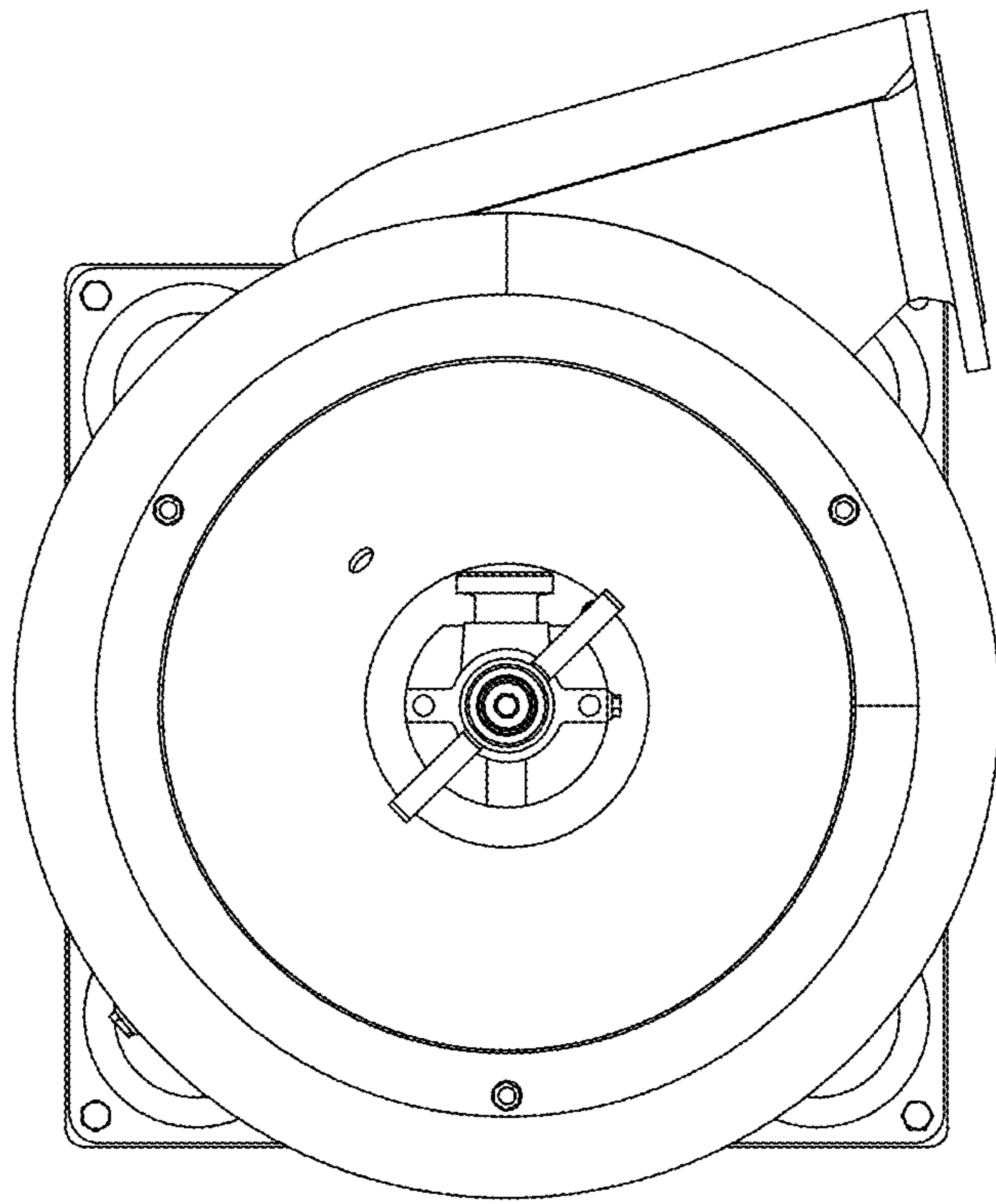

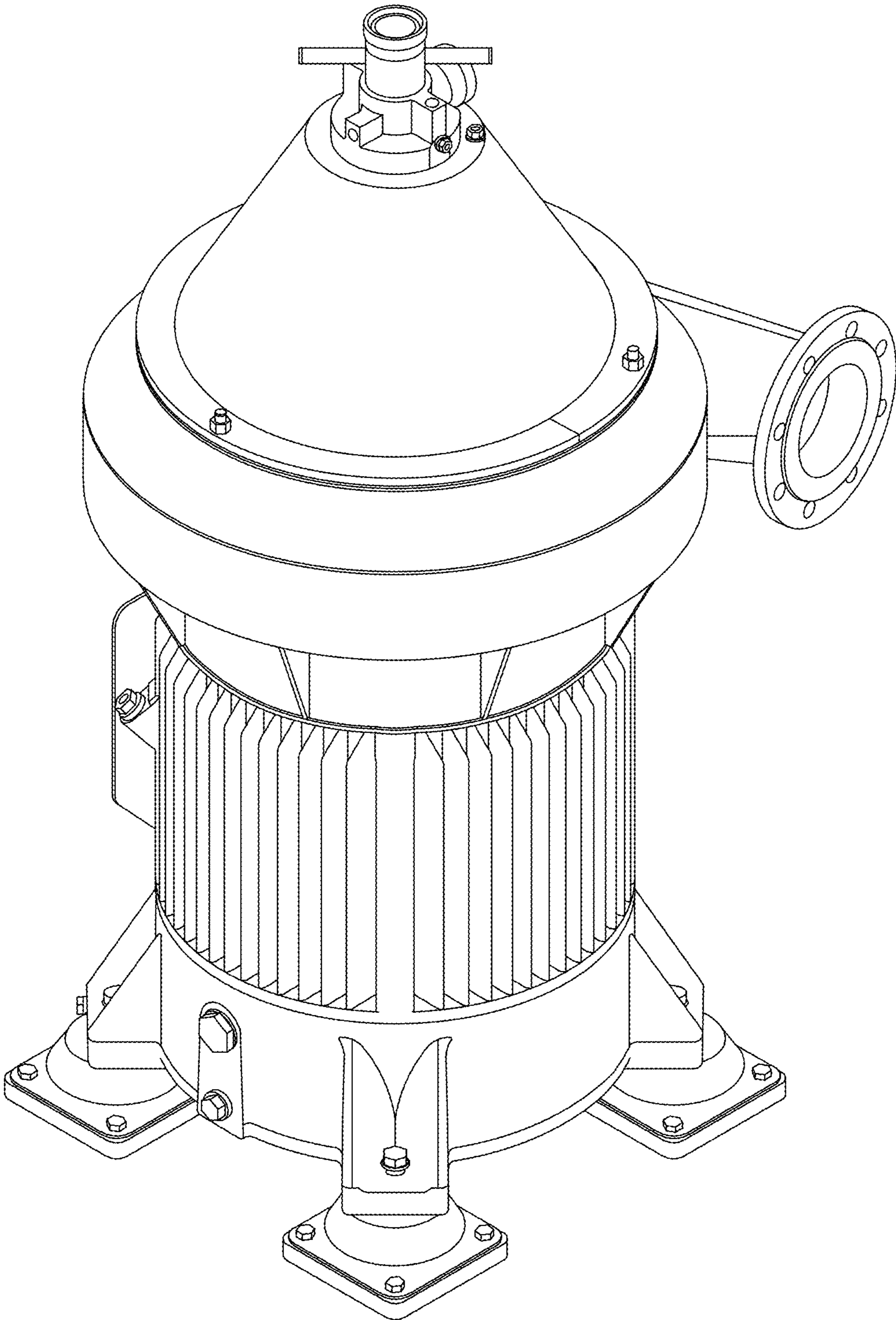
