FIG. 5 is a side elevational view thereof;

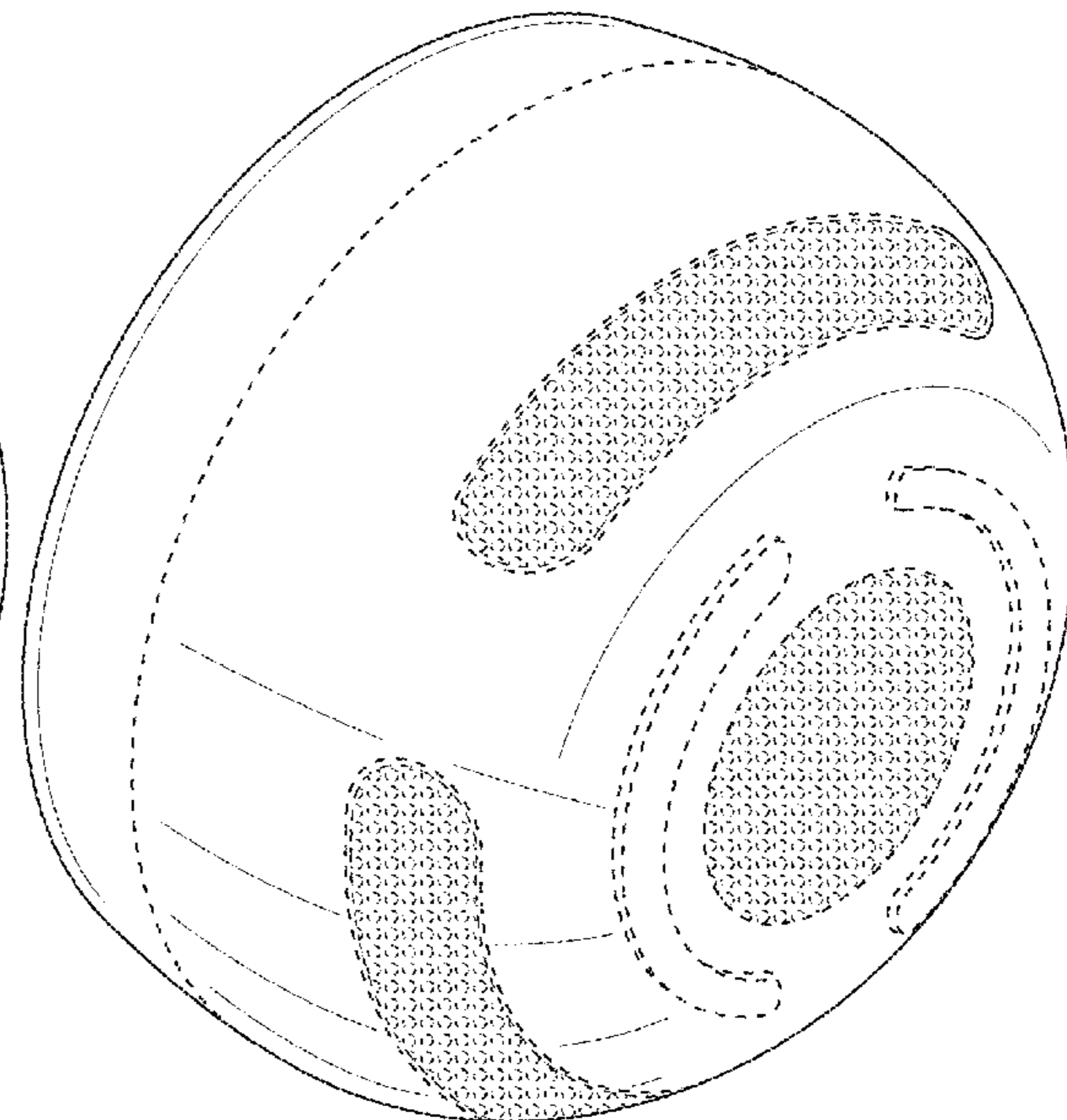
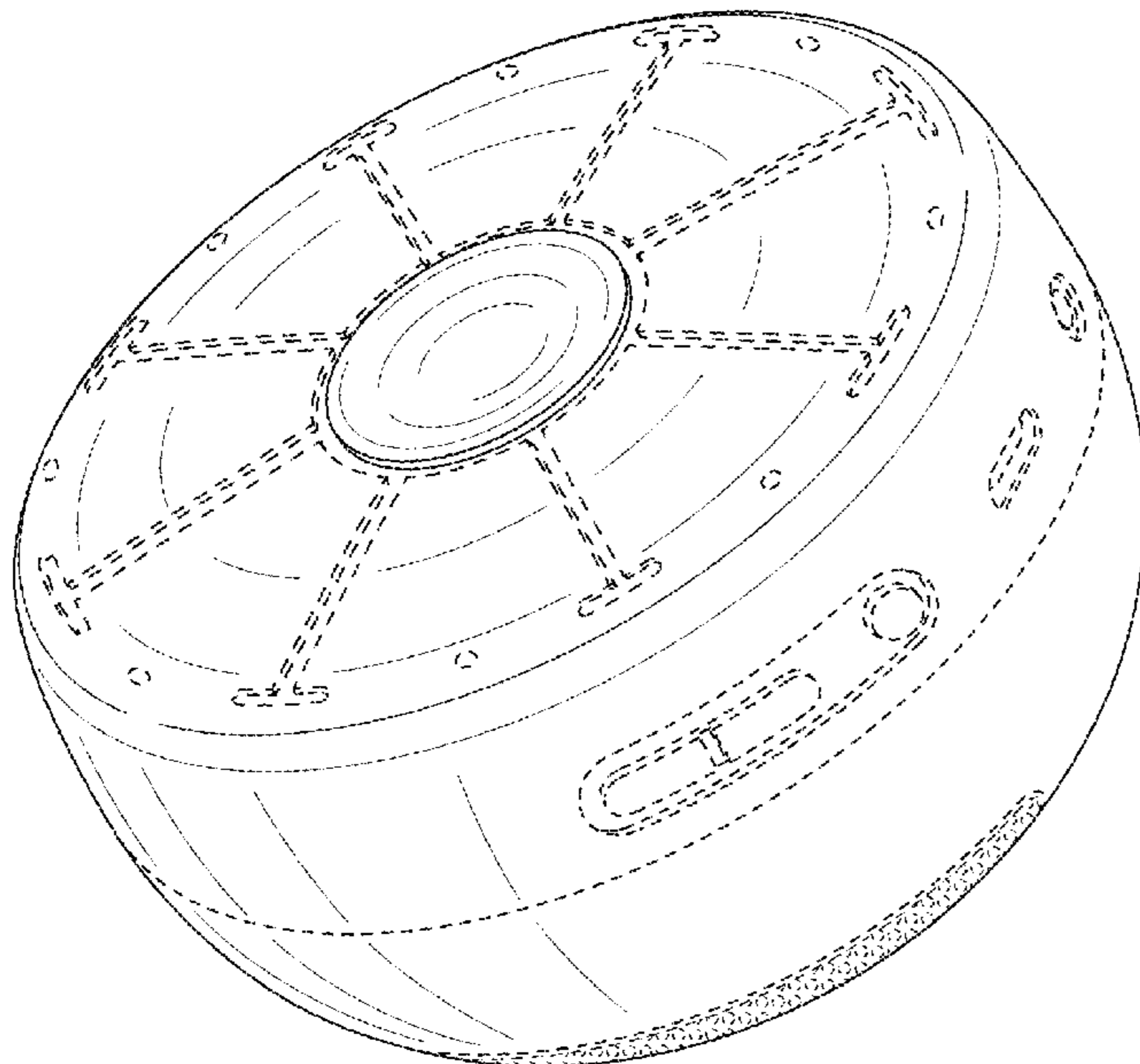
FIG. 6 is a side elevational view thereof;

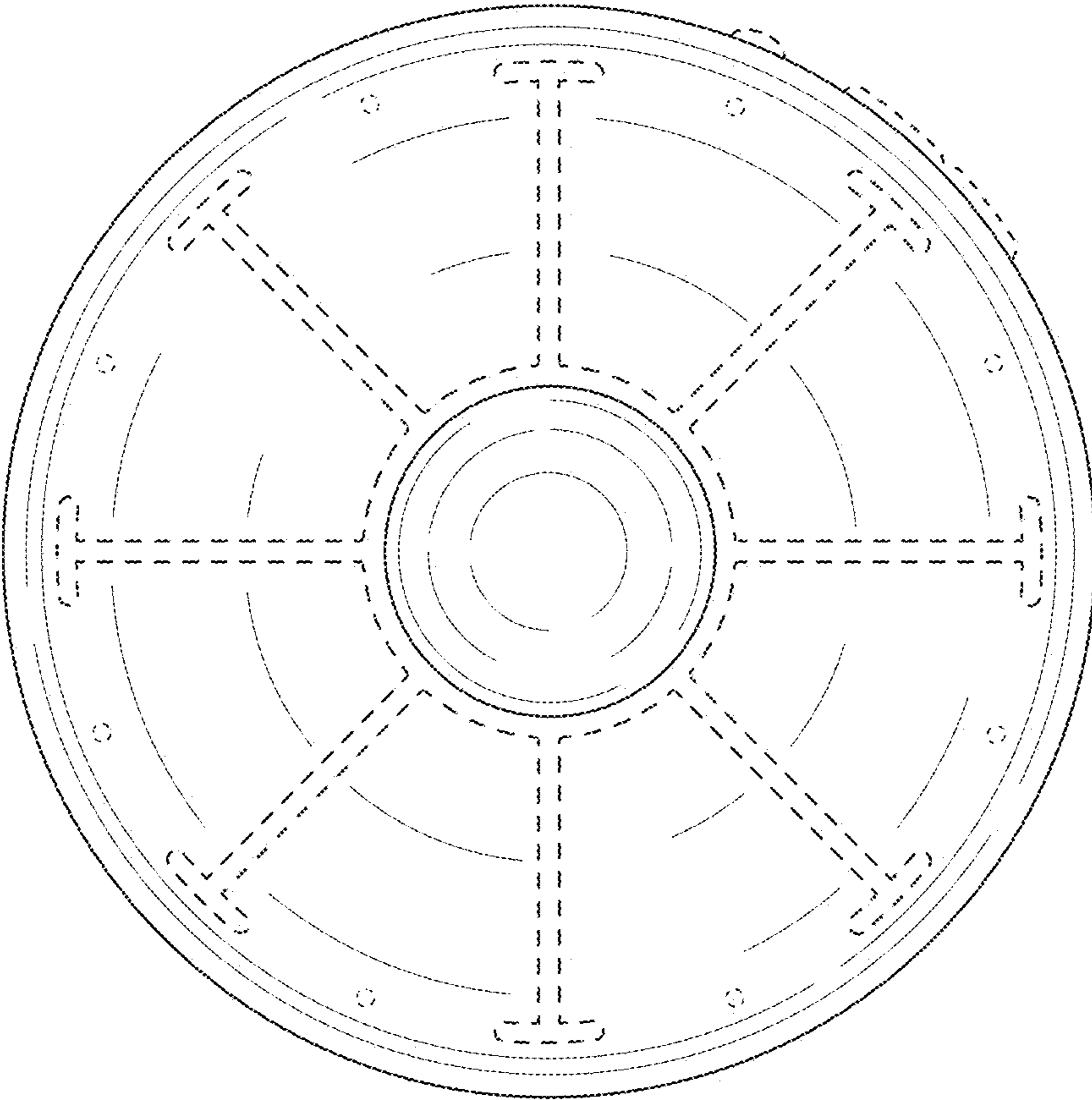

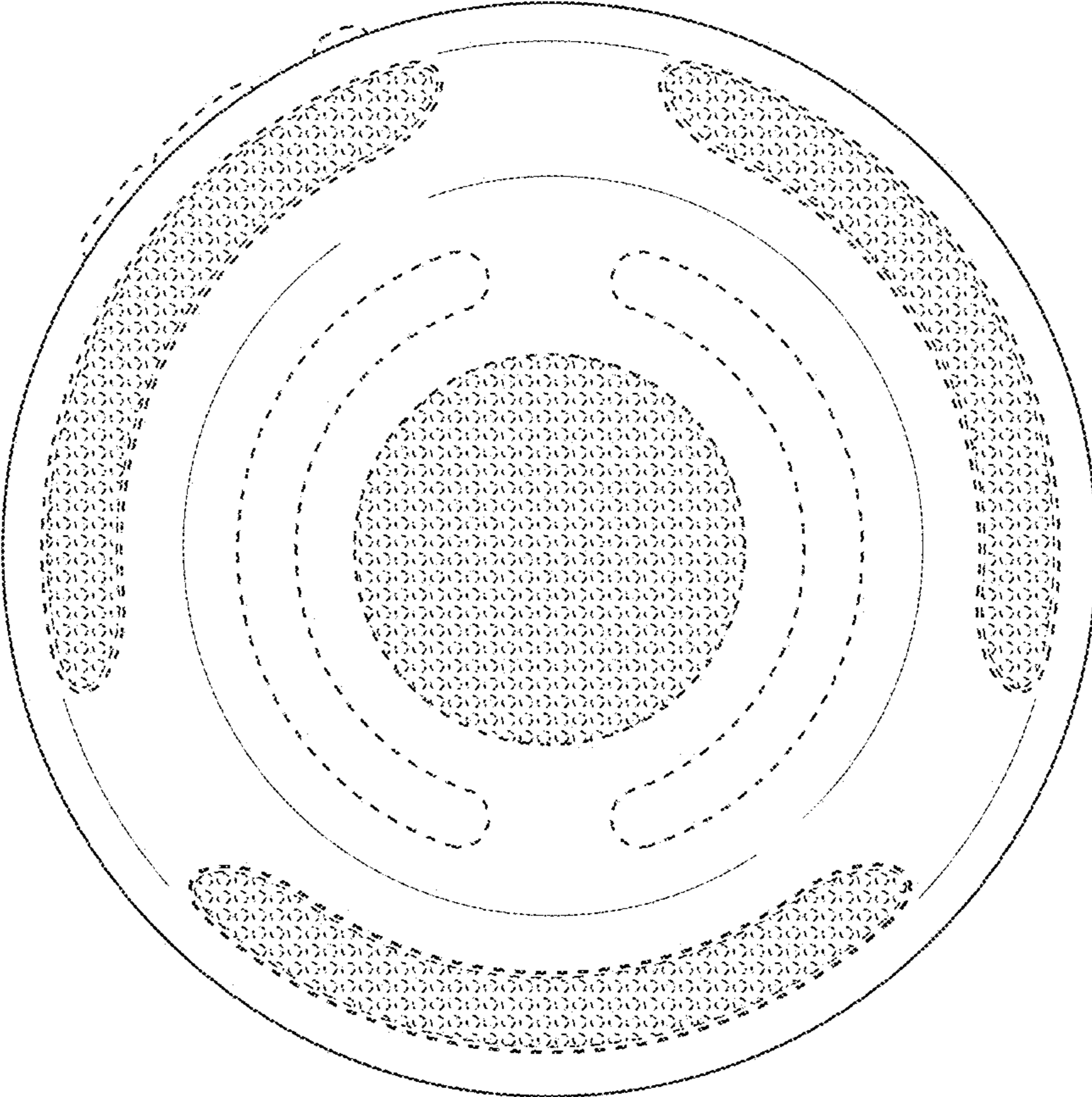

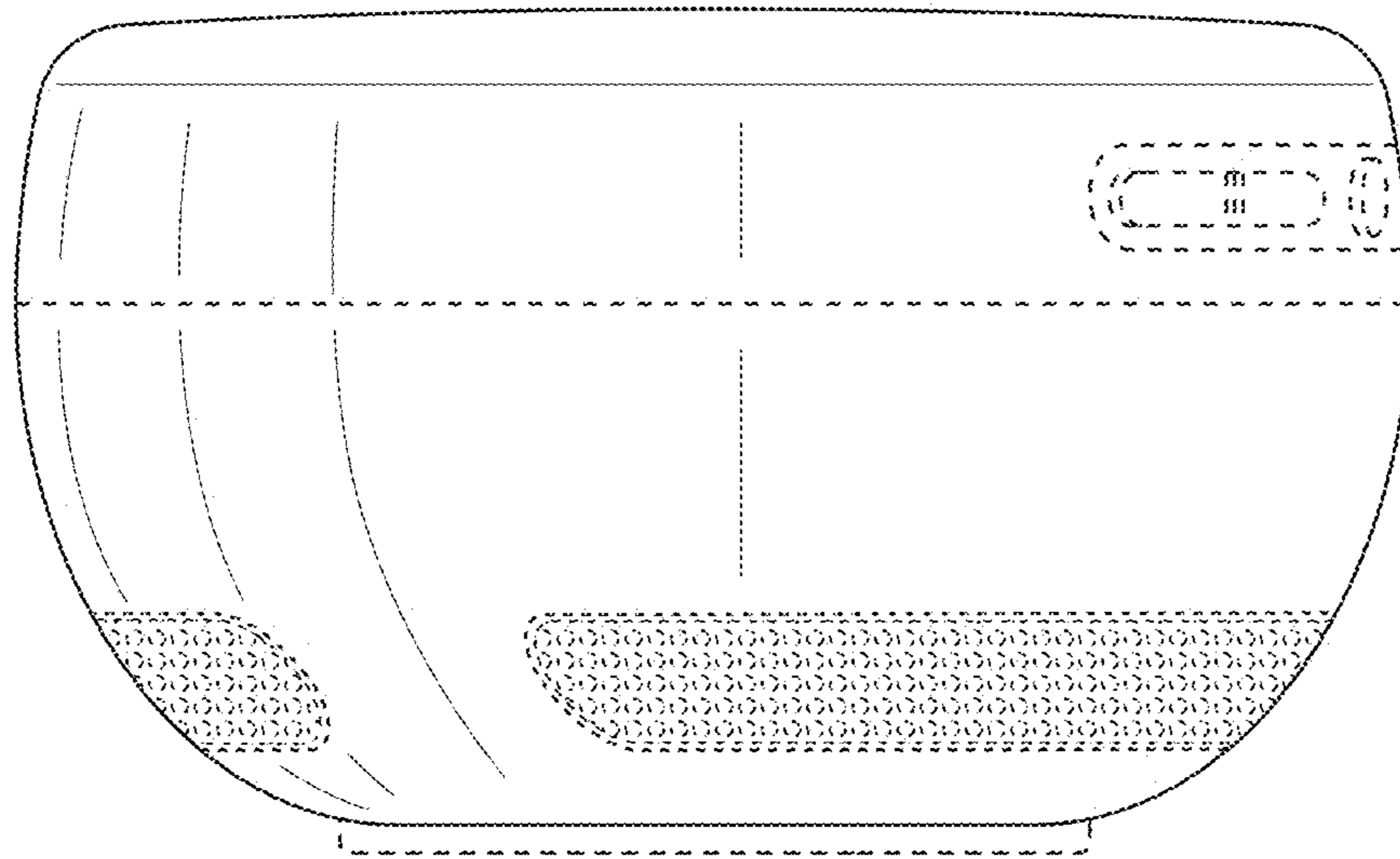

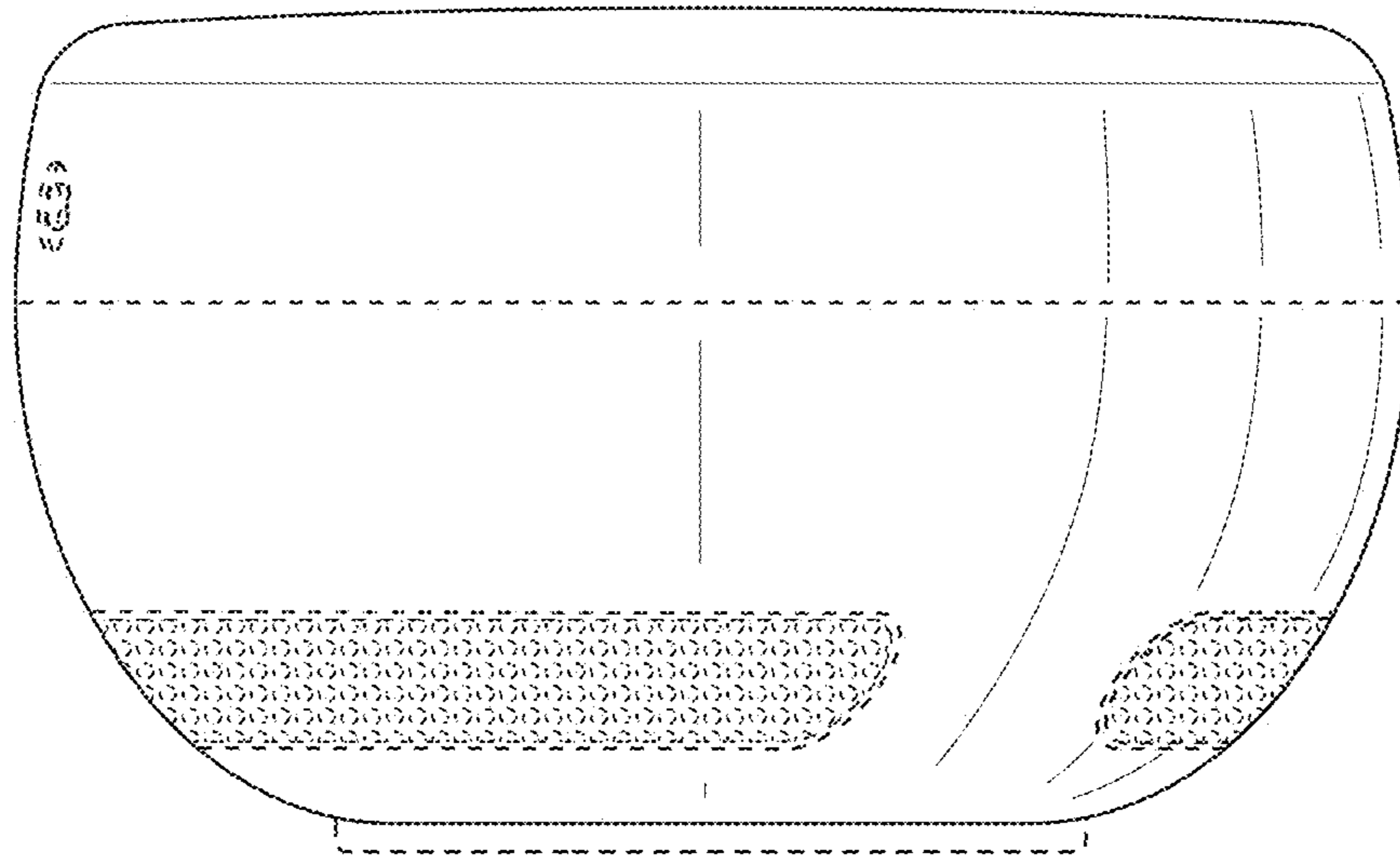

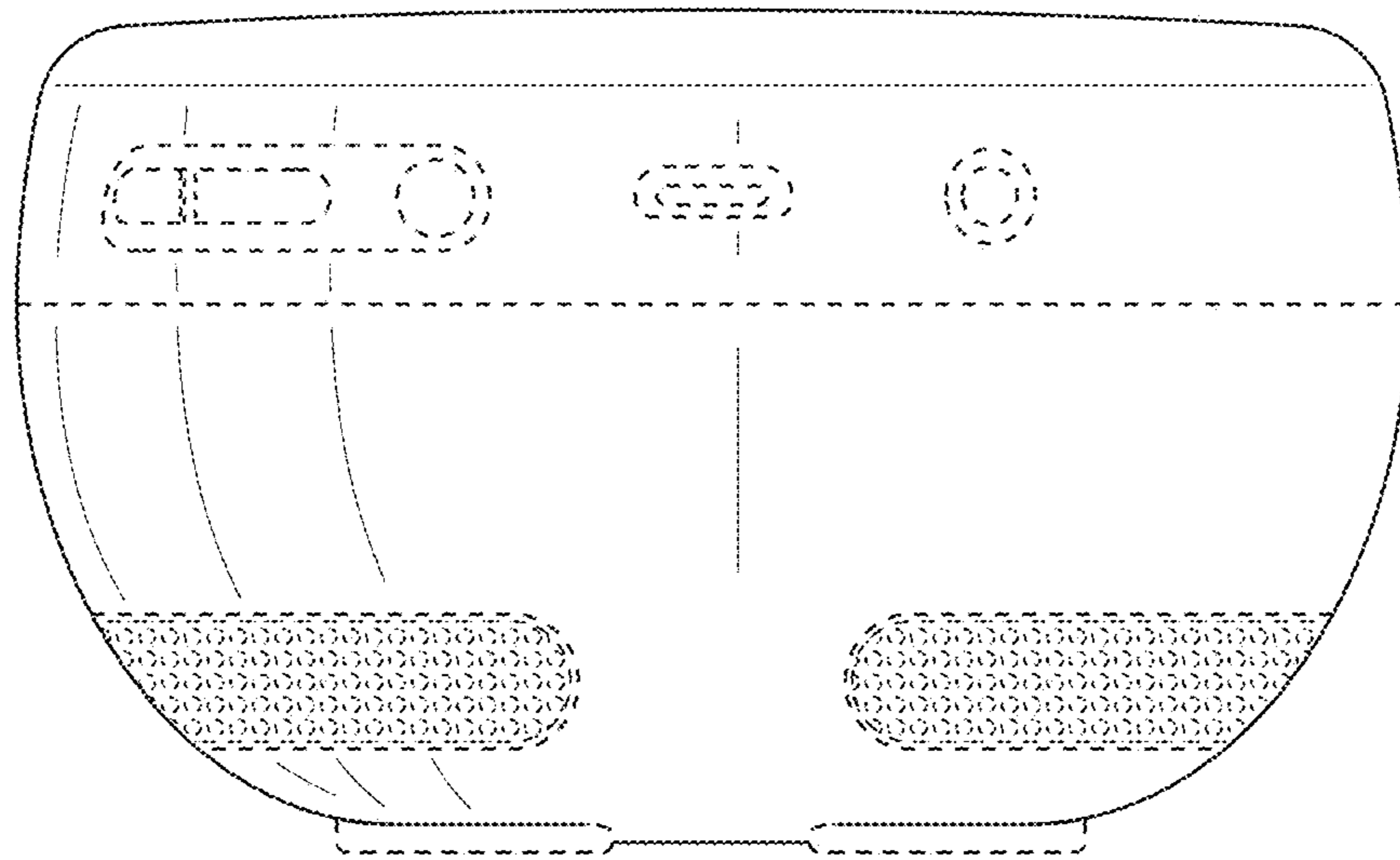

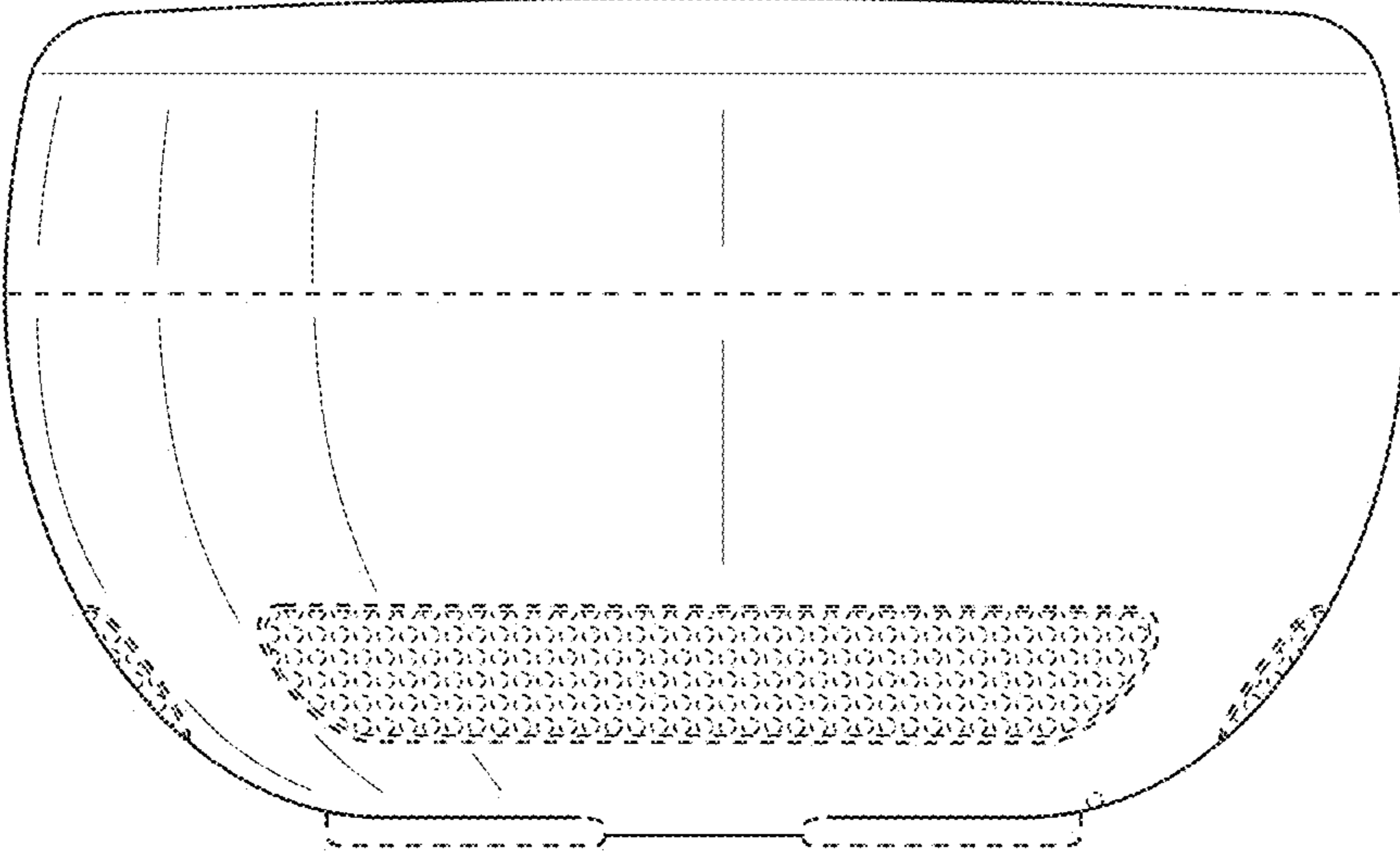

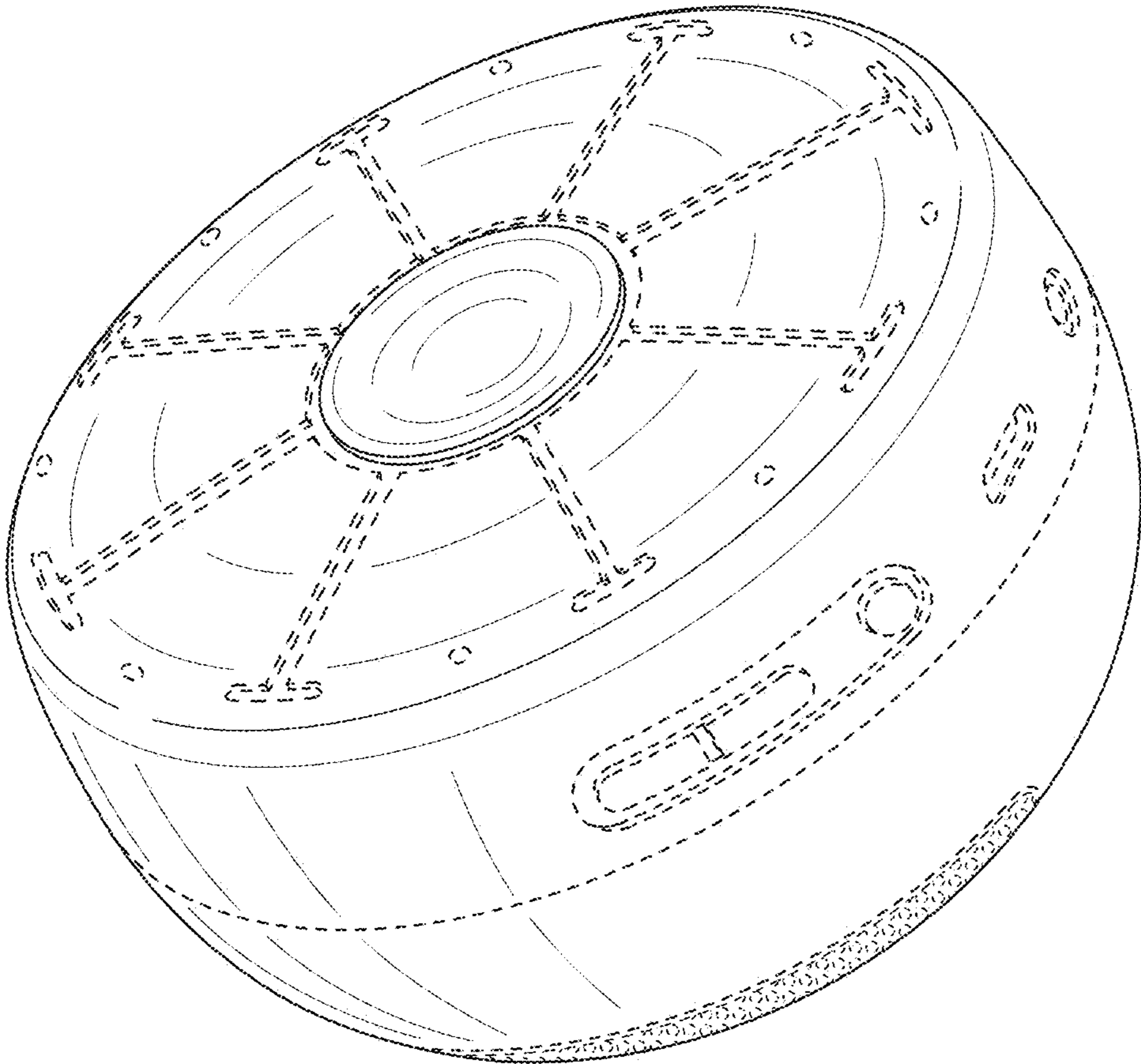

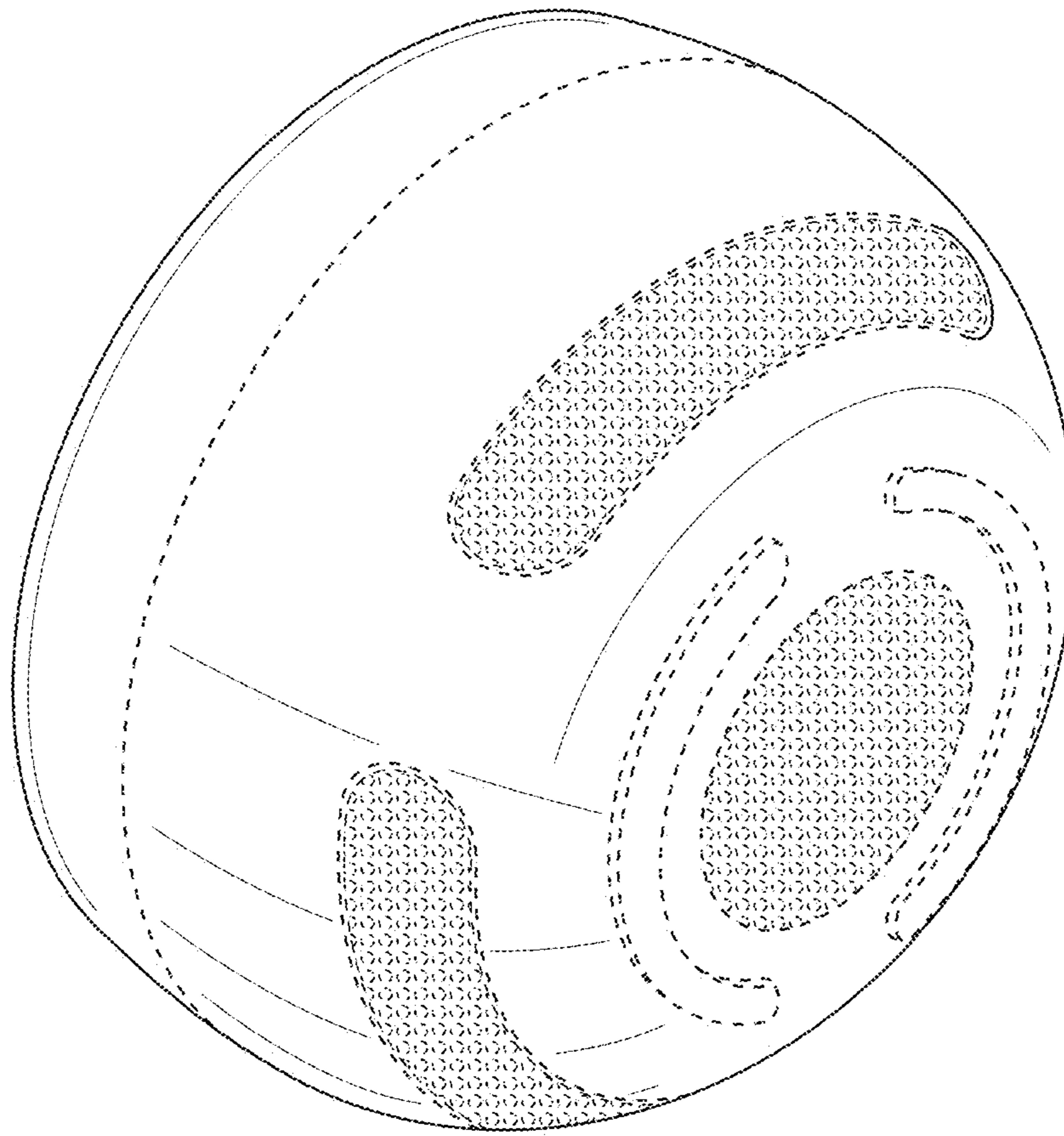
