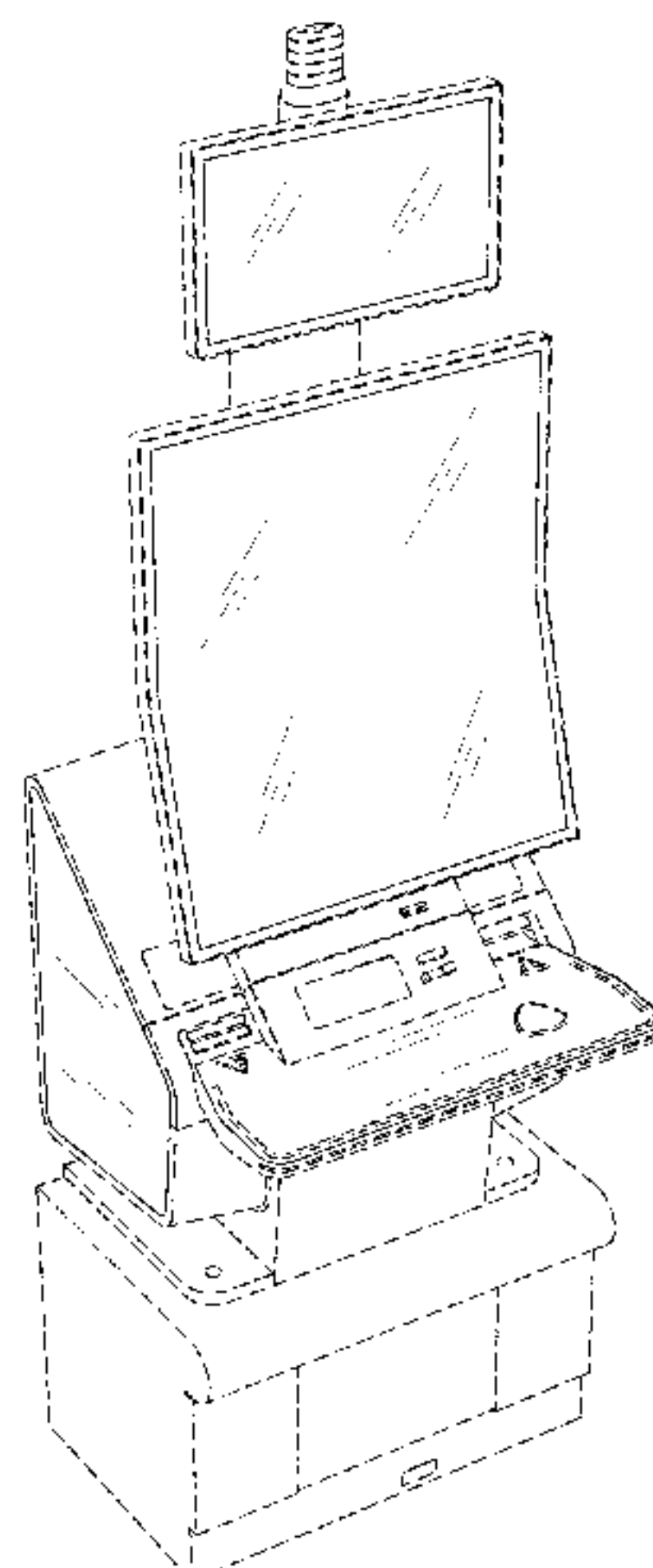

(57) **CLAIM**

We claim the ornamental design for a gaming machine, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a gaming machine showing our new design;

FIG. 2 is a front view of the gaming machine shown in FIG. 1;

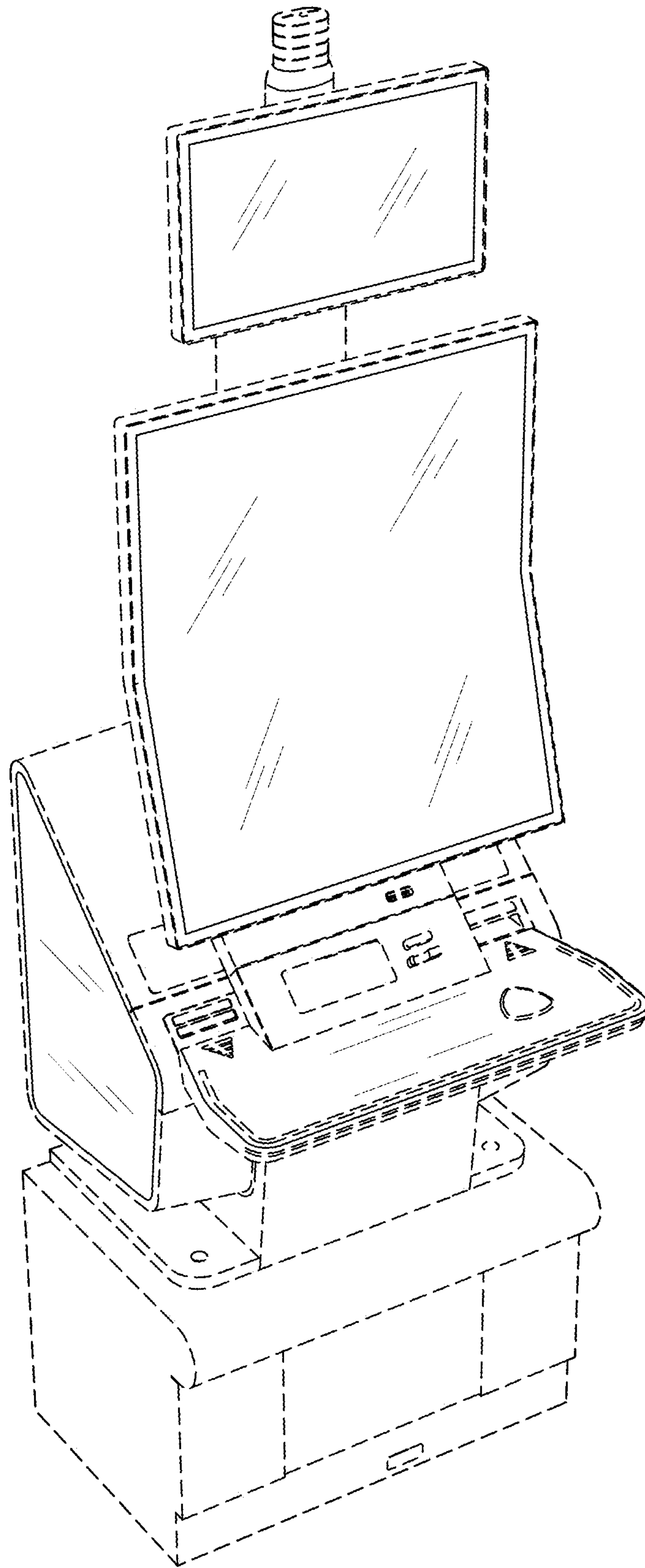

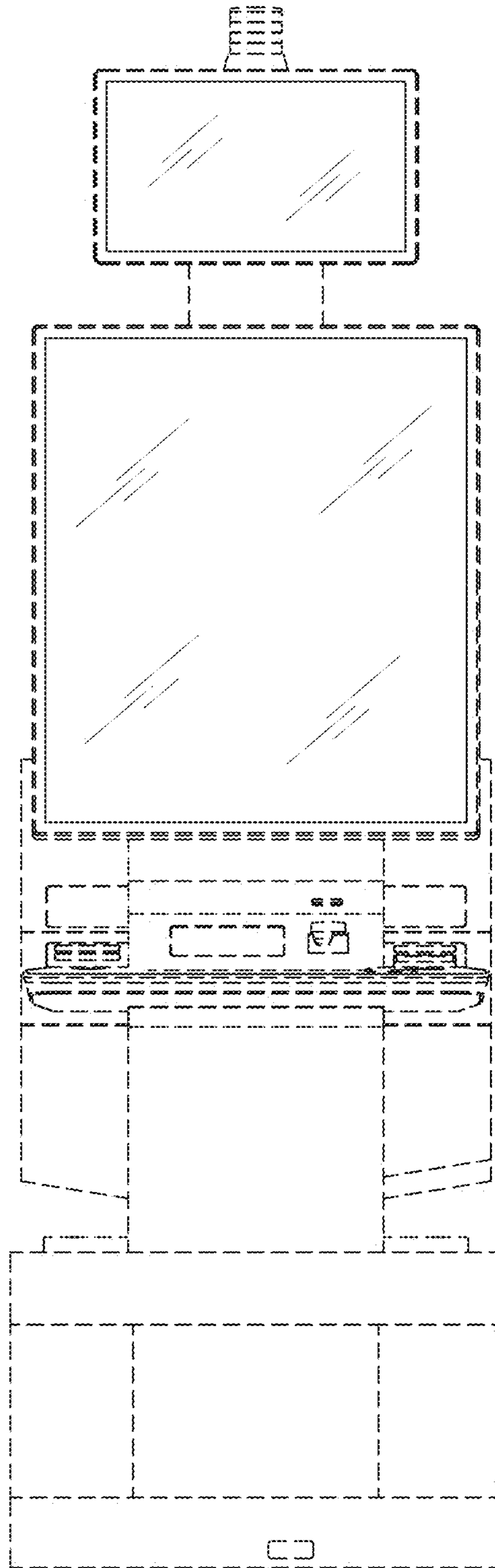

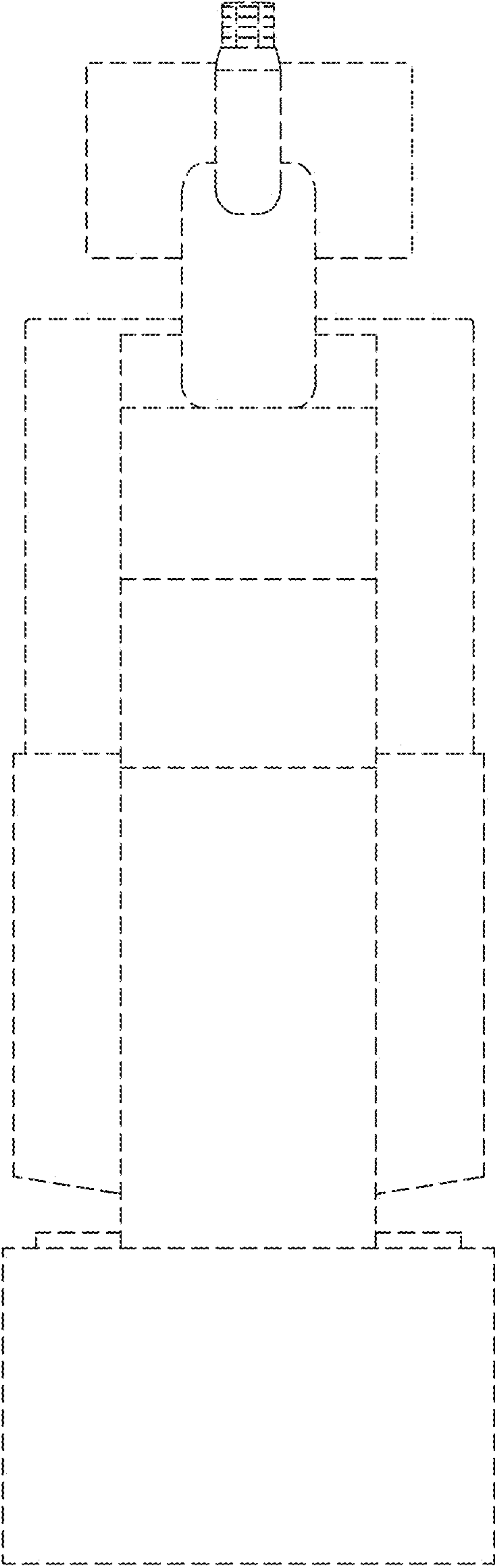

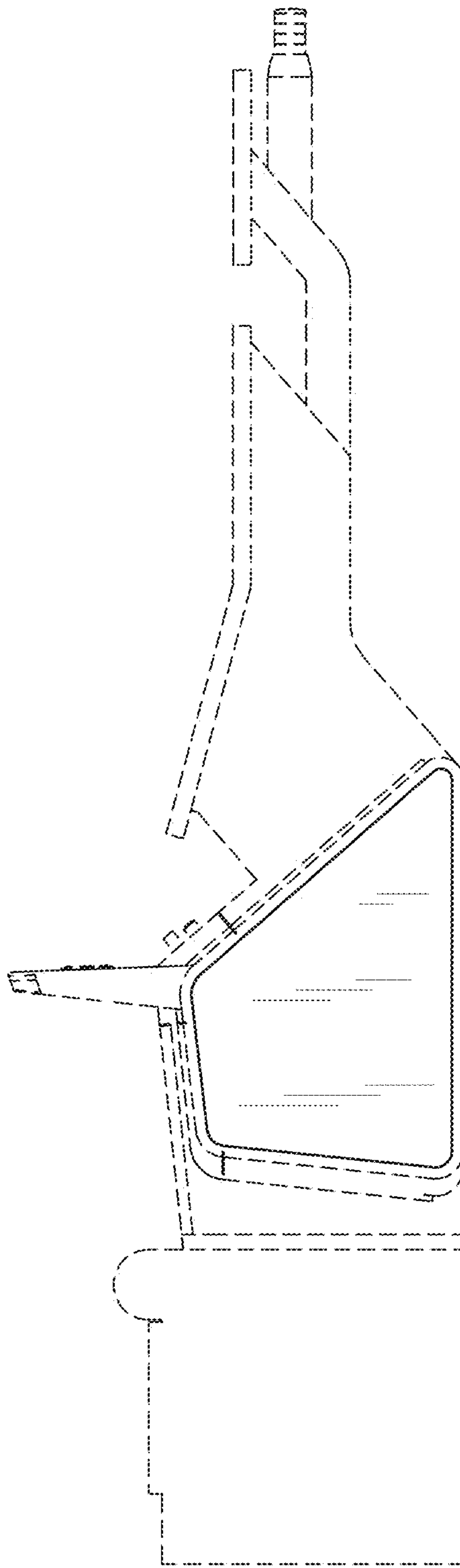

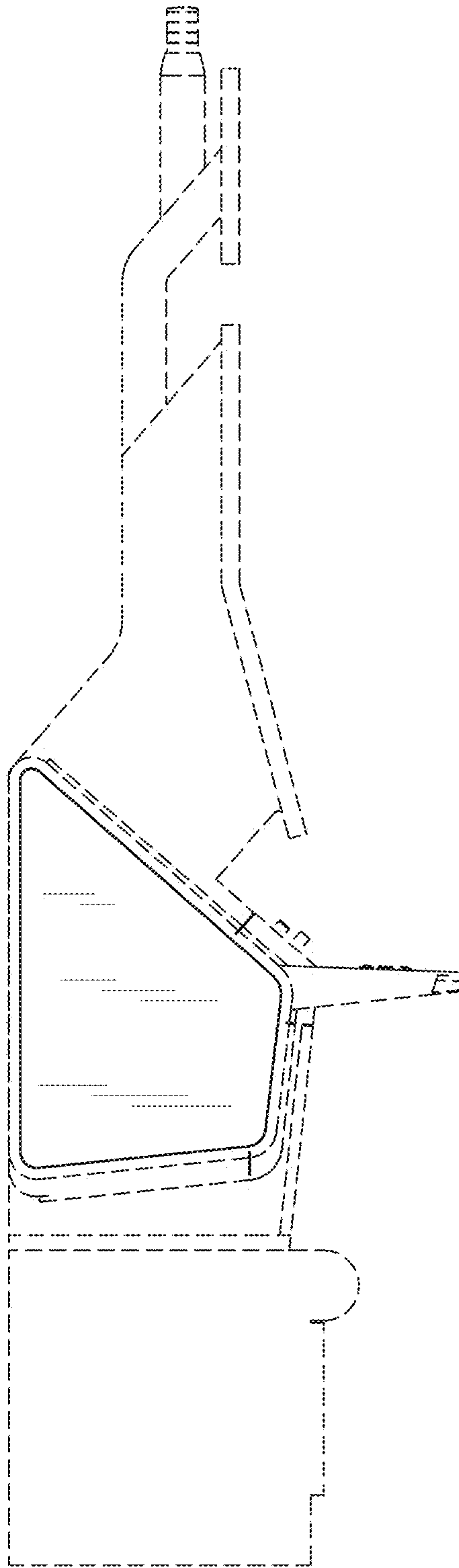

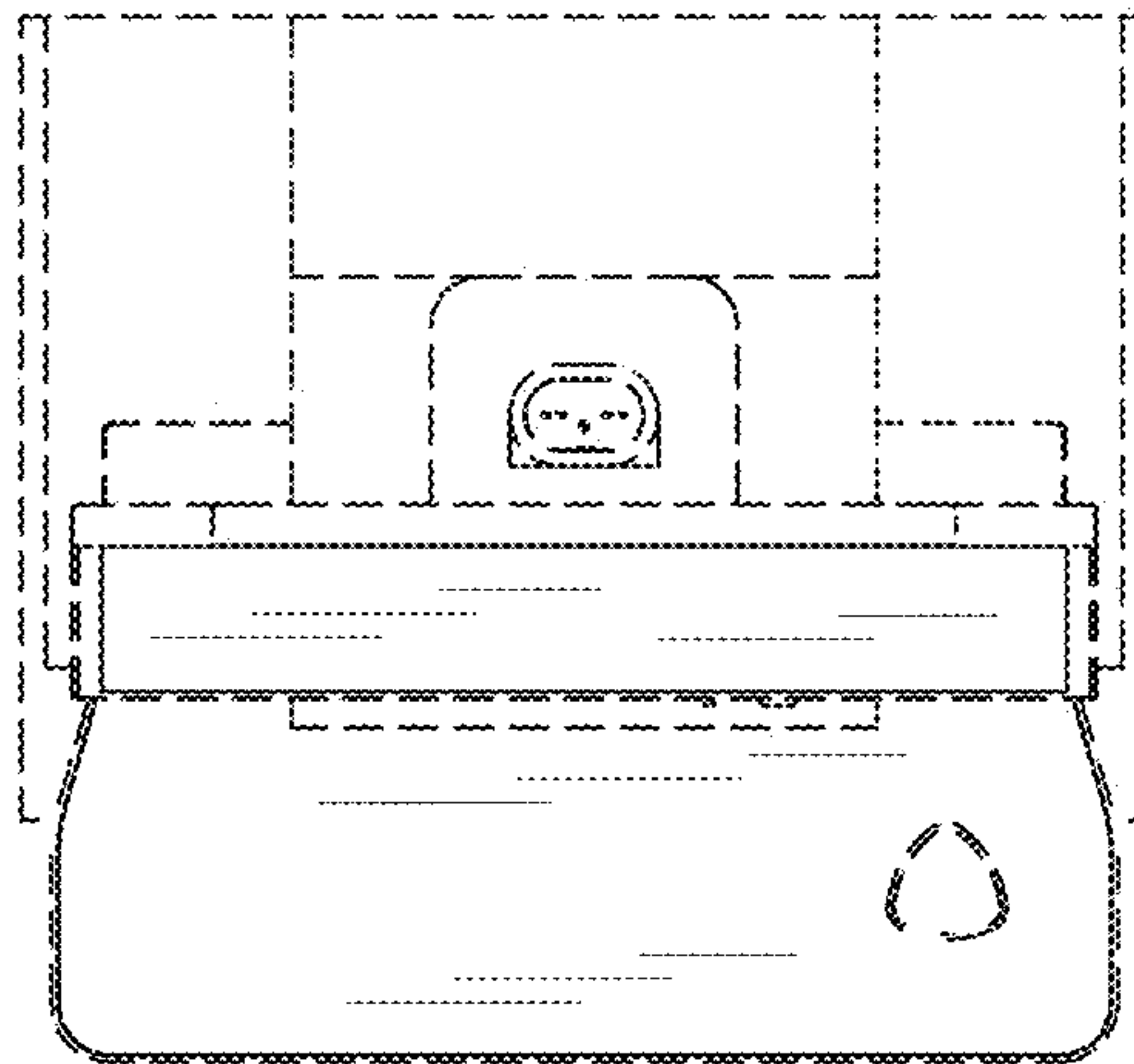

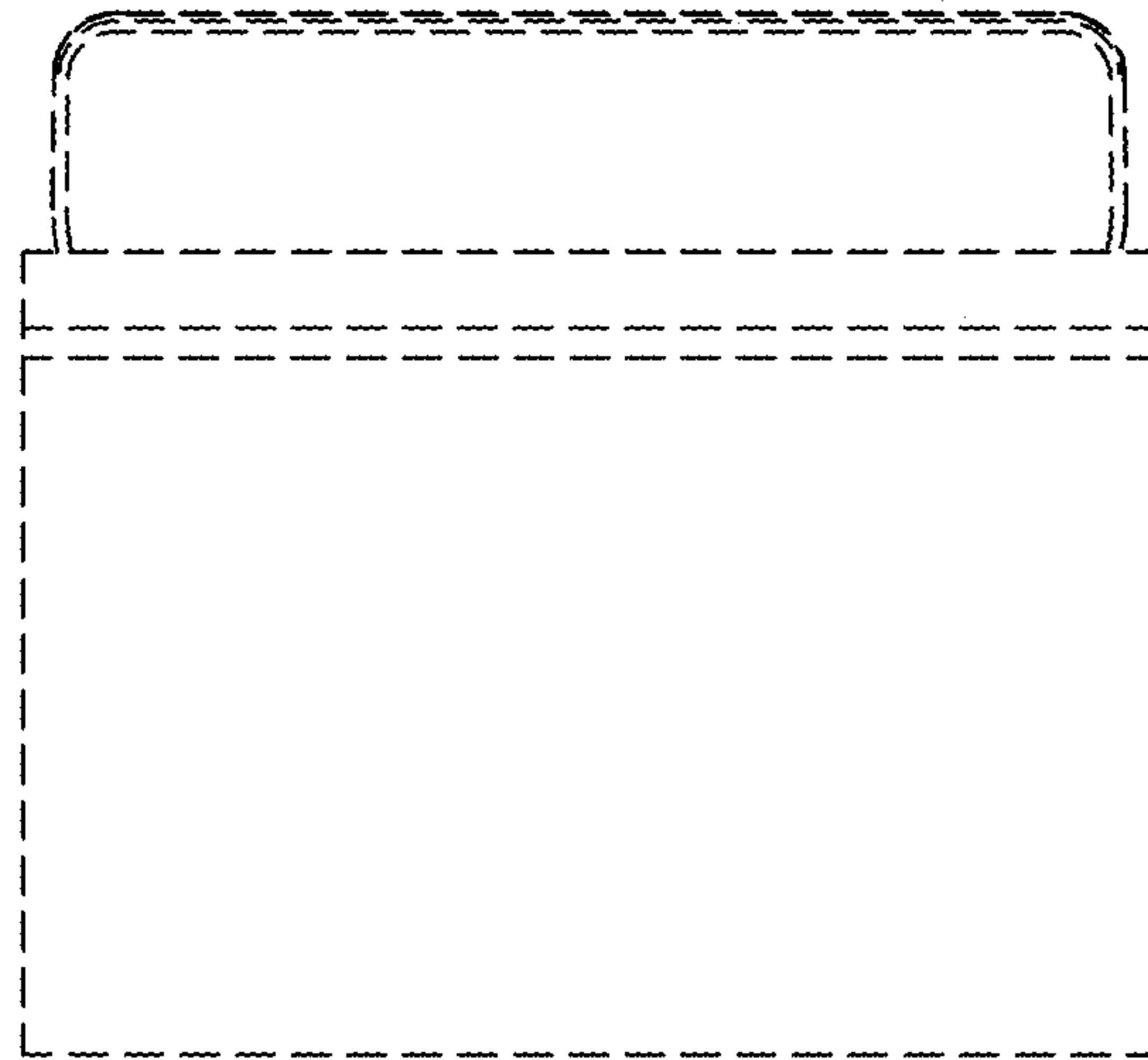

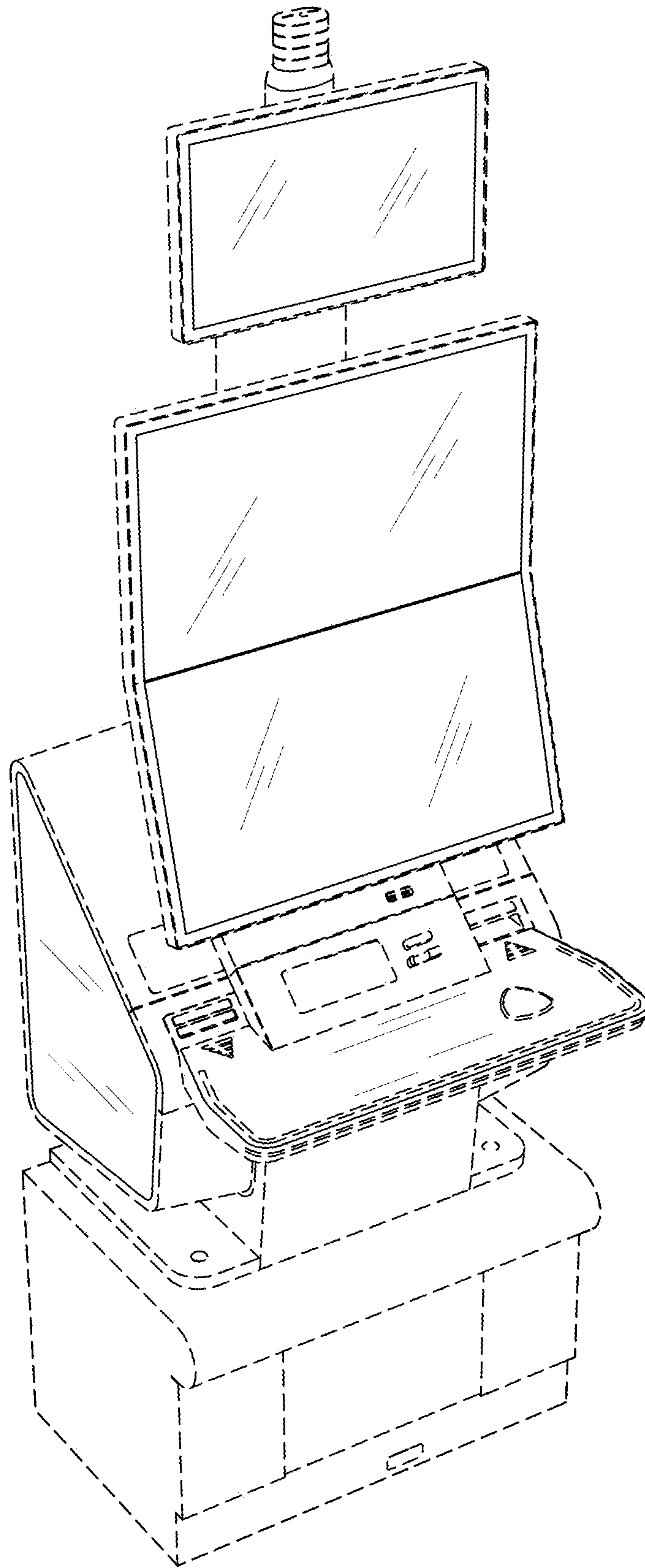

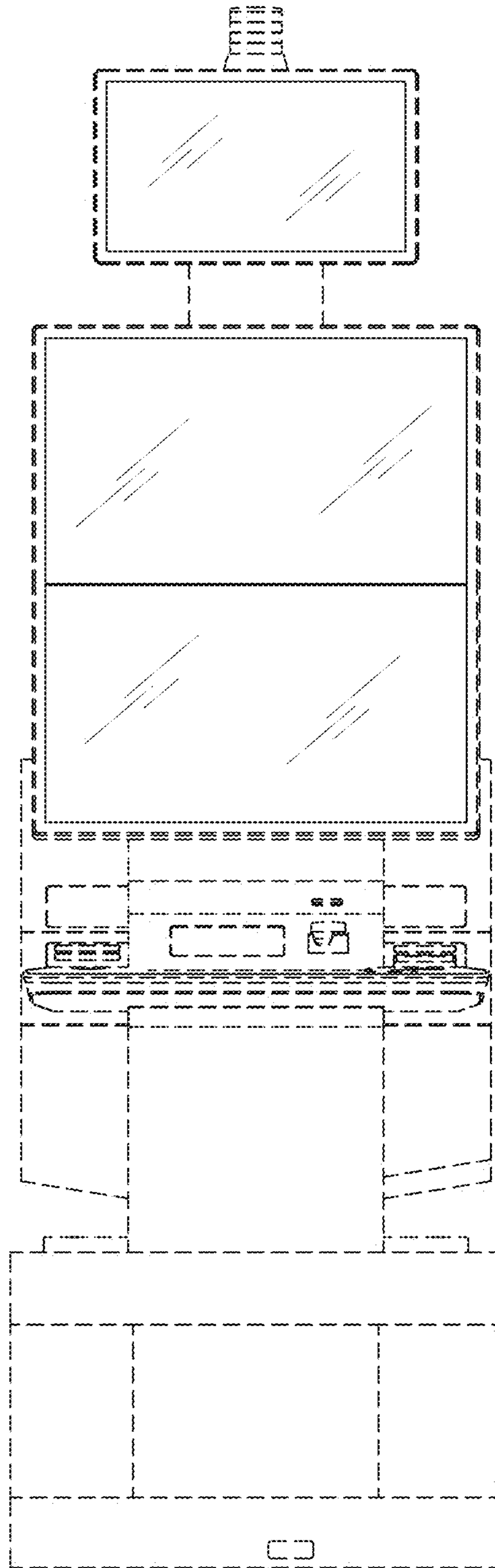

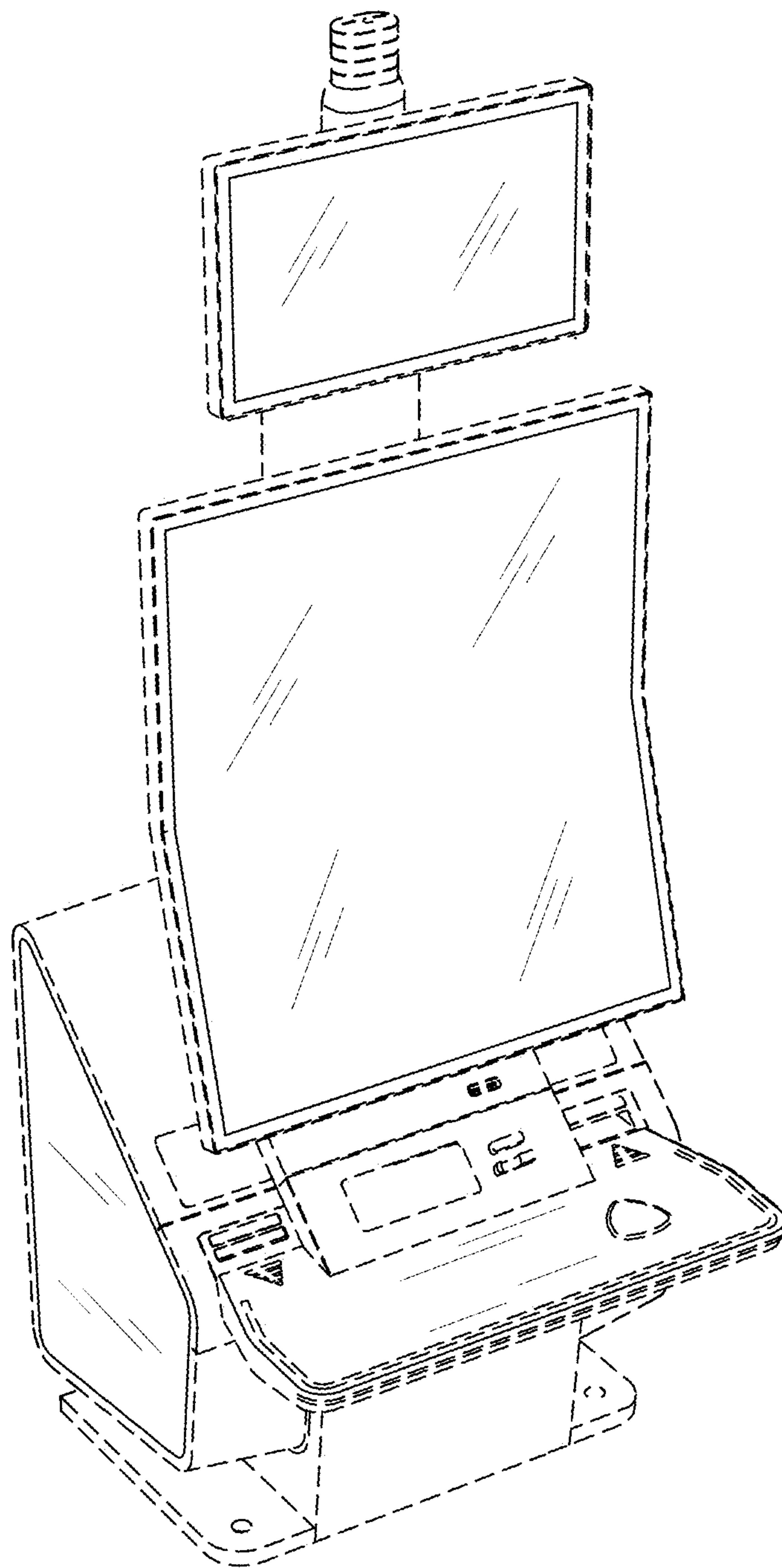

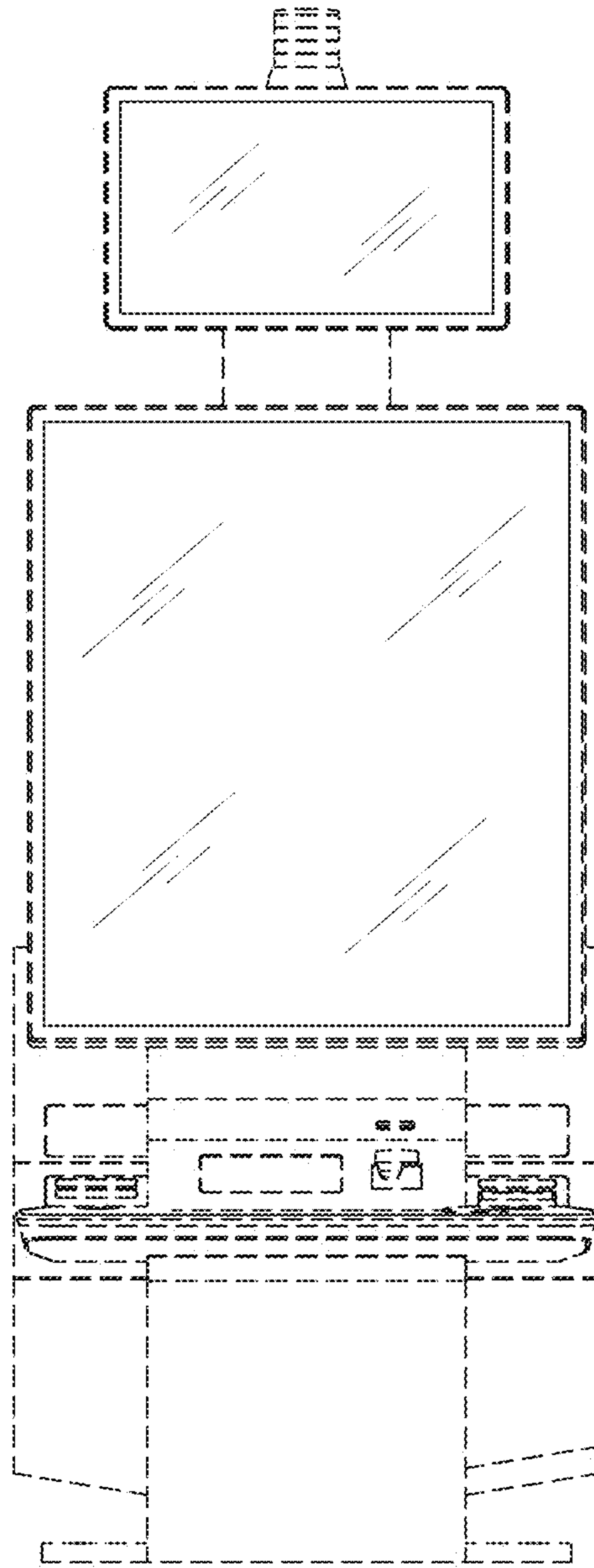

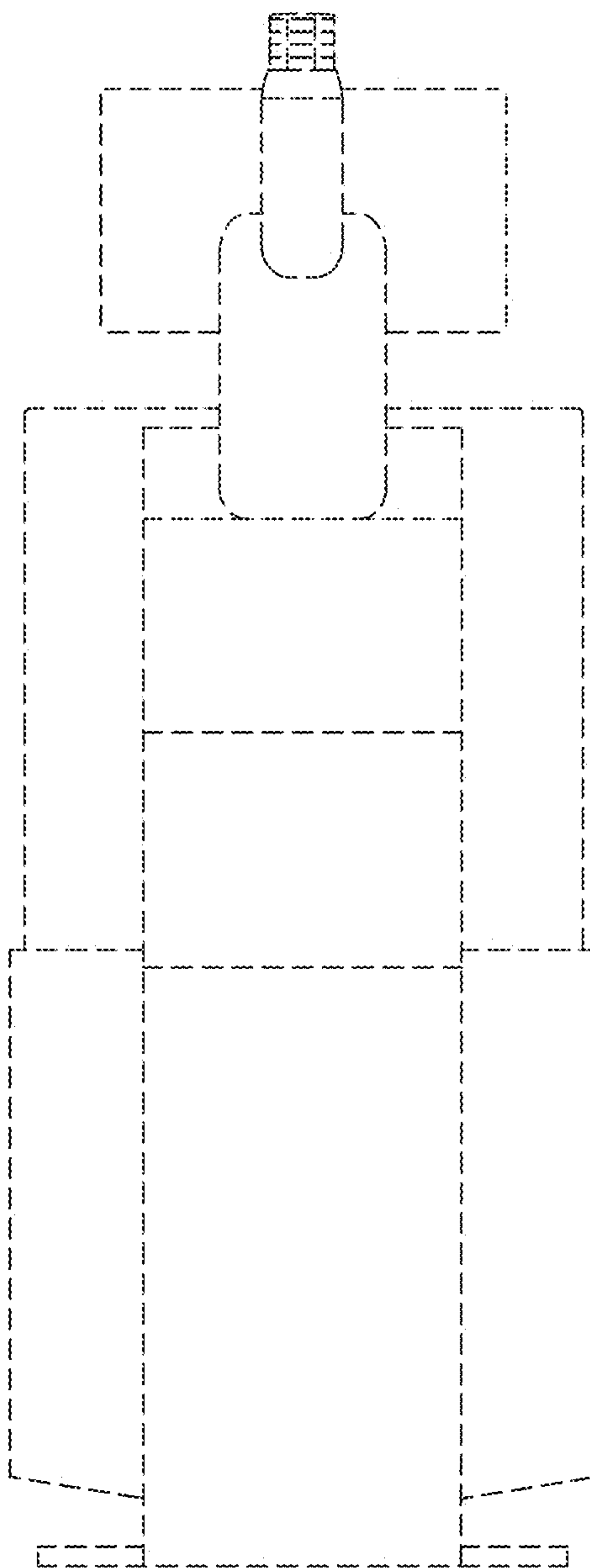

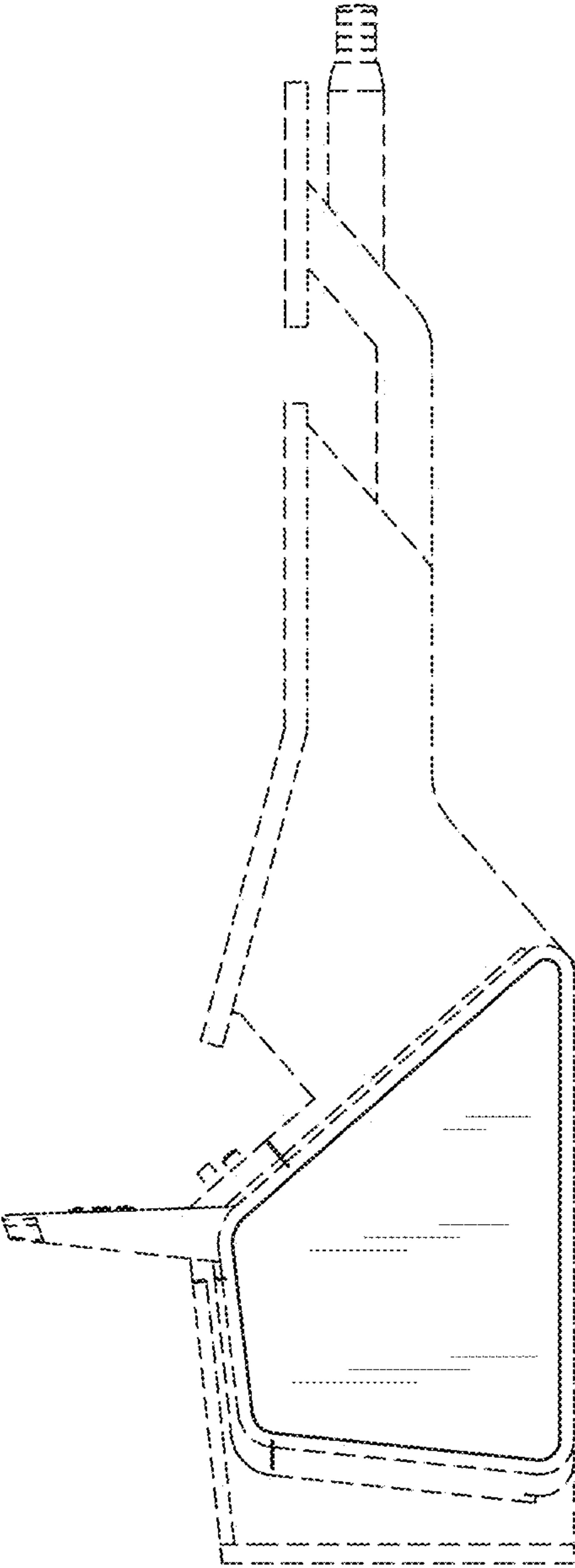

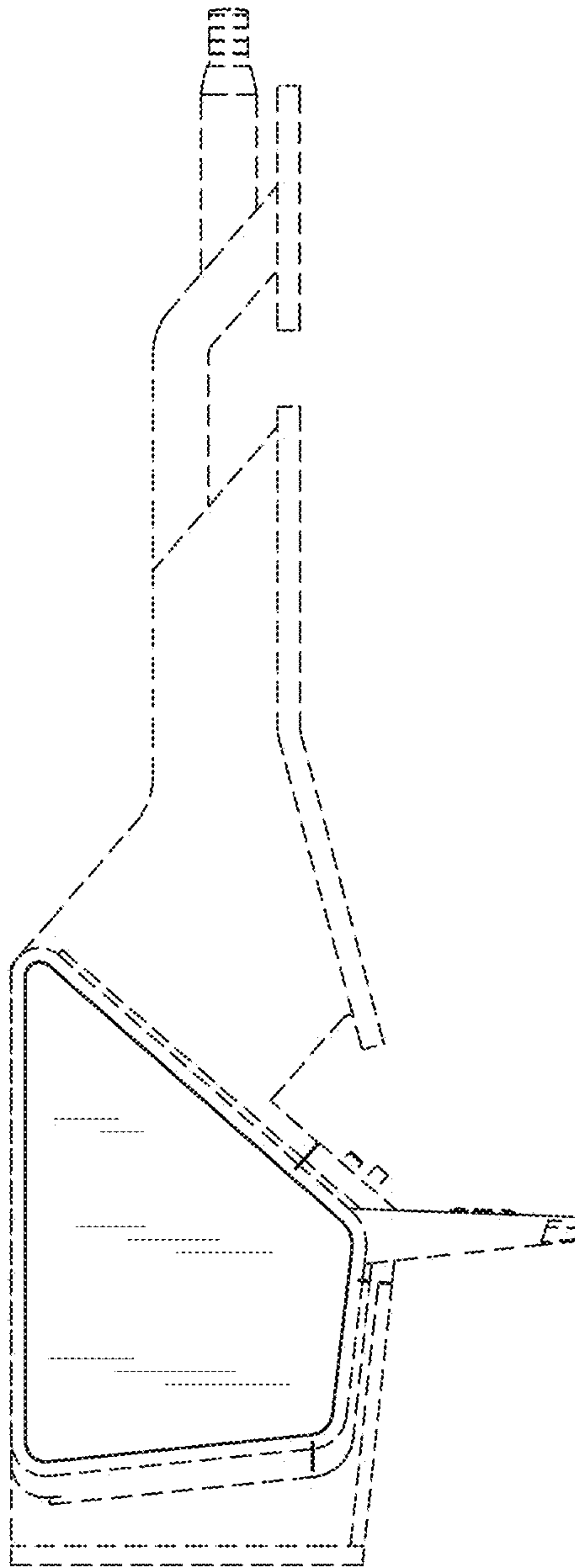

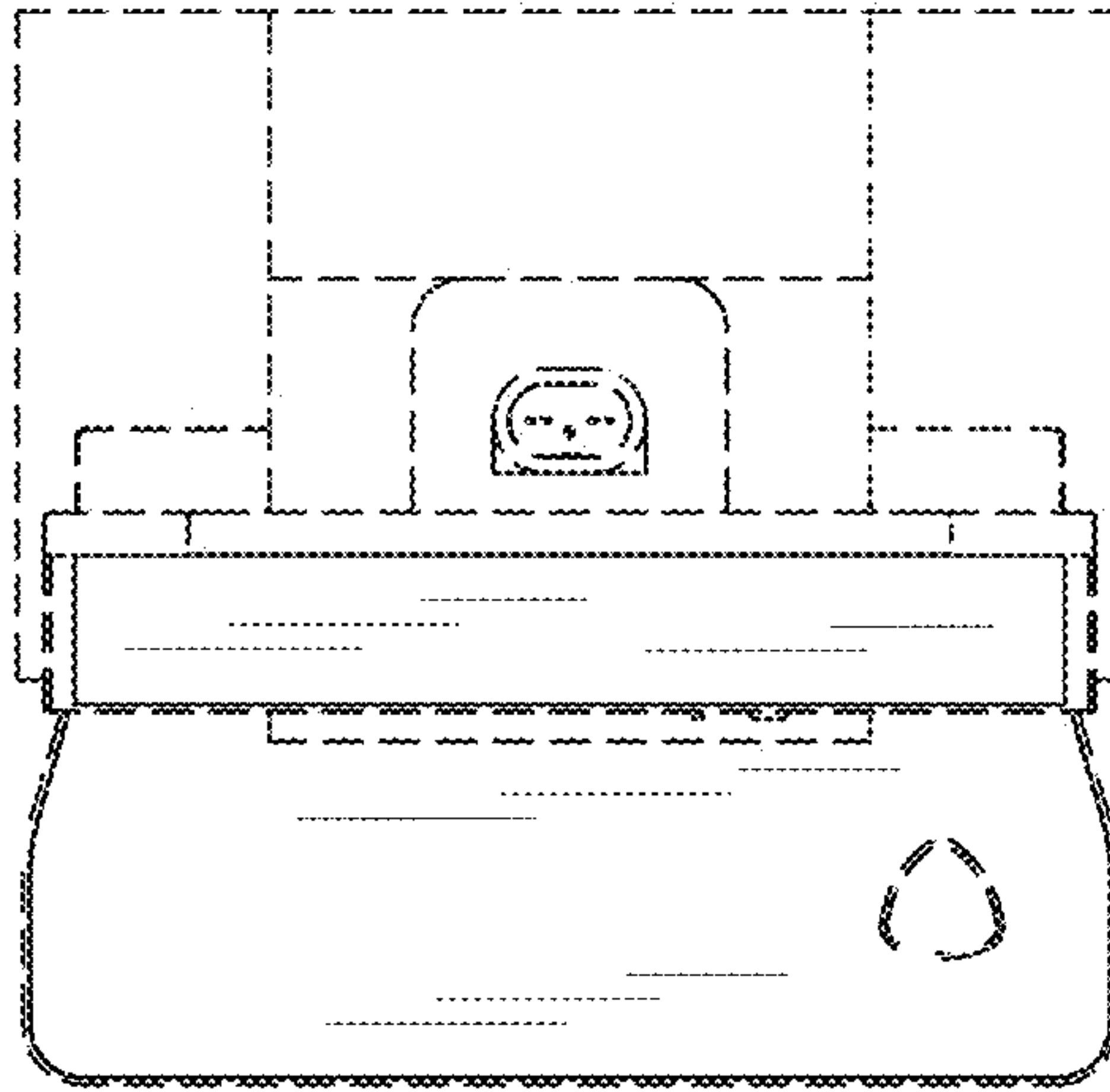

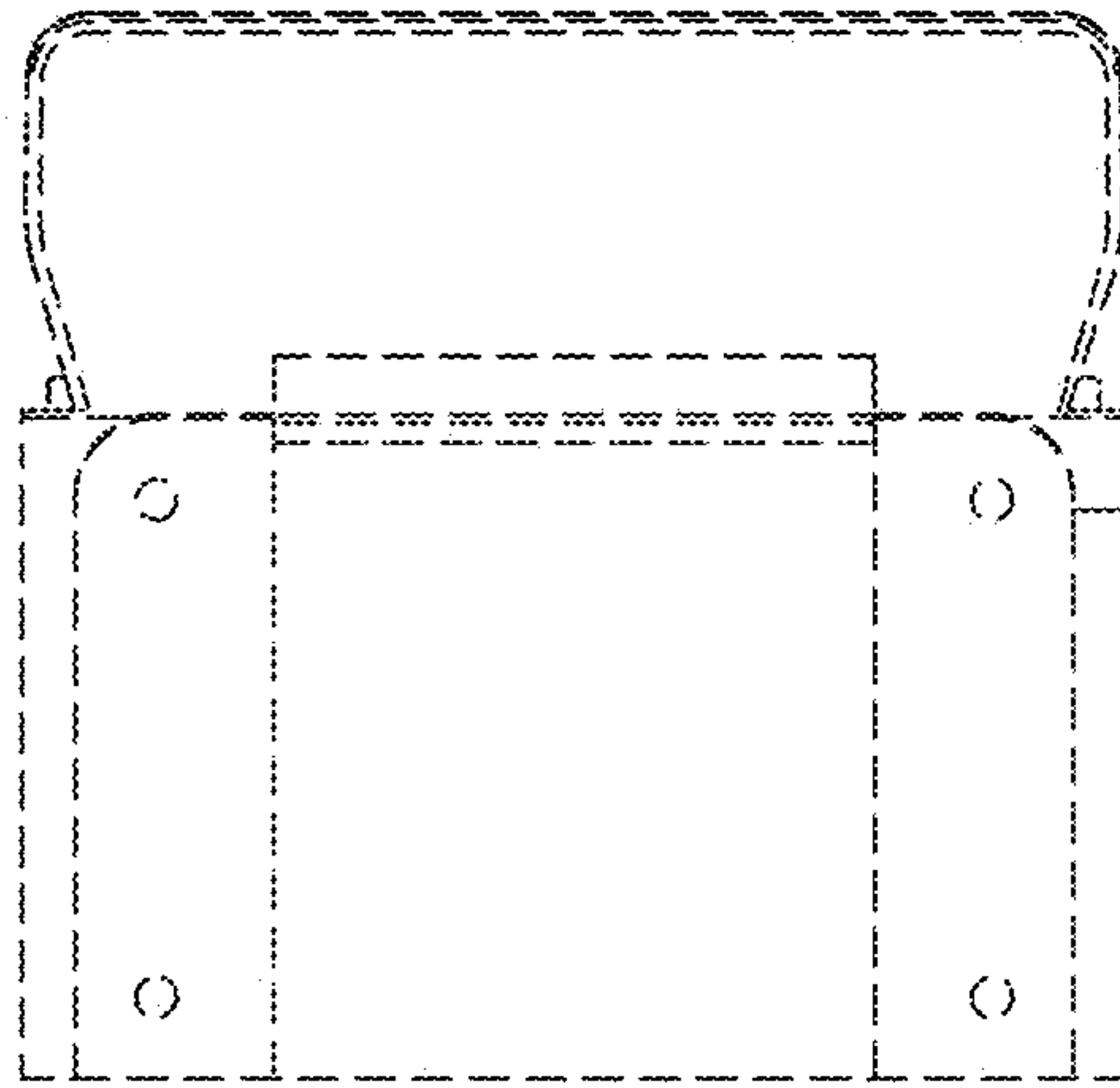

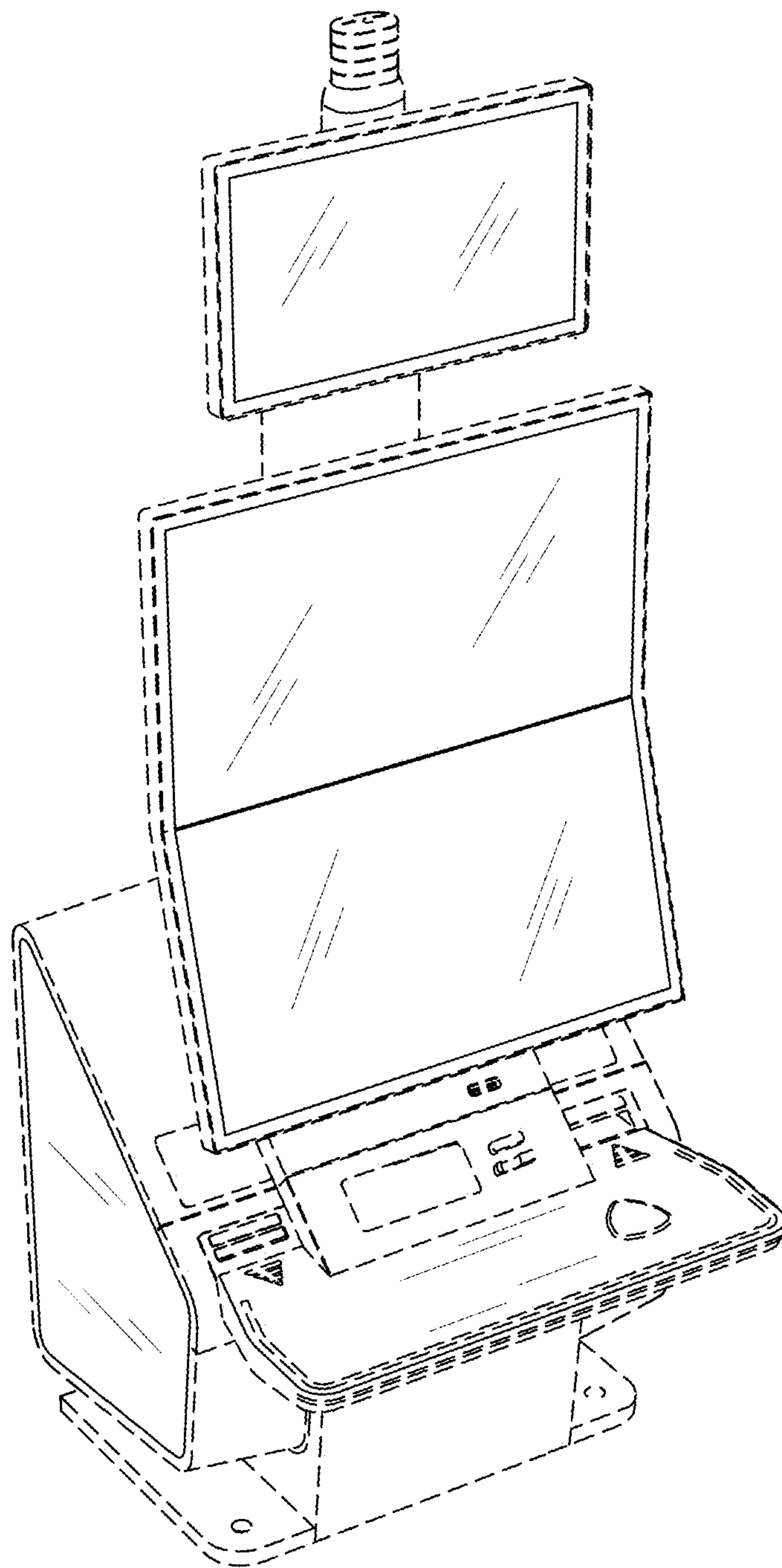

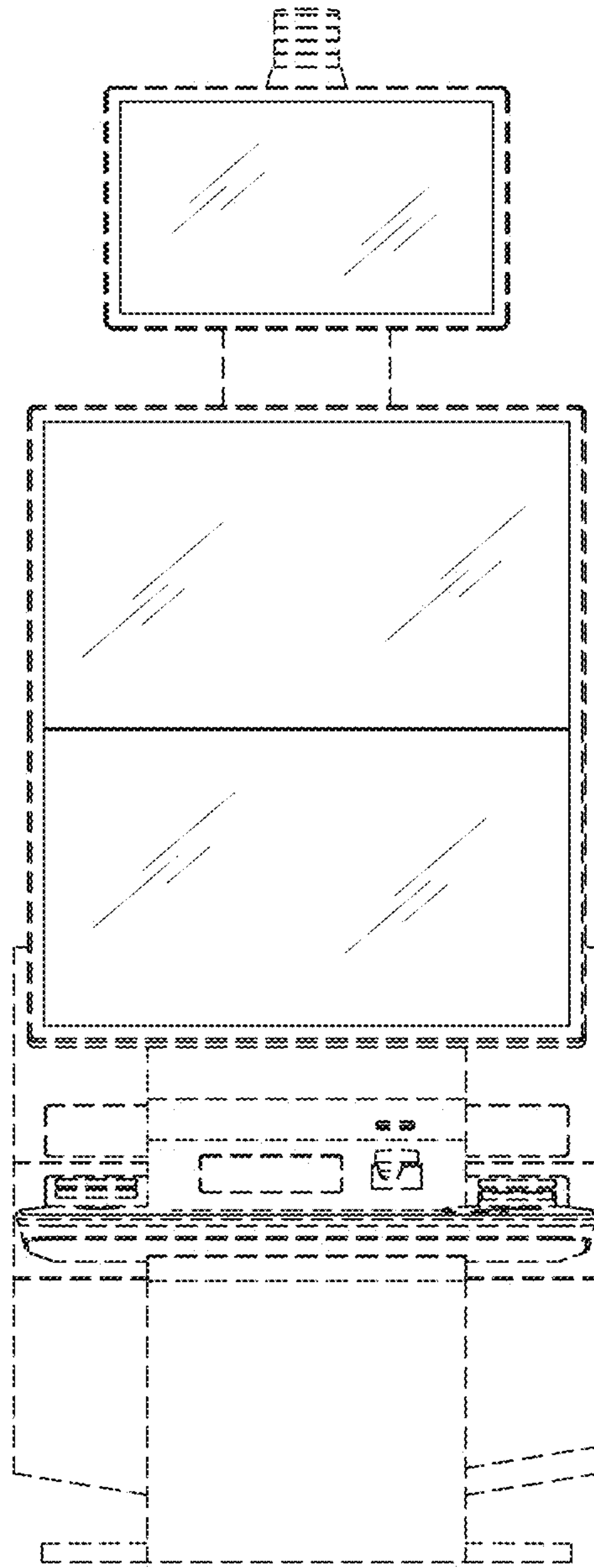
