The ornamental design for a pair of spaced-apart exercise
handles, as shown and described.

DESCRIPTION

FIG. 1 is a bottom-front perspective view of an embodiment
of a pair of spaced-apart exercise handles showing our new
design;

FIG. 2 is a rear-bottom perspective view of the embodiment
shown in FIG. 1;

FIG. 3 is a front elevational view of the embodiment shown
in FIG. 1;

FIG. 4 is a rear elevational view of the embodiment shown
in FIG. 1;

FIG. 5 is a bottom plan view of the embodiment shown in
FIG. 1;

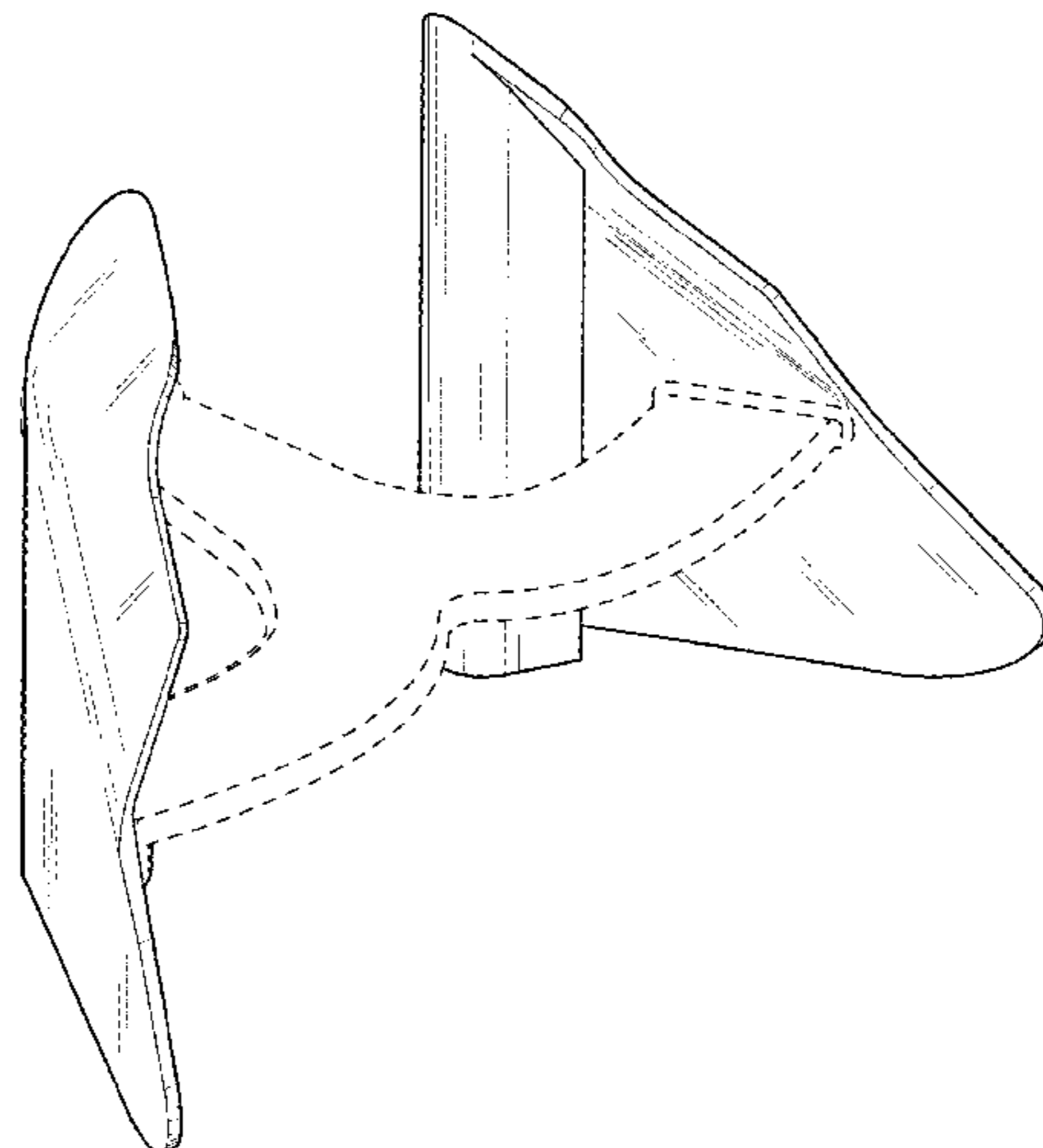
FIG. 6 is a top plan view of the embodiment shown in FIG.

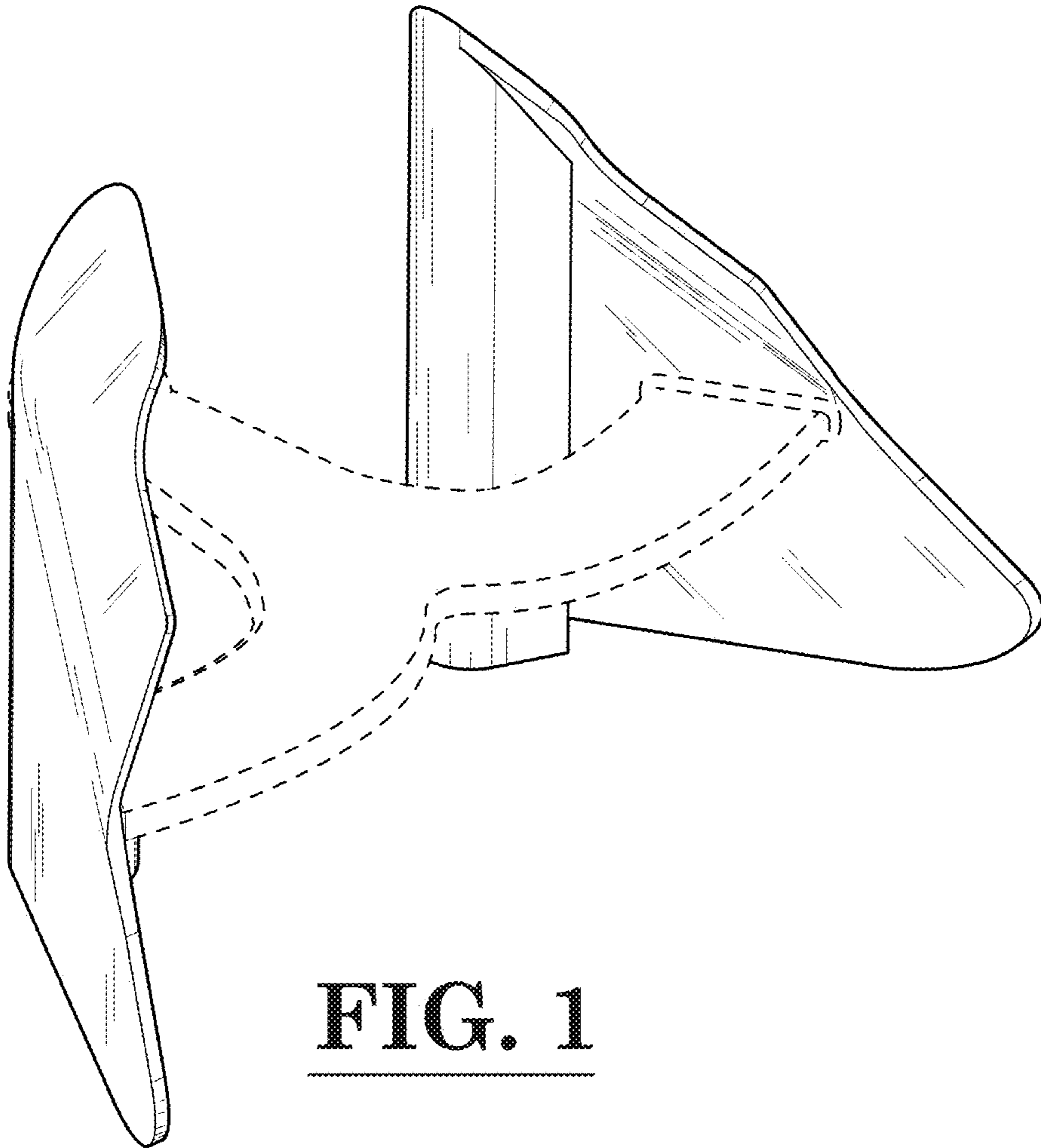

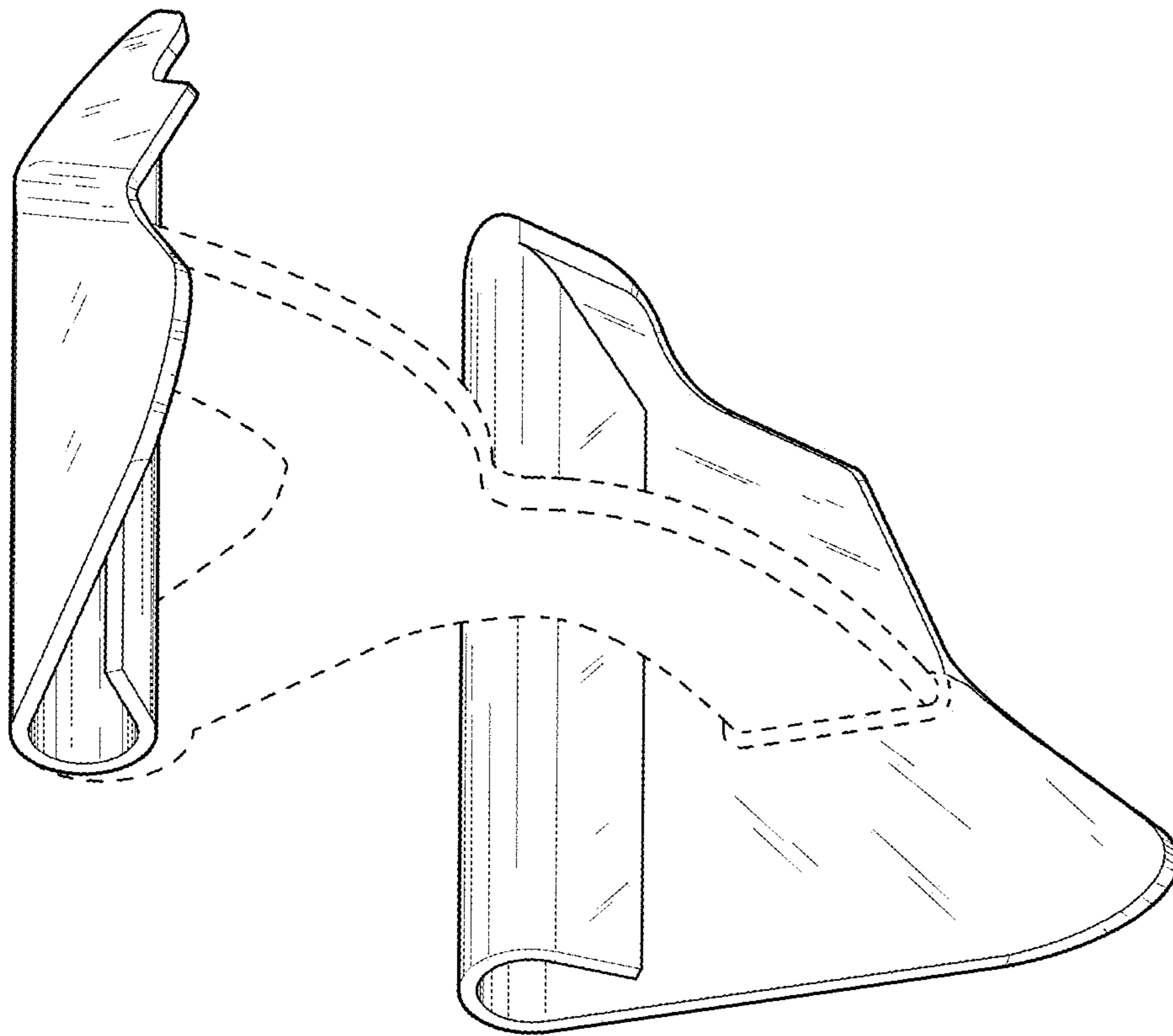
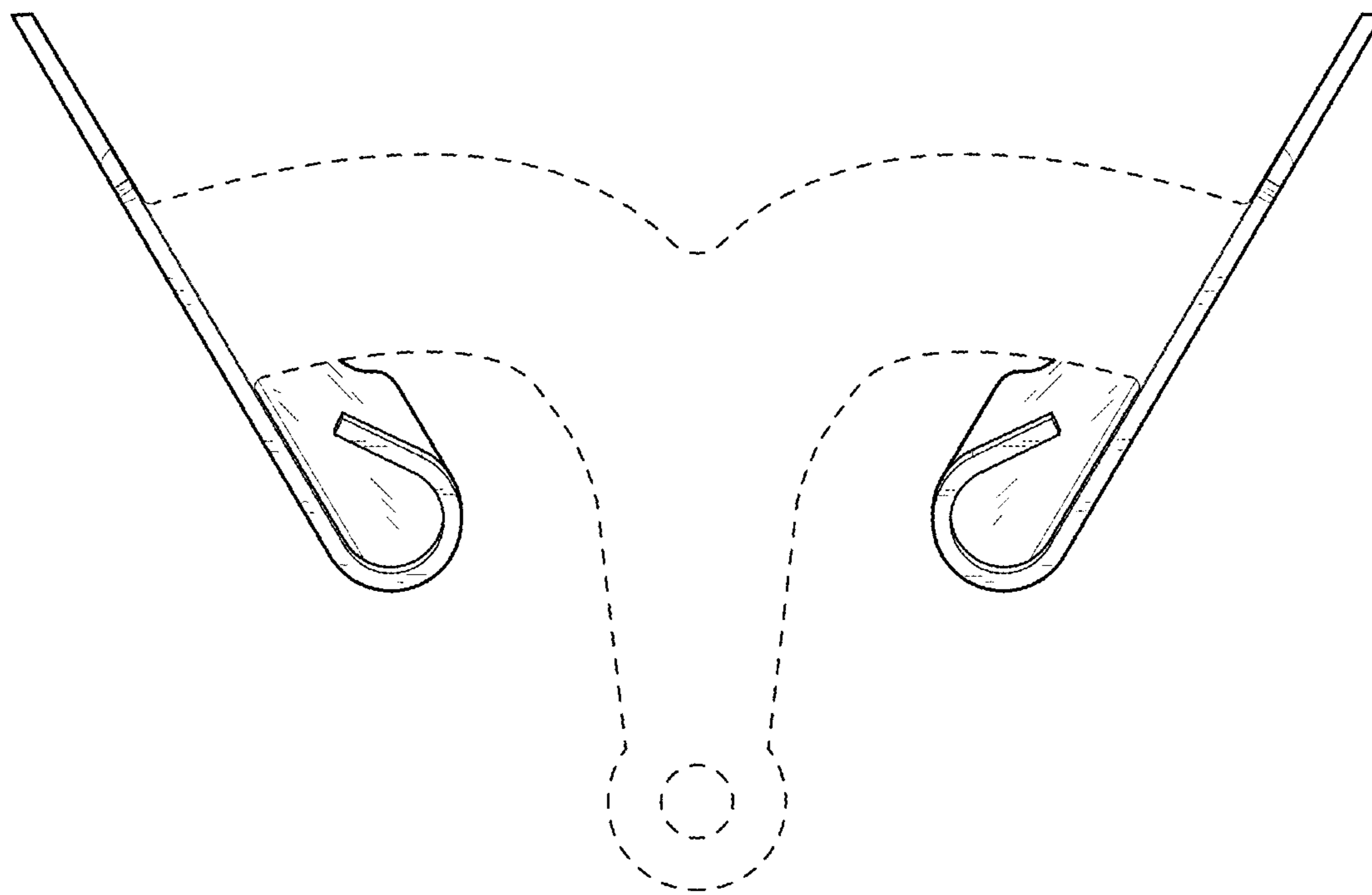
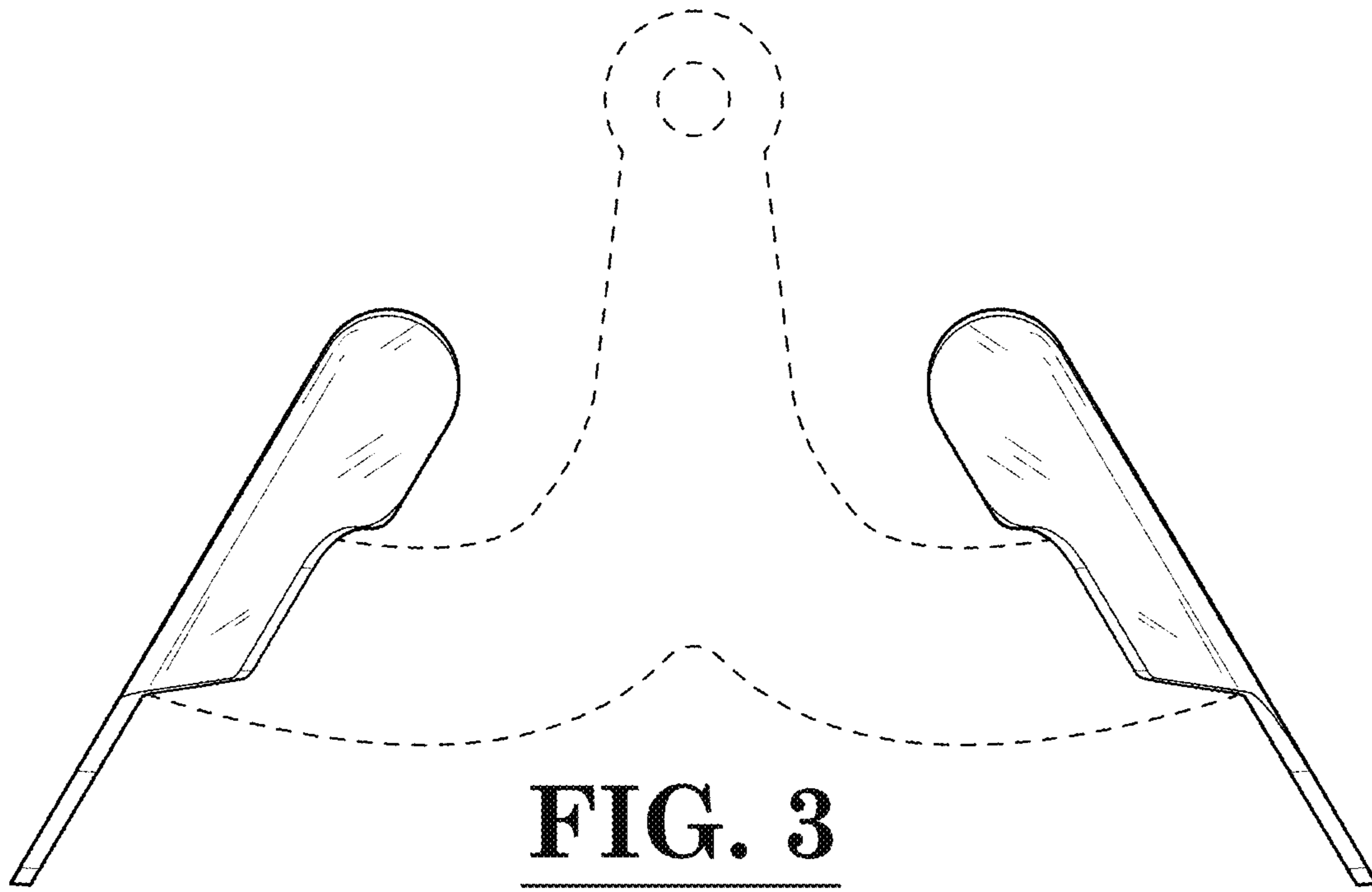

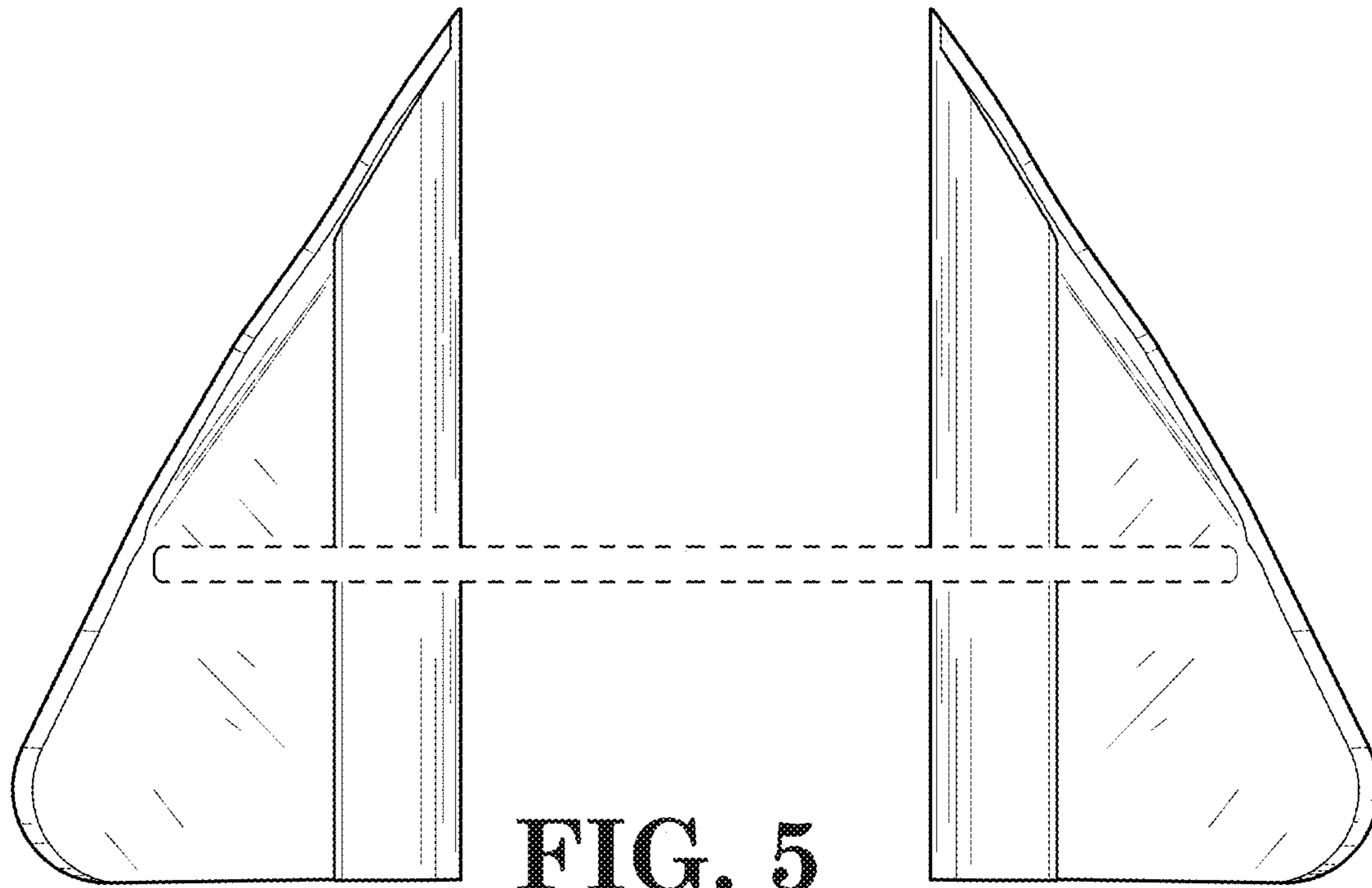

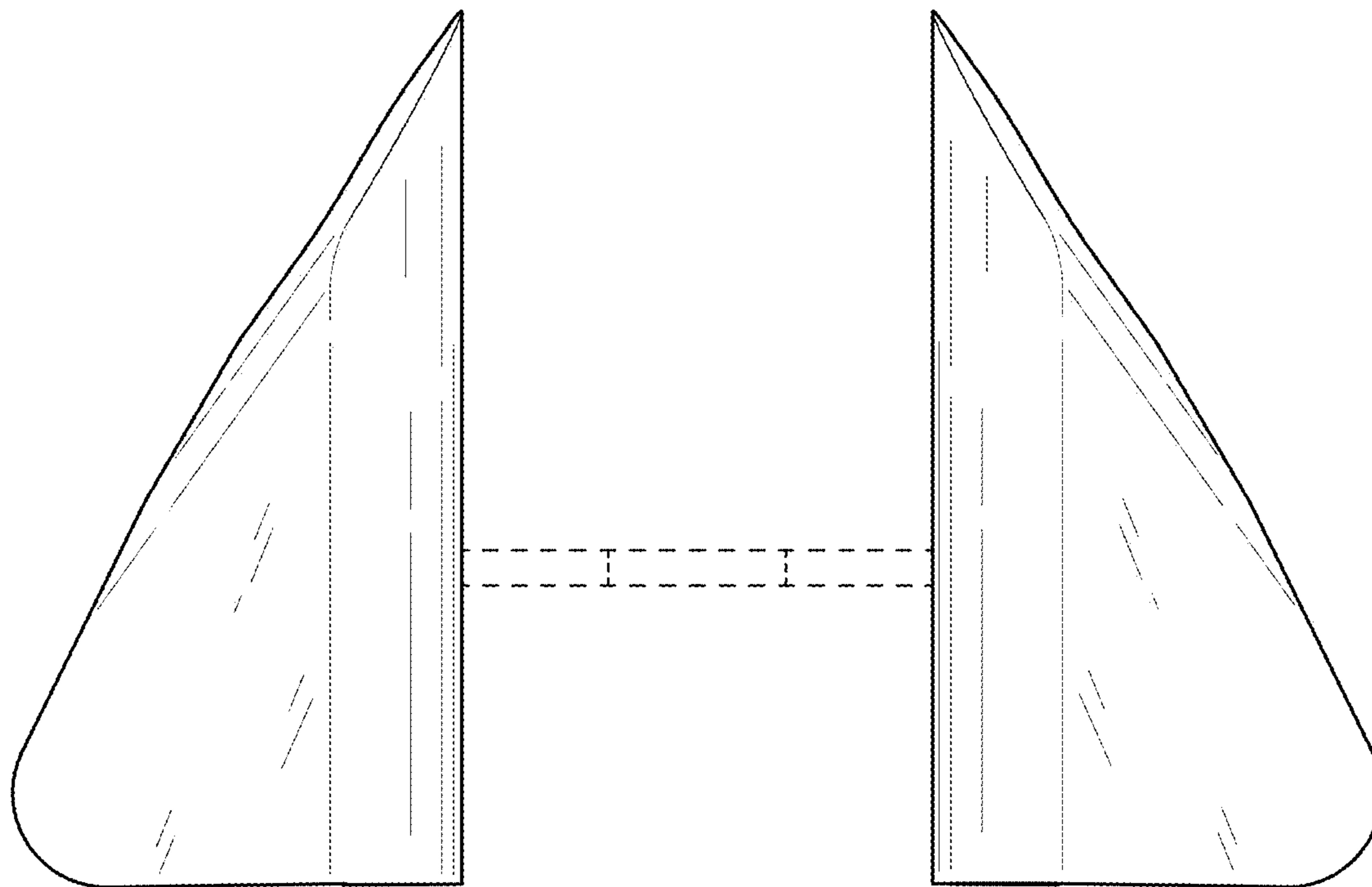

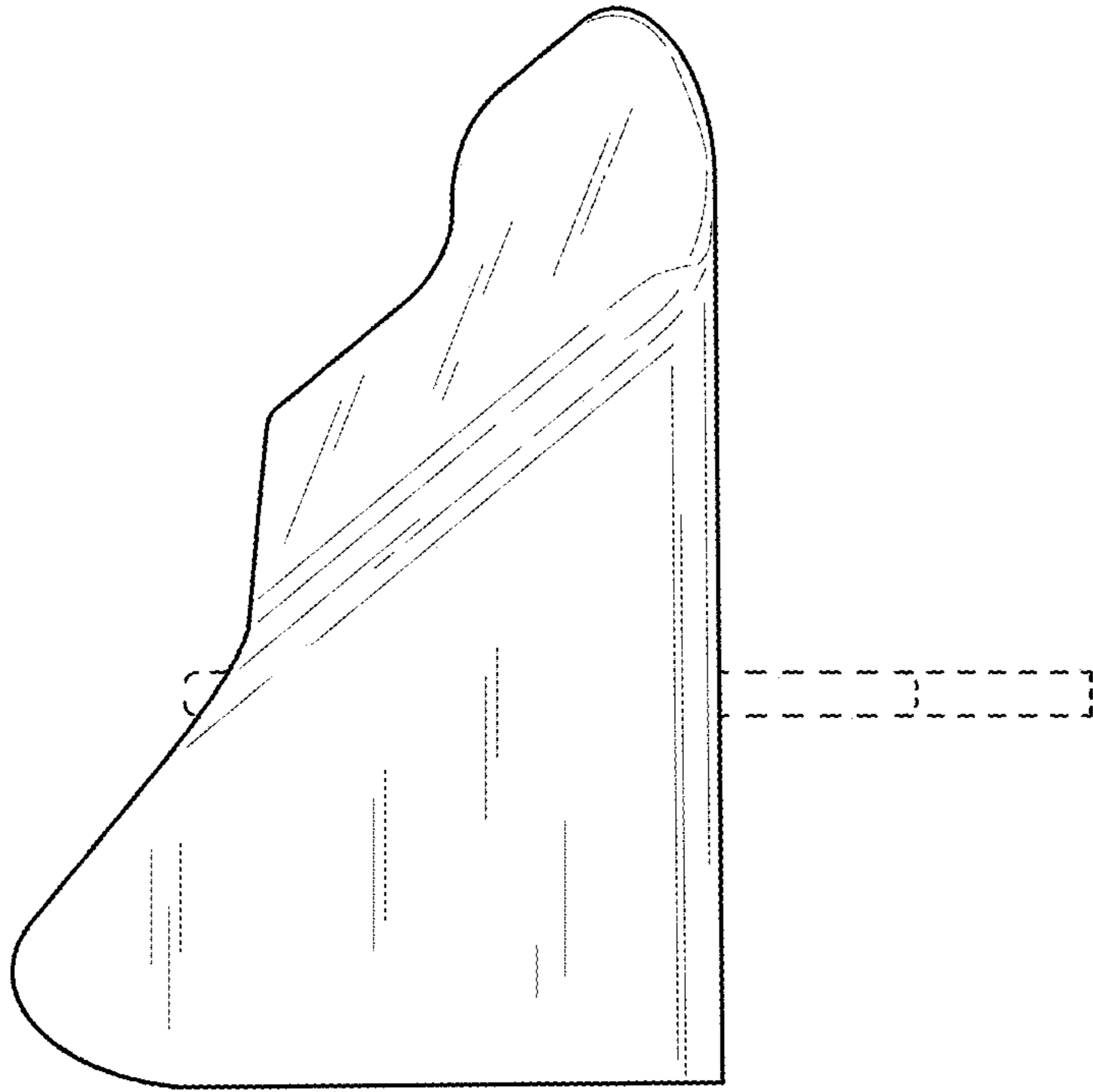

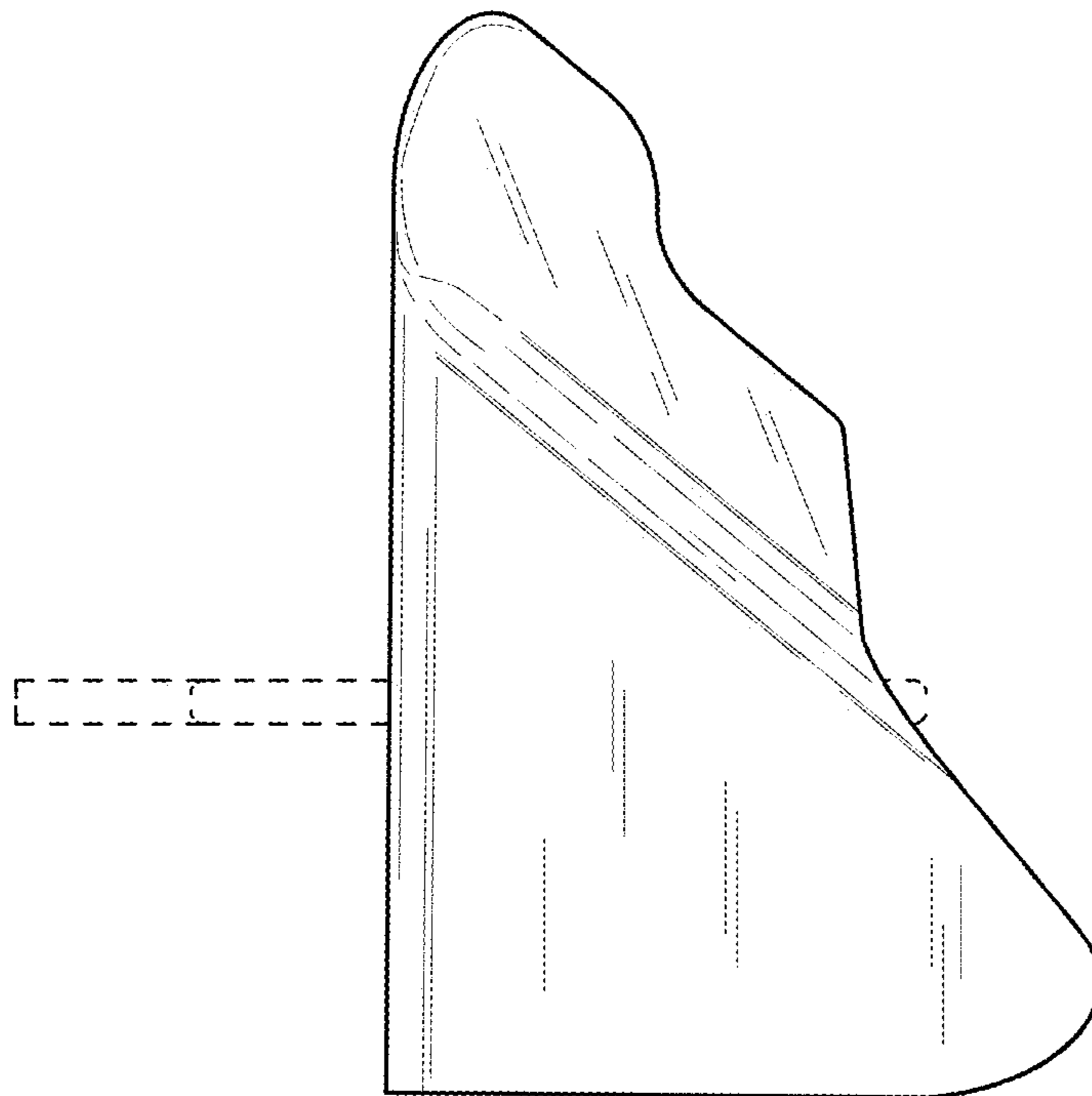
