(57) **CLAIM**

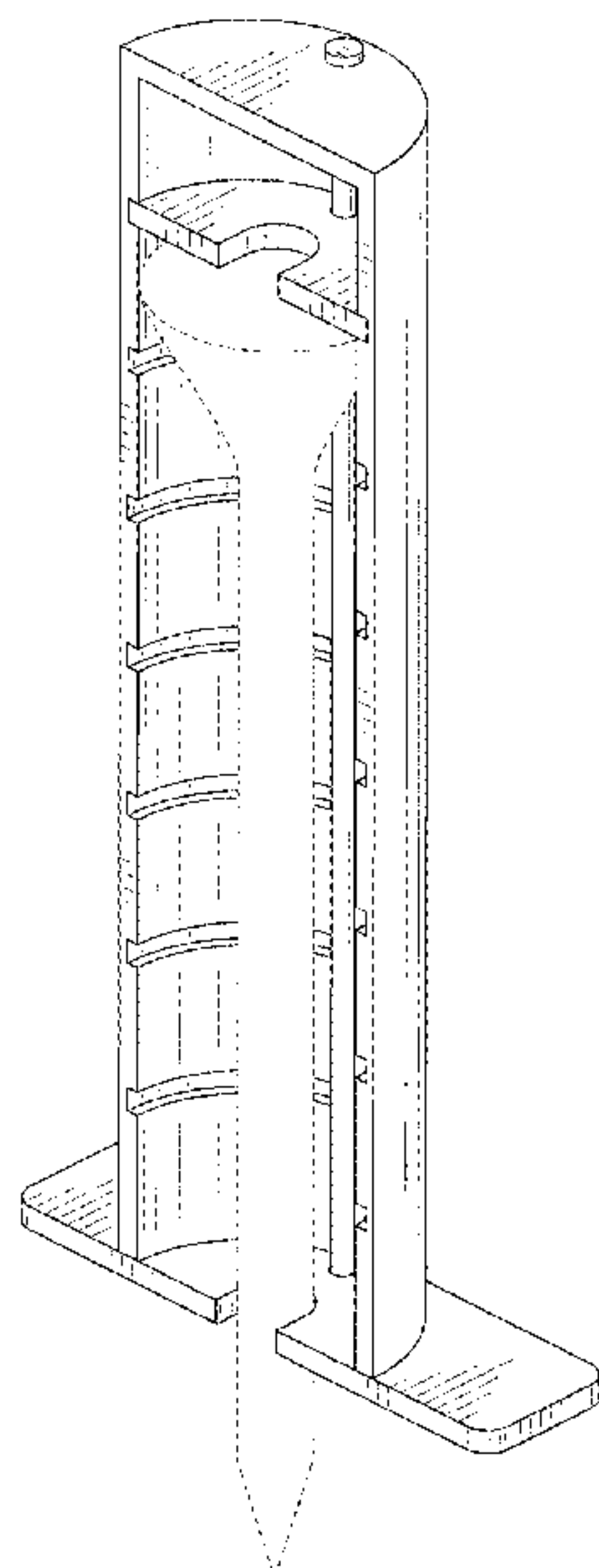
The ornamental design for a golf tee positioner, as shown and described.

DESCRIPTION

FIG. 1 is an exploded front perspective view of the golf tee positioner of the instant invention;
 FIG. 2 is an assembled front perspective view thereof;
 FIG. 3 is a front side plane view thereof;
 FIG. 4 is a rear side plane view thereof;
 FIG. 5 is a right side plane view thereof, not shown is the left side view which forms a mirror image of the right side;
 FIG. 6 is a top plane view thereof;
 FIG. 7 is a bottom plane view thereof; and,
 FIG. 8 is a top plane view of the position disk shown for clarify of illustration.
 The broken line showing of a golf tee is included for the purpose of illustrating environment and forms no part of the claimed design.

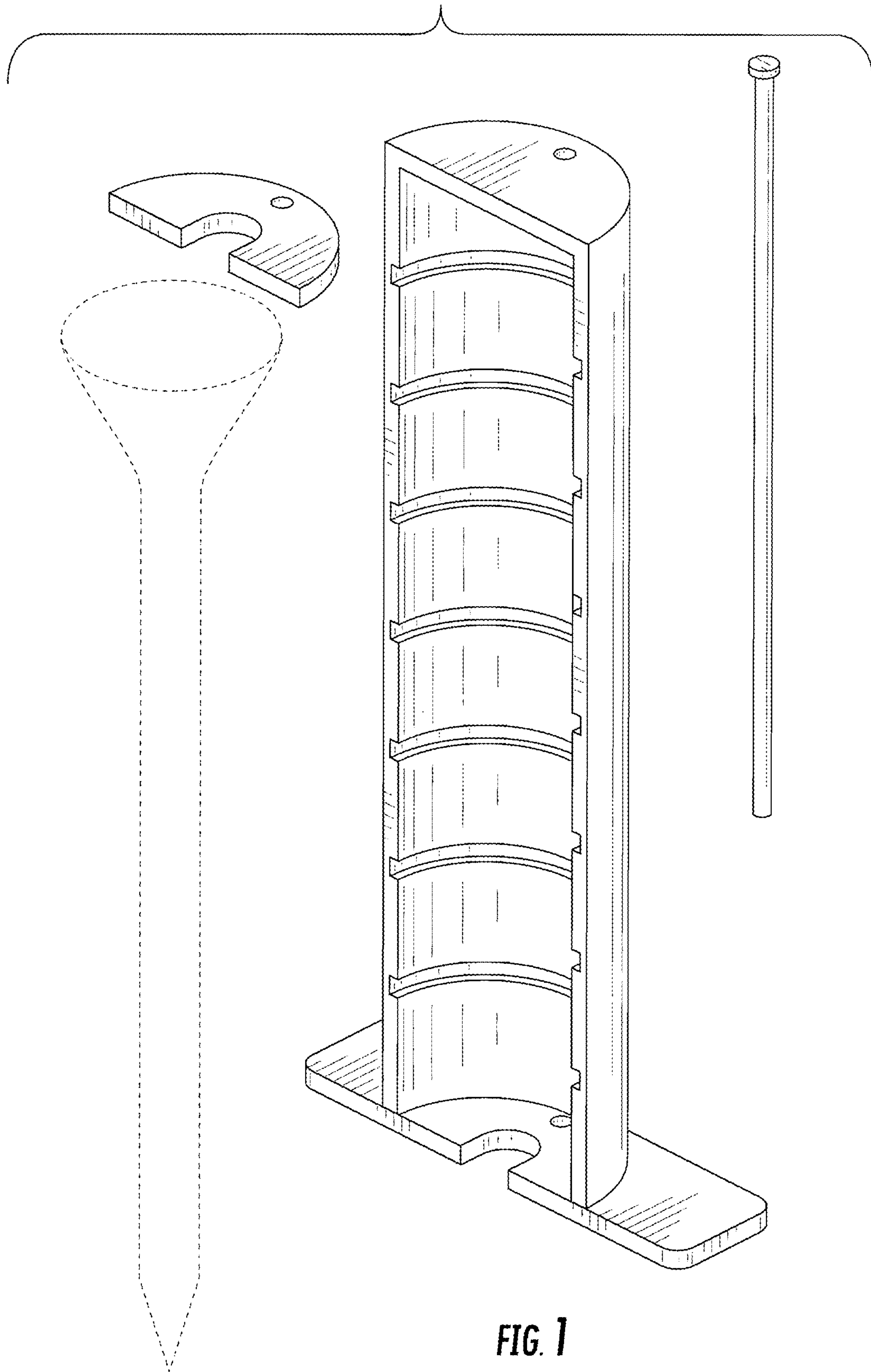

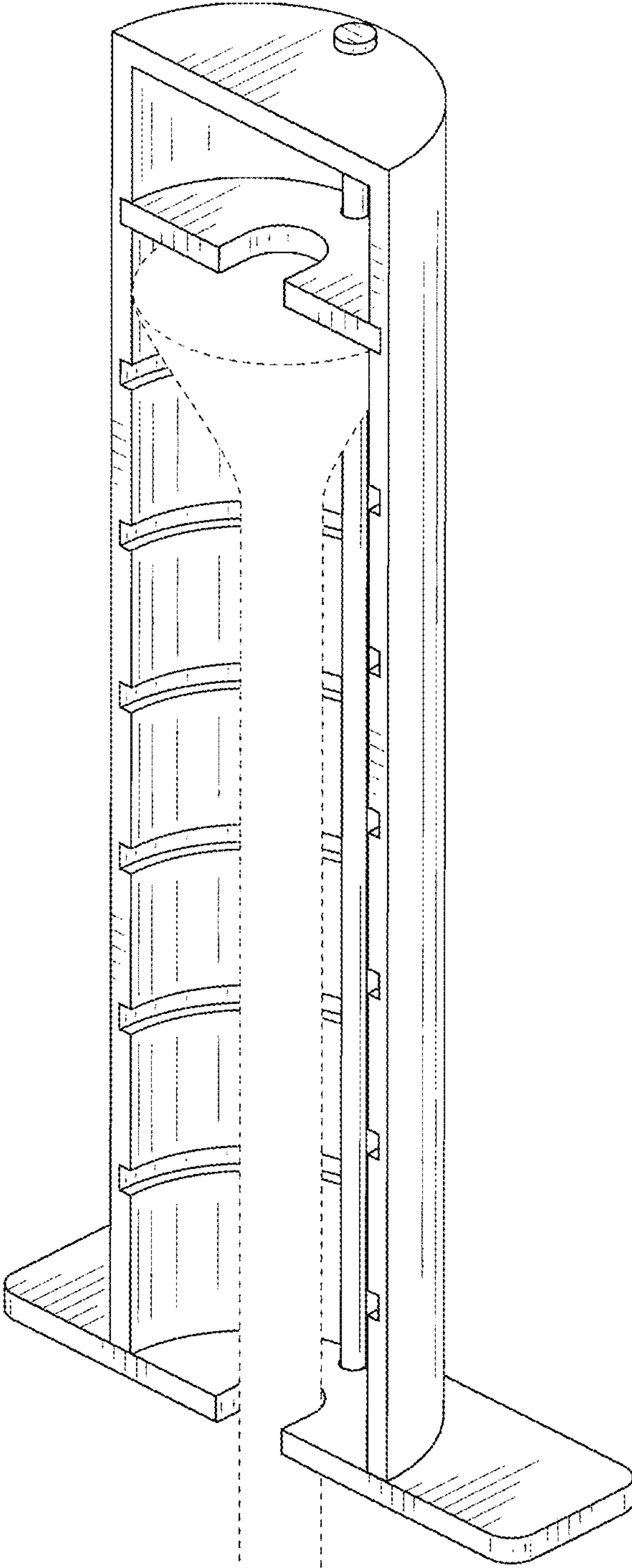

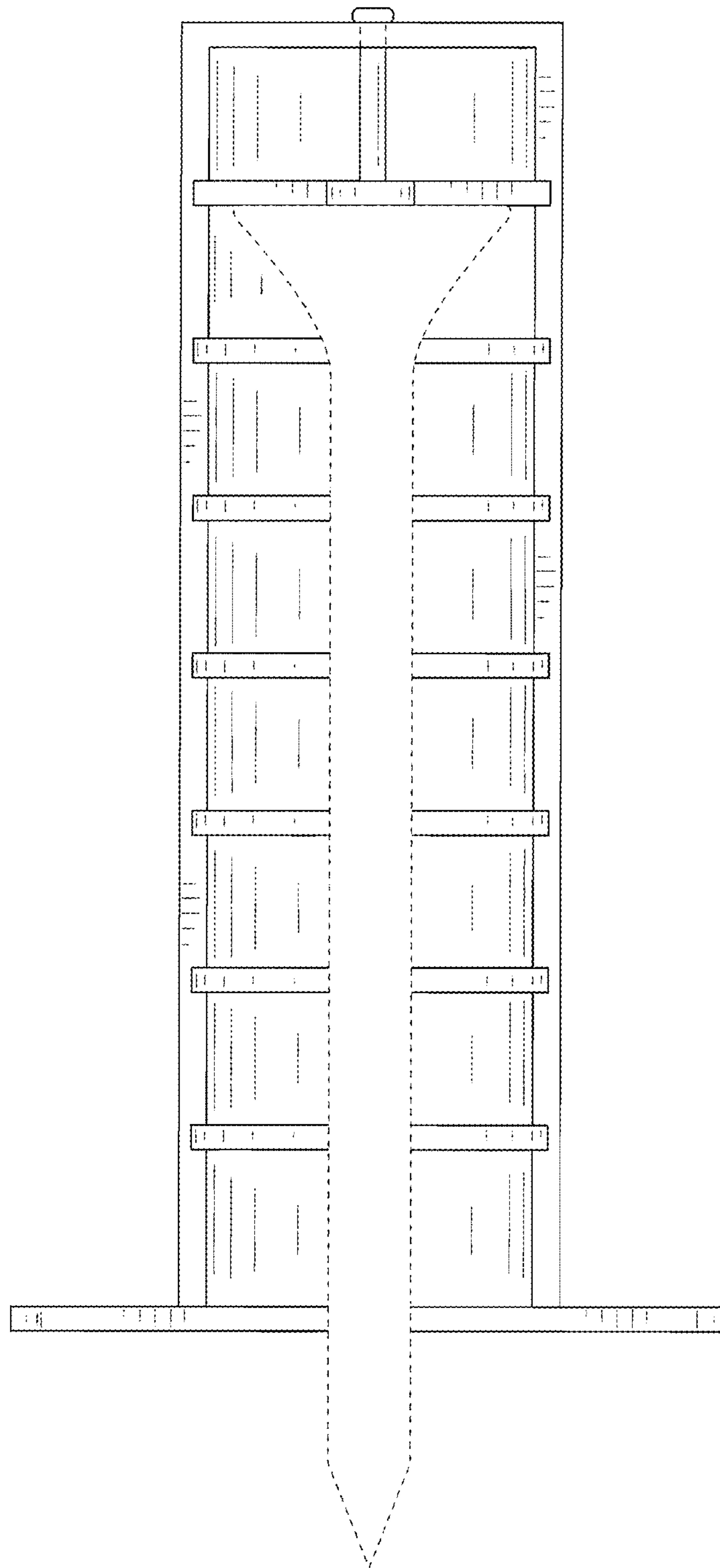

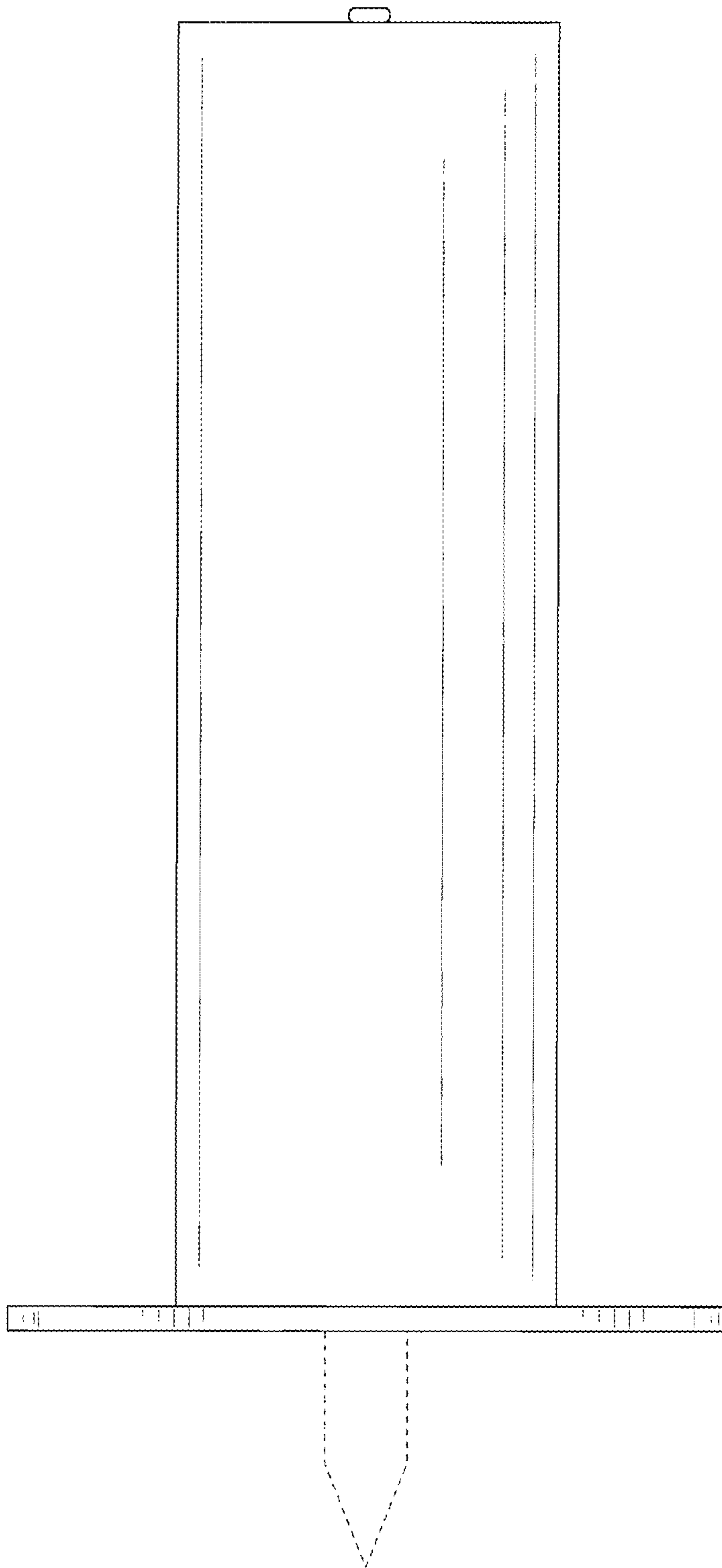

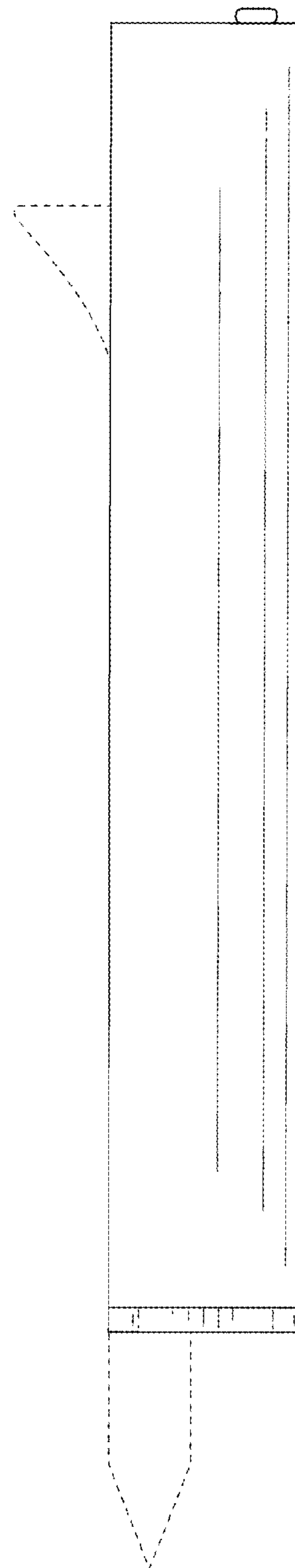

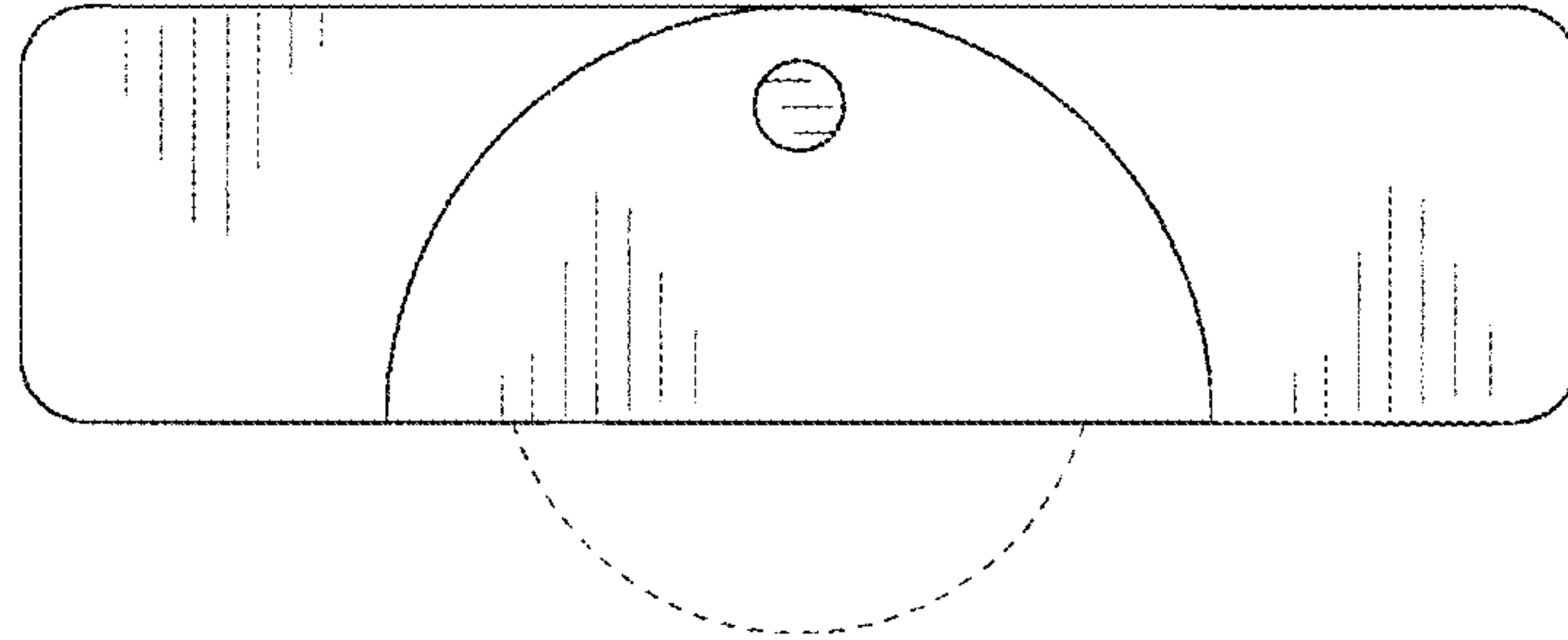

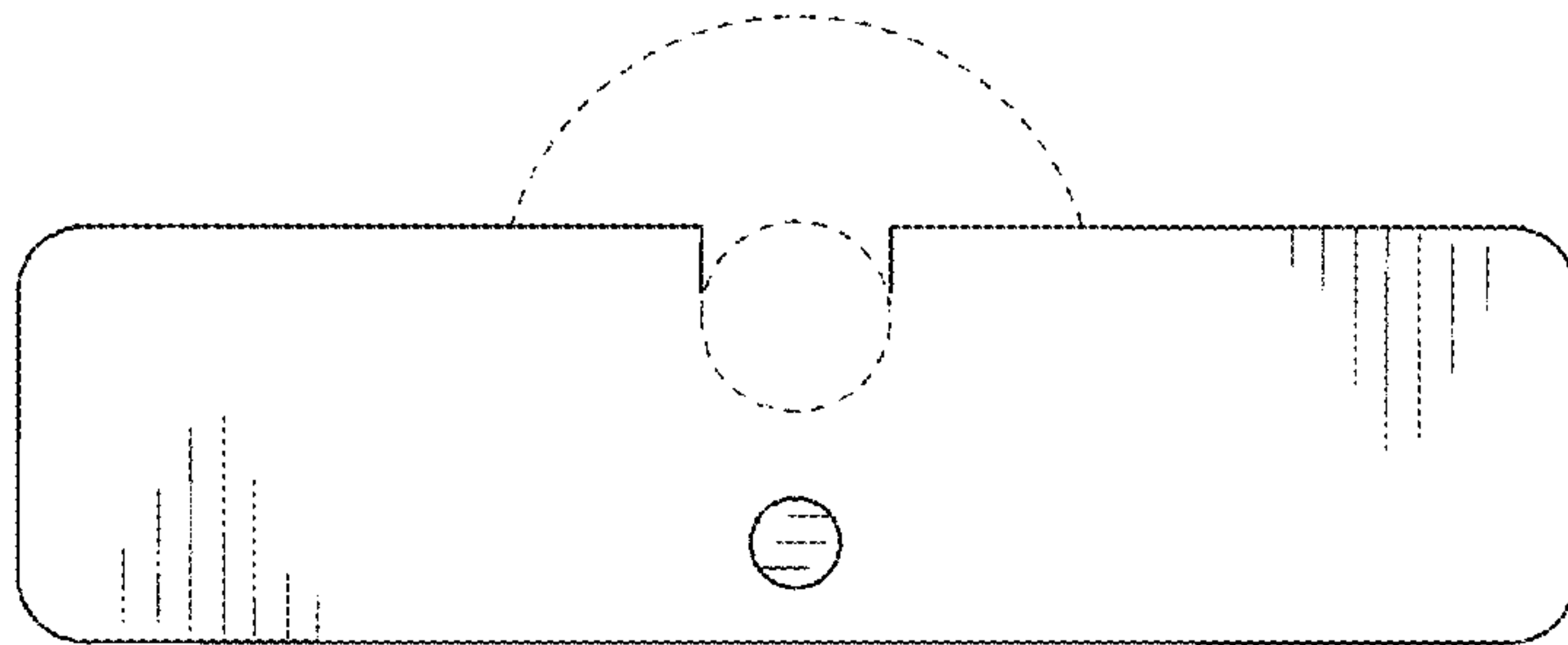

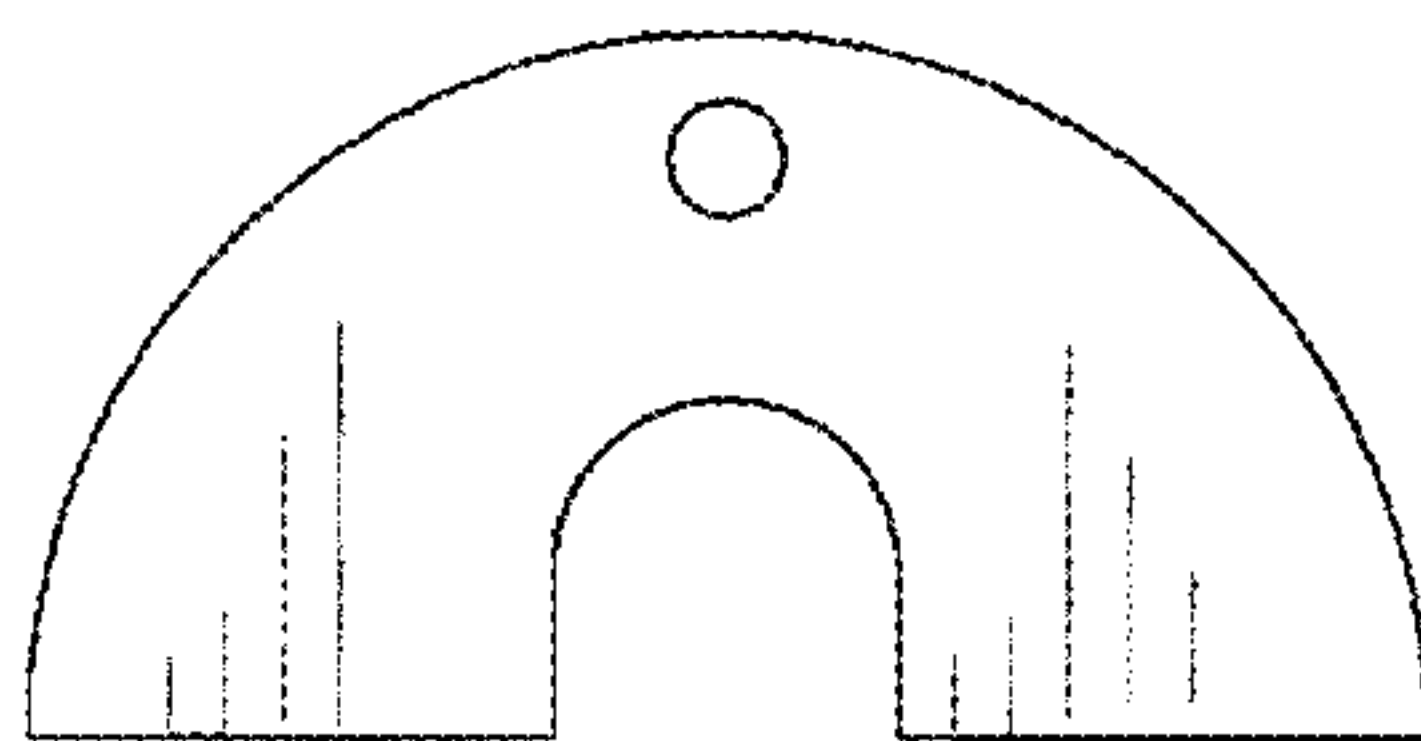
