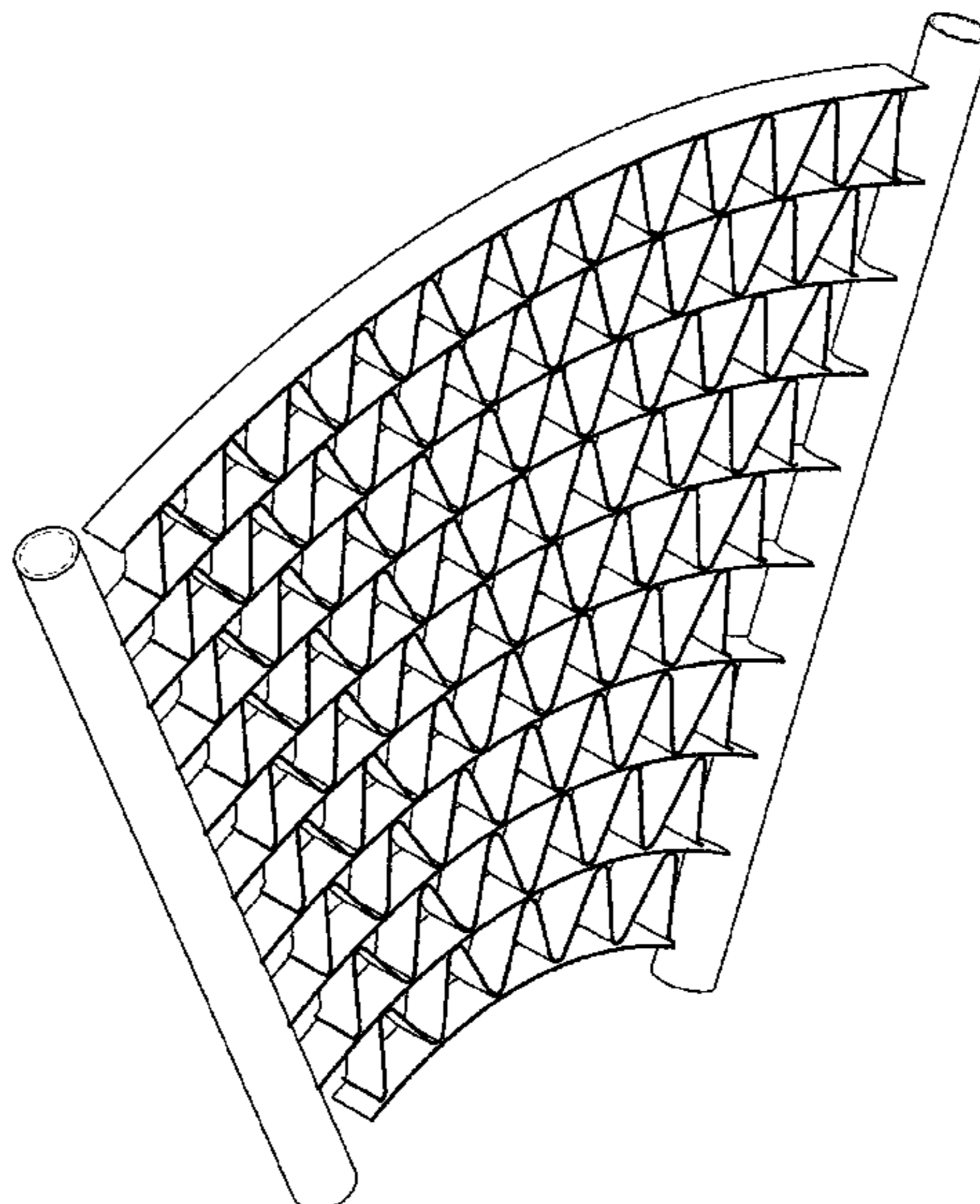
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, left side and top perspective view of a heat exchanger comprising a new, original and ornamental design;

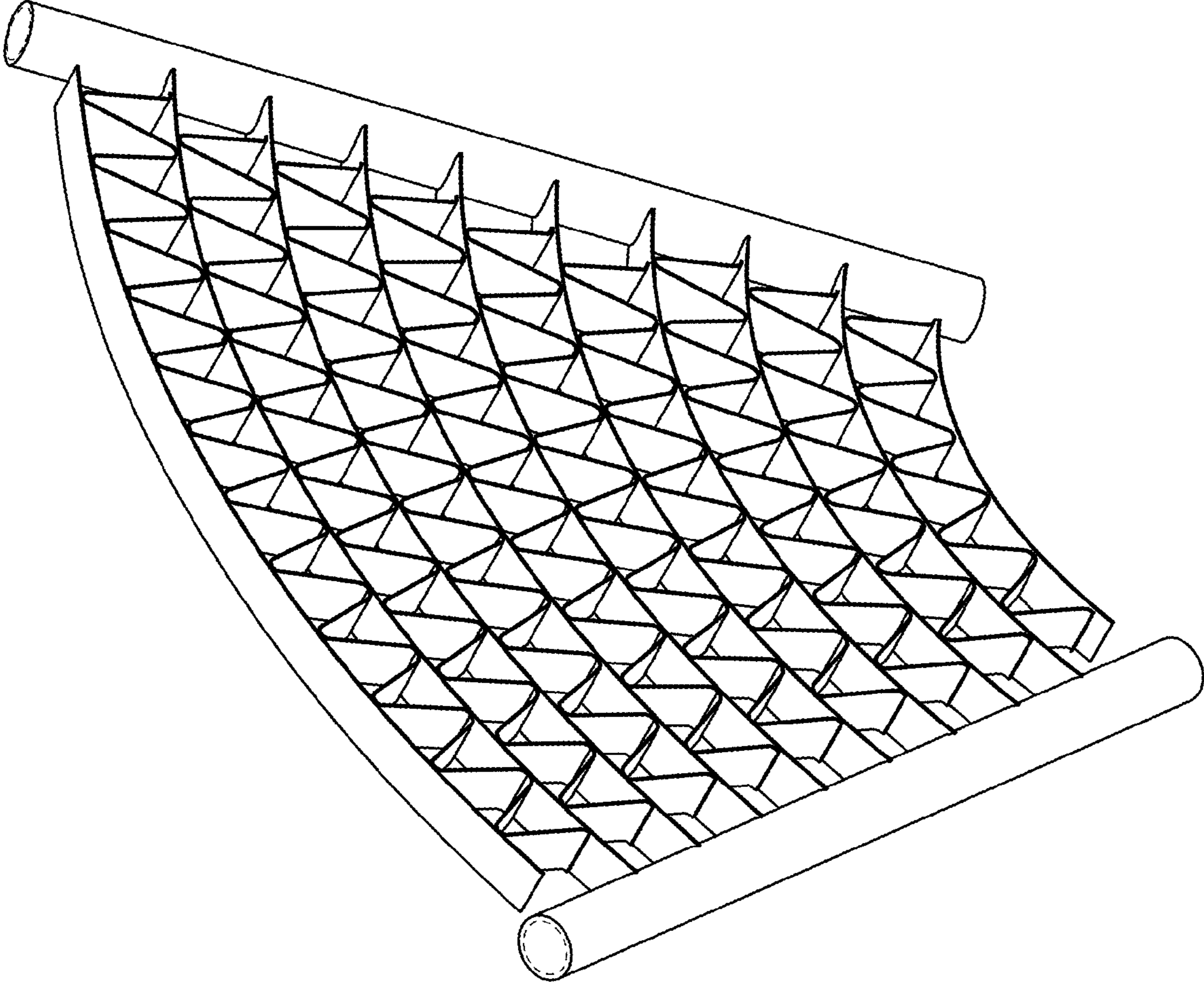

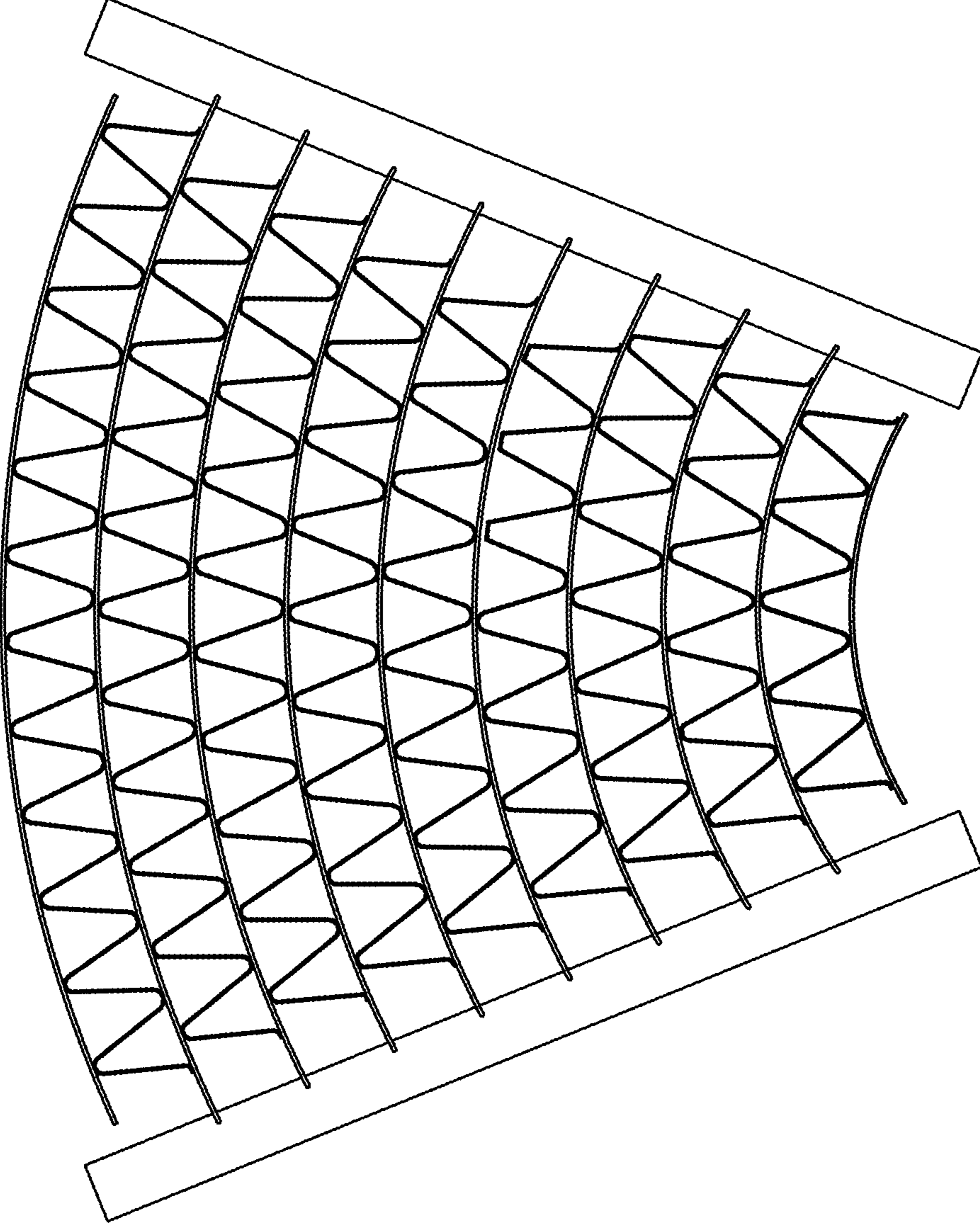

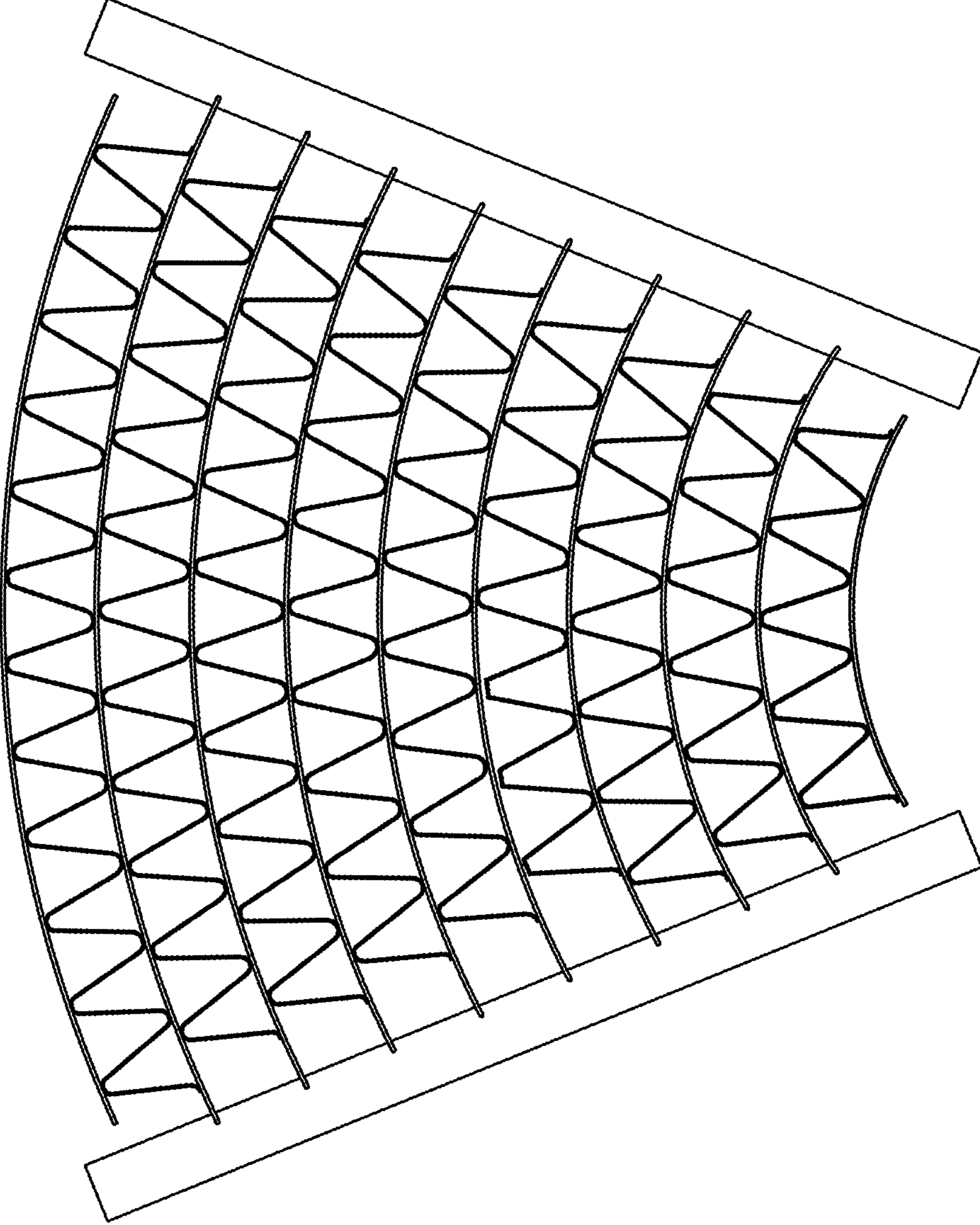

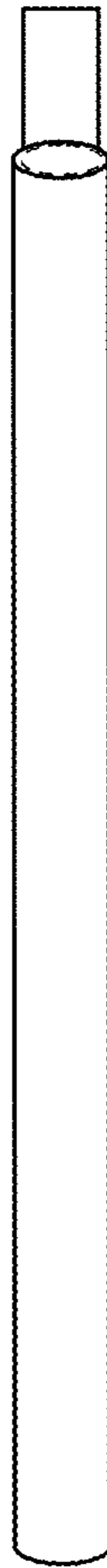

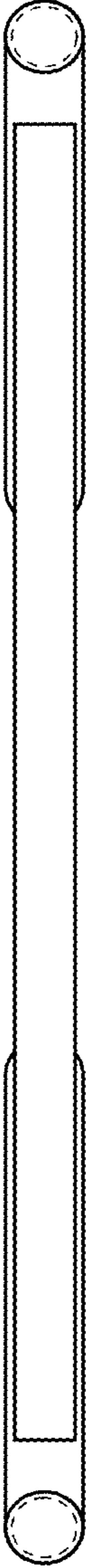

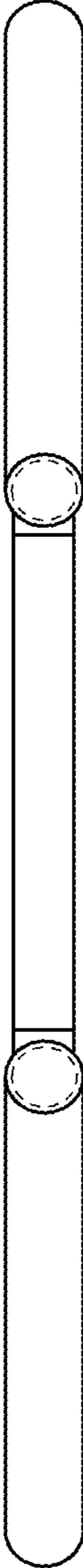
