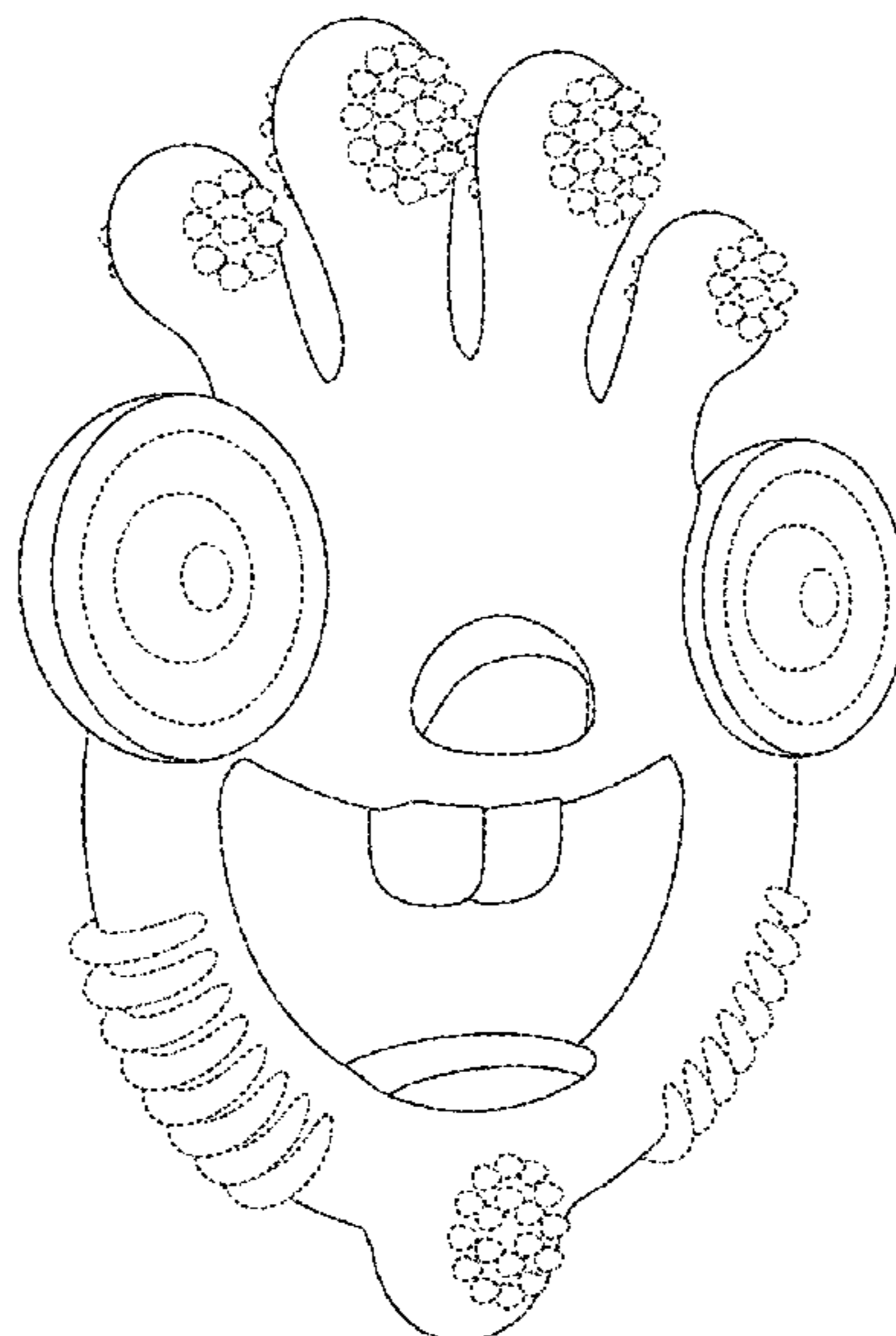
(57) **CLAIM**

The ornamental design for a face-shaped teether, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left perspective view of a face-shaped teether, showing my new design;  
FIG. 2 is a rear, right perspective view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a left side elevation view thereof;  
FIG. 6 is a right side elevation view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.

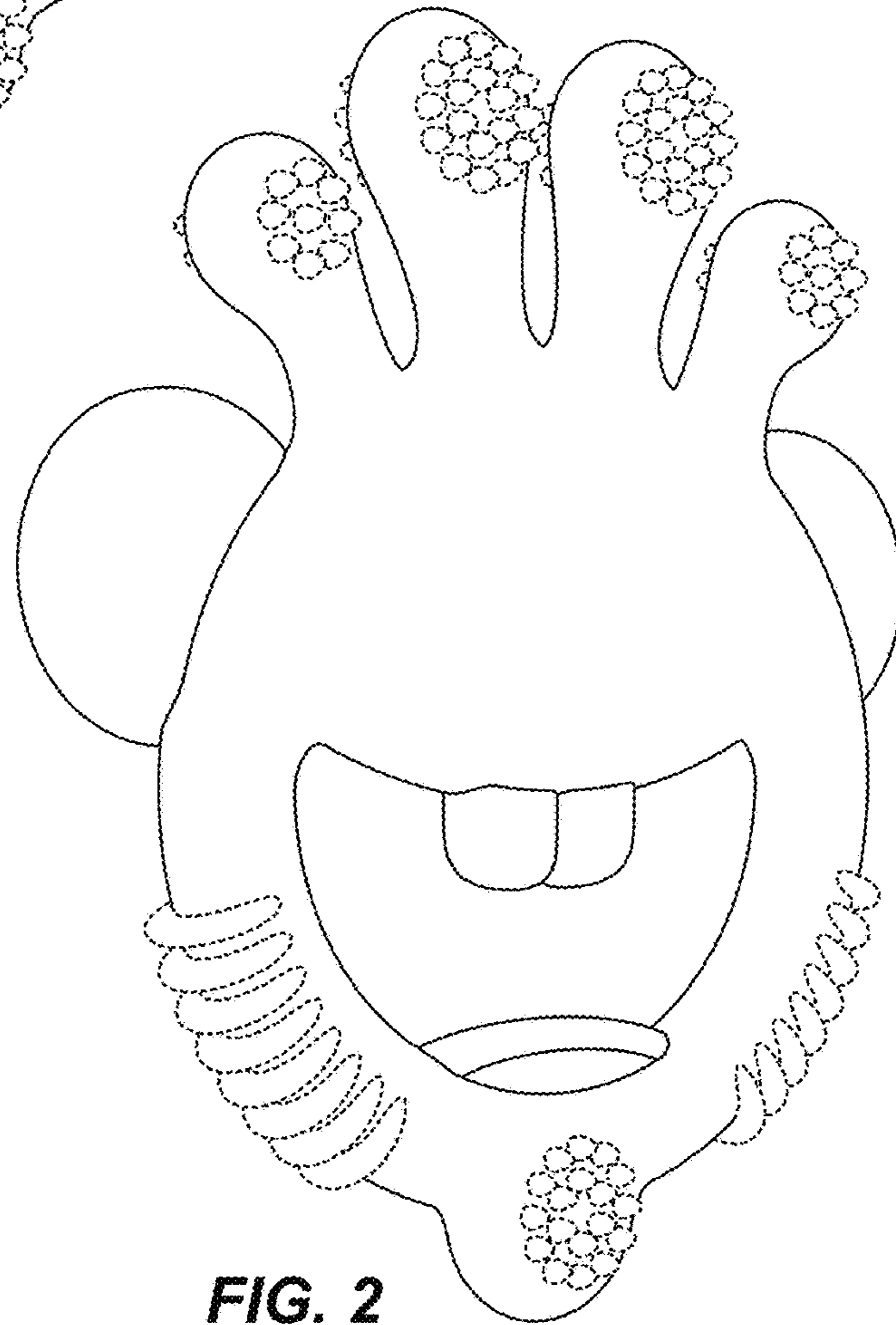
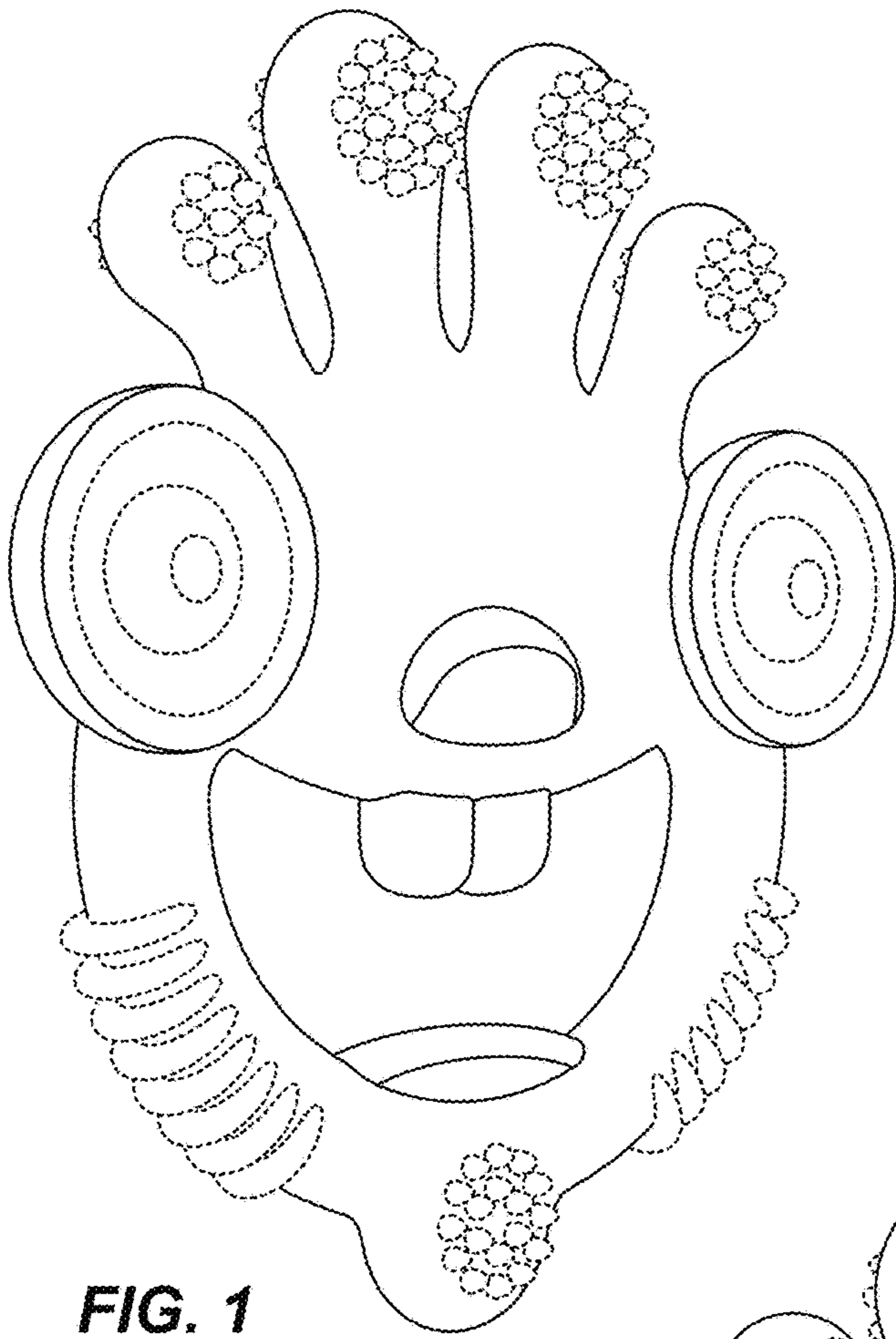

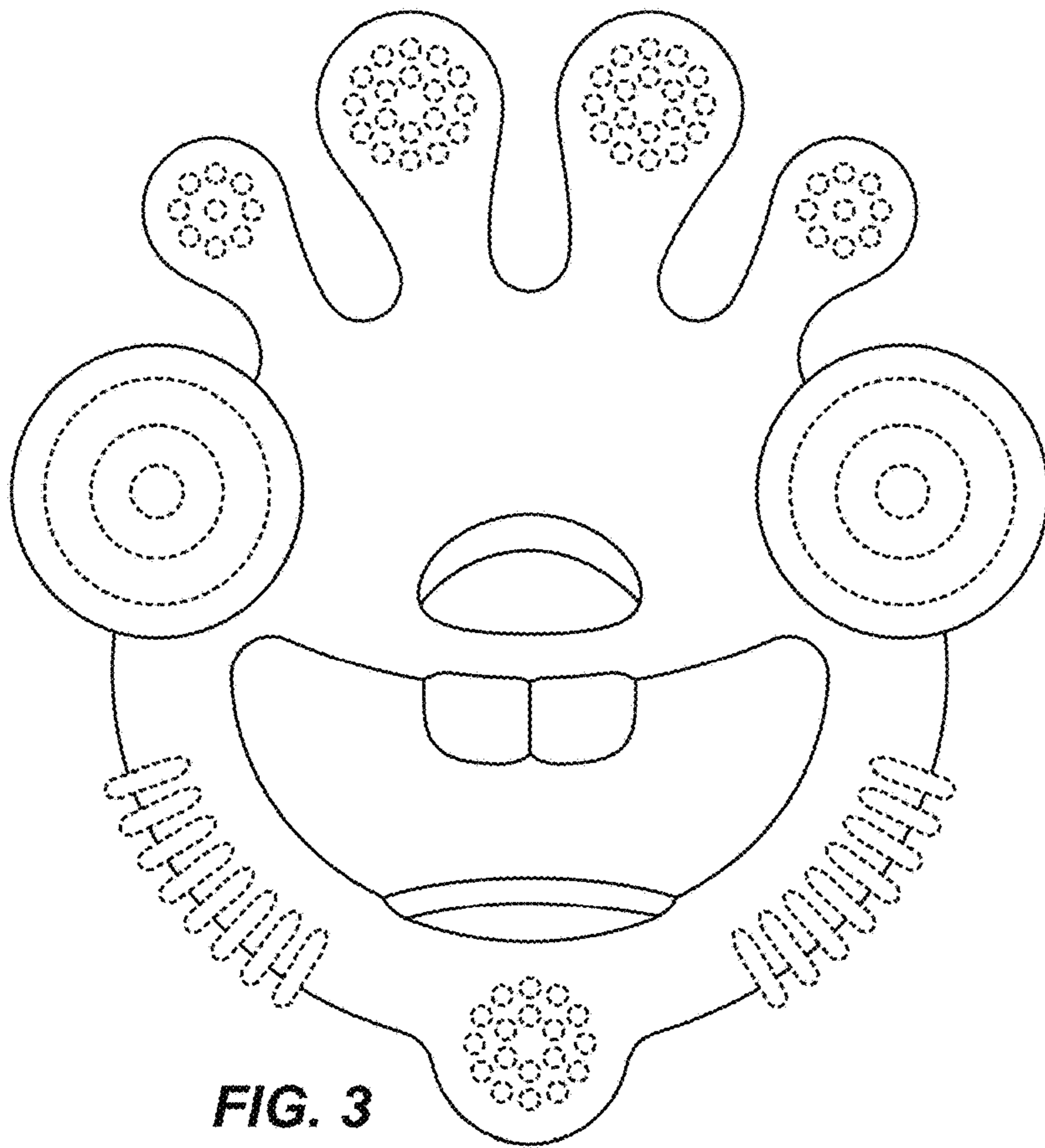

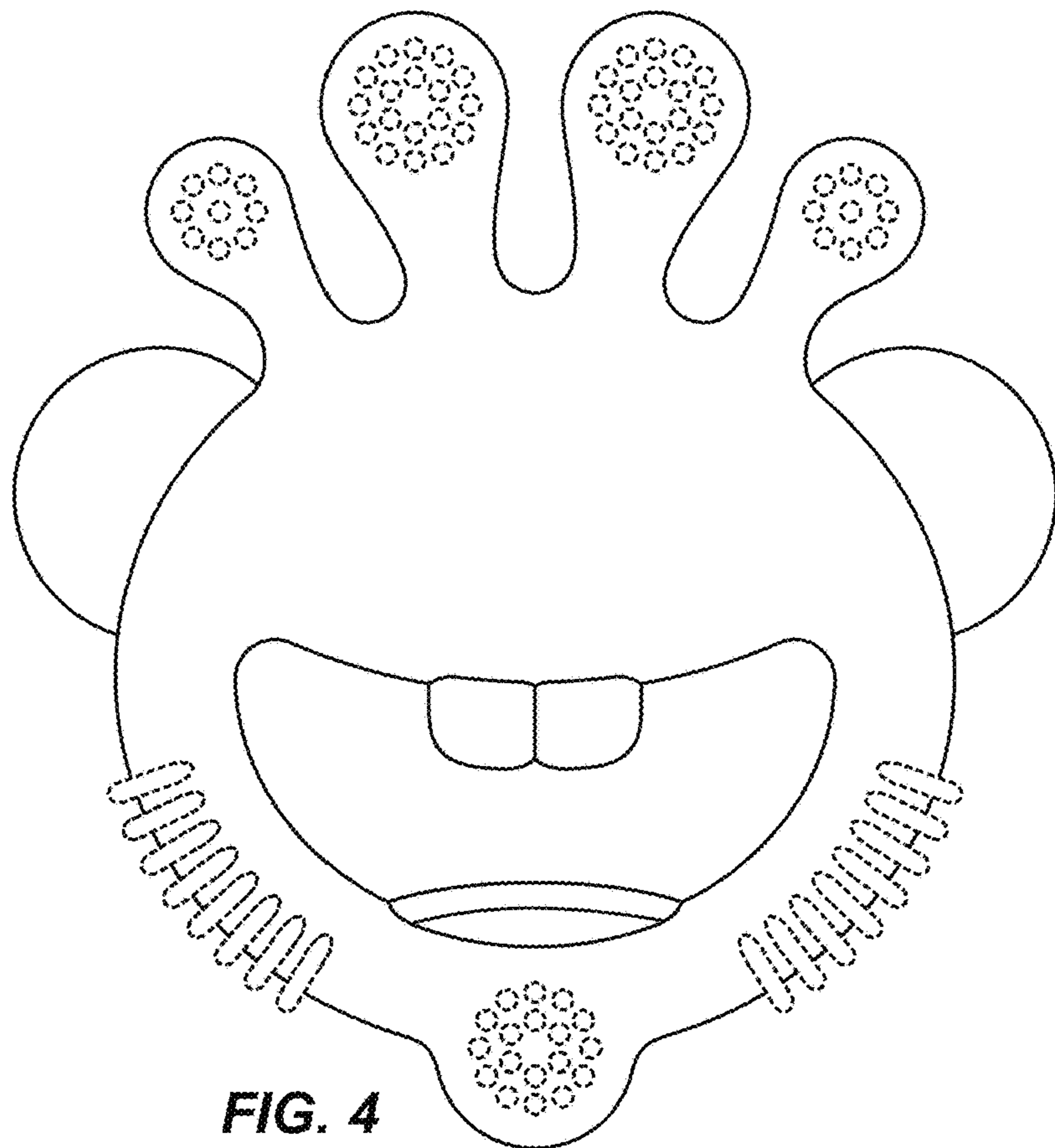

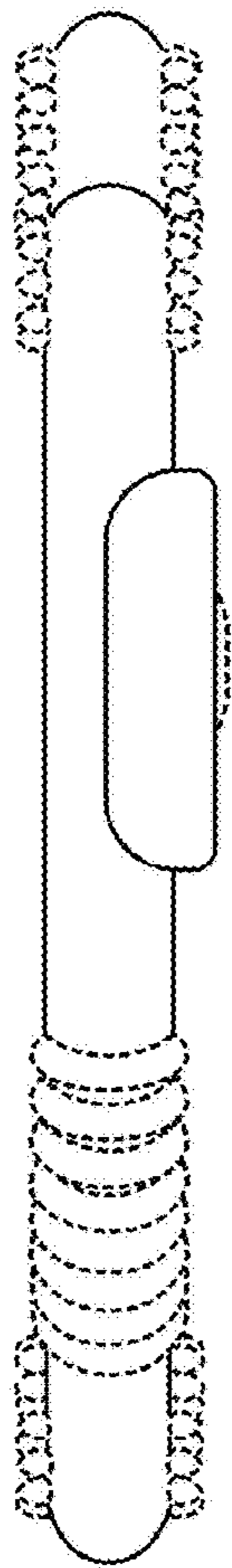




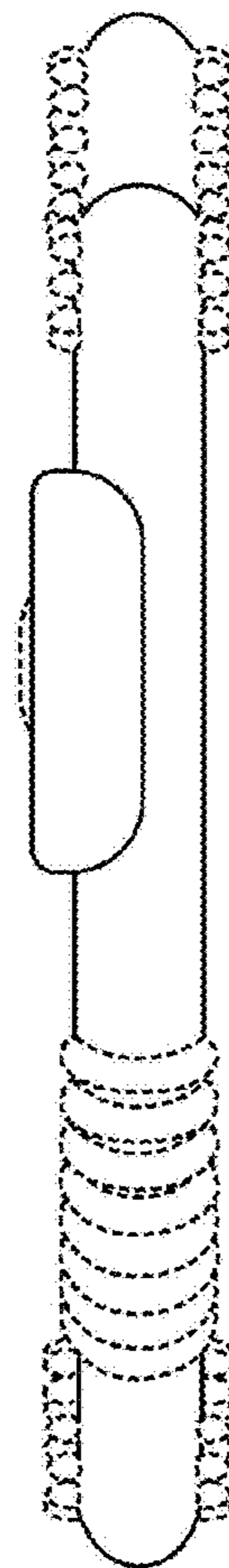

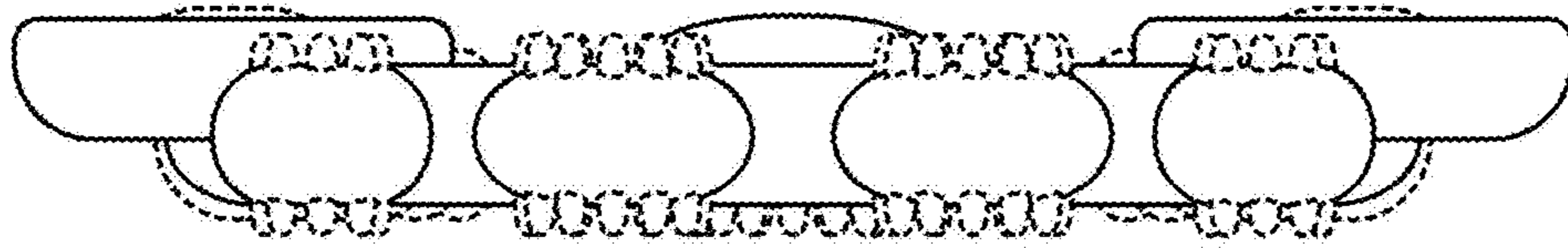

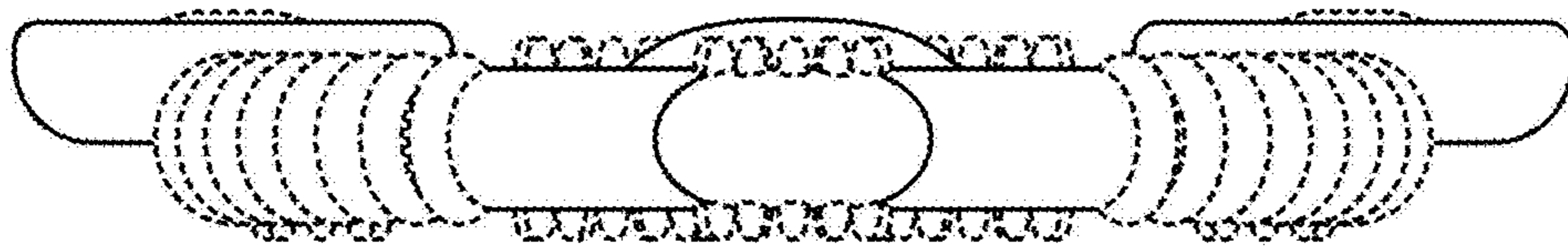
