(57) **CLAIM**

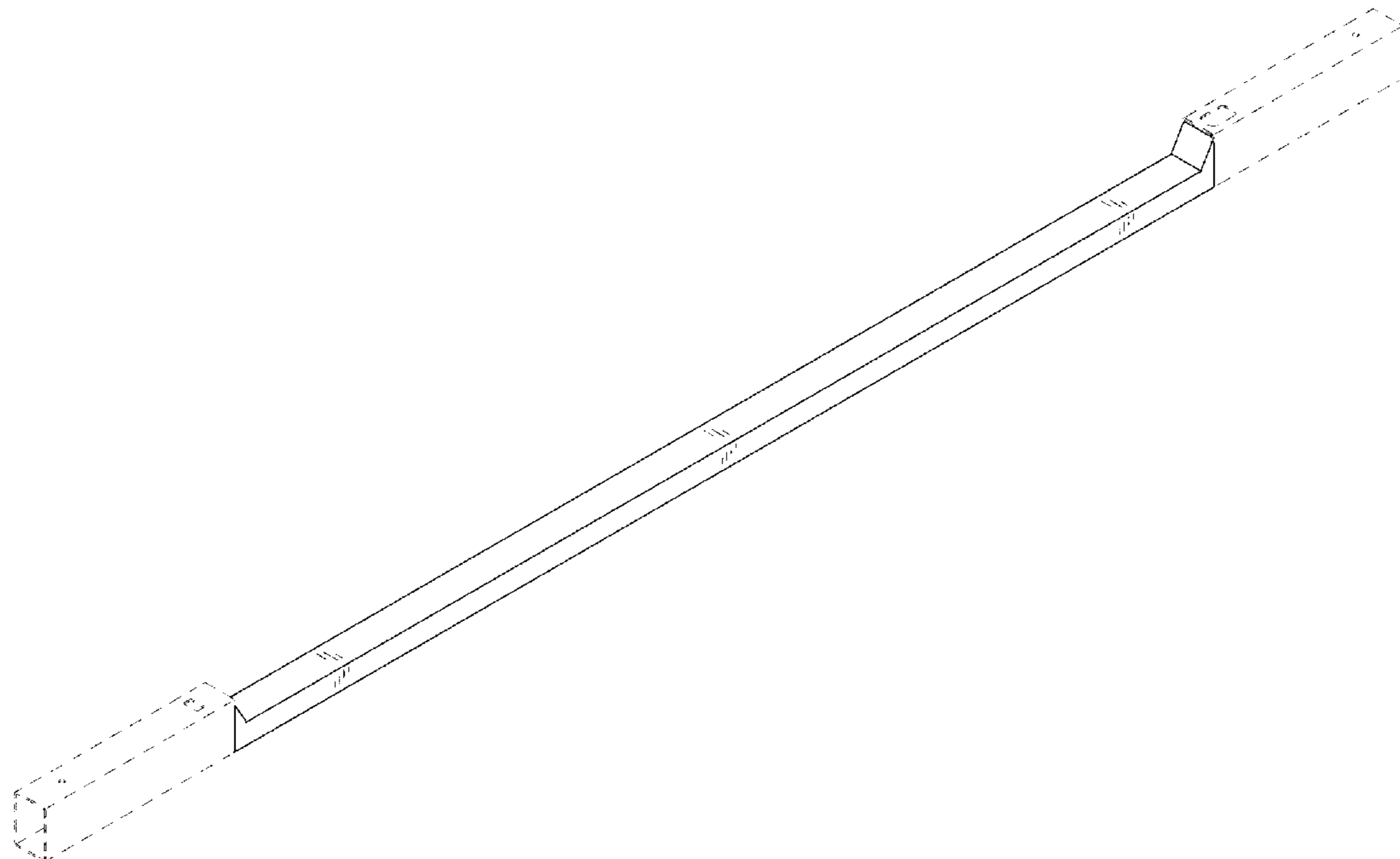
The ornamental design for a low-profile threshold of a safety gate, as shown and described.

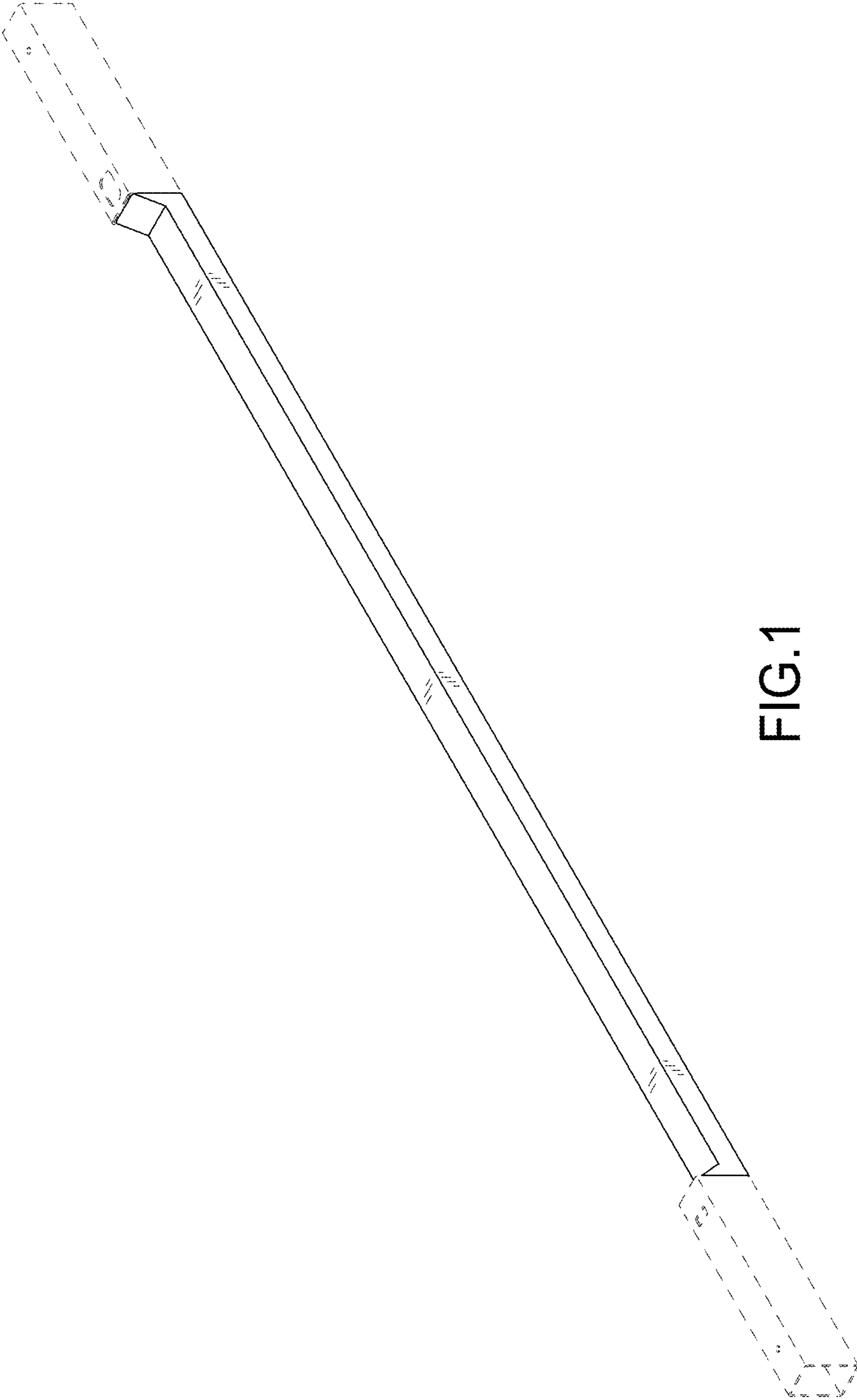

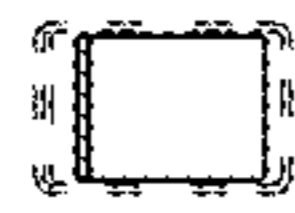

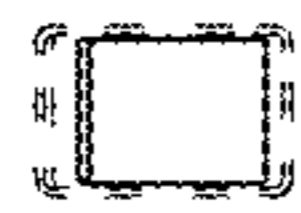

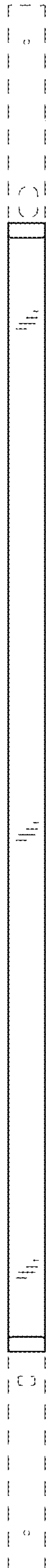

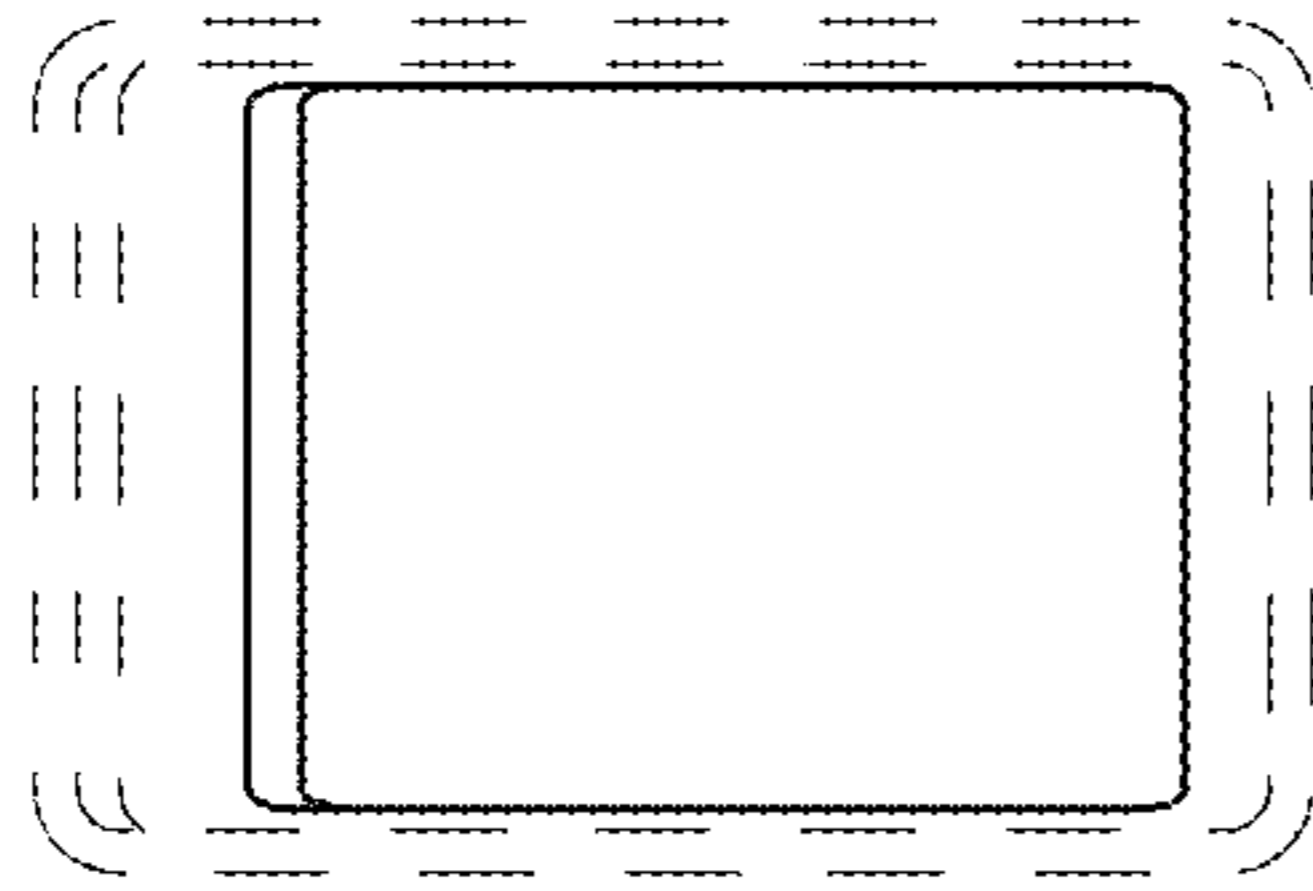

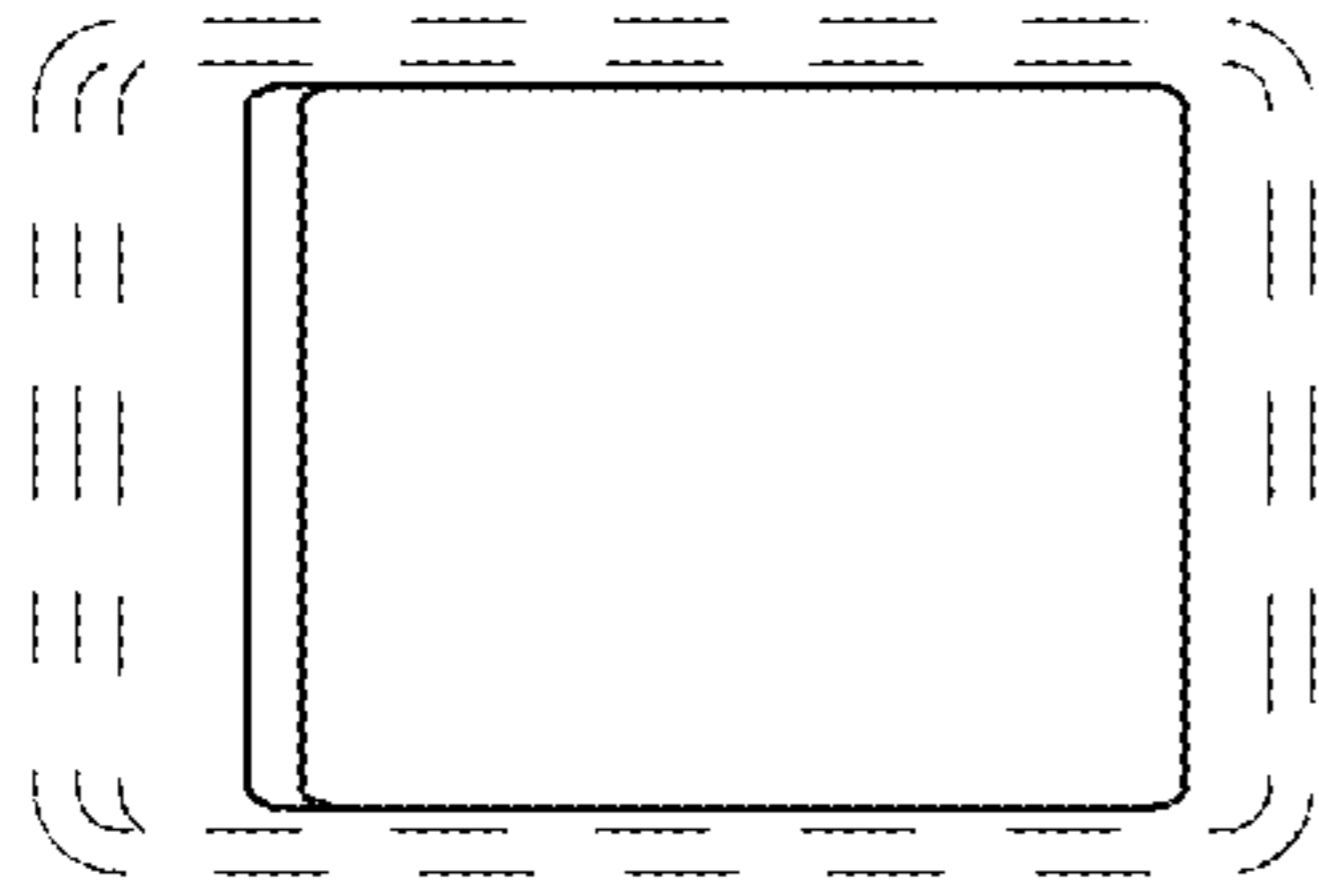

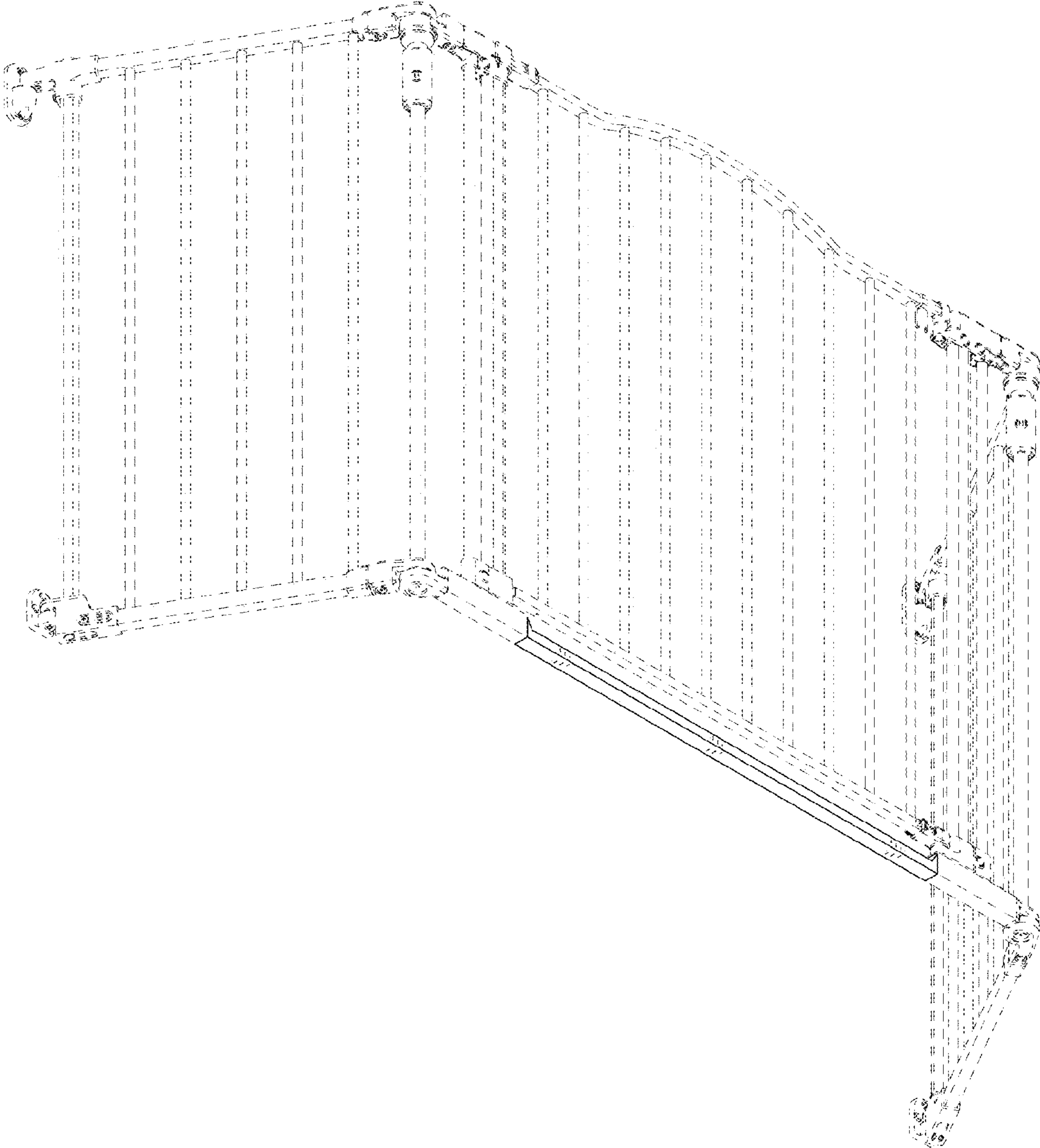
