FIG. 8 is a cross-sectional elevation view of the pressed shredded potato bowl of FIG. 1 taken on the line 8-8 in FIG. 1.

The pattern shown indicates the contribution of pressed, shredded potato pieces to the appearance of the pressed shredded potato bowl.

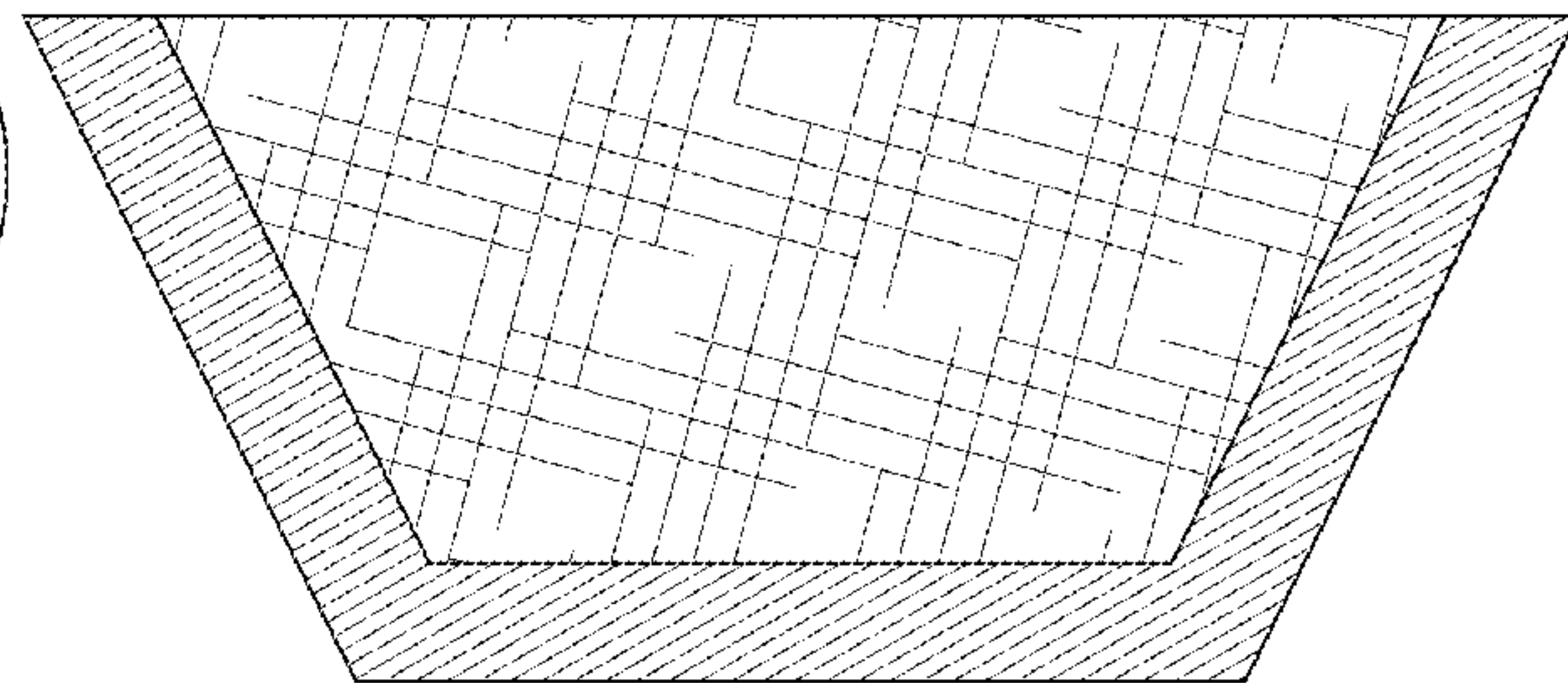
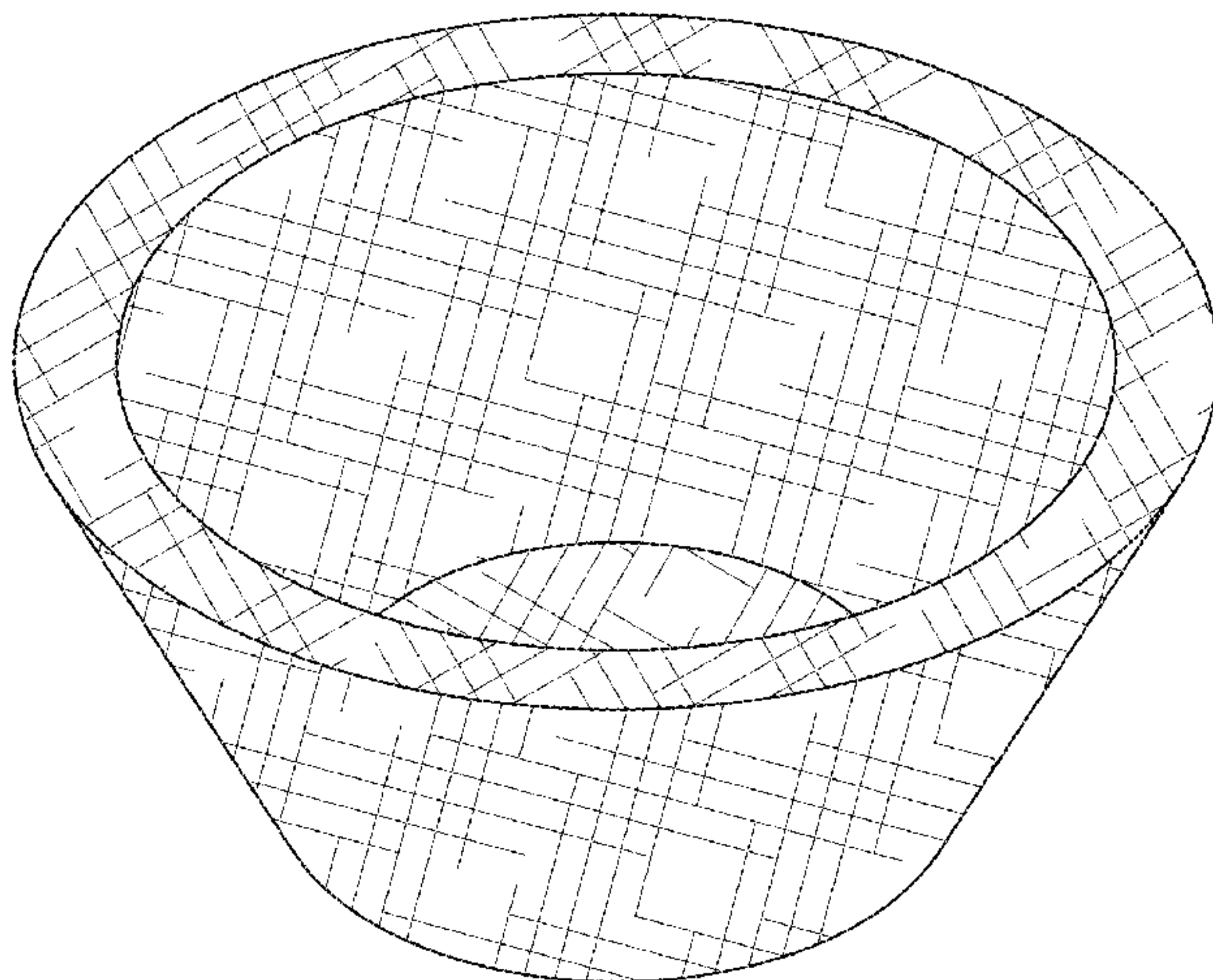

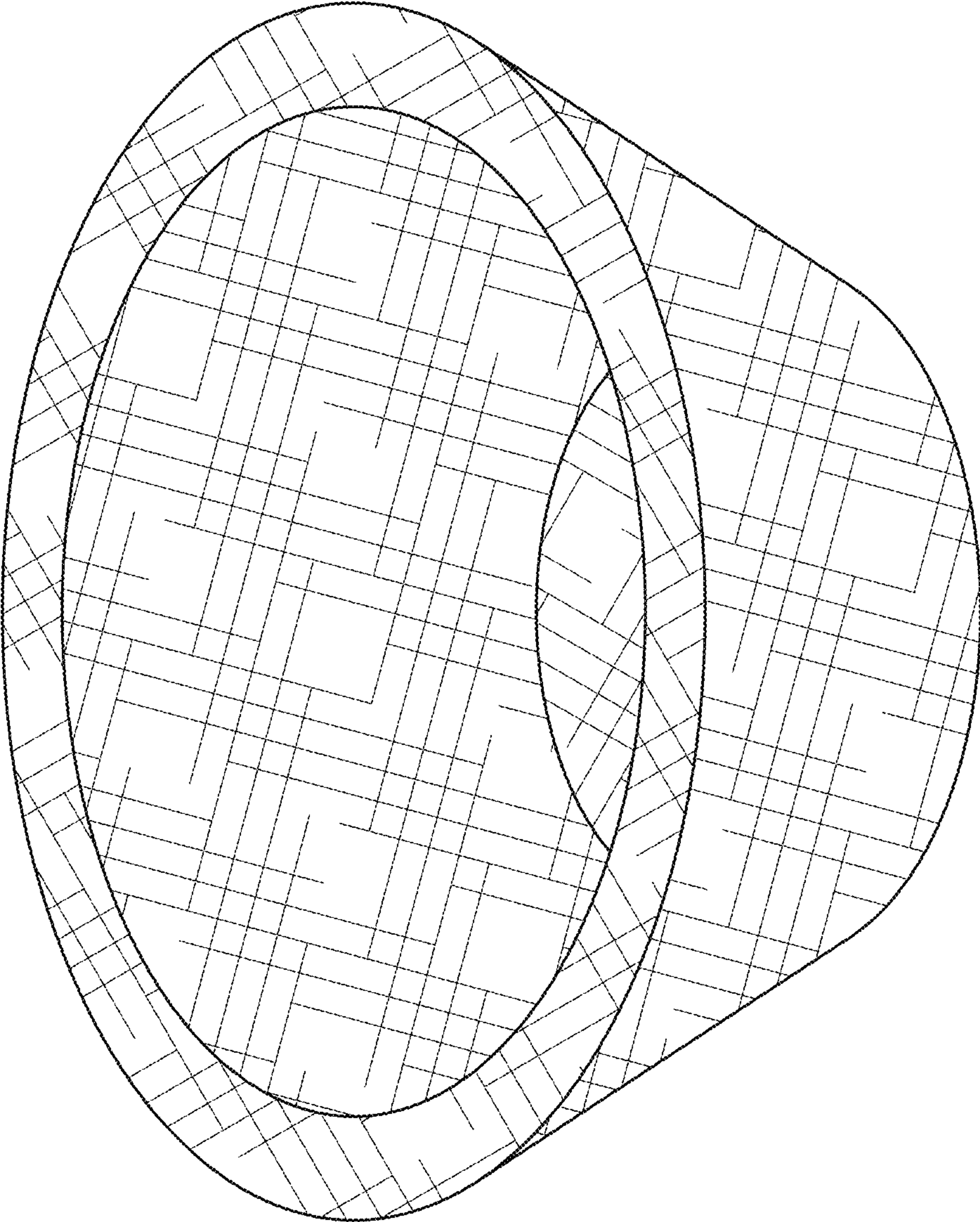

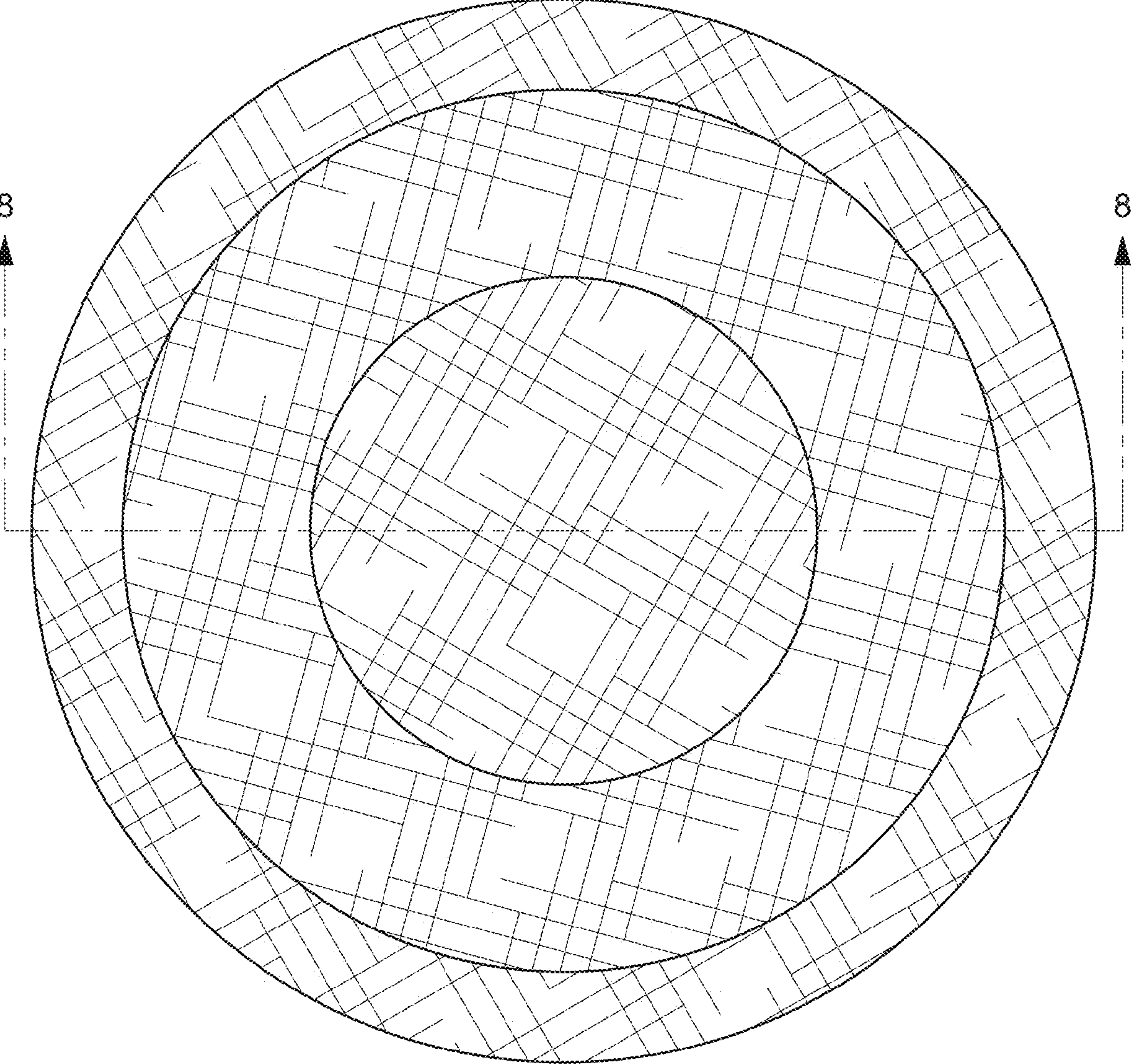

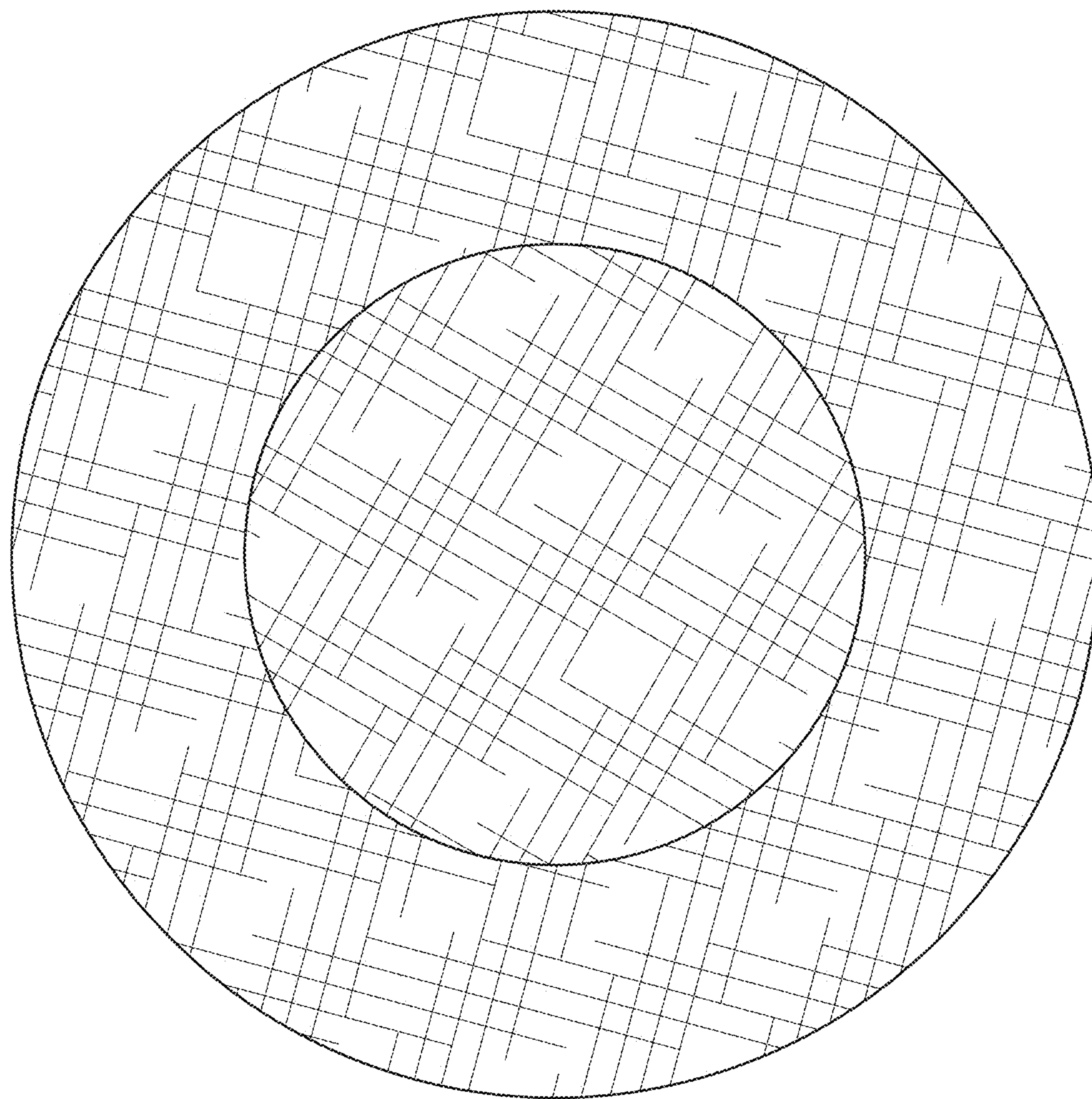

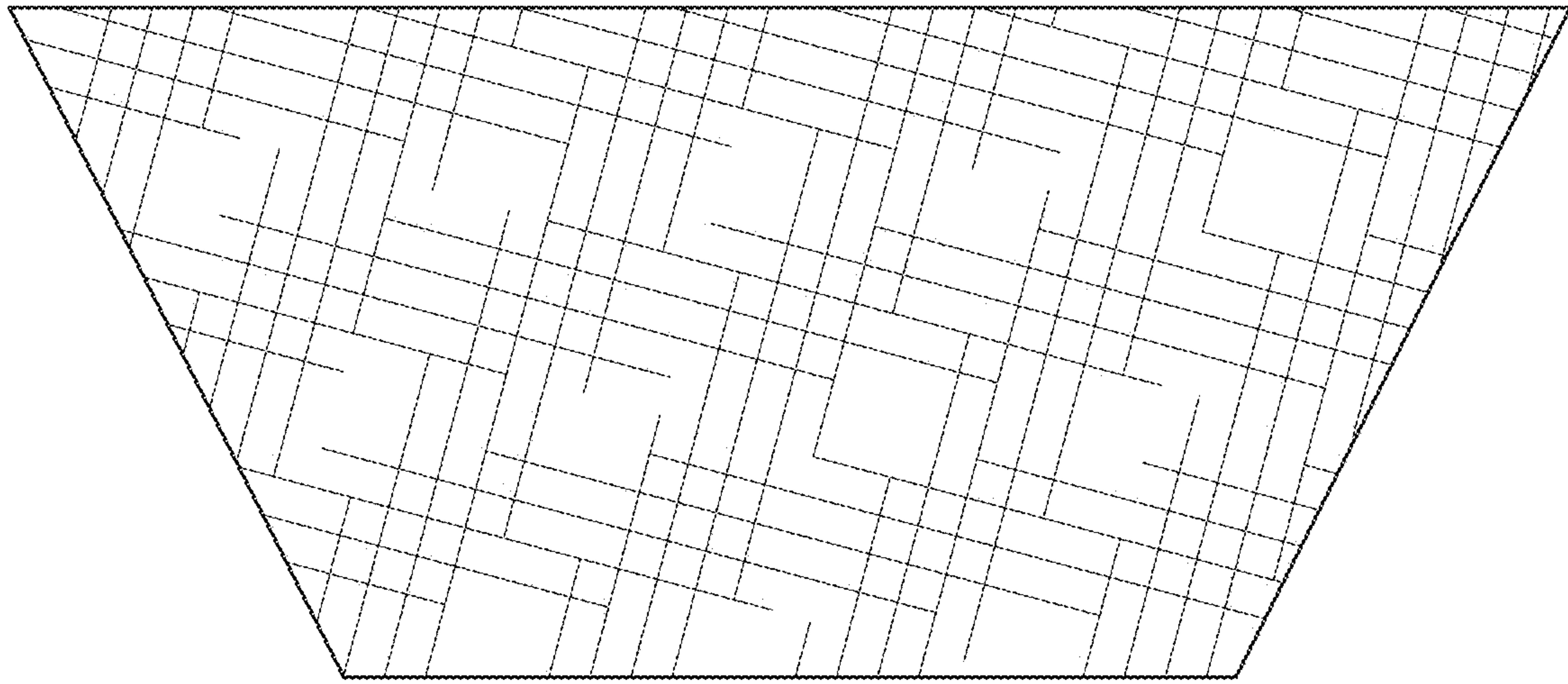

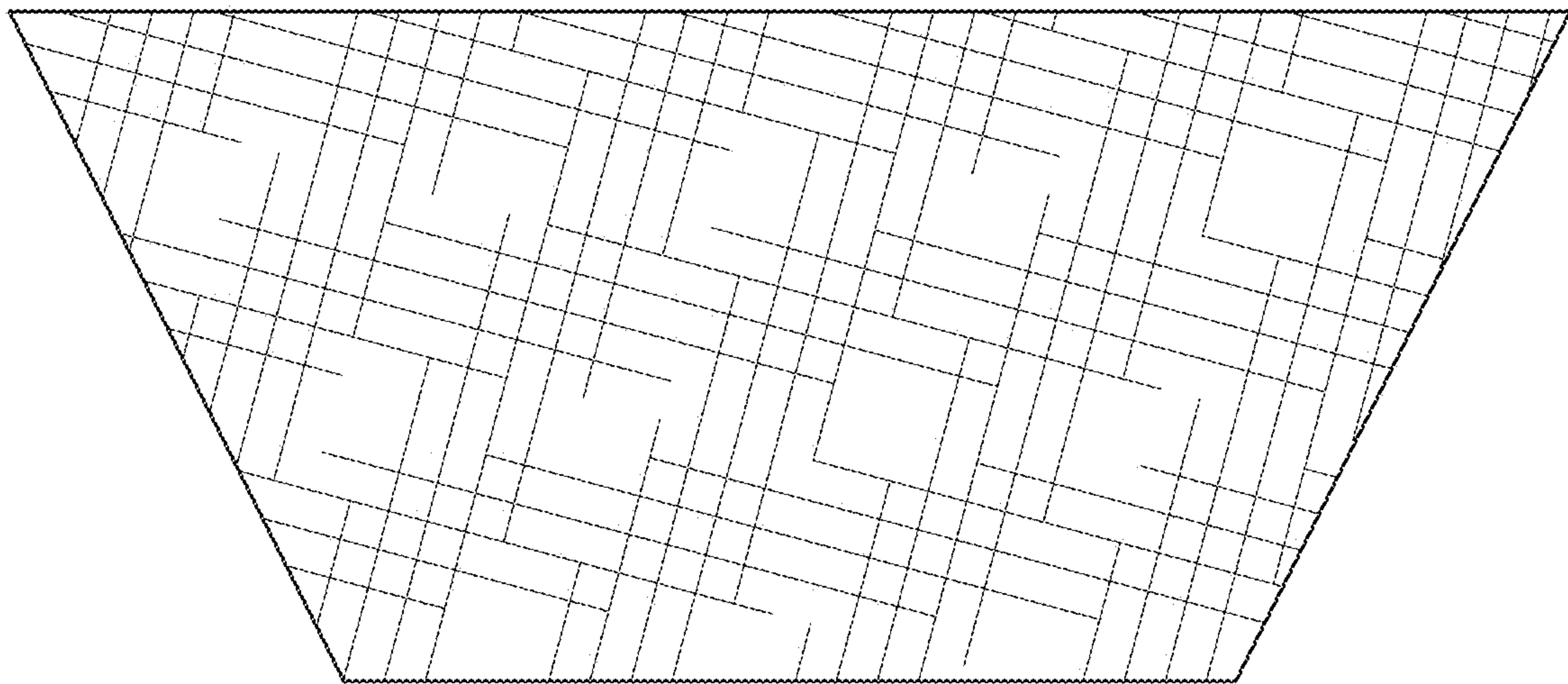

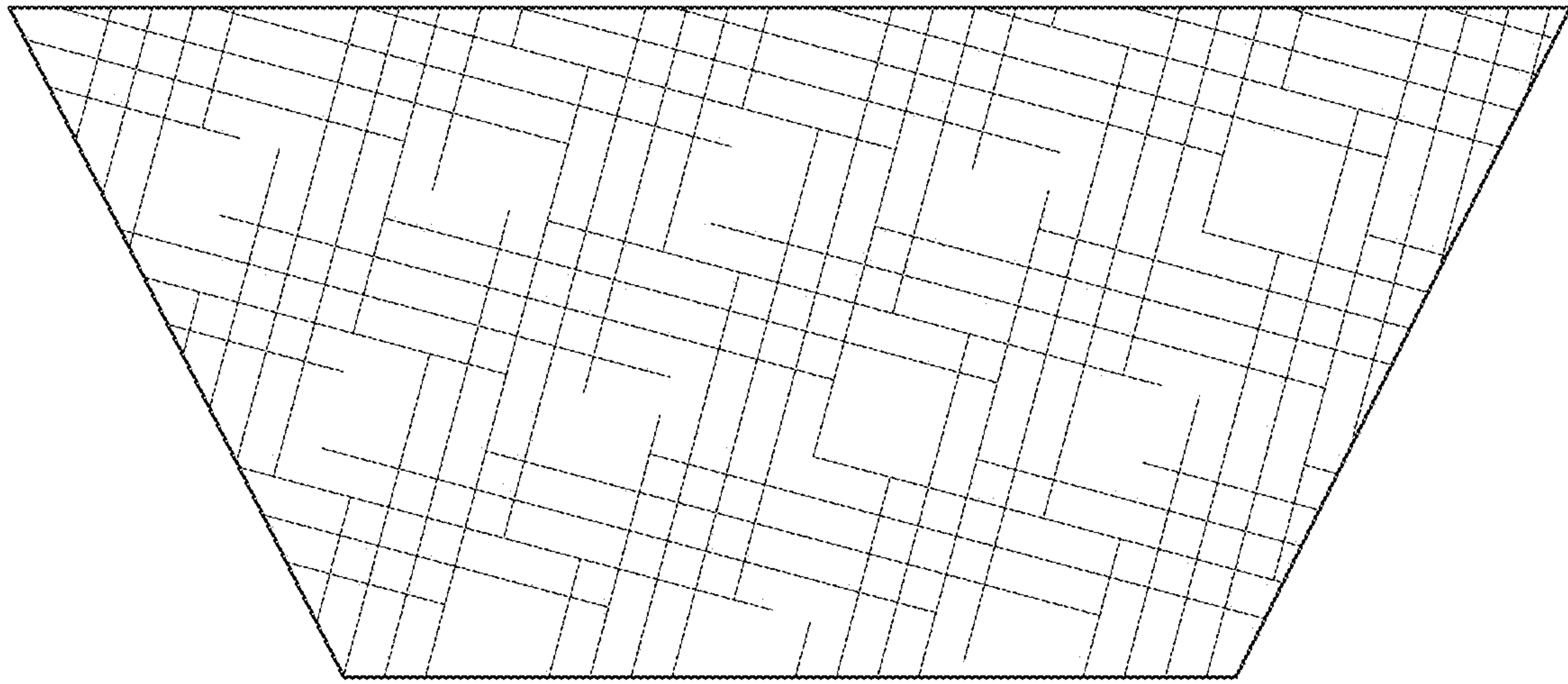

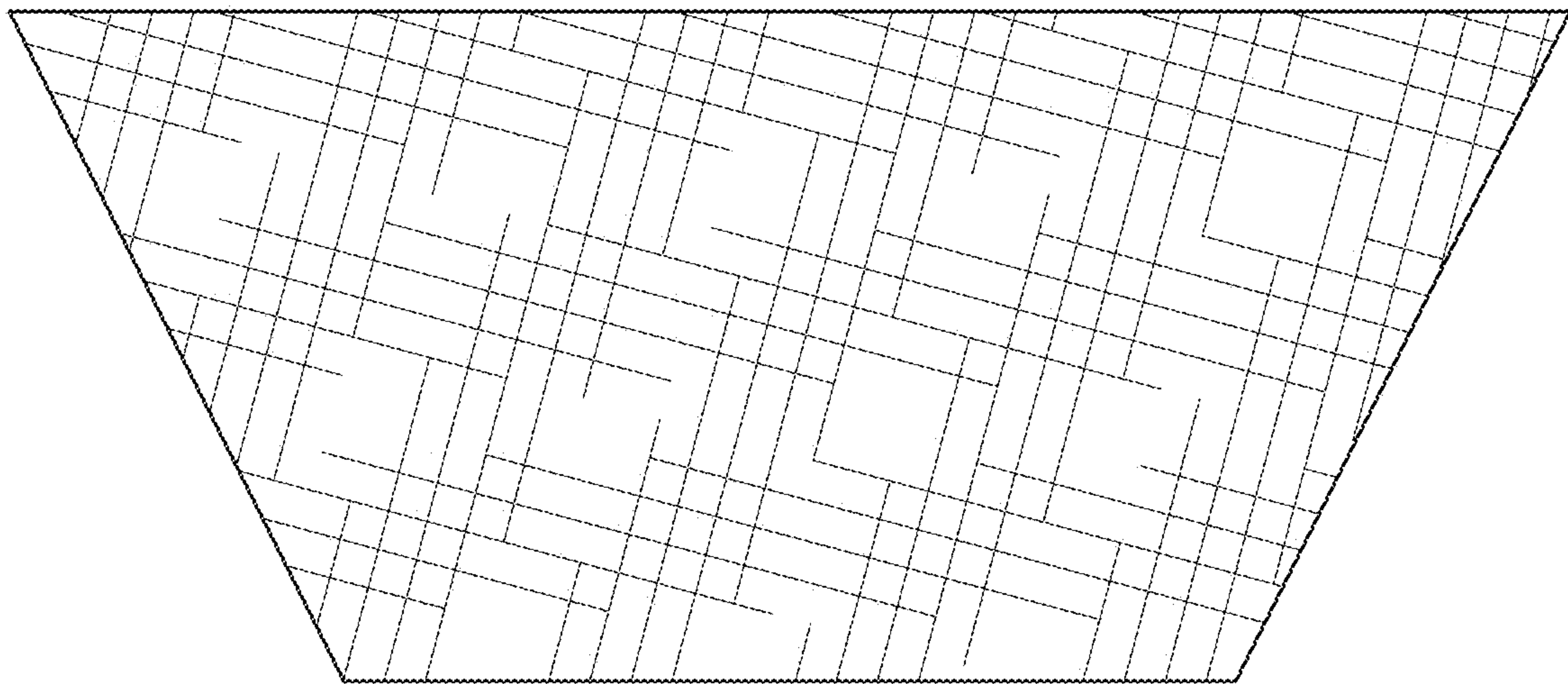

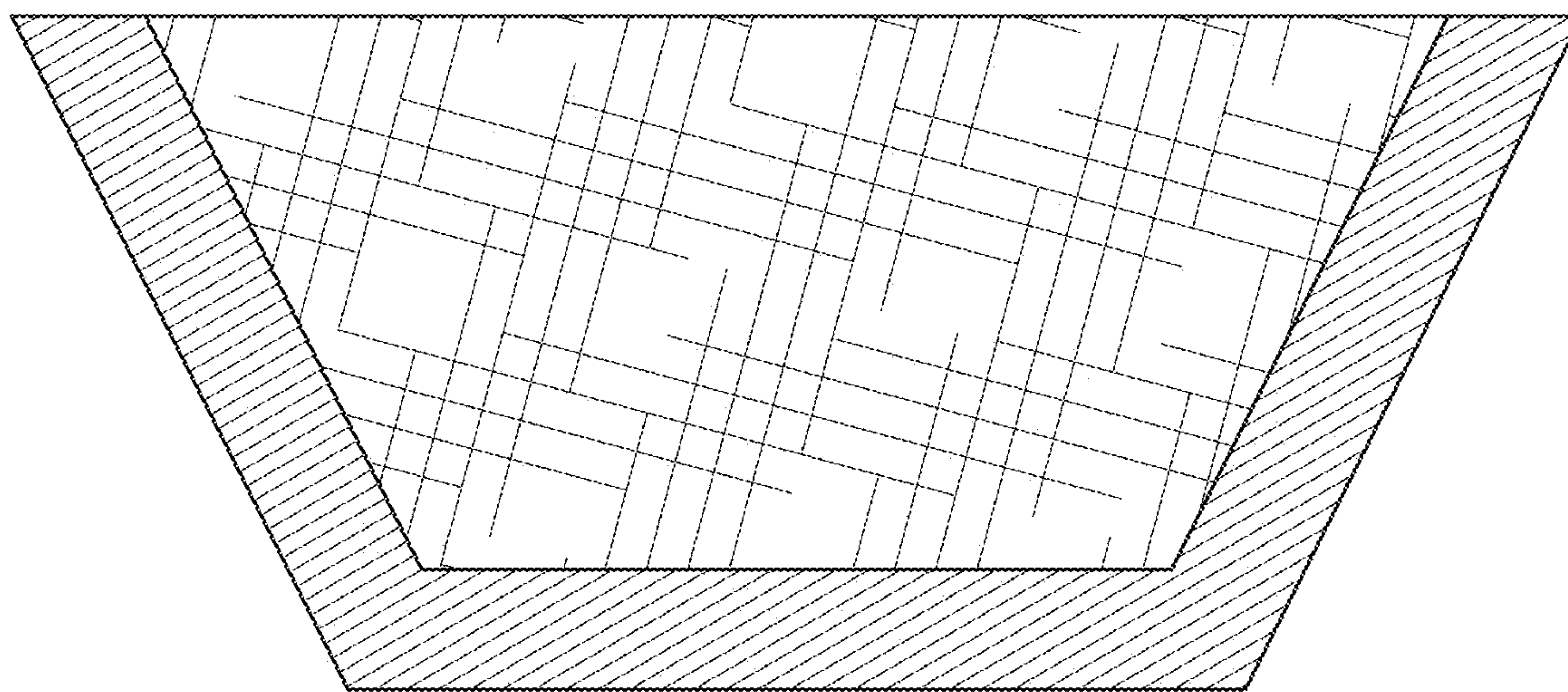
