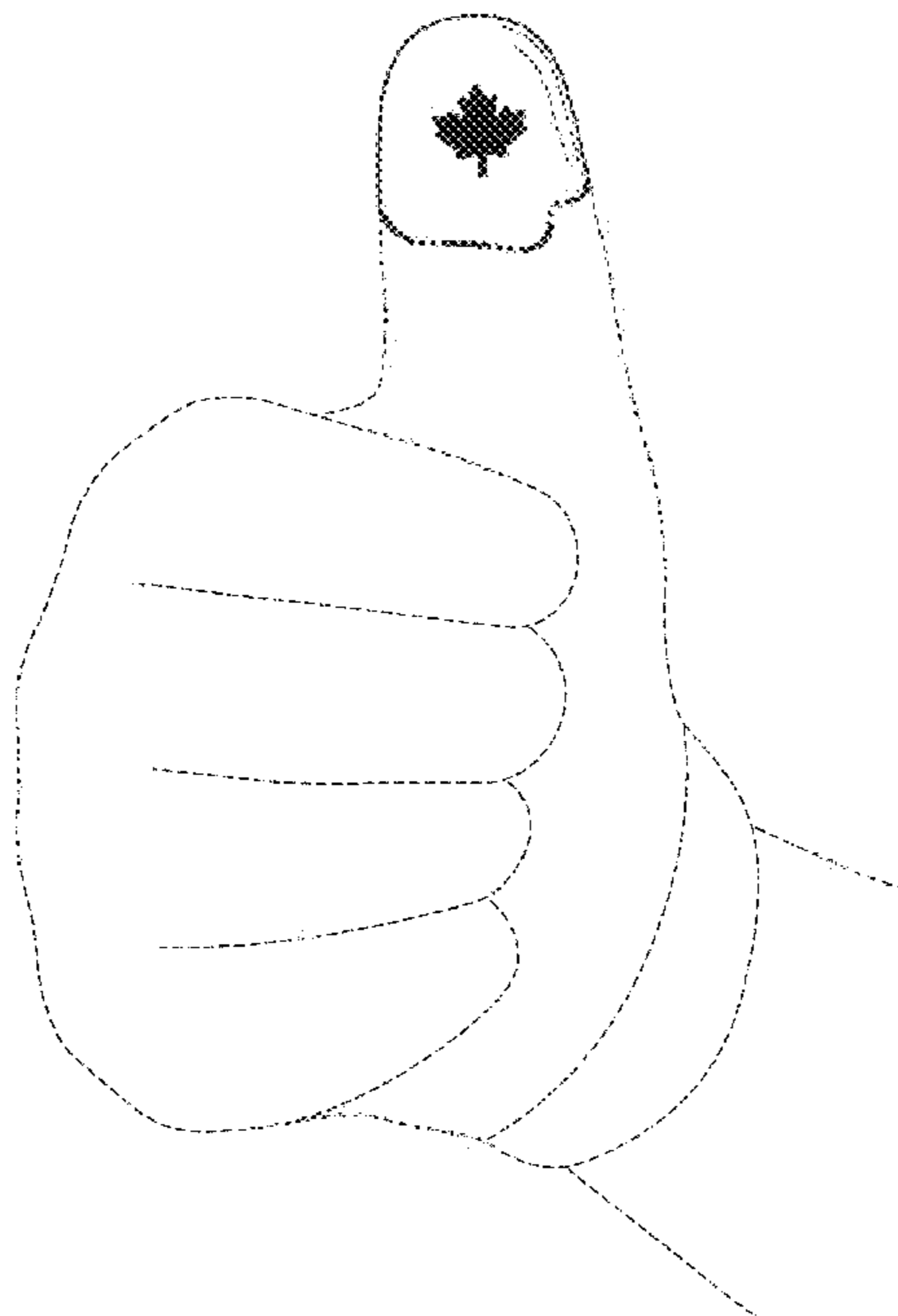
The ornamental design for a hand covering, as shown and described.

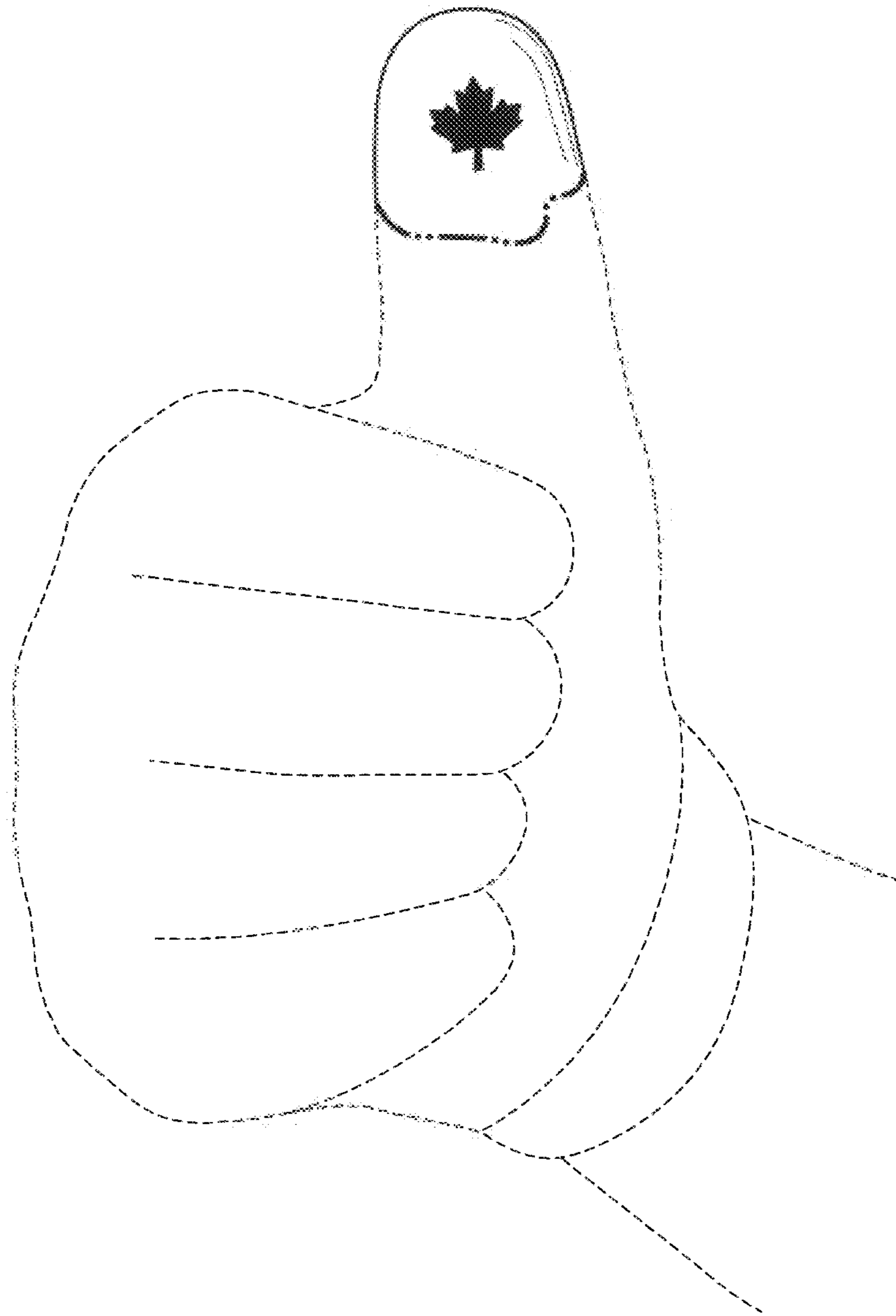

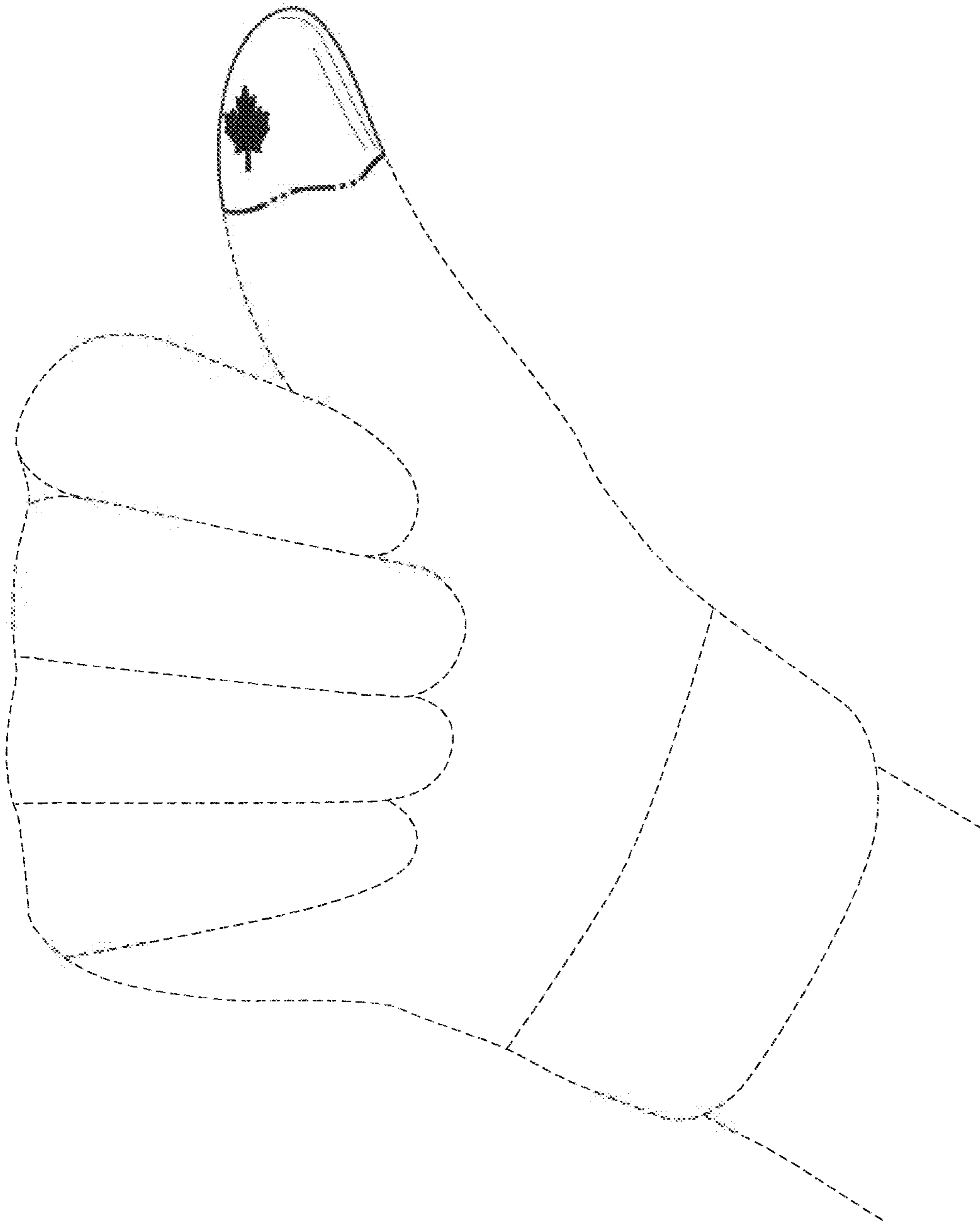
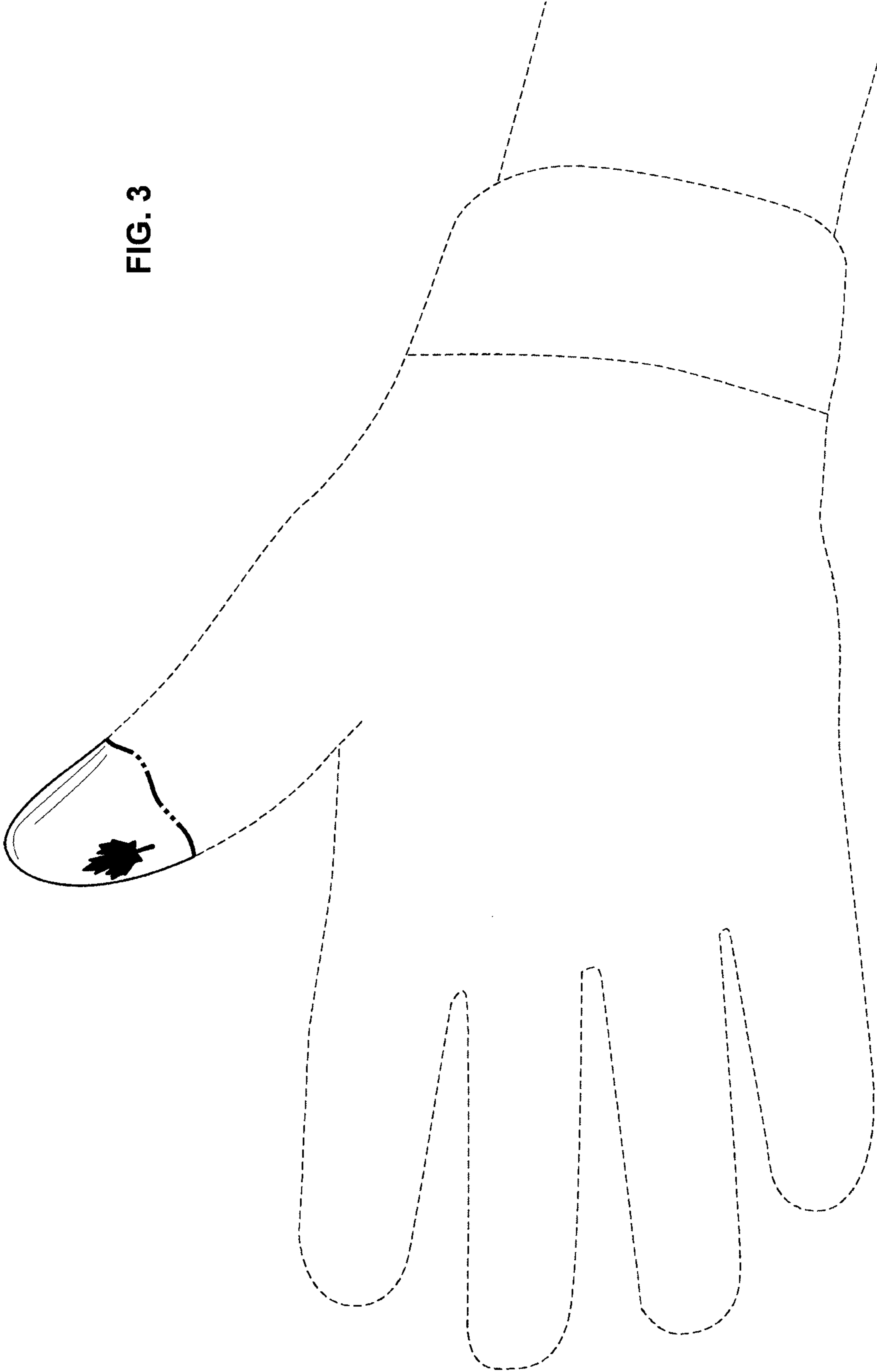

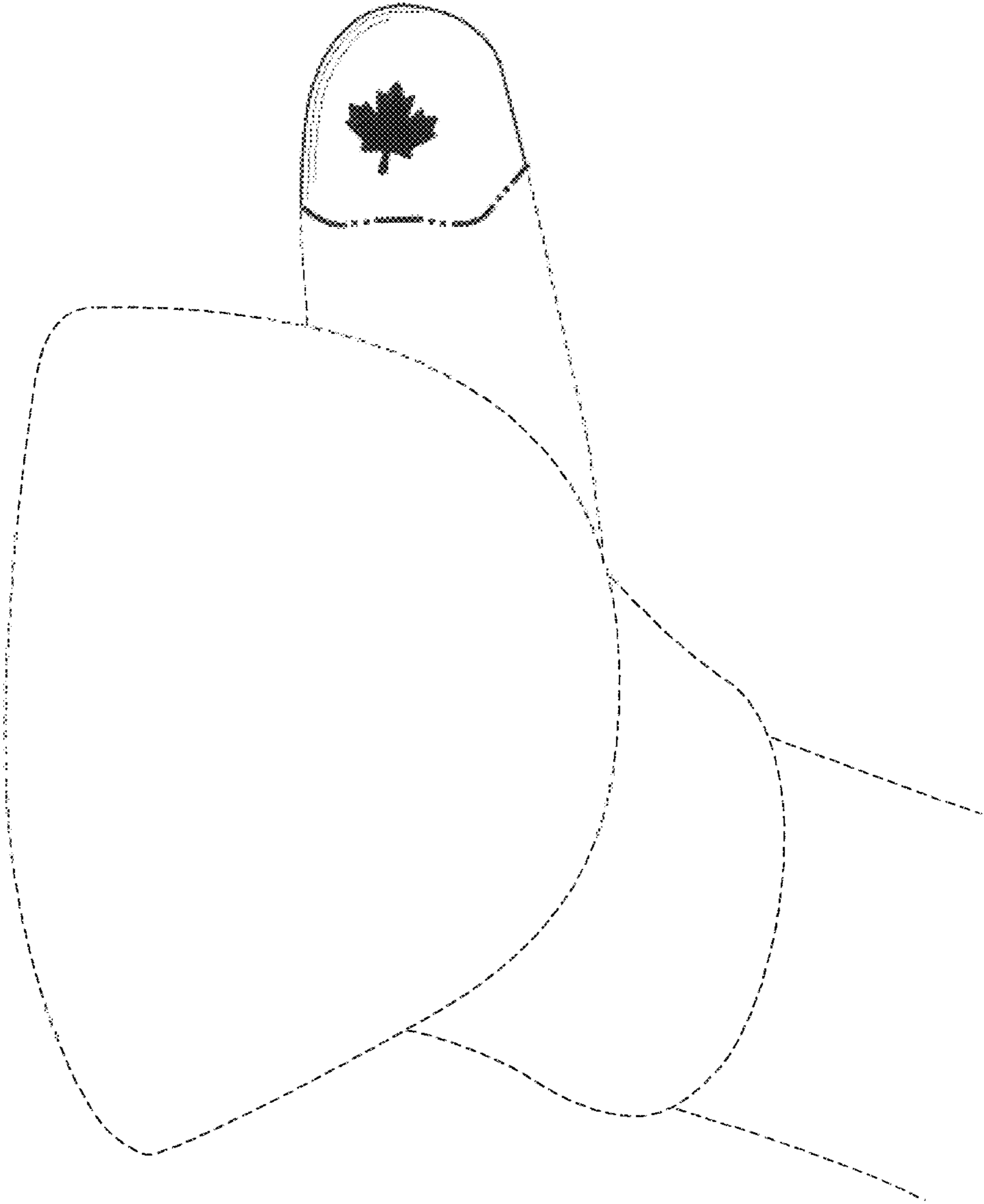

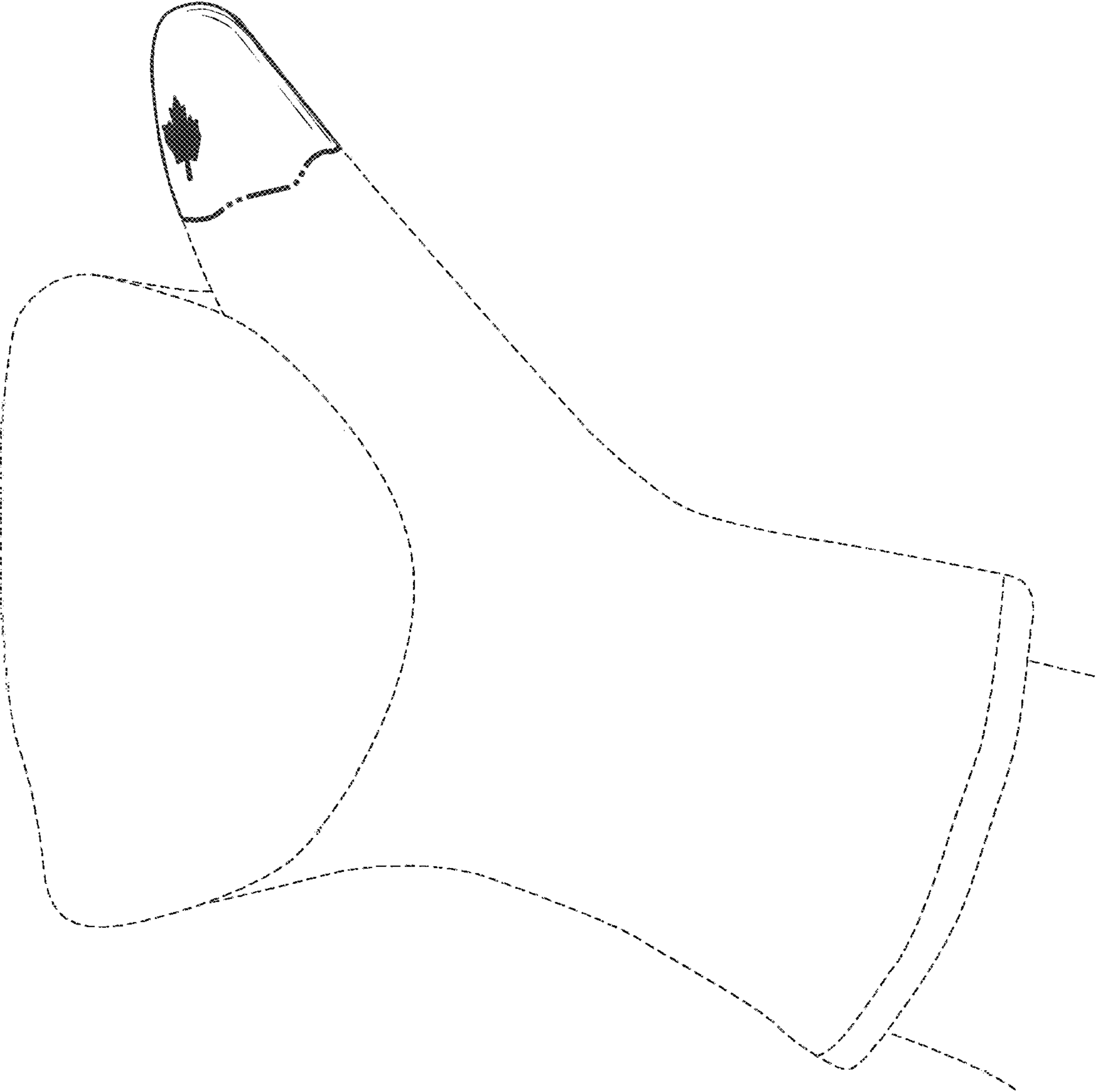
