(57) **CLAIM**

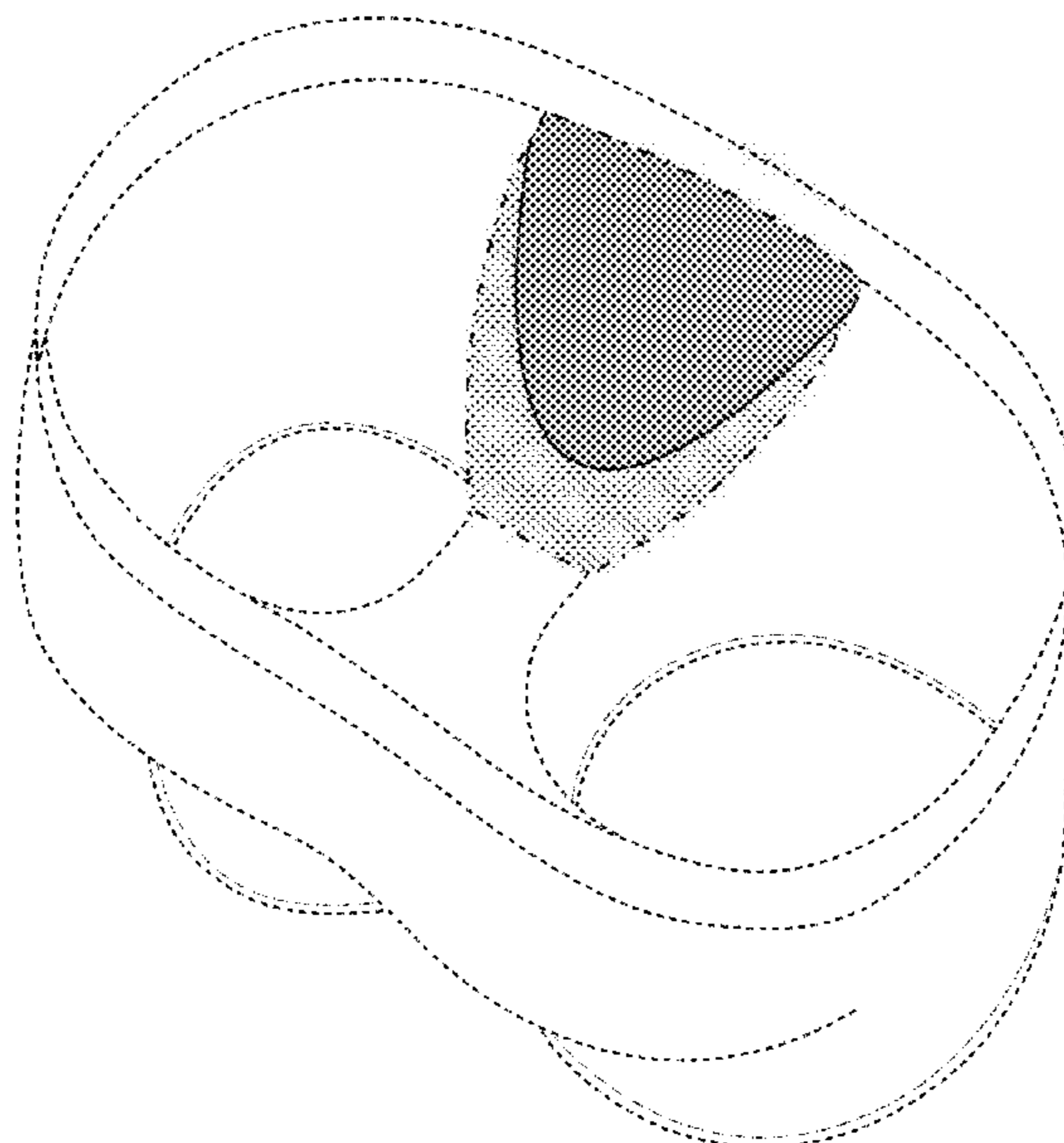
The ornamental design for a a molded pouch with inner mesh fabric lining for a man's brief, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a molded pouch with inner mesh fabric lining for a man's brief;
FIG. 2 is front view of a molded pouch with inner mesh fabric lining for a man's brief;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a top plan view of a molded pouch with inner mesh fabric lining or a man's brief; and,
FIG. 6 is a bottom view thereof.

The evenly spaced broken lines shown in the drawings depict portions of the man's brief that form no part of the claimed design. The dash-dot broken lines in the drawings depict the boundaries of the claim and form no part of the claimed design.

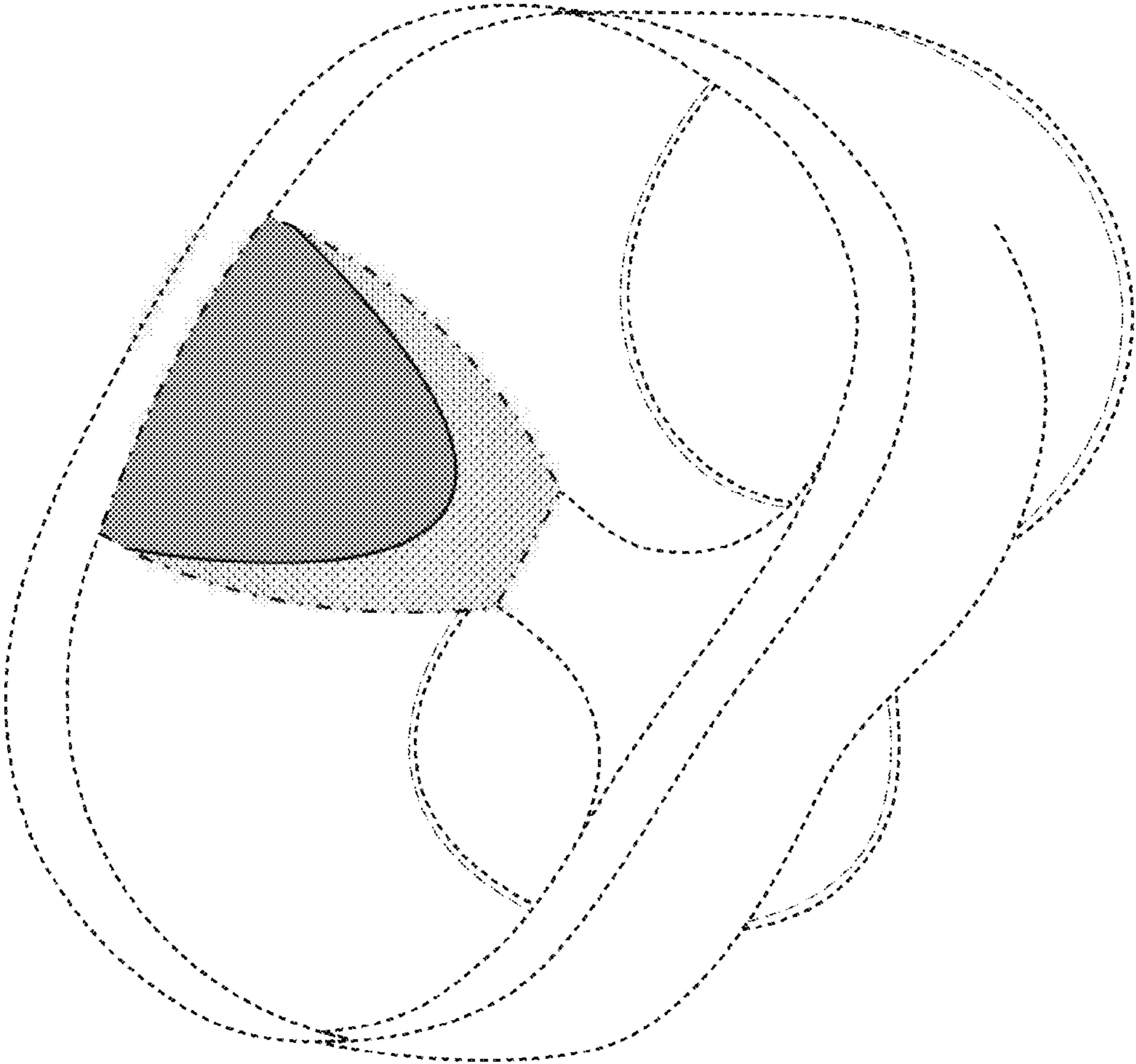

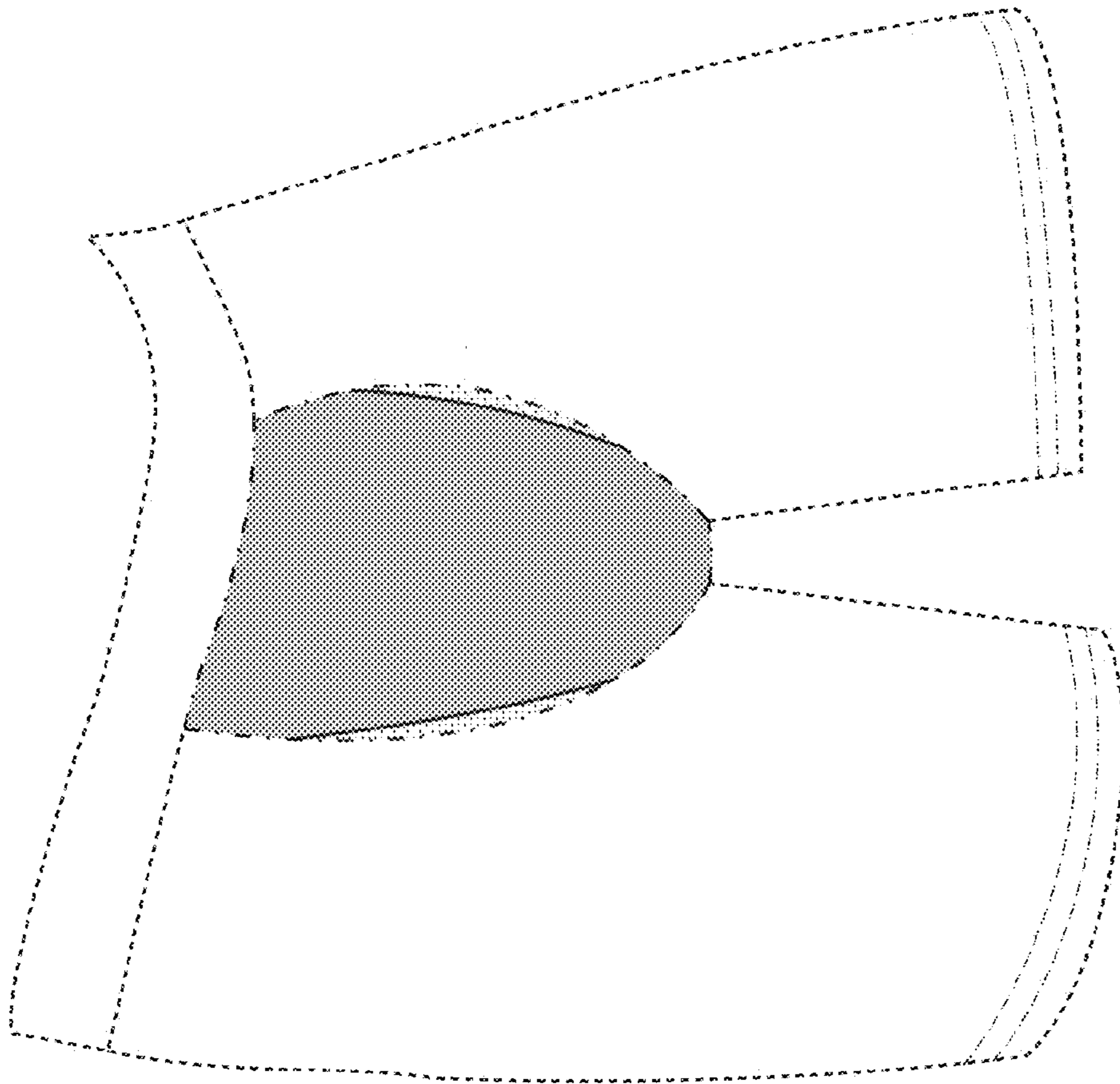

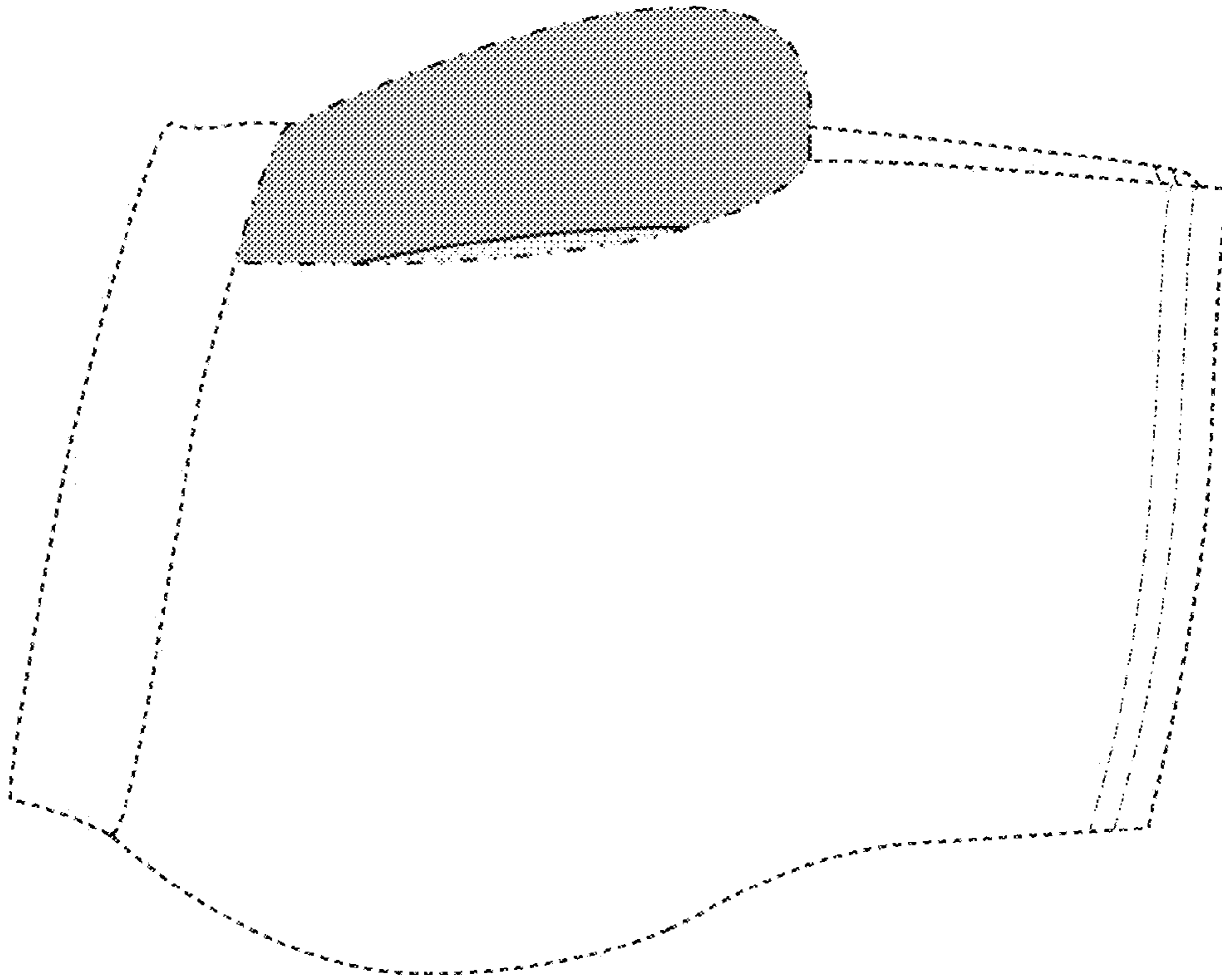

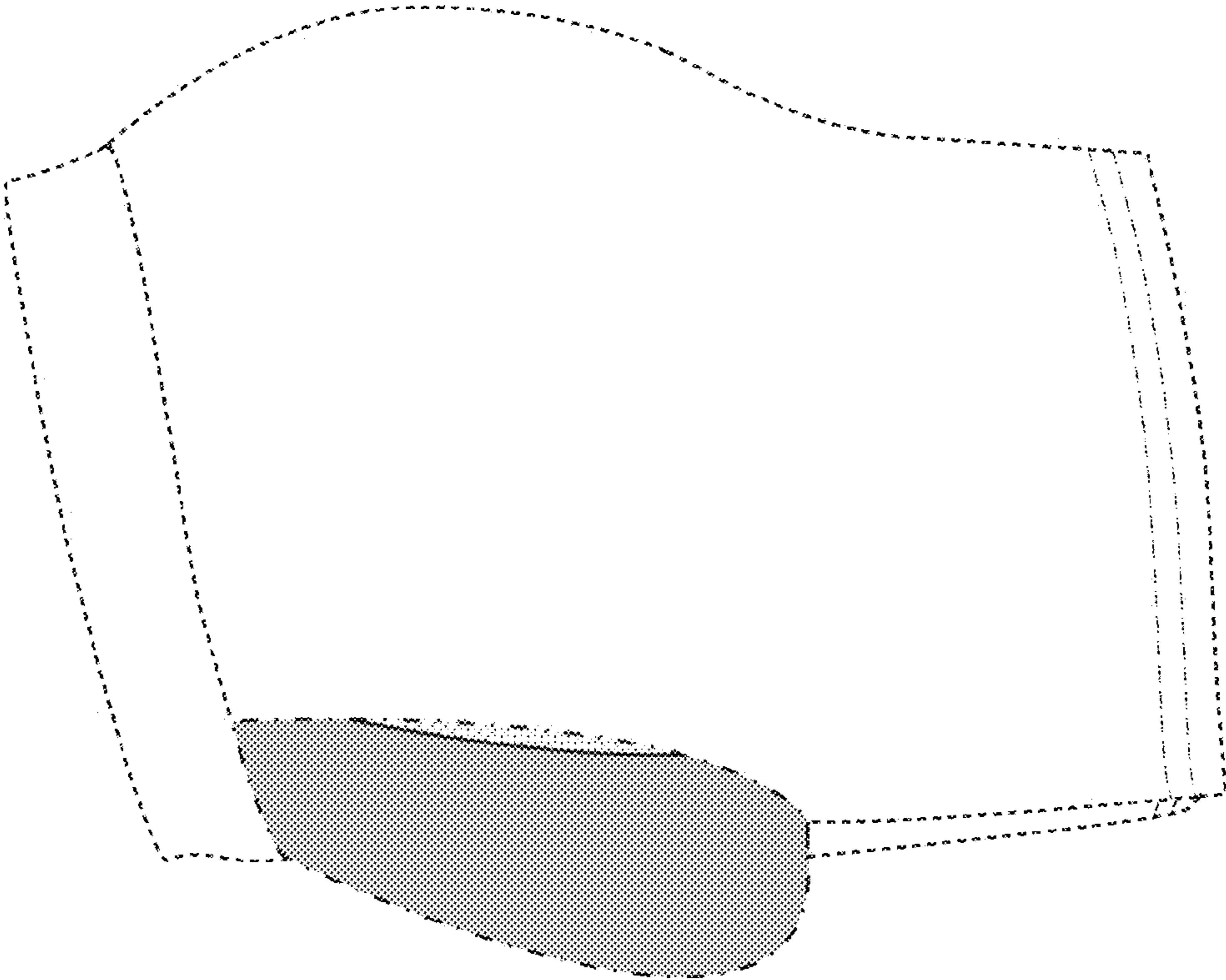

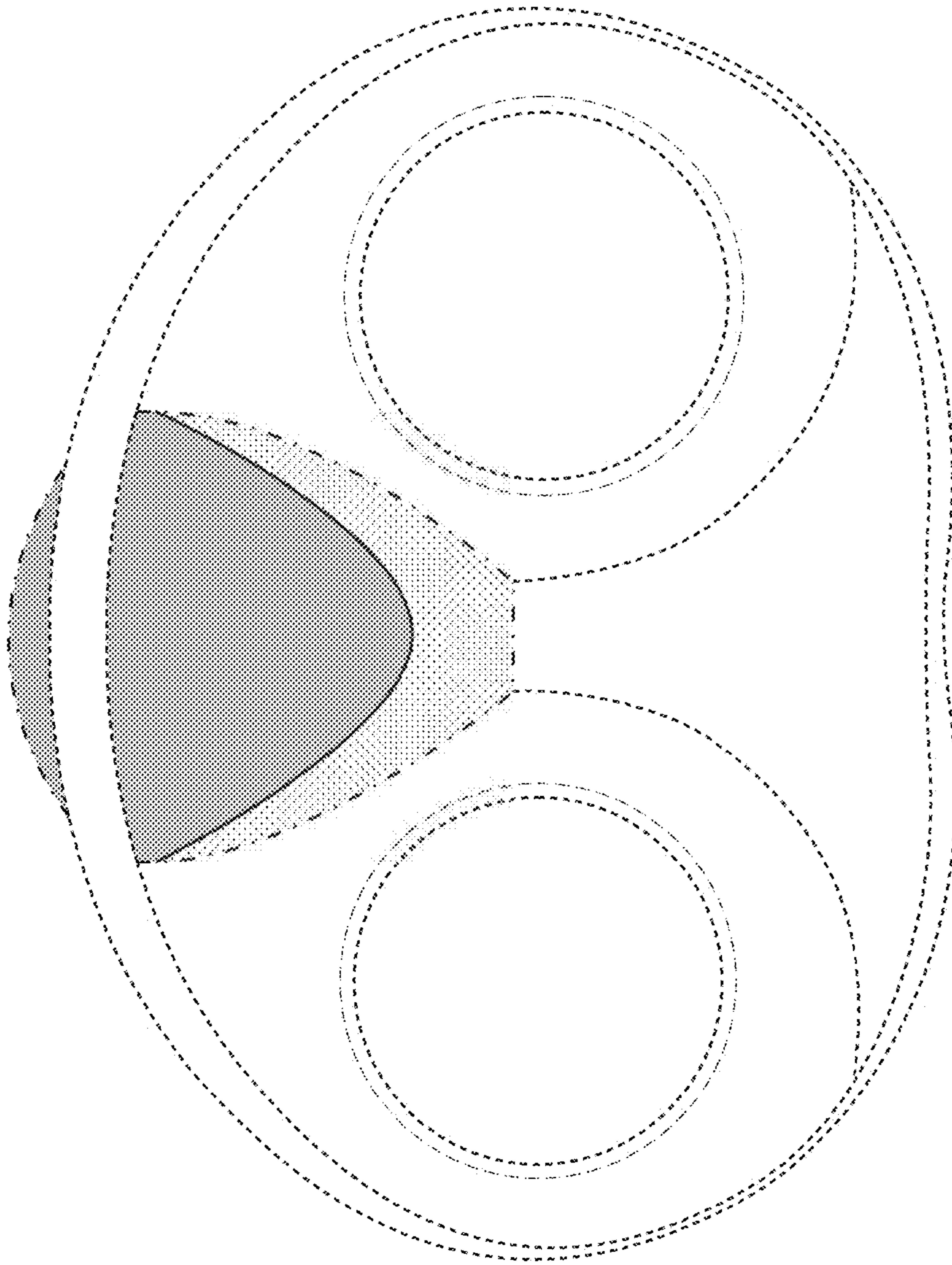

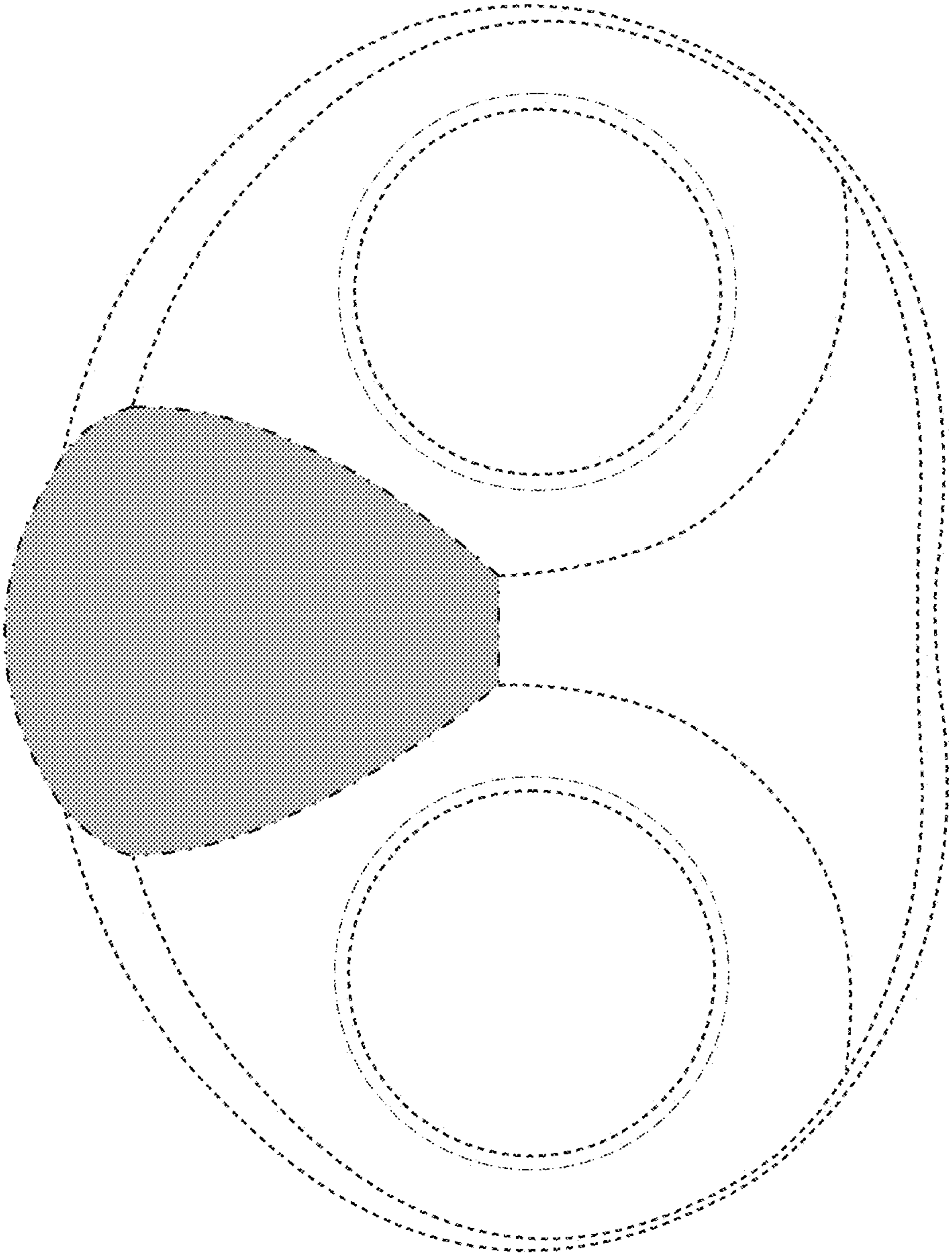
