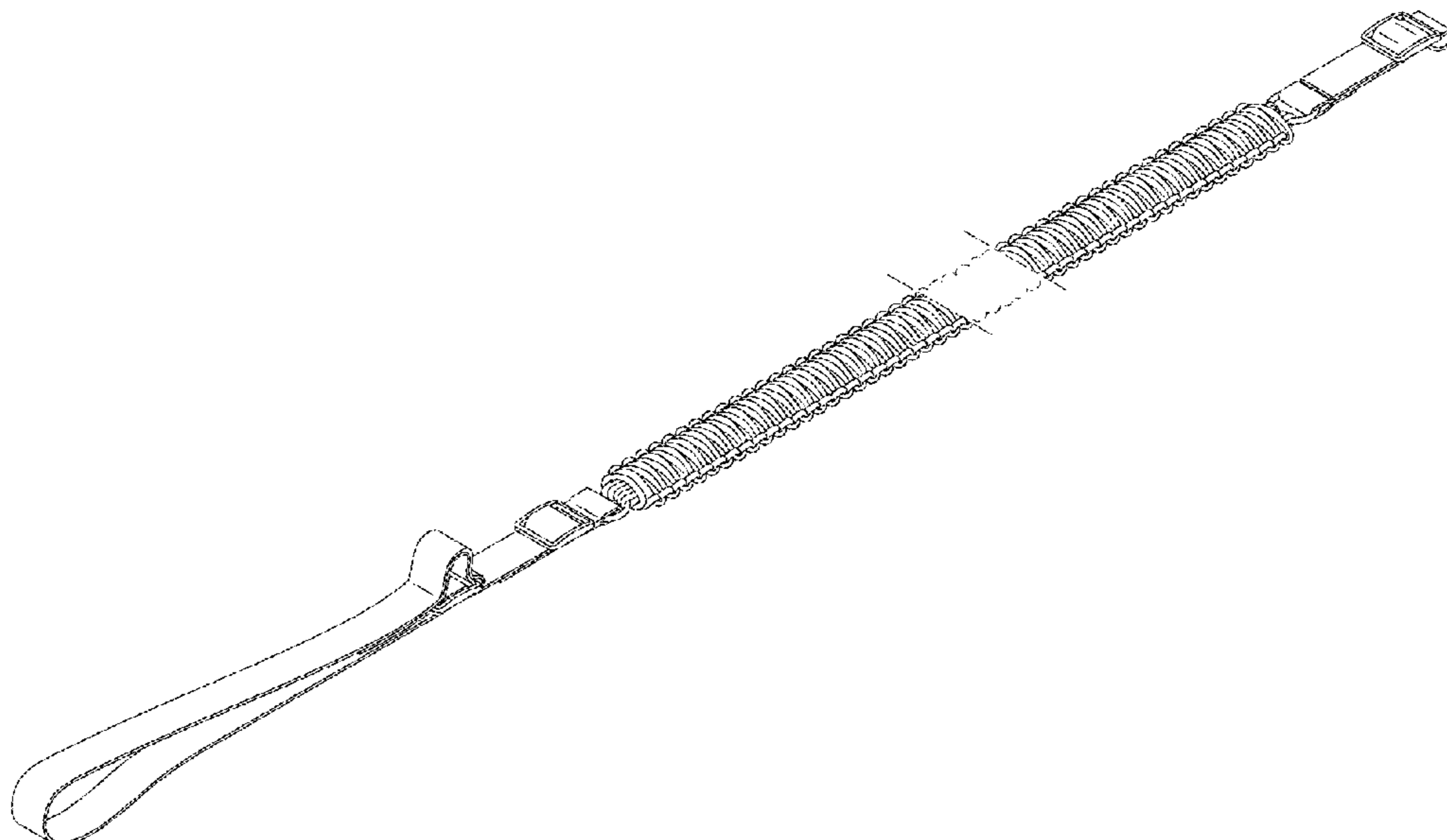
(57) **CLAIM**

The ornamental design for a sling for firearm, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of the sling for a firearm showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a right side elevation view thereof;
 FIG. 5 is a left side elevation view thereof;
 FIG. 6 is a front elevation view thereof; and,
 FIG. 7 is a rear elevation view thereof.
 The sling for firearm is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

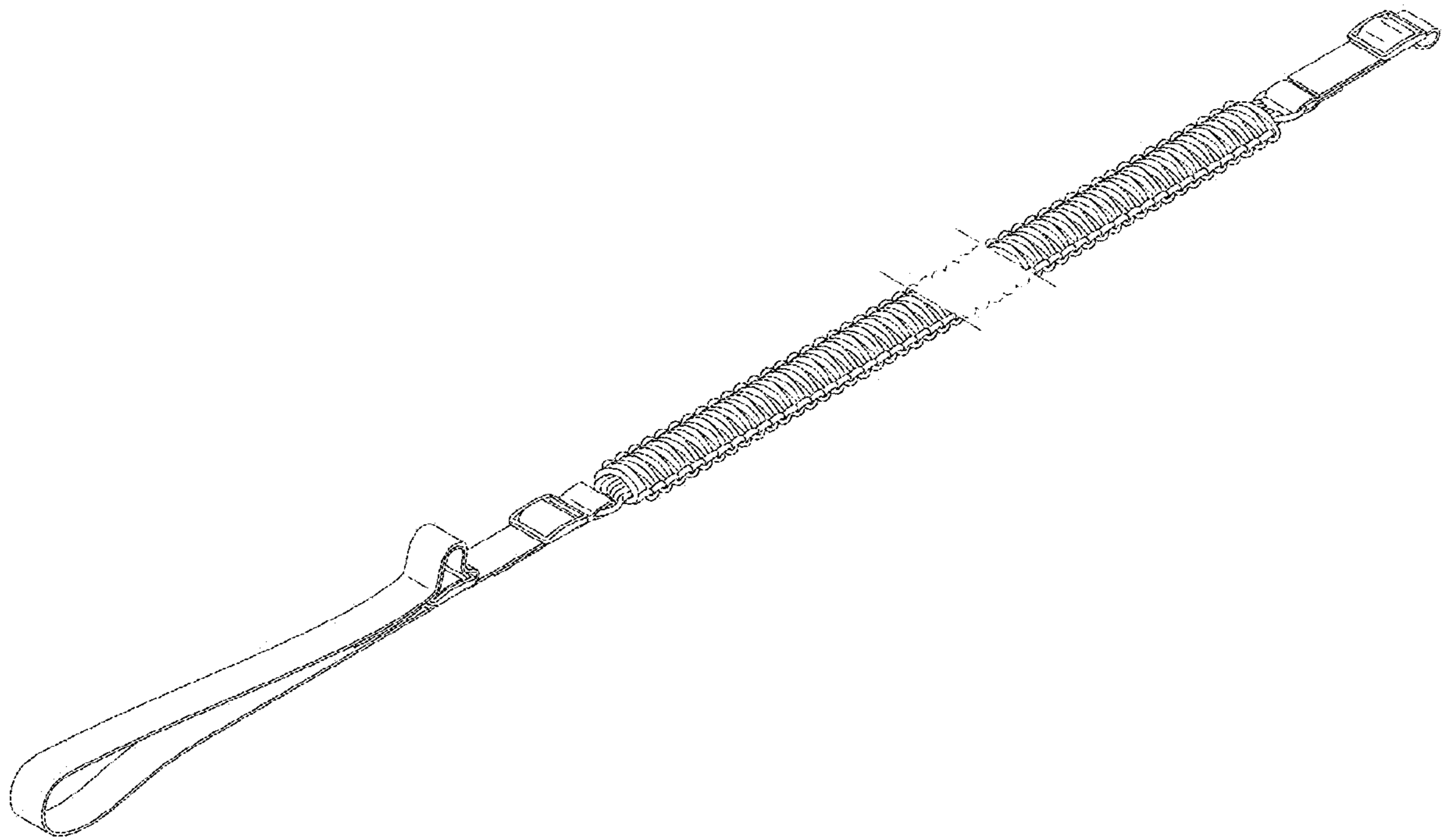

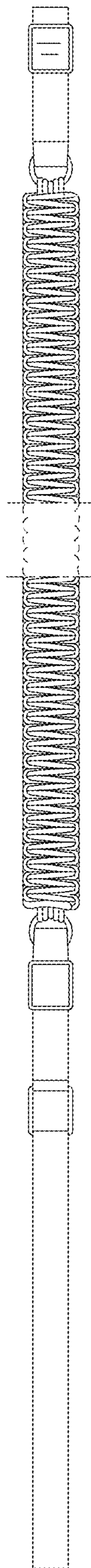

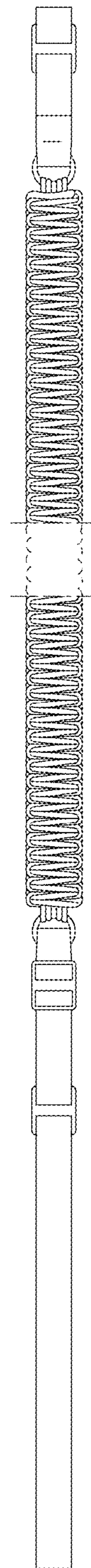

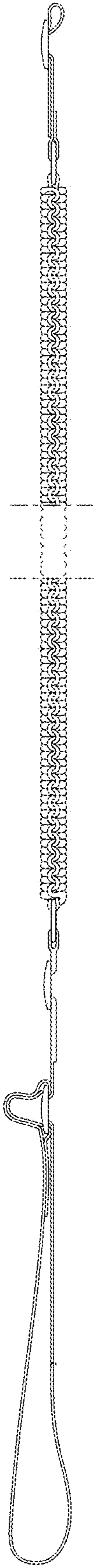

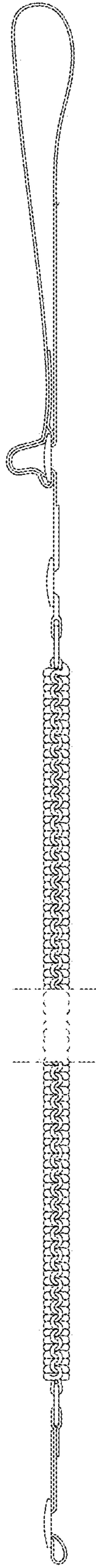

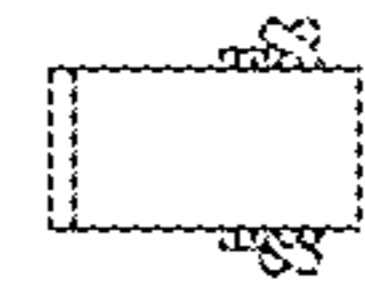

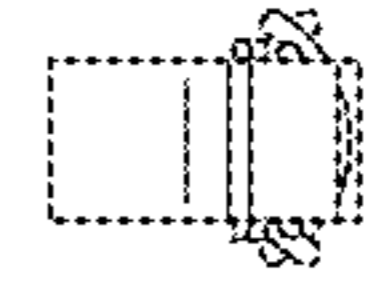
