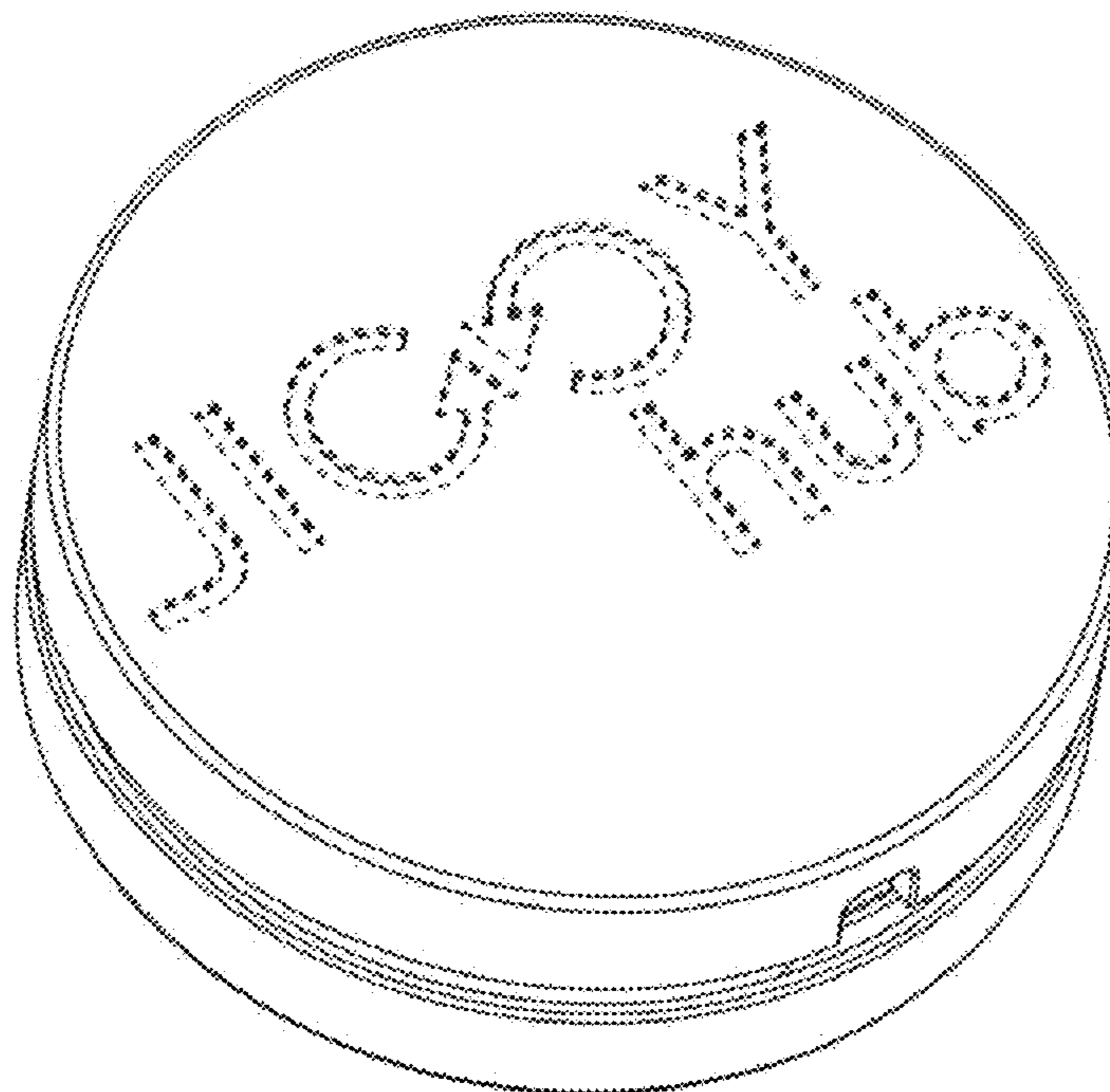
(57) **CLAIM**

The ornamental design for a carrier for headphone cables, as shown and described.

DESCRIPTION

FIG. 1 is an isometric top view of the carrier for headphone cables;
FIG. 2 is a front view of the carrier for headphone cables;
FIG. 3 is a rear view of the carrier for headphone cables;
FIG. 4 is a left view of the carrier for headphone cables;

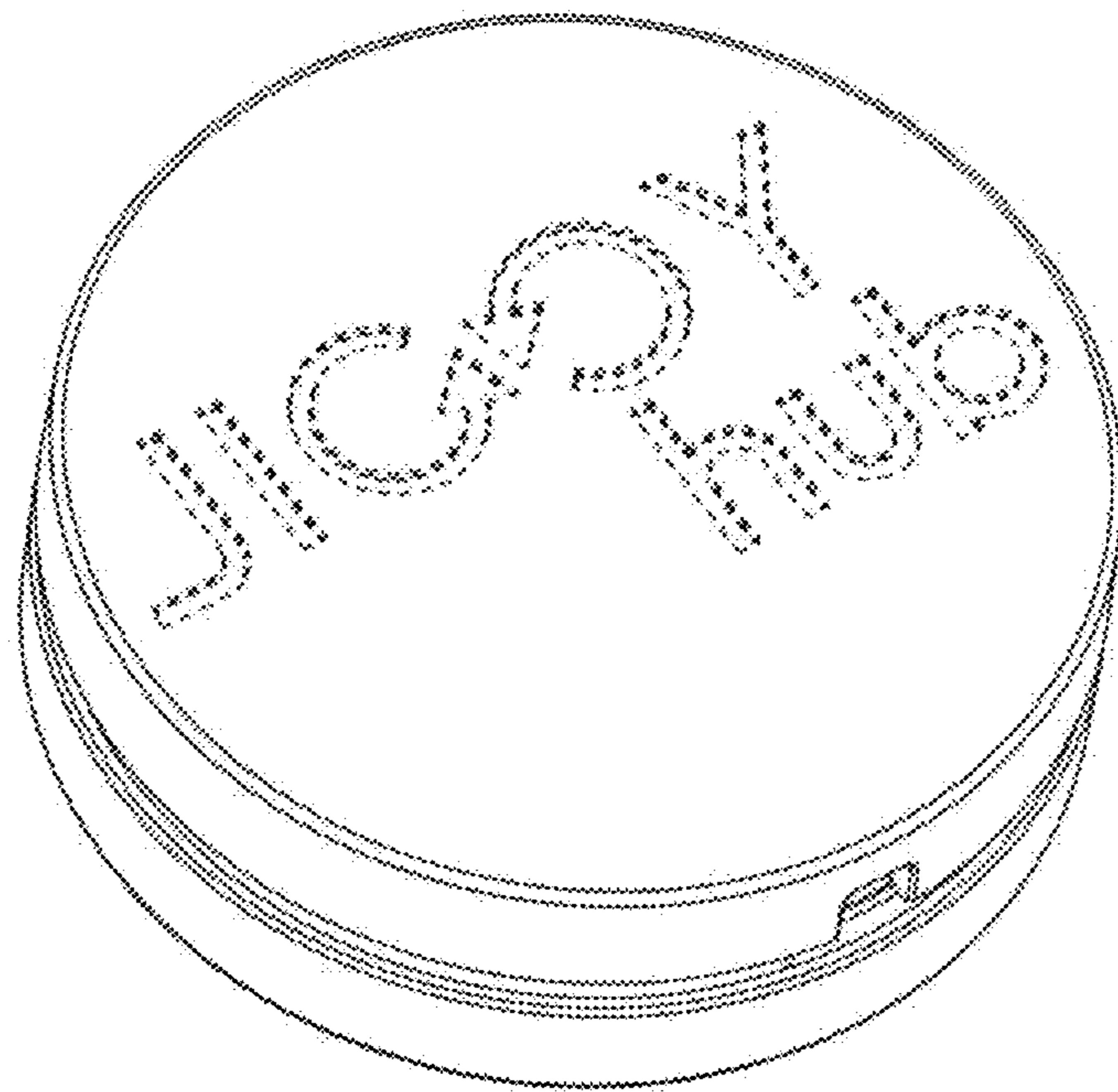

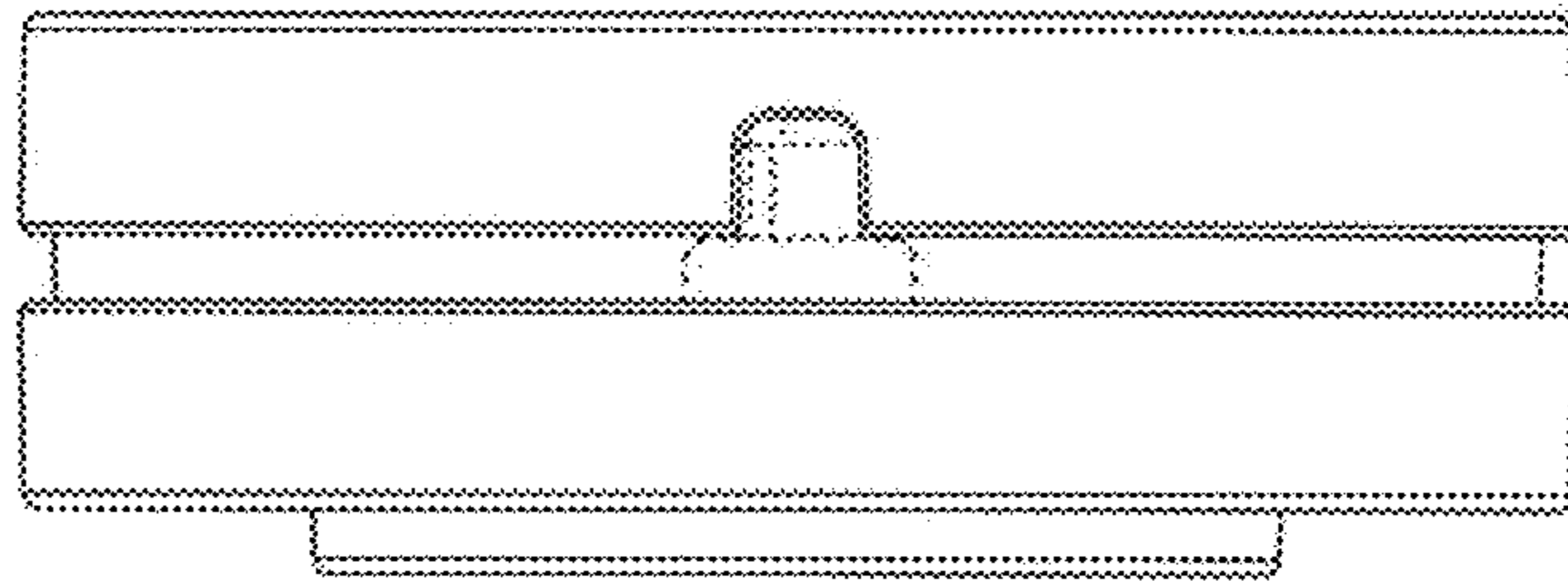

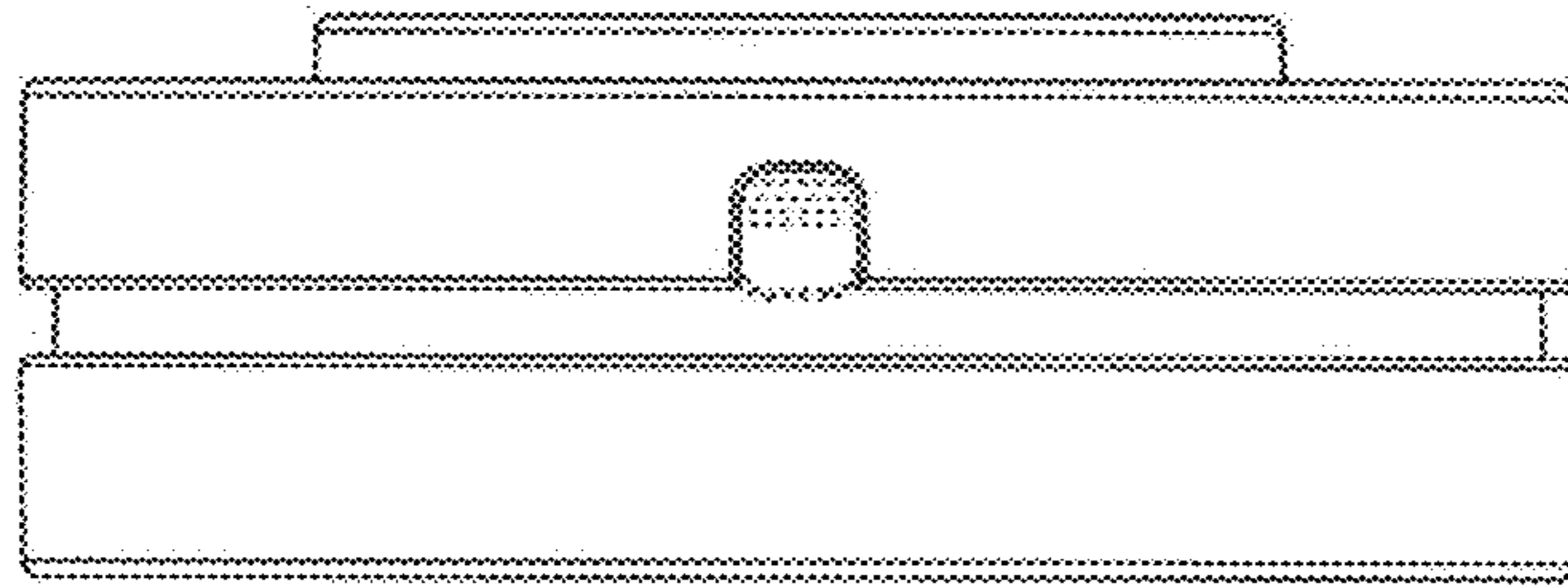

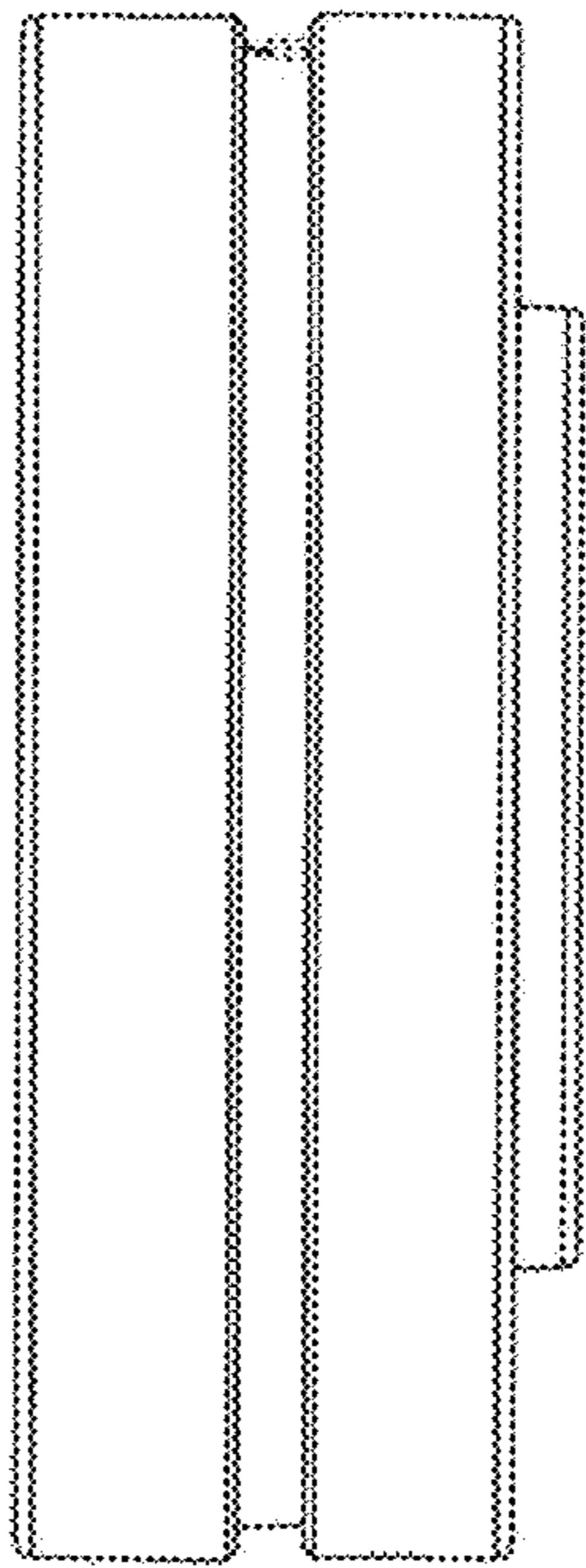

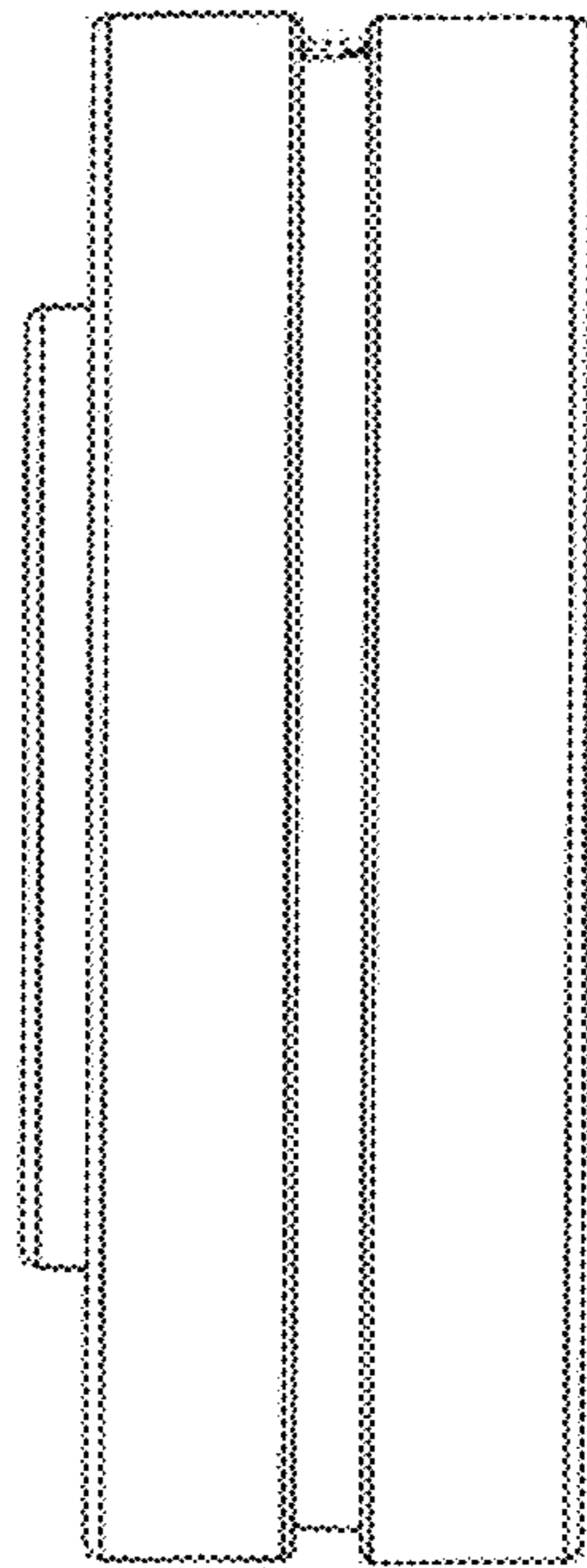

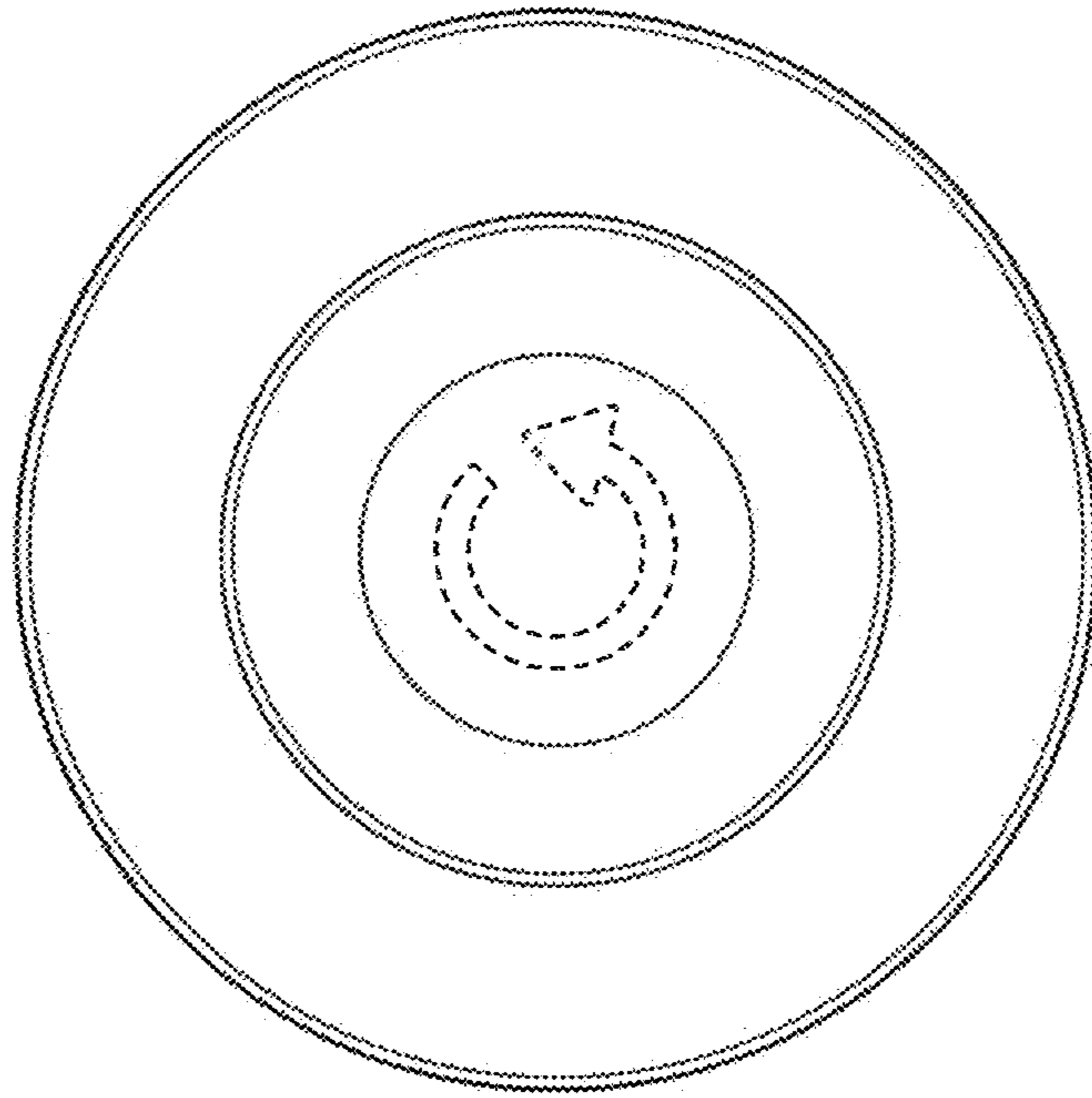

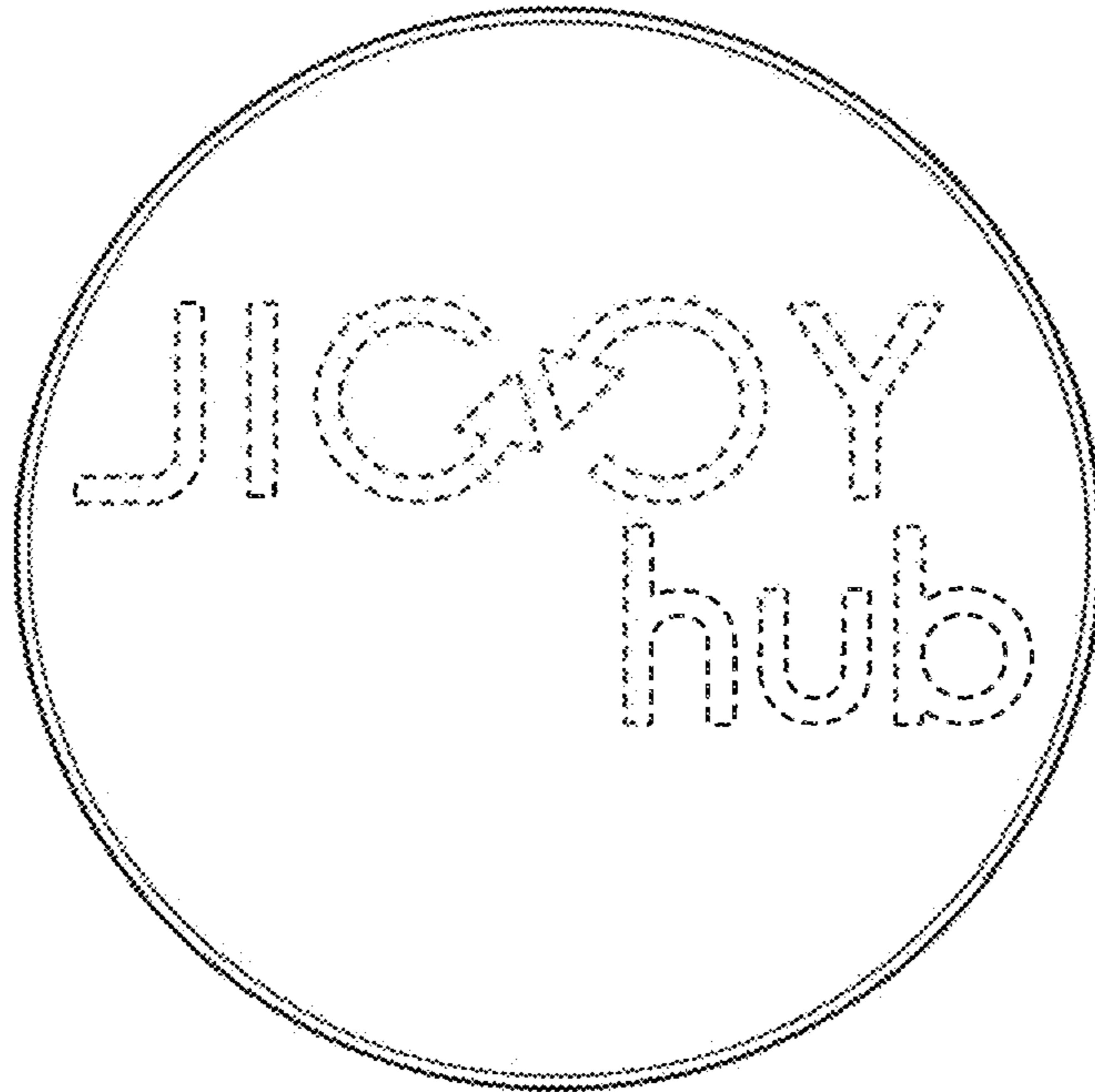
