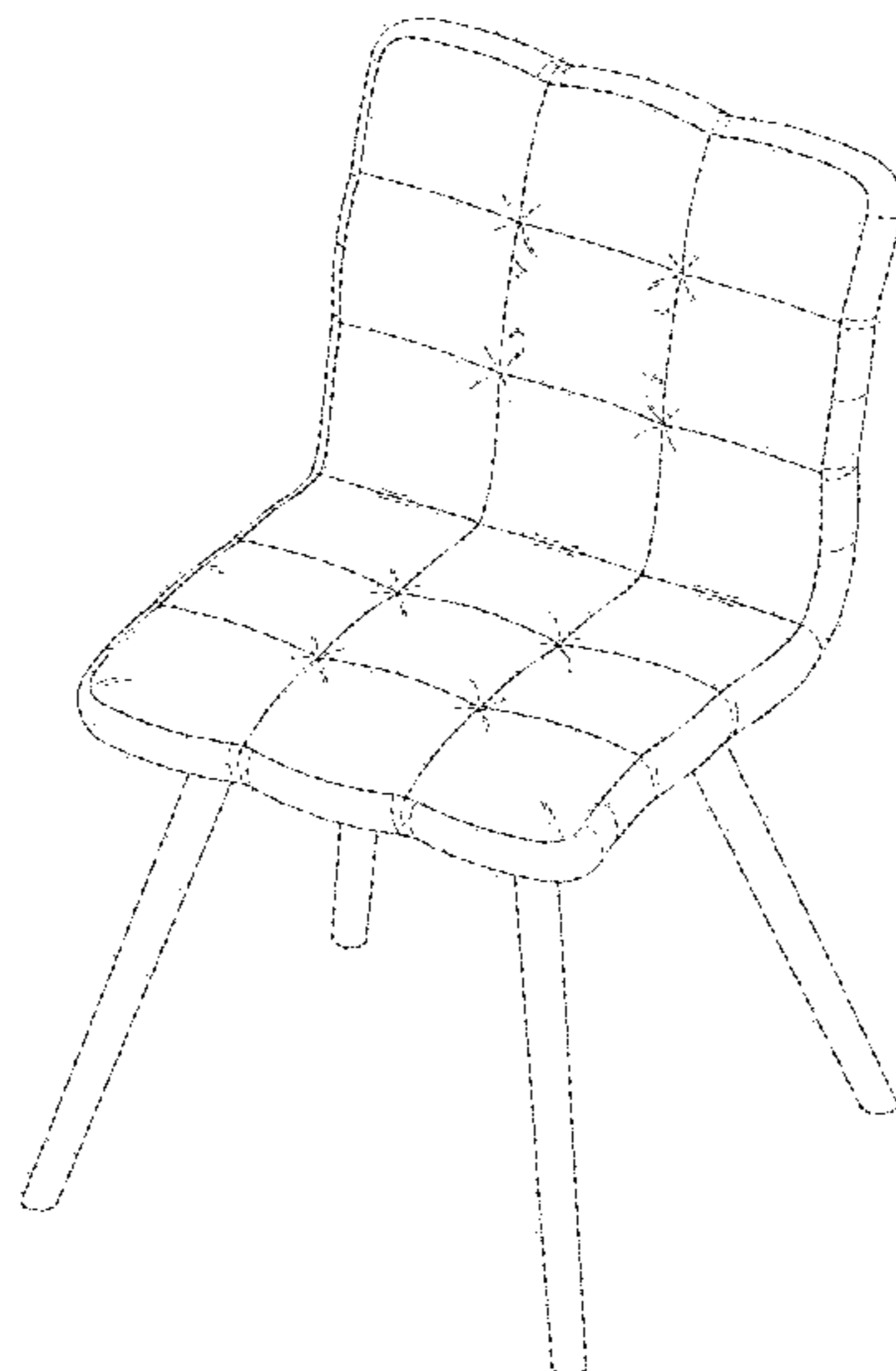
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a chair showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a perspective view thereof; and, FIG. 8 is a rear perspective view thereof. The claimed design, as shown in FIG. 1-8, is a new and ornamental design for a chair.

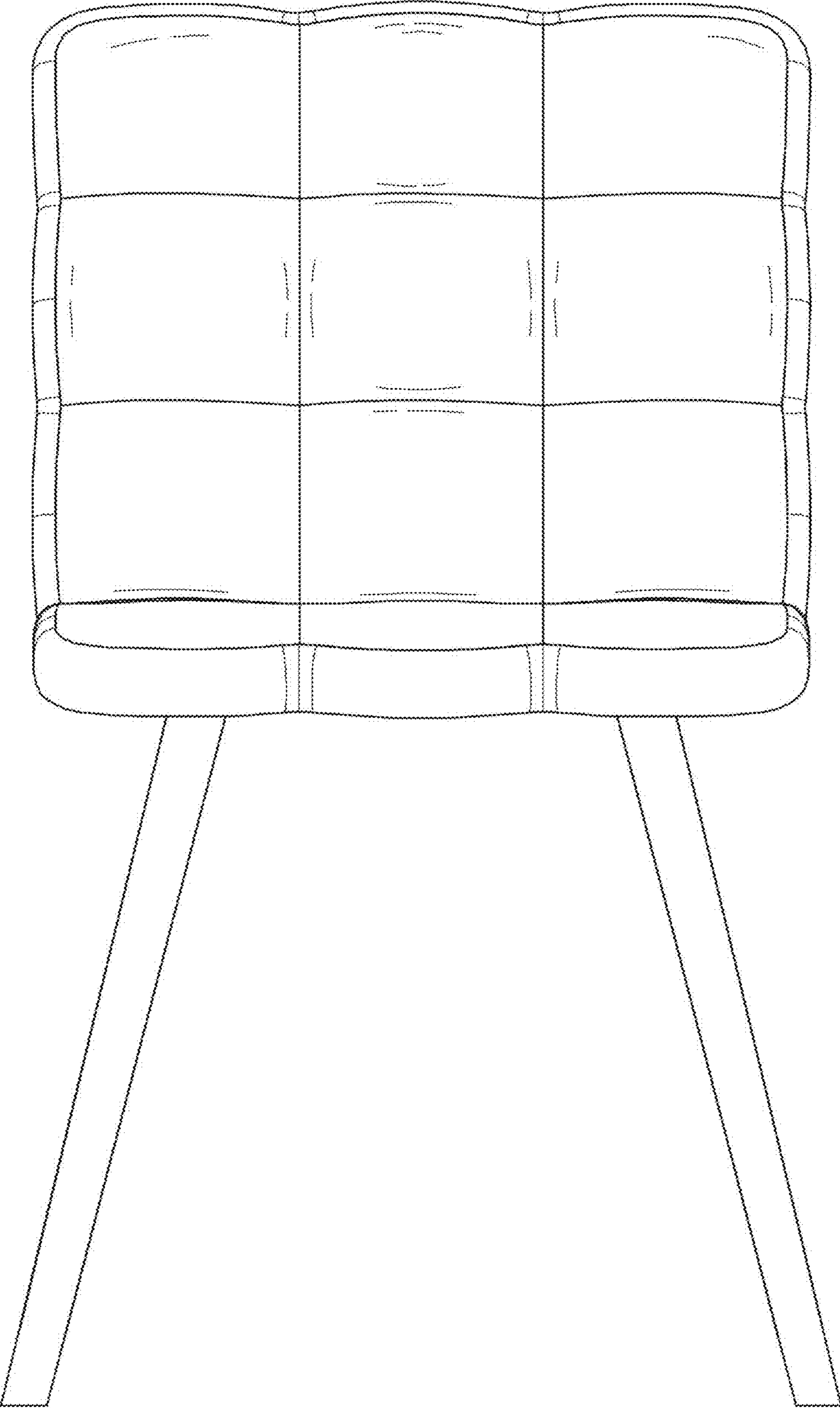

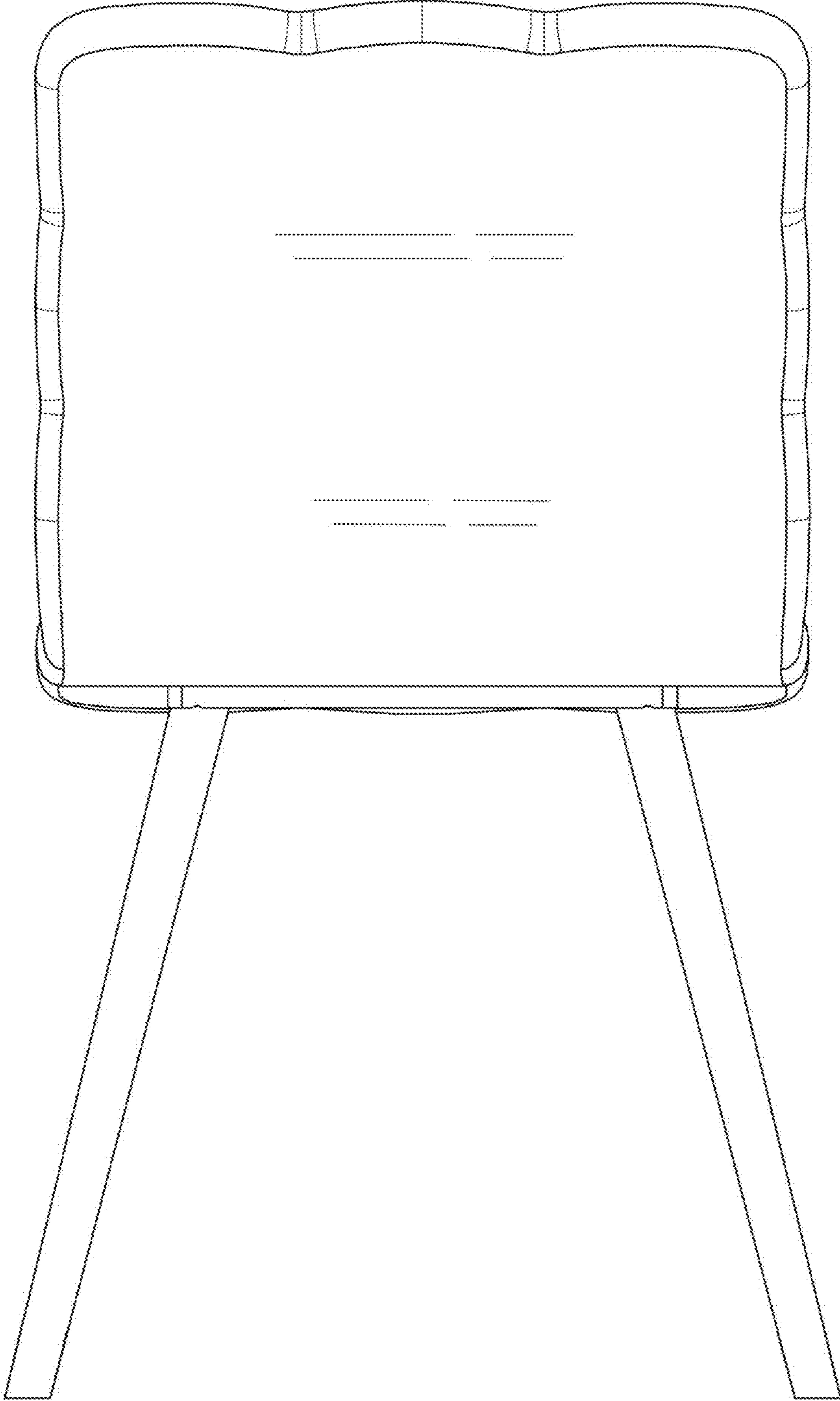

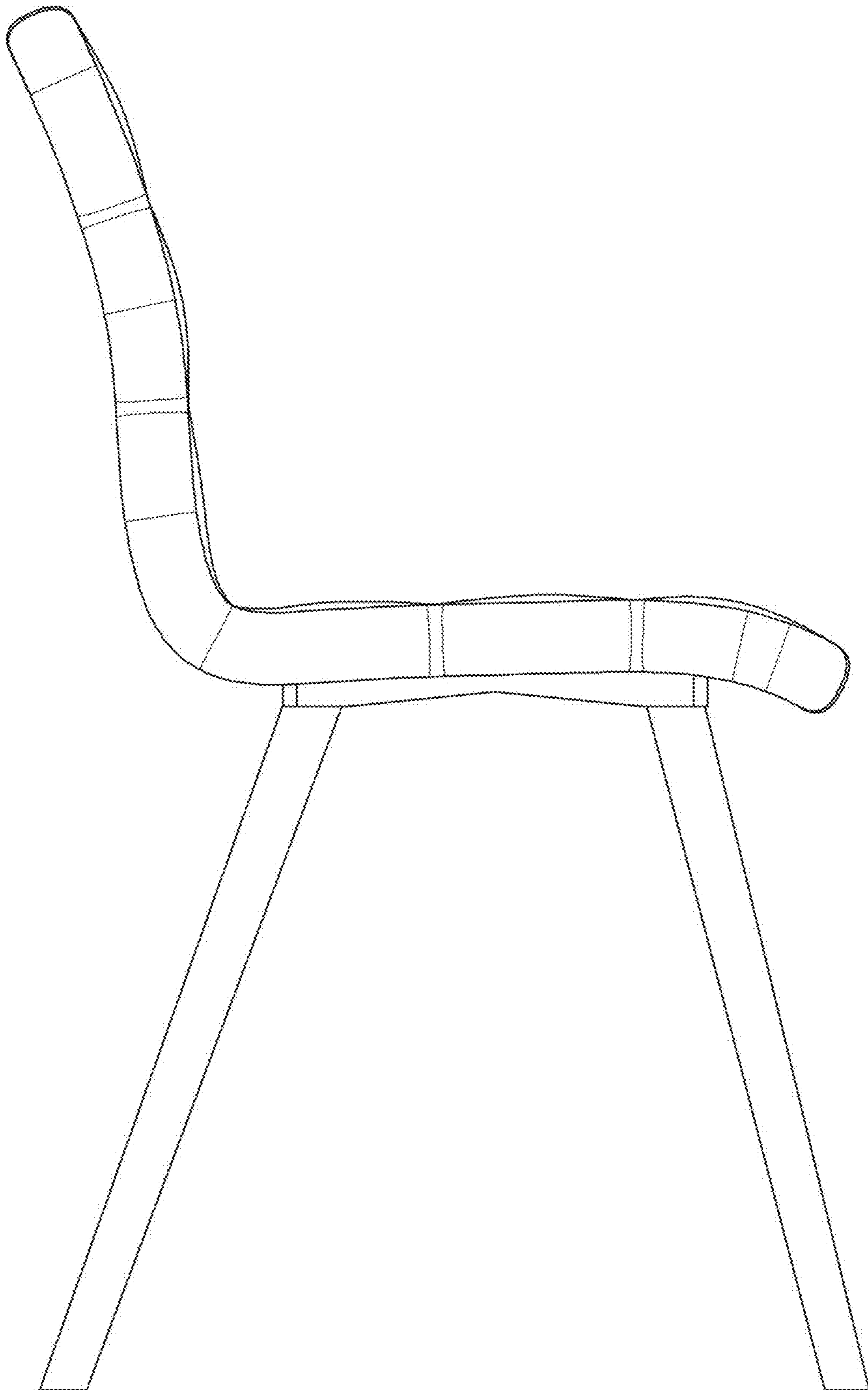

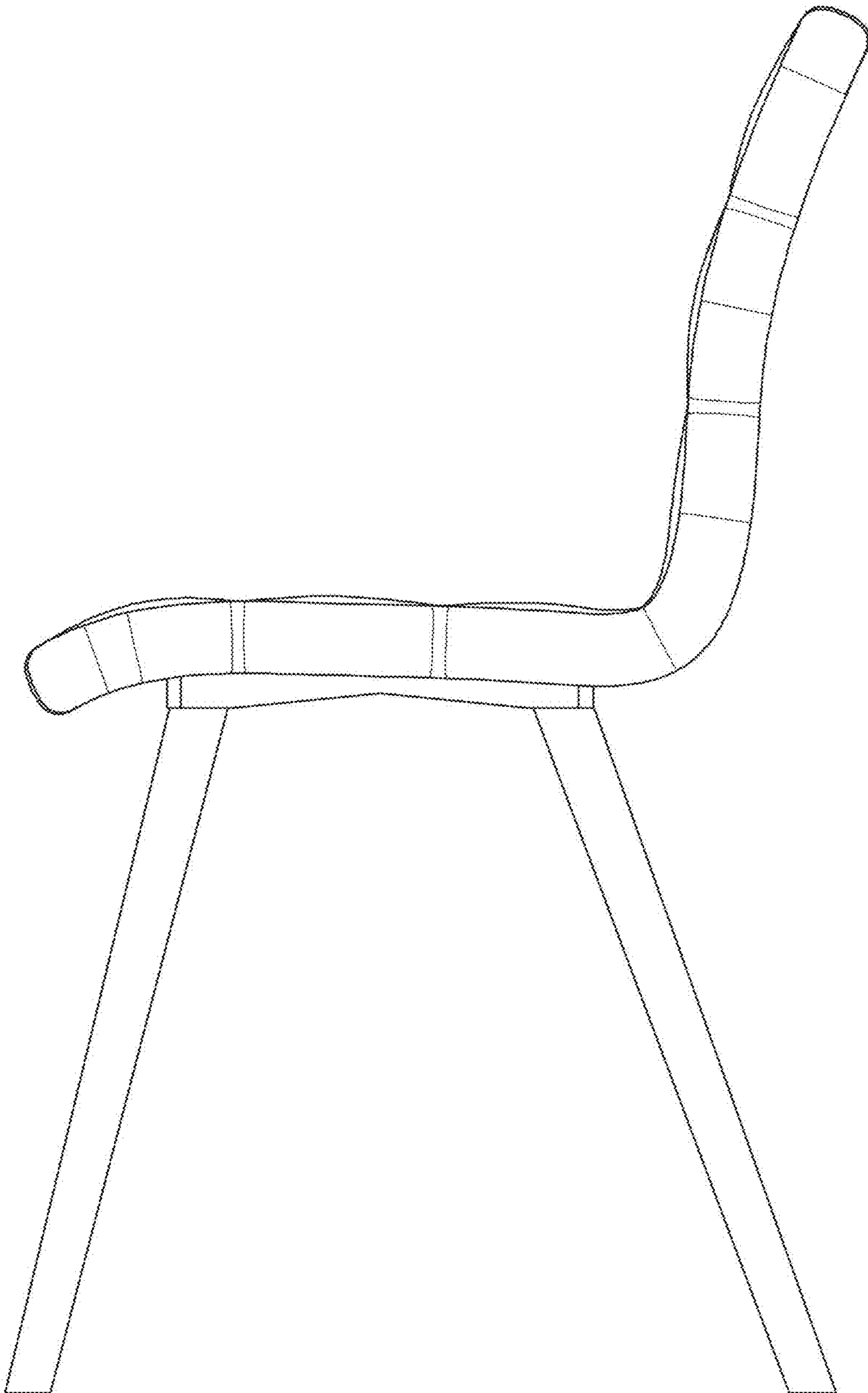

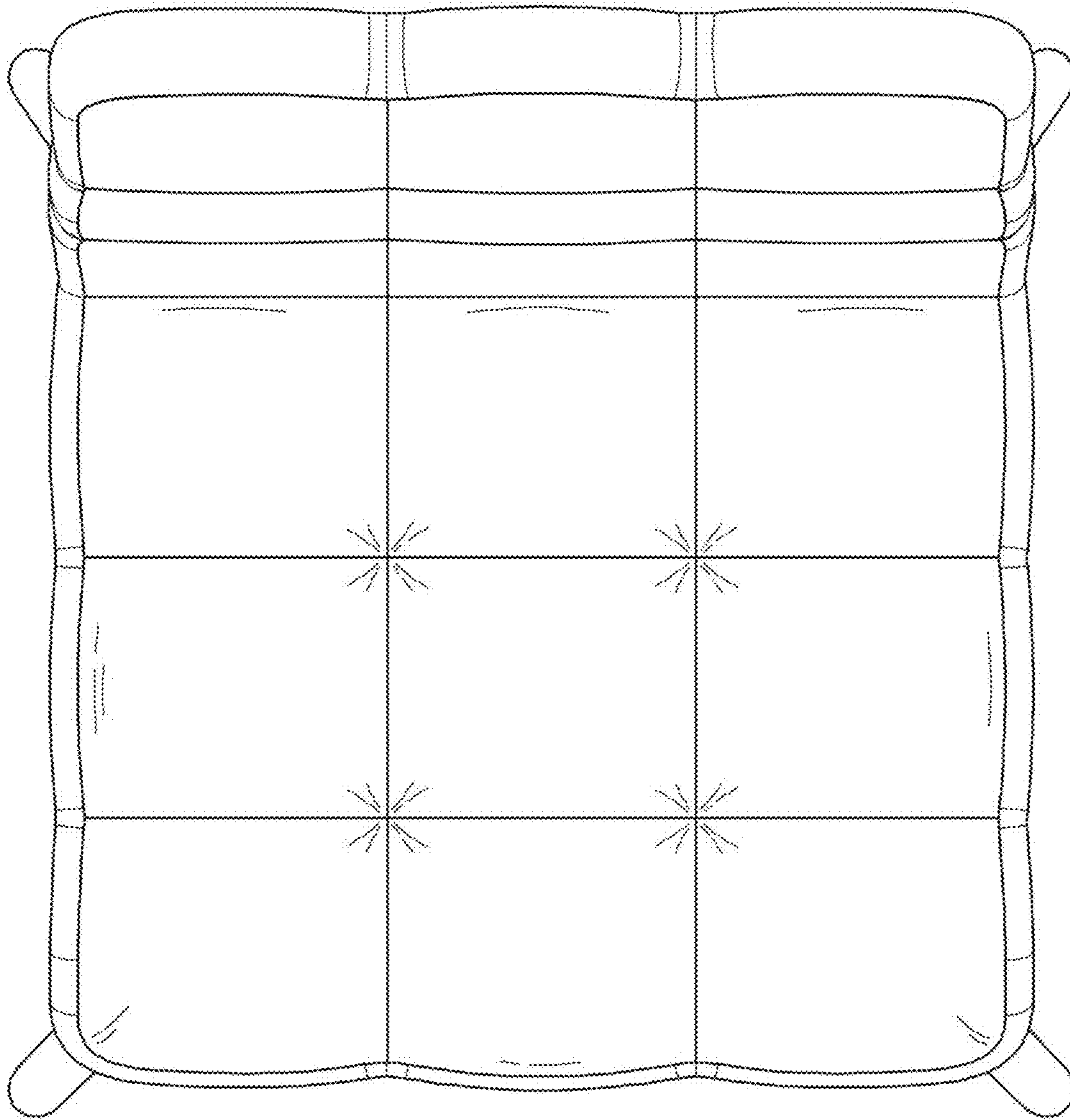

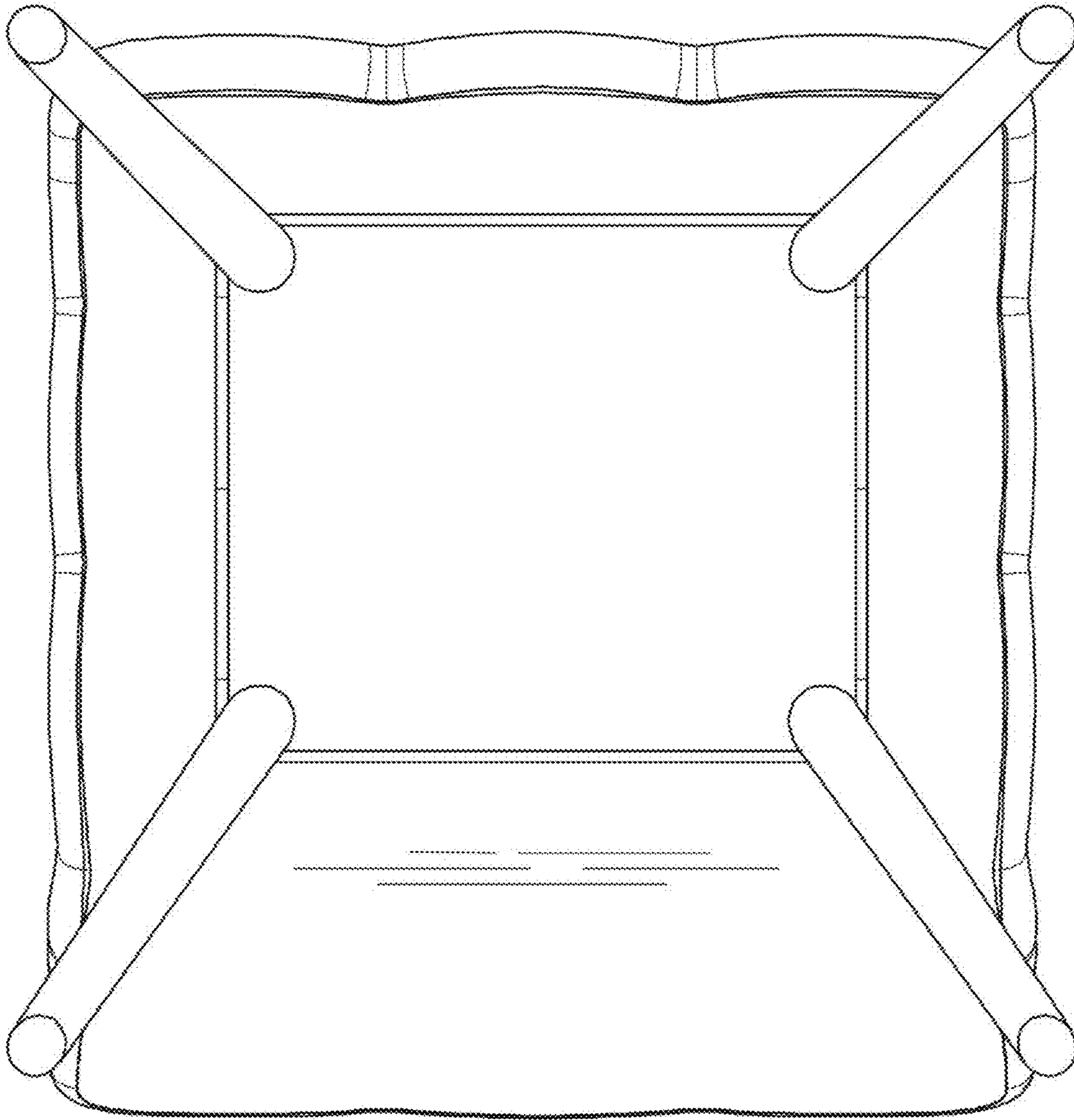

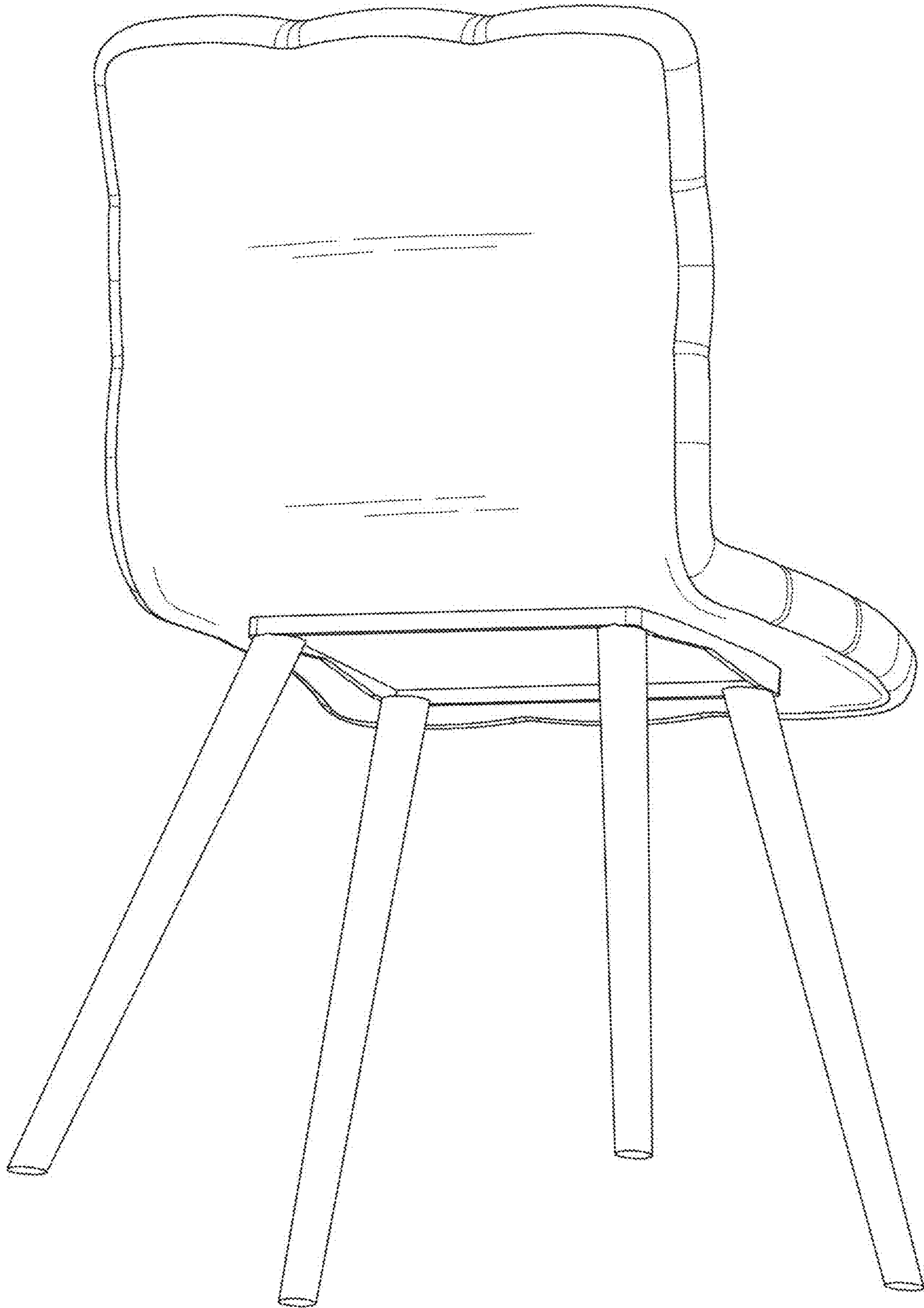
