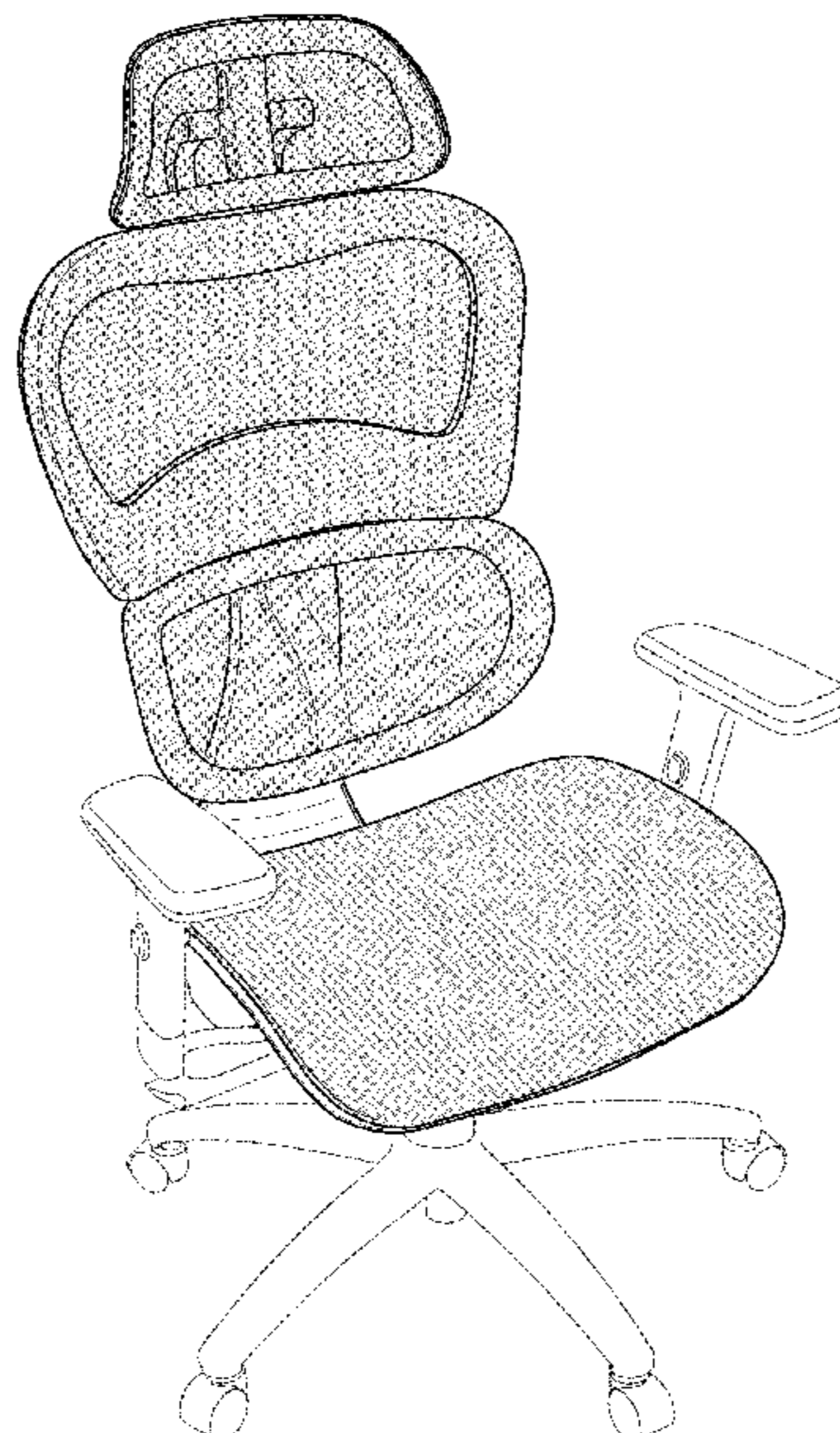
The ornamental design for a chair, as shown and described.

 FIG. 6 is a top view thereof; and,

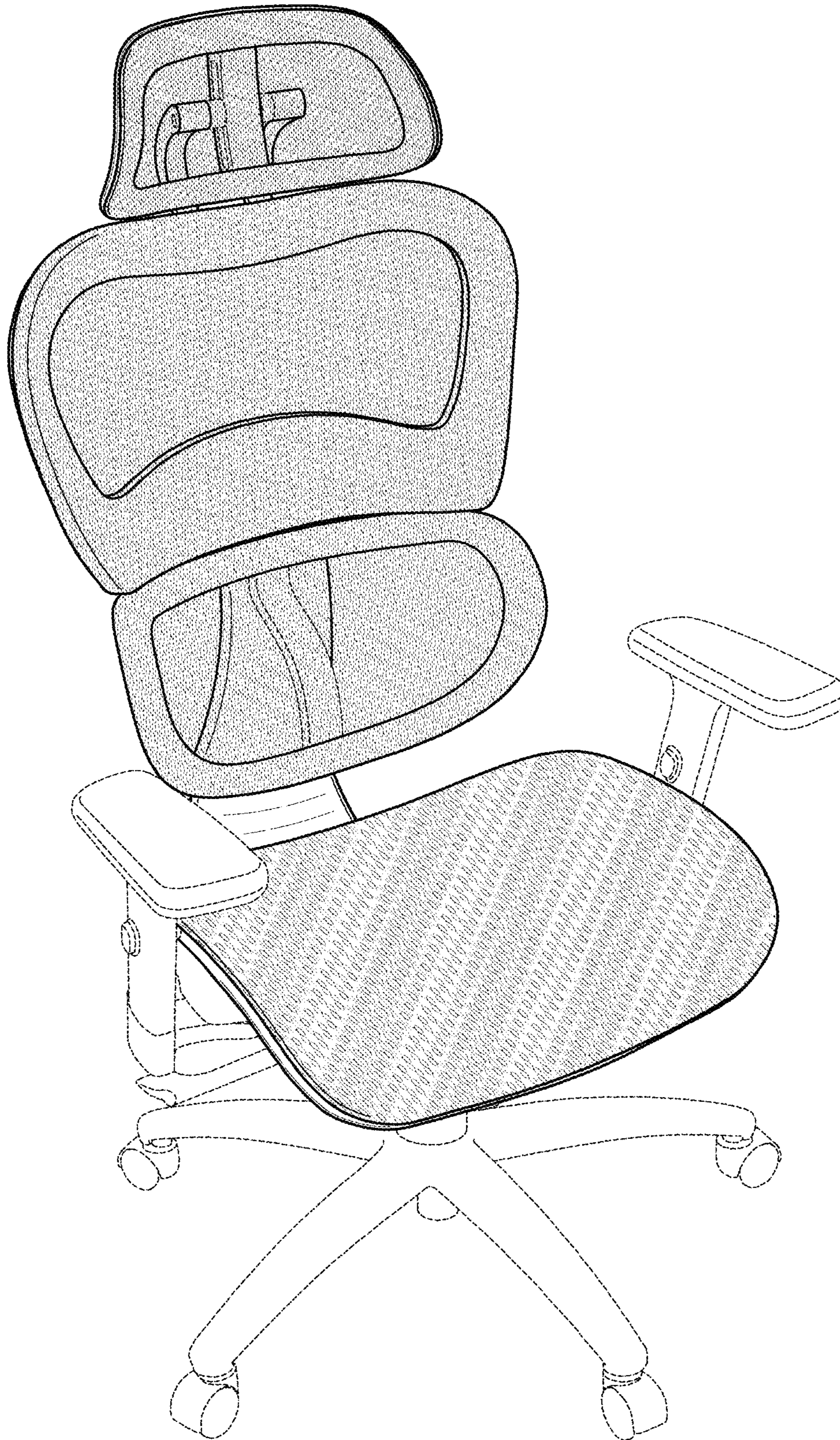

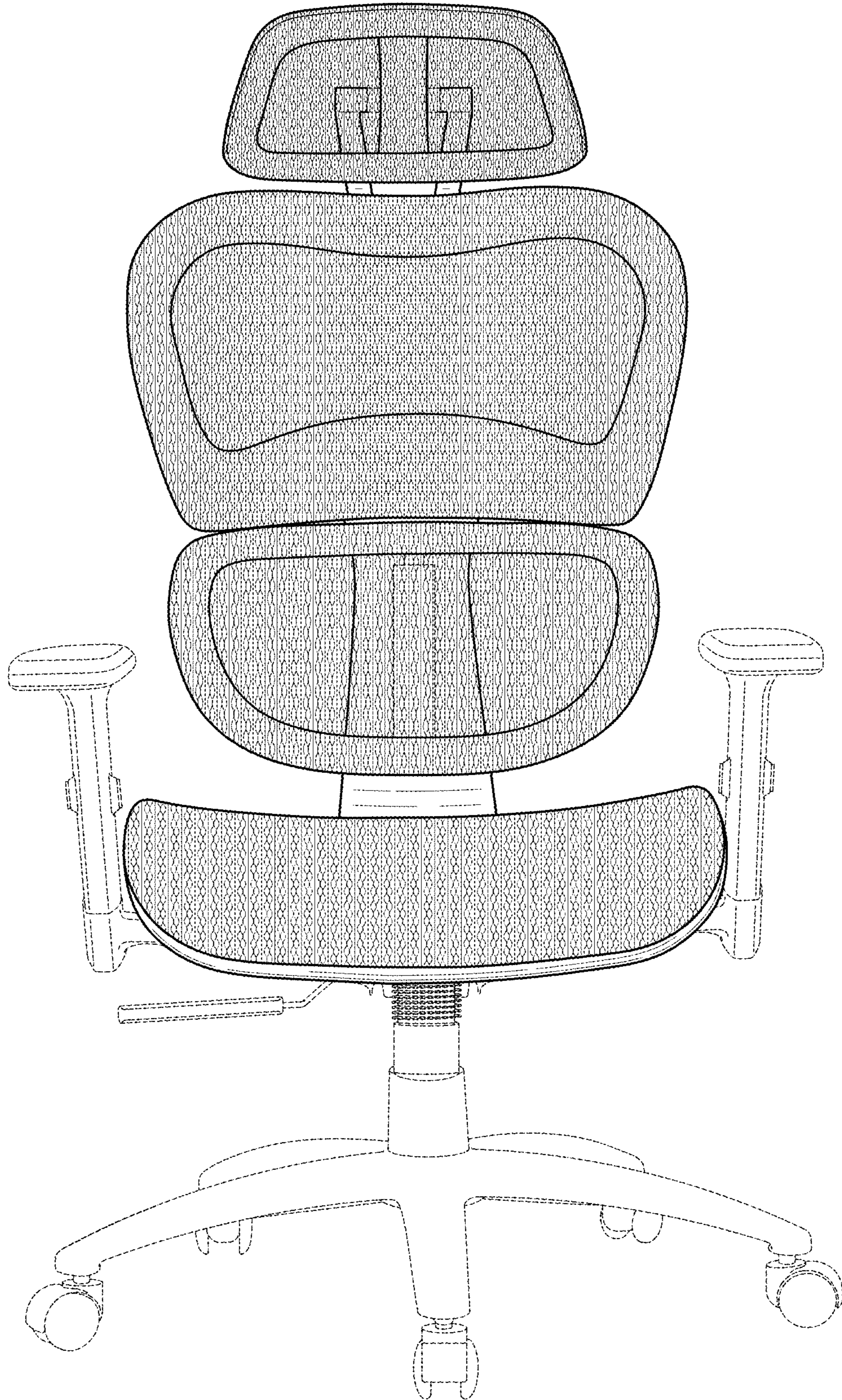

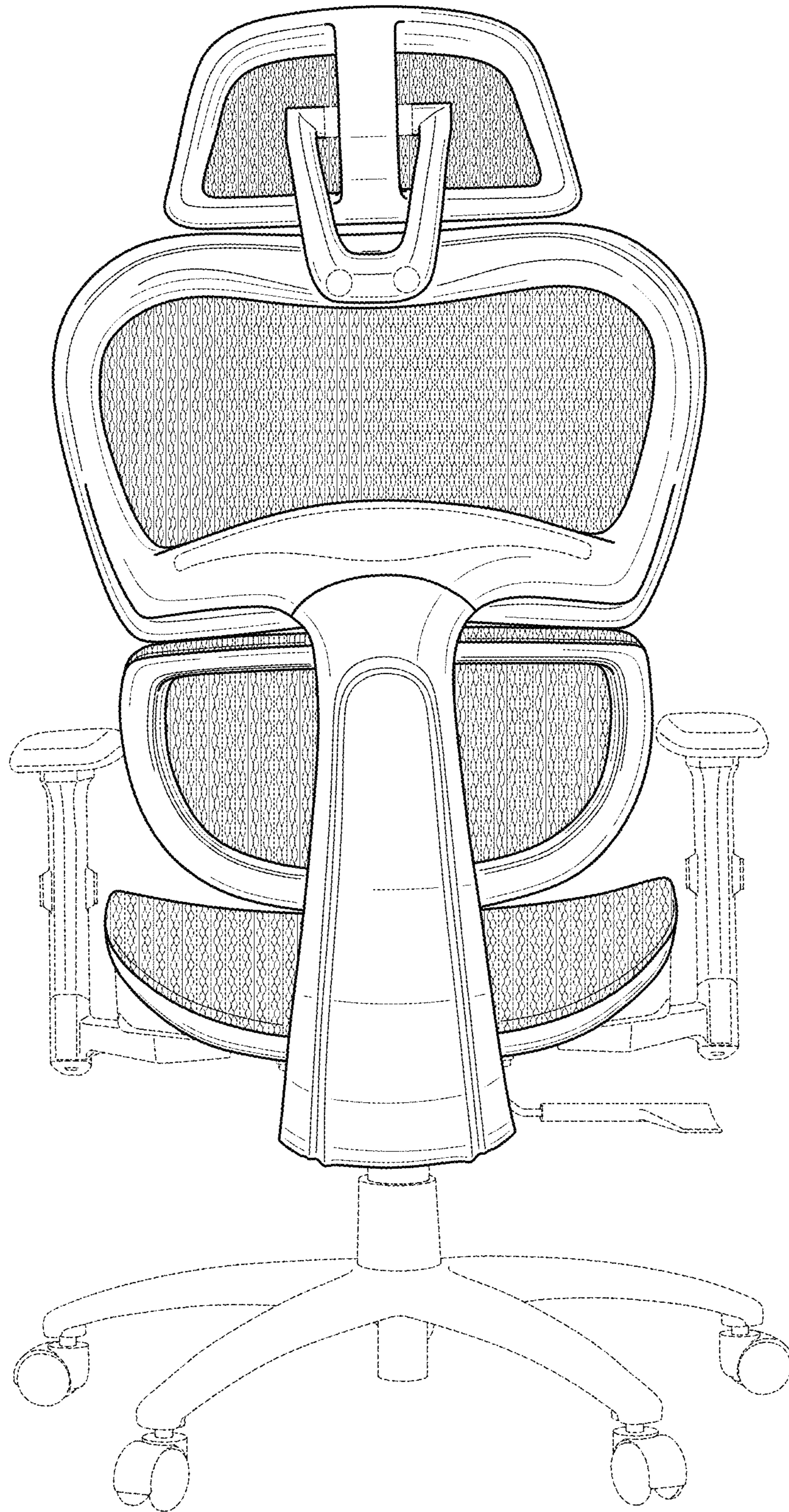

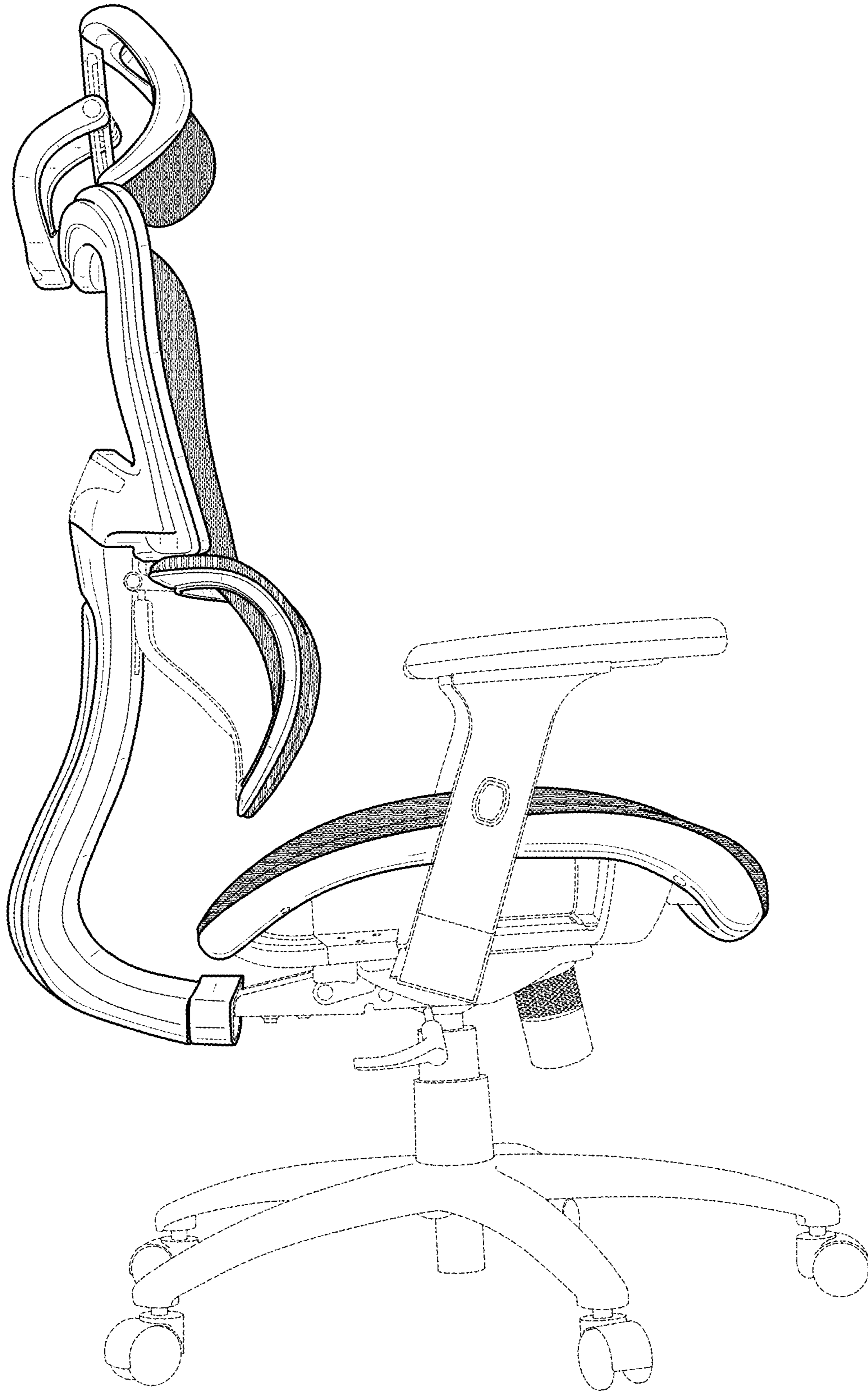

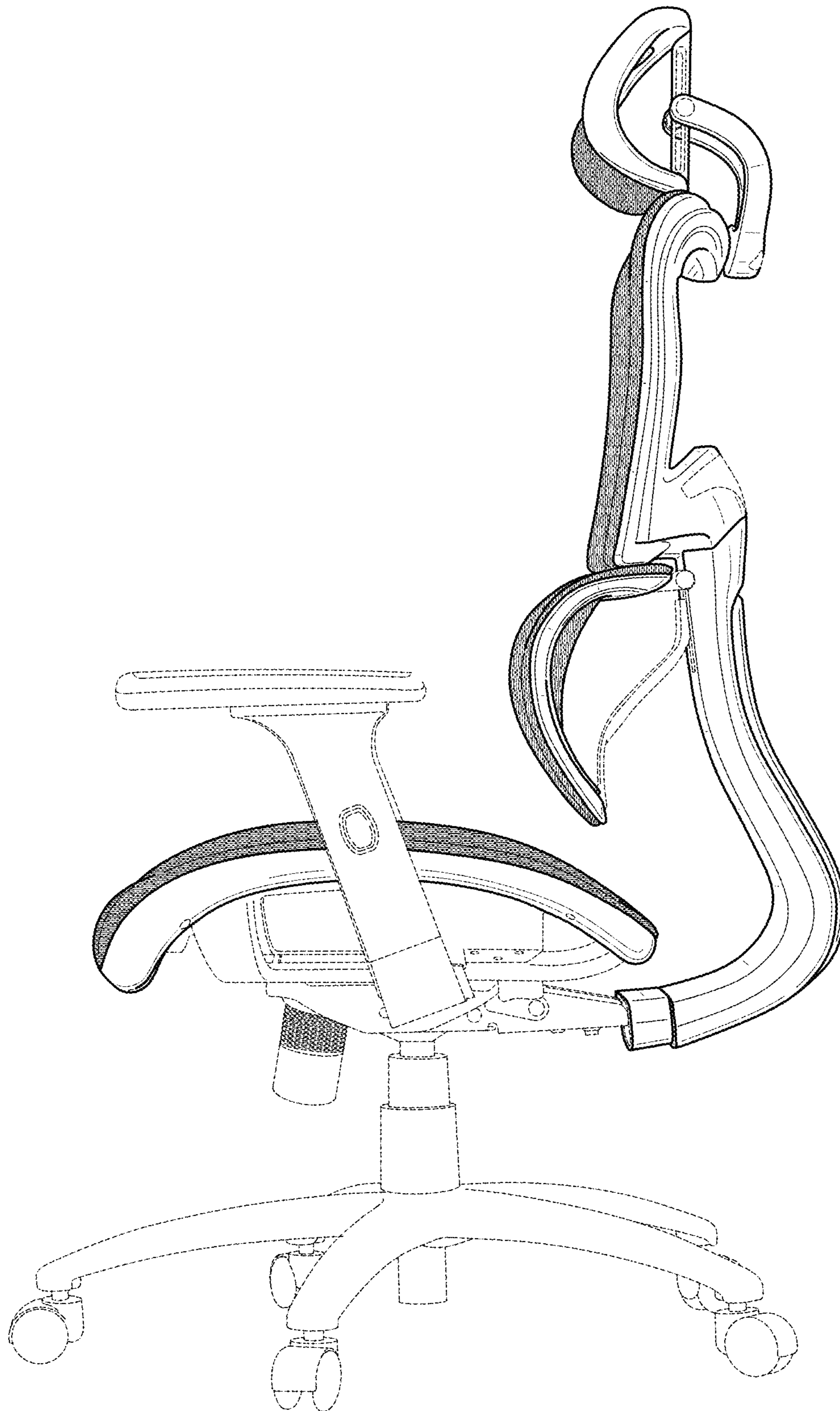

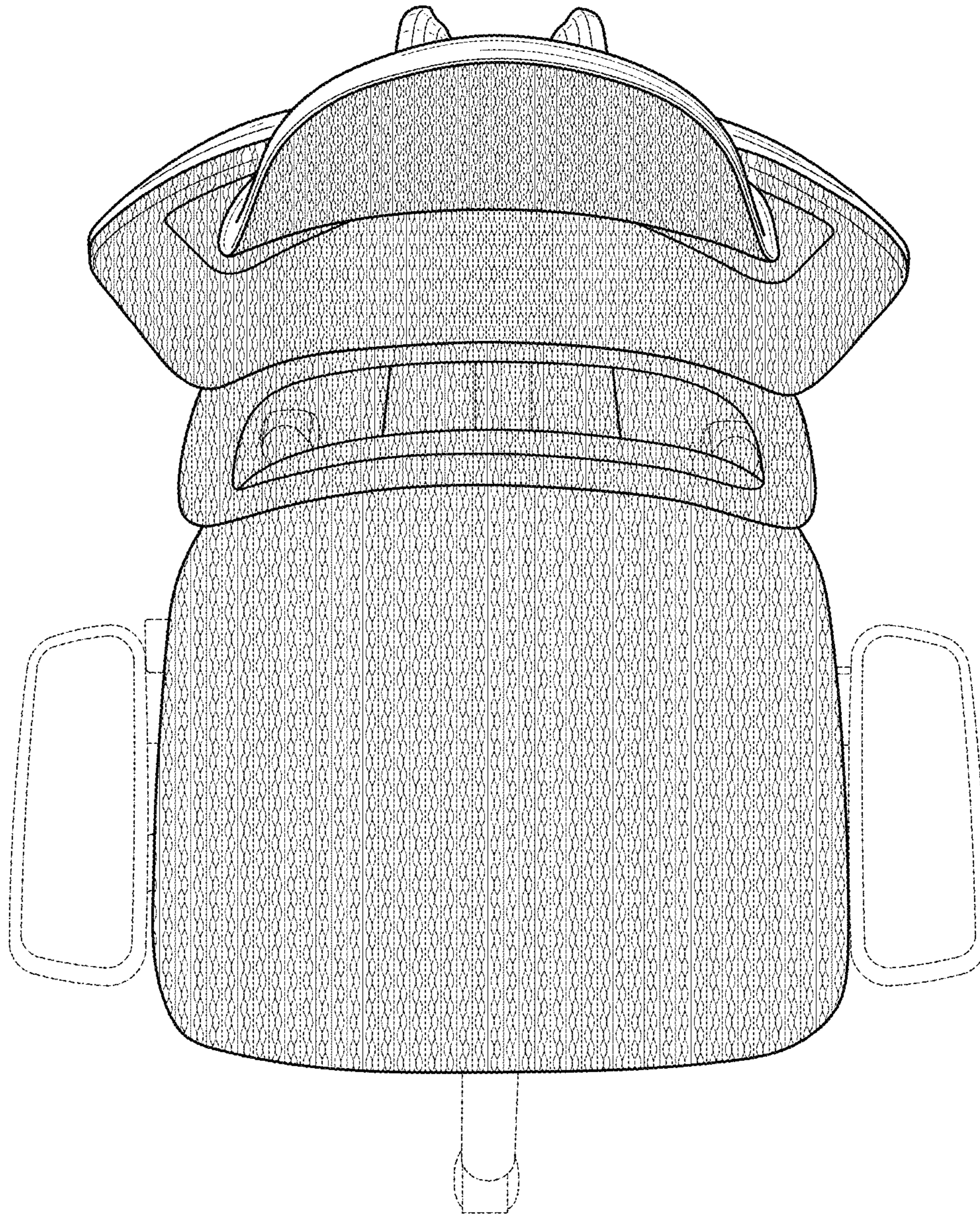

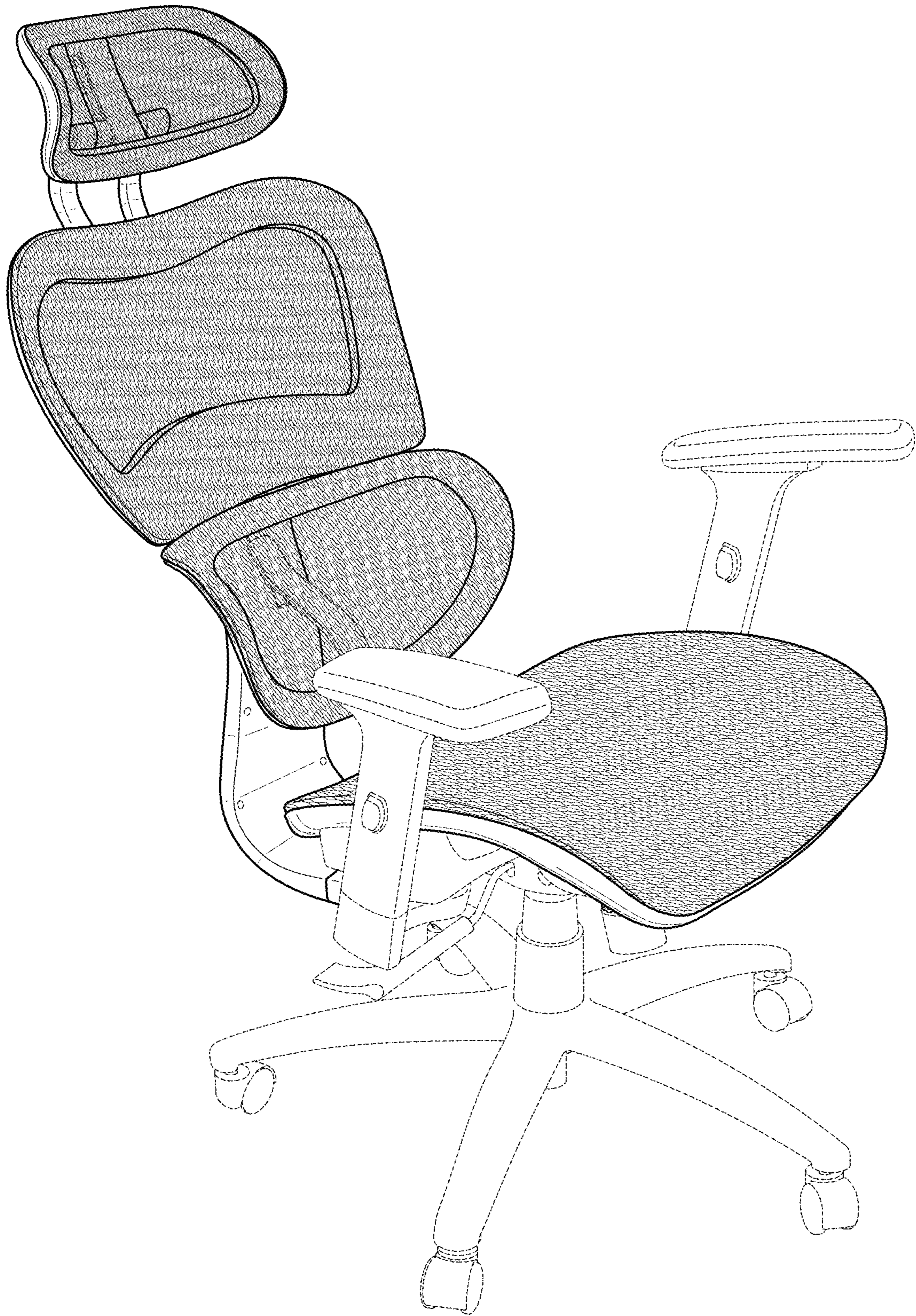
