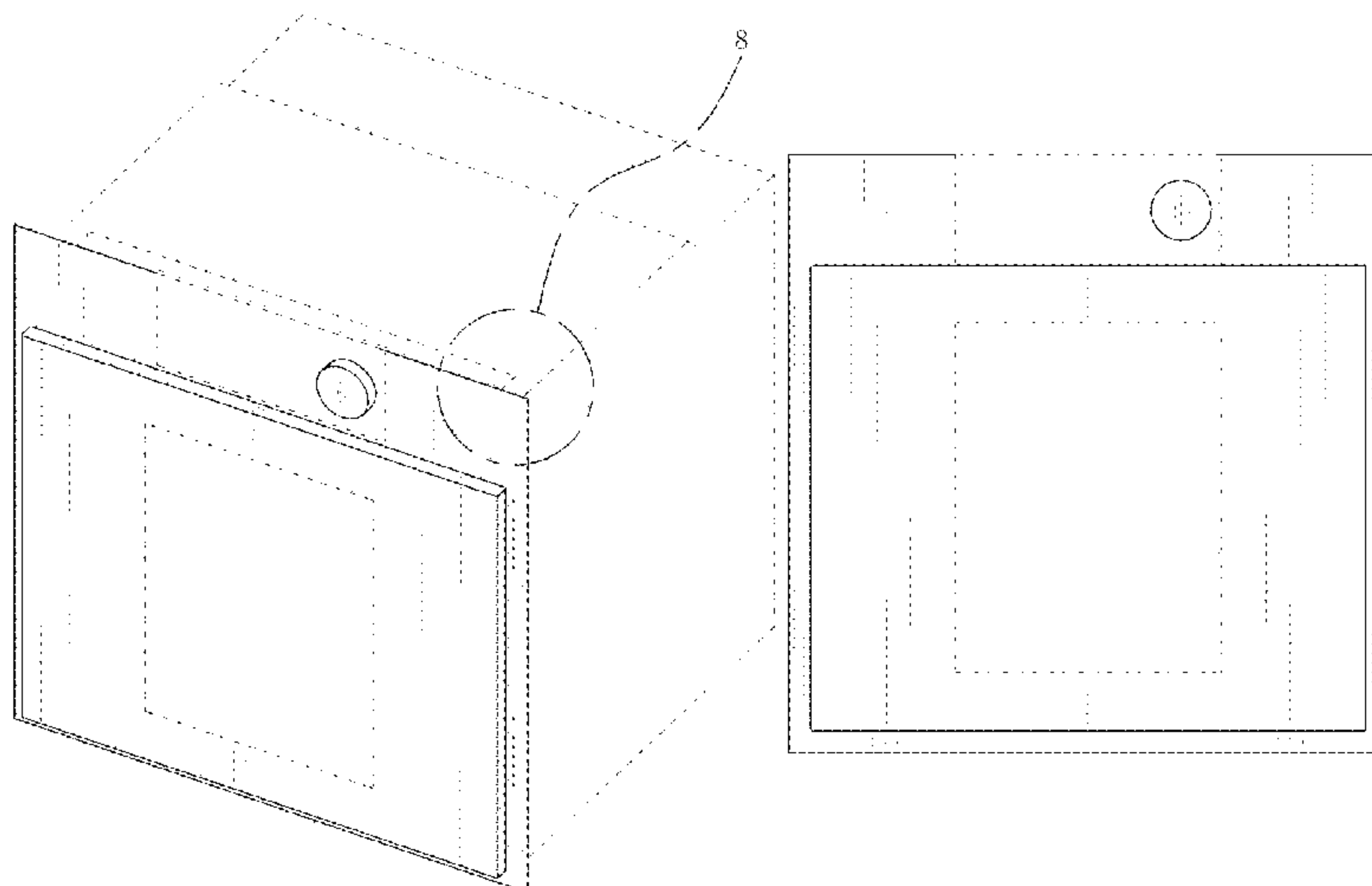
The ornamental design for an electric oven, as shown and described.

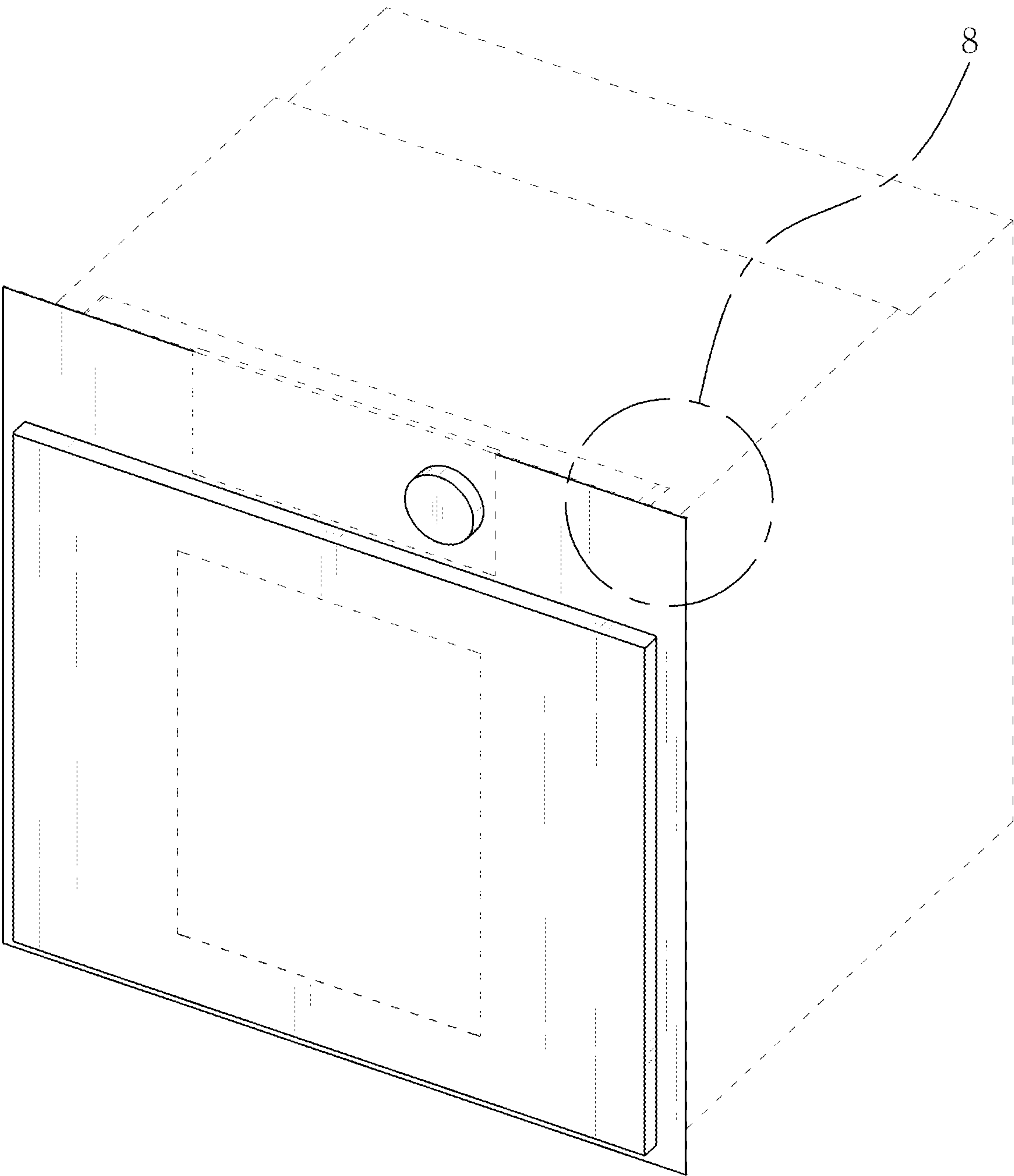

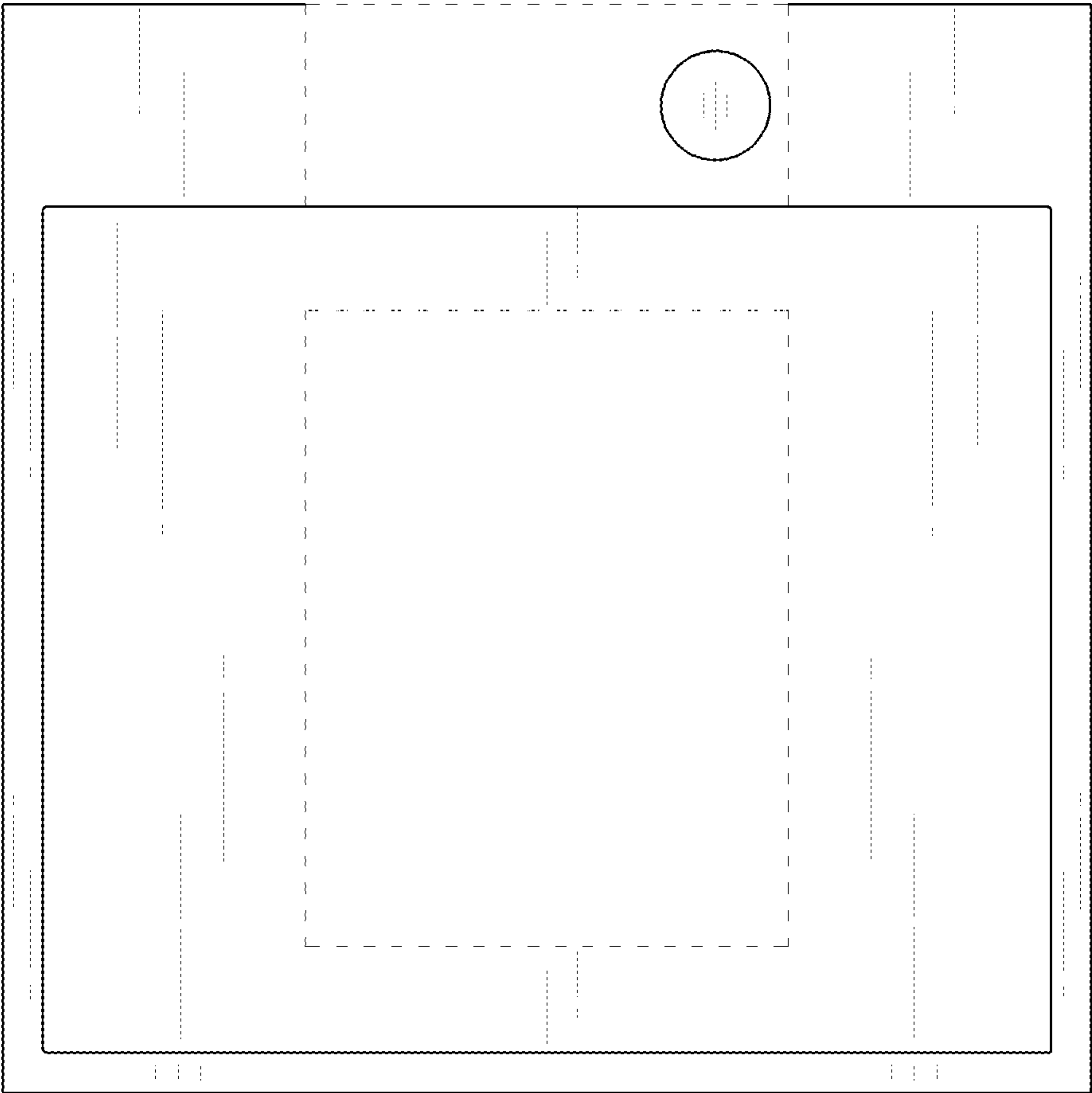

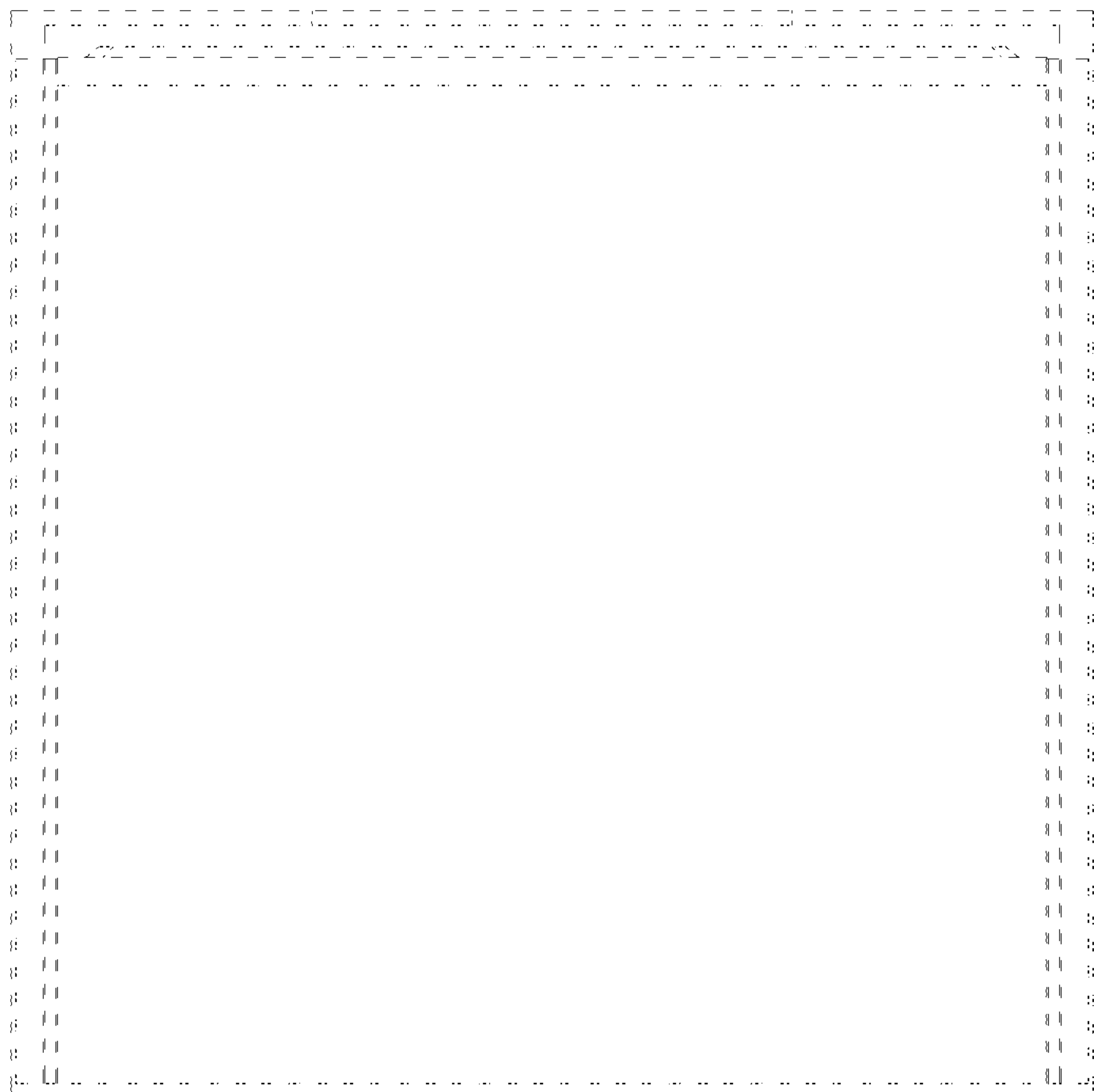

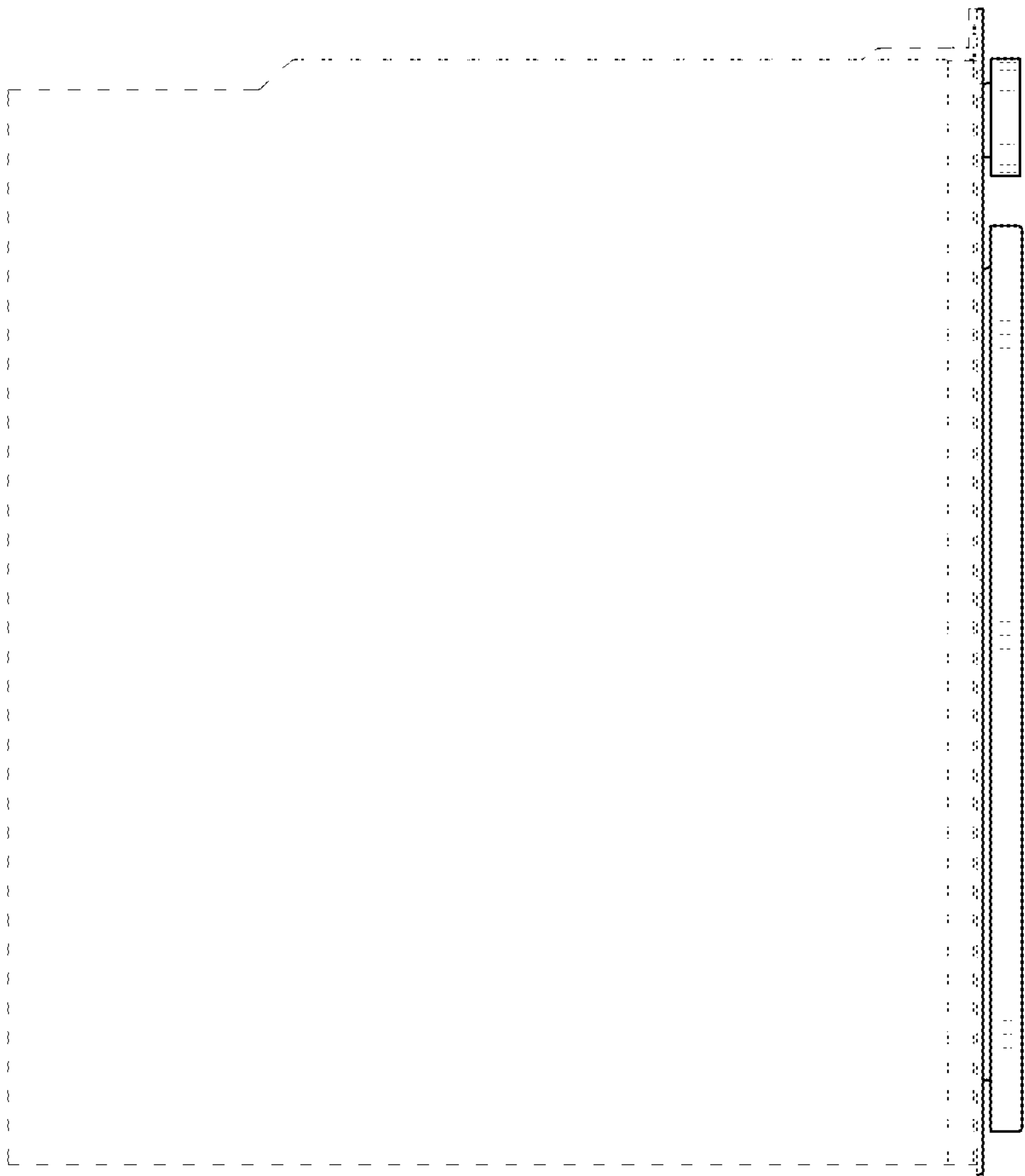

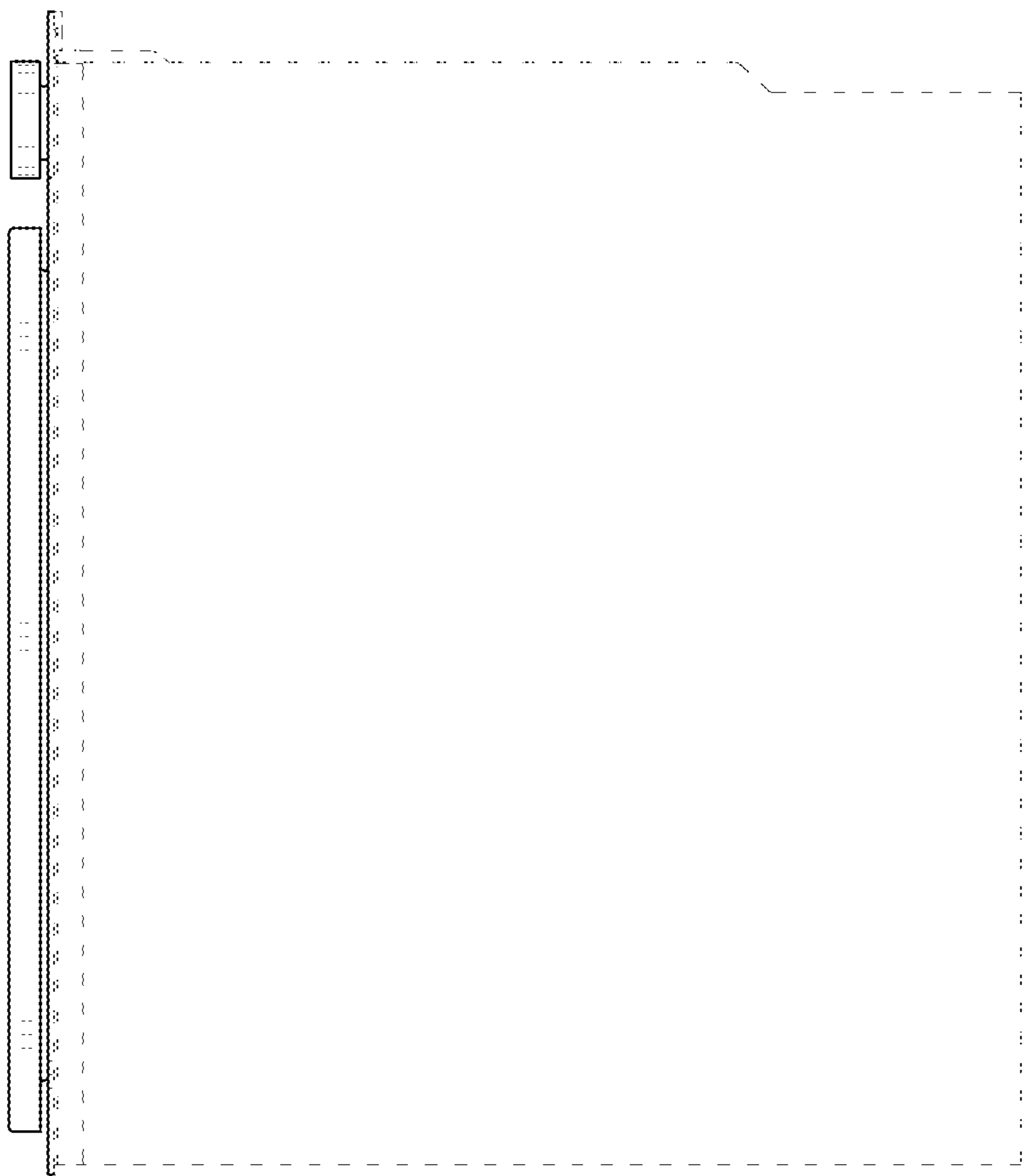

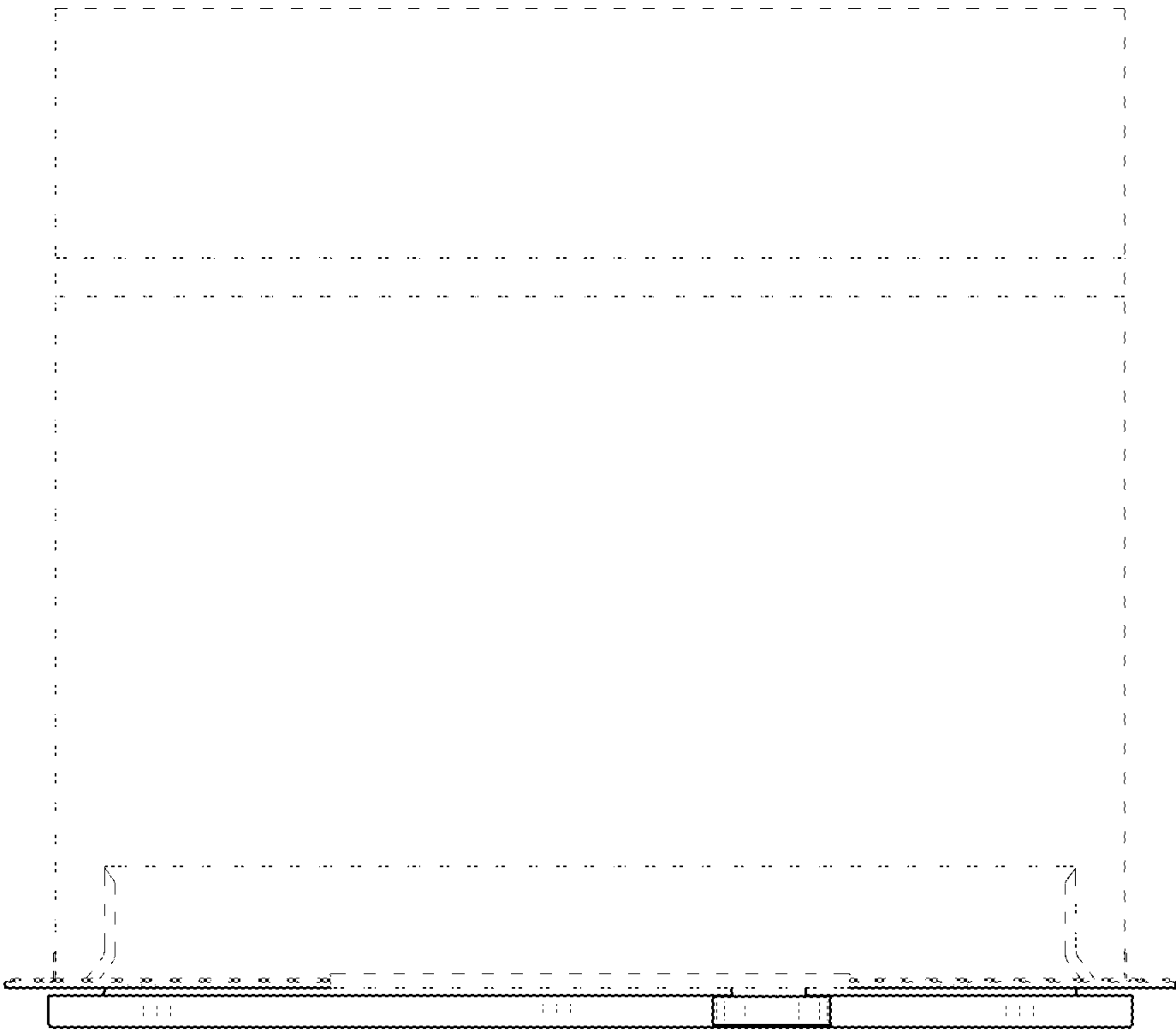
