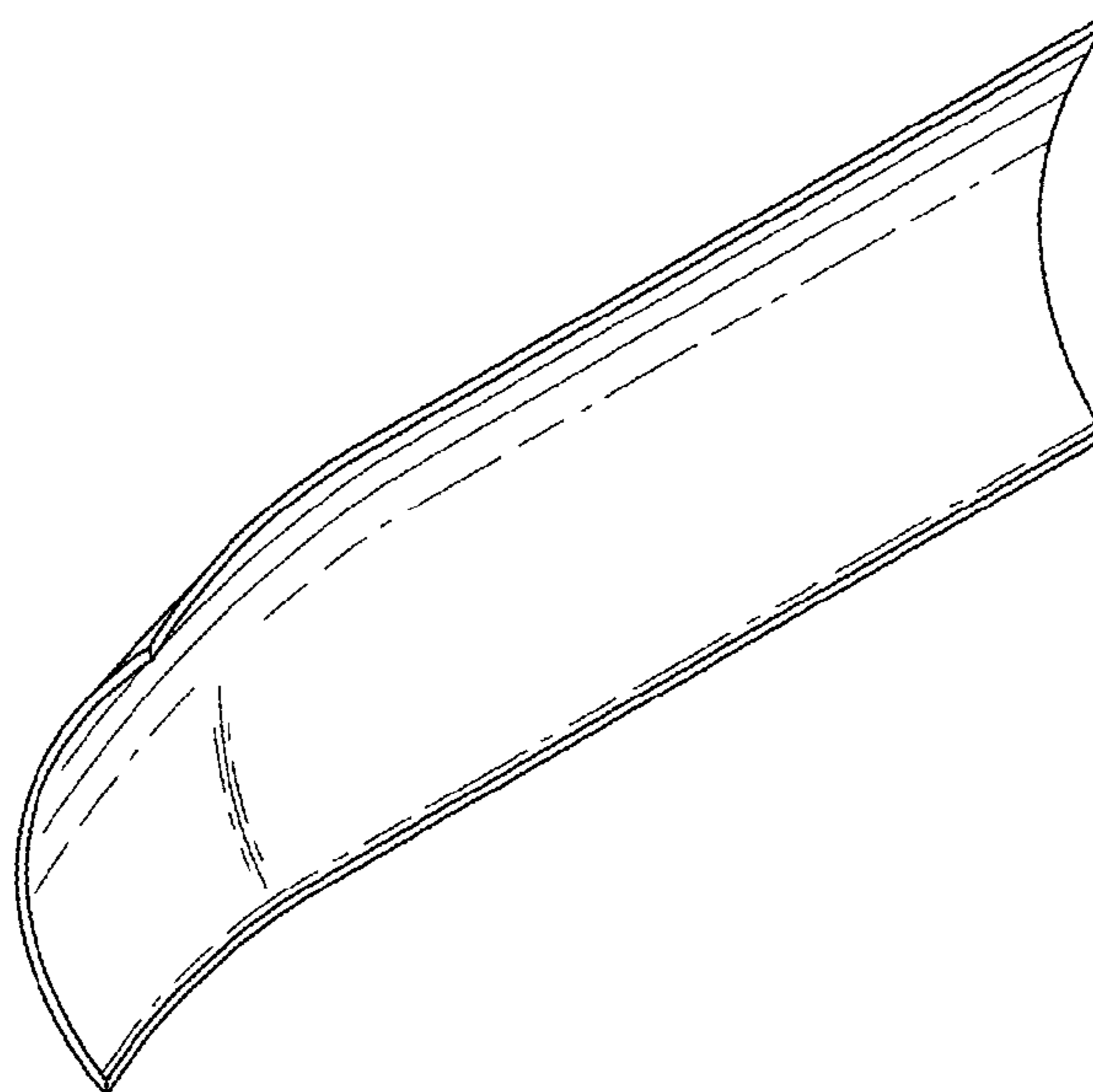
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the embodiment showing the new design for a snow shovel blade;

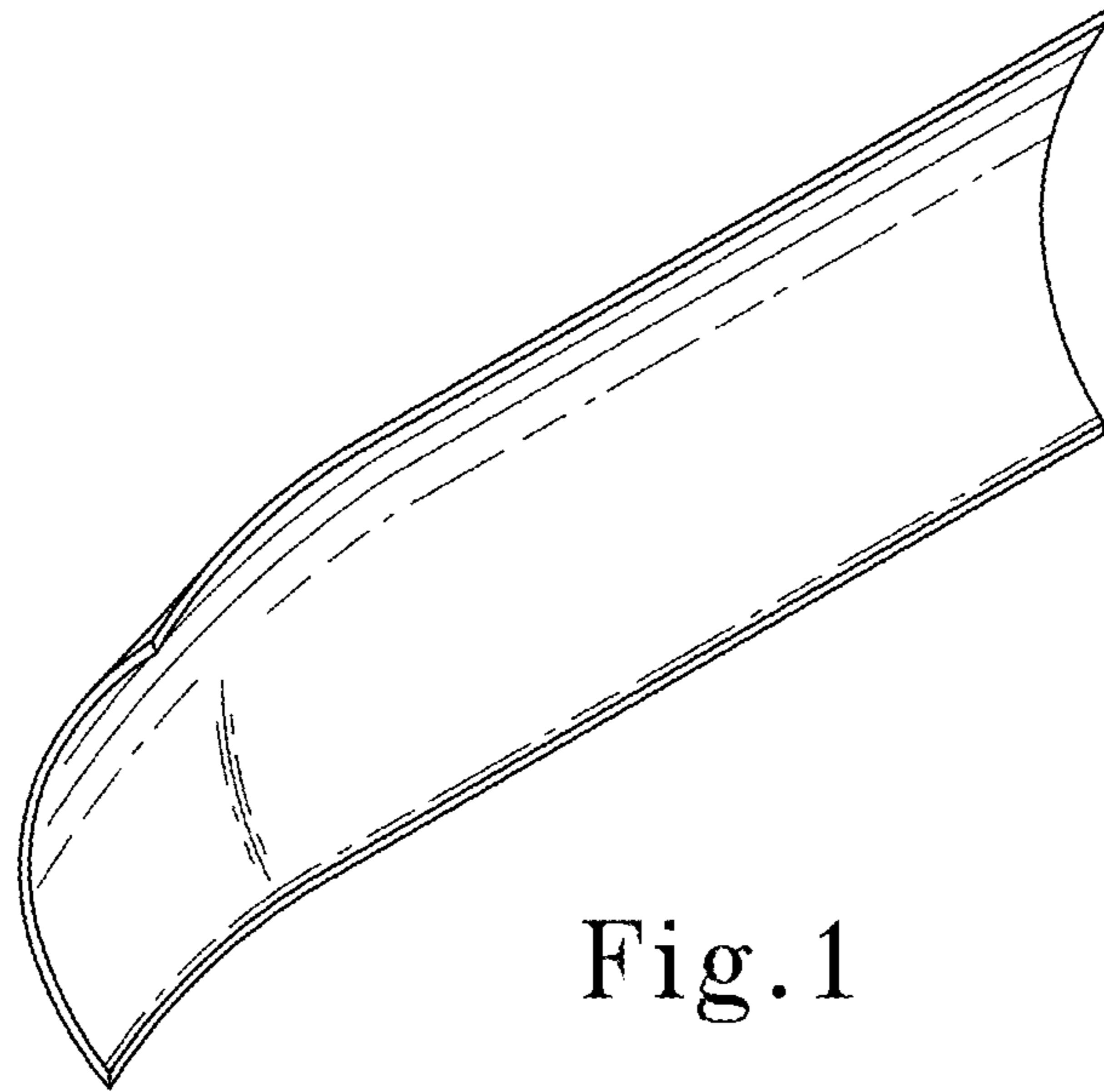

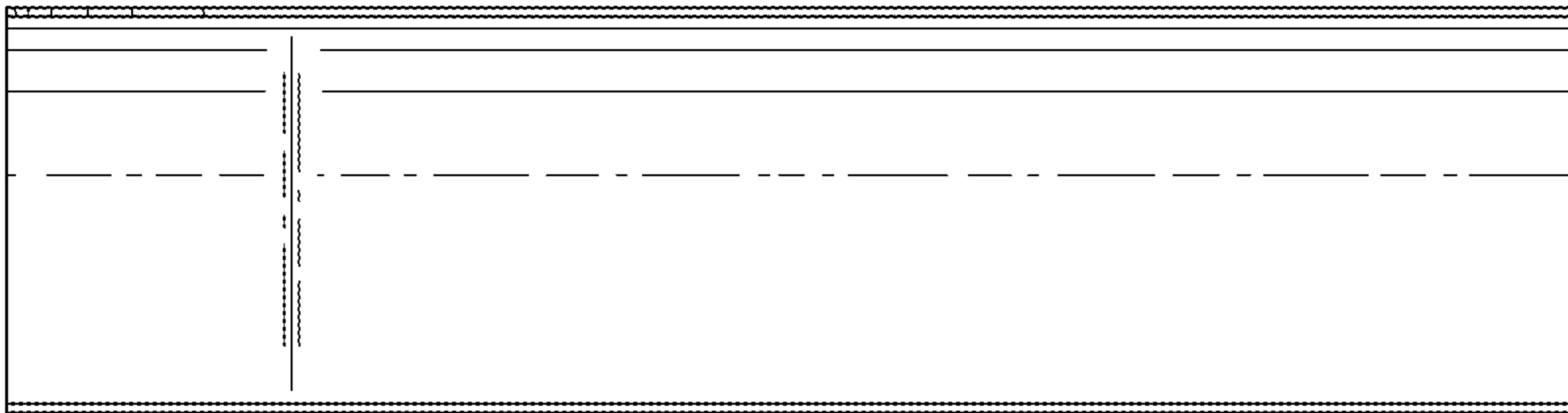

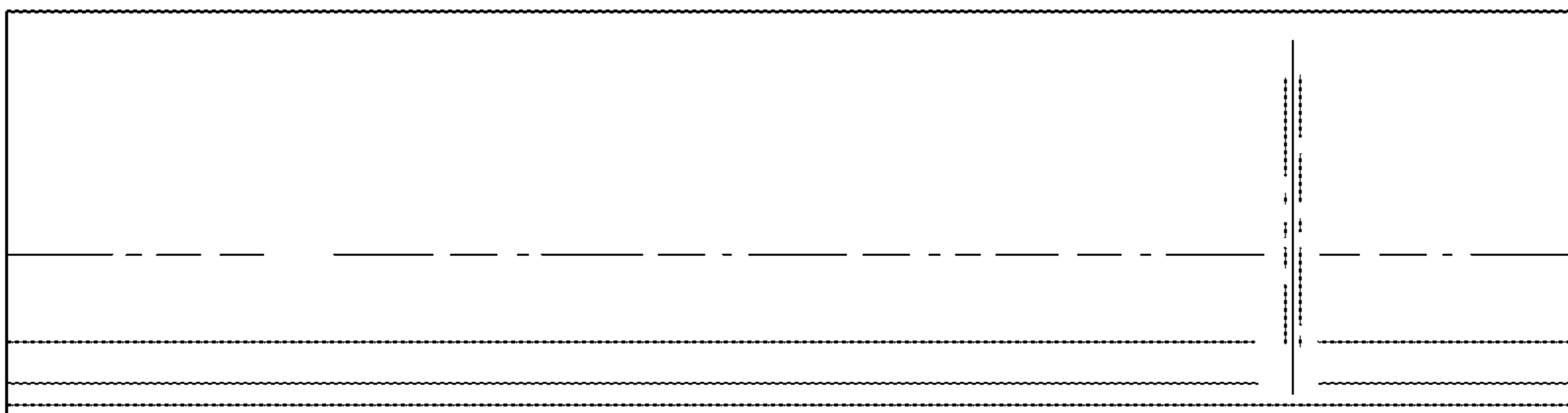

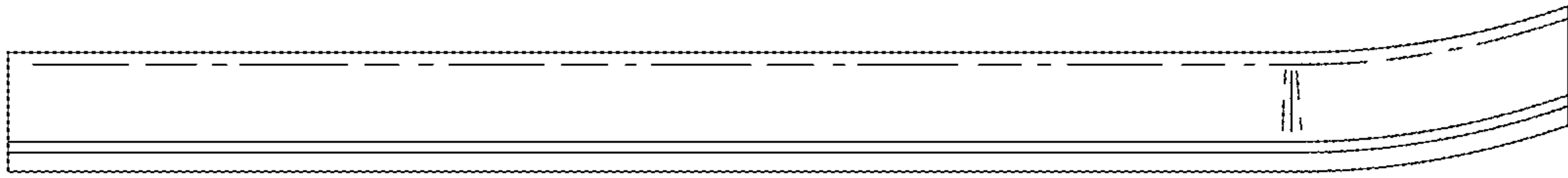

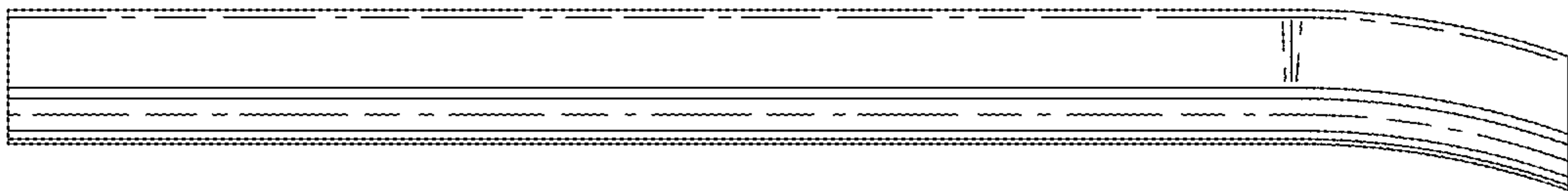

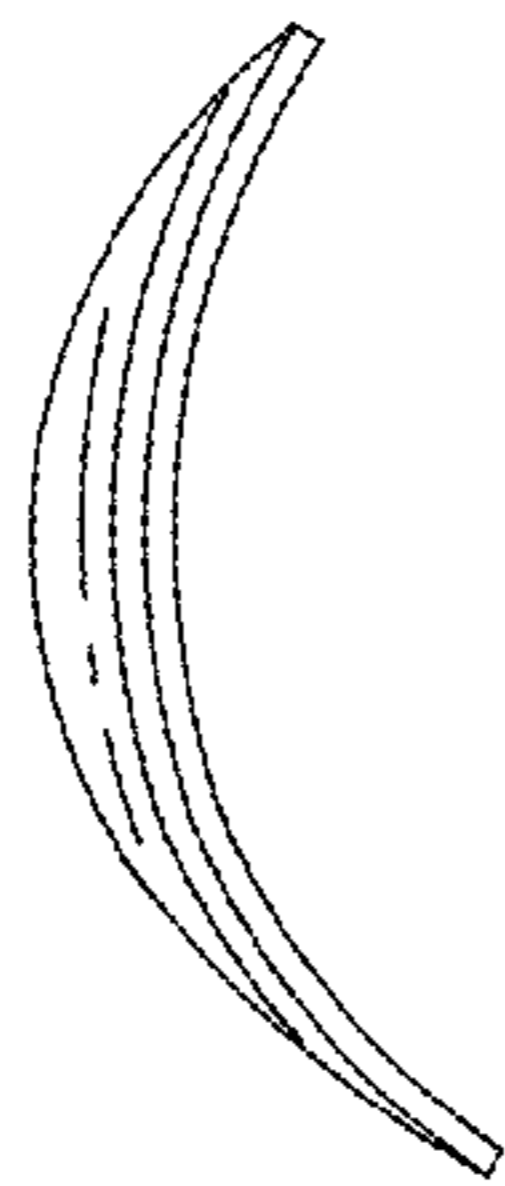

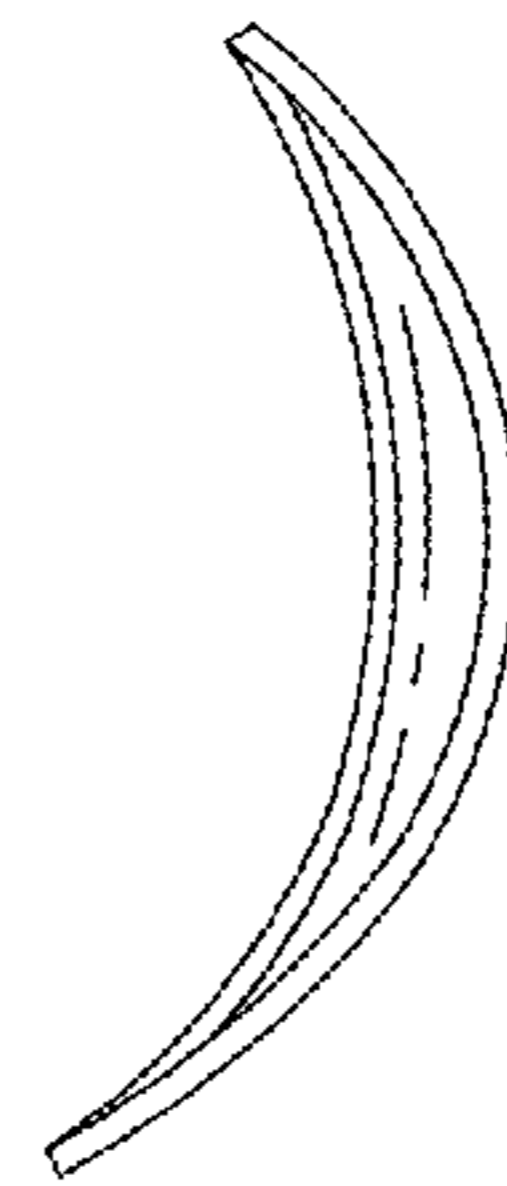
