(57) **CLAIM**

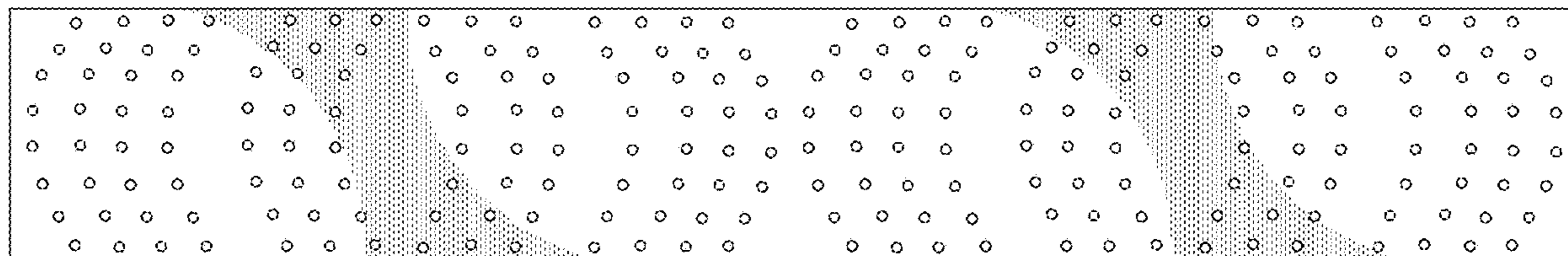
The ornamental design for an abrasive strip, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of an abrasive strip, showing the new design;
FIG. 2 is a bottom plan view of the abrasive strip of FIG. 1, with a fold line at the center;
FIG. 3 is a side elevation view of the abrasive strip of FIGS. 1 and 2;
FIG. 4 is a top plan view of an alternate embodiment of the abrasive strip, with the outer edge shown by broken lines;
FIG. 5 is a bottom plan view of the abrasive strip of FIG. 4, with a fold line at the center; and,
FIG. 6 is a side elevation view of the abrasive strip of FIGS. 4 and 5.

The broken line portions of the Figures are included to show unclaimed subject matter and form no part of the claimed design.

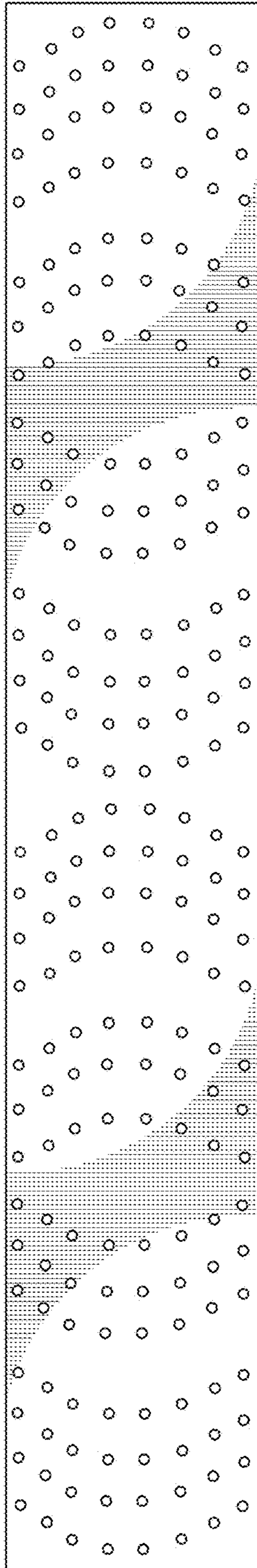

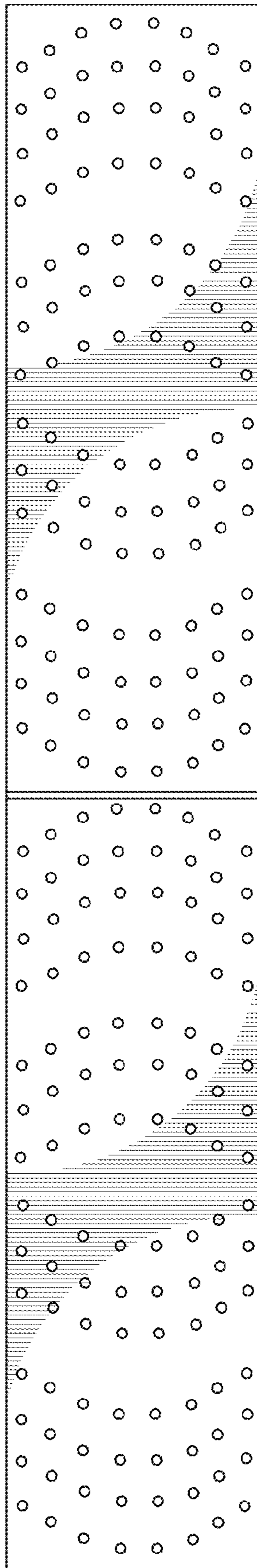

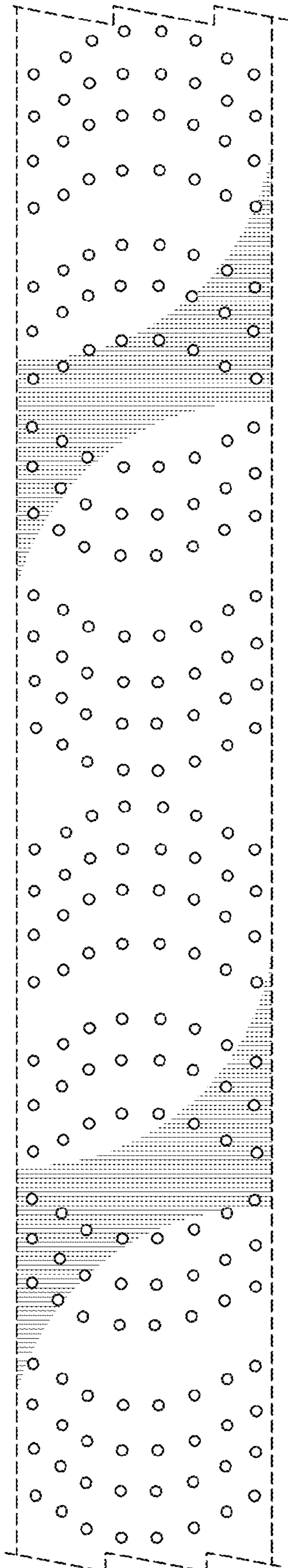

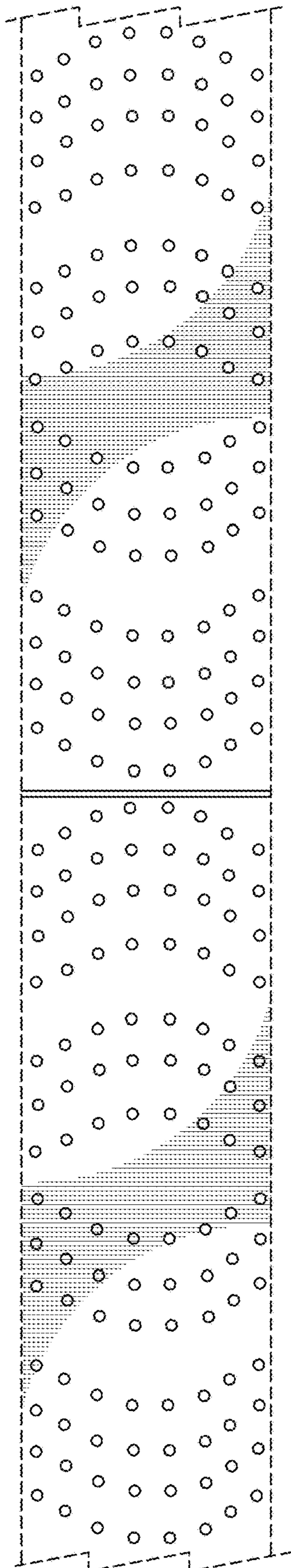
