The ornamental design for a bottle, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top perspective view of a bottle in accordance with the invention.

FIG. 2 is a bottom, rear perspective view of the bottle depicted in FIG. 1.

FIG. 3 is a front, orthogonal view of the bottle depicted in FIG. 1.

FIG. 4 is a right, orthogonal view of the bottle depicted in FIG. 1.

FIG. 5 is a back, orthogonal view of the bottle depicted in FIG. 1.

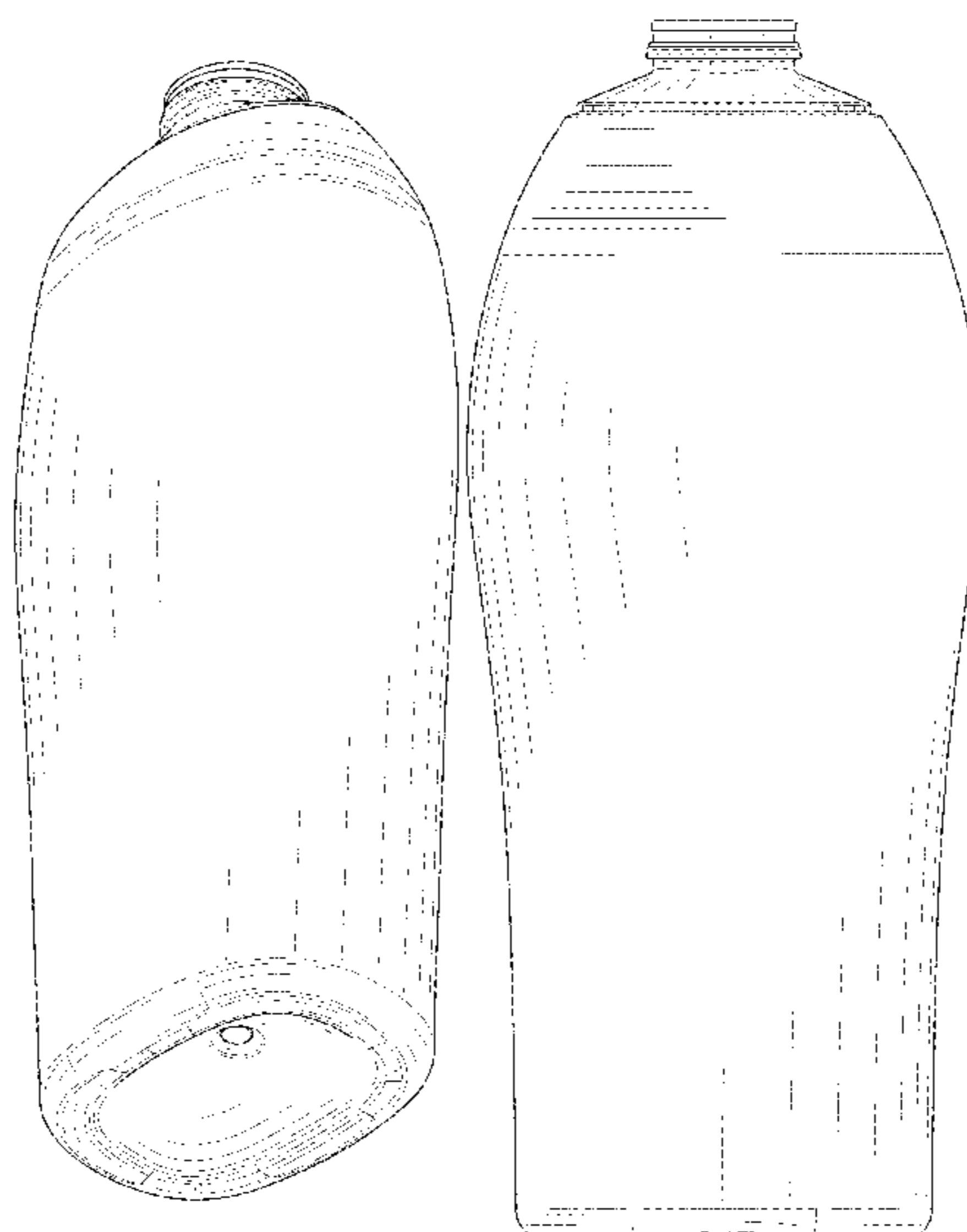
FIG. 6 is a left, orthogonal view of the bottle depicted in FIG. 1.

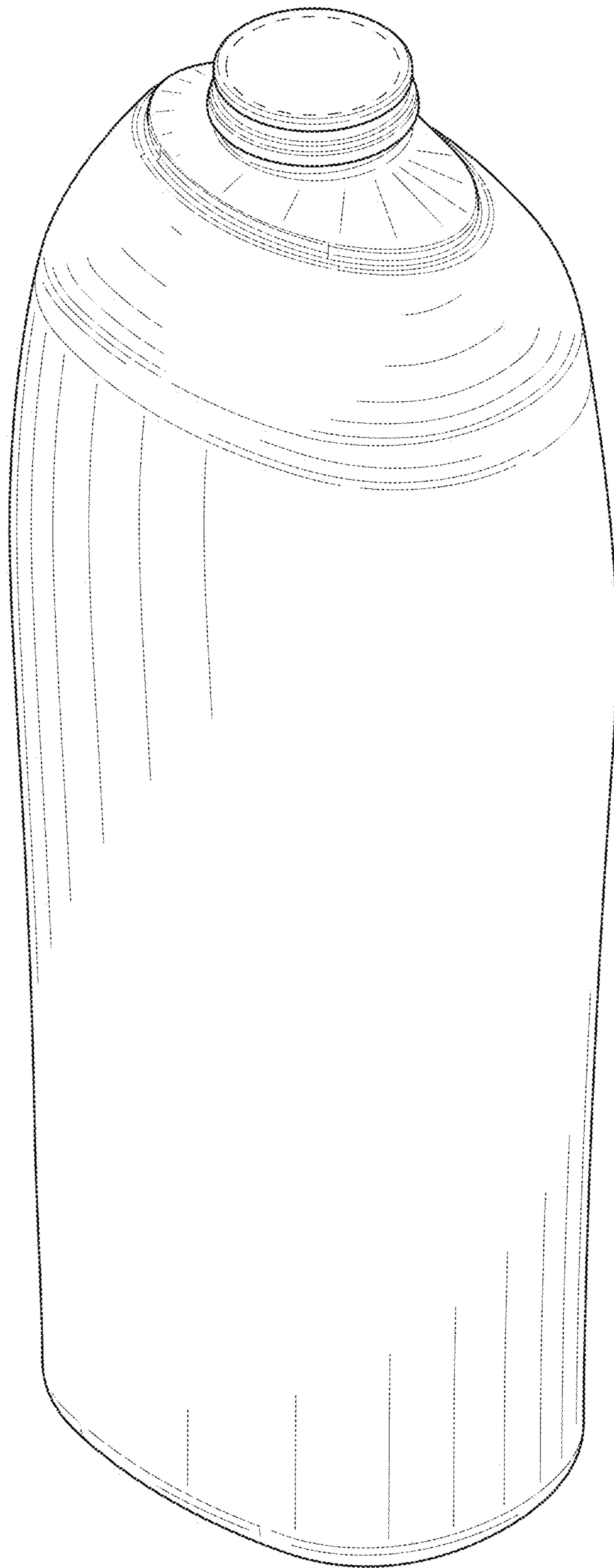

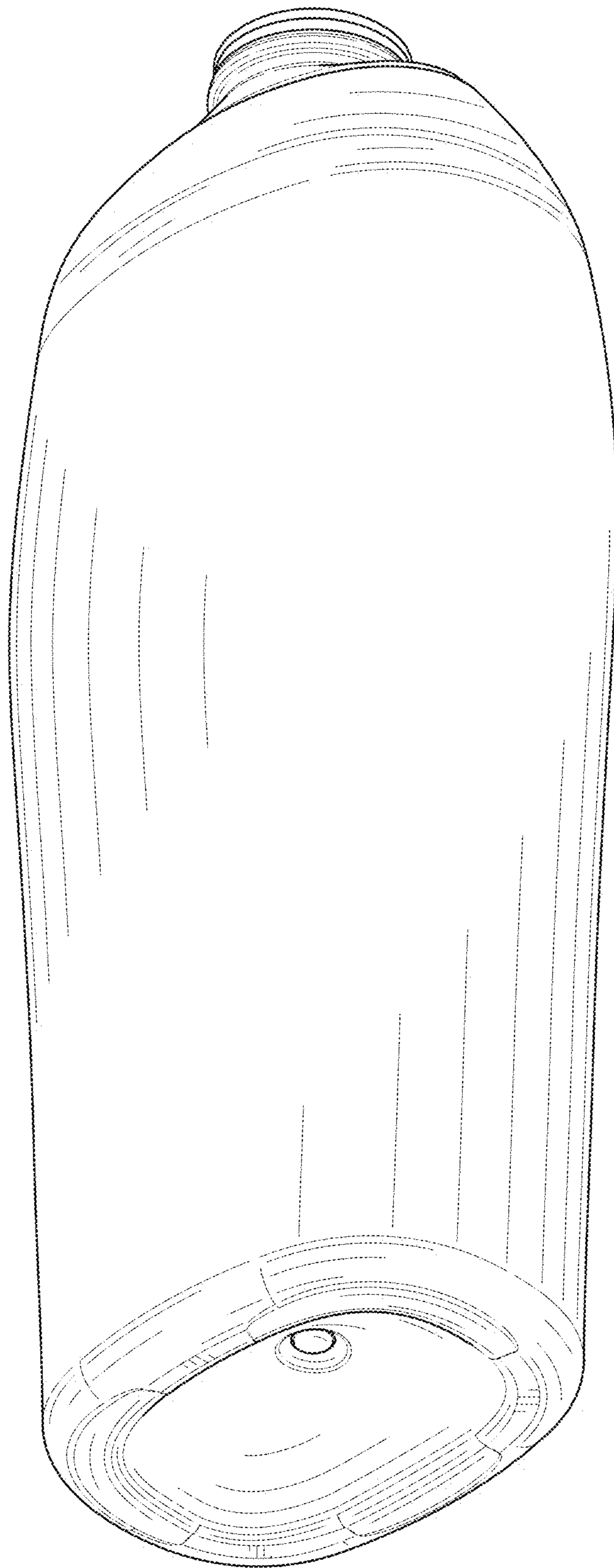

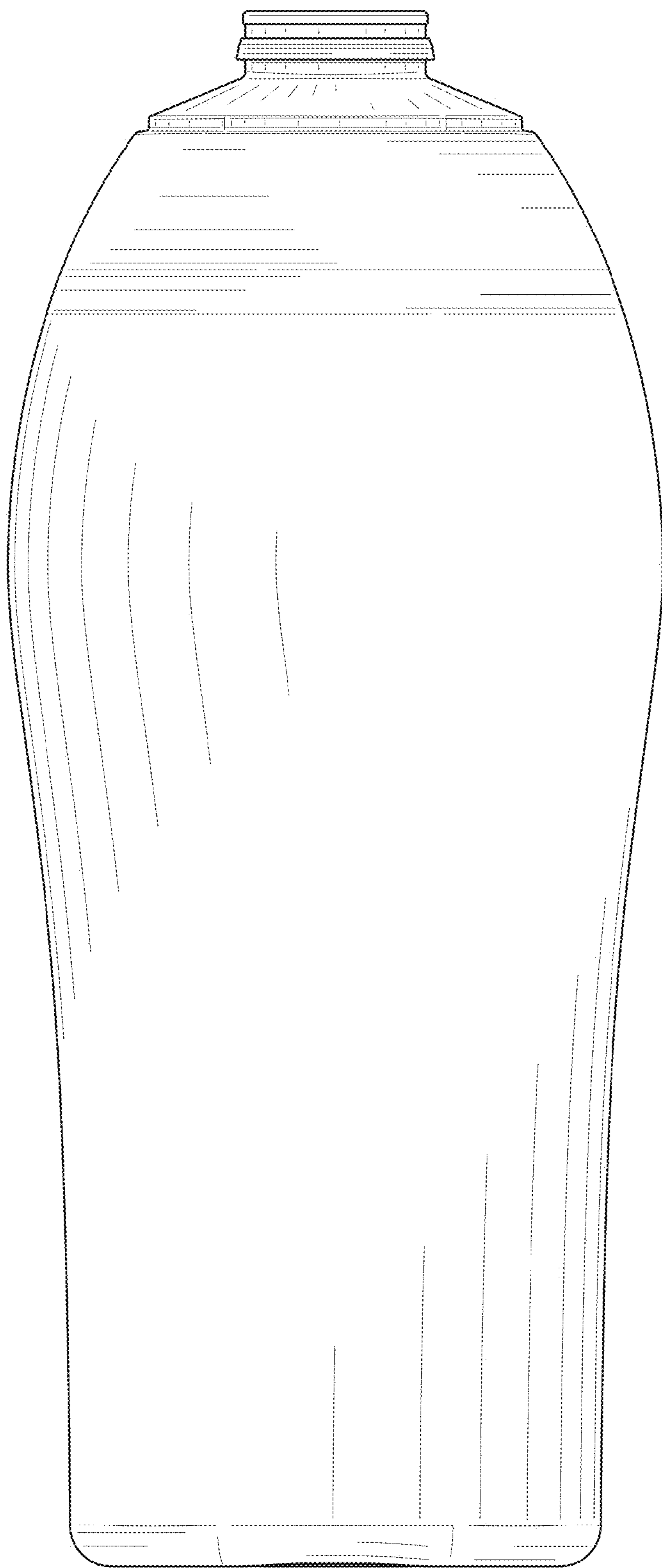

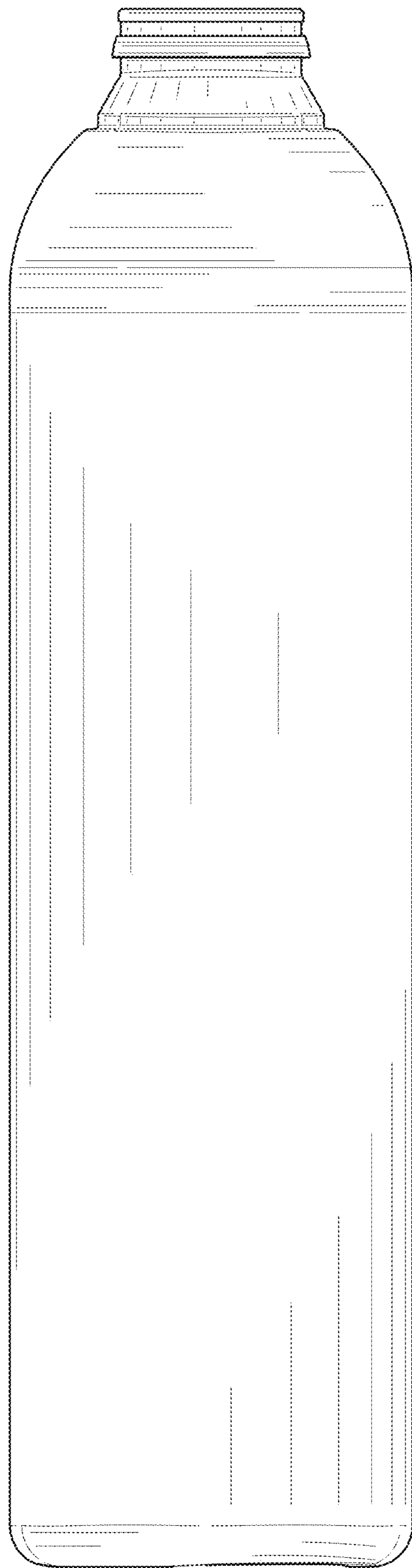

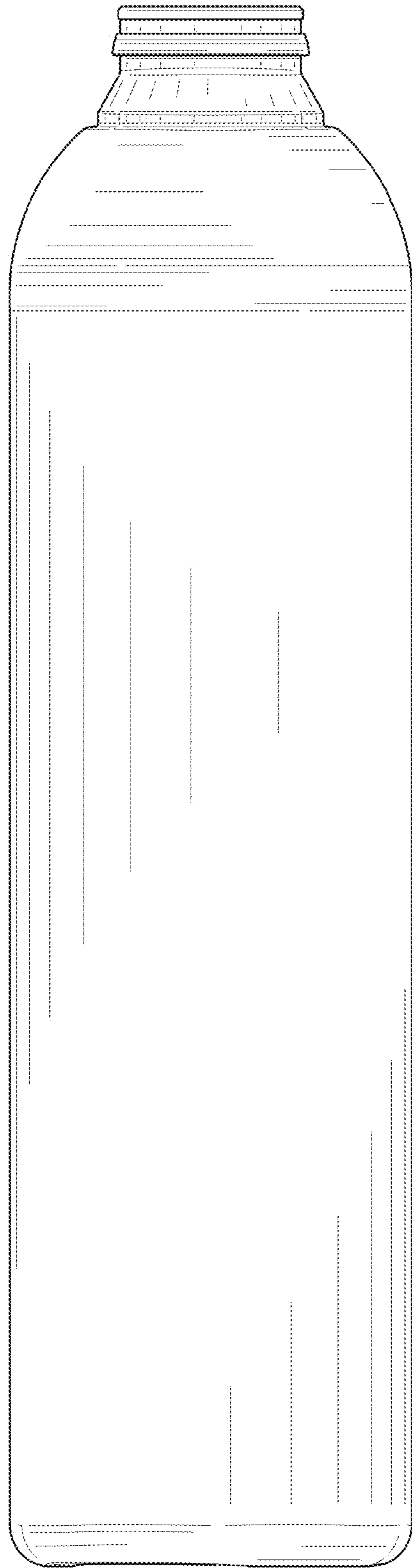

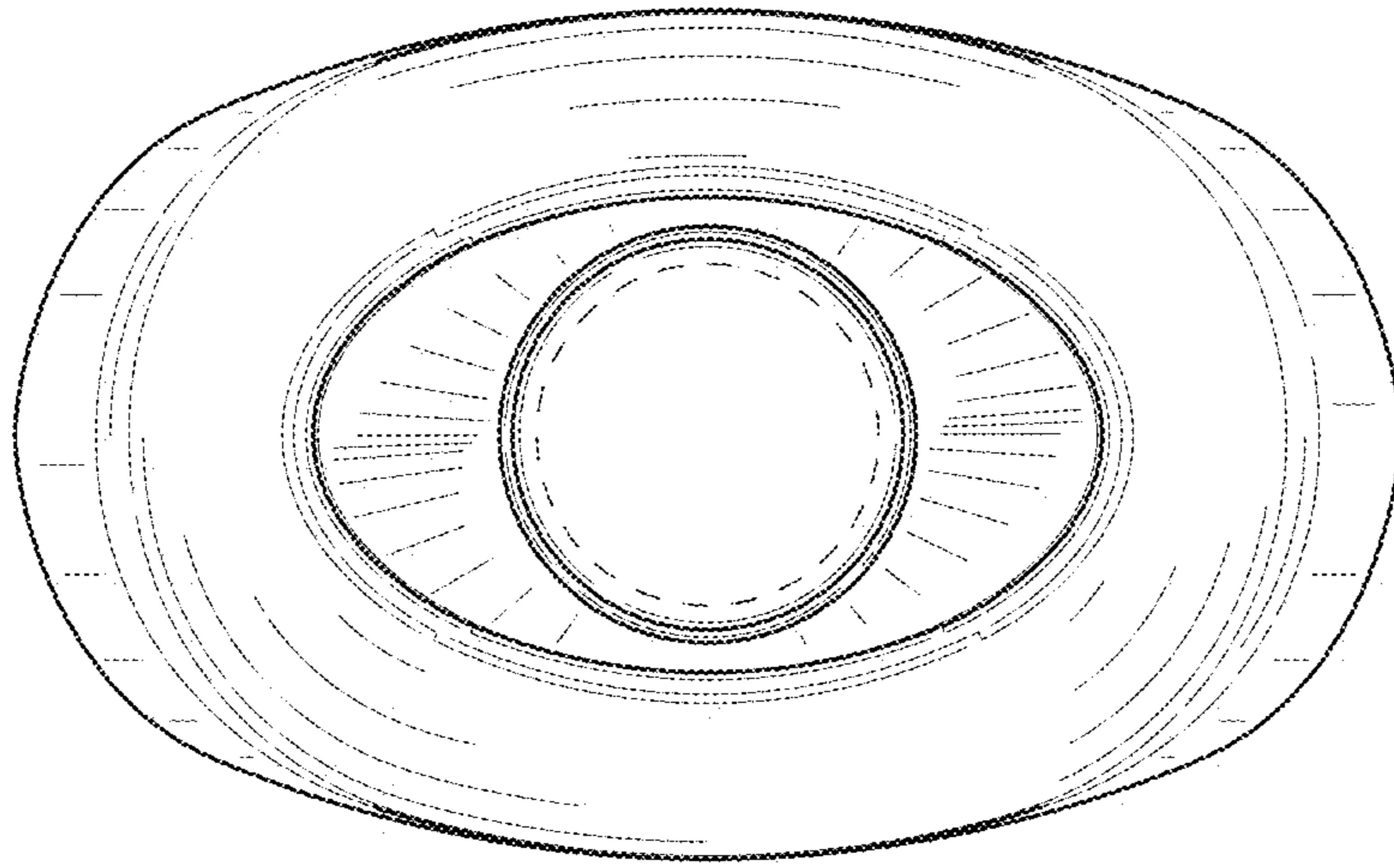

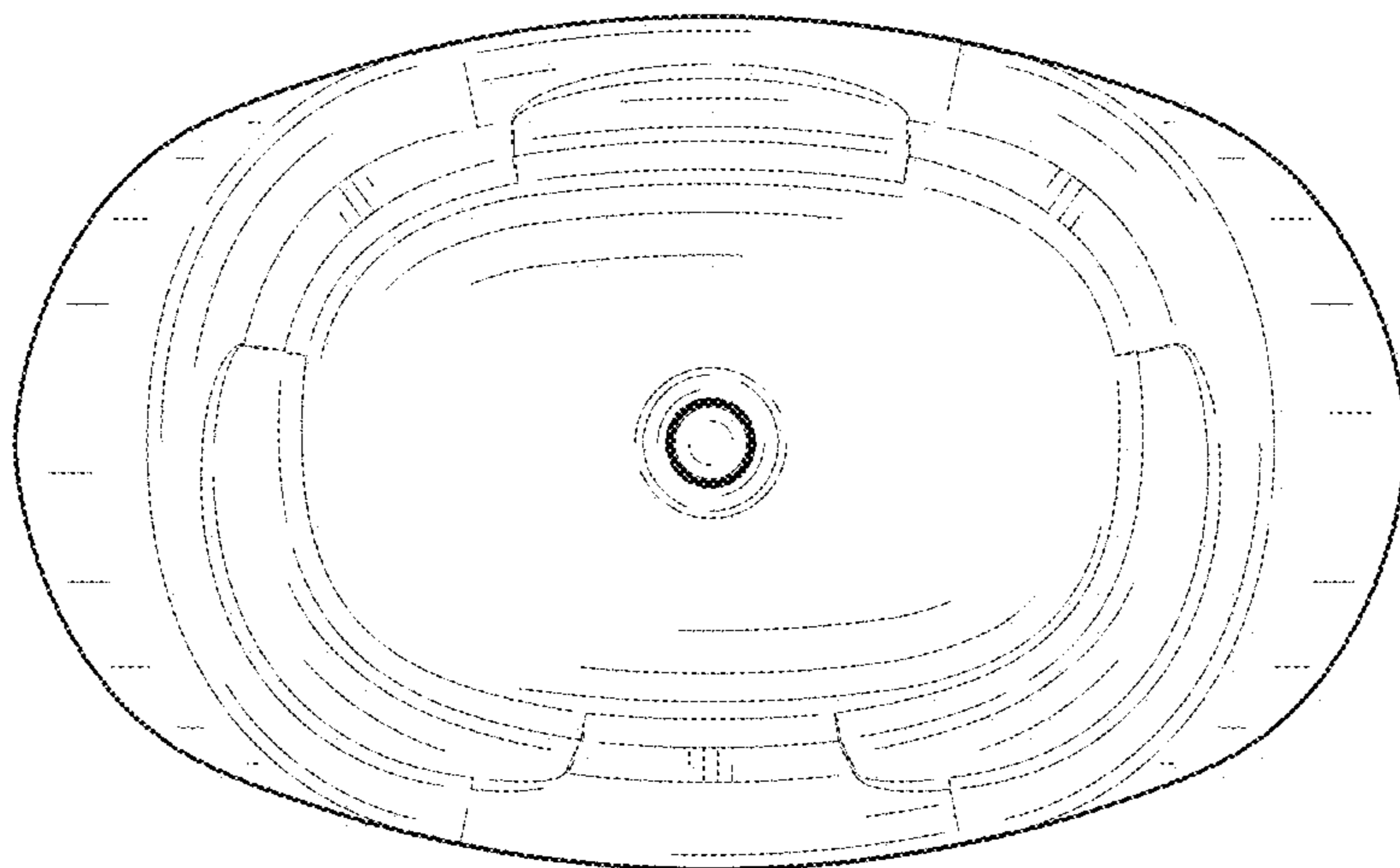
