(57) **CLAIM**

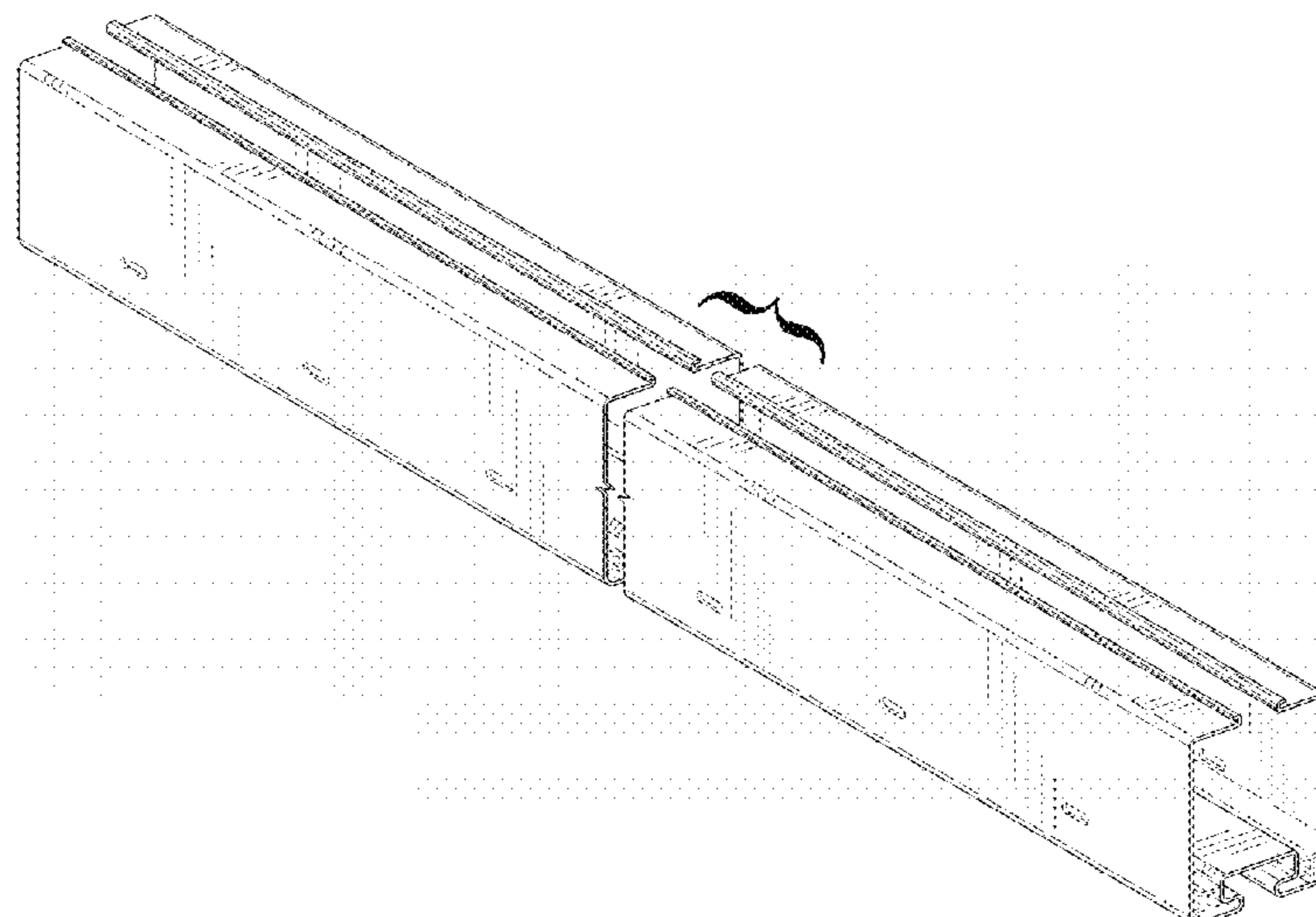
I claim the ornamental design for a growing tray, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-front perspective view of a growing tray, showing the new design;  
FIG. 2 is a bottom-rear perspective view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a front view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a rear view thereof;  
FIG. 7 is a top plan view thereof; and  
FIG. 8 is a bottom plan view thereof.  
FIG. 9 is a top-front perspective view of a second embodiment of a growing tray, showing the new design;  
FIG. 10 is a bottom-rear perspective view thereof;  
FIG. 11 is a left side view thereof;  
FIG. 12 is a front view thereof;  
FIG. 13 is a right side view thereof;  
FIG. 14 is a rear view thereof;  
FIG. 15 is a top plan view thereof; and,  
FIG. 16 is a bottom plan view thereof.

The dashed broken lines in FIGS. 1-6 and 9-14 illustrate portions of the growing tray that form no part of the claimed design. The broken away symbols that consist of solid, straight zig-zag lines in FIGS. 1, 2, 3, 5, 7, 8, 9, 10, 11, 13, 15 and 16 indicate that the appearance of any portion of the article between the broken away symbols forms no part of the claimed design.

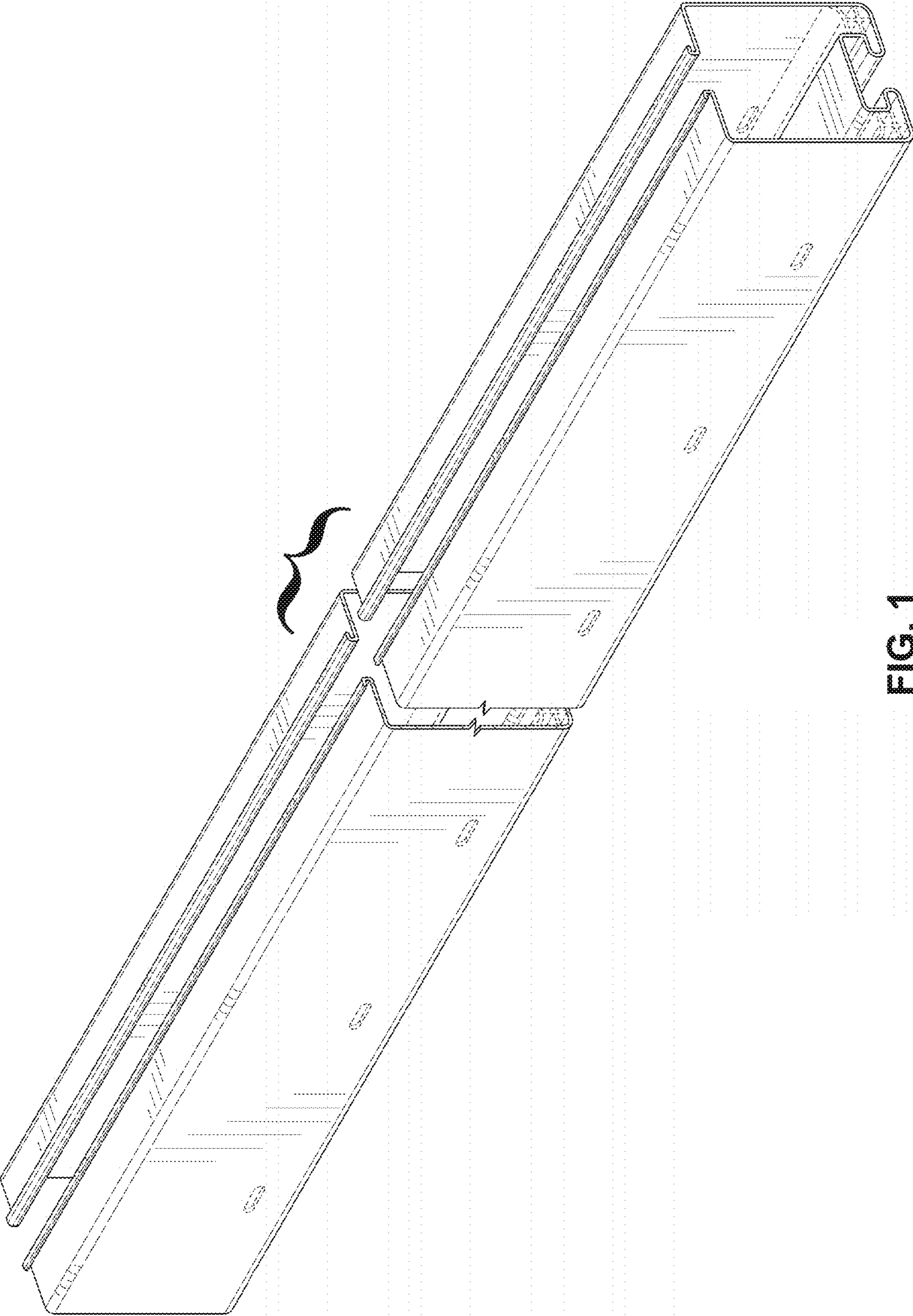

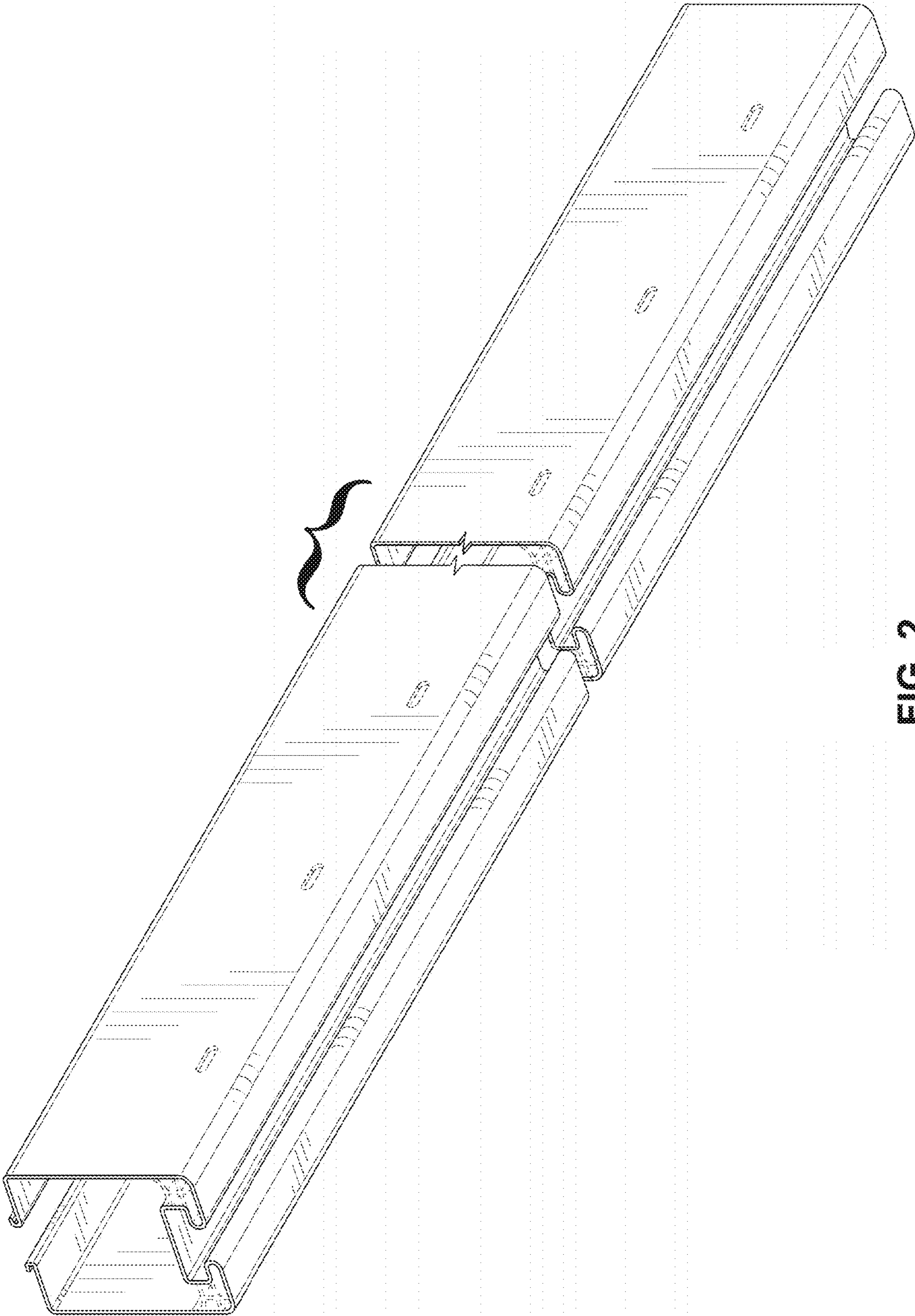

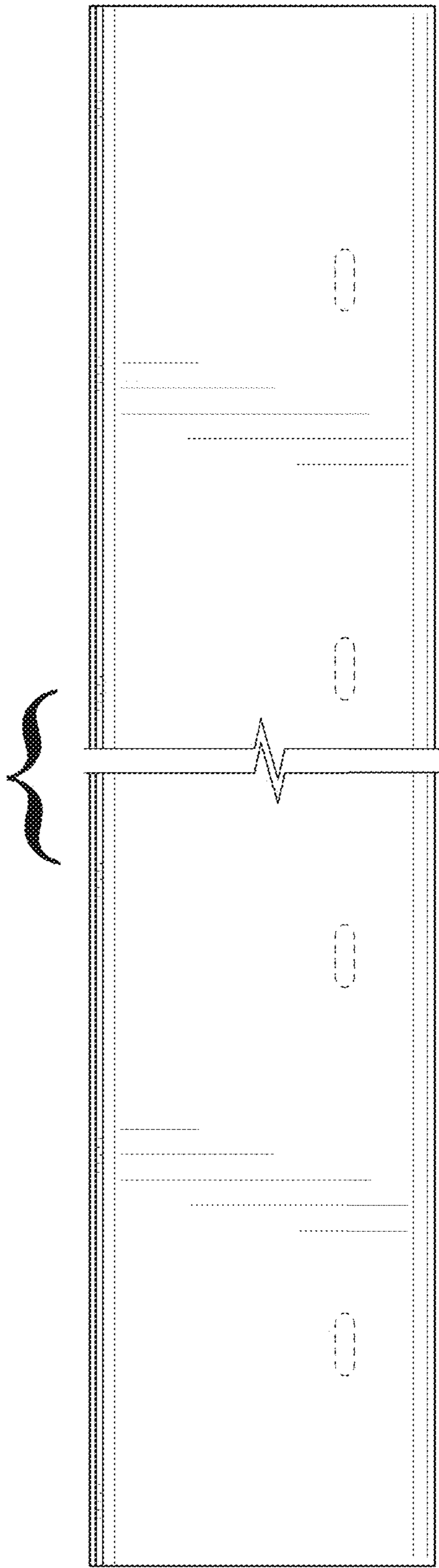

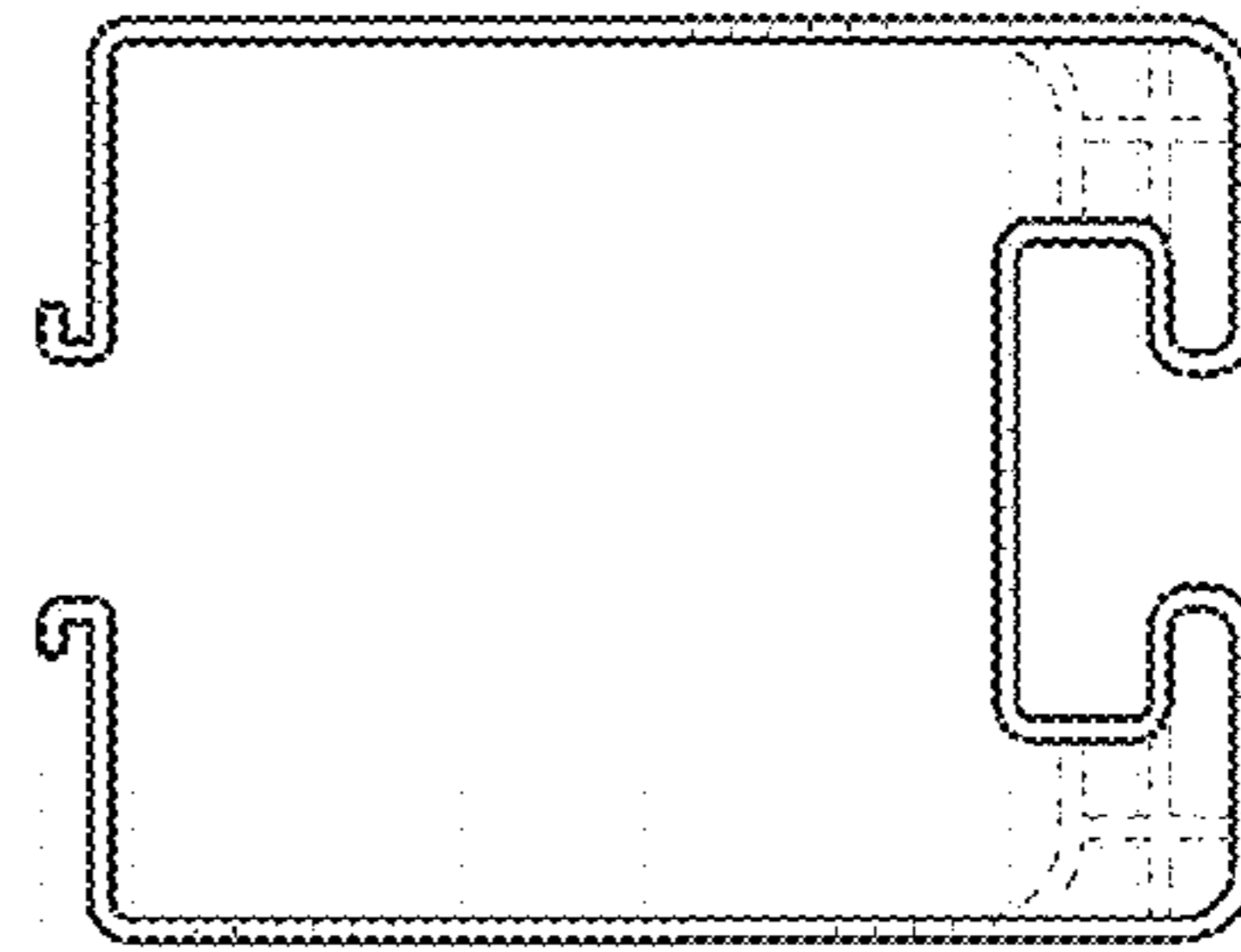

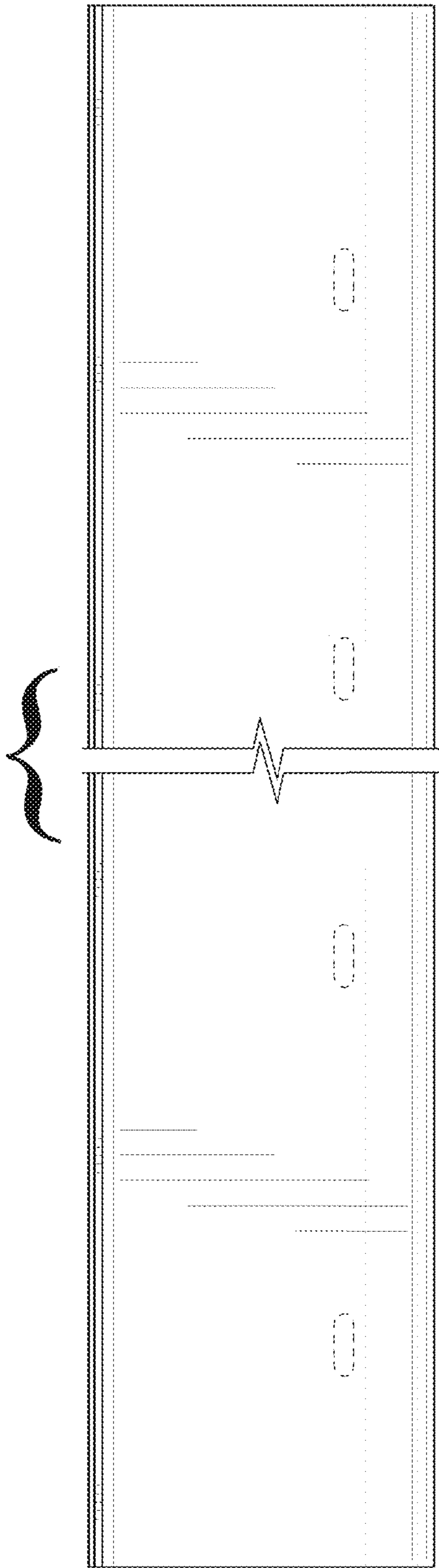

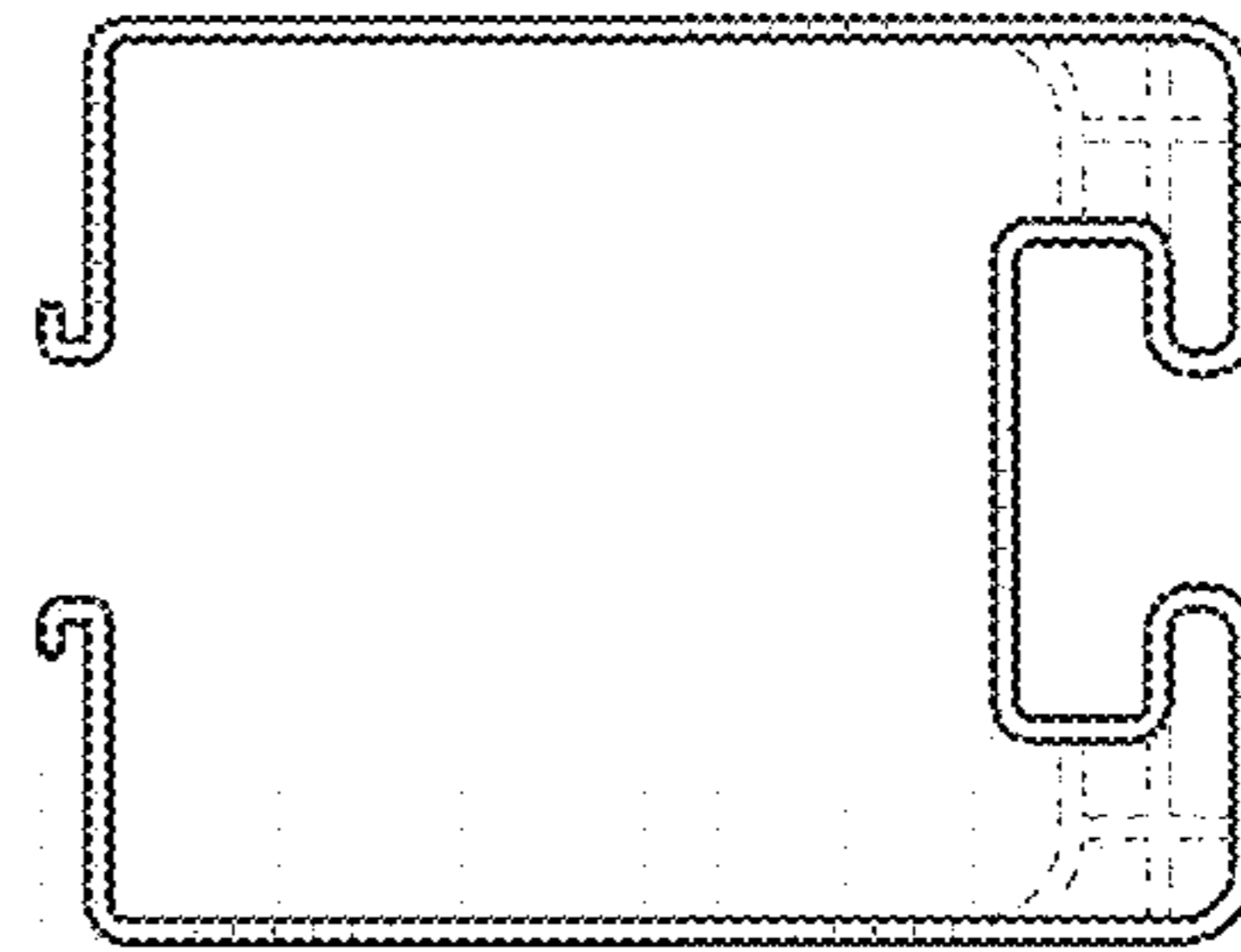

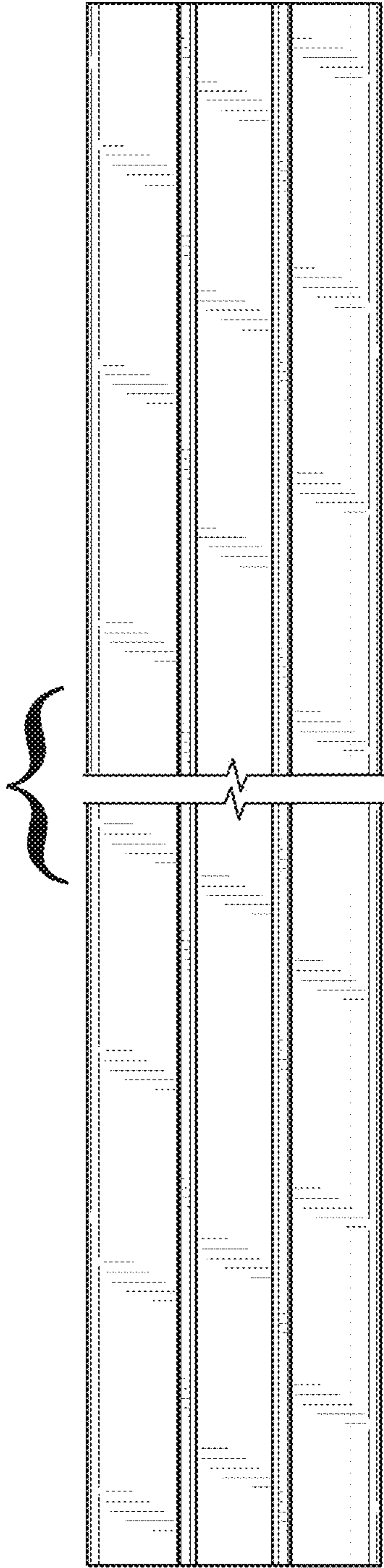

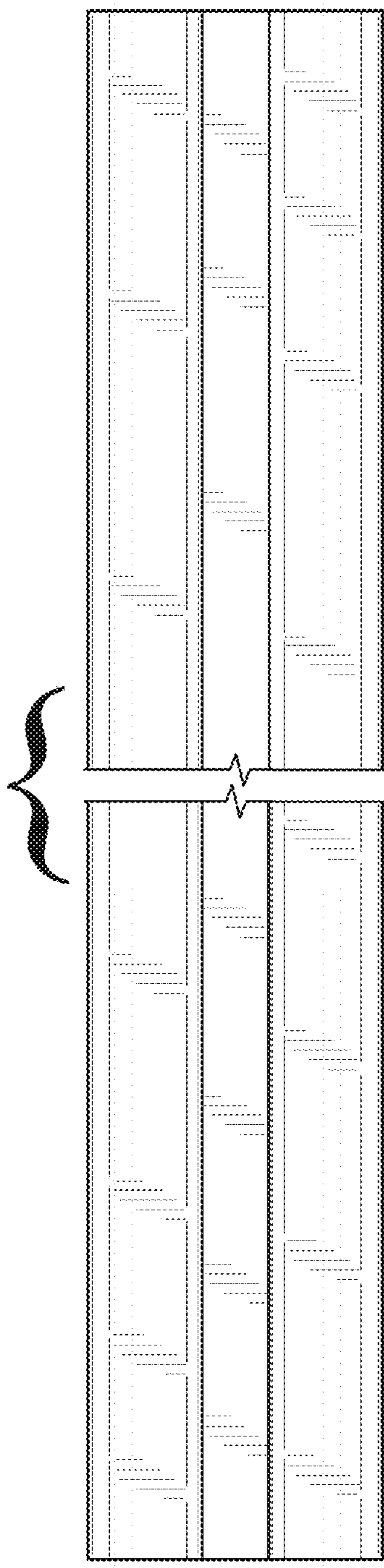

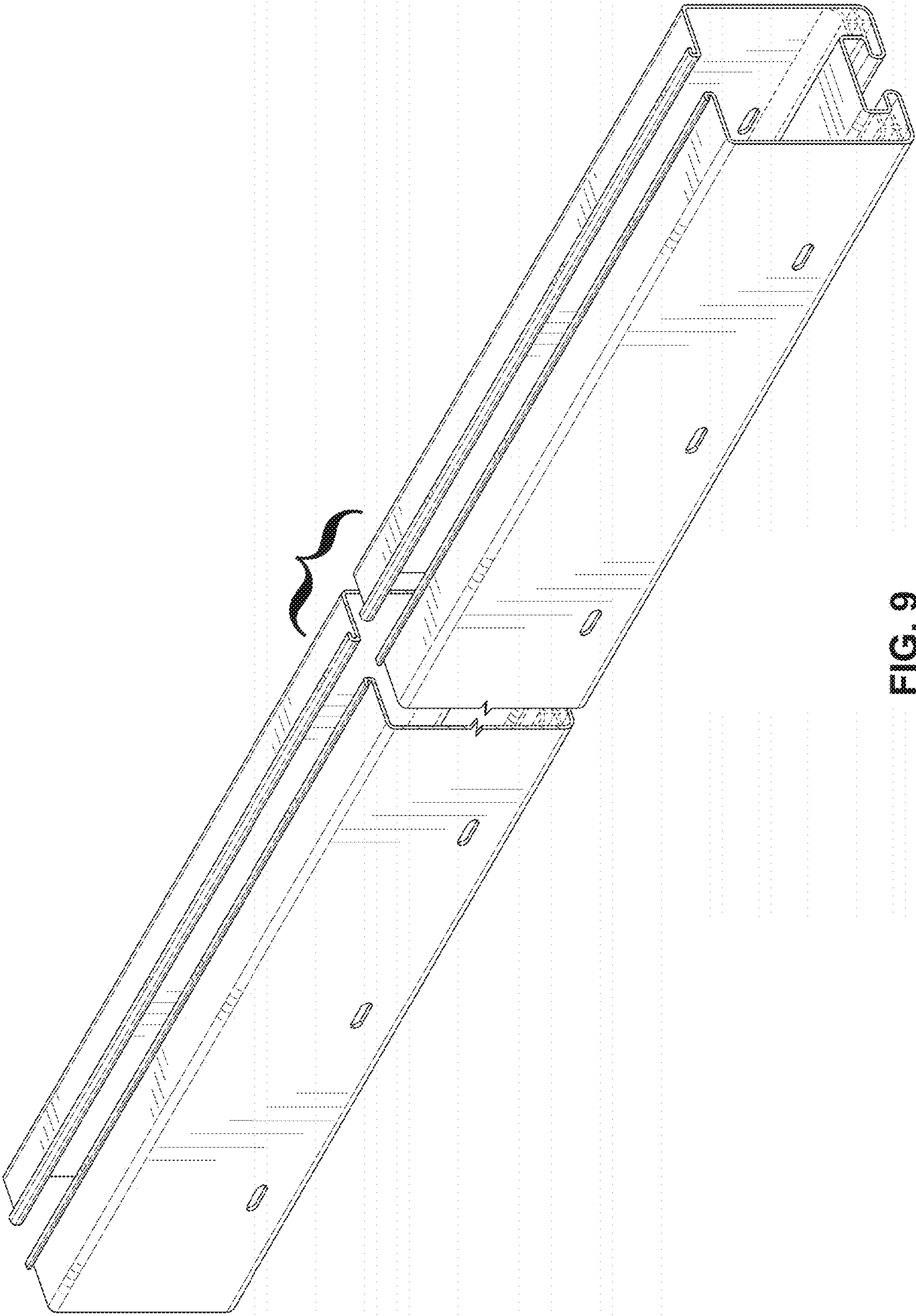

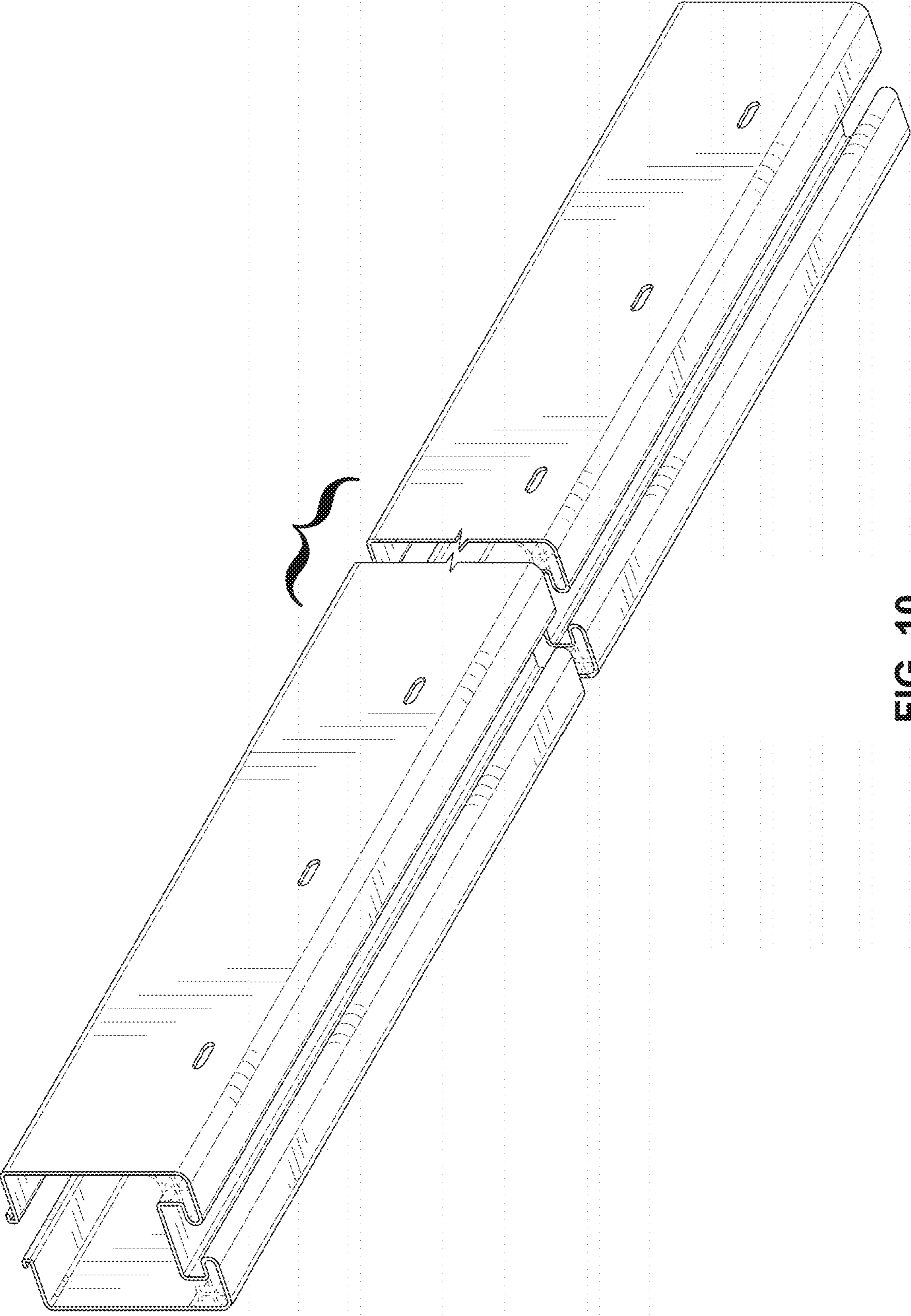

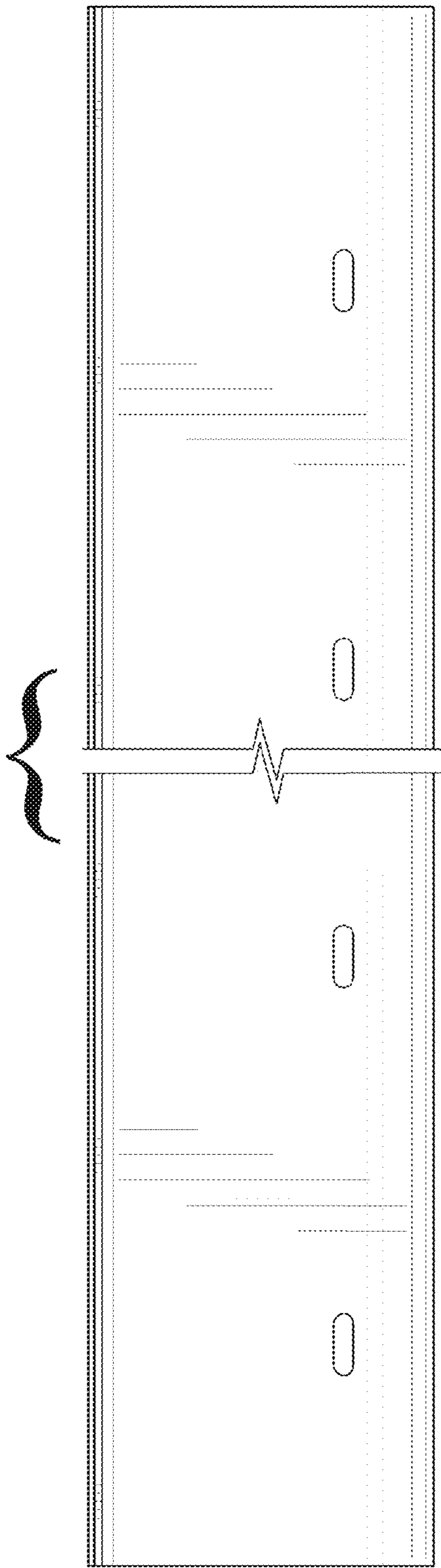

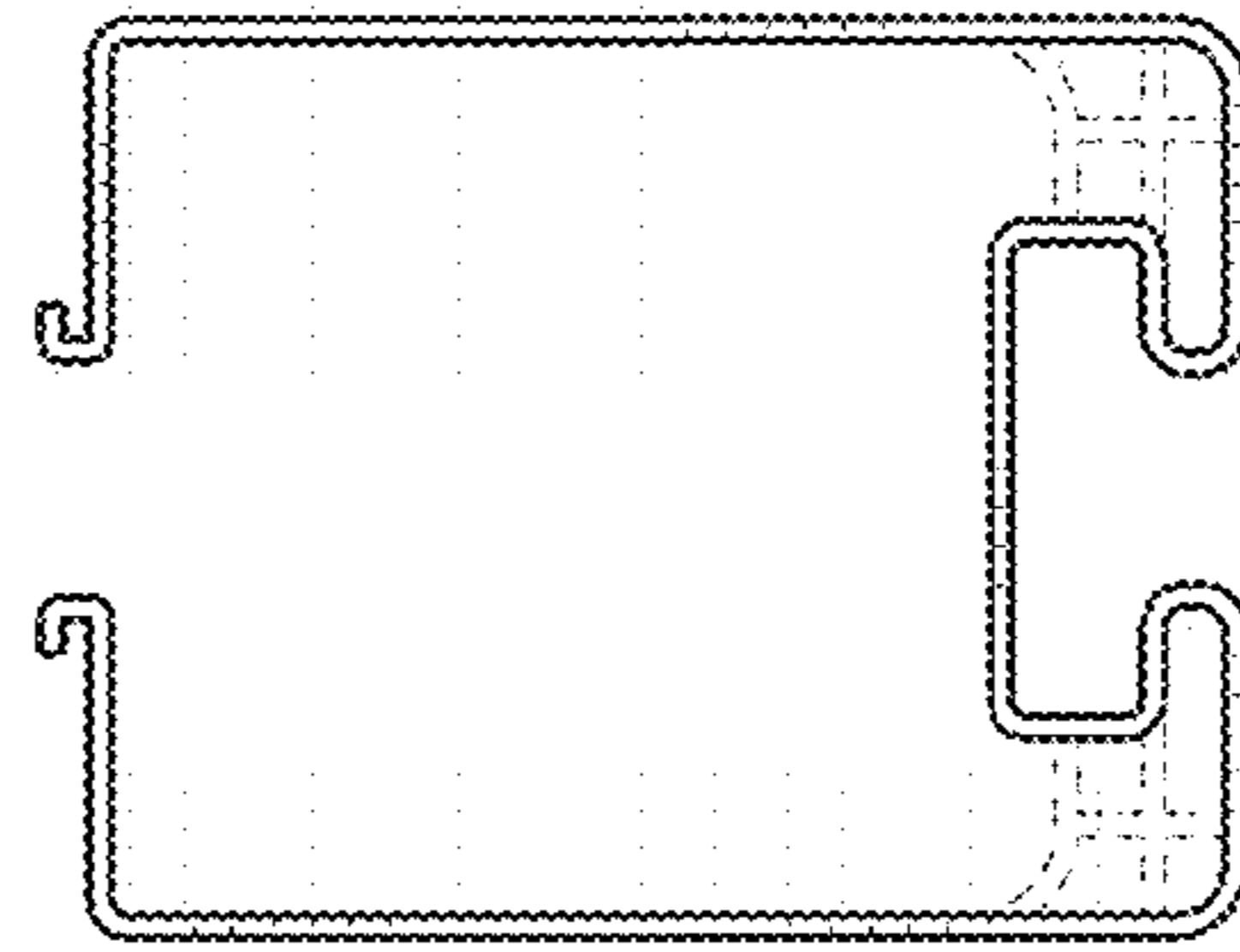




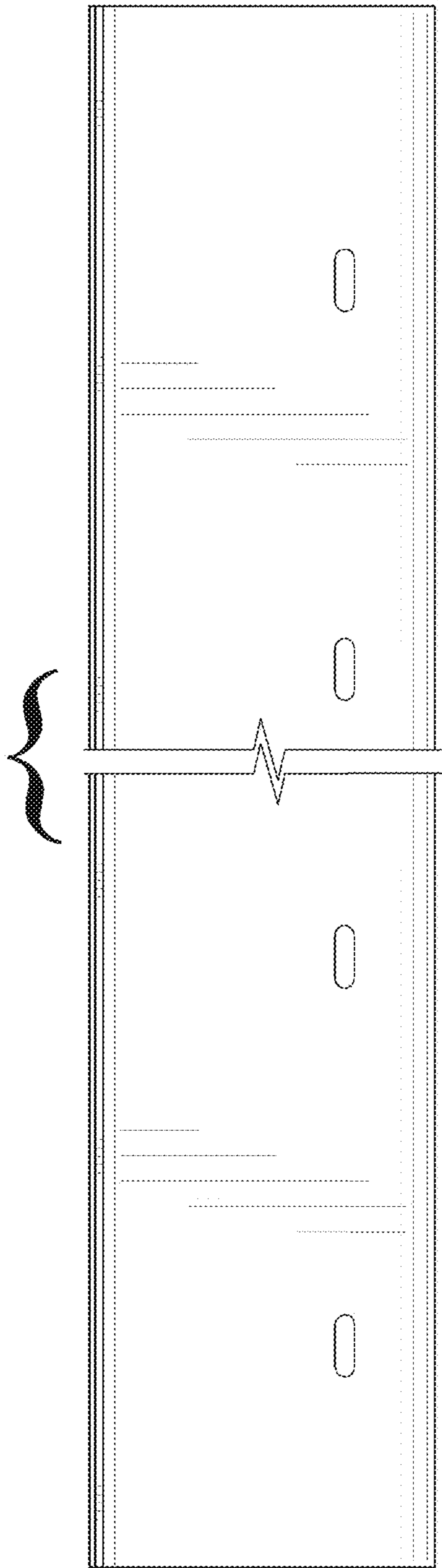

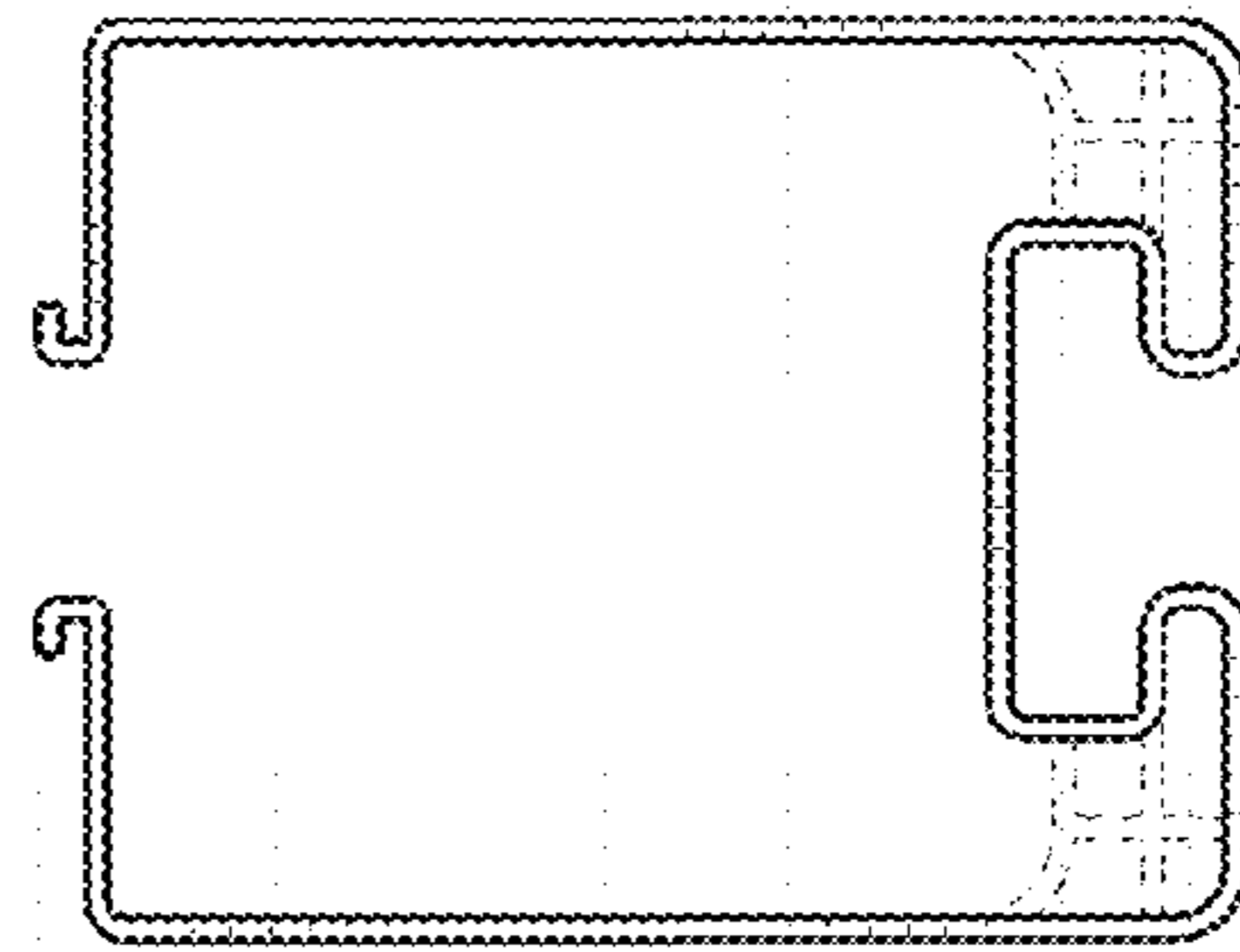

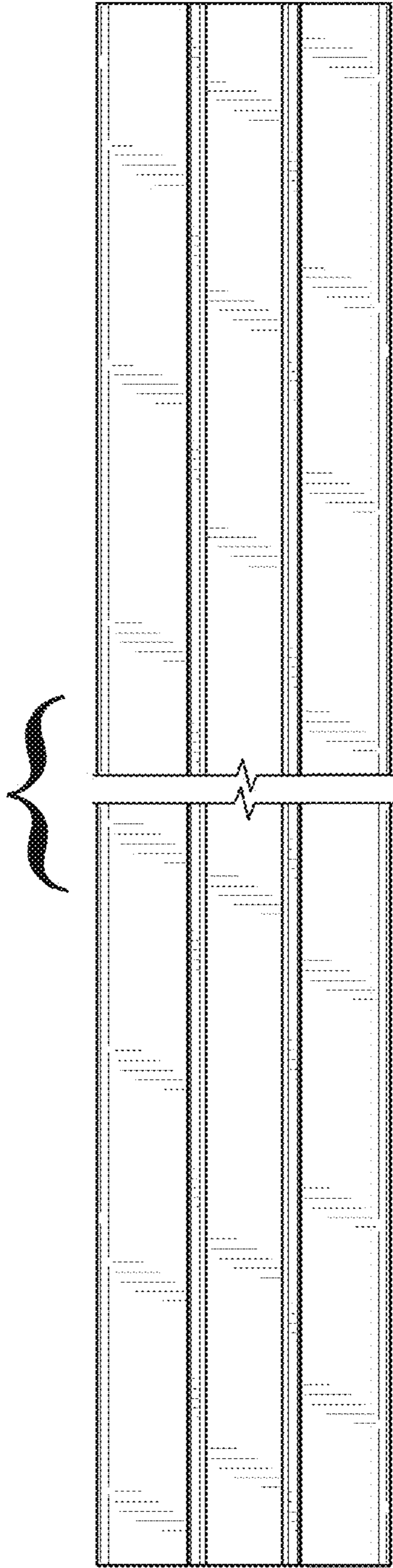

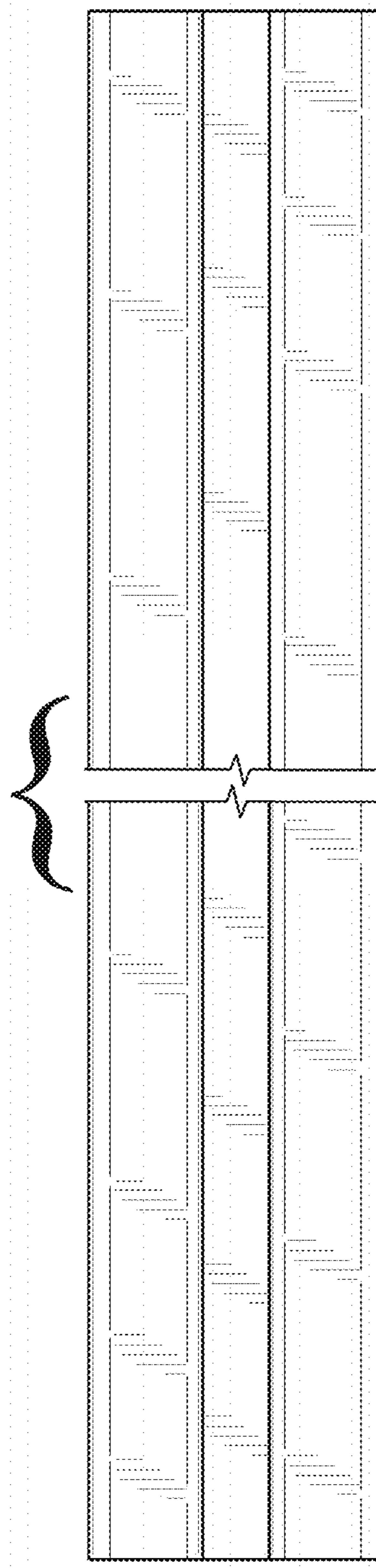
