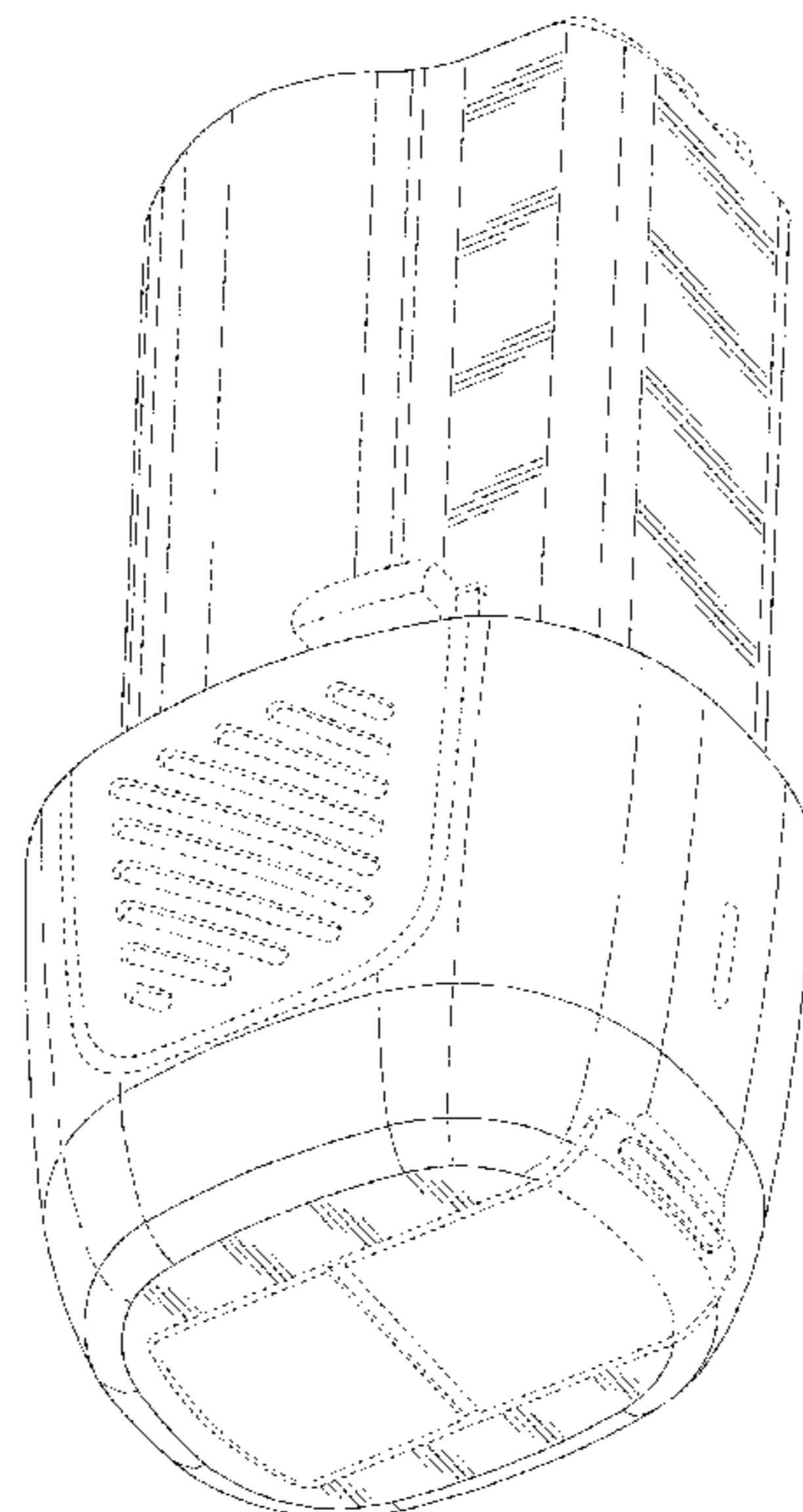
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a battery showing my new design;  
FIG. 2 is a right side elevational view of the battery of FIG. 1;  
FIG. 3 is a left side elevational view of the battery of FIG. 1;  
FIG. 4 is a top plan view of the battery of FIG. 1;  
FIG. 5 is a bottom plan view of the battery of FIG. 1;

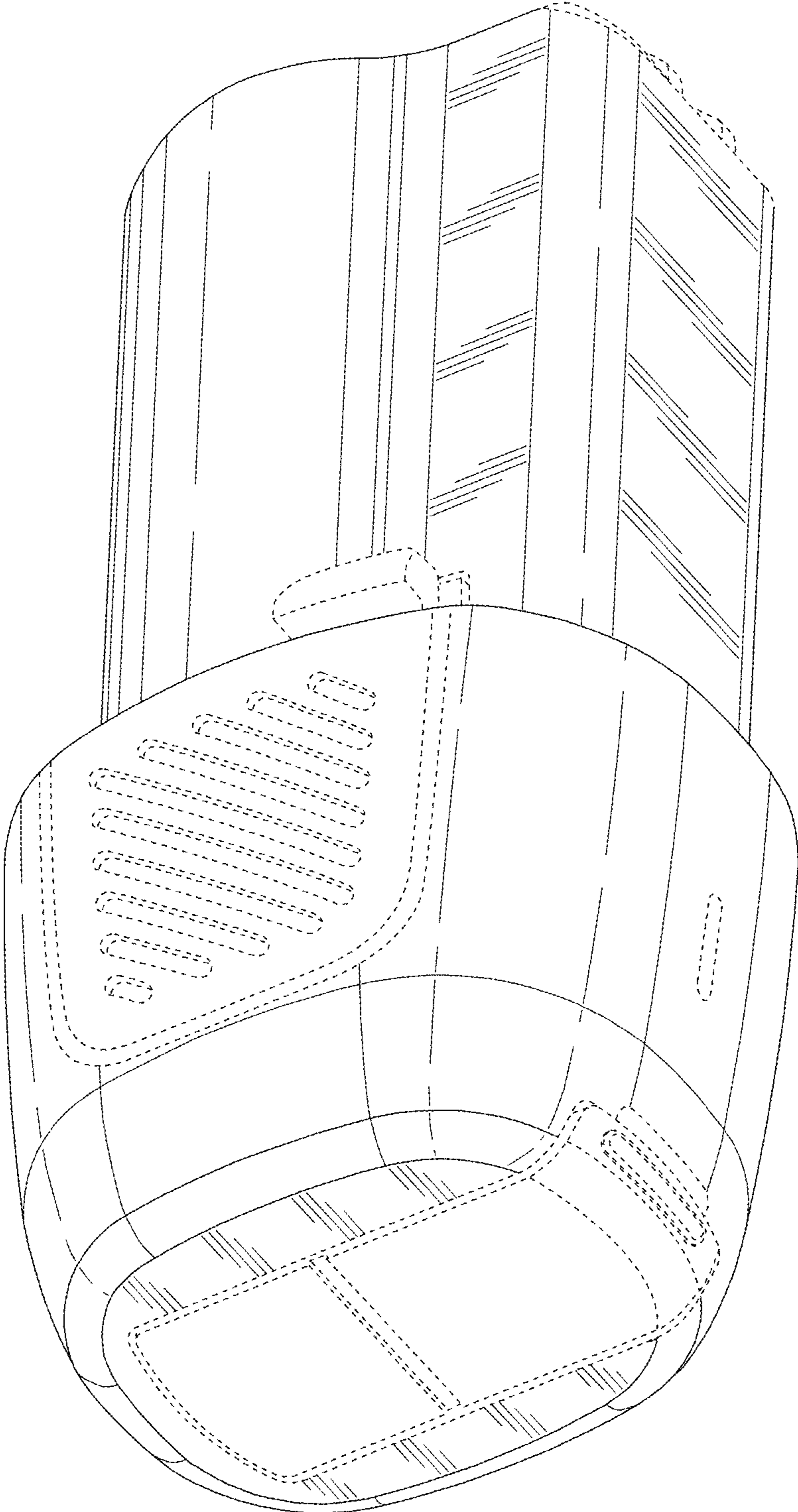

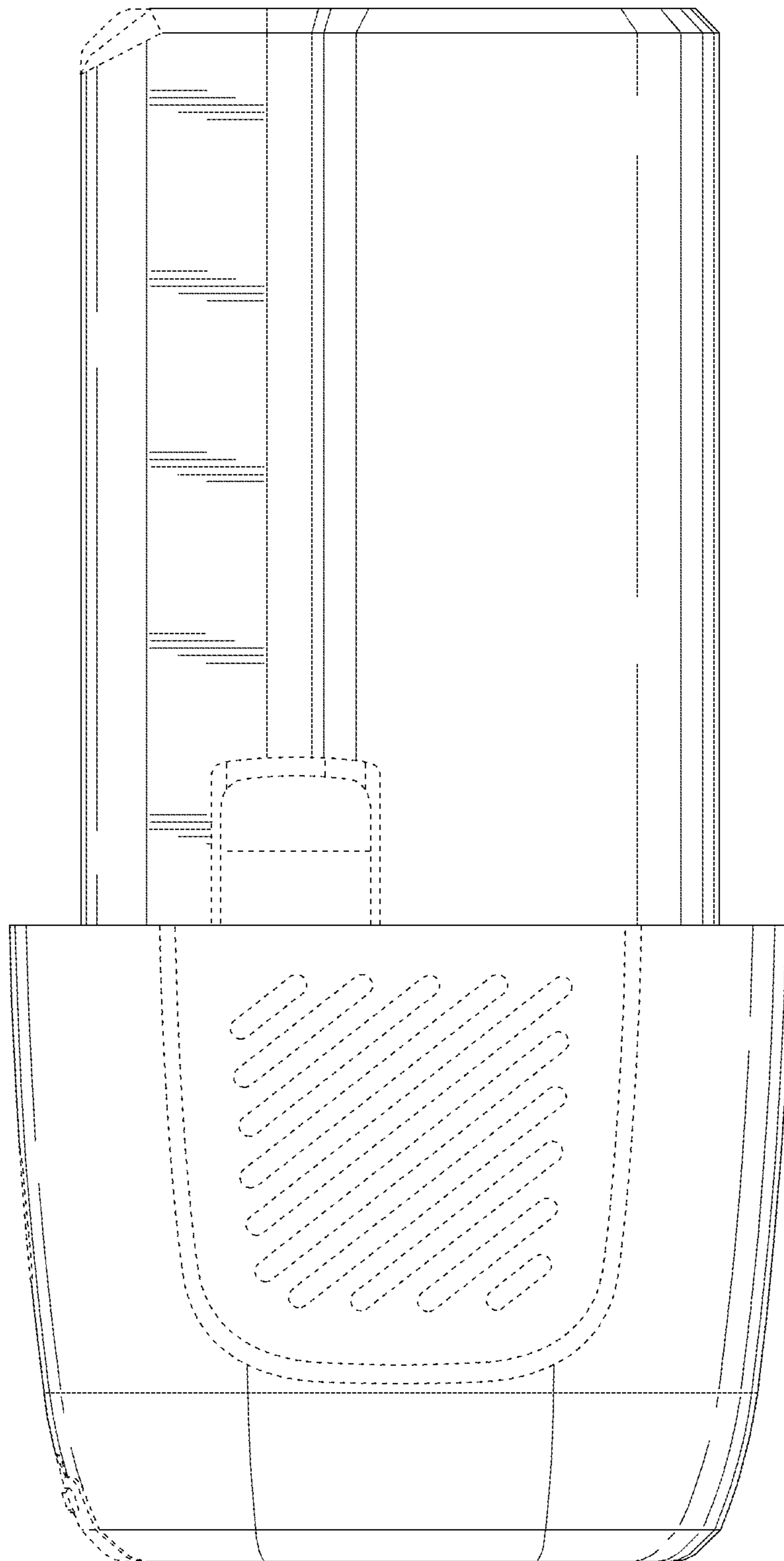

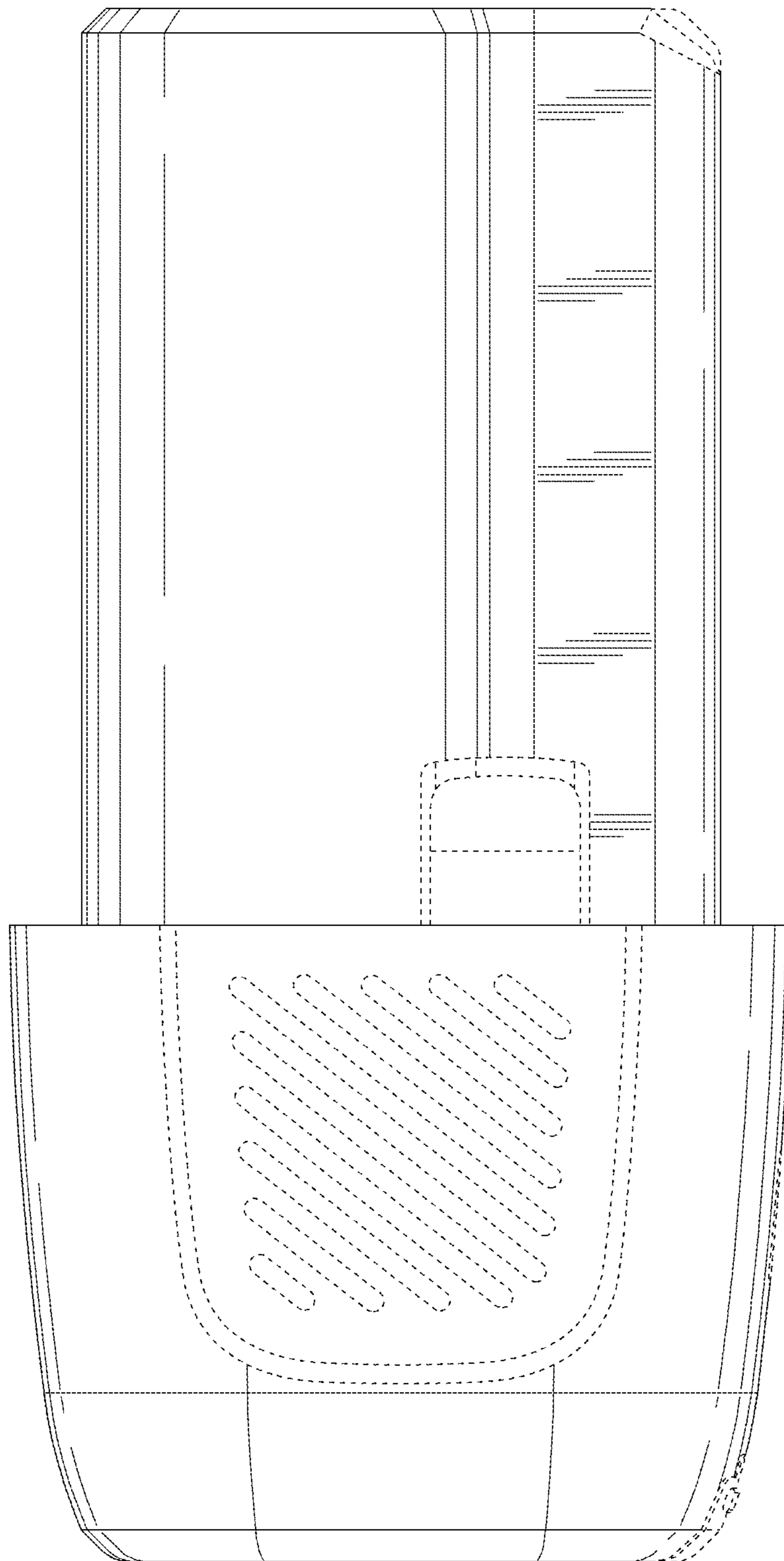

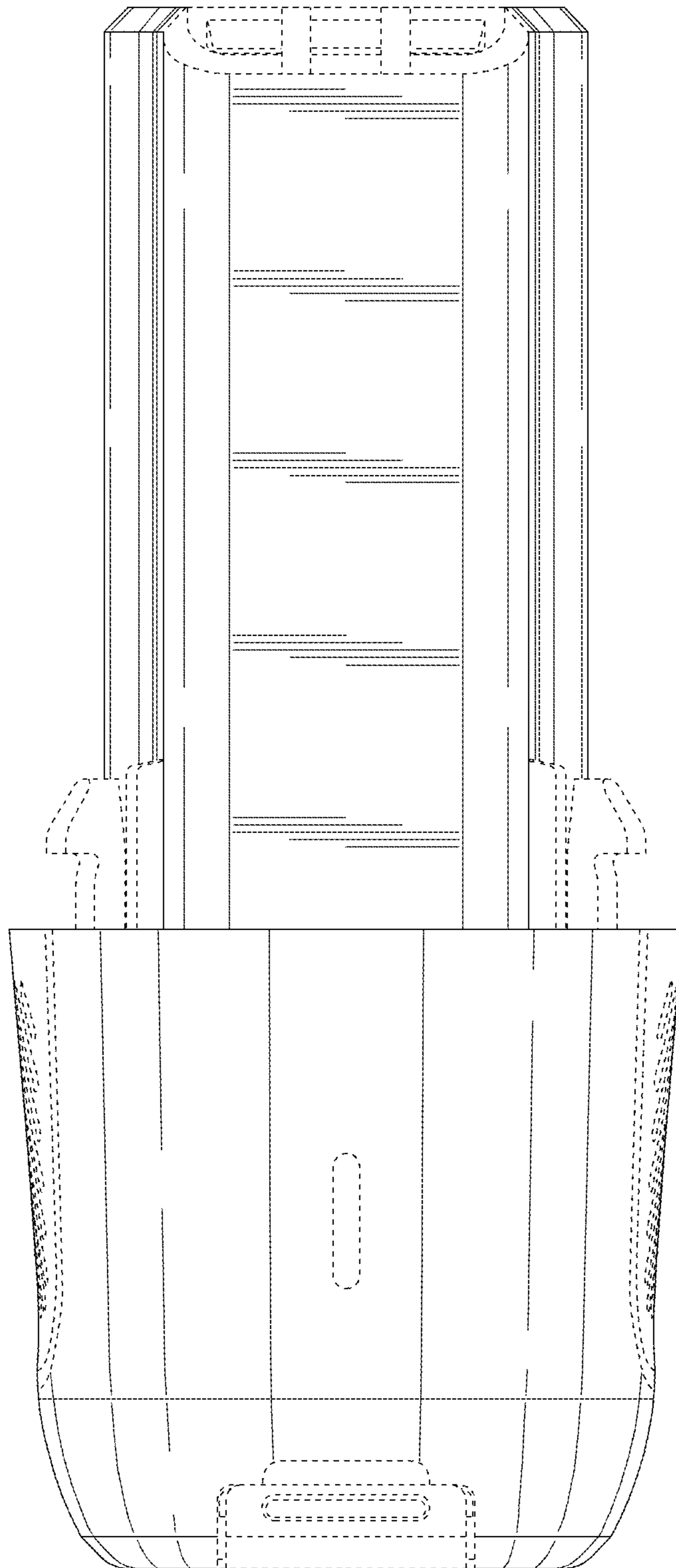

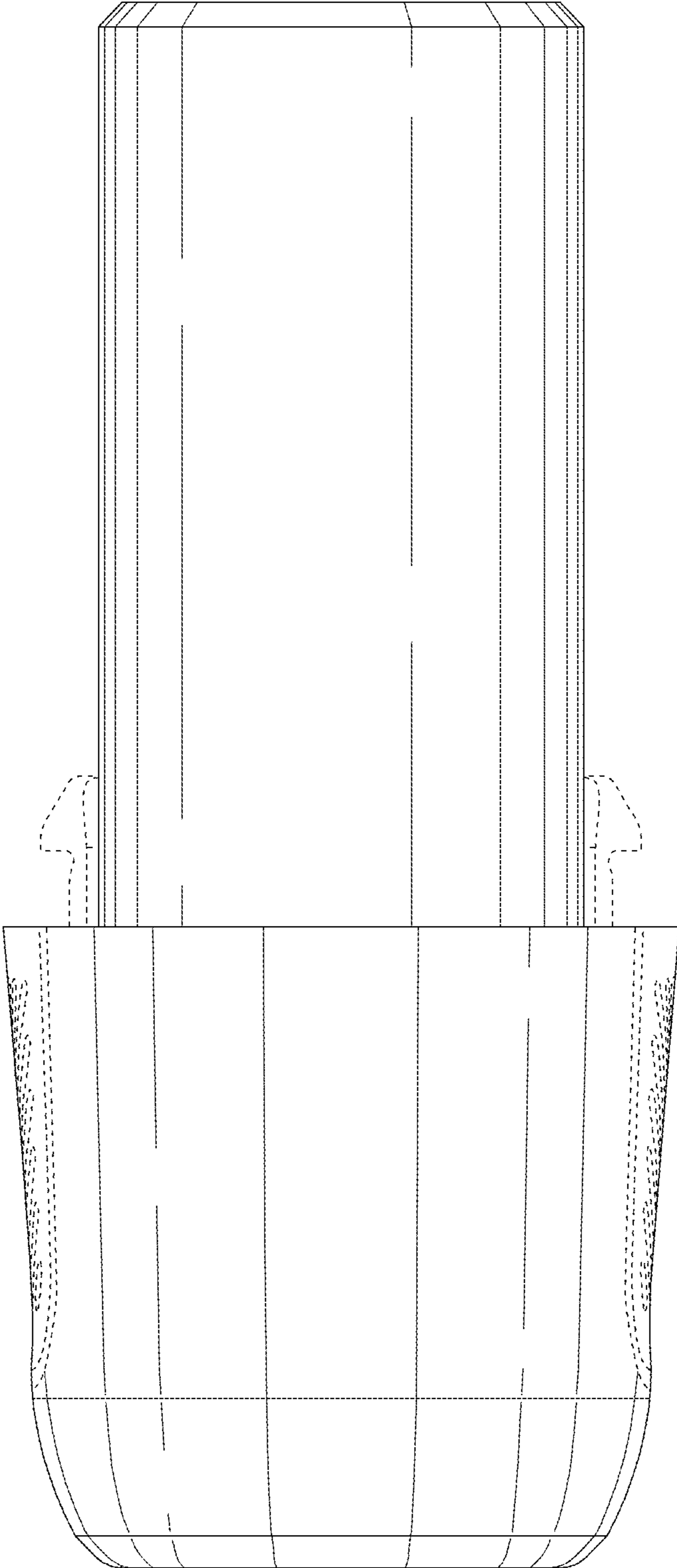

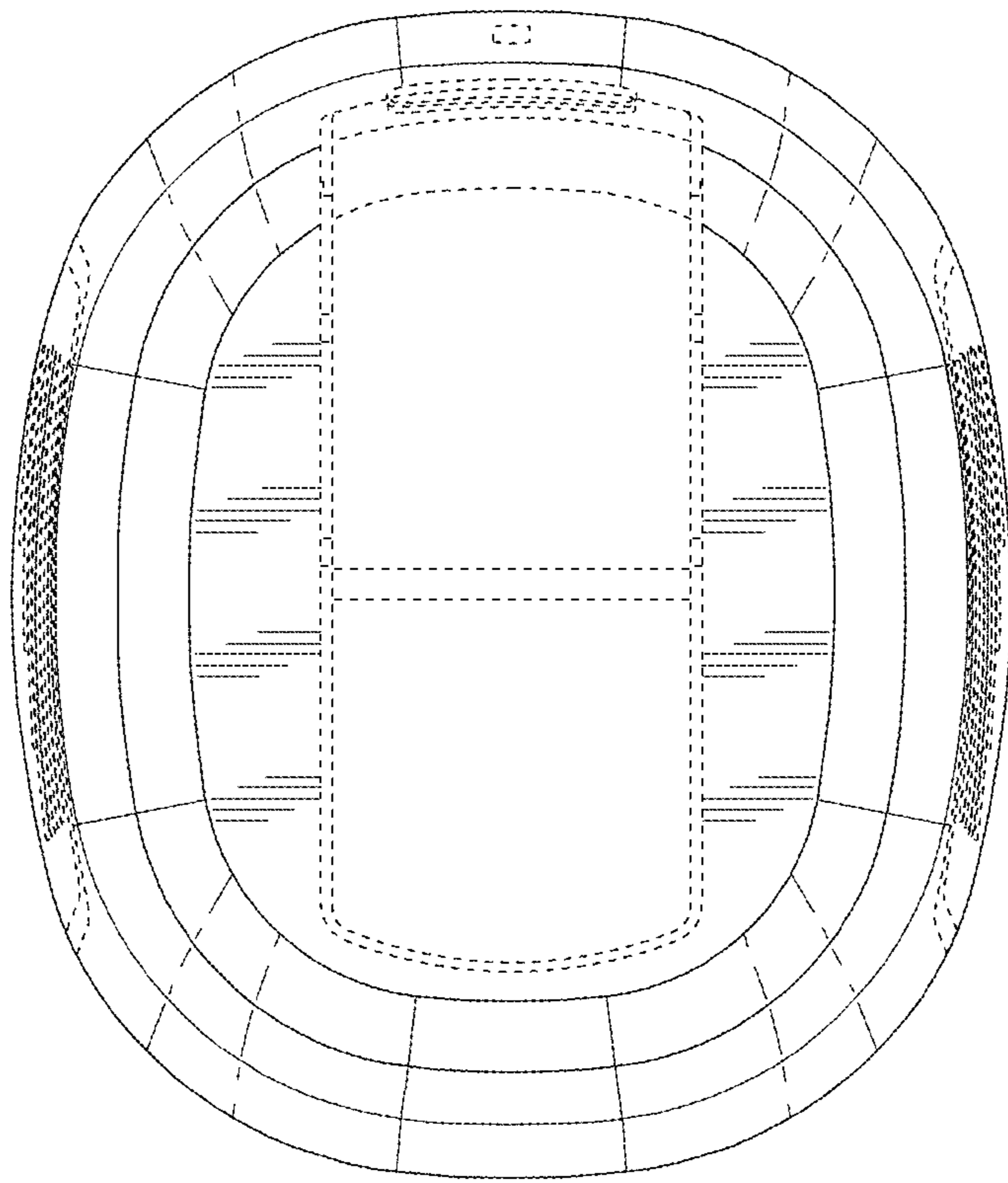

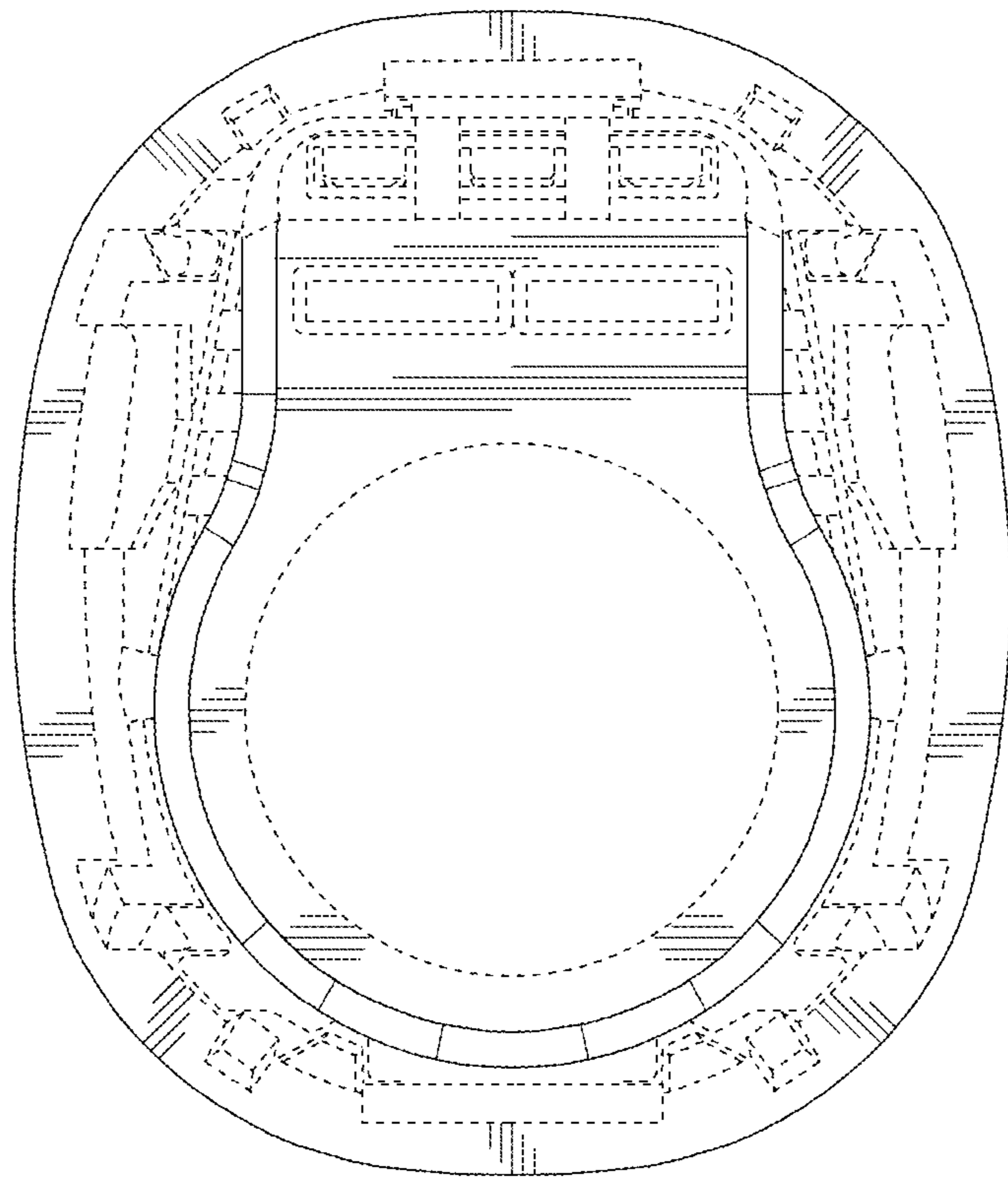
