(57) **CLAIM**

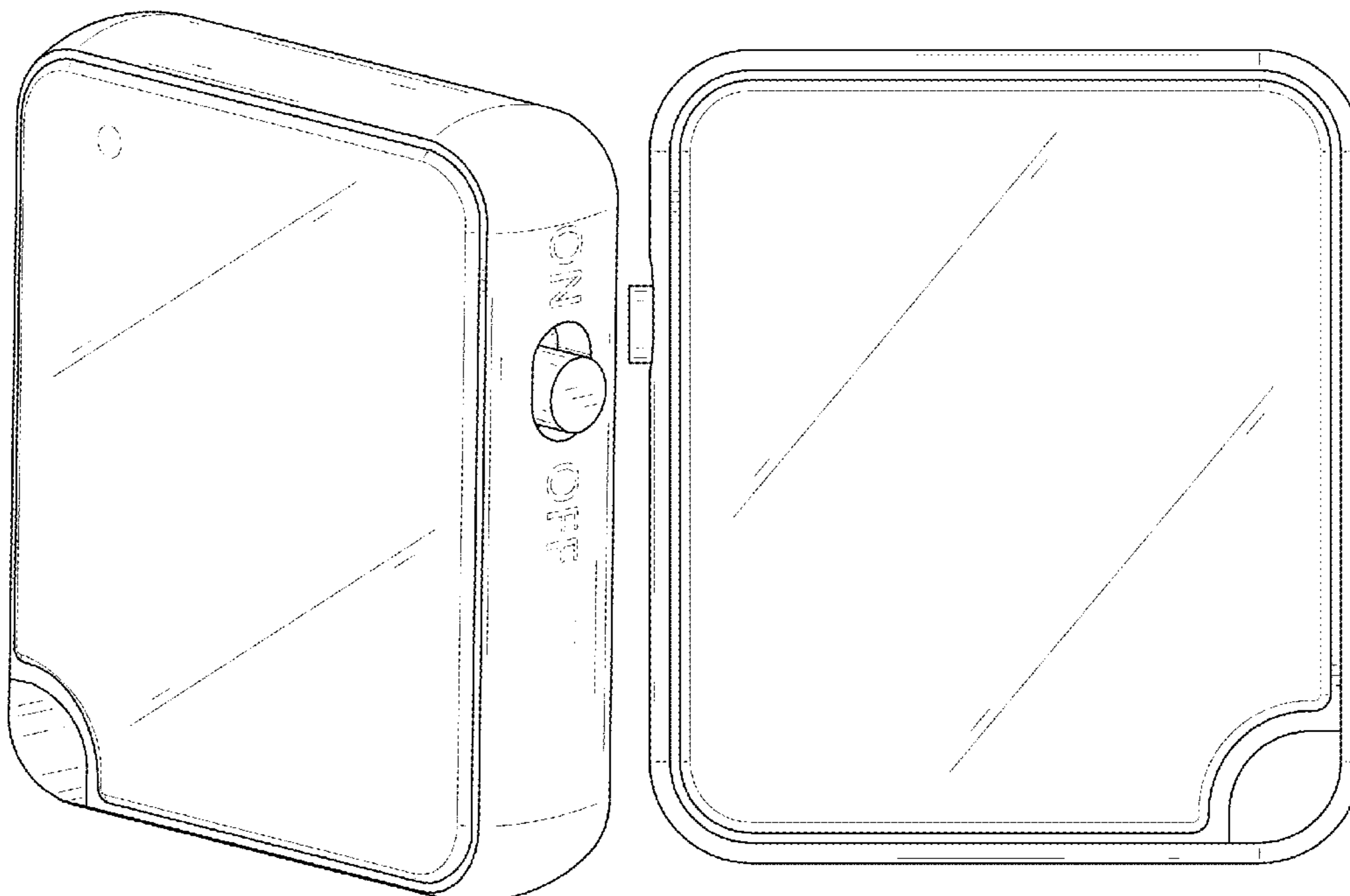
The ornamental design for a digital voice recorder, as shown

DESCRIPTION

voice recorder showing my new design;

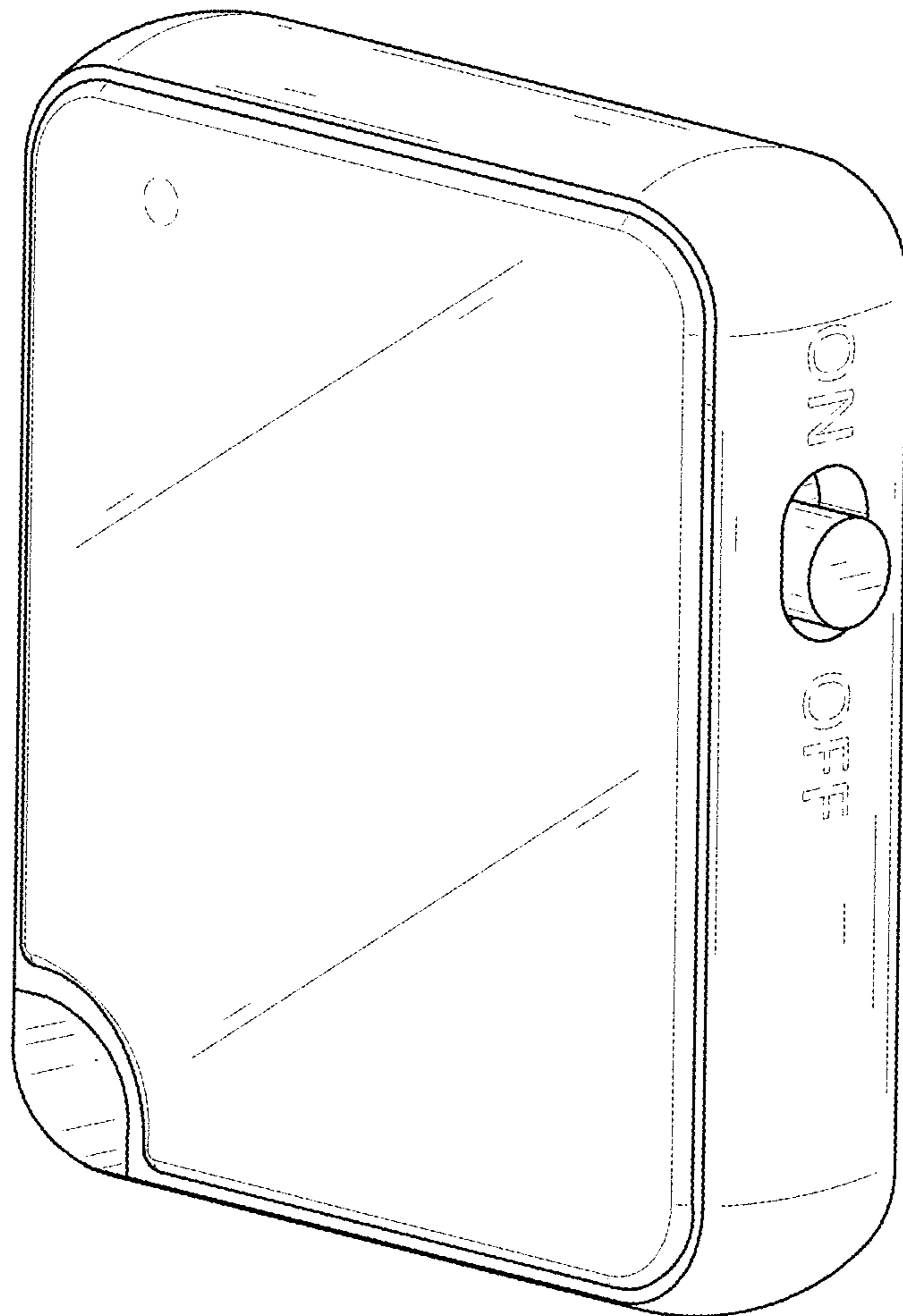

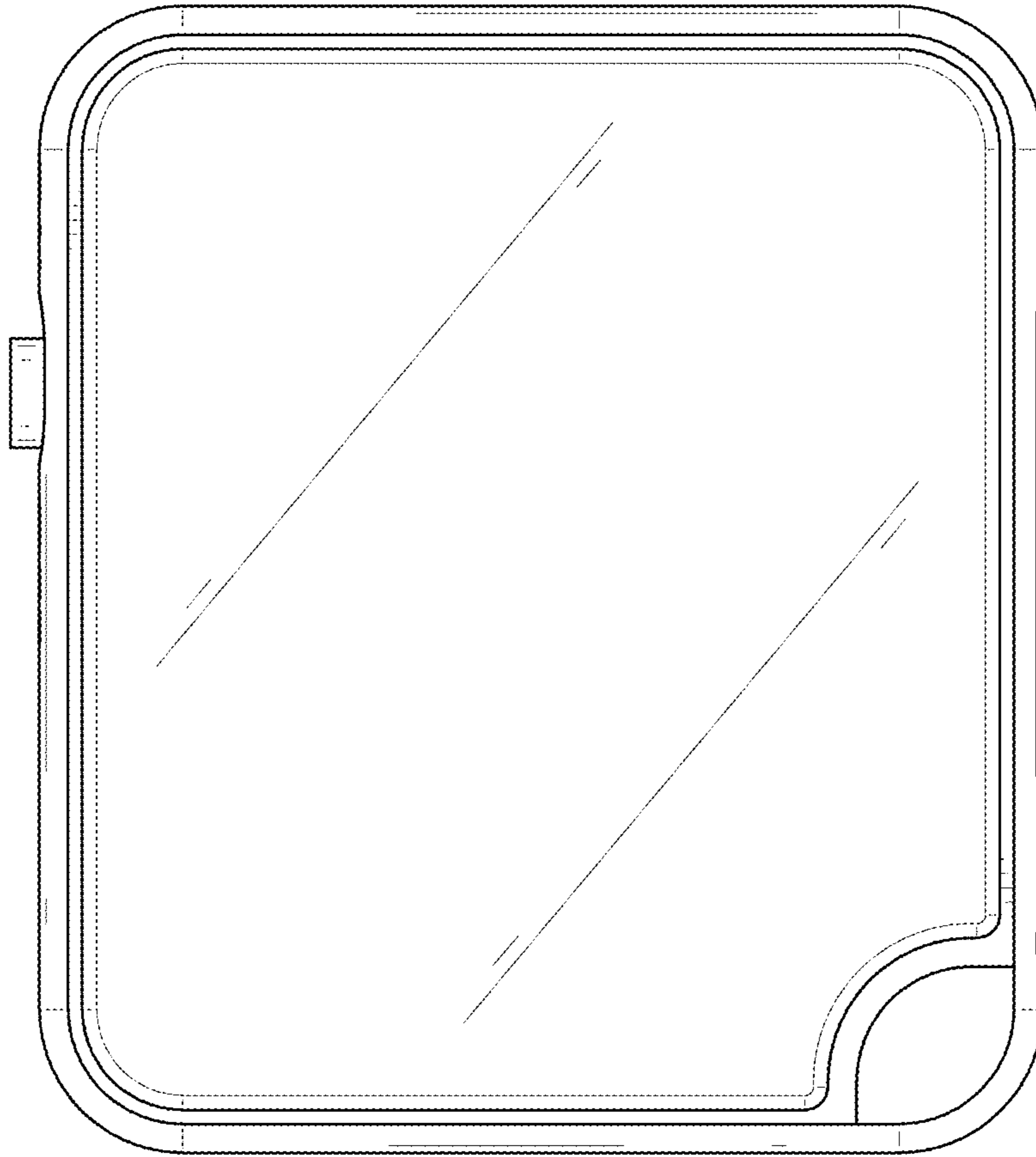

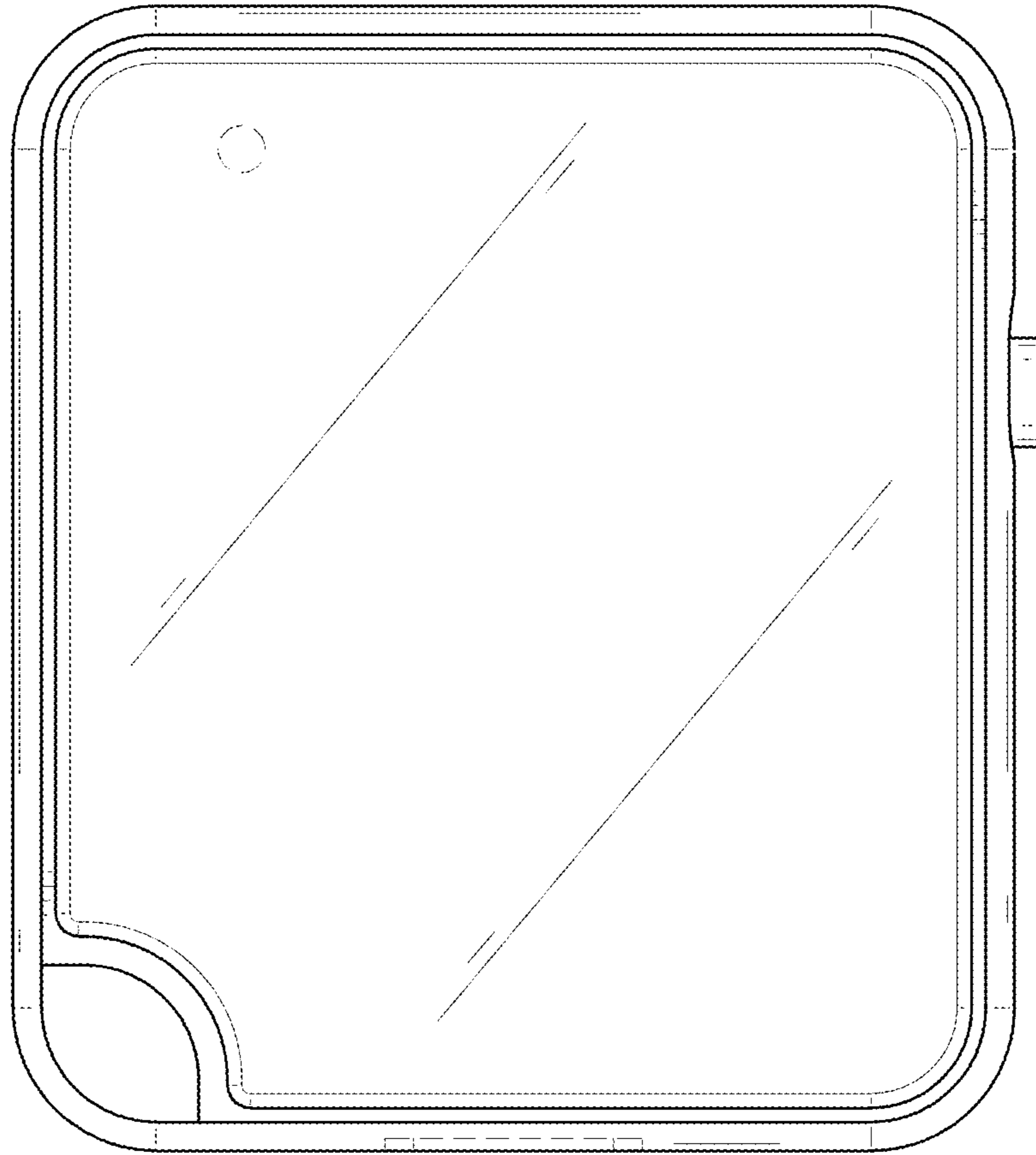

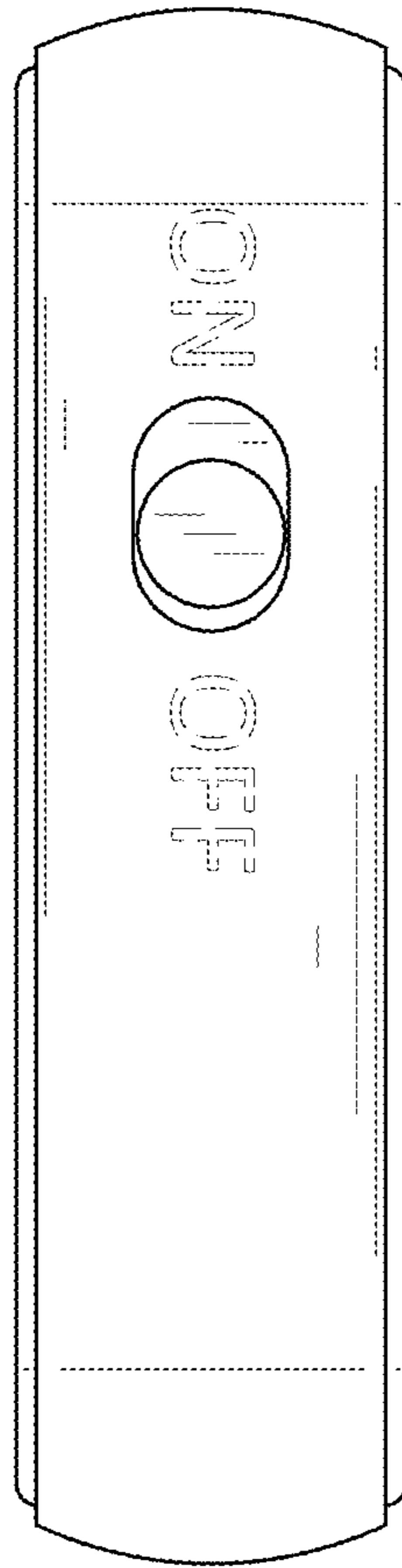

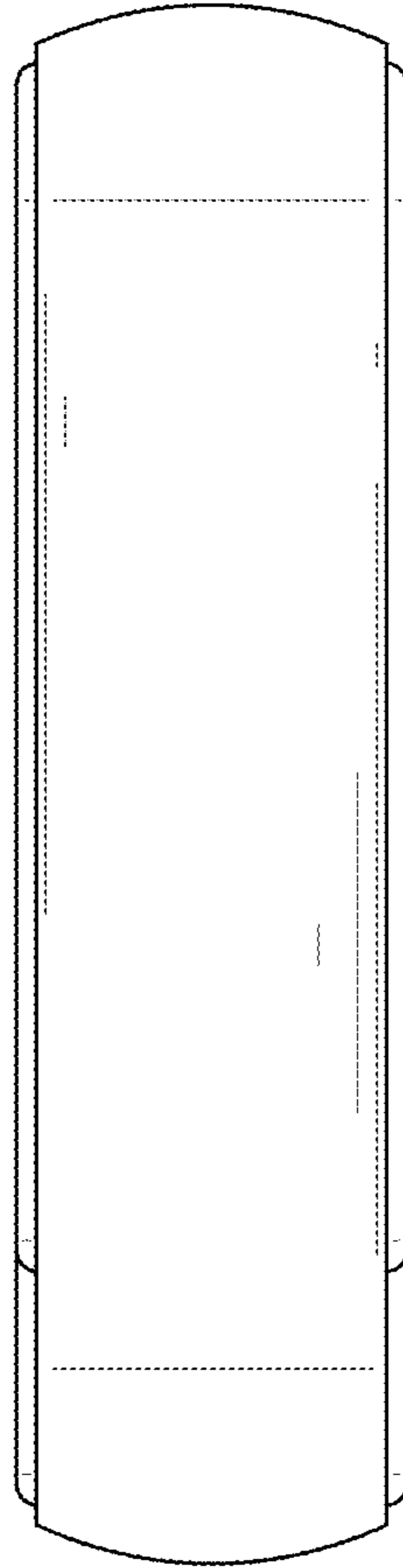

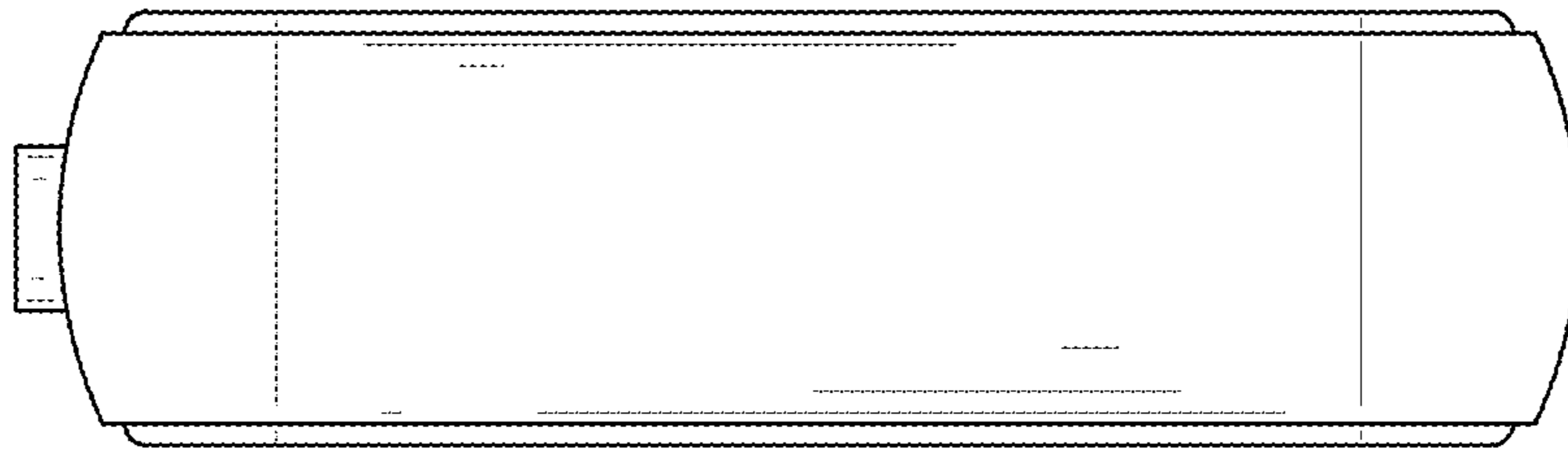

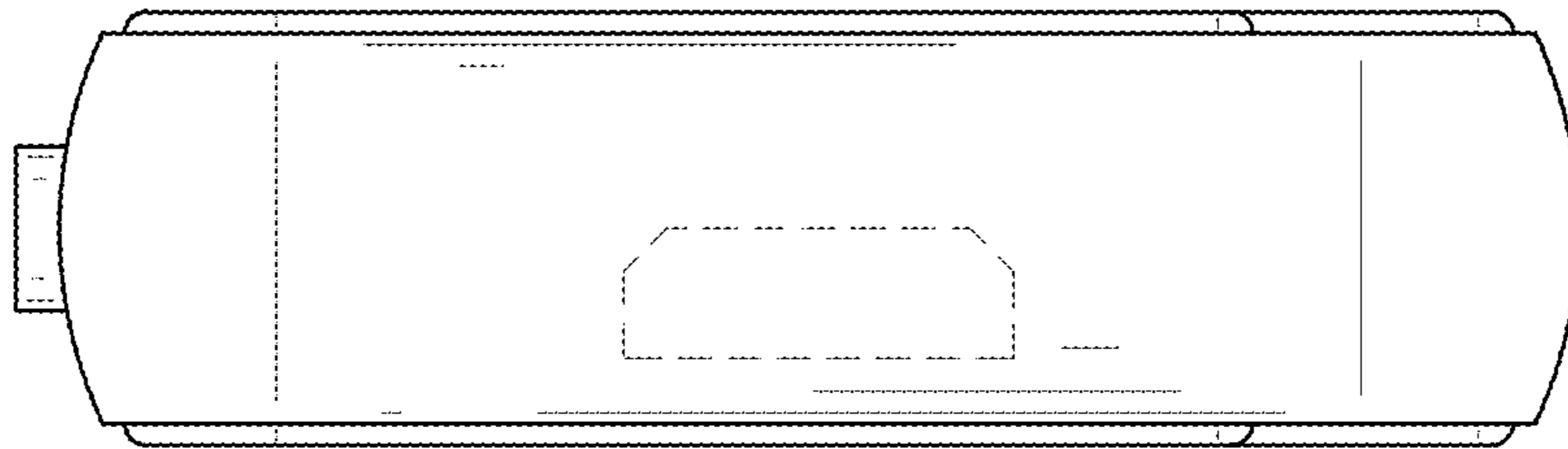
