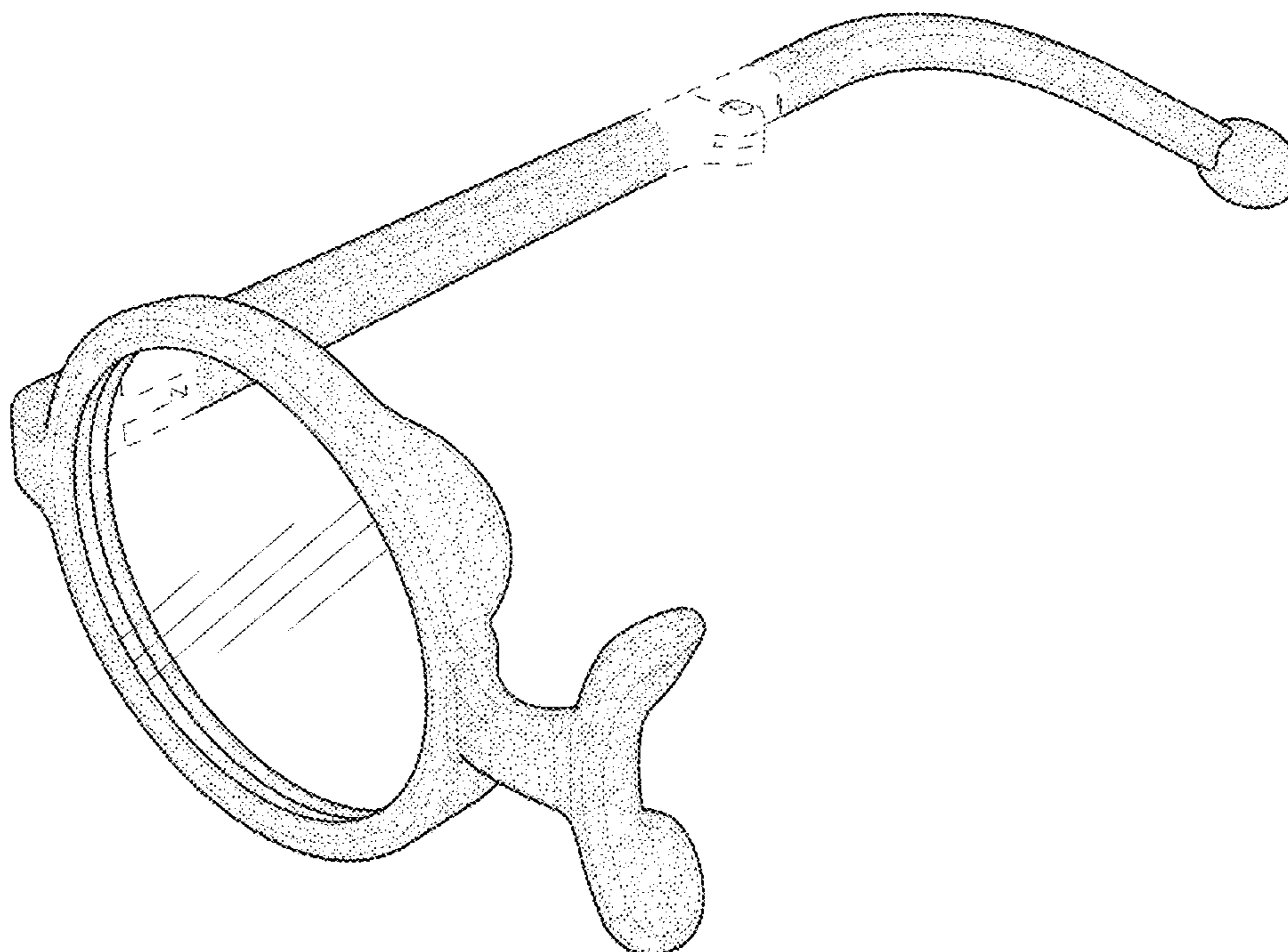
(57) **CLAIM**

The ornamental design for a monocle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a monocle showing my new design.
FIG. 2 is a left-side perspective view of a left side thereof.
FIG. 3 is a right-side perspective view thereof.
FIG. 4 is an elevated rear perspective view thereof.
FIG. 5 is a front view thereof.
FIG. 6 is a rear view thereof.
FIG. 7 is a left-side view thereof.
FIG. 8 is a right-side view thereof.
FIG. 9 is a top view thereof.
FIG. 10 is a bottom view thereof.
FIG. 11 is a front view thereof.
FIG. 12 is a cross-section view thereof, taken along line 12-12 in FIG. 11.
FIG. 13 is a right-side perspective view with a rear hinge folded in and front hinge unfolded, thereof; and,
FIG. 14 is a right-side perspective view with a rear hinge folded in and front hinge folded in, thereof.

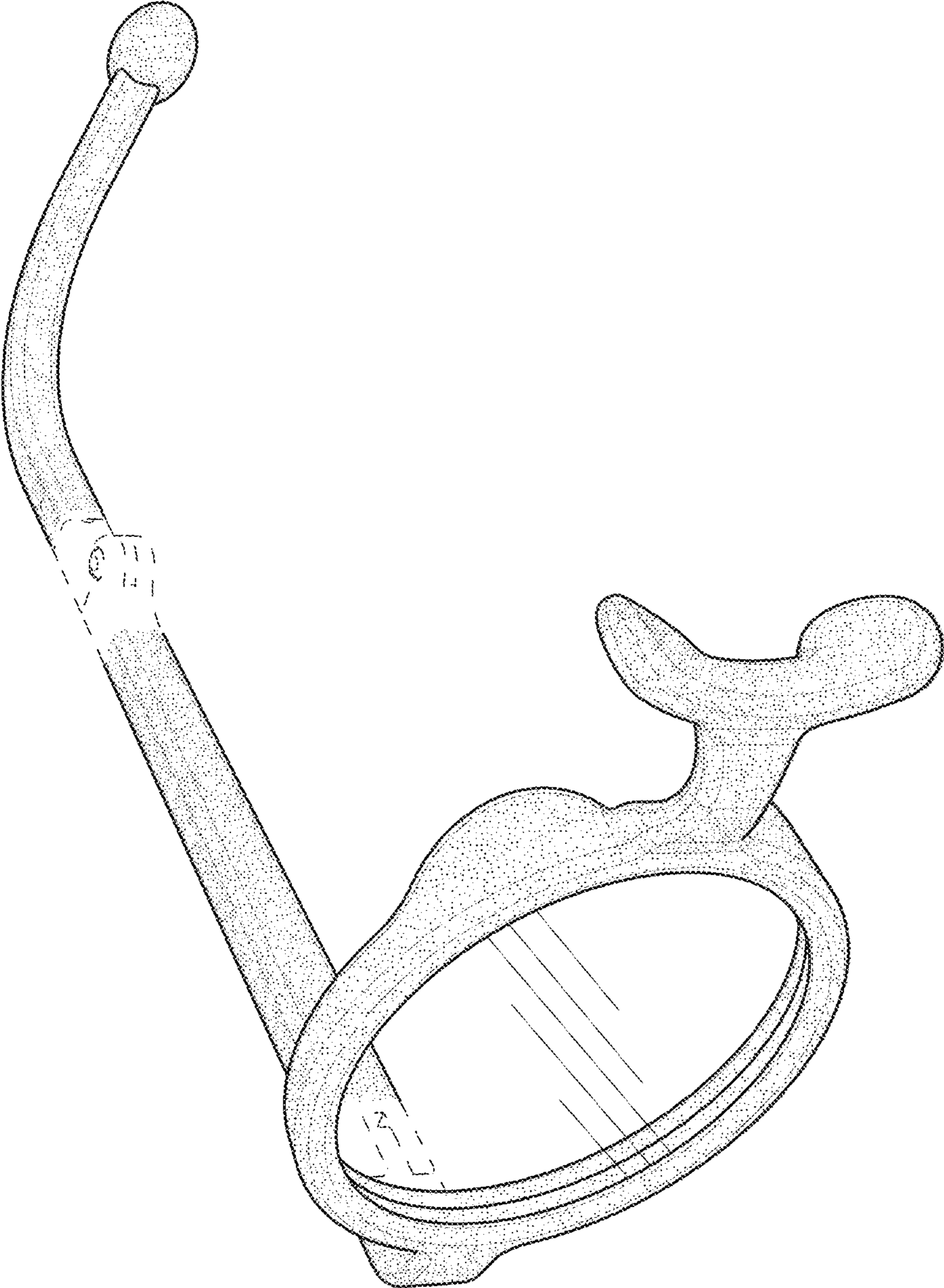

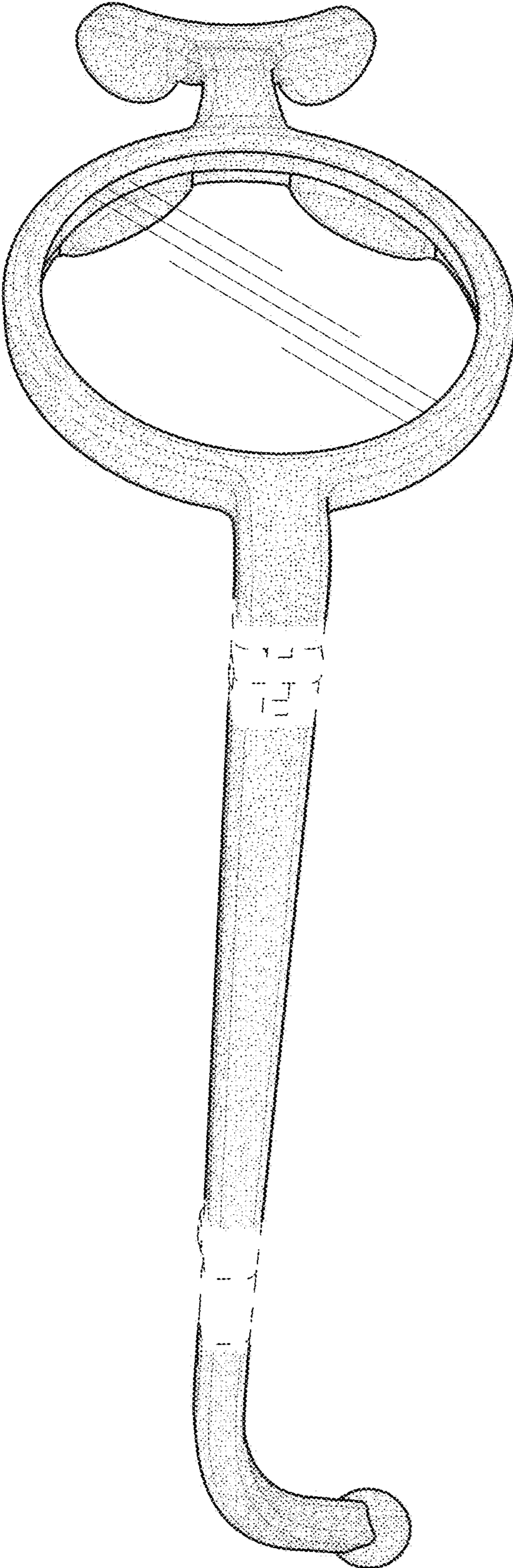

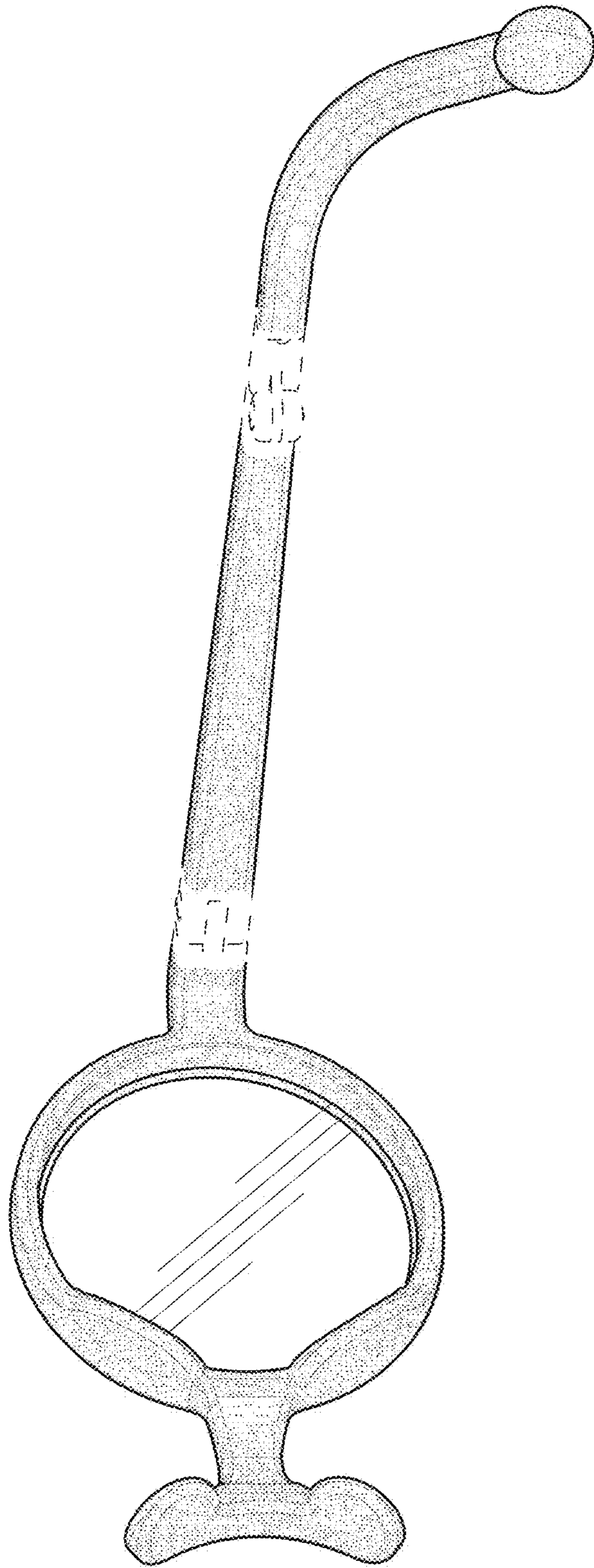

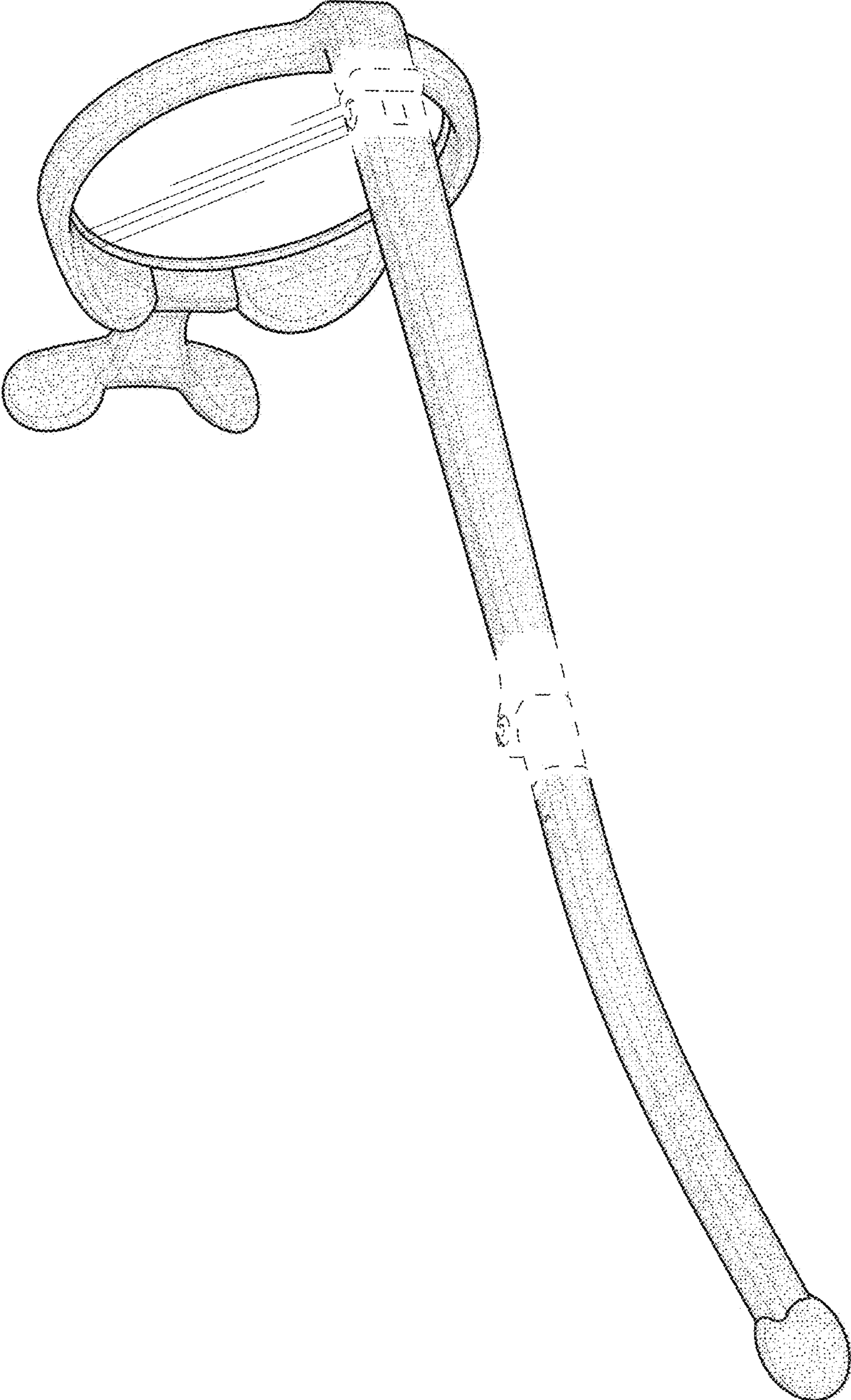

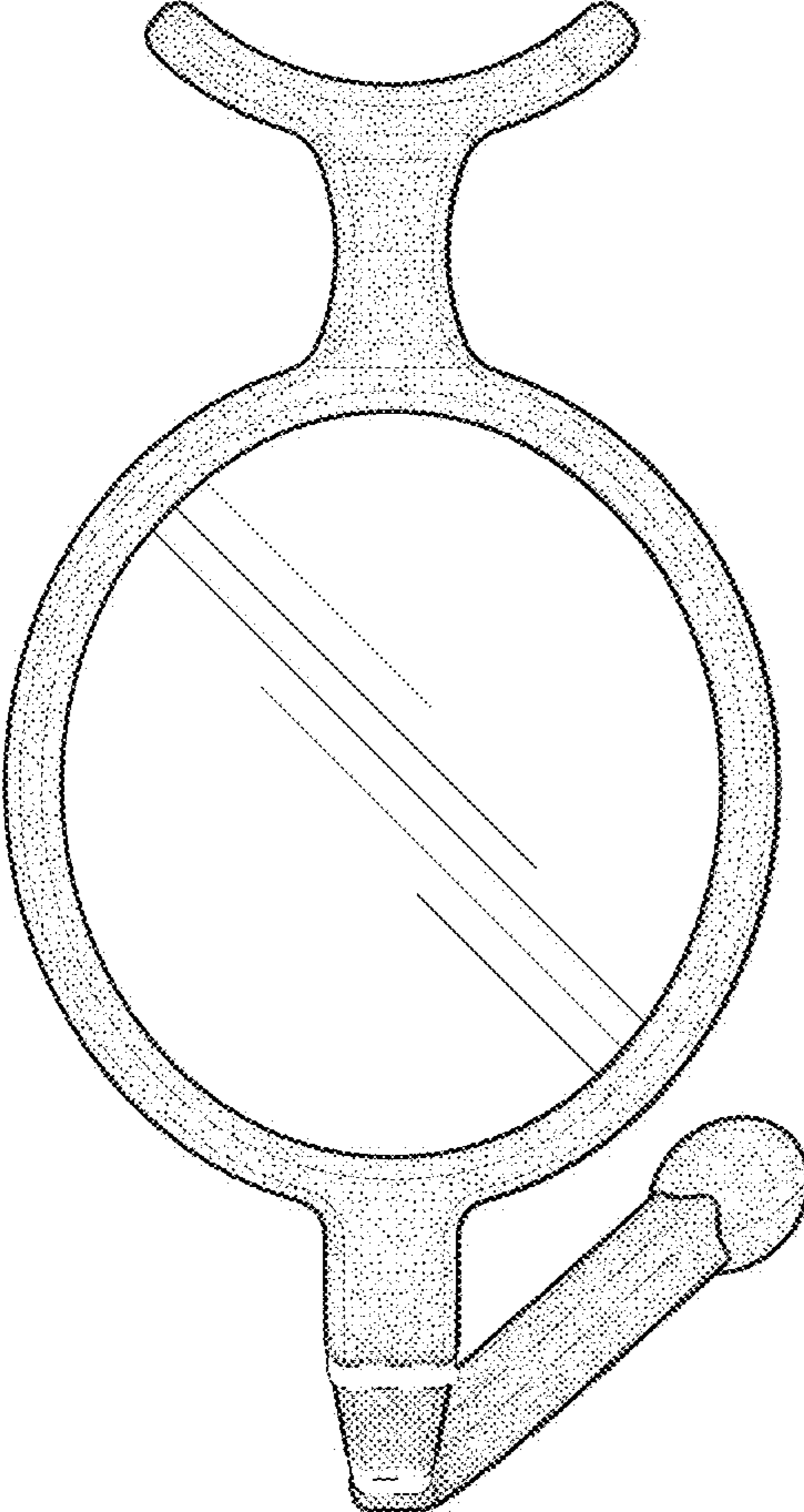

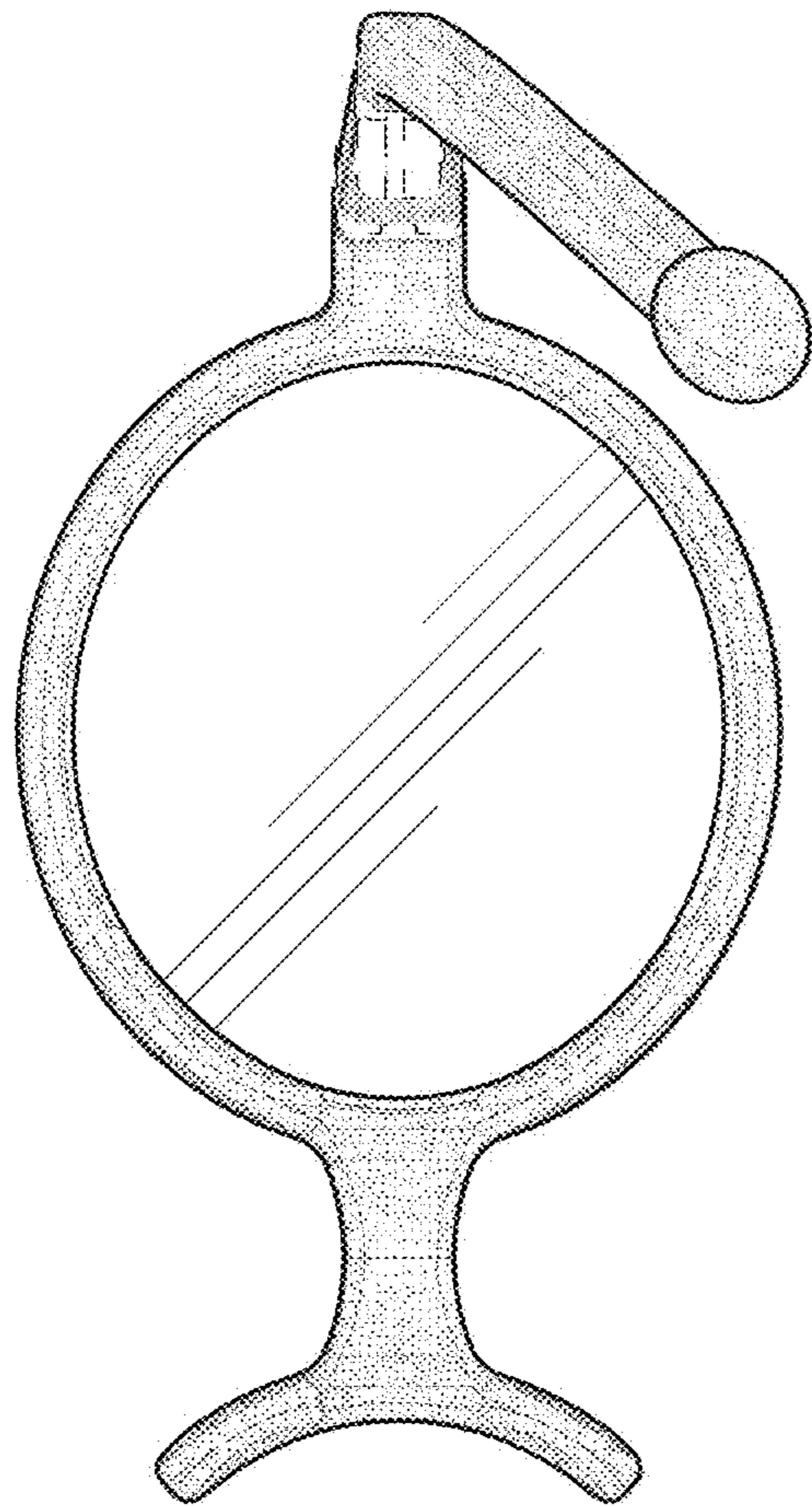

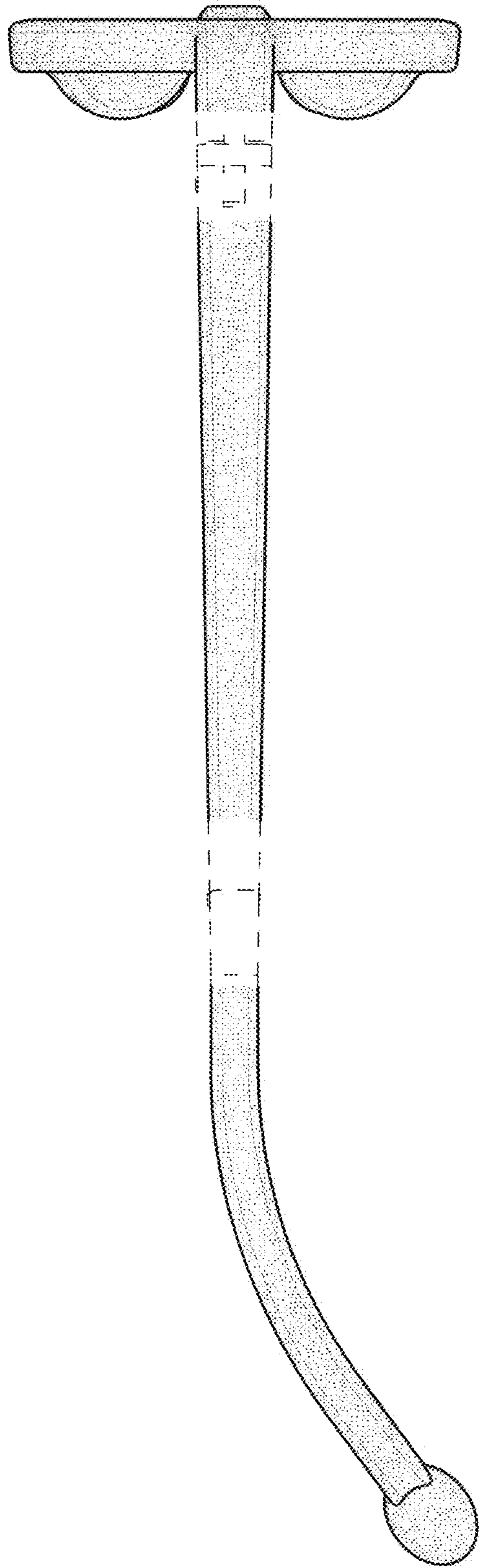

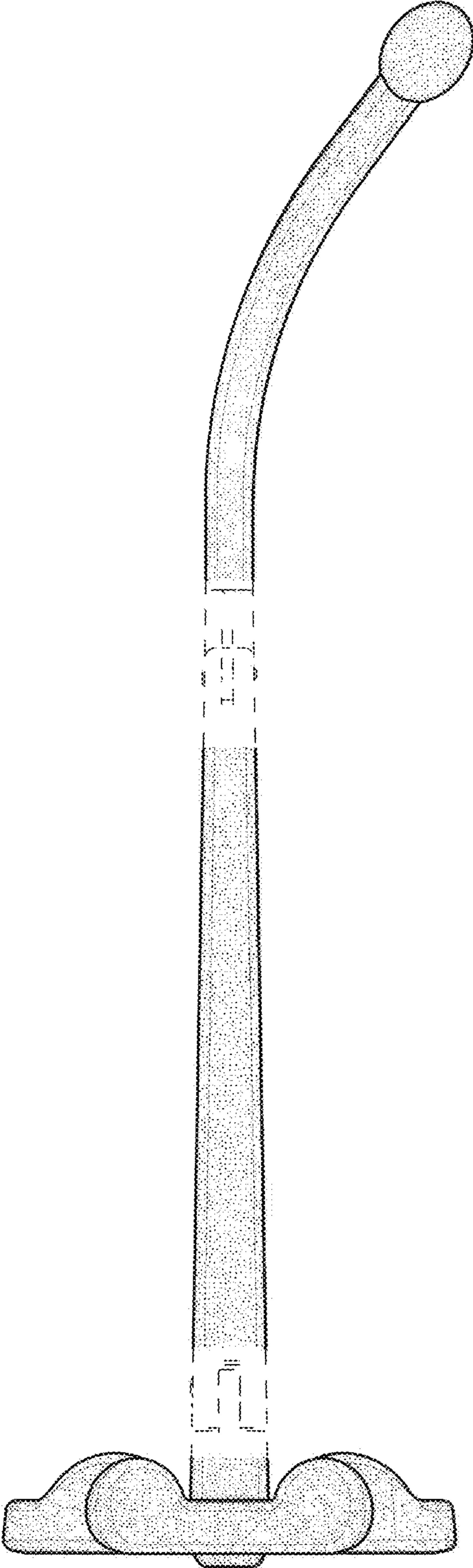

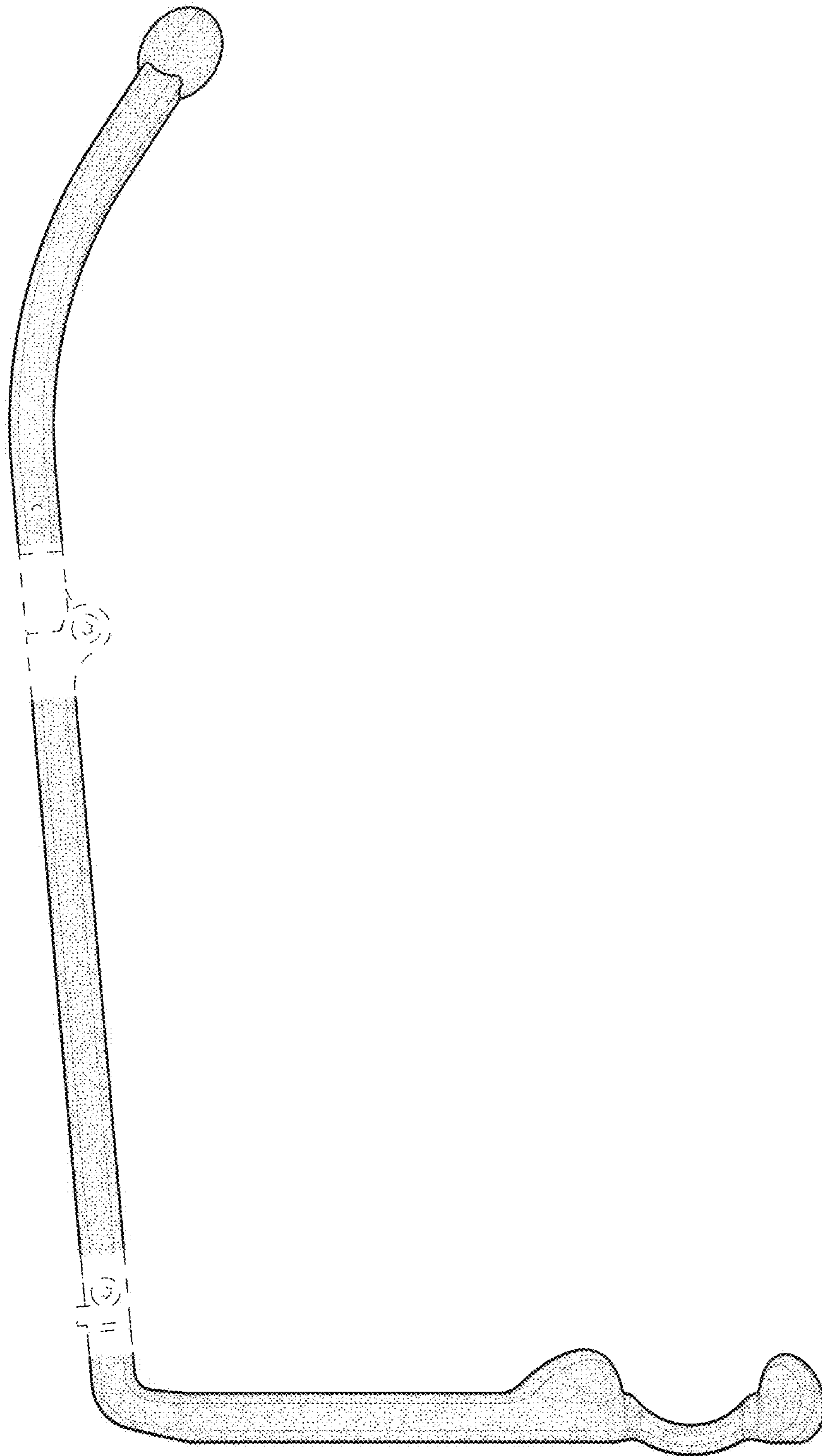

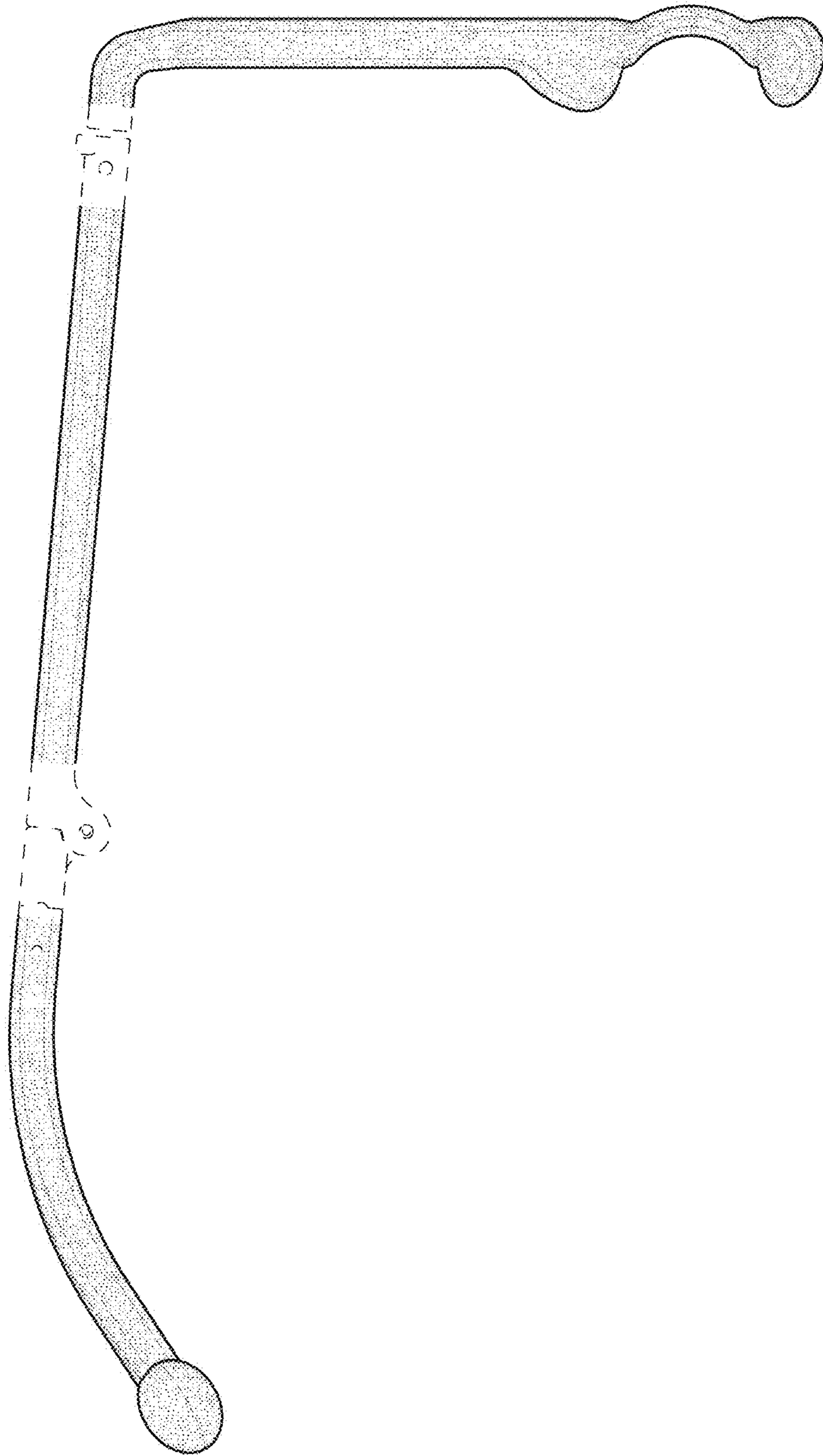

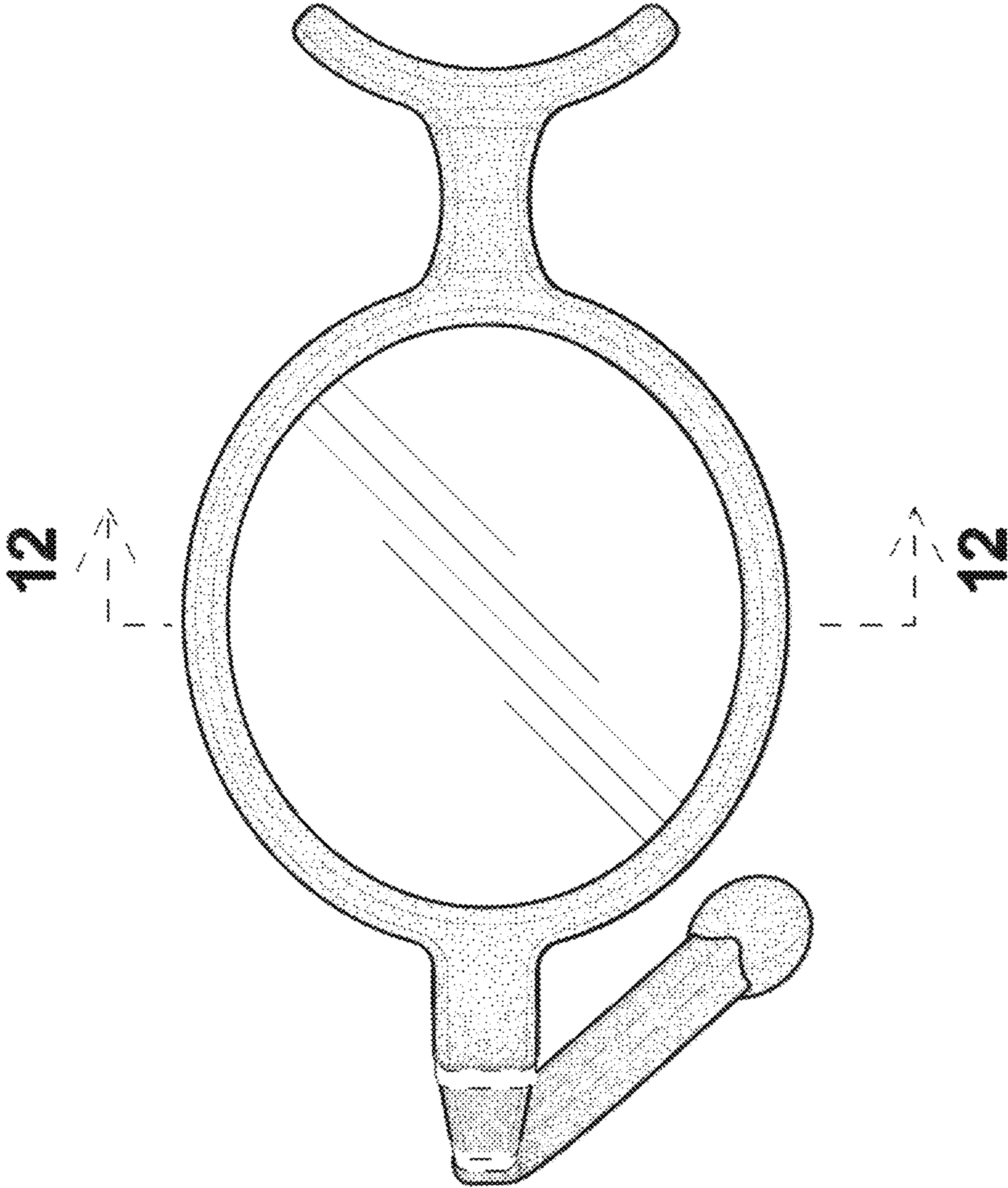

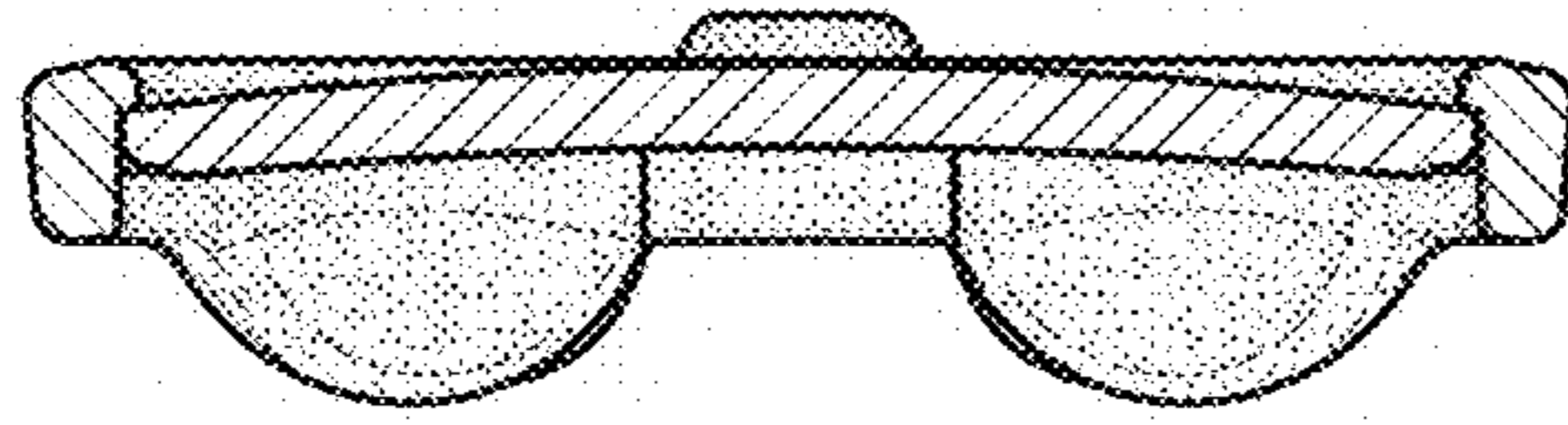

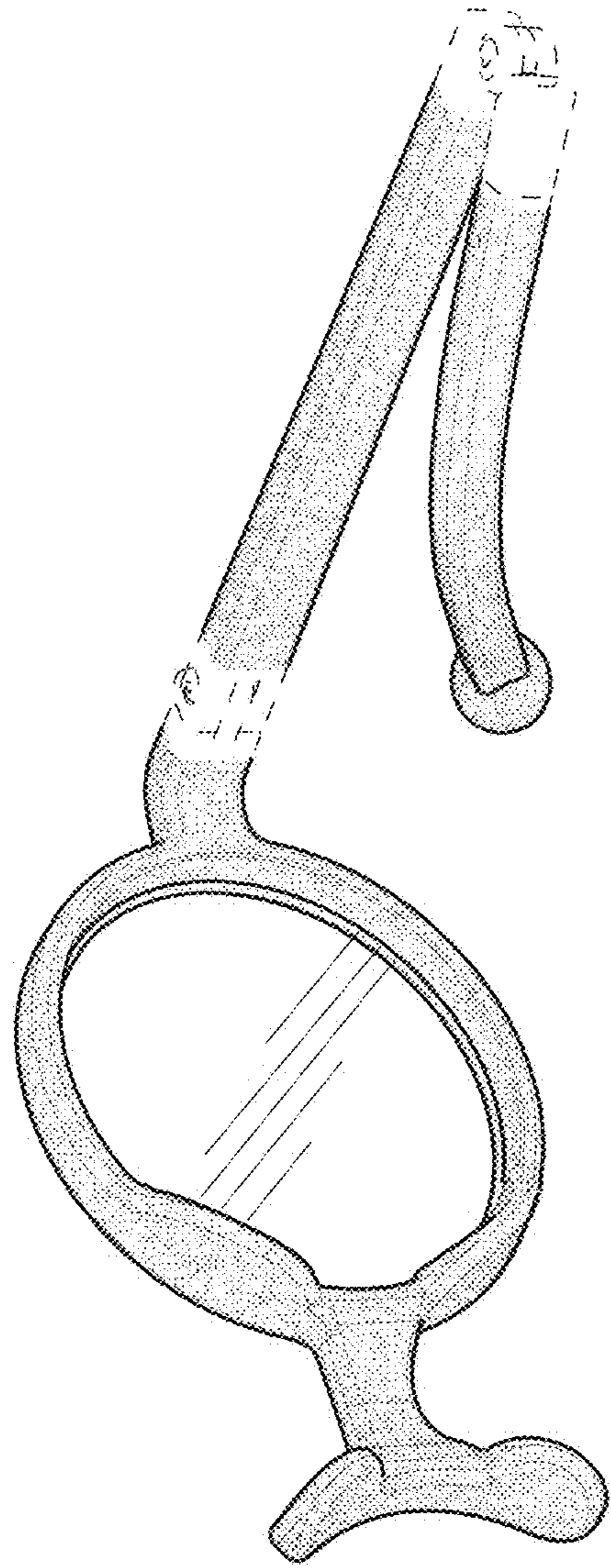

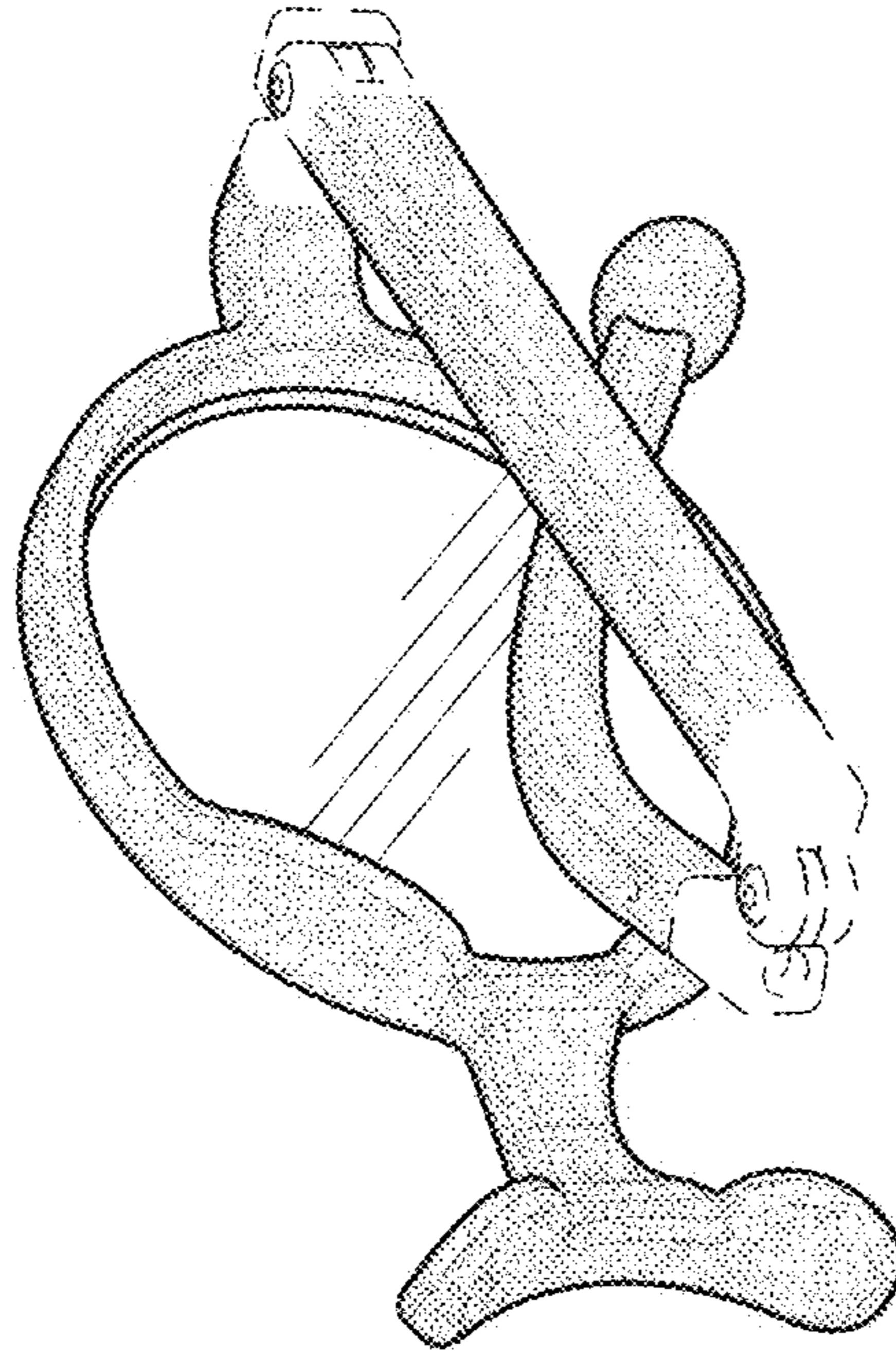
