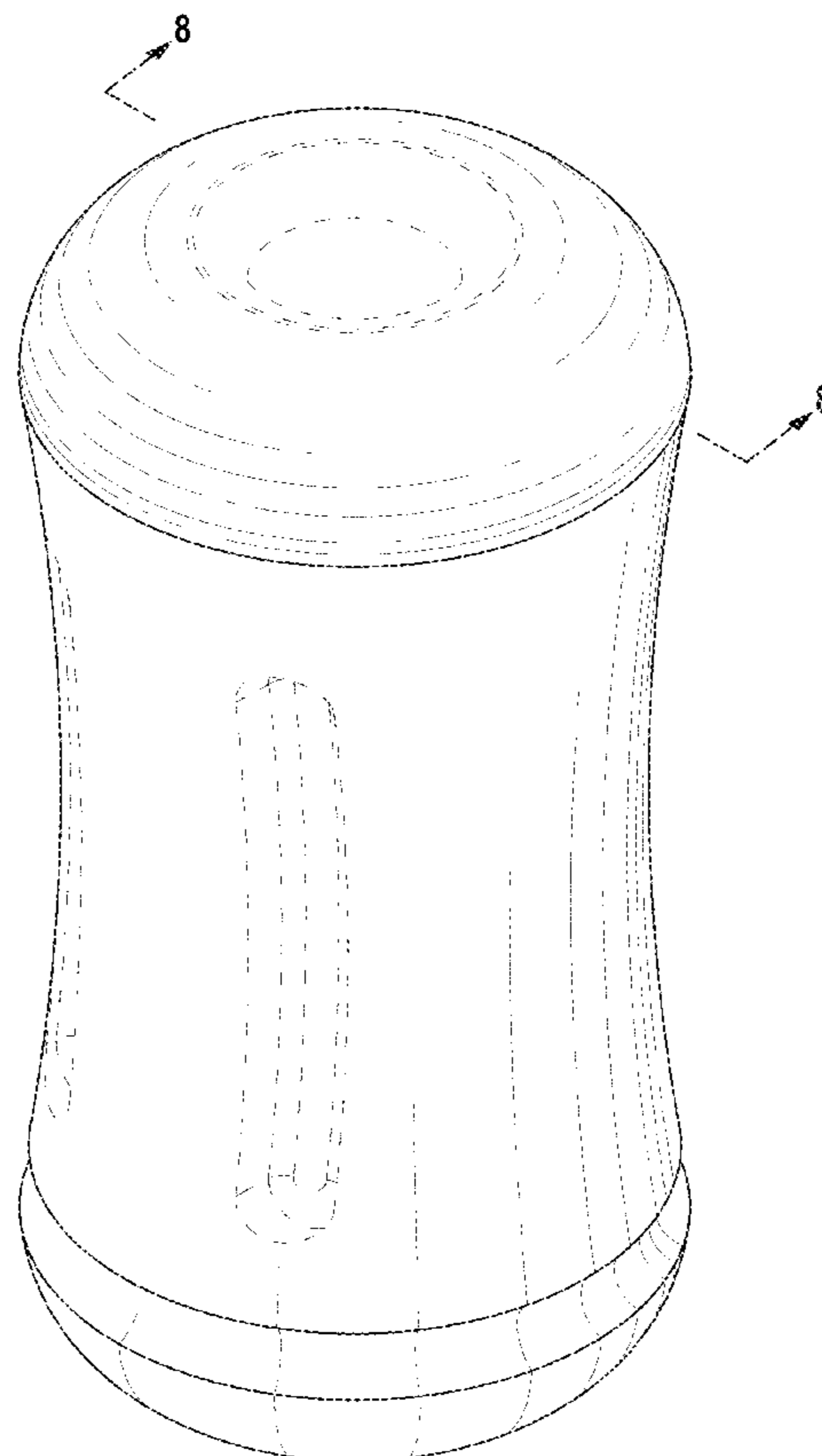
The ornamental design for a dental instrument handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dental instrument handle; FIG. 2 is a first side view; FIG. 3 is a second side view; FIG. 4 is a third side view; FIG. 5 is a fourth side view; FIG. 6 is a bottom view; FIG. 7 is a top view; and, FIG. 8 is a side cross sectional view taken along line 8-8 of FIG. 1.

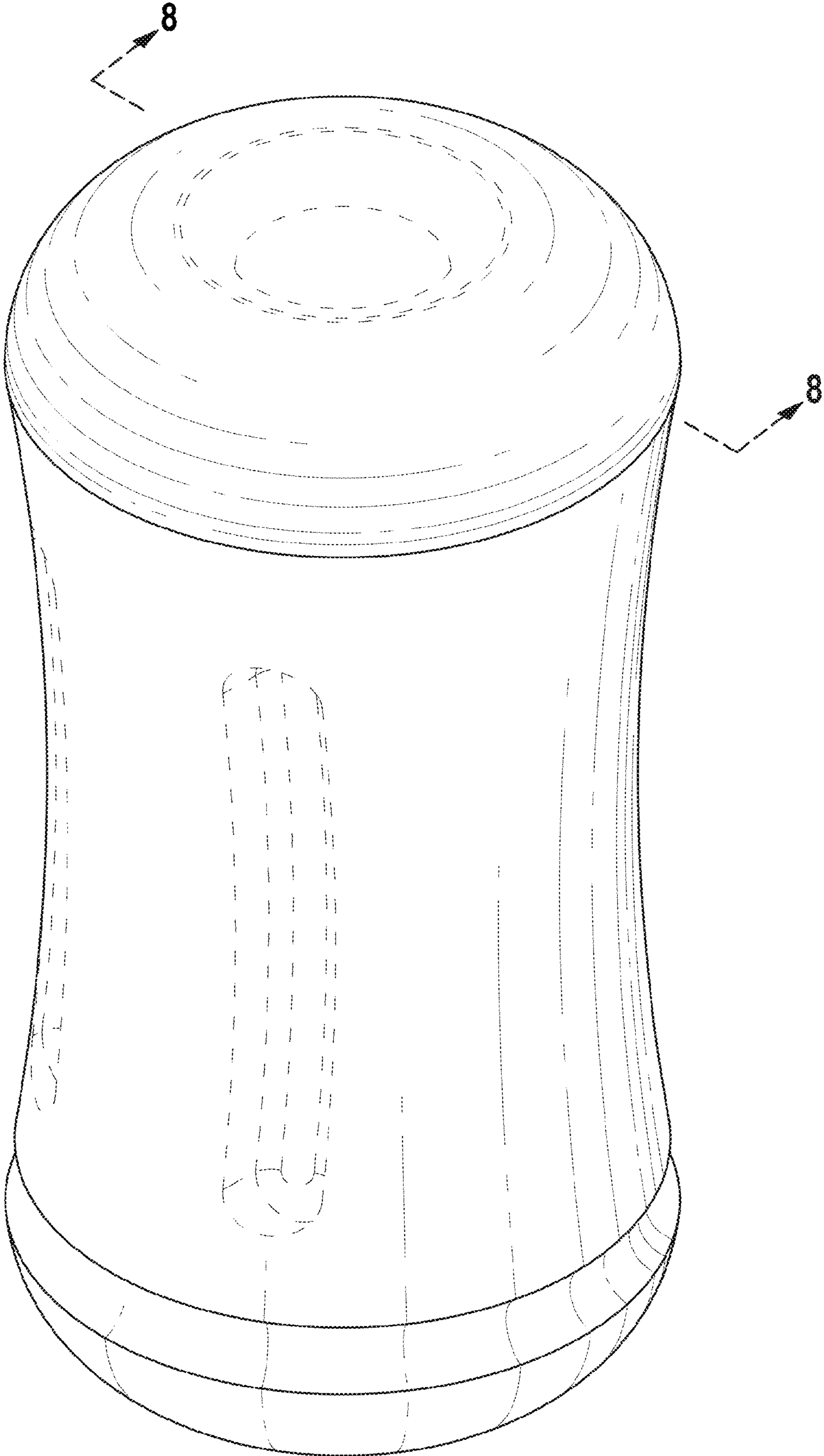

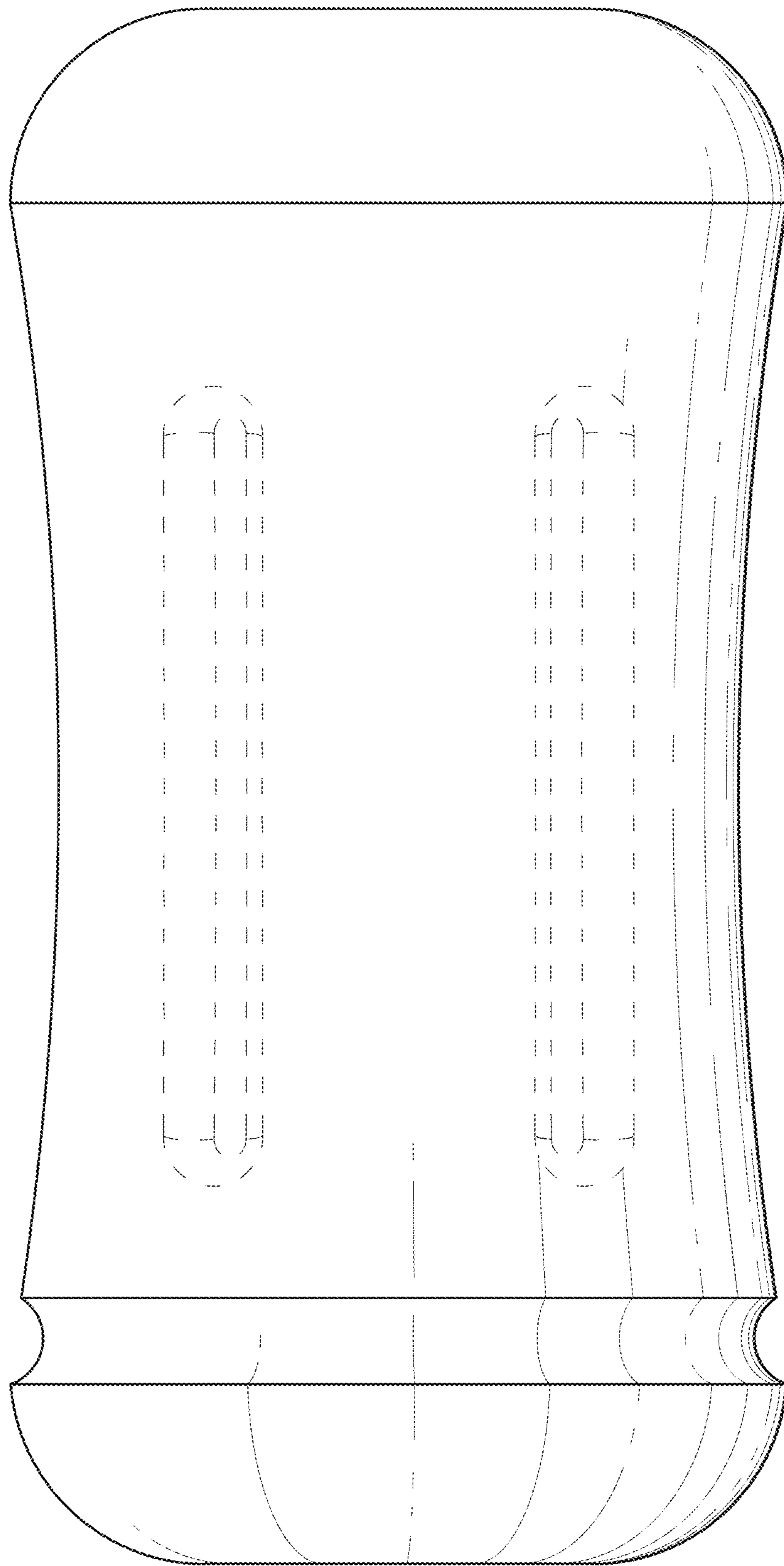

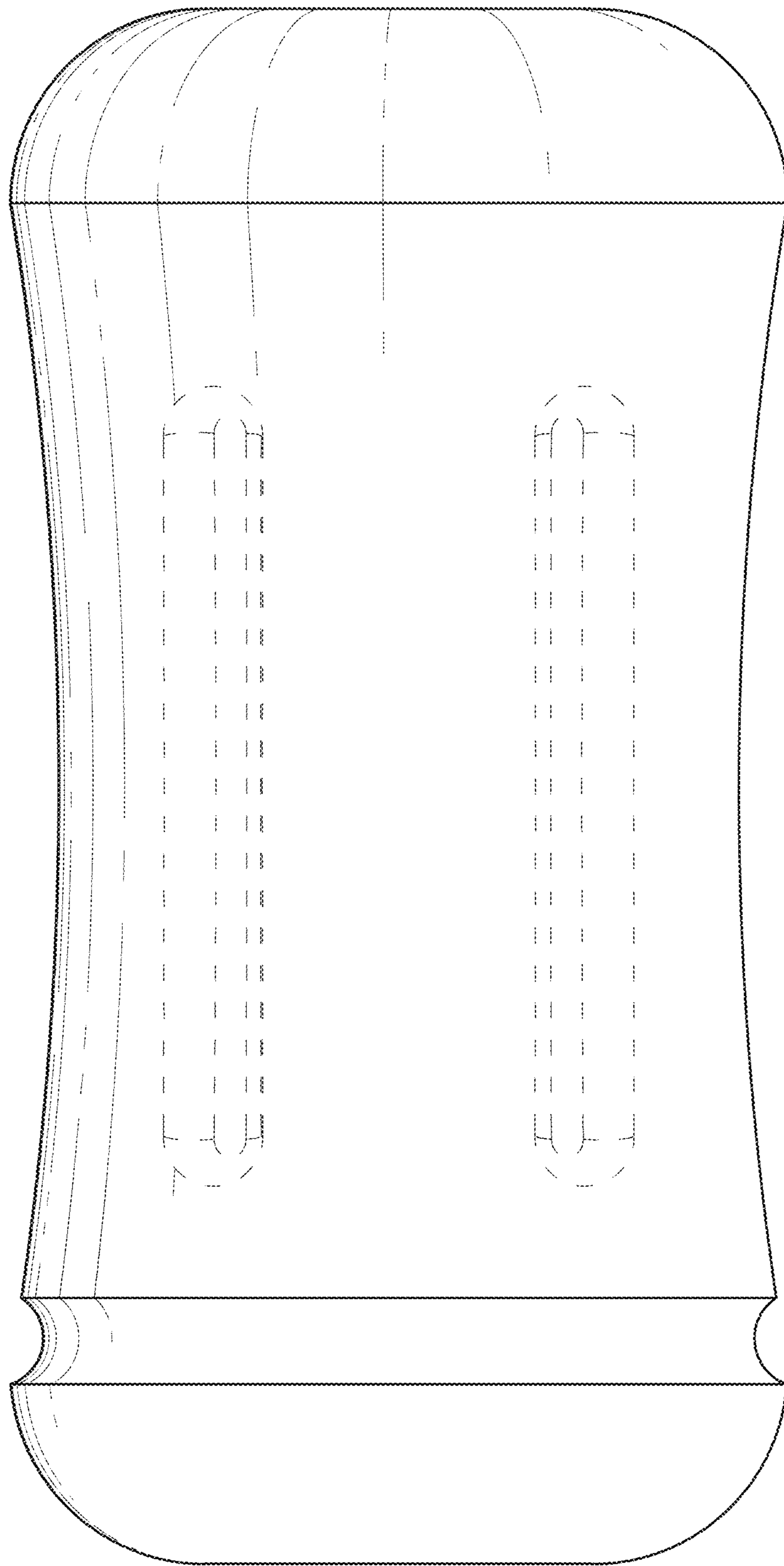

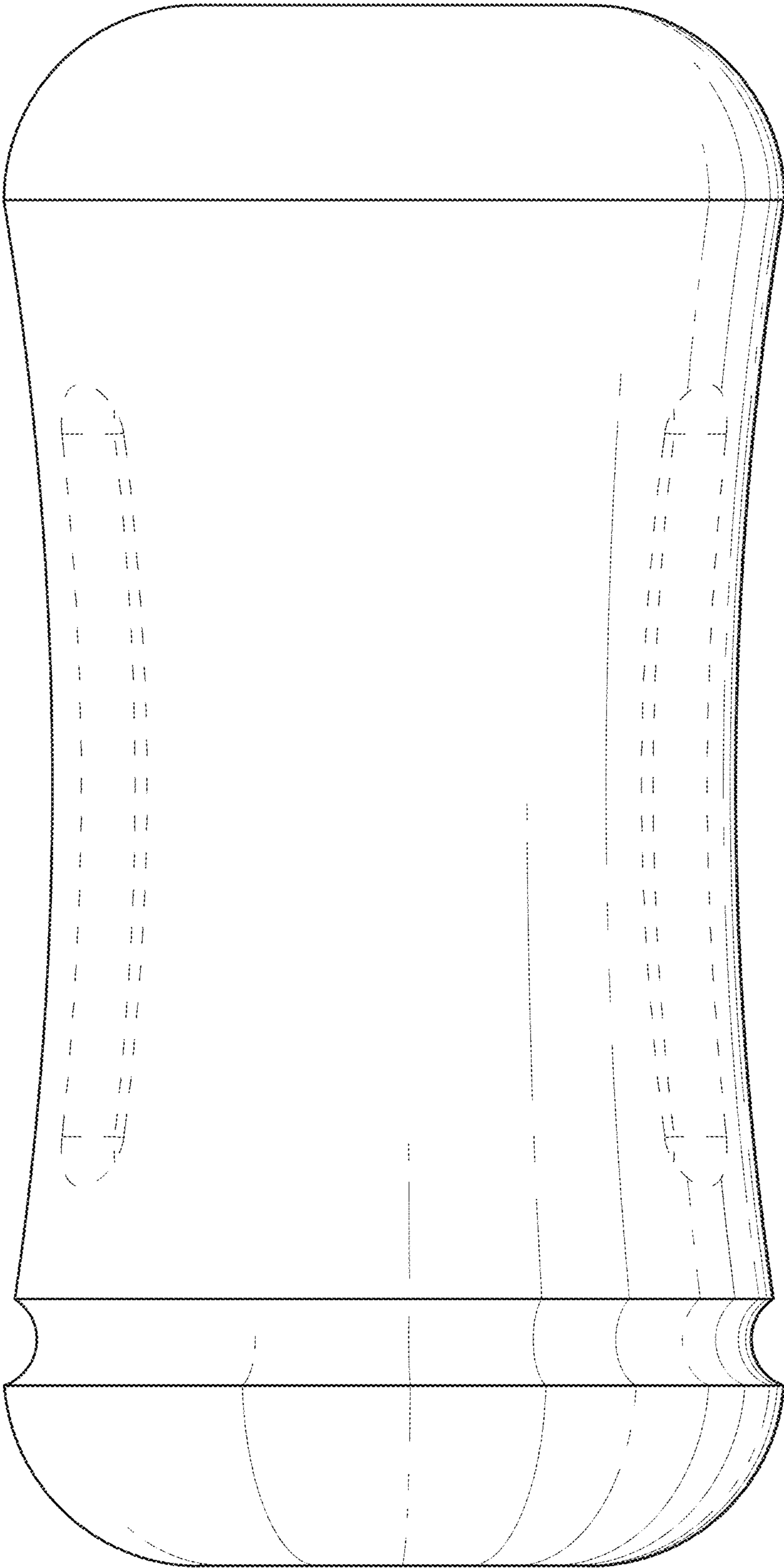

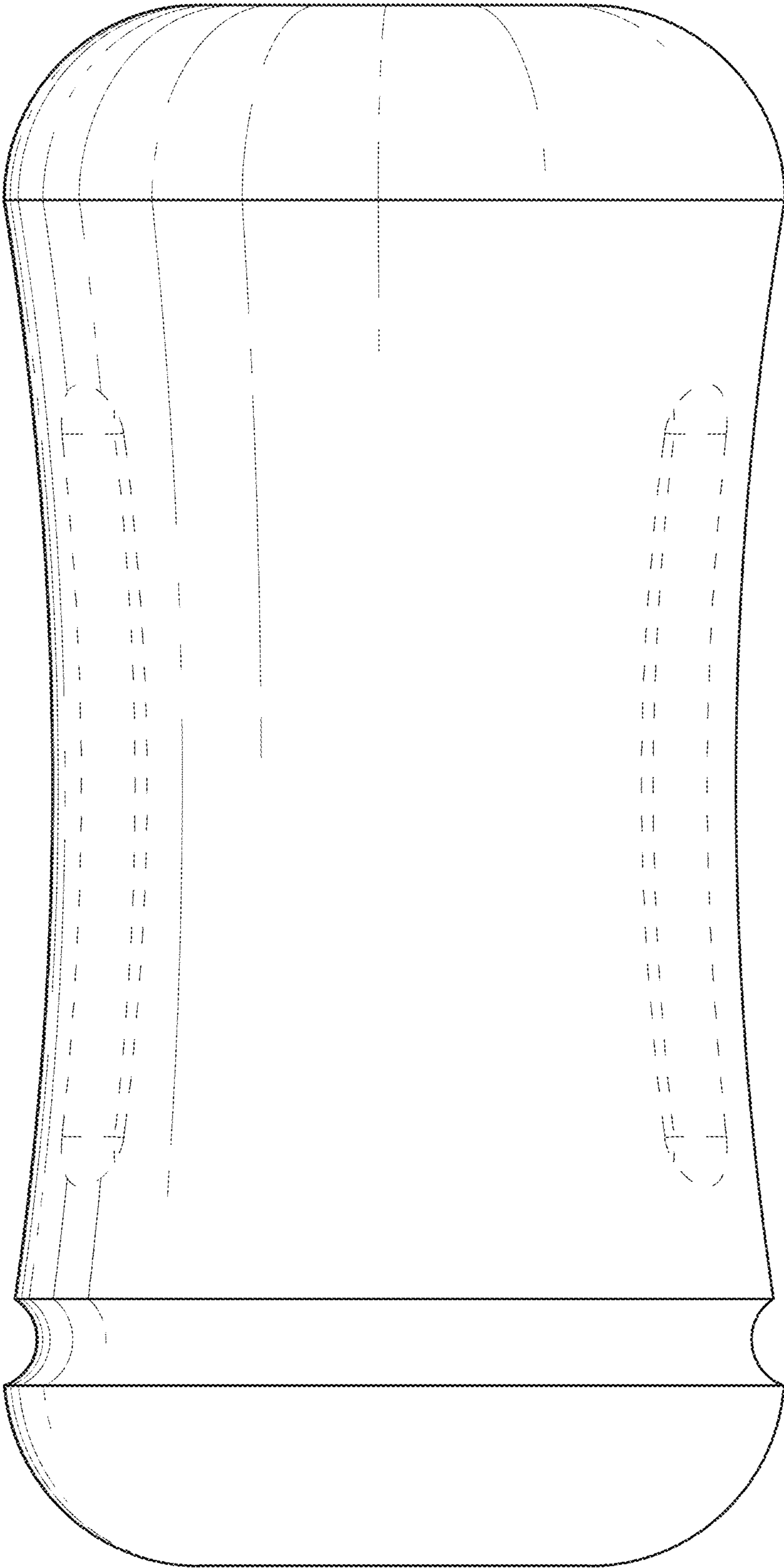

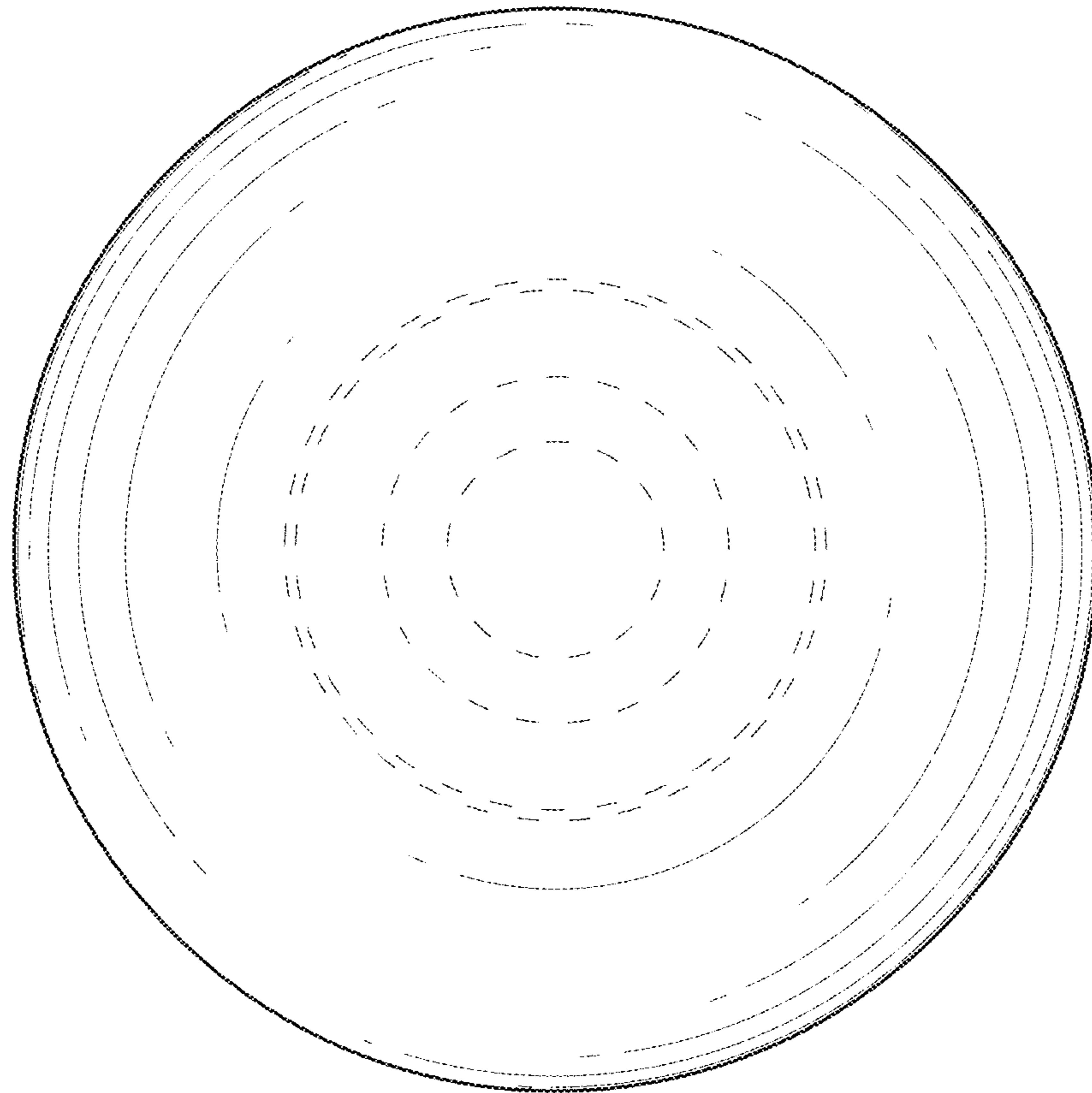

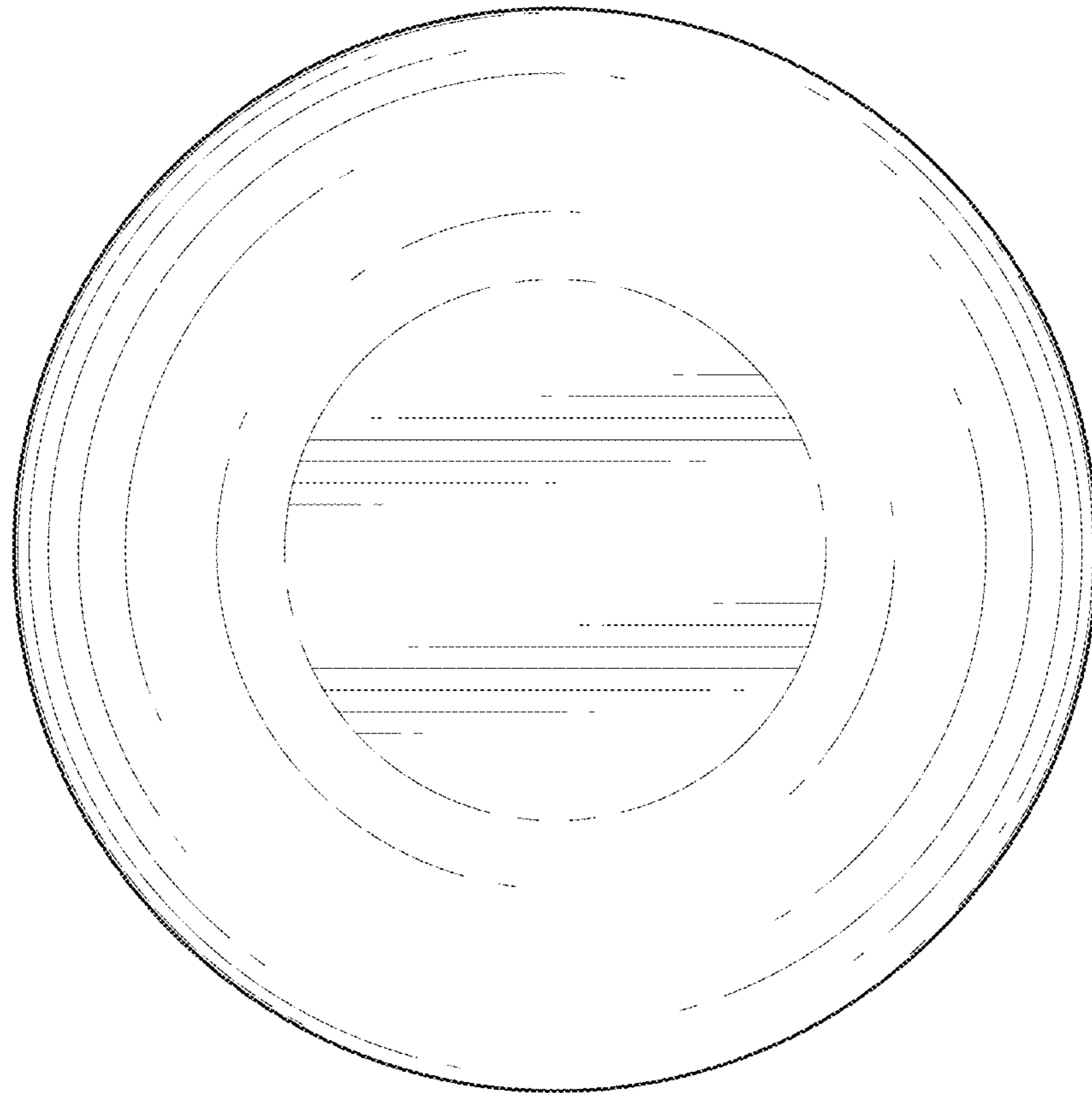

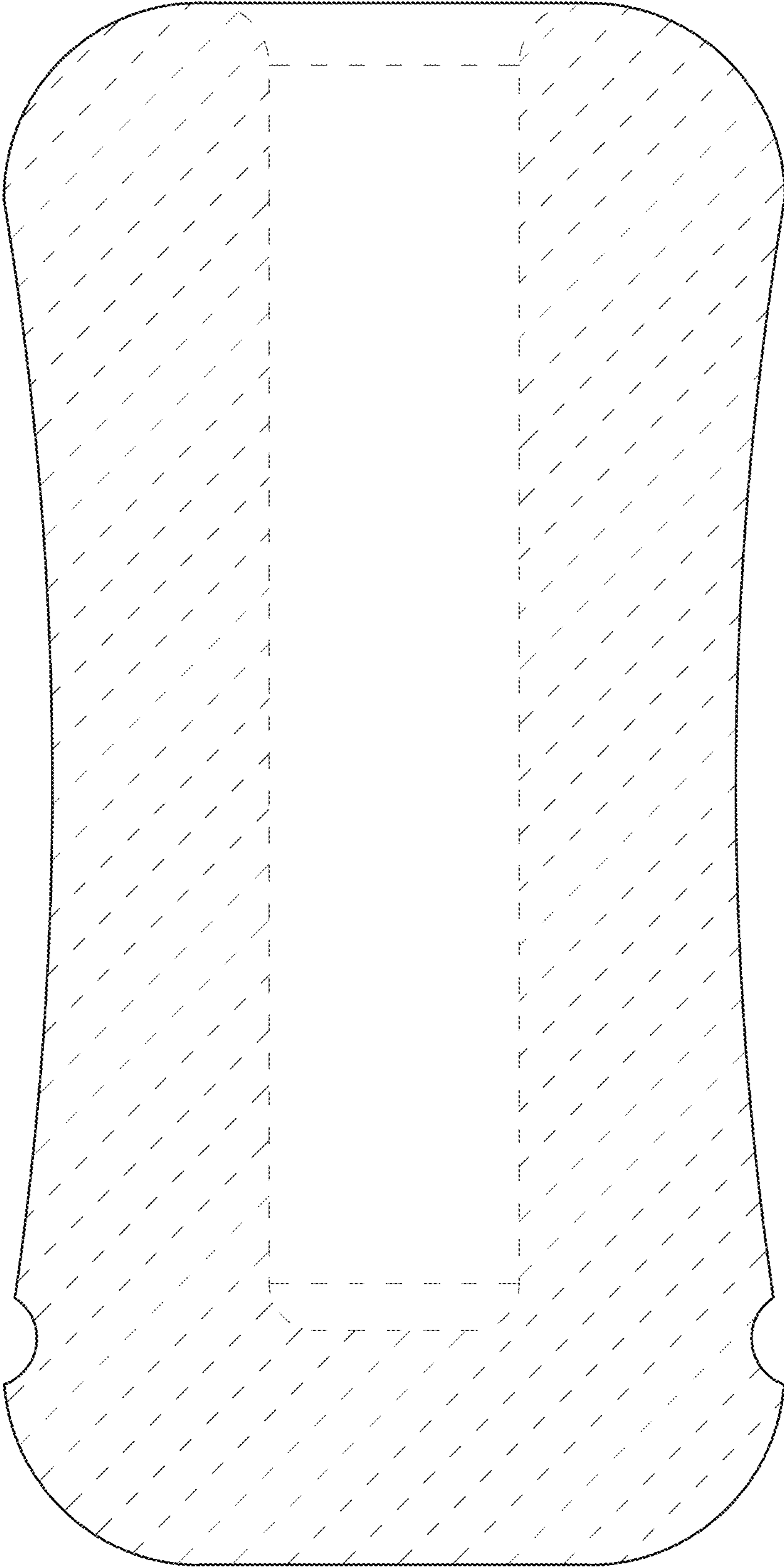
