(57) **CLAIM**

The ornamental design for a component for patient table, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a component for patient table showing our new design;
FIG. 2 is a back elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a perspective view taken generally from the upper, front, left-hand side thereof; and,
FIG. 8 is a perspective view taken generally from the upper, back, right-hand side thereof.
The broken lines depict portions of the component for patient table that form no part of the claimed design.

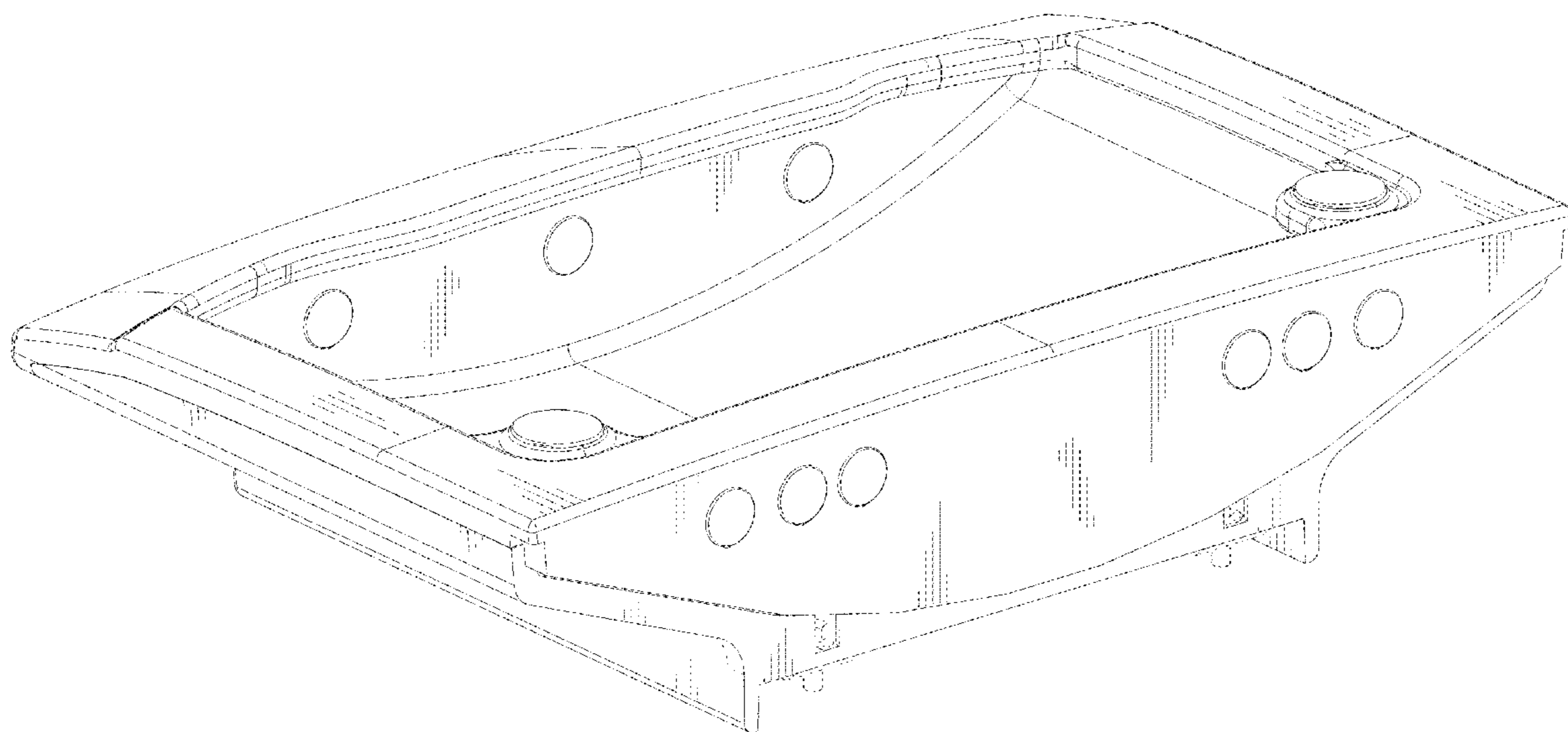

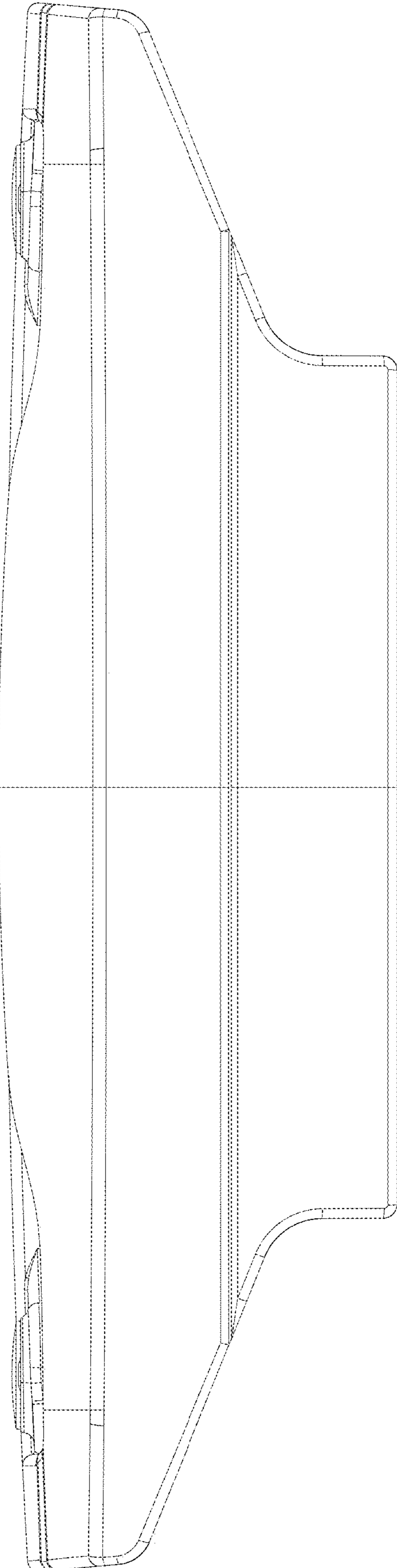

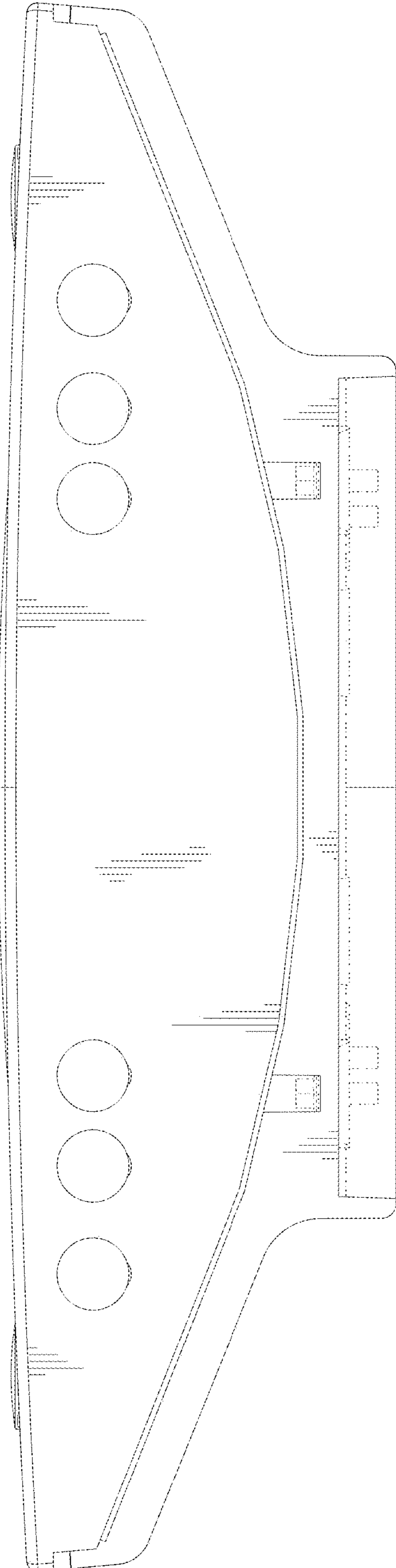

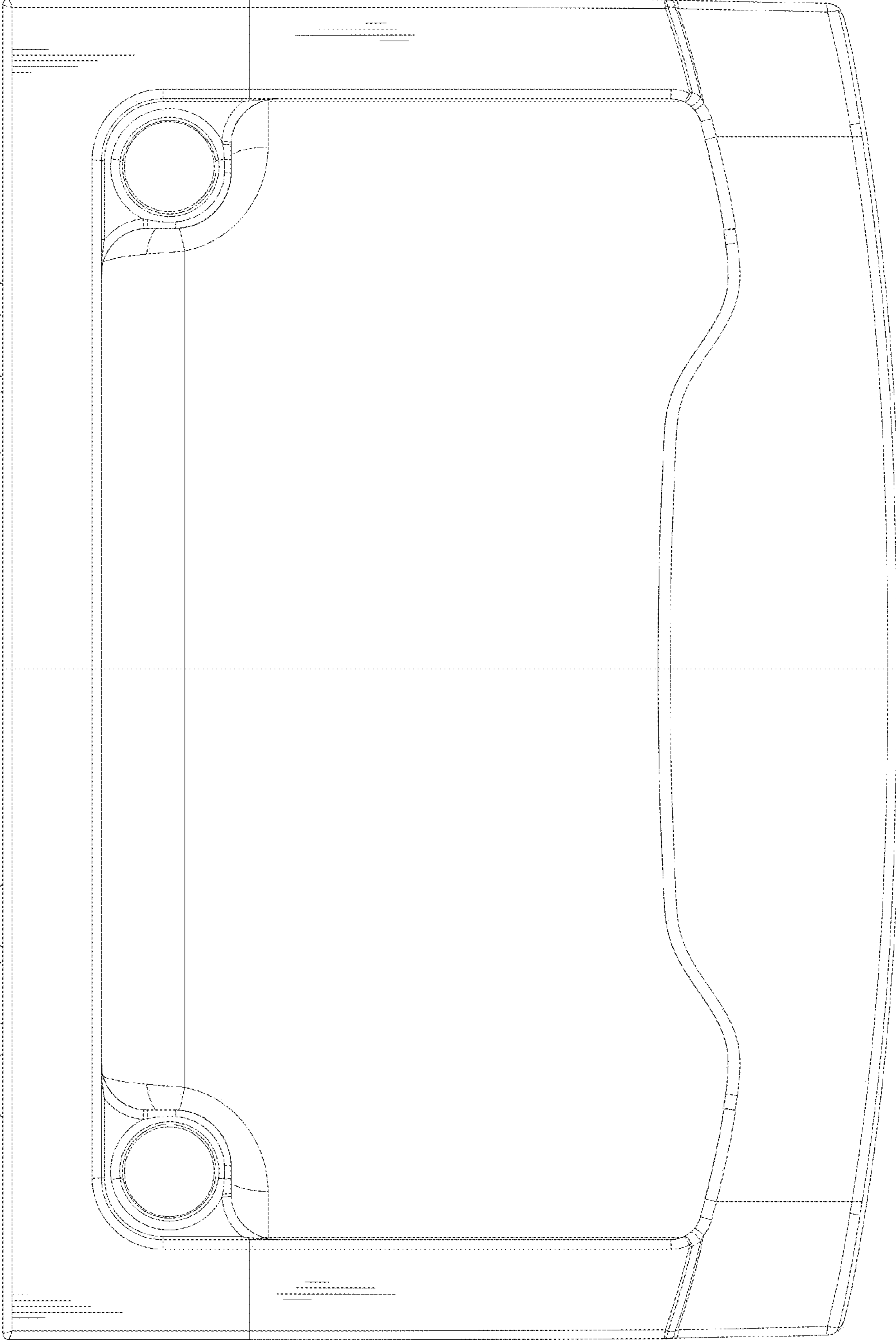

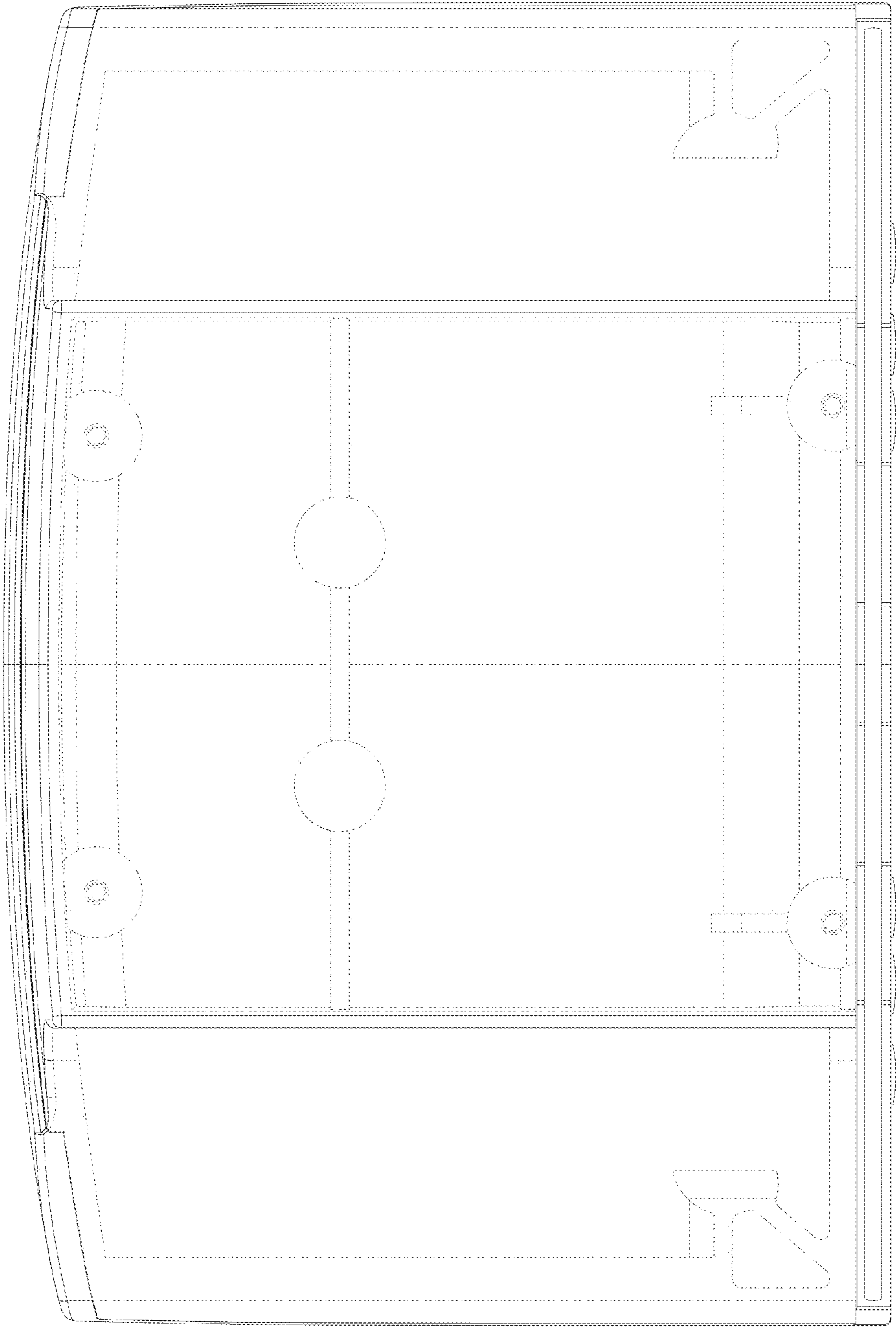

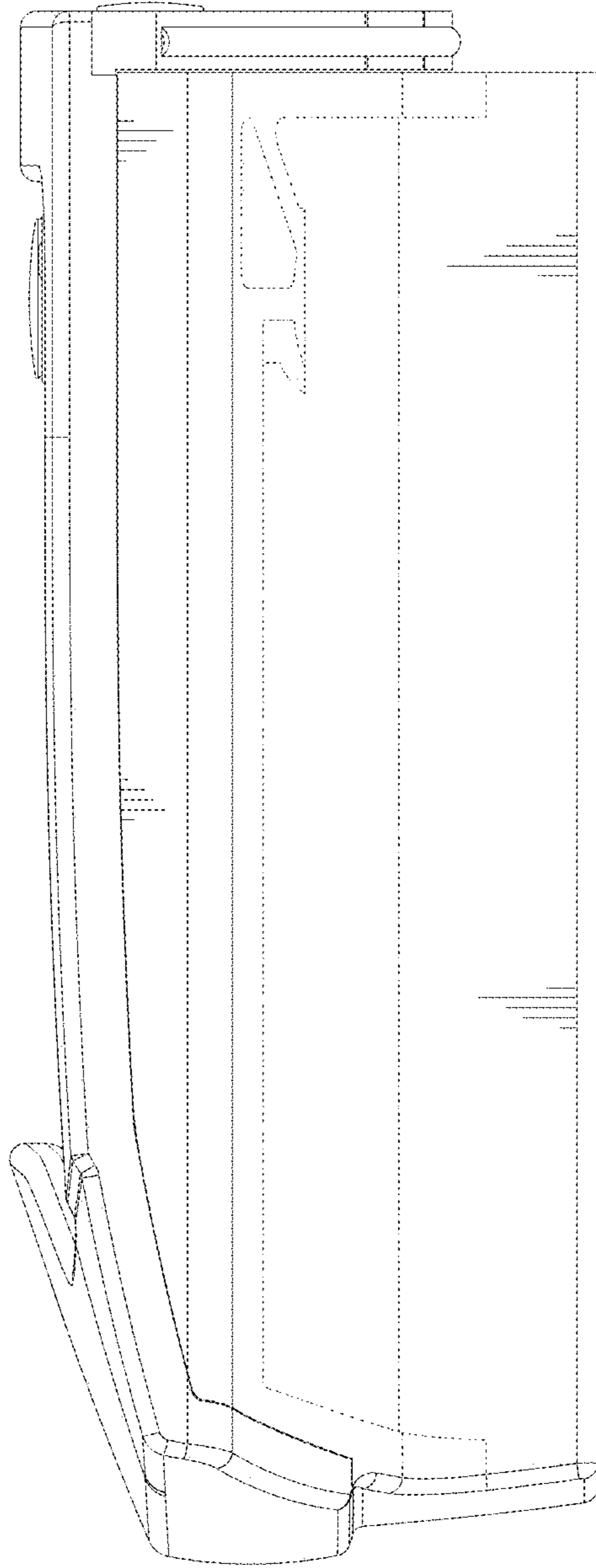
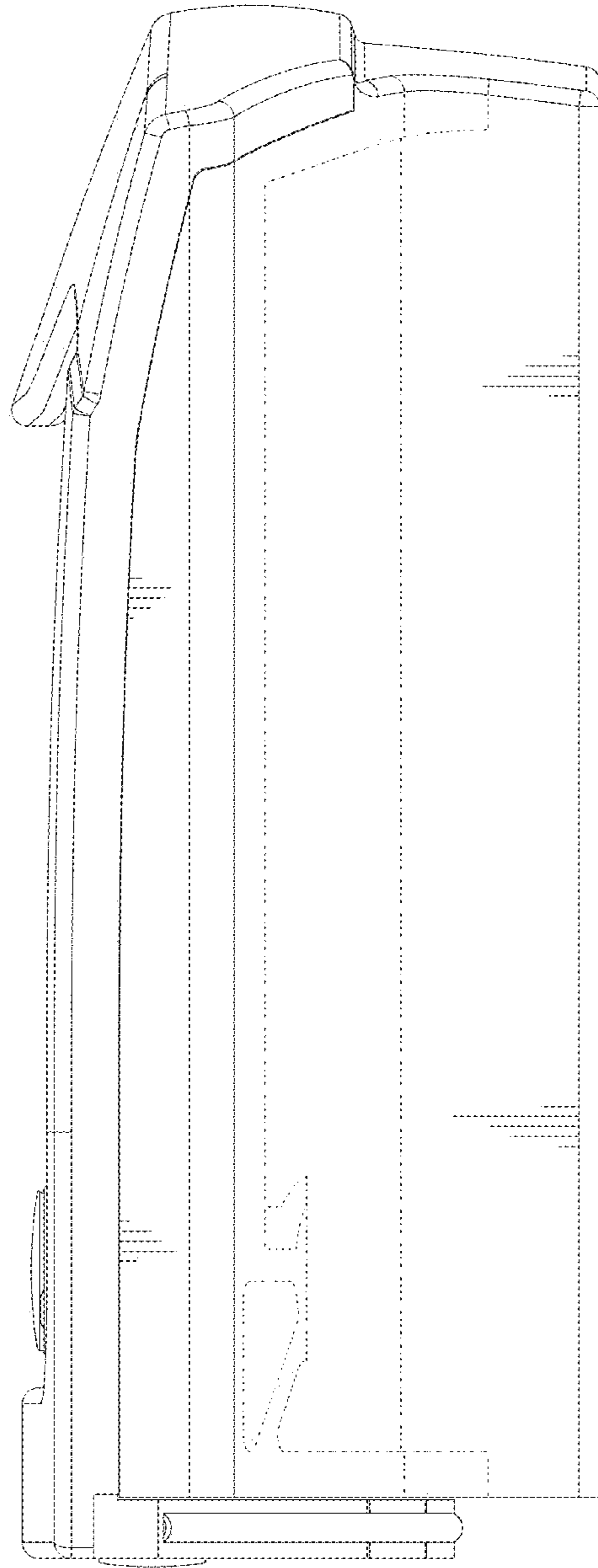

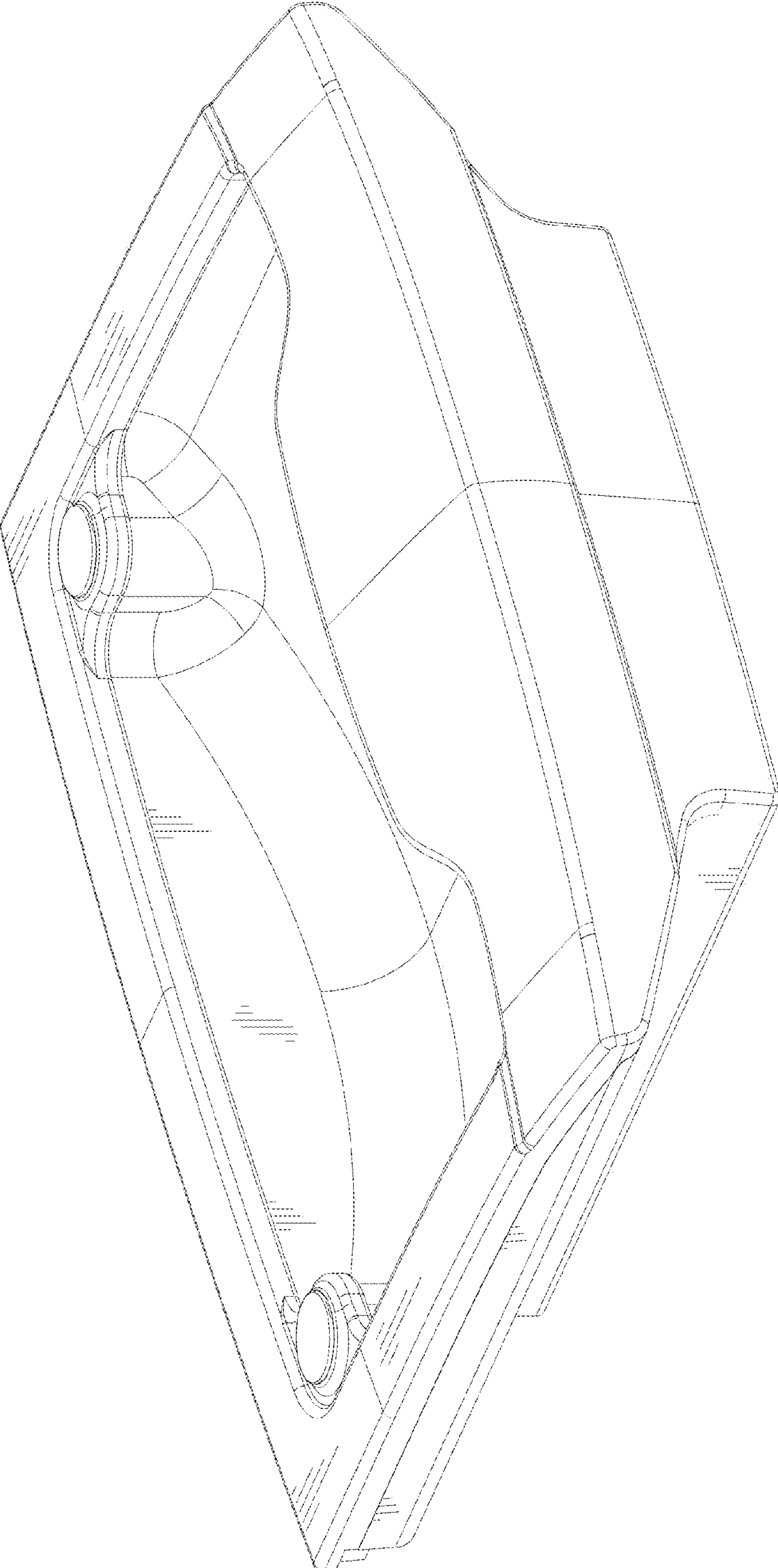
