The ornamental design for an orthosis, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an orthosis showing our new design;  
FIG. 2 is a top view of the orthosis shown in FIG. 1;  
FIG. 3 is a bottom view of the orthosis shown in FIG. 1;  
FIG. 4 is a front view of the orthosis shown in FIG. 1, the back view being a mirror image thereof; and,  
FIG. 5 is a left side view of the orthosis shown in FIG. 1, the right side being a mirror image thereof.

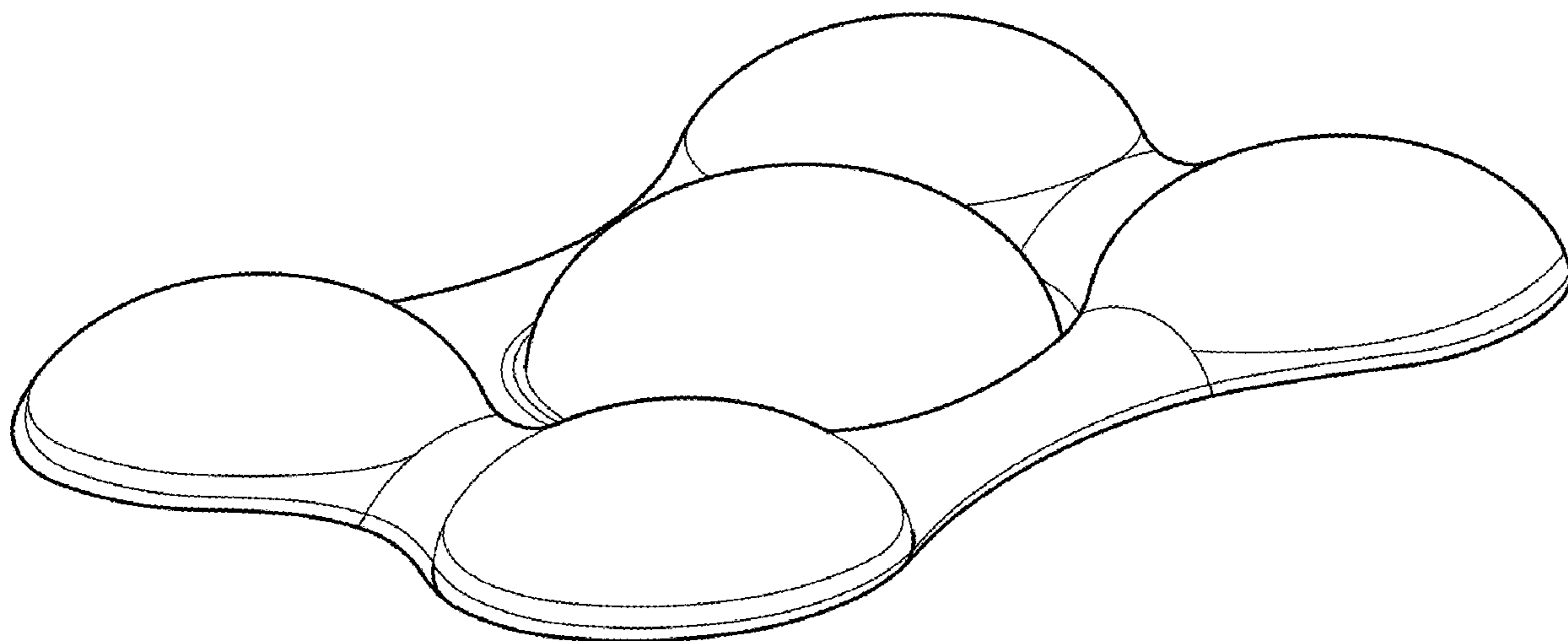

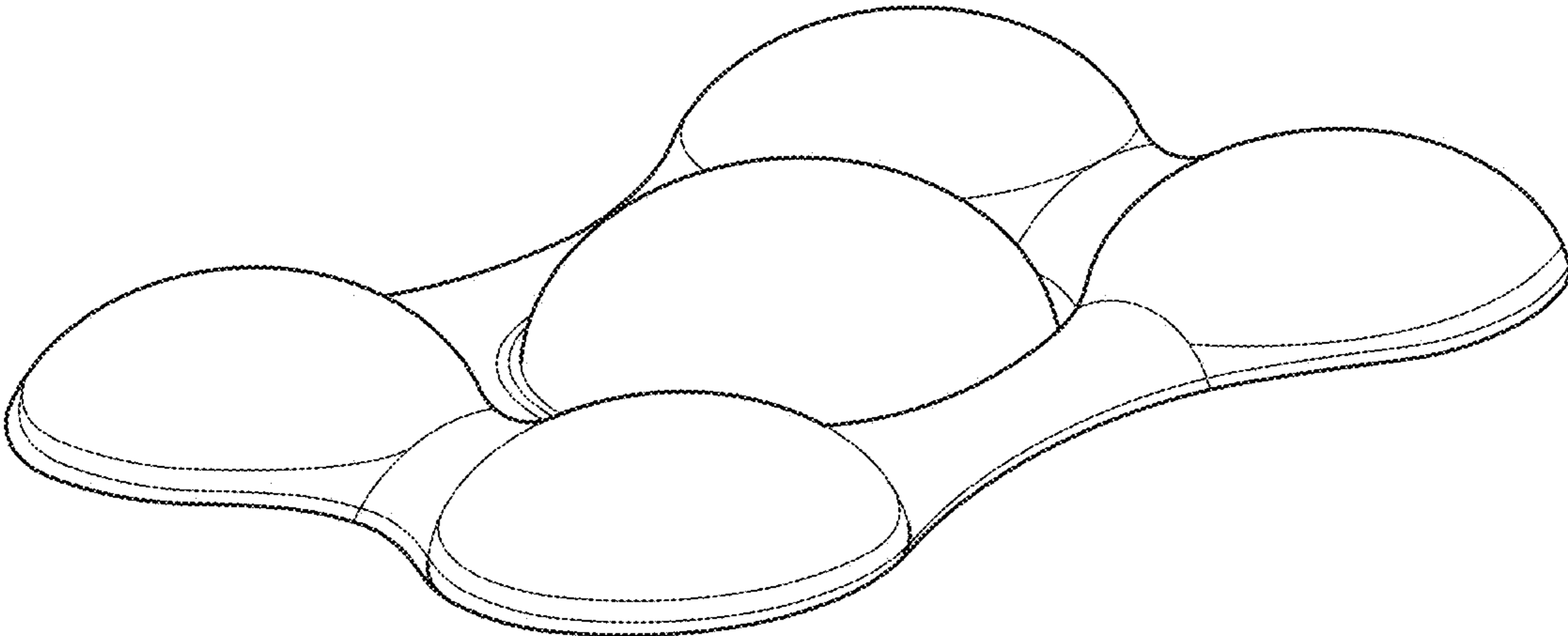

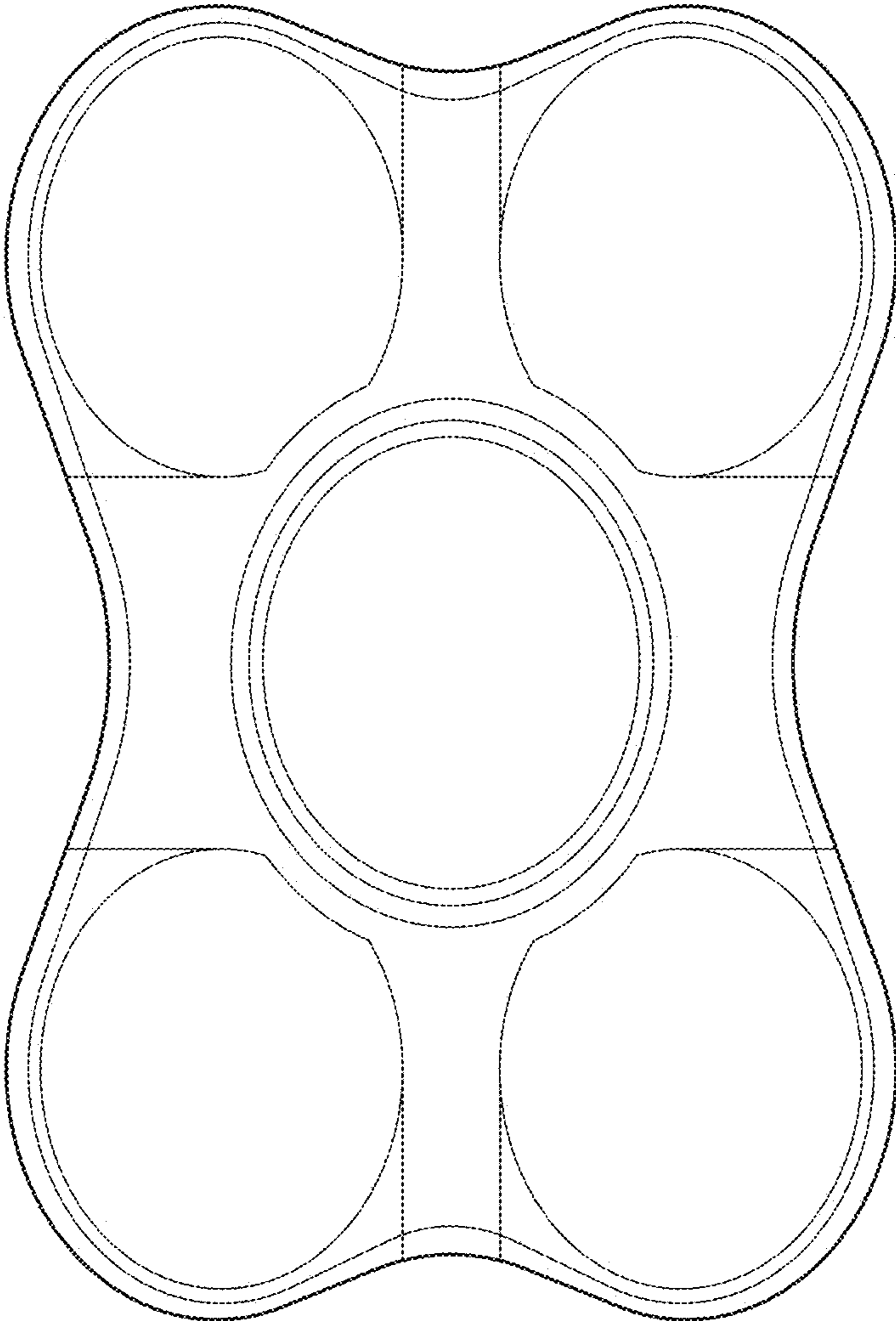

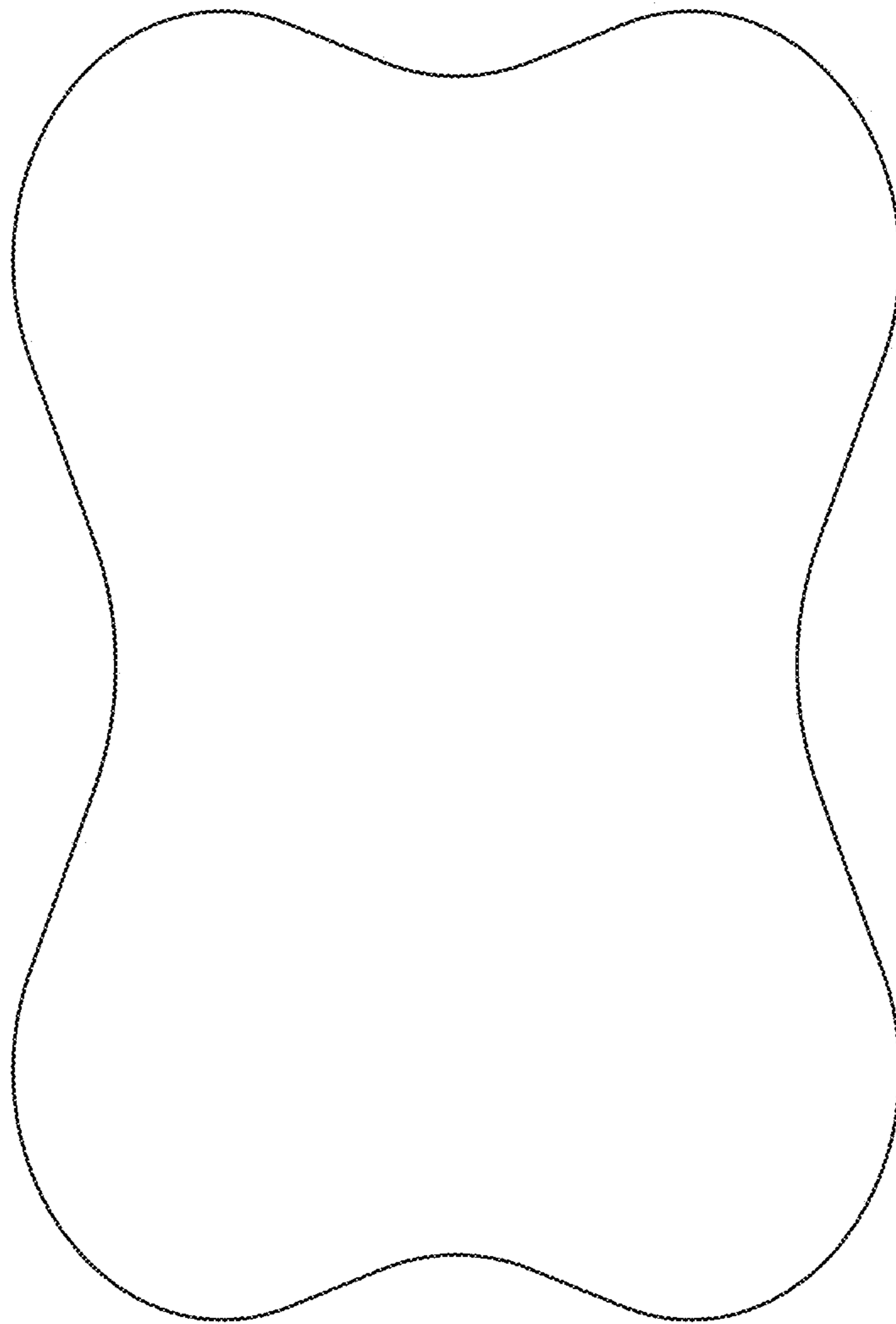

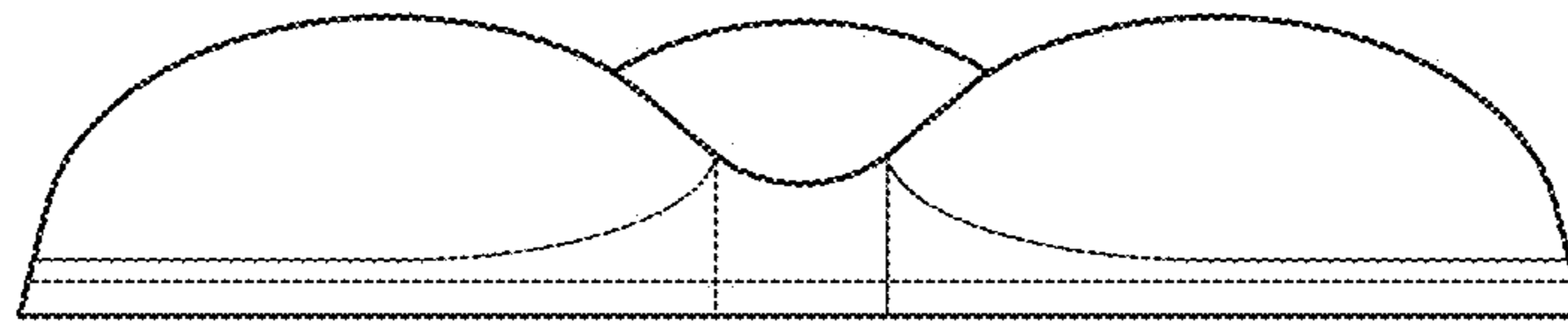
