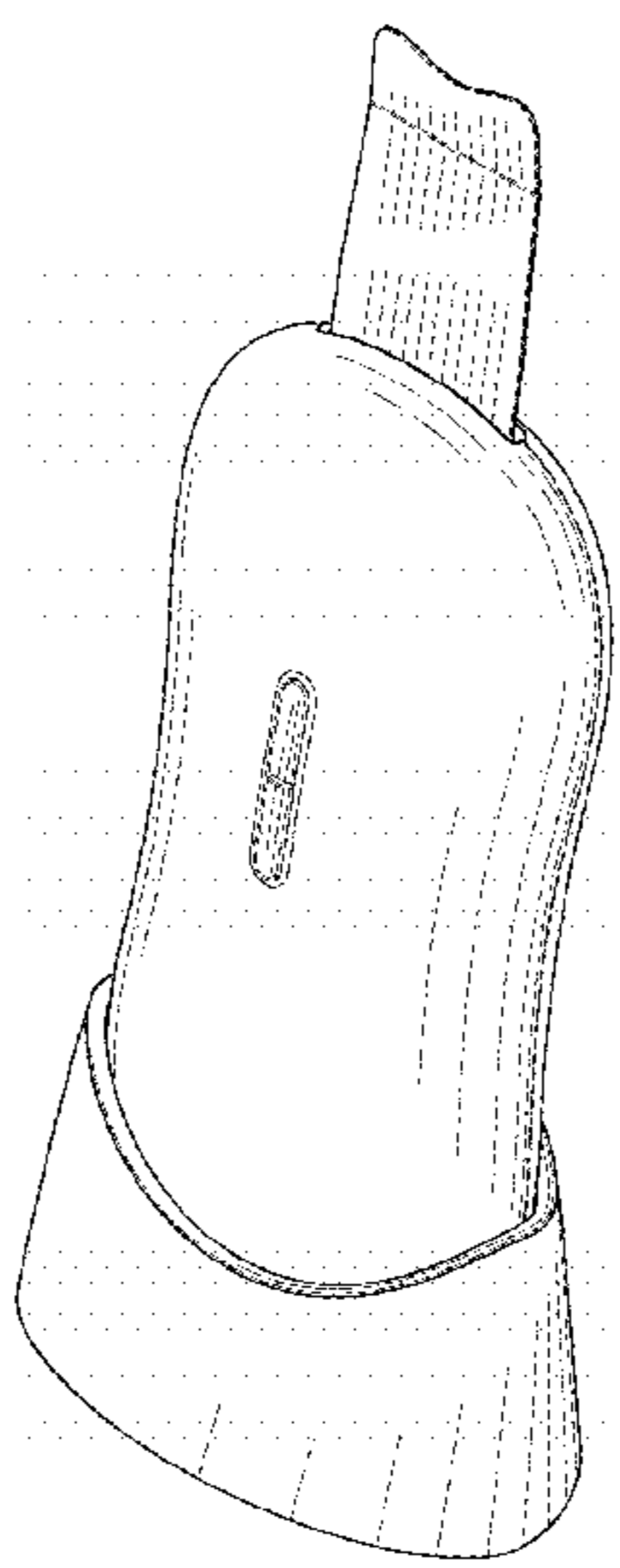
The ornamental design for an ultrasonic beauty device, as shown and described.

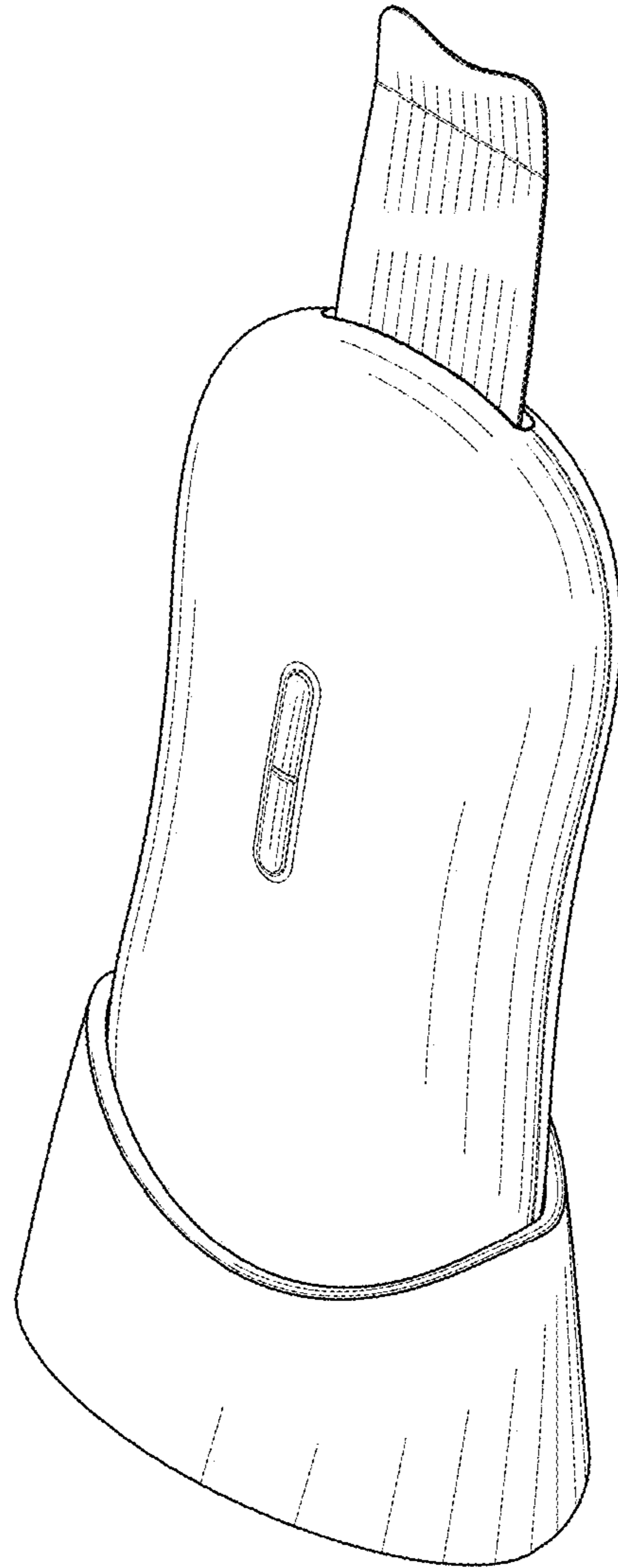

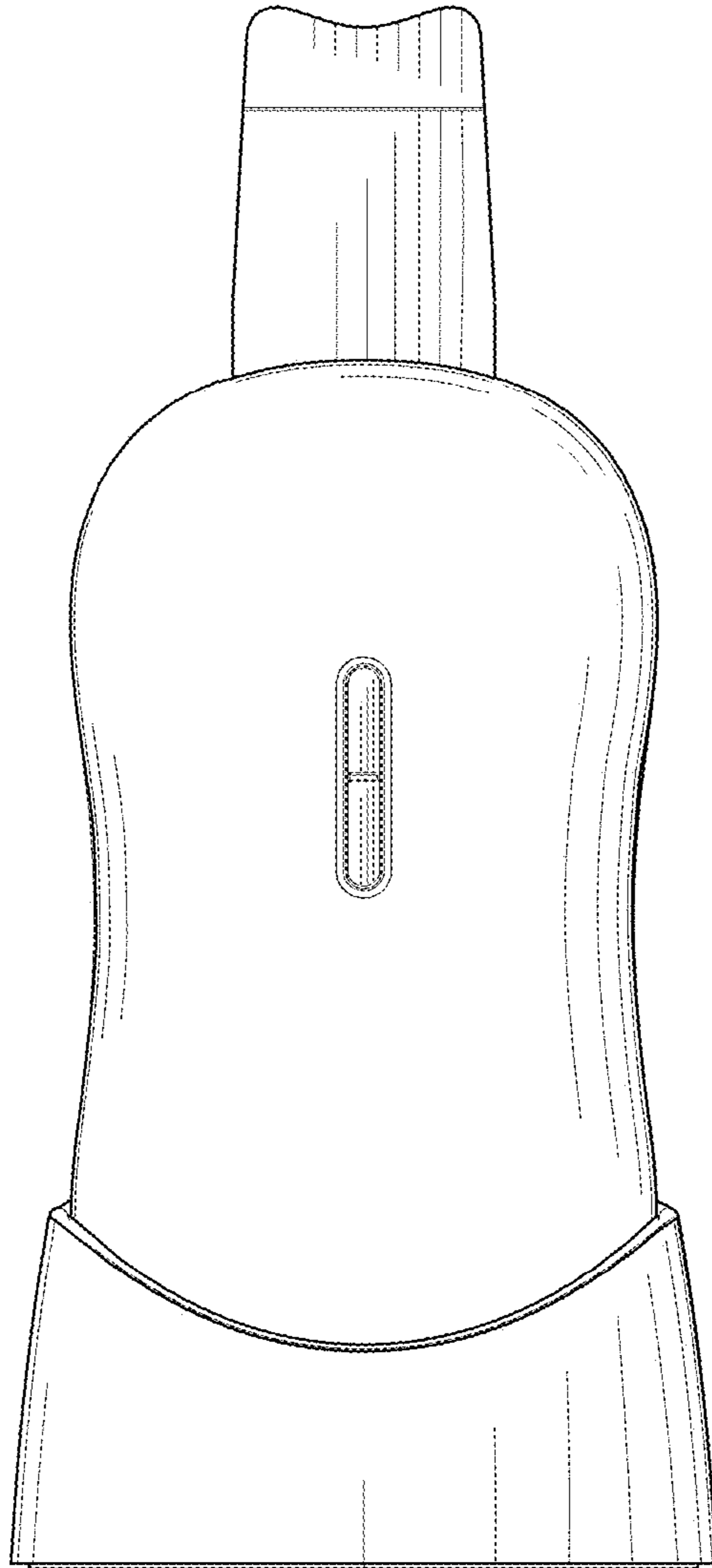

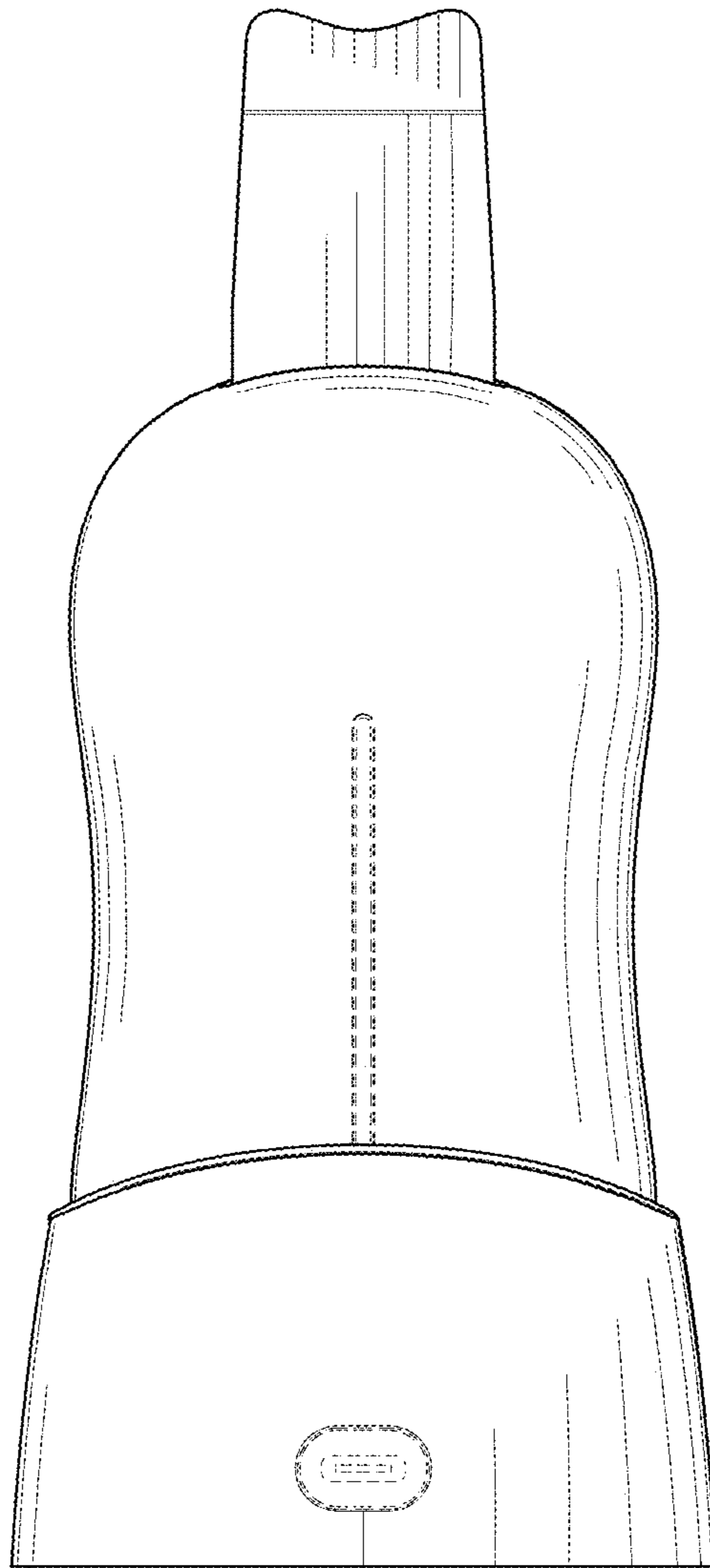

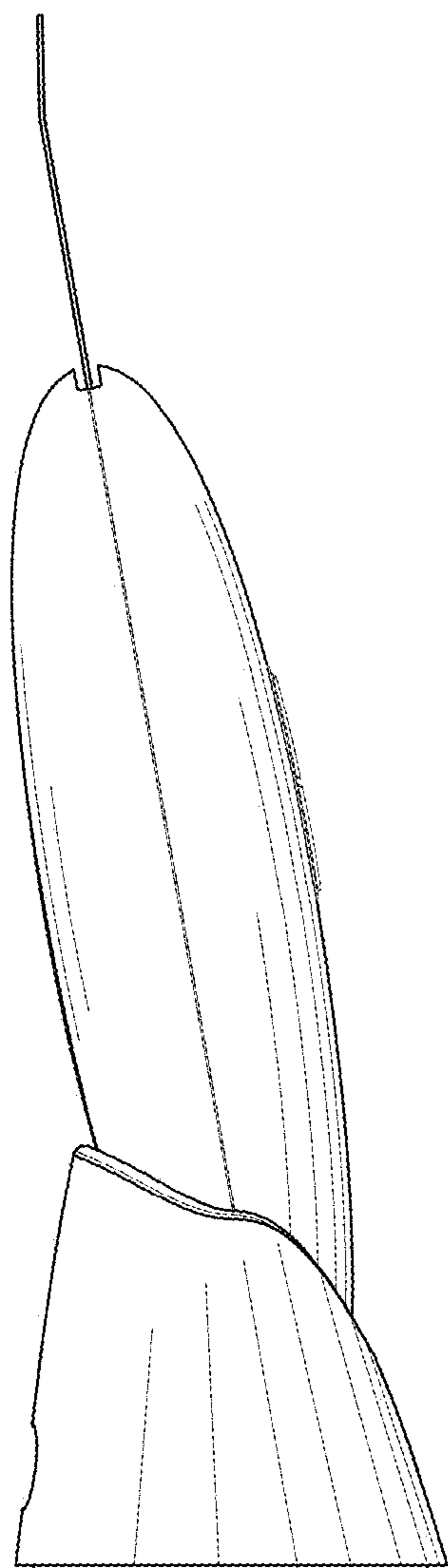

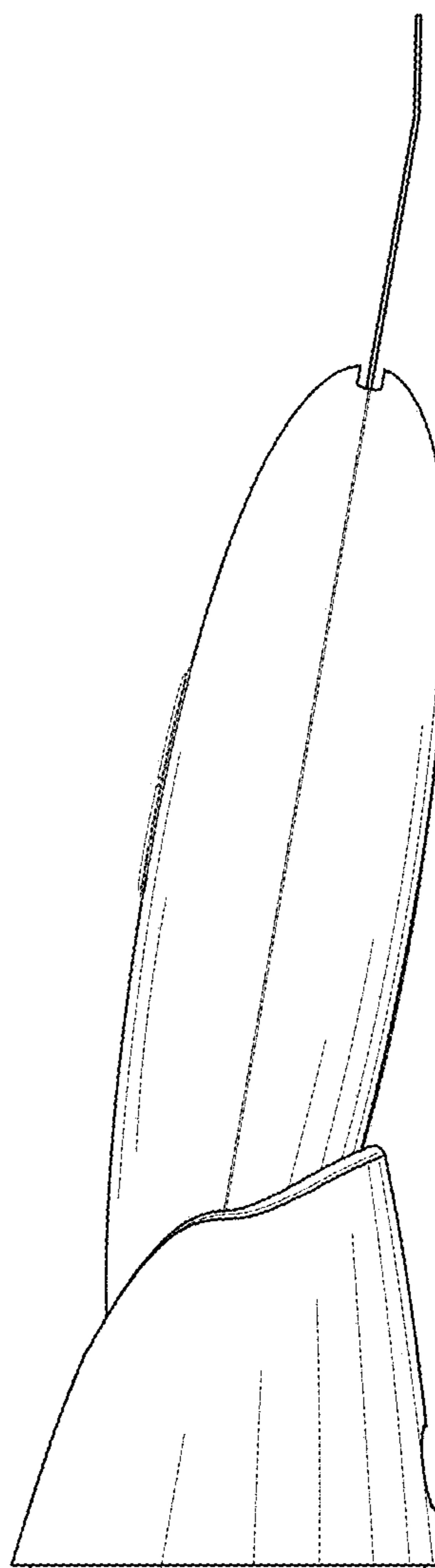

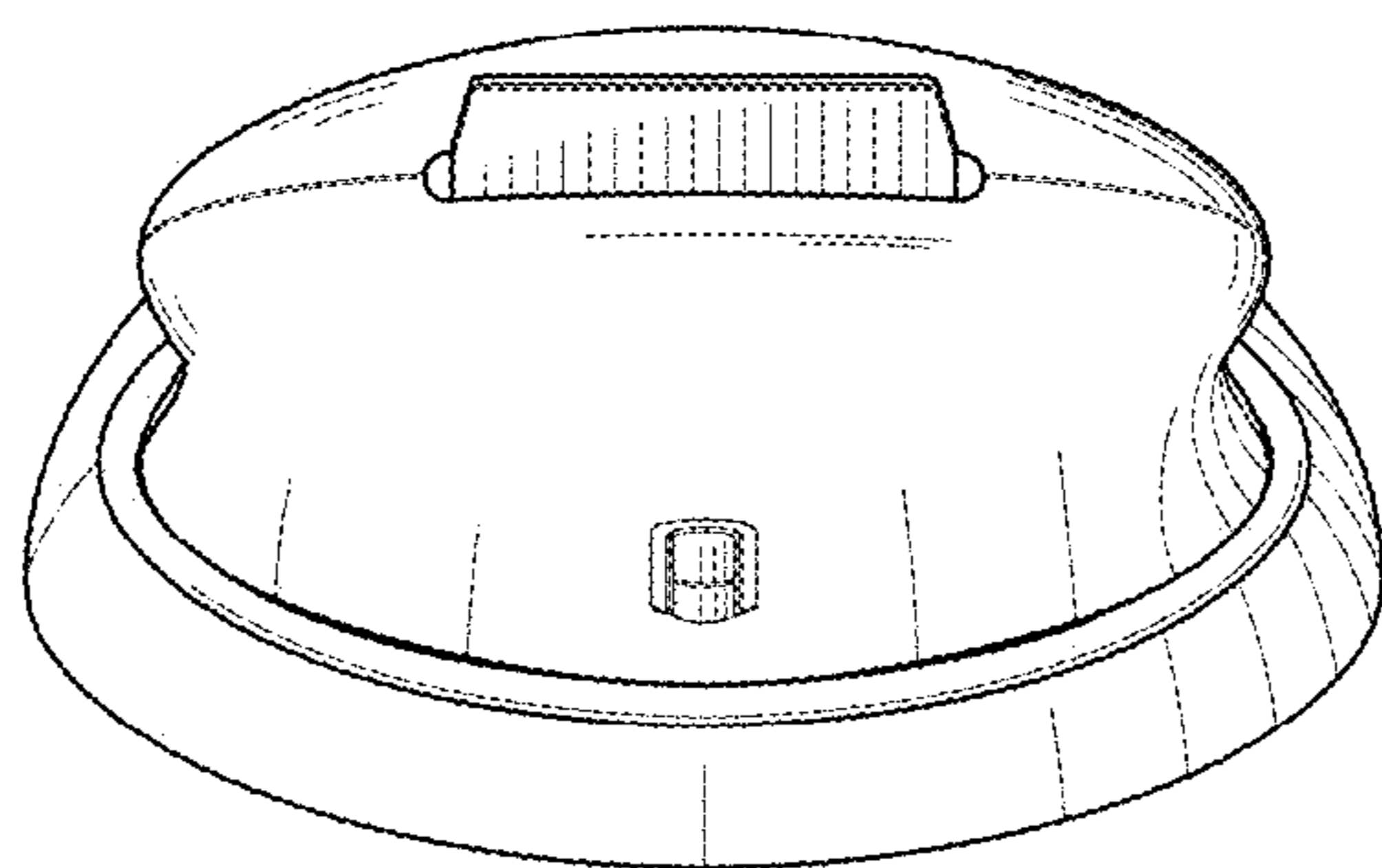

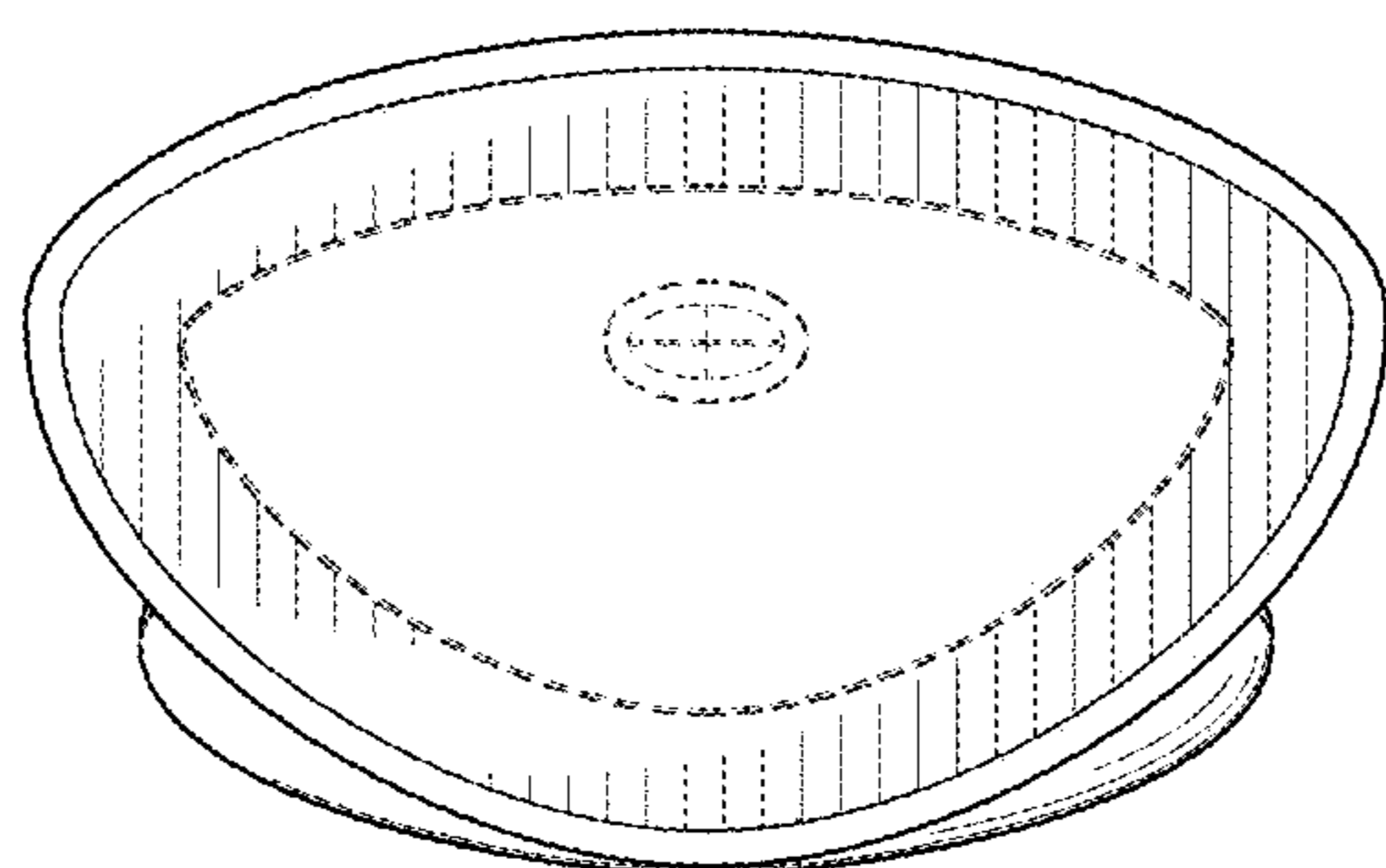
