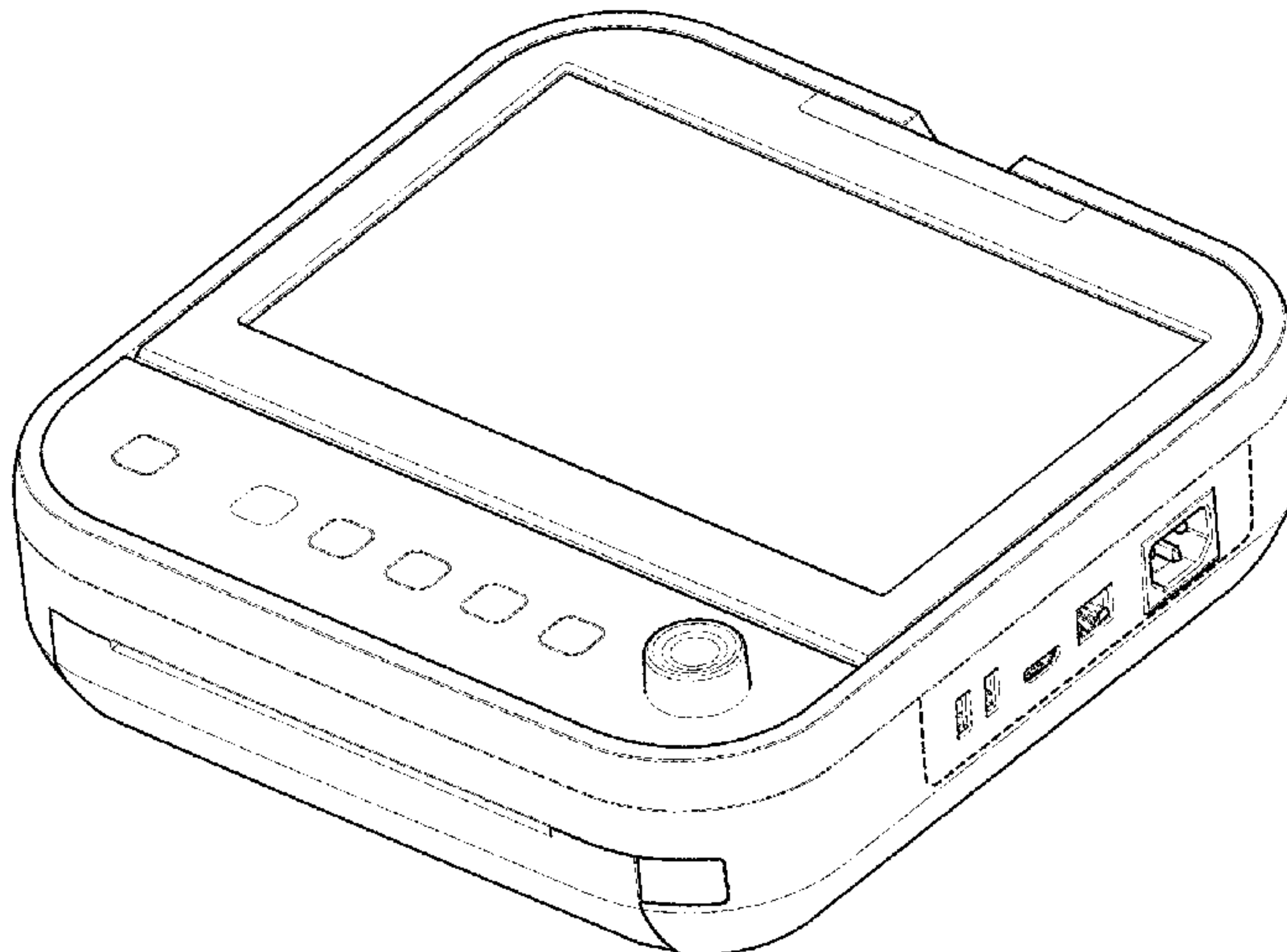
We claim the ornamental design for a fetal and maternal monitor, as shown and described.

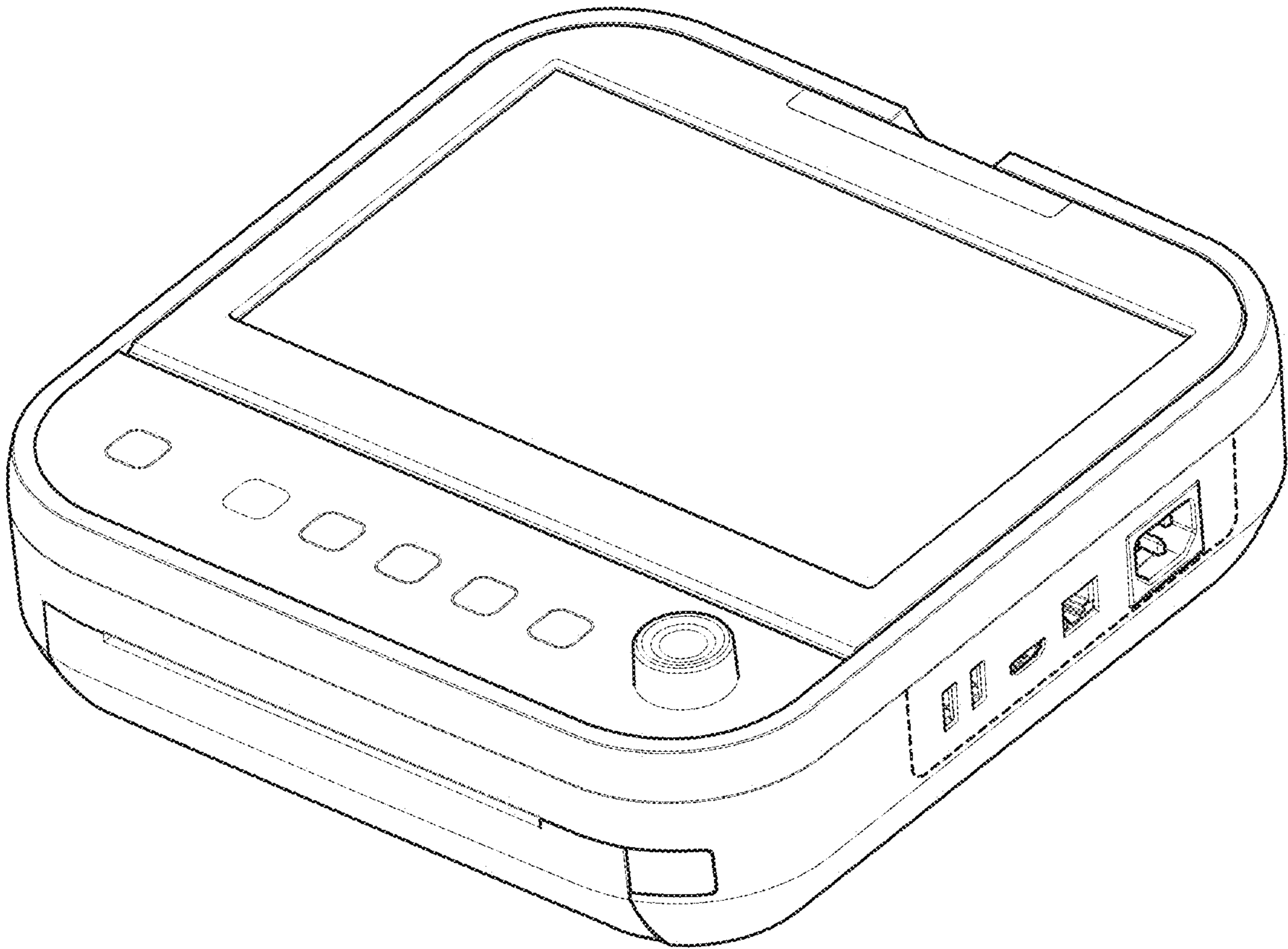

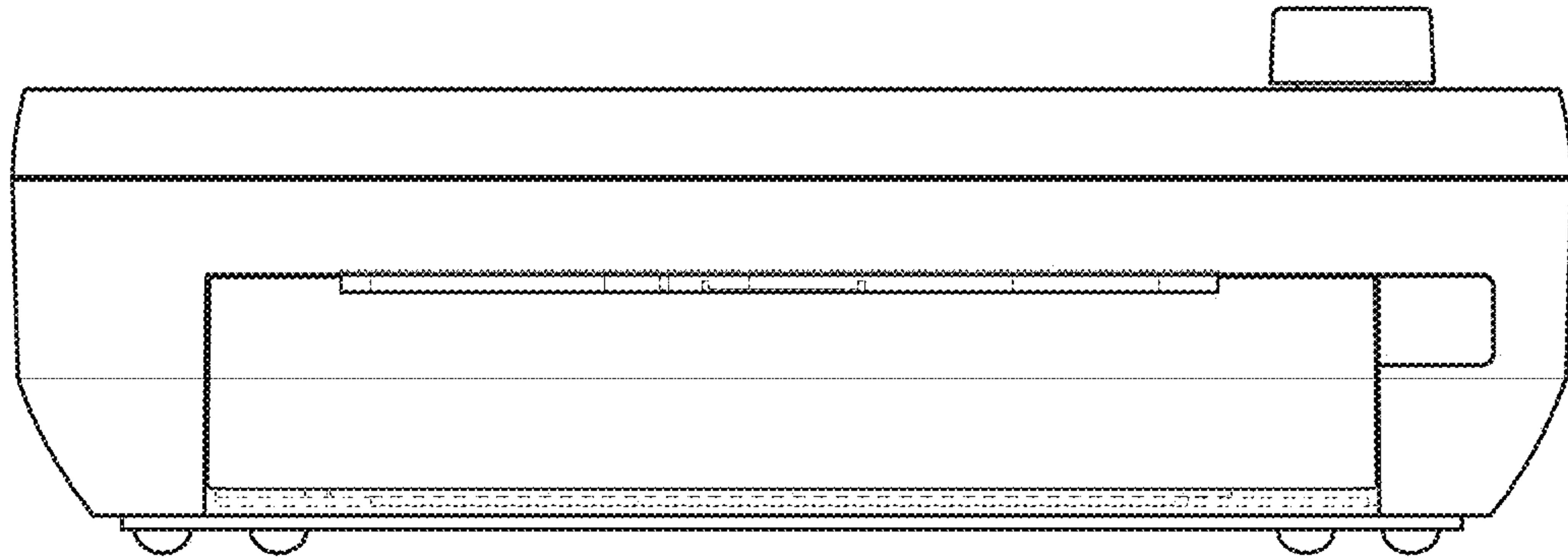

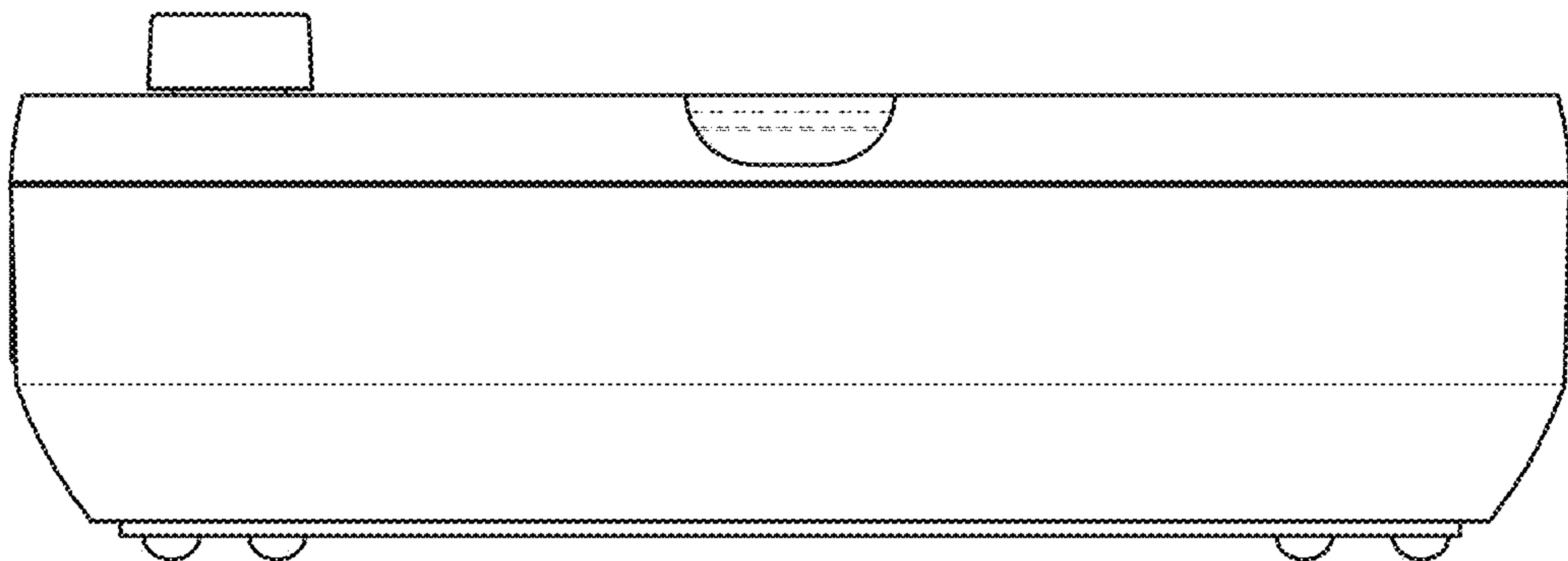

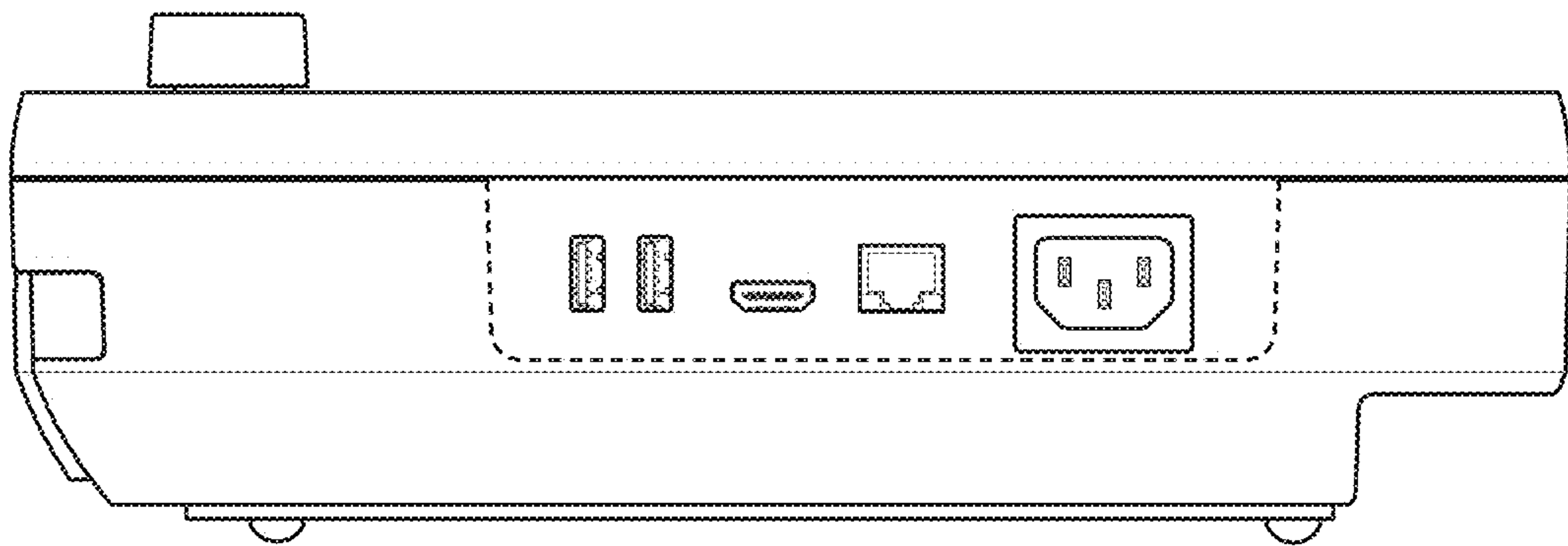

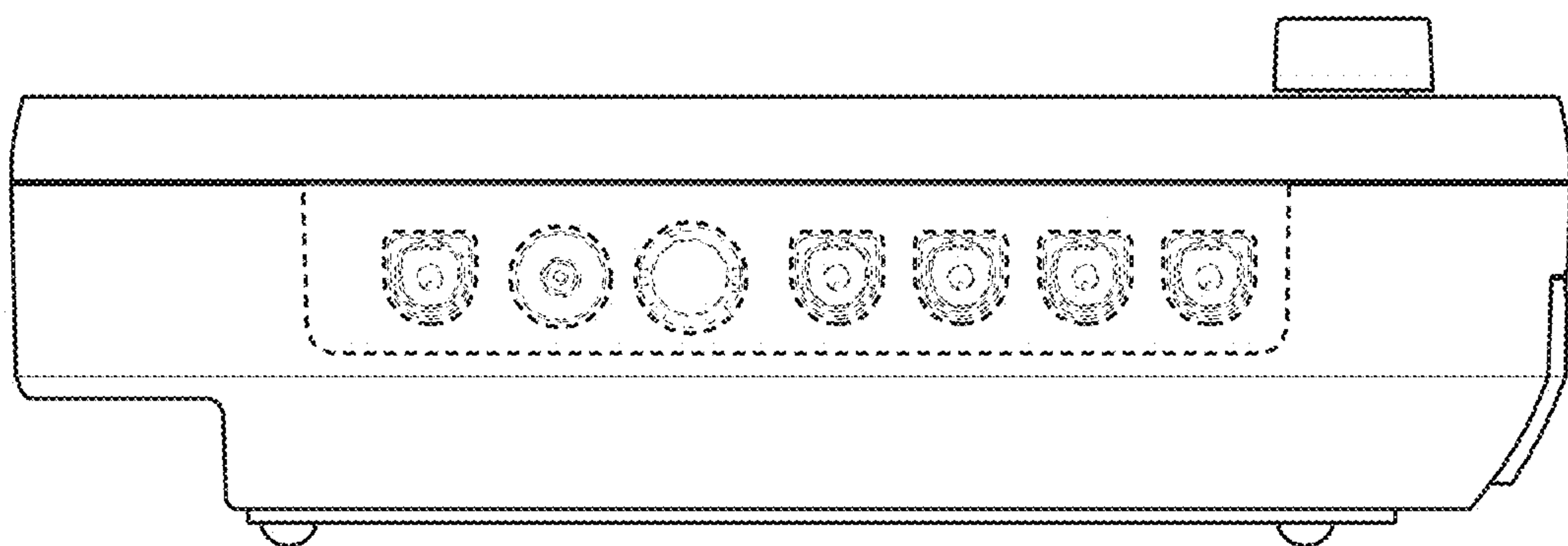

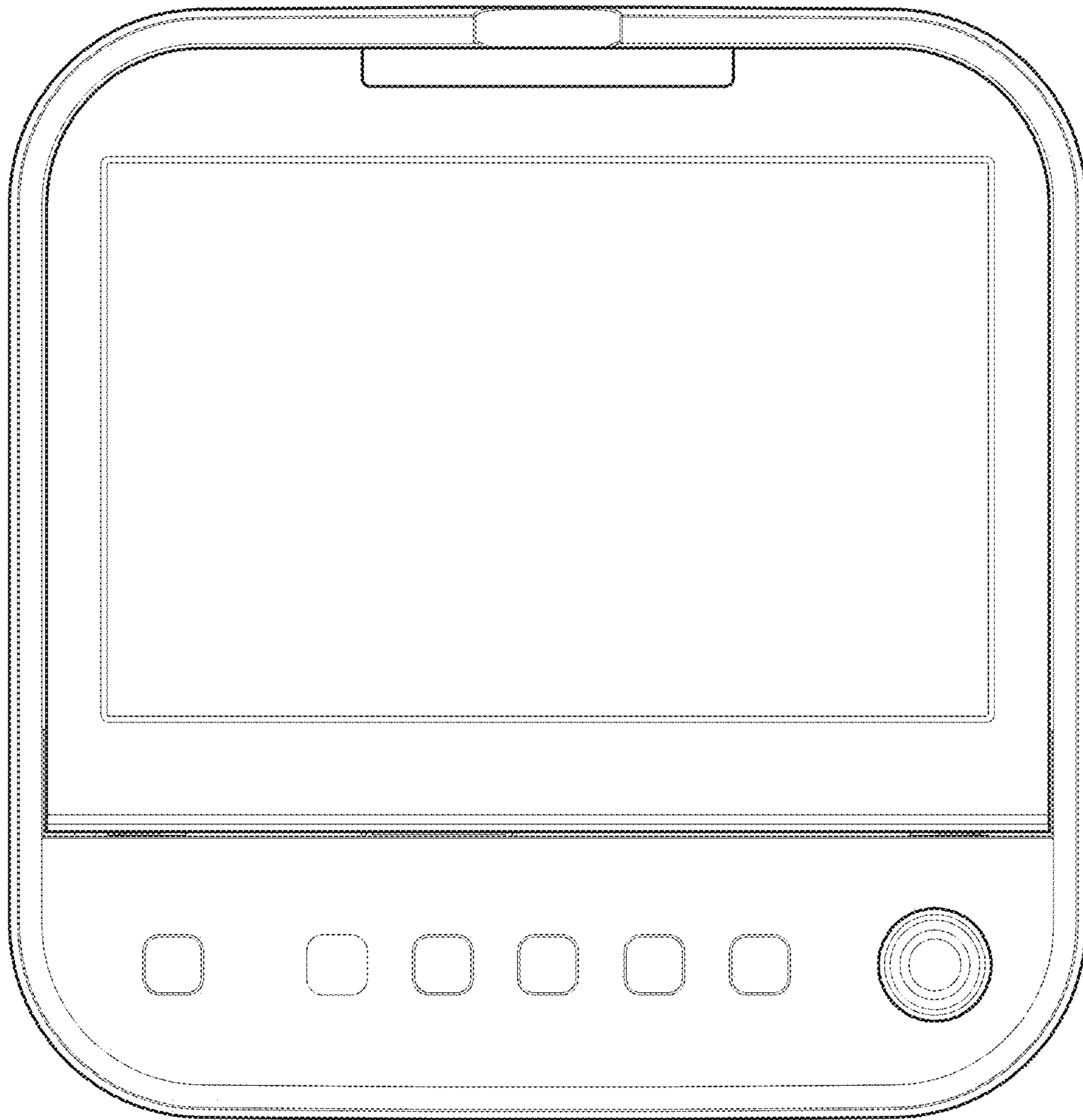

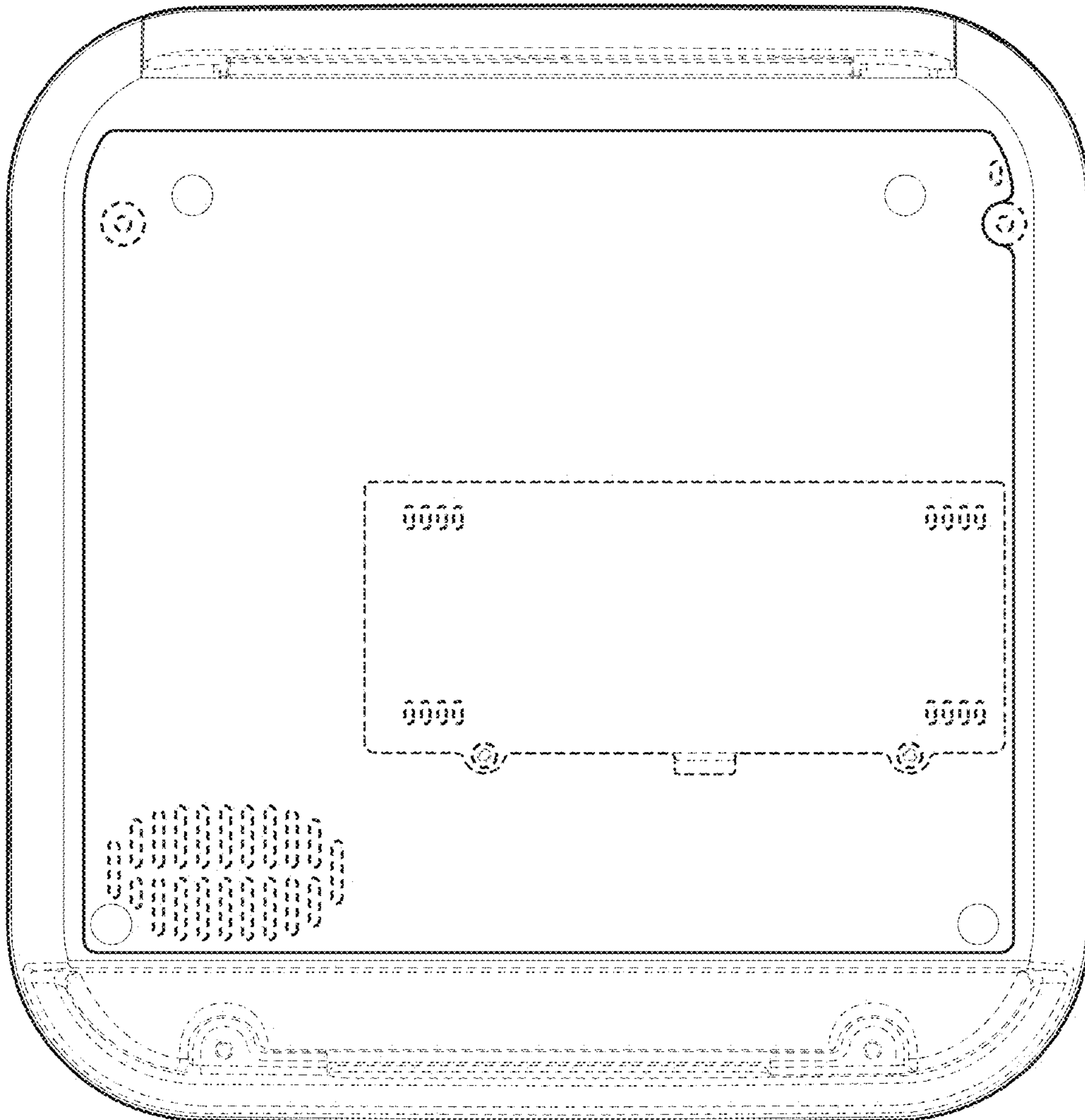
