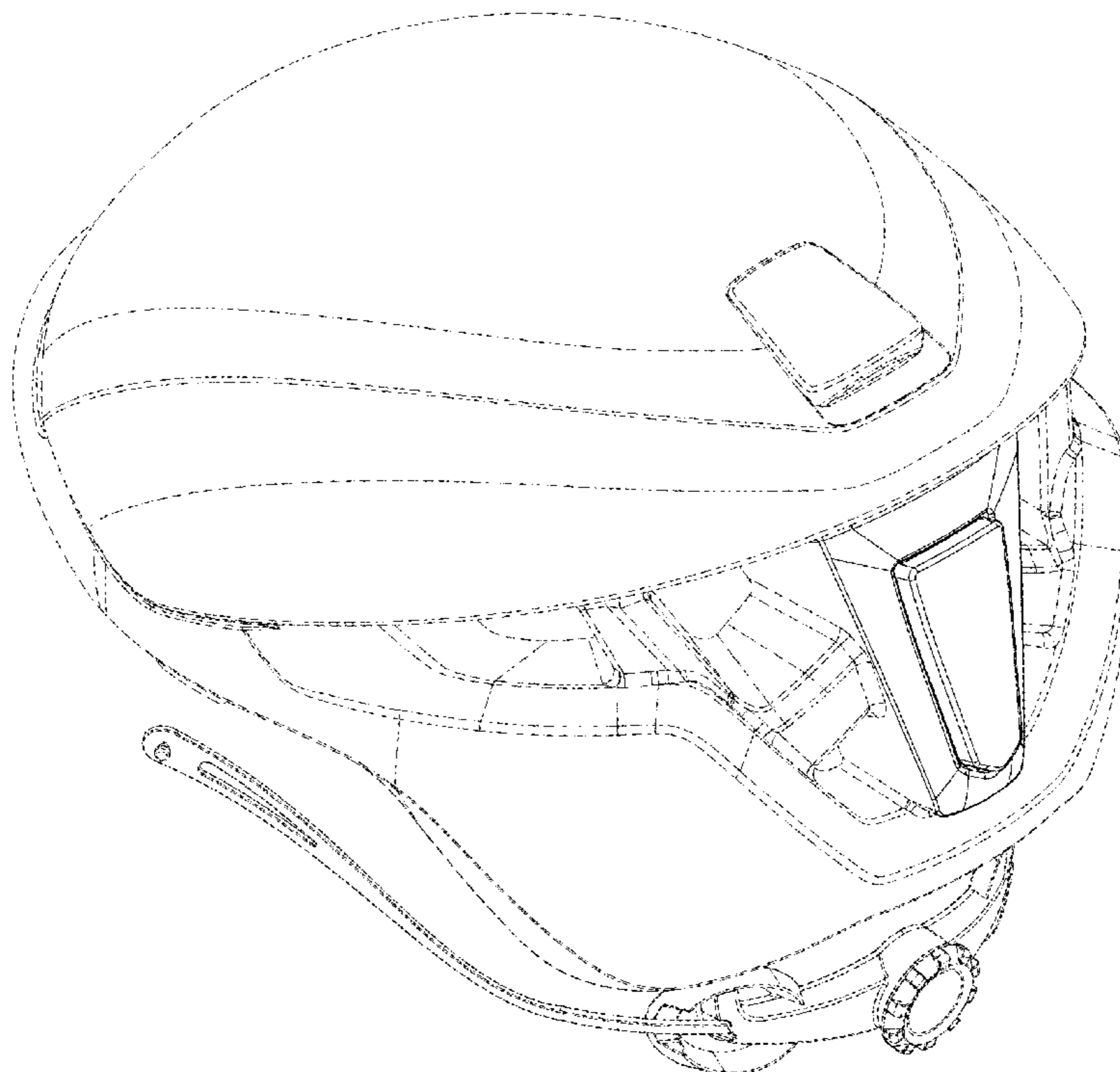
(57) **CLAIM**

The ornamental design for a helmet, as shown and described.

DESCRIPTION

FIG. 1 is an upper rear perspective of a helmet embodying our design;
 FIG. 2 is a side elevation of the helmet shown in FIG. 1, with the opposite side elevation being a mirror image thereof;
 FIG. 3 is a rear elevation of the helmet shown in FIGS. 1 and 2;
 FIG. 4 is a top view of the helmet shown in FIGS. 1-3; and,
 FIG. 5 is a bottom view of the helmet shown in FIGS. 1-4.

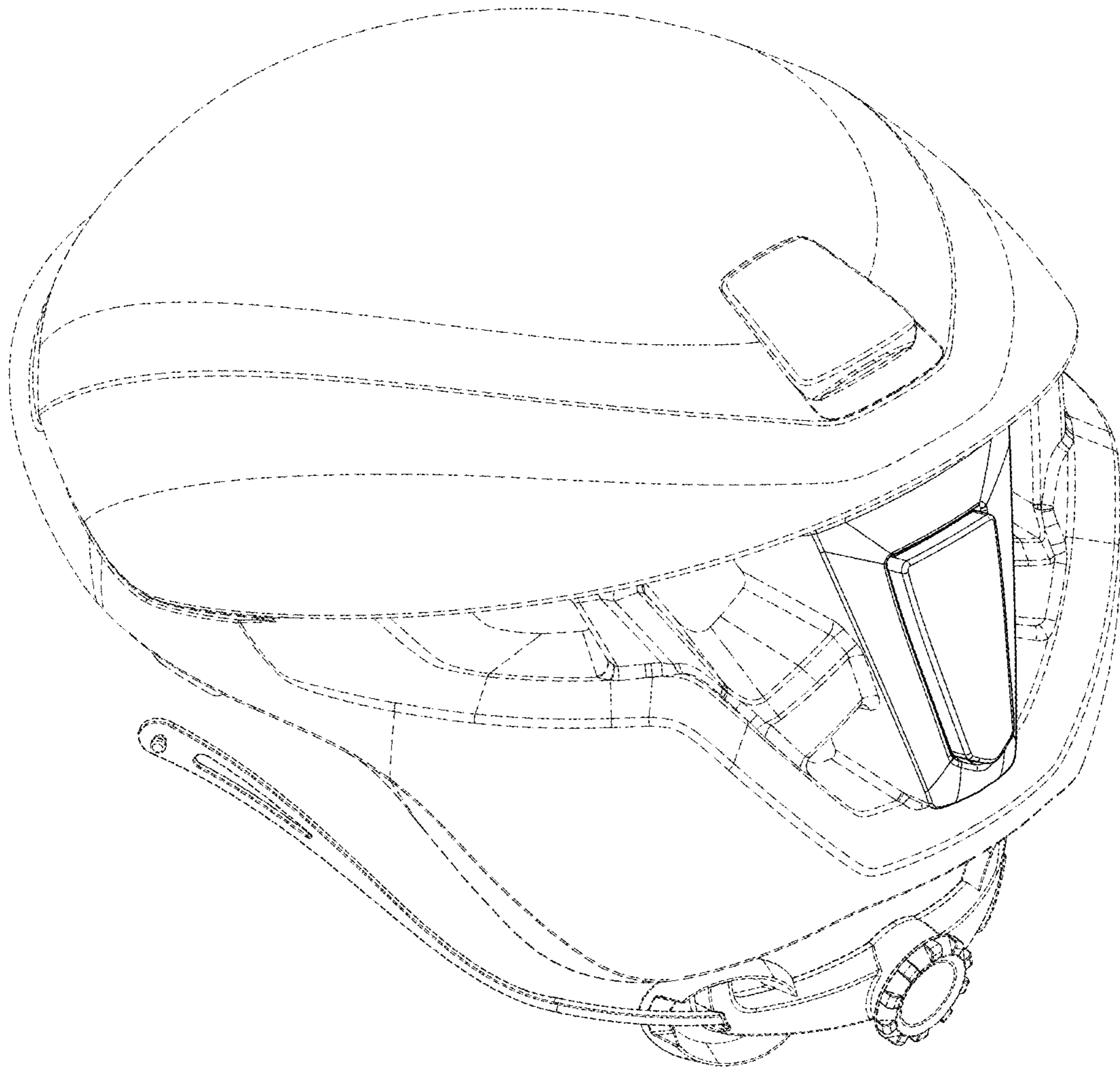

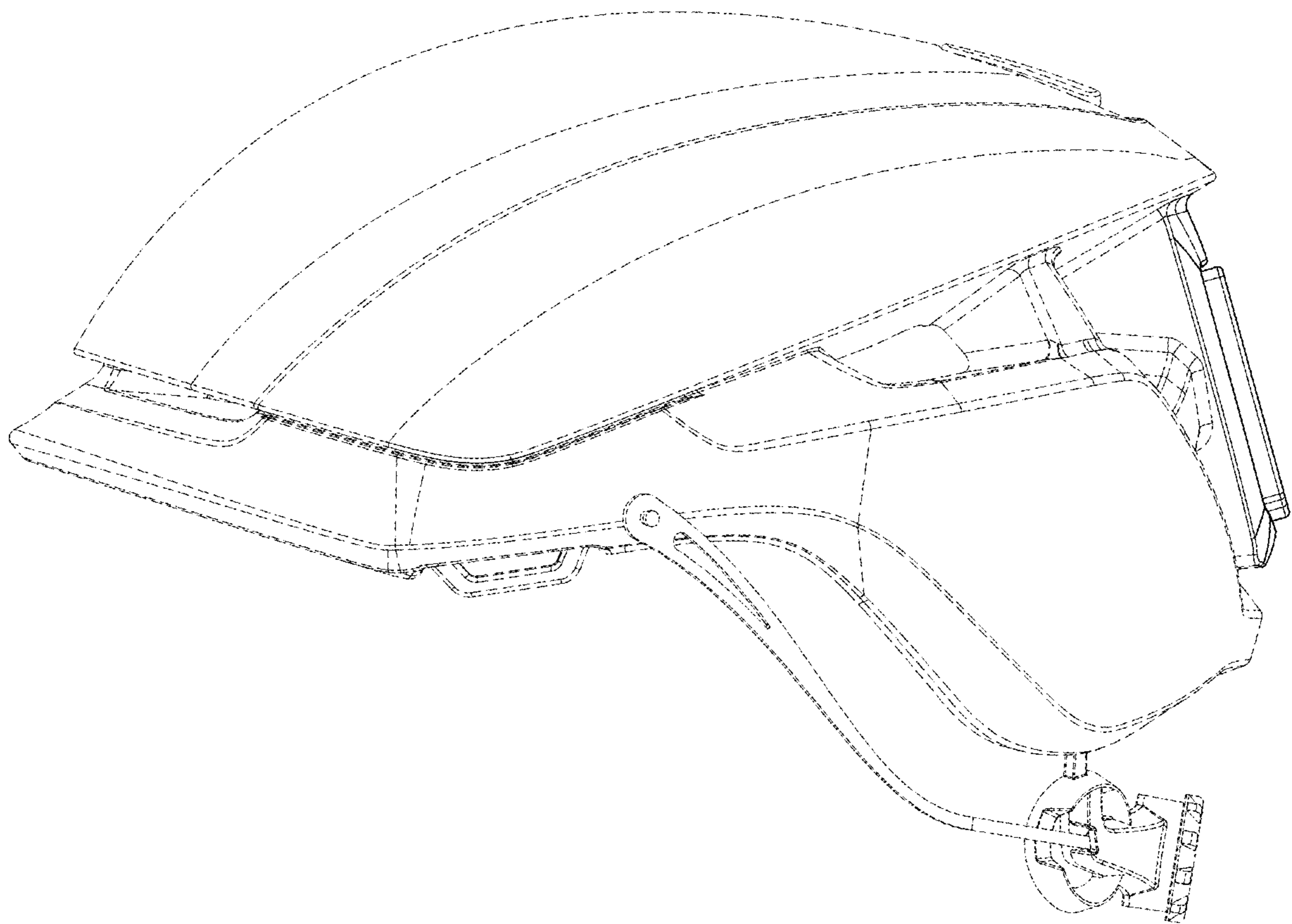

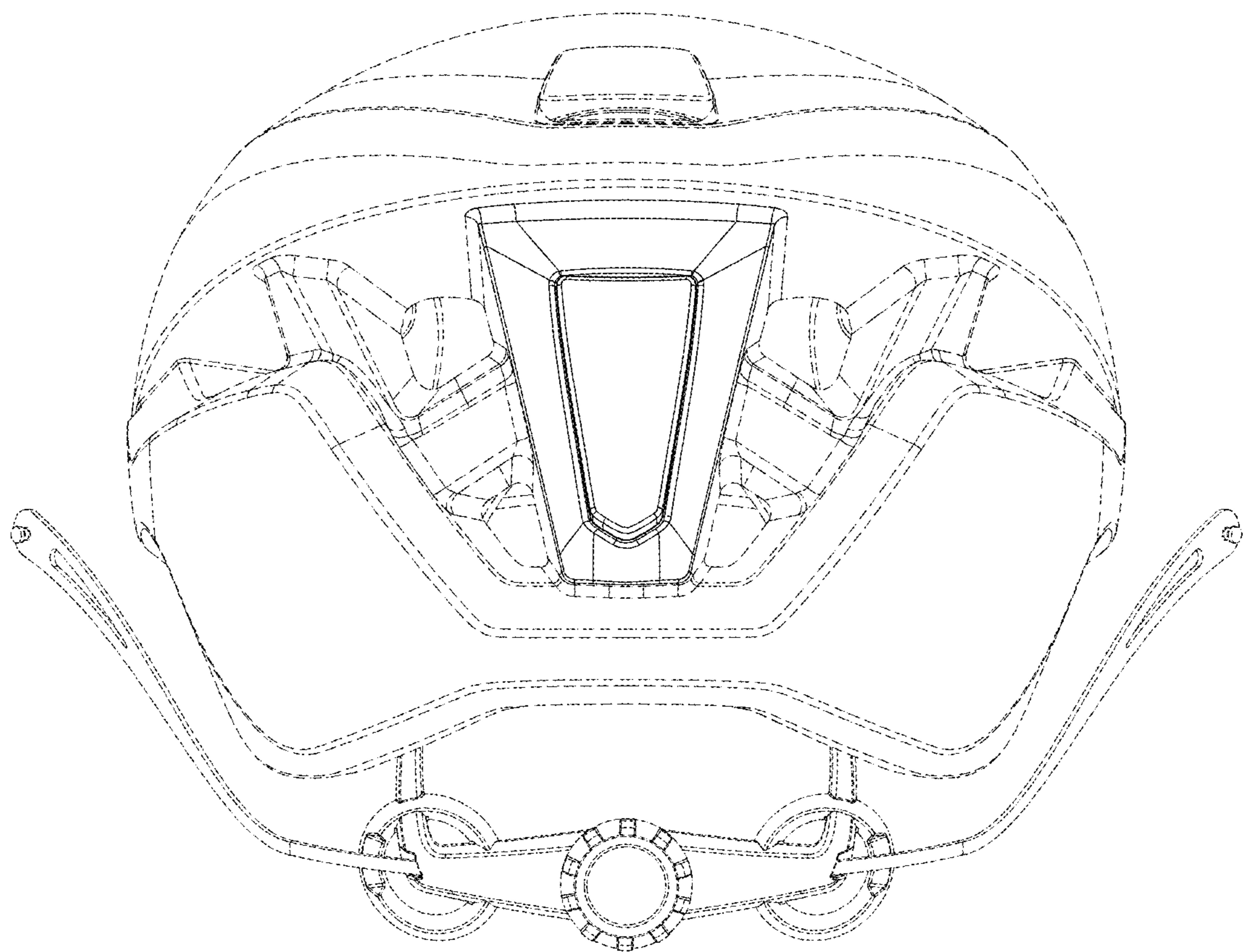

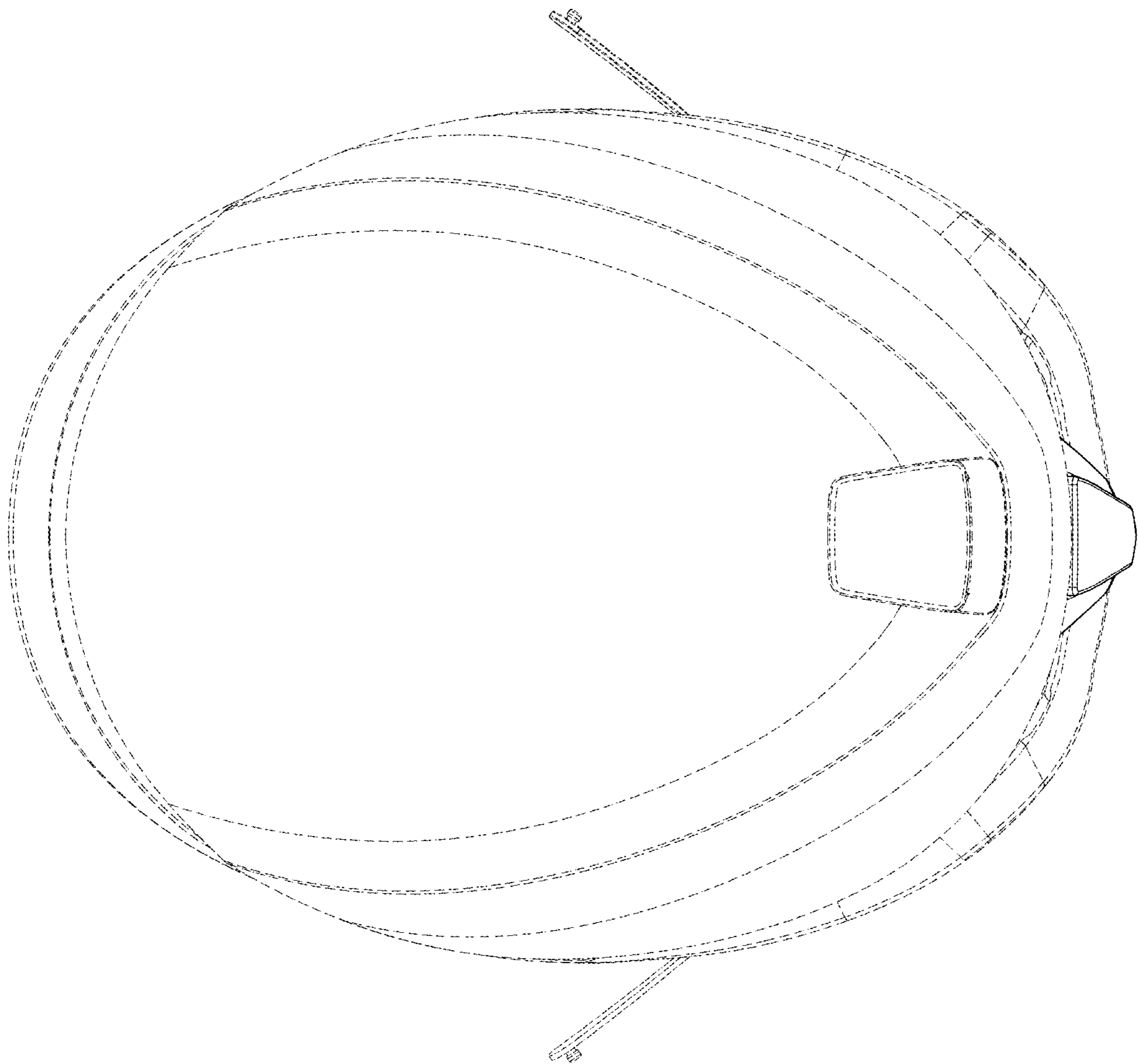

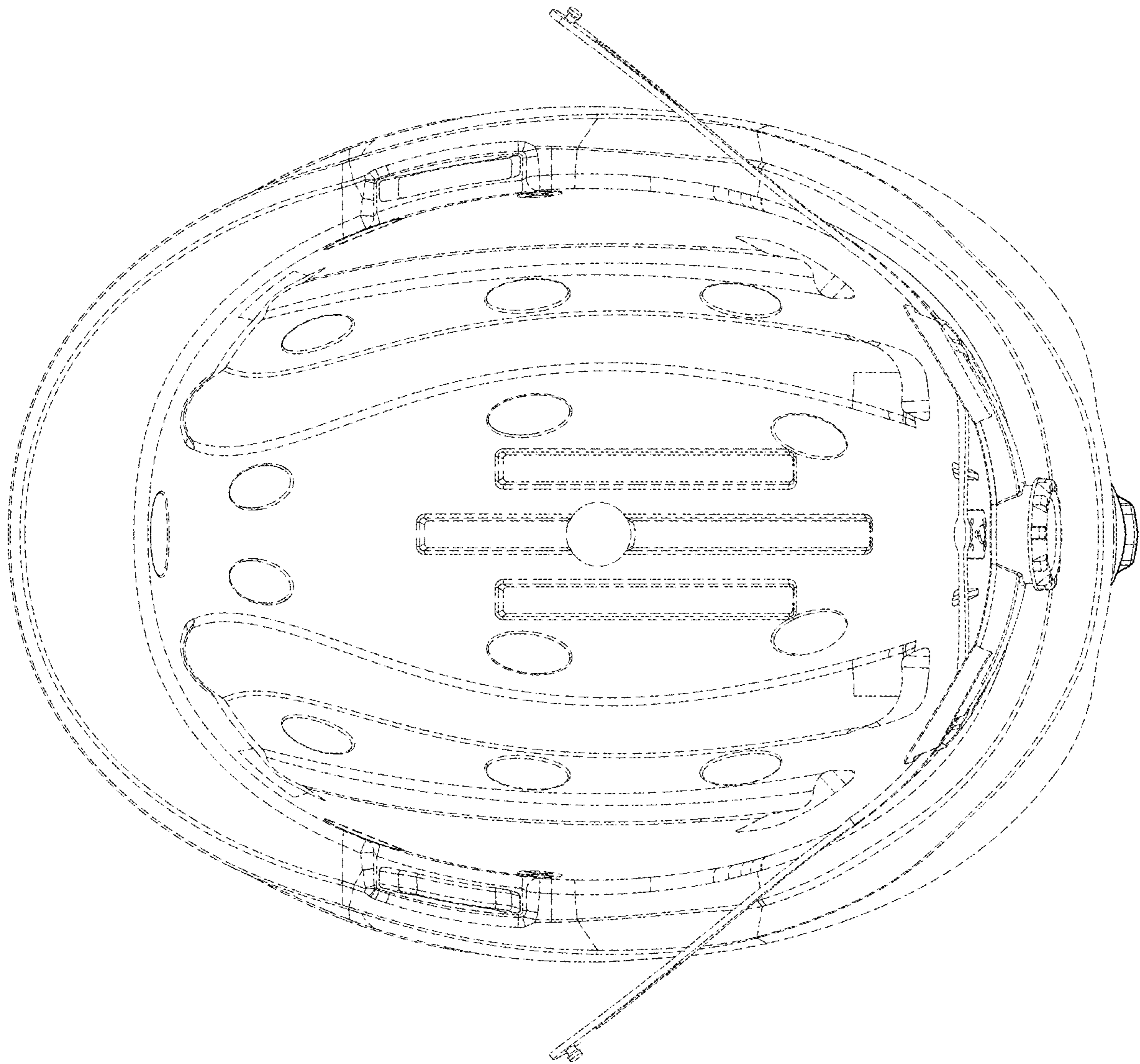
