DESCRIPTION

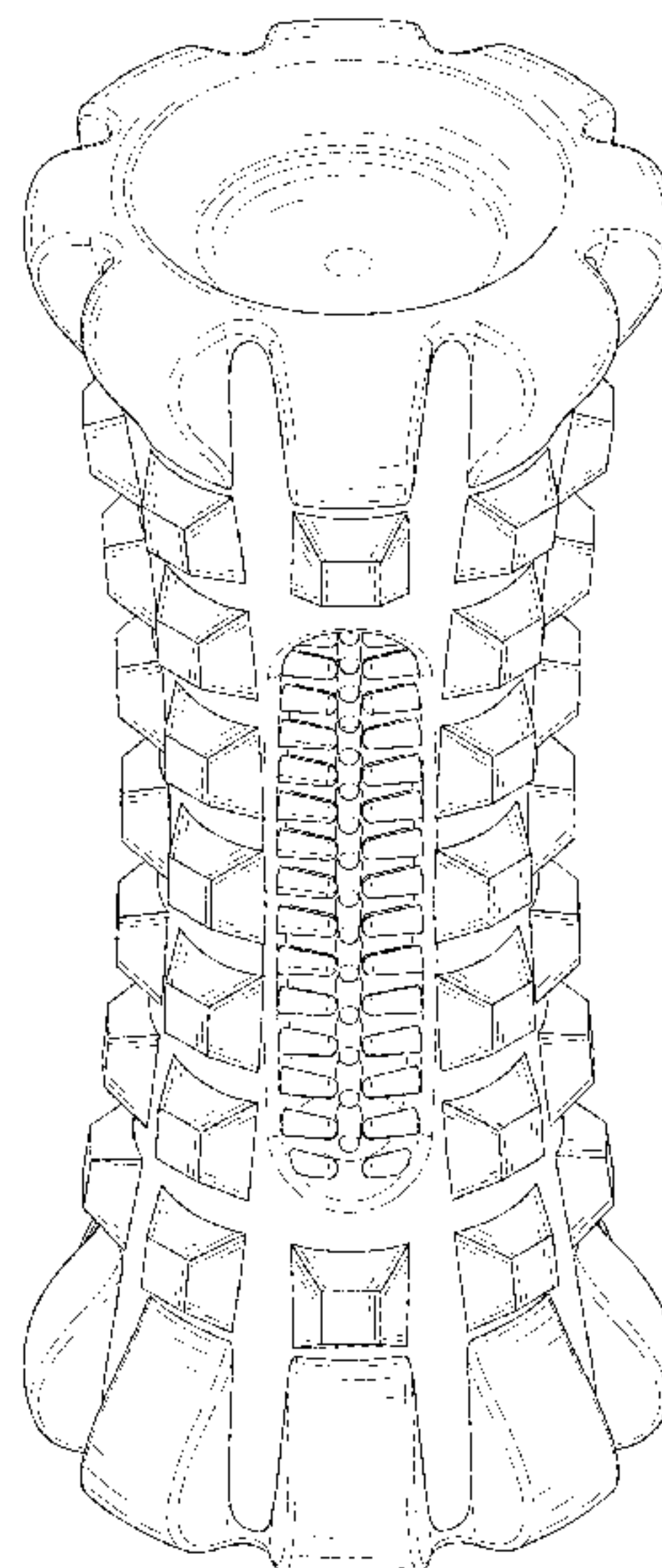
FIG. 1 is a front and top perspective view of a dog squeaky chew toy, showing my new design;

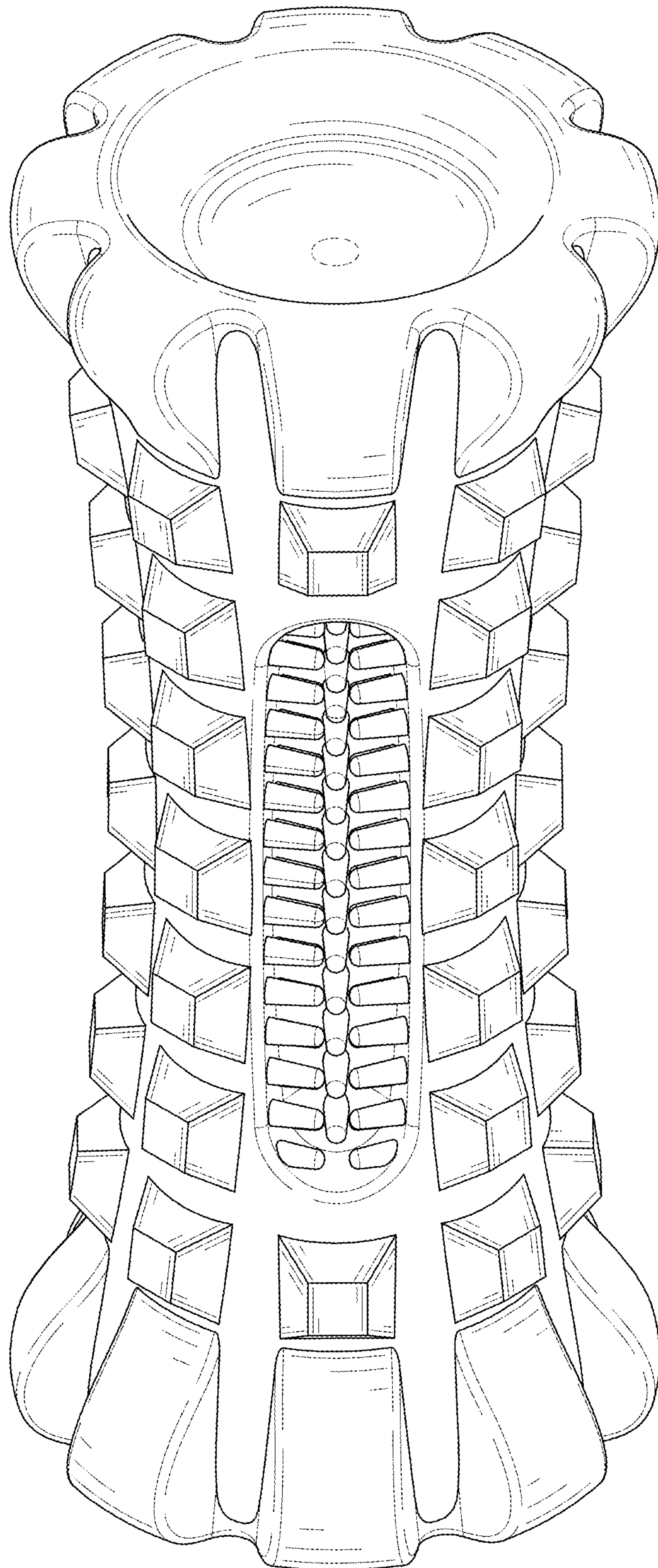

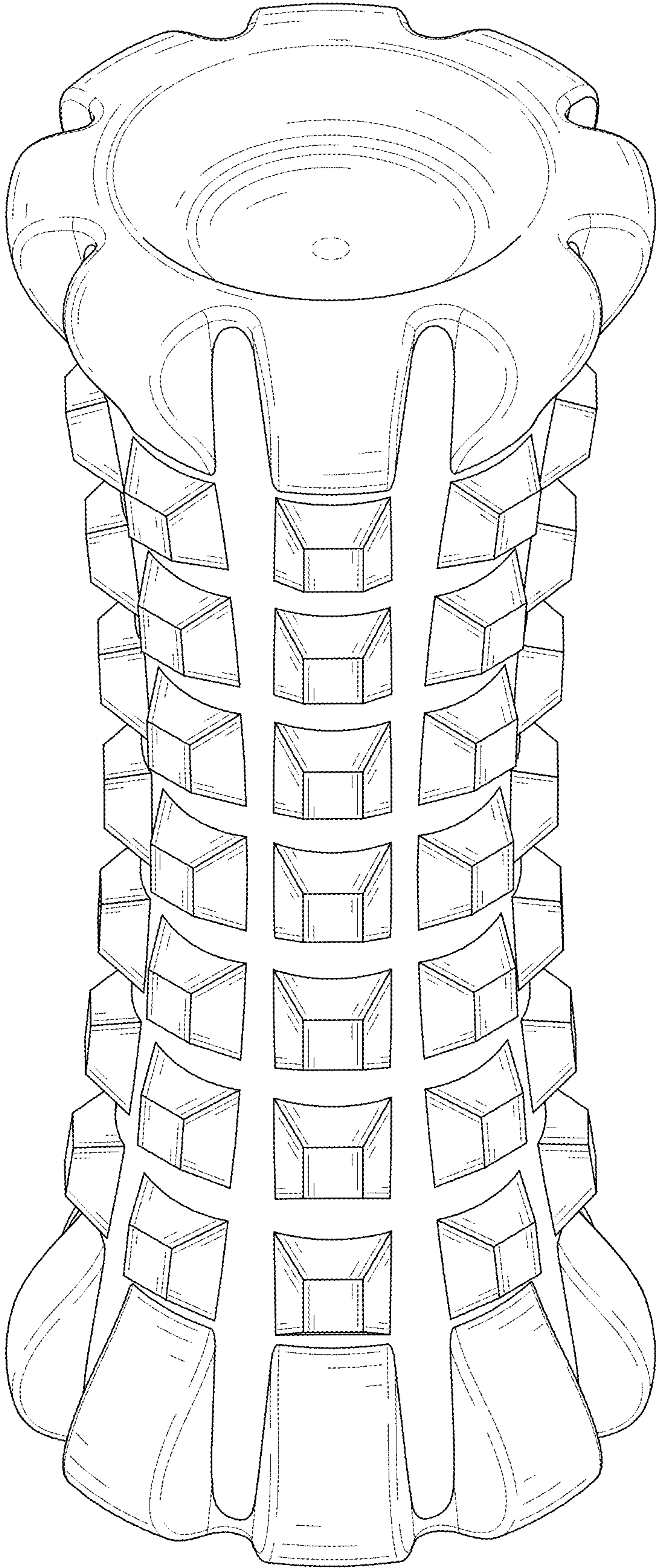

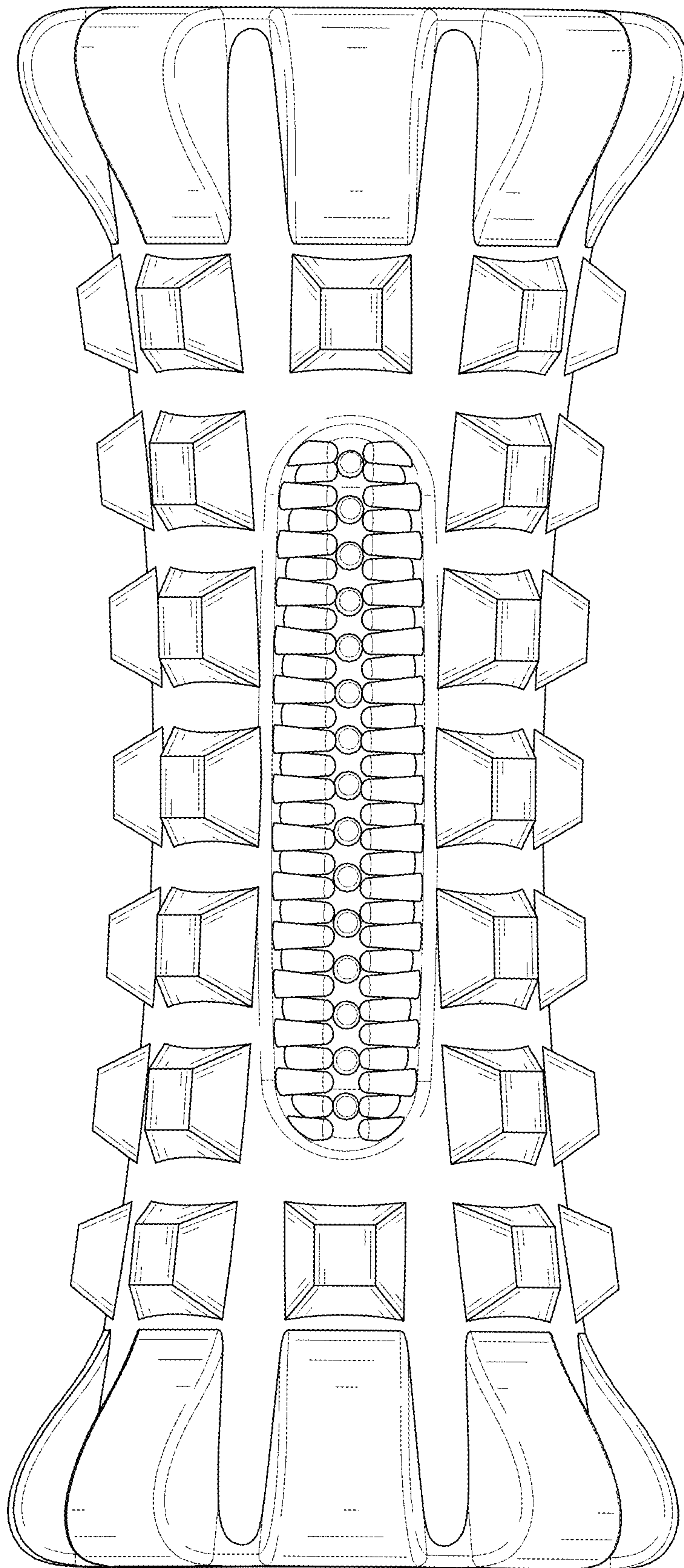

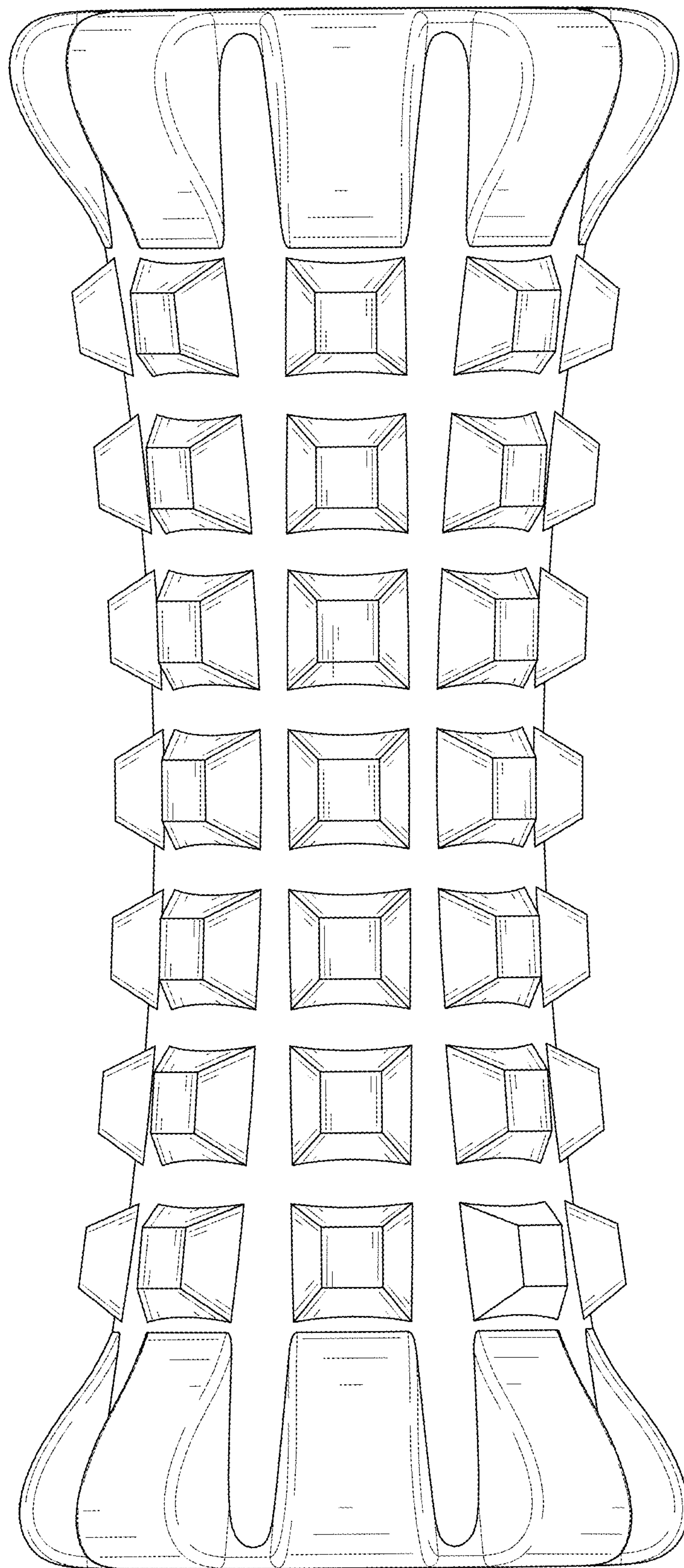

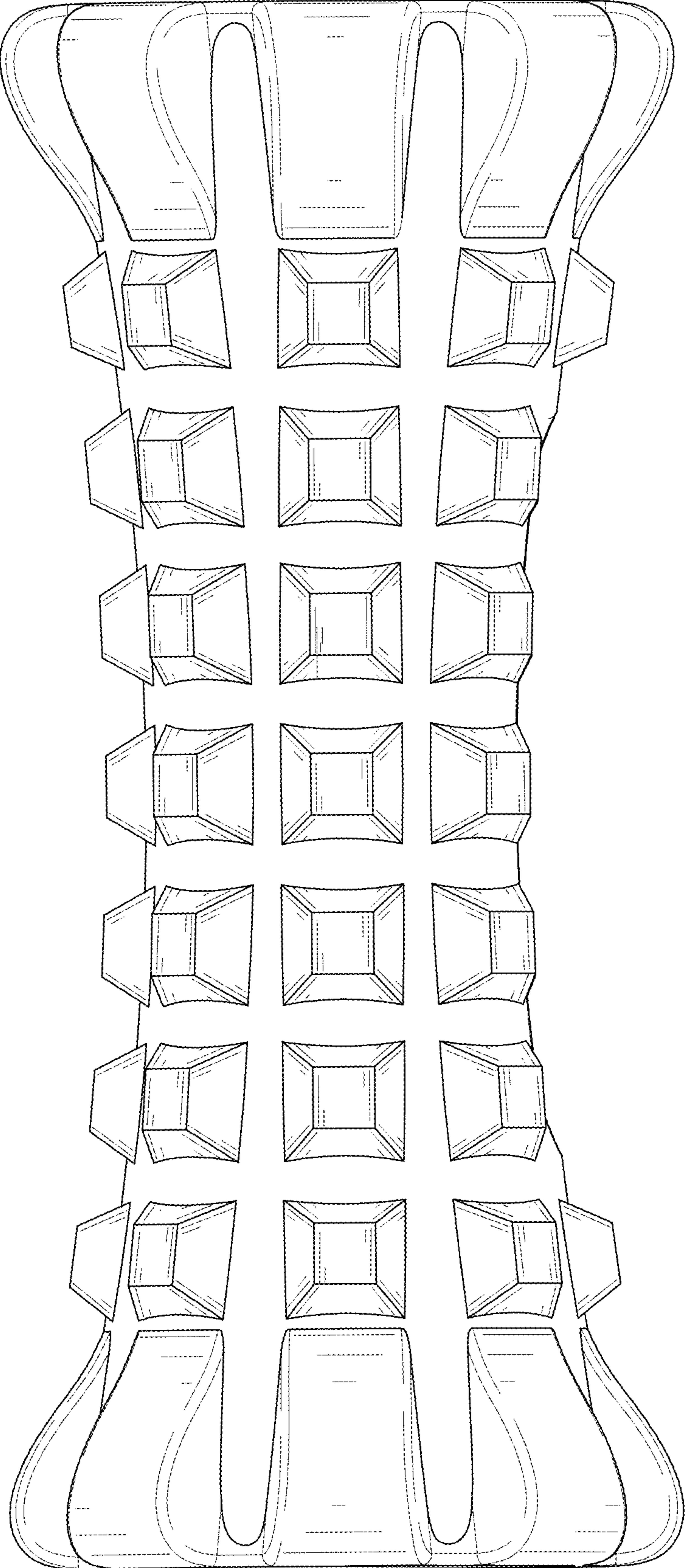

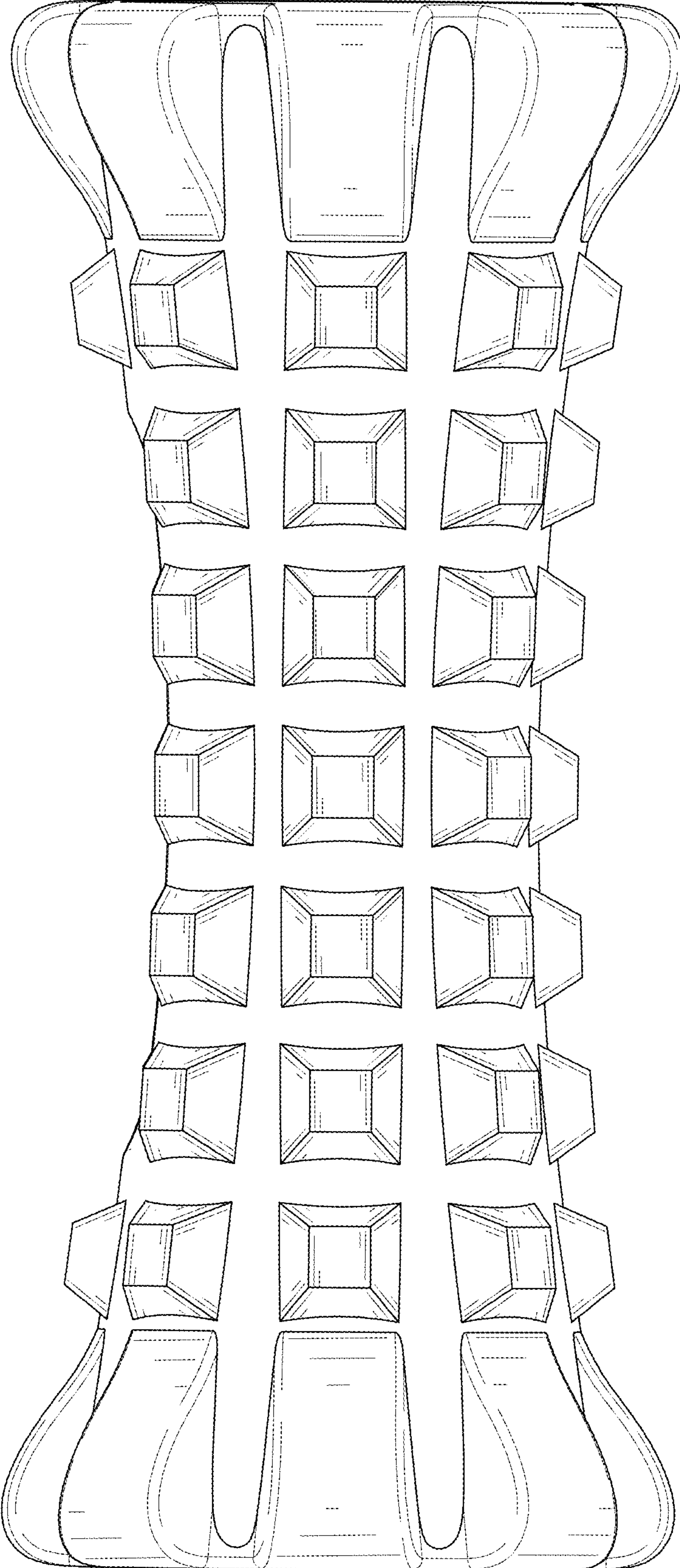

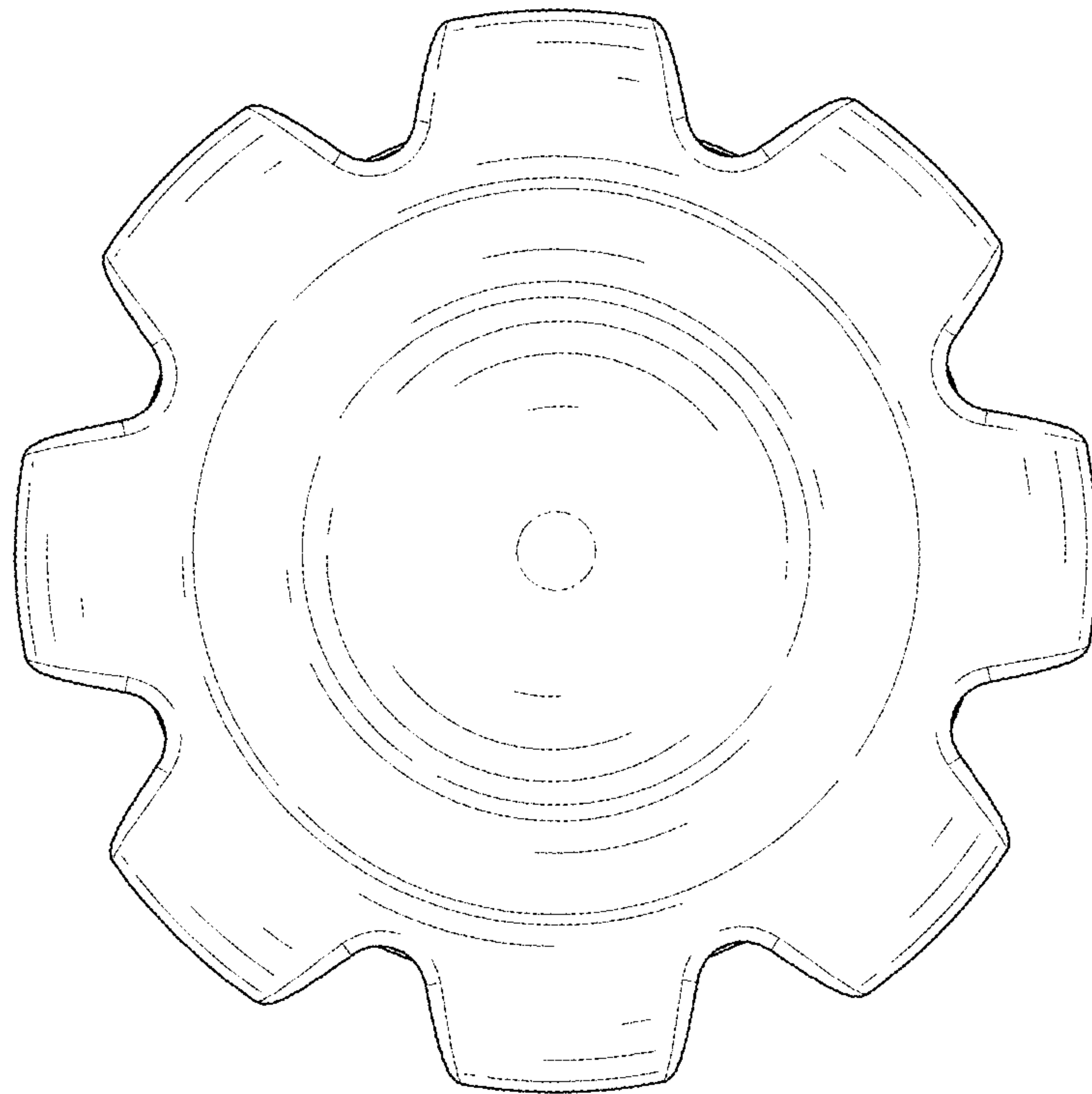

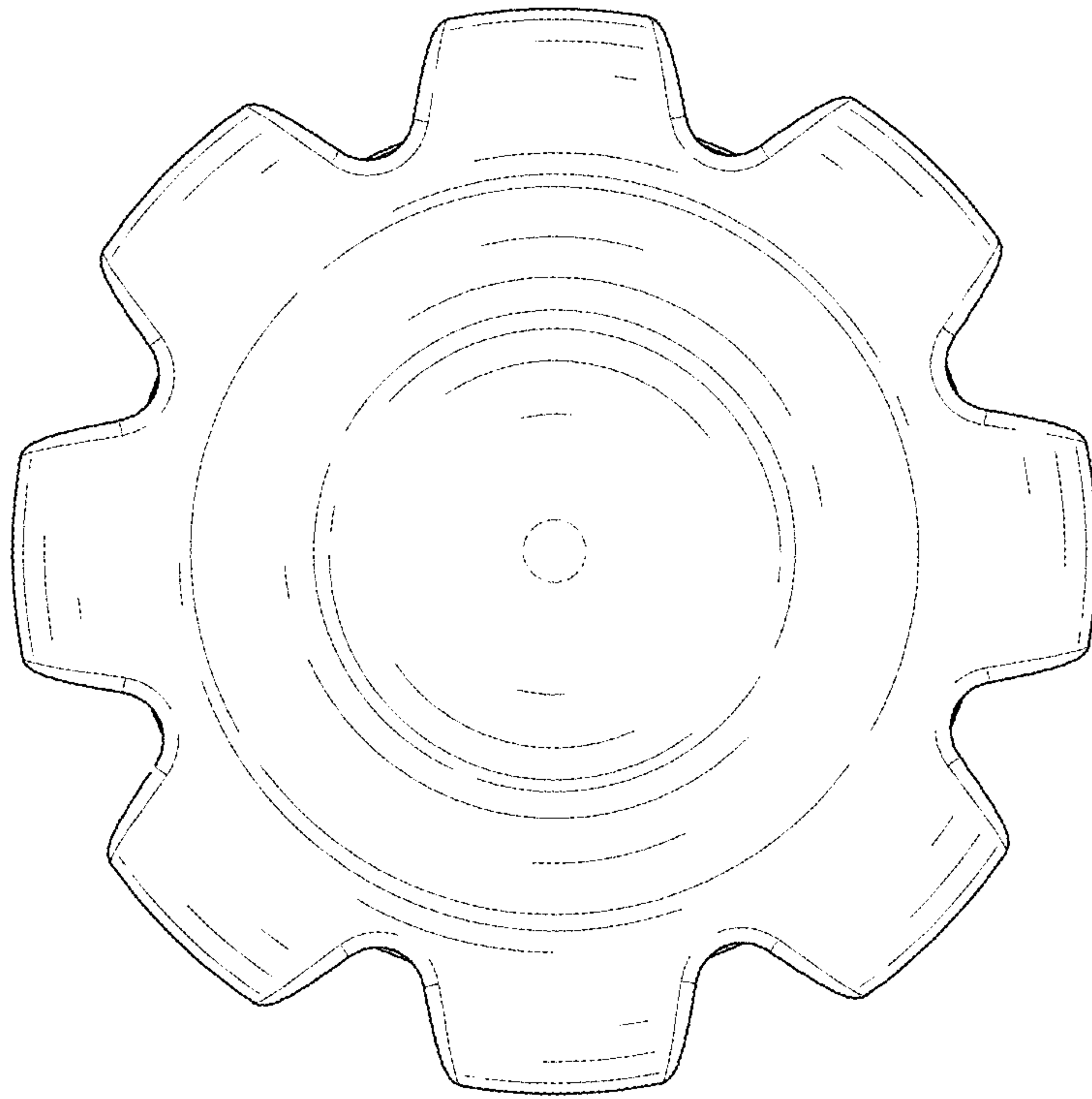
