DESCRIPTION

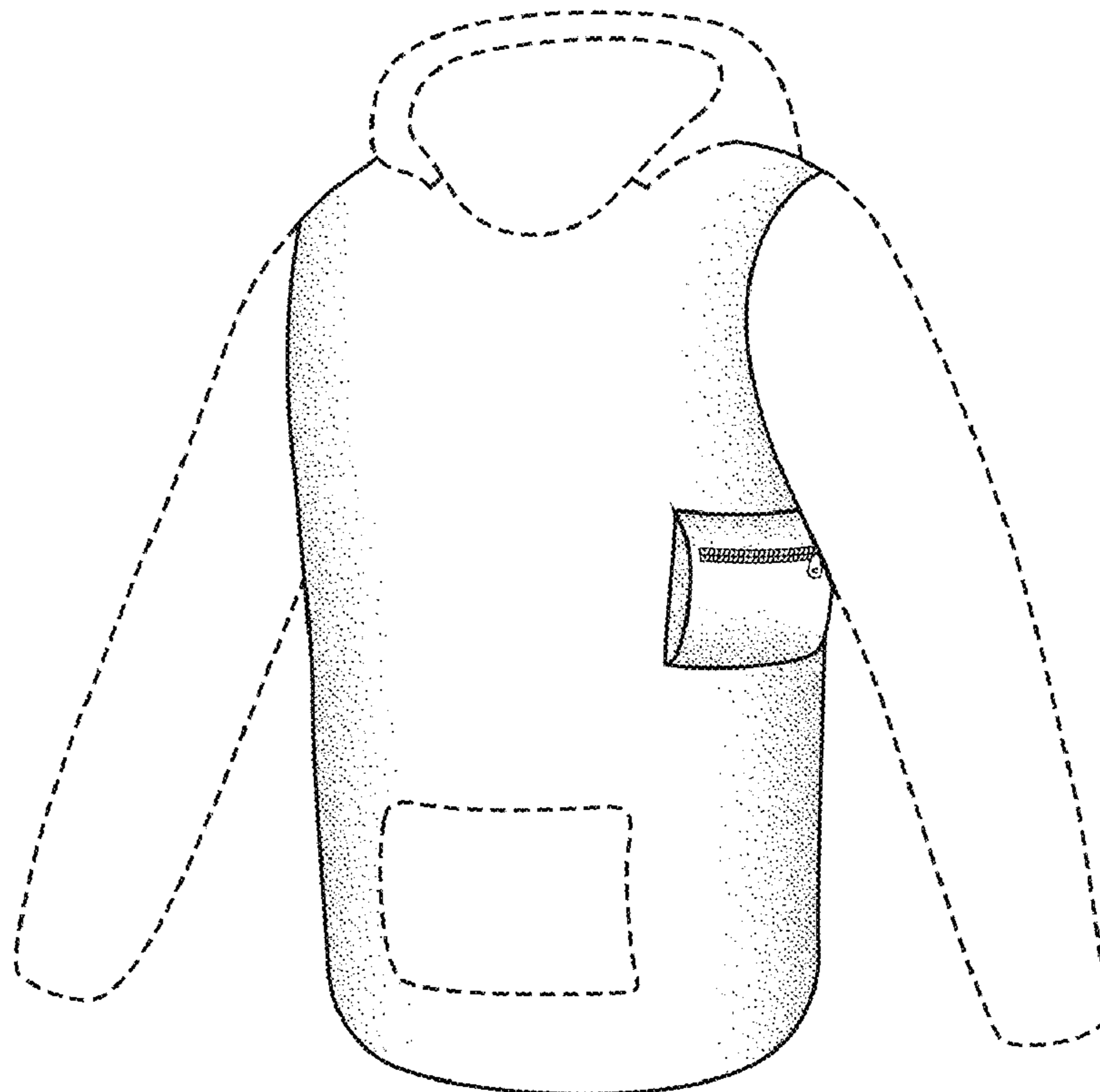
FIG. 1 is a front left perspective view of the garment with a side pocket, showing my new design;

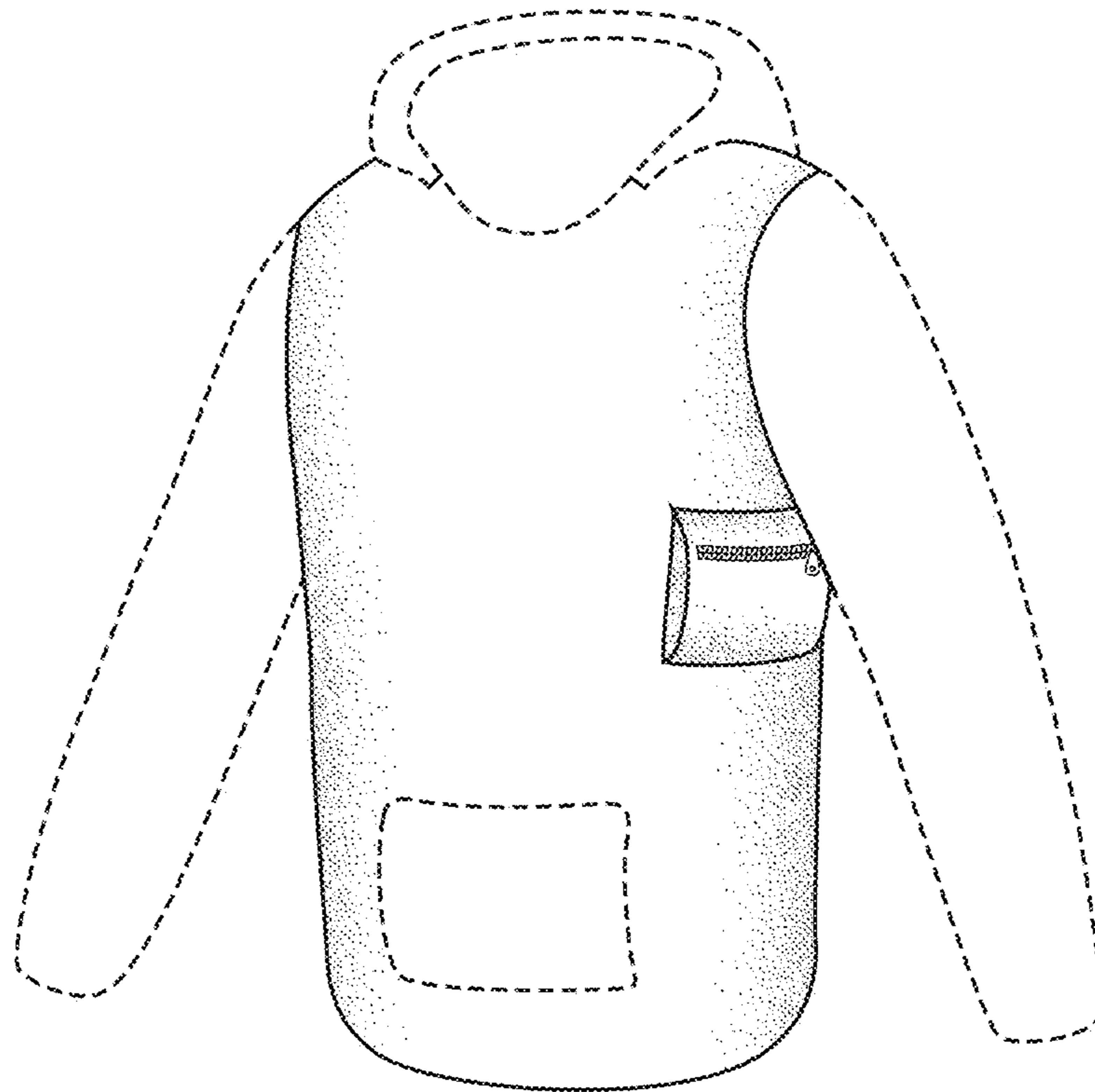

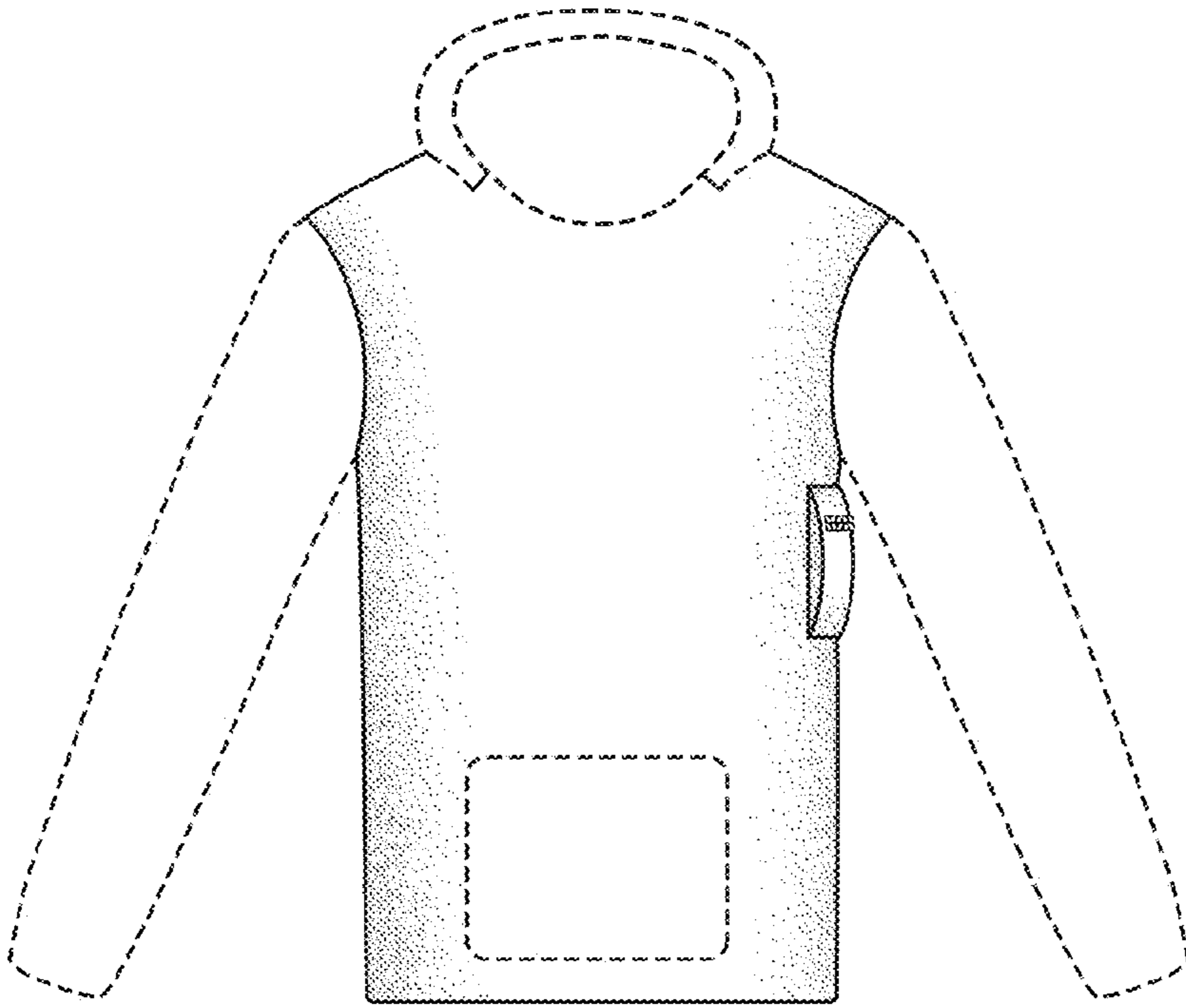

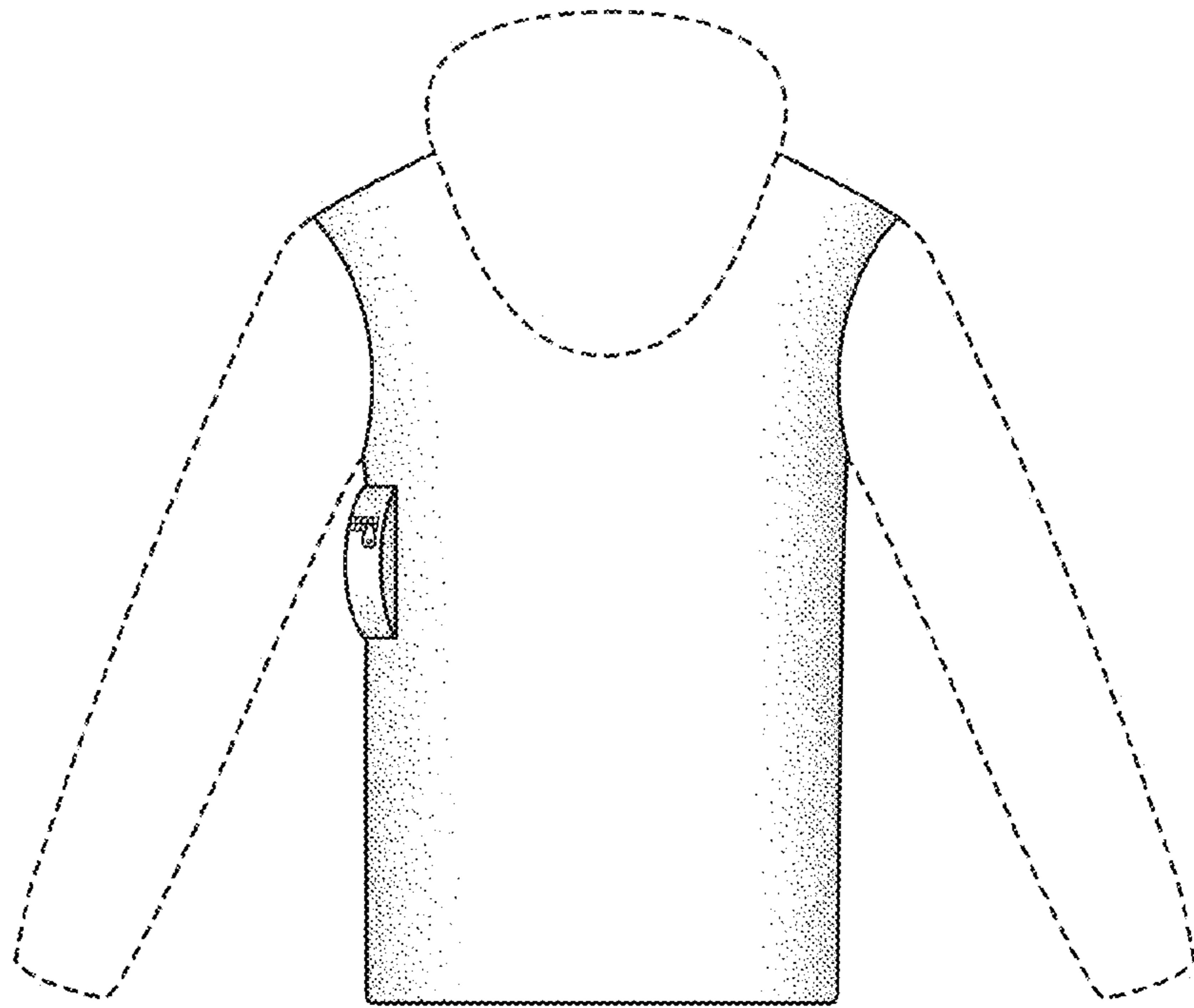

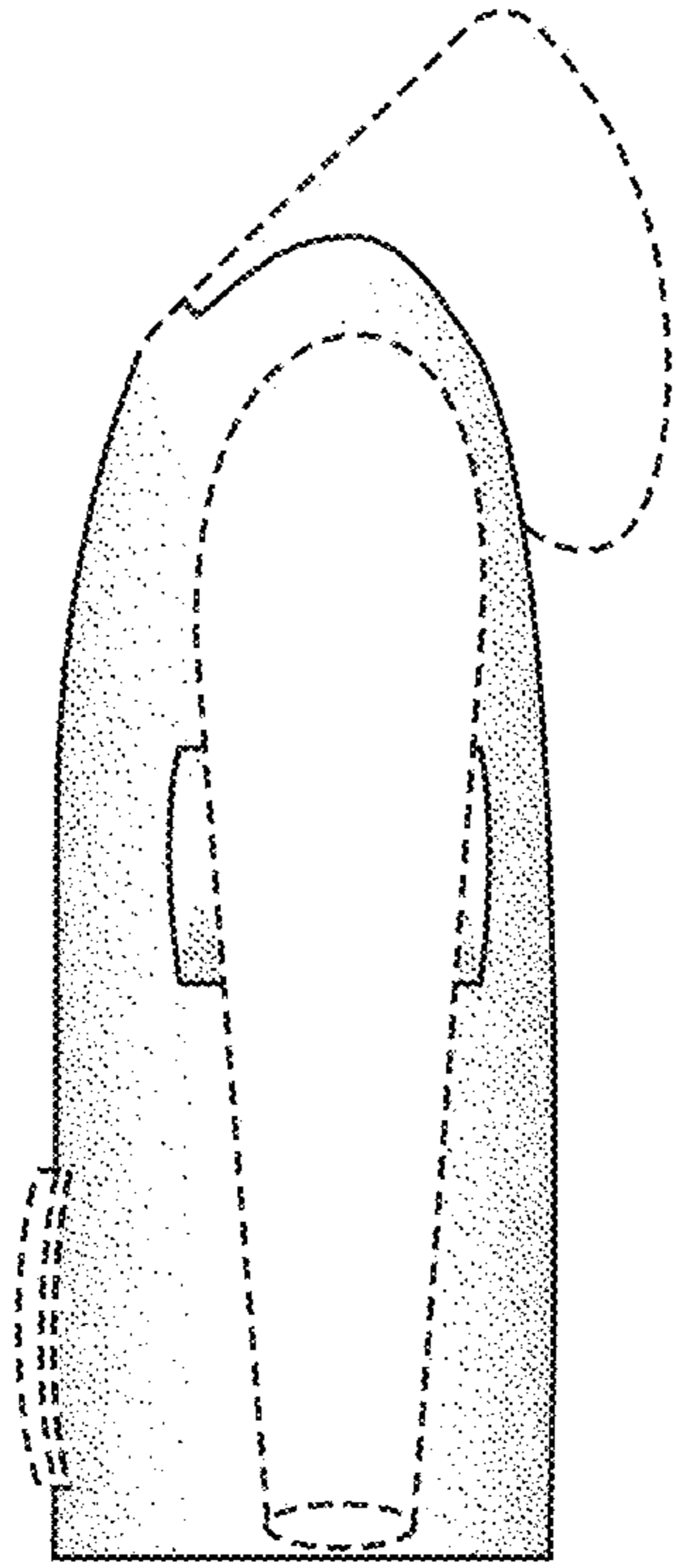

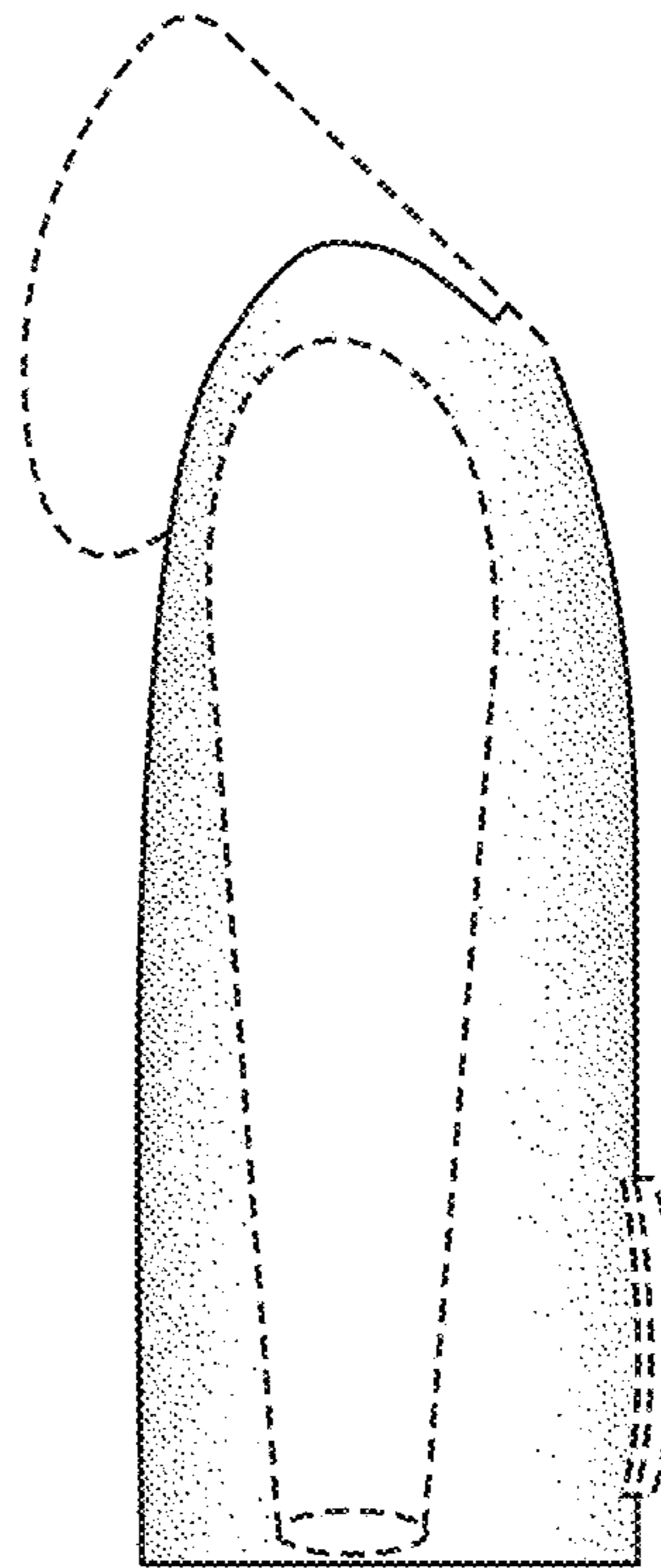

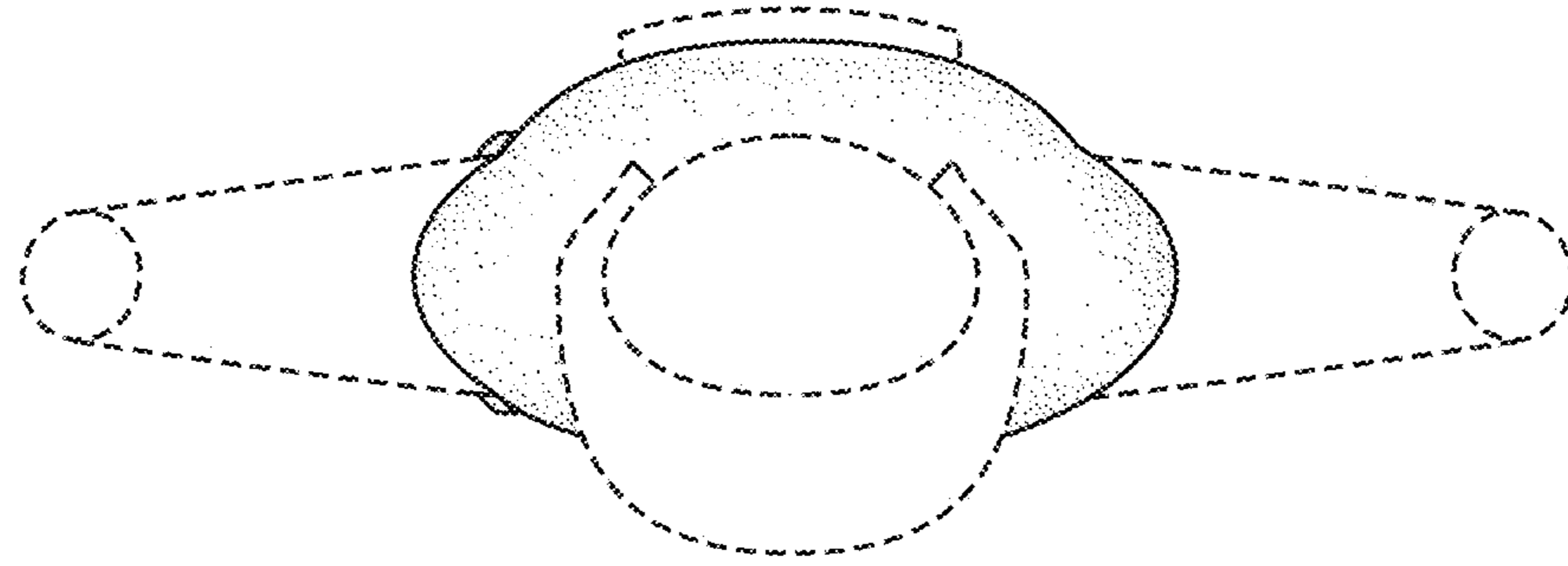

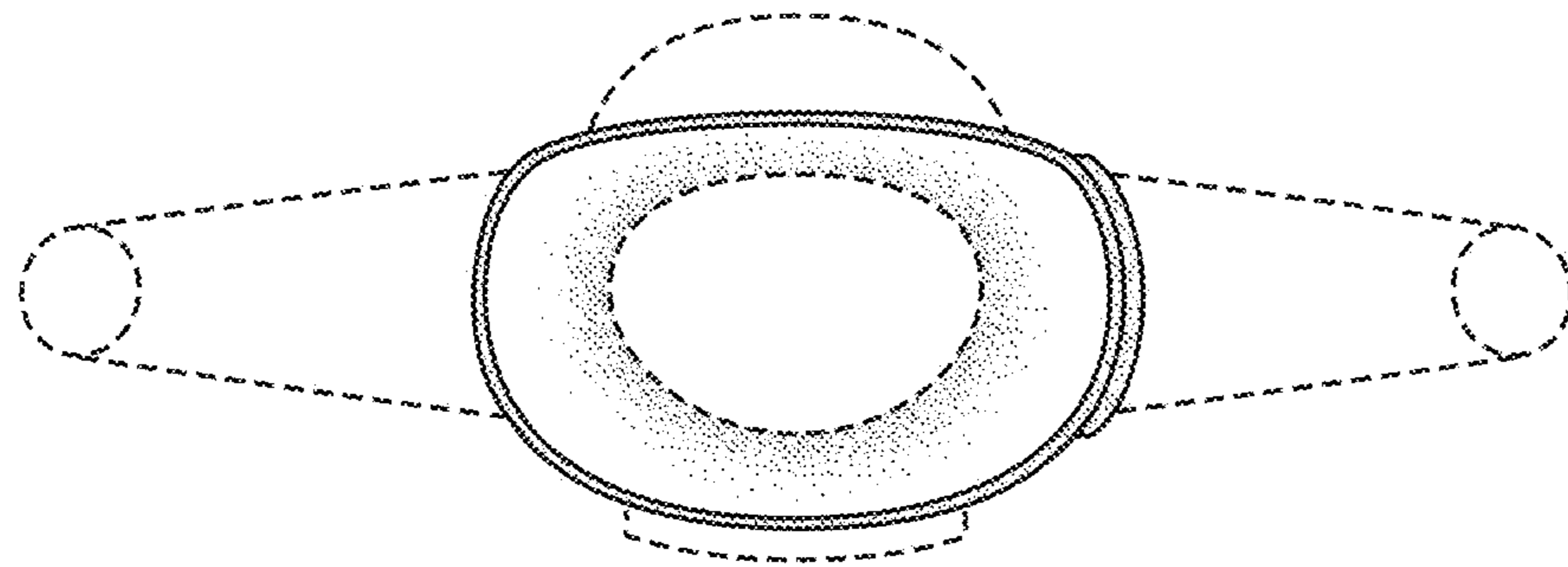
