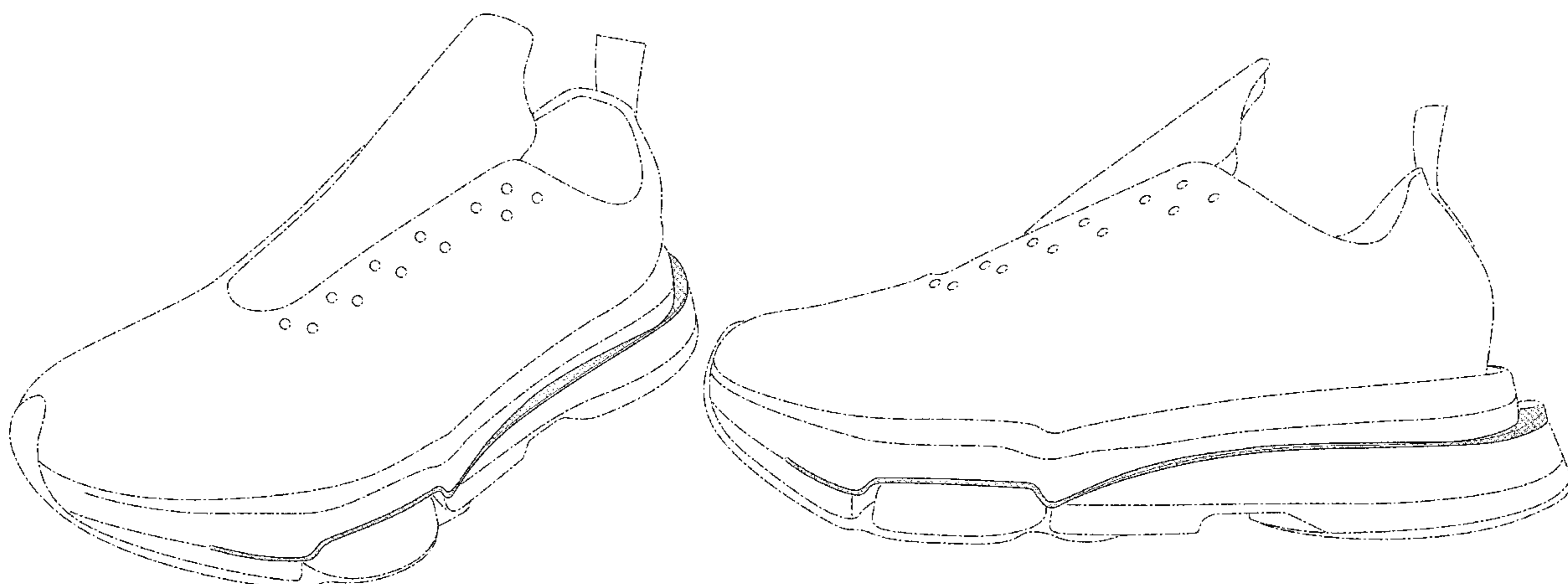
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing our new design;  
FIG. 2 is a side view thereof; and,  
FIG. 3 is a rear perspective view thereof.  
The broken lines immediately adjacent to the front and rear ends of the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

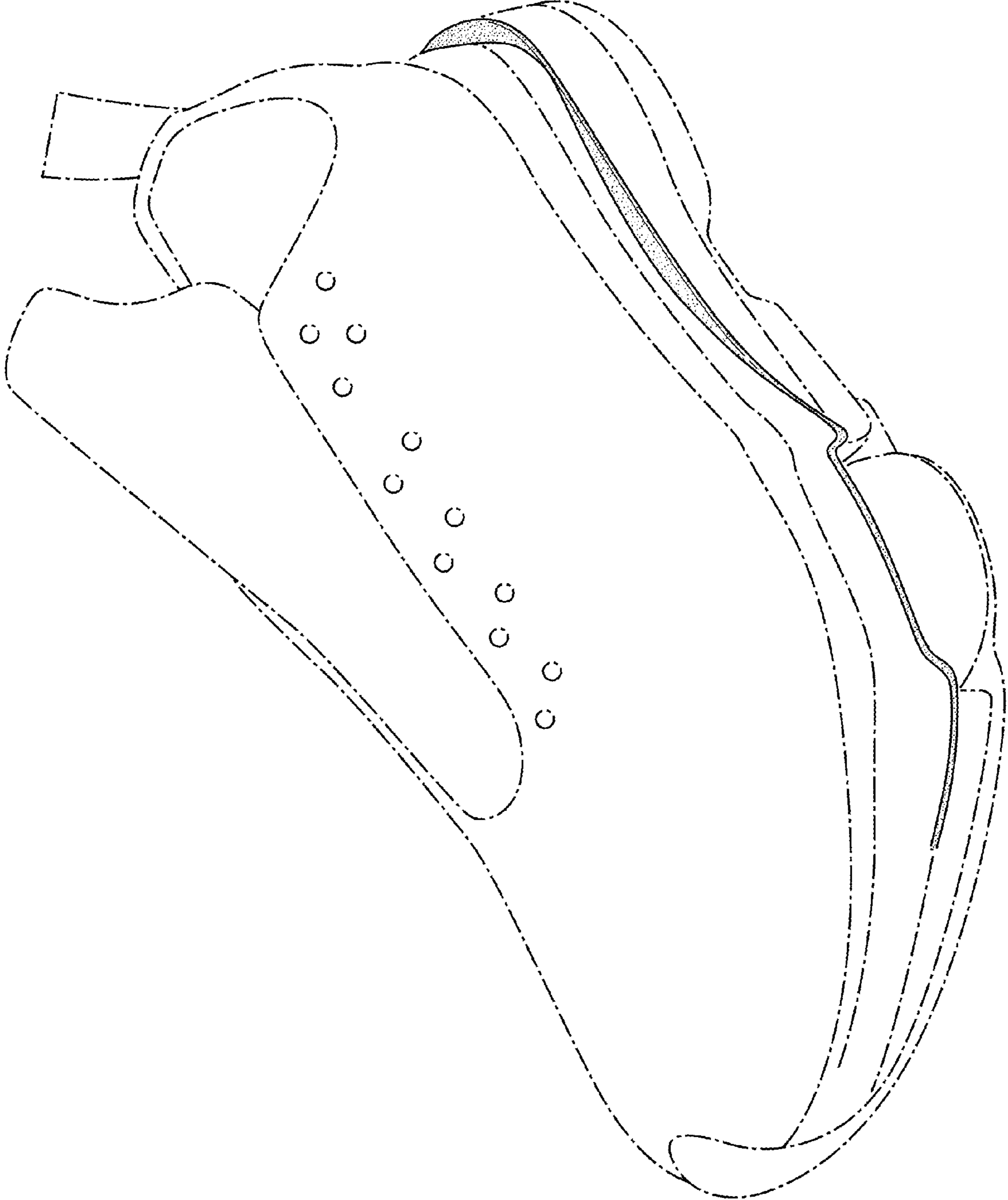

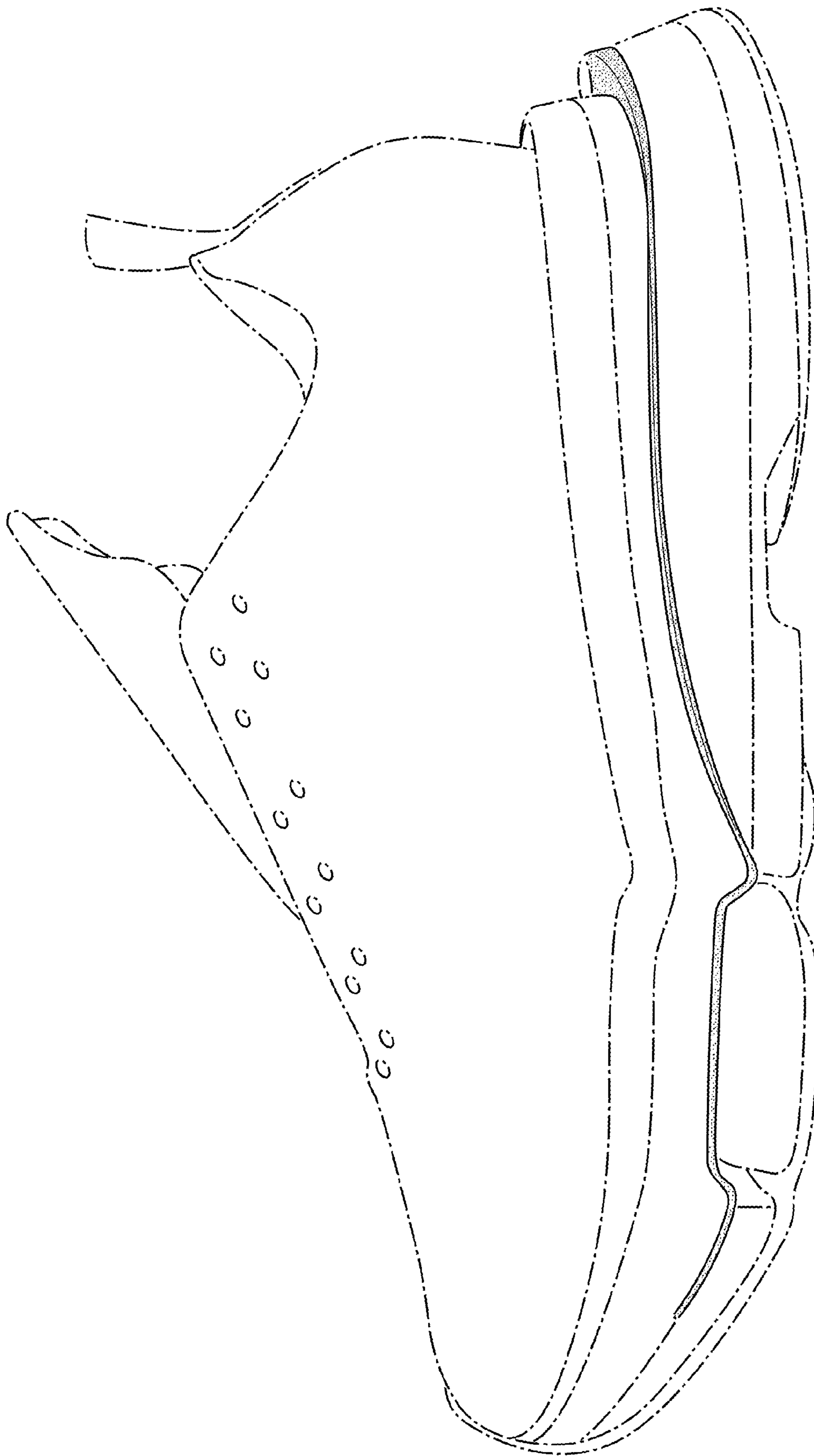

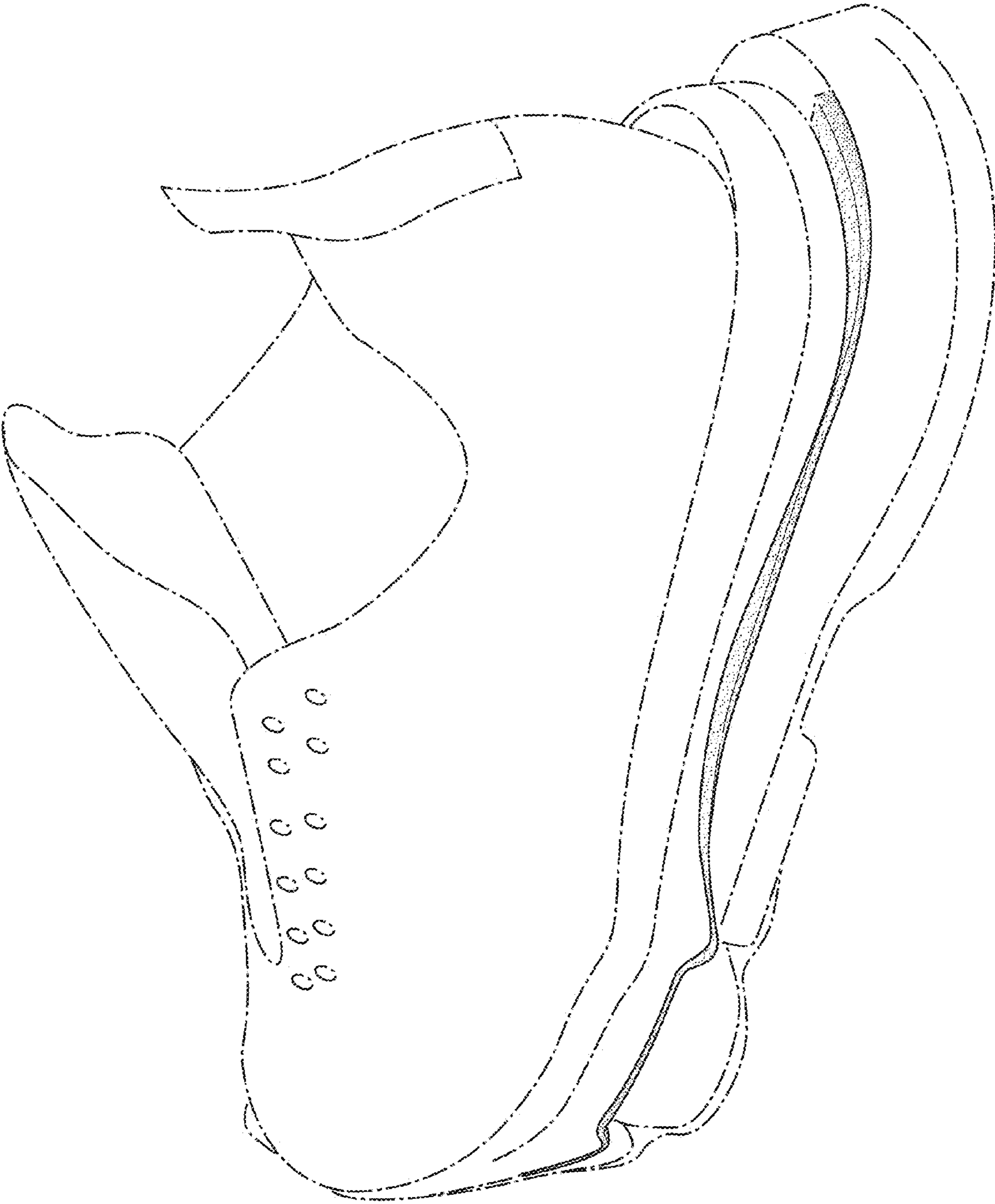
