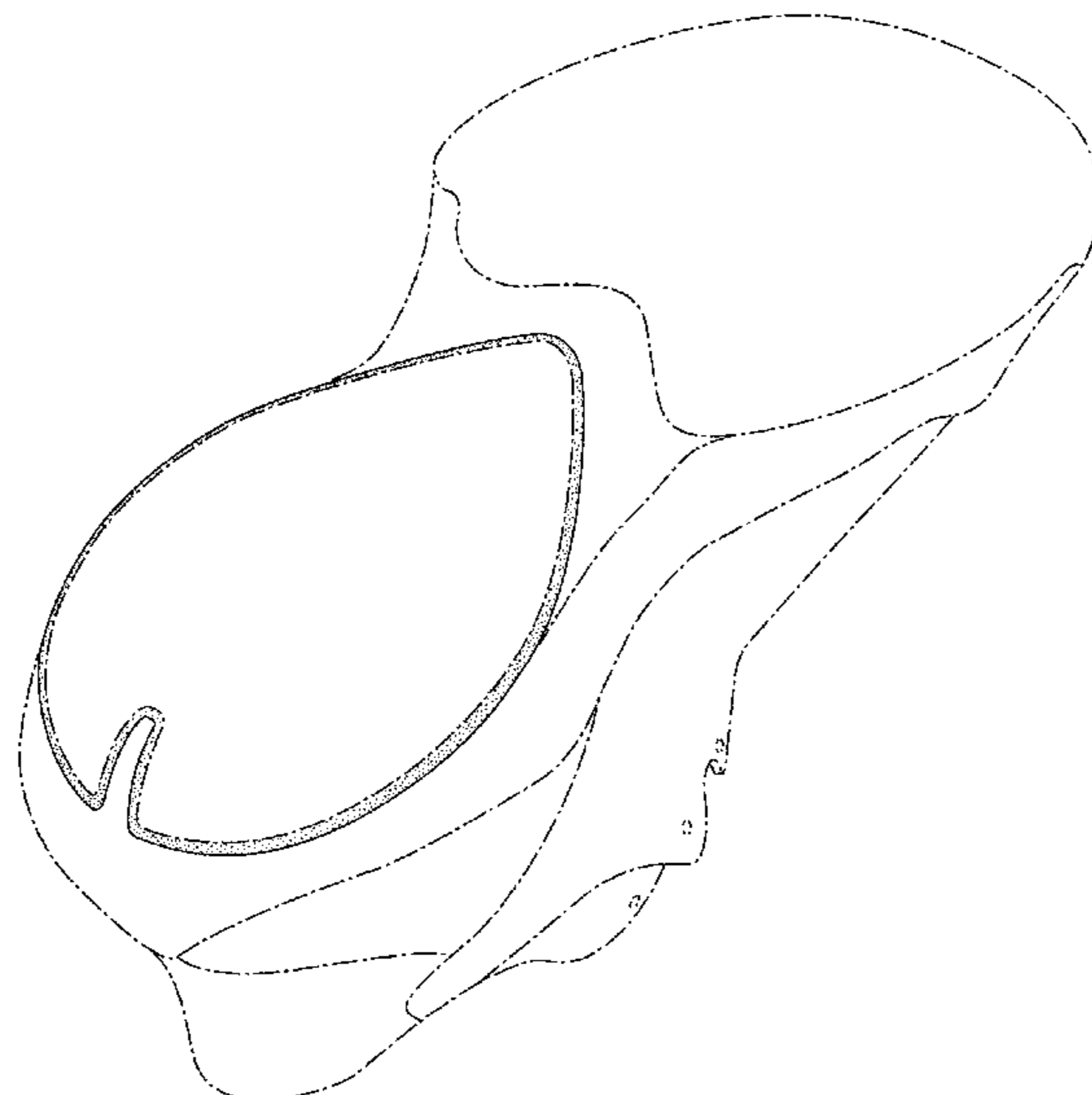
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a rear bottom perspective view of a shoe showing our new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a front bottom perspective view thereof.
The broken line immediately adjacent to the internal perimeter of the shaded area defines the bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

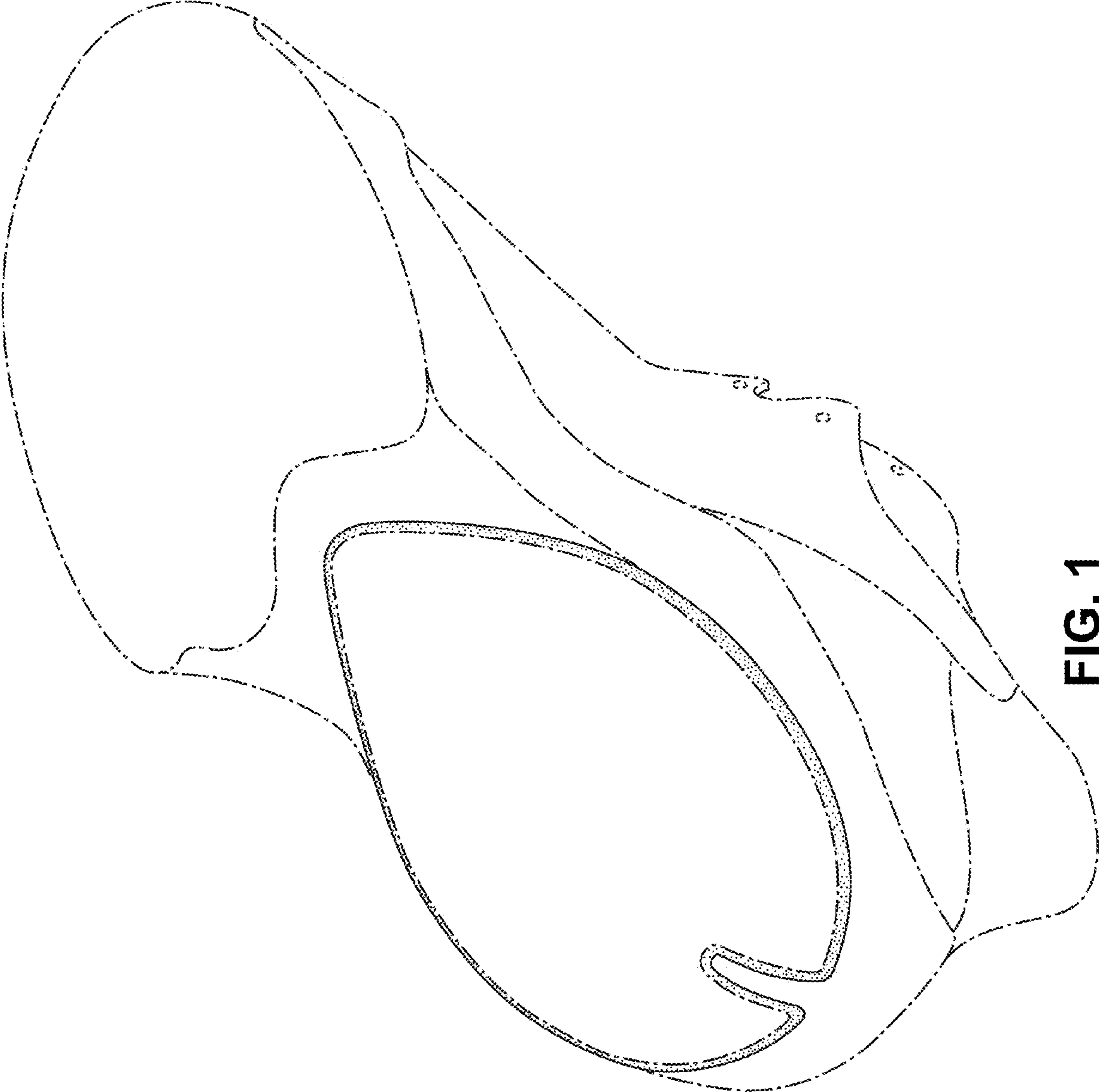

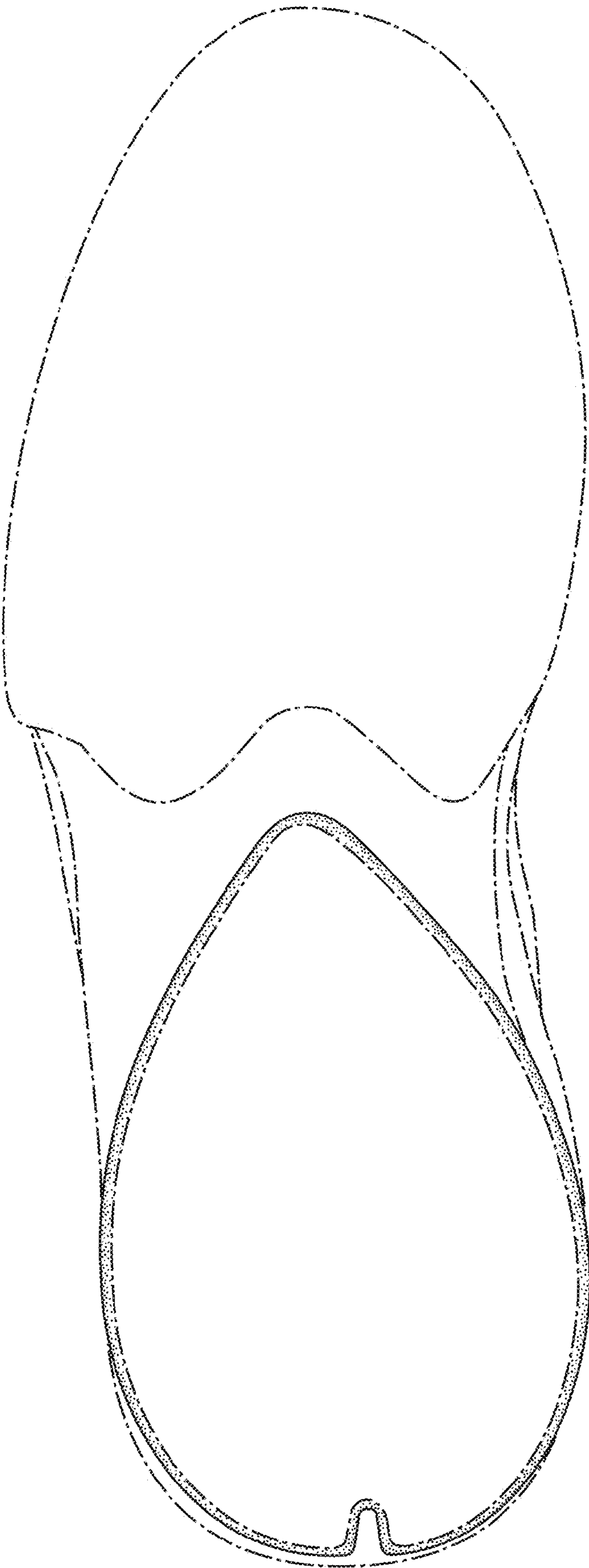

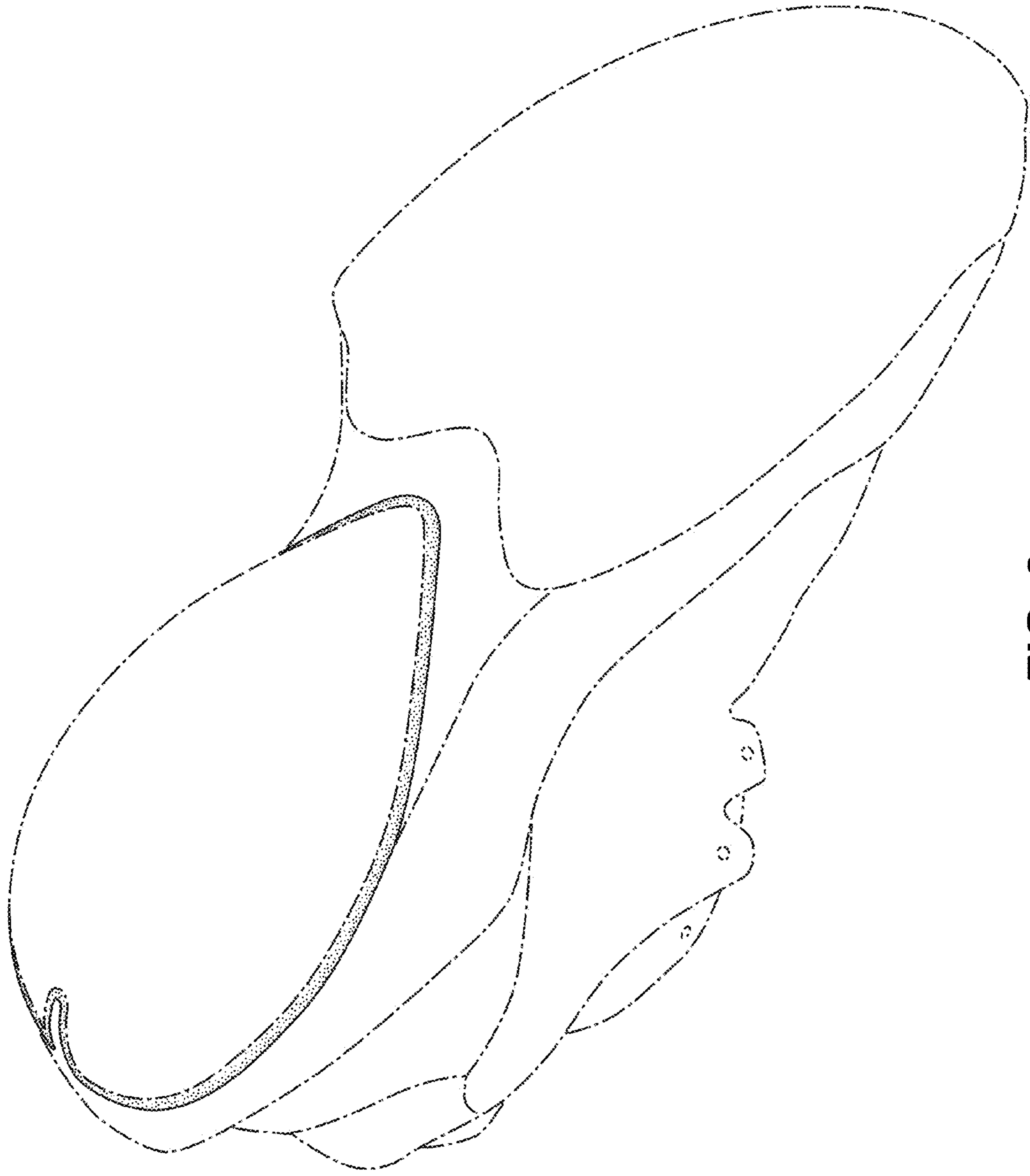
