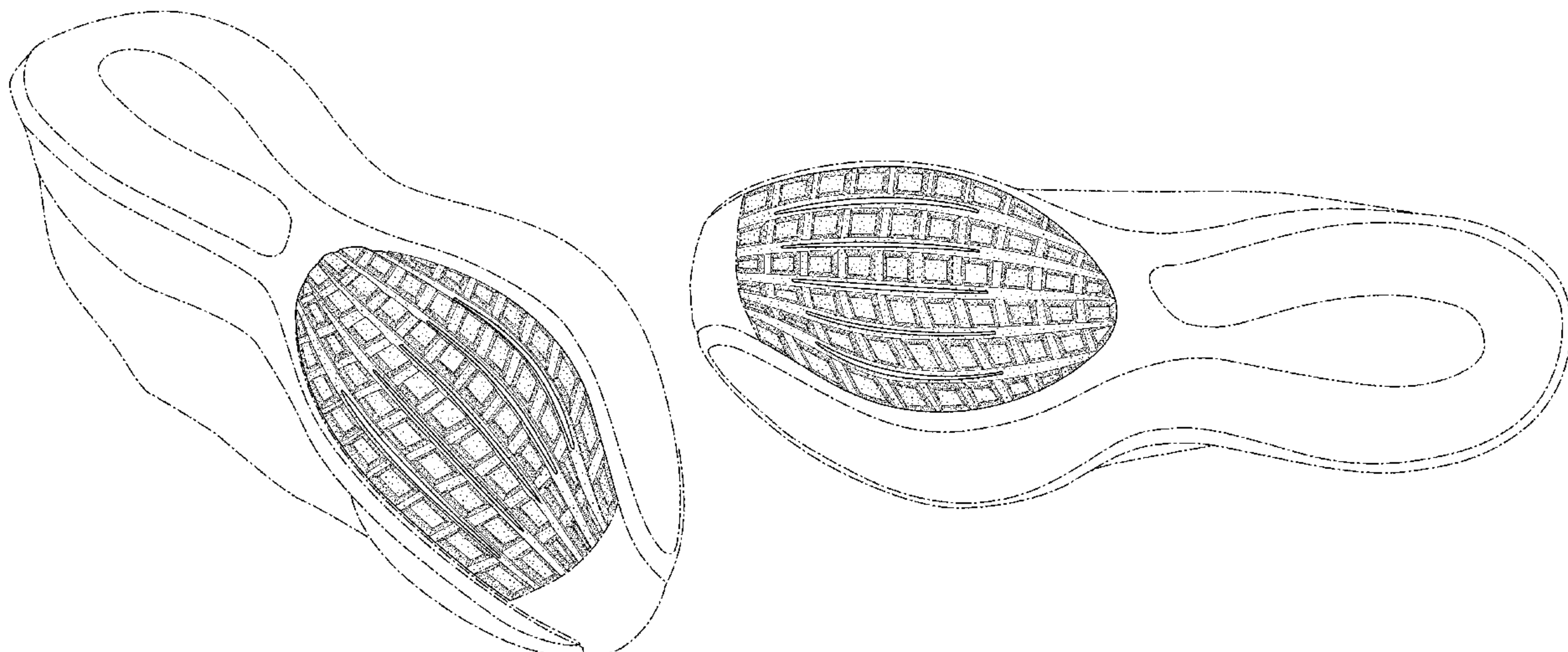
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front bottom perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a rear bottom perspective view thereof.
The broken line immediately adjacent to the front-most end of the shaded area defines the bounds of the claimed design and forms no part thereof. The five unshaded oblong regions within the solid line area forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

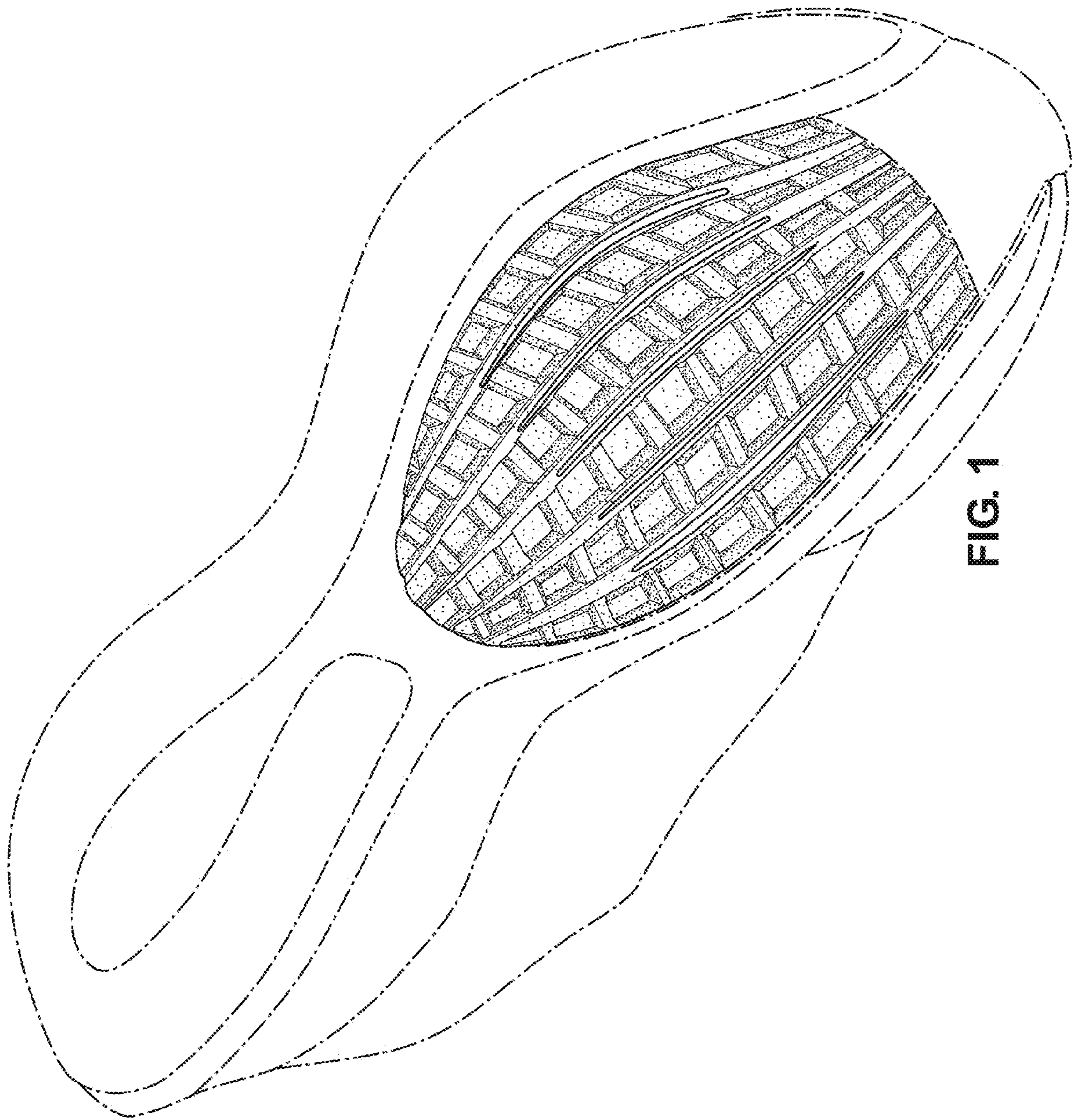

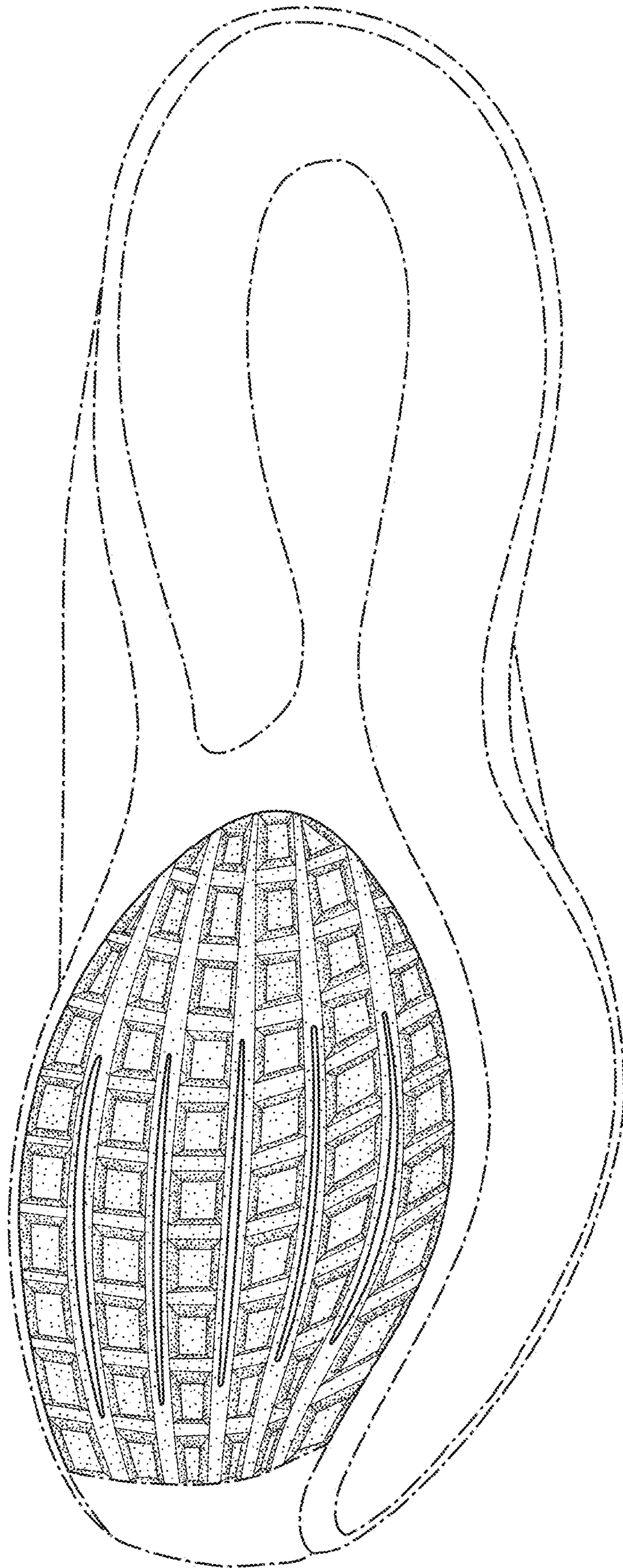

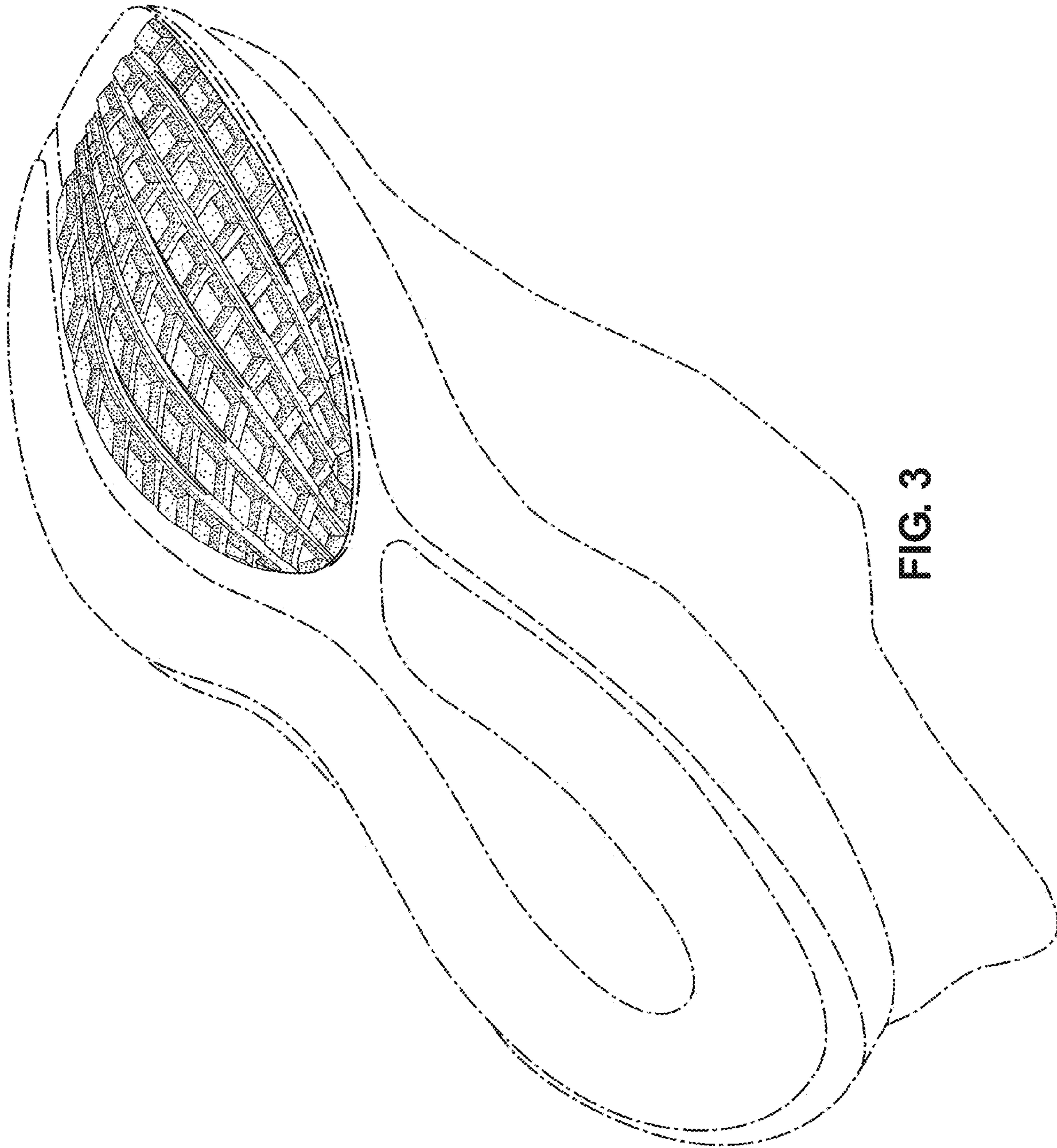
