DESCRIPTION

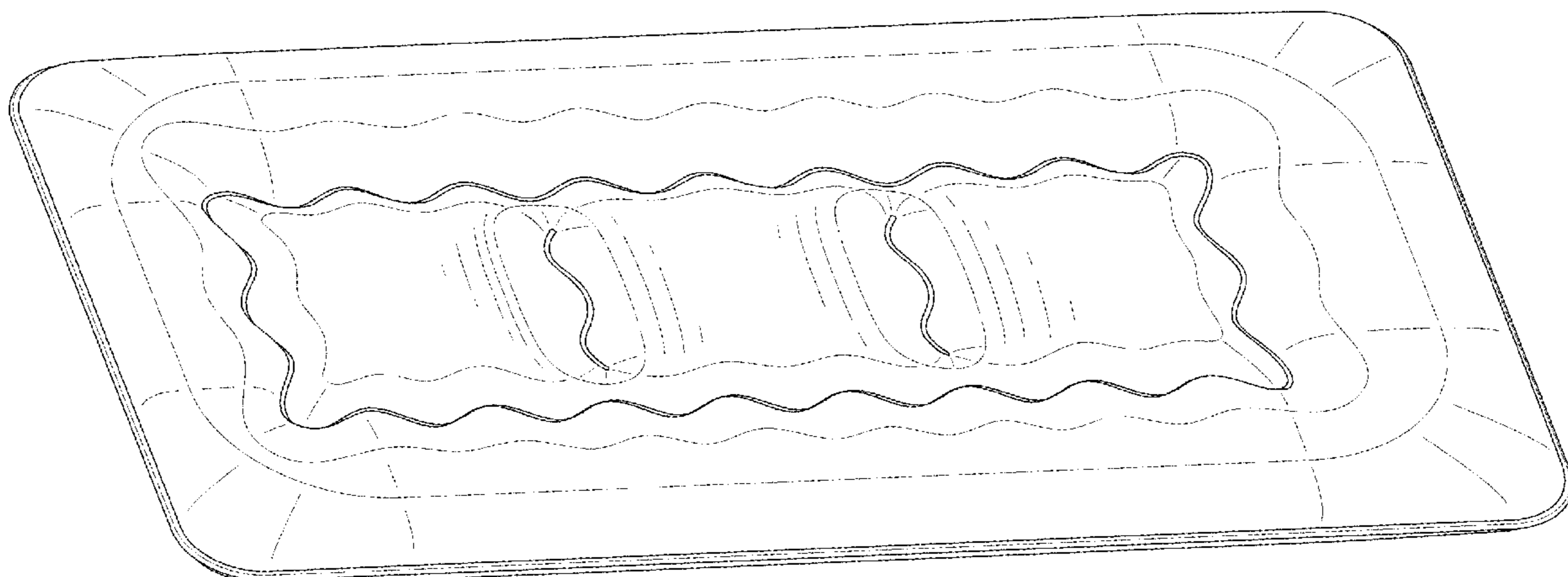
FIG. 1 is a perspective view of a mat showing my new design;

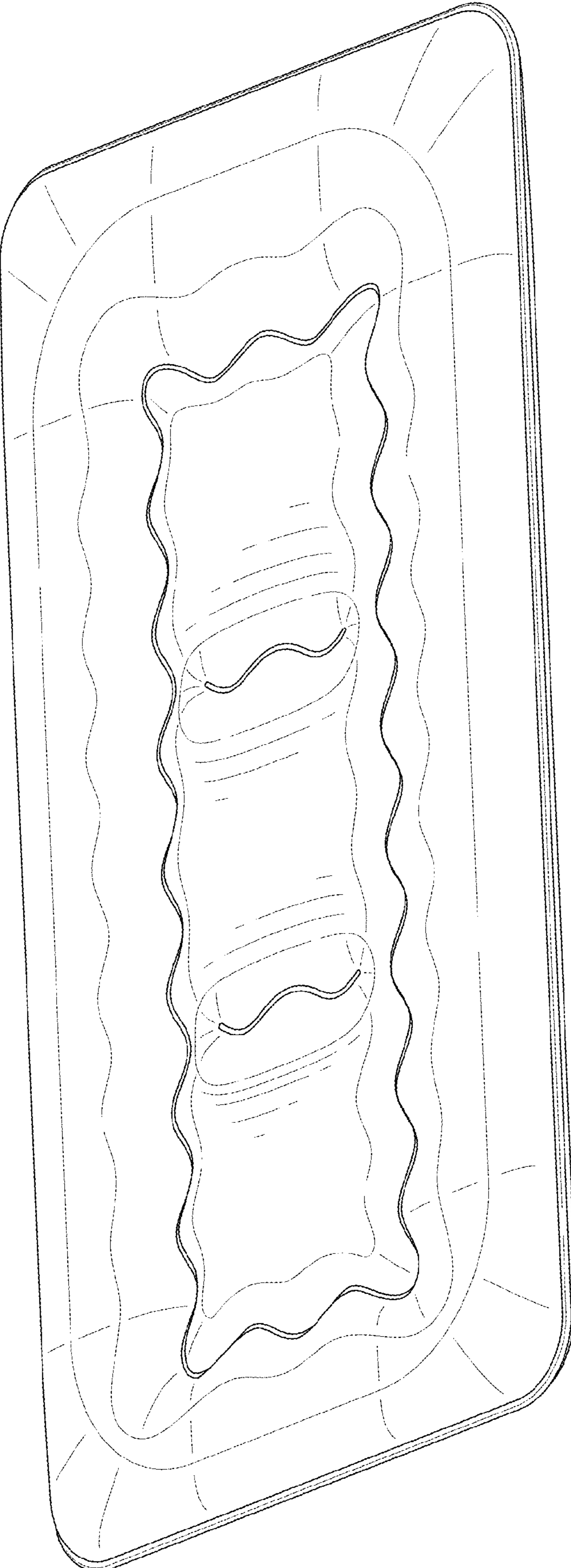

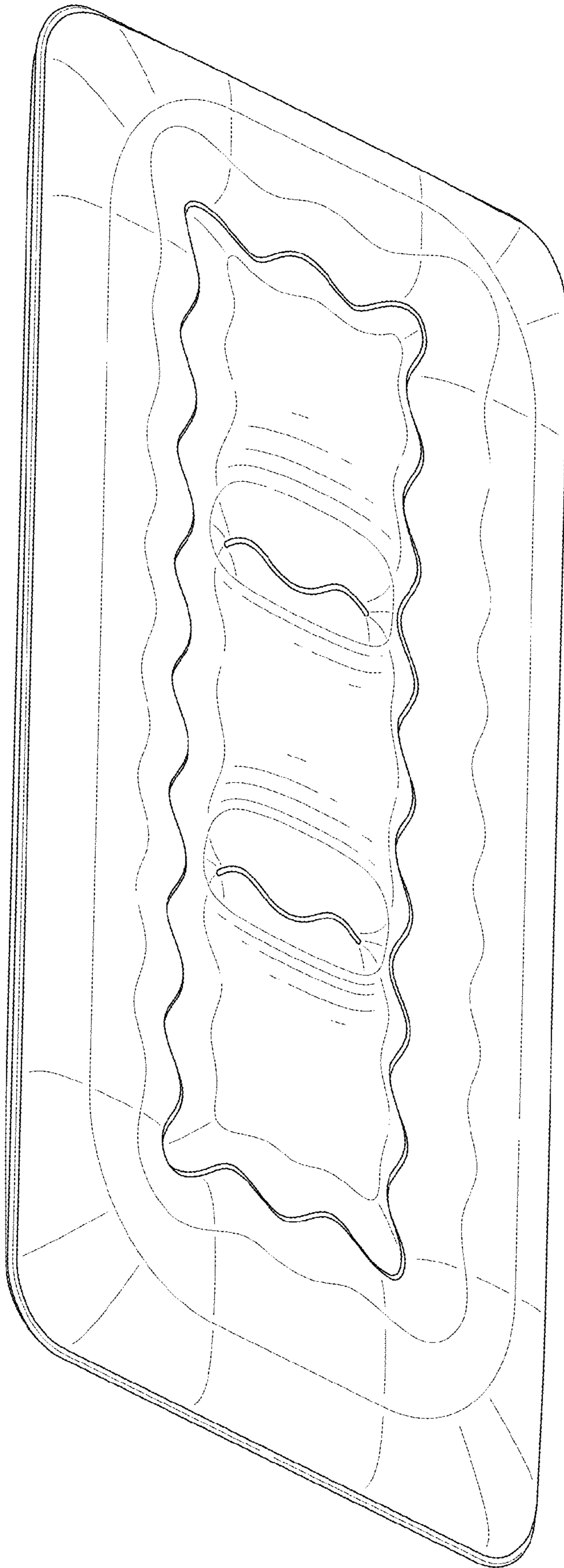

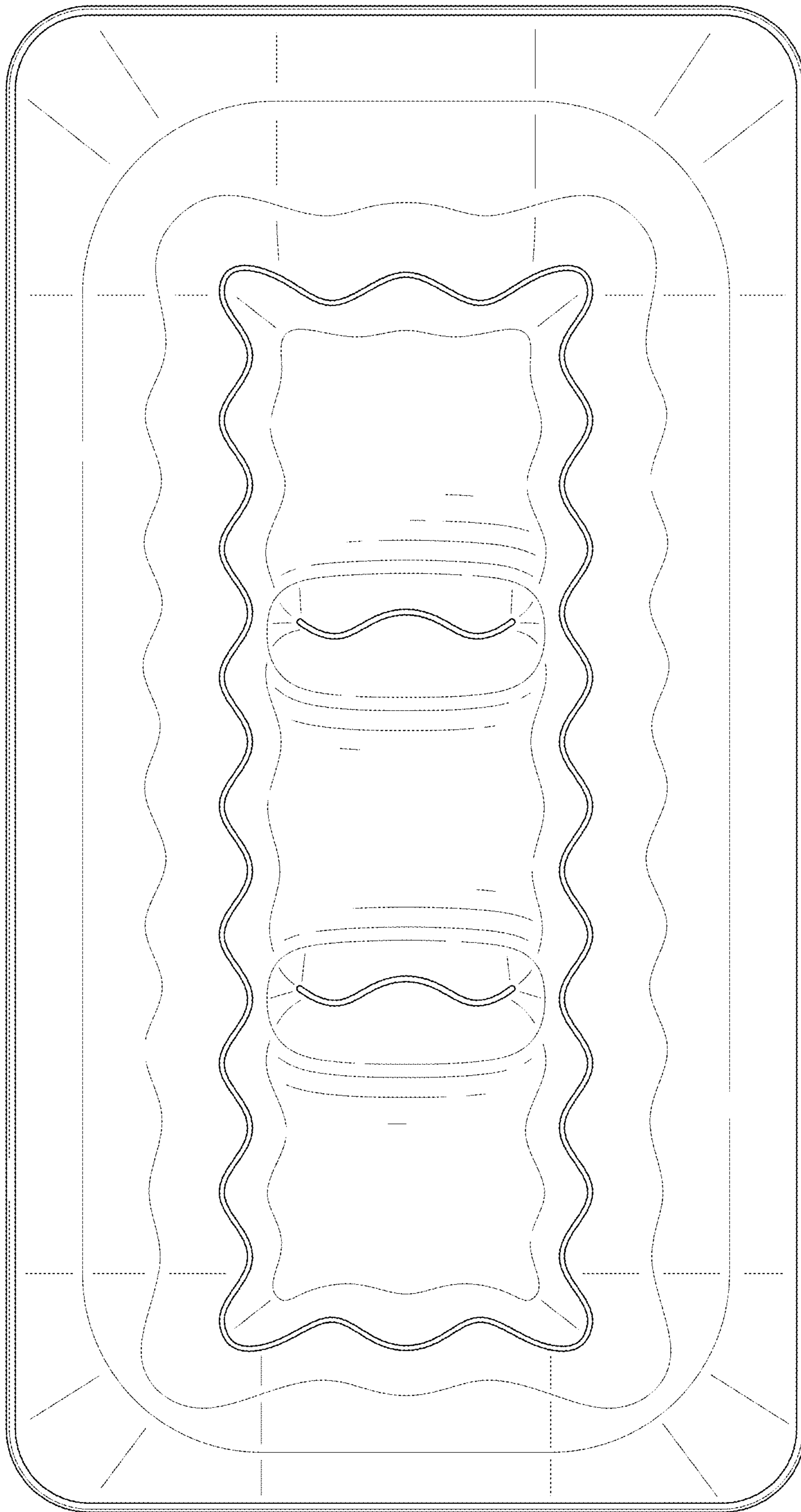

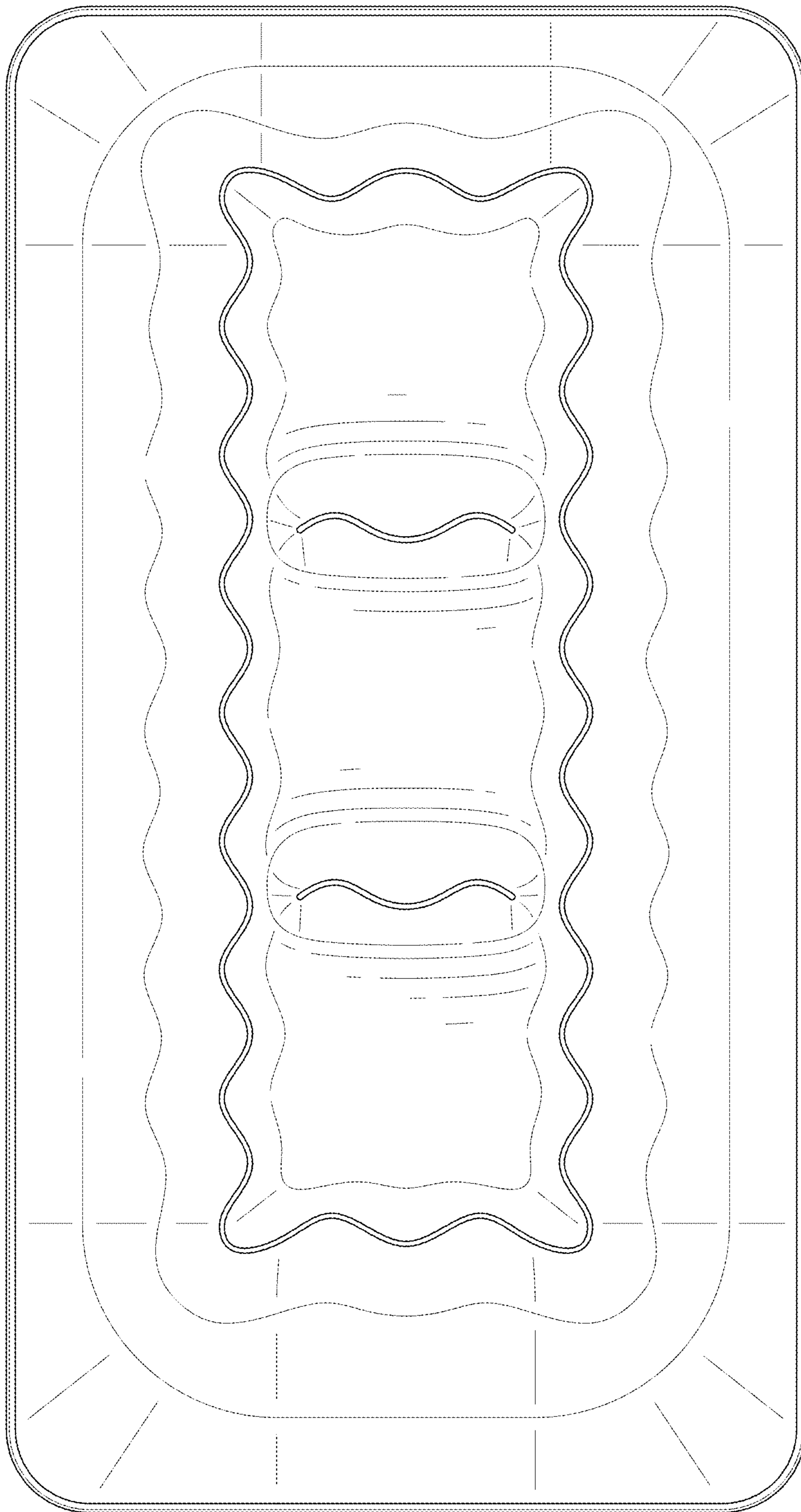

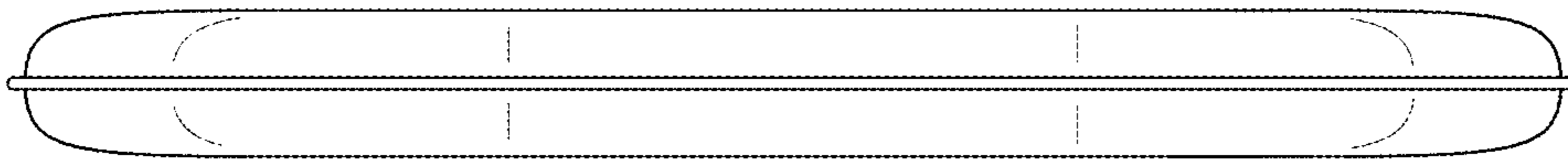

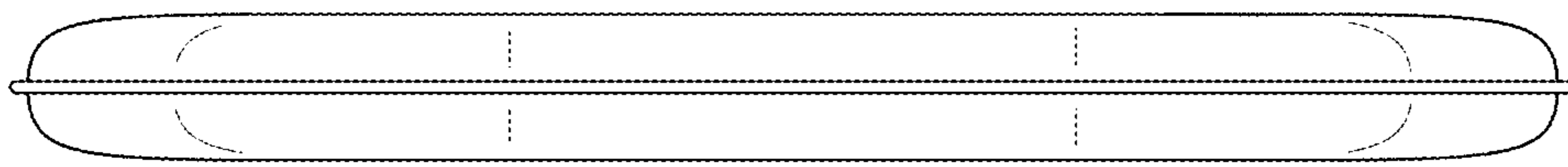

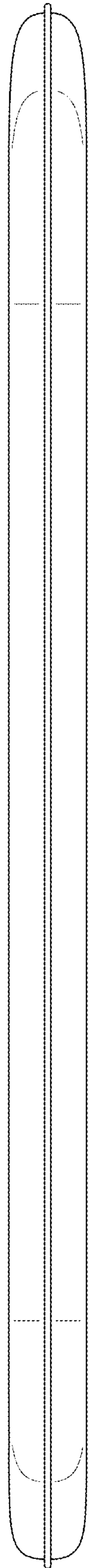

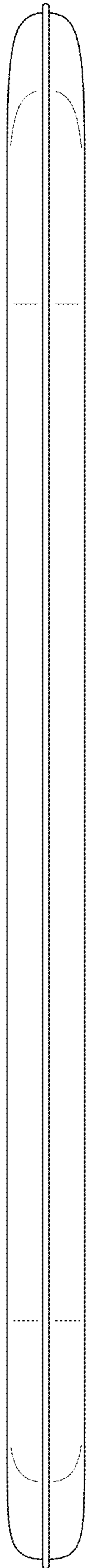
