FIG. 9 is a cross-sectional view taken along line 9-9 of FIG. 4.

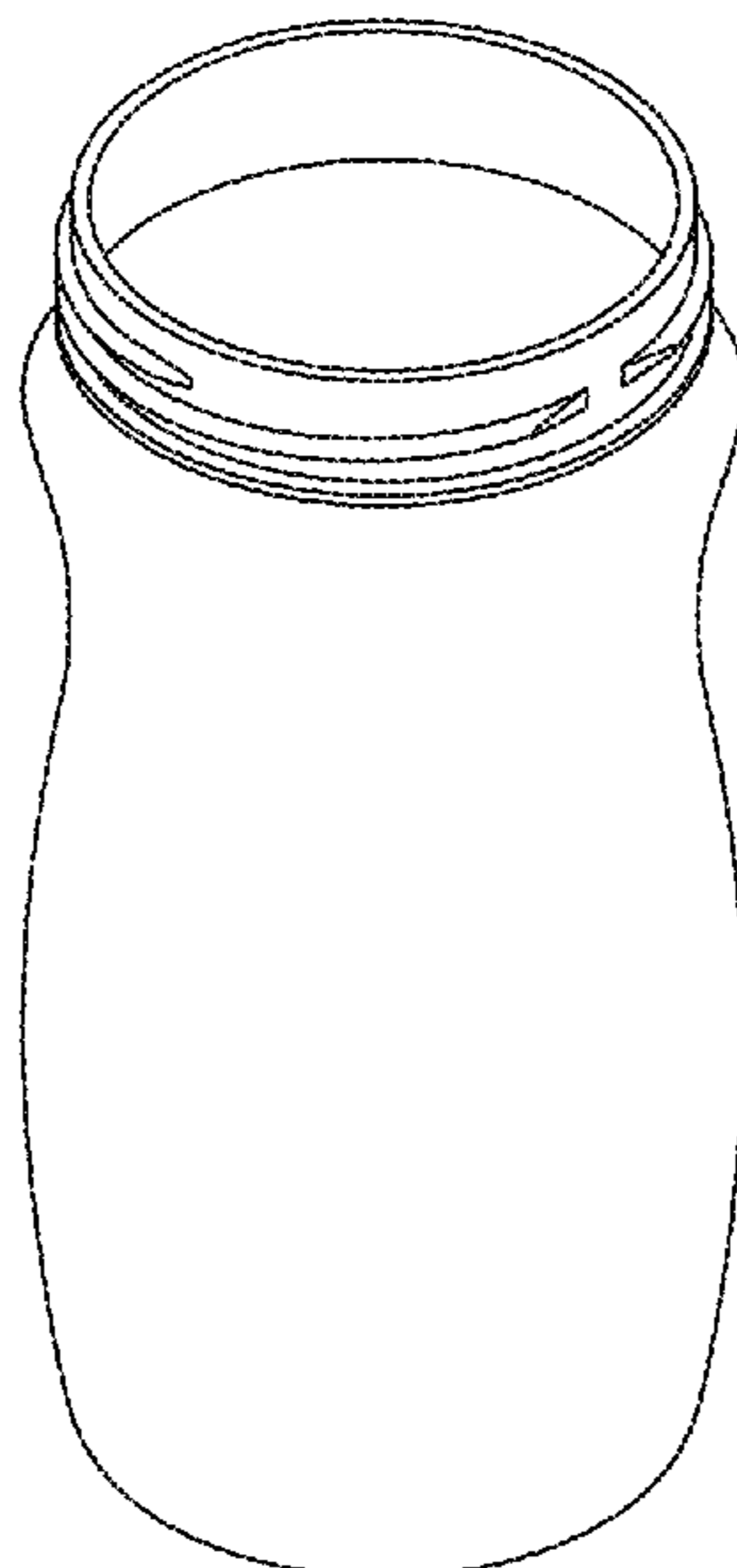

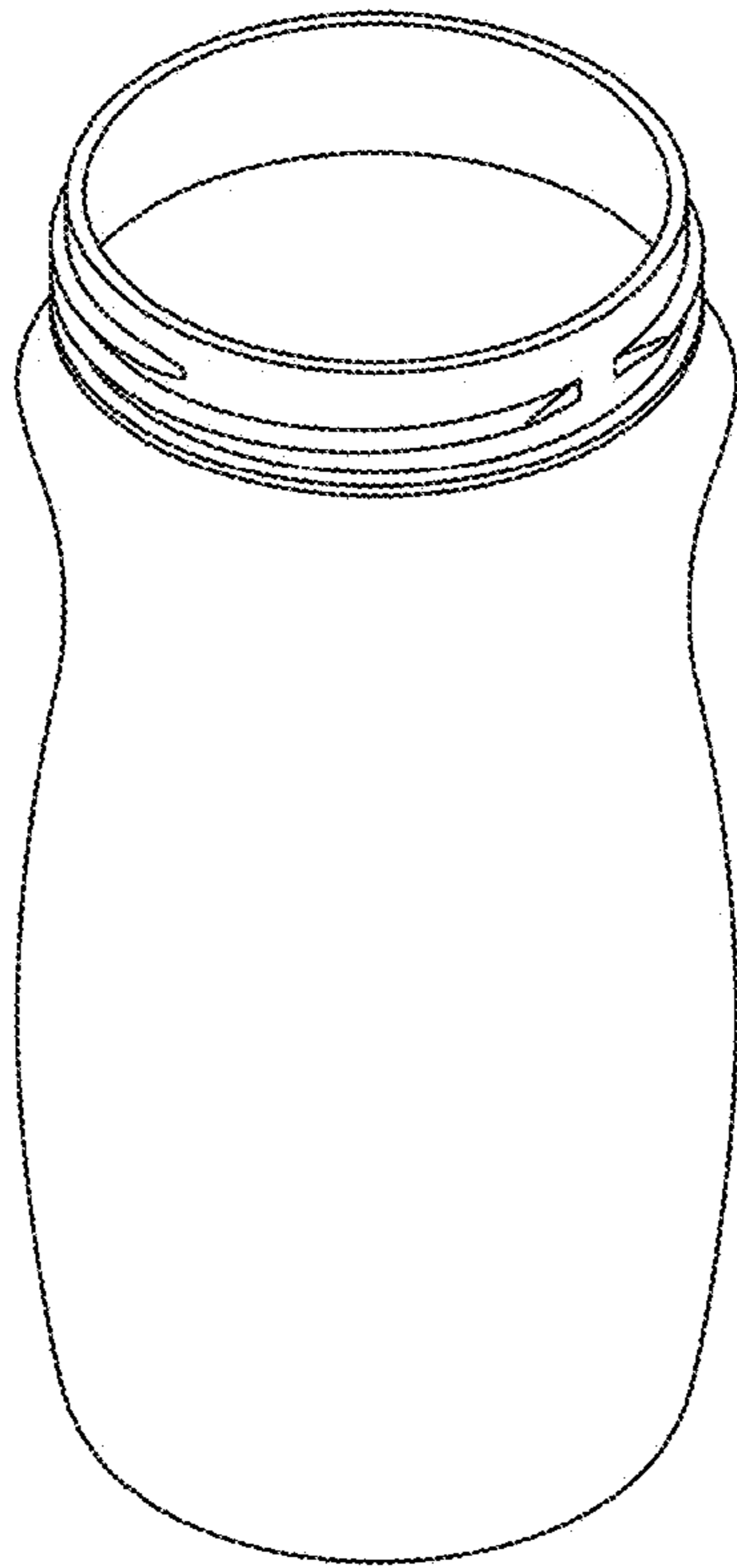

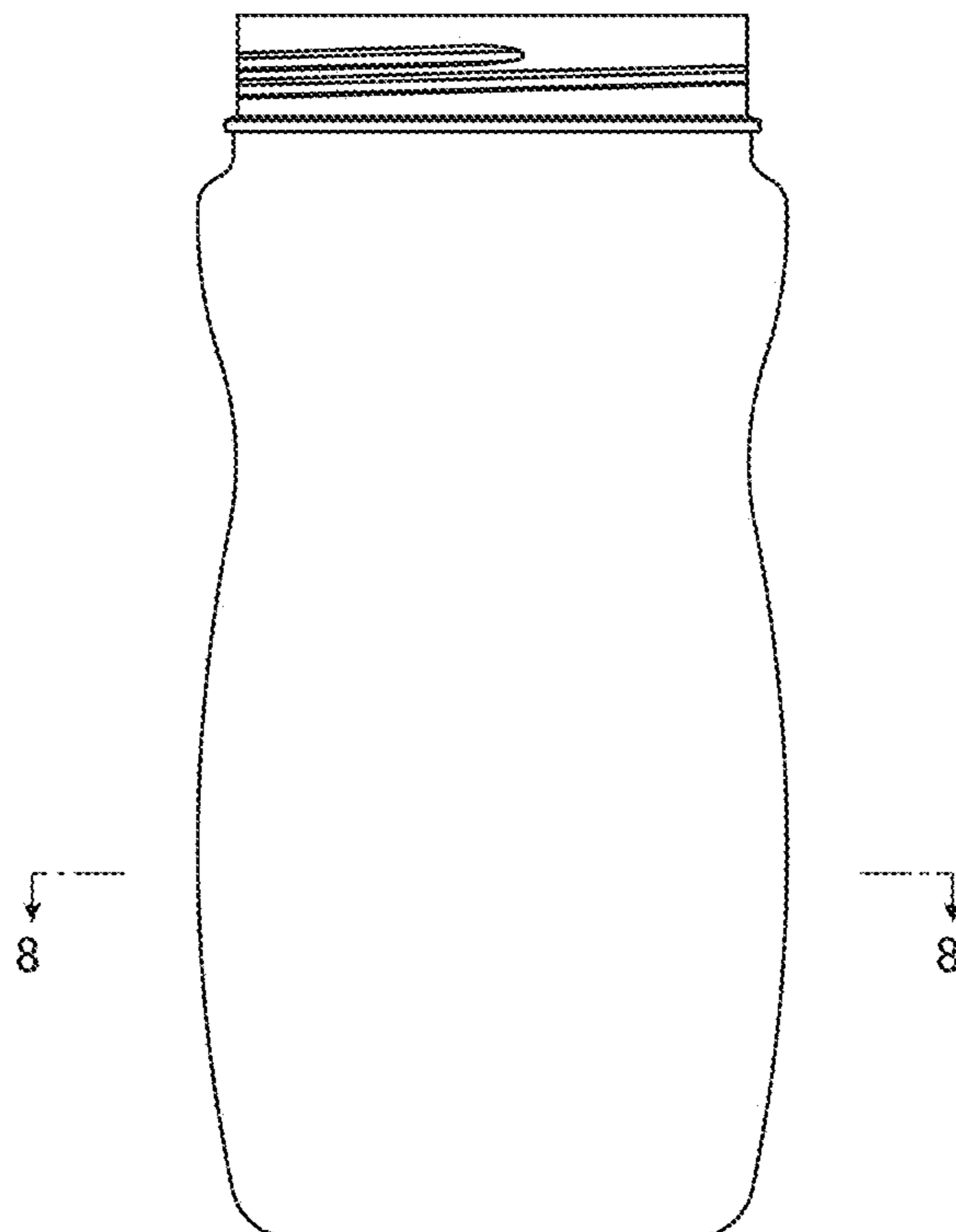

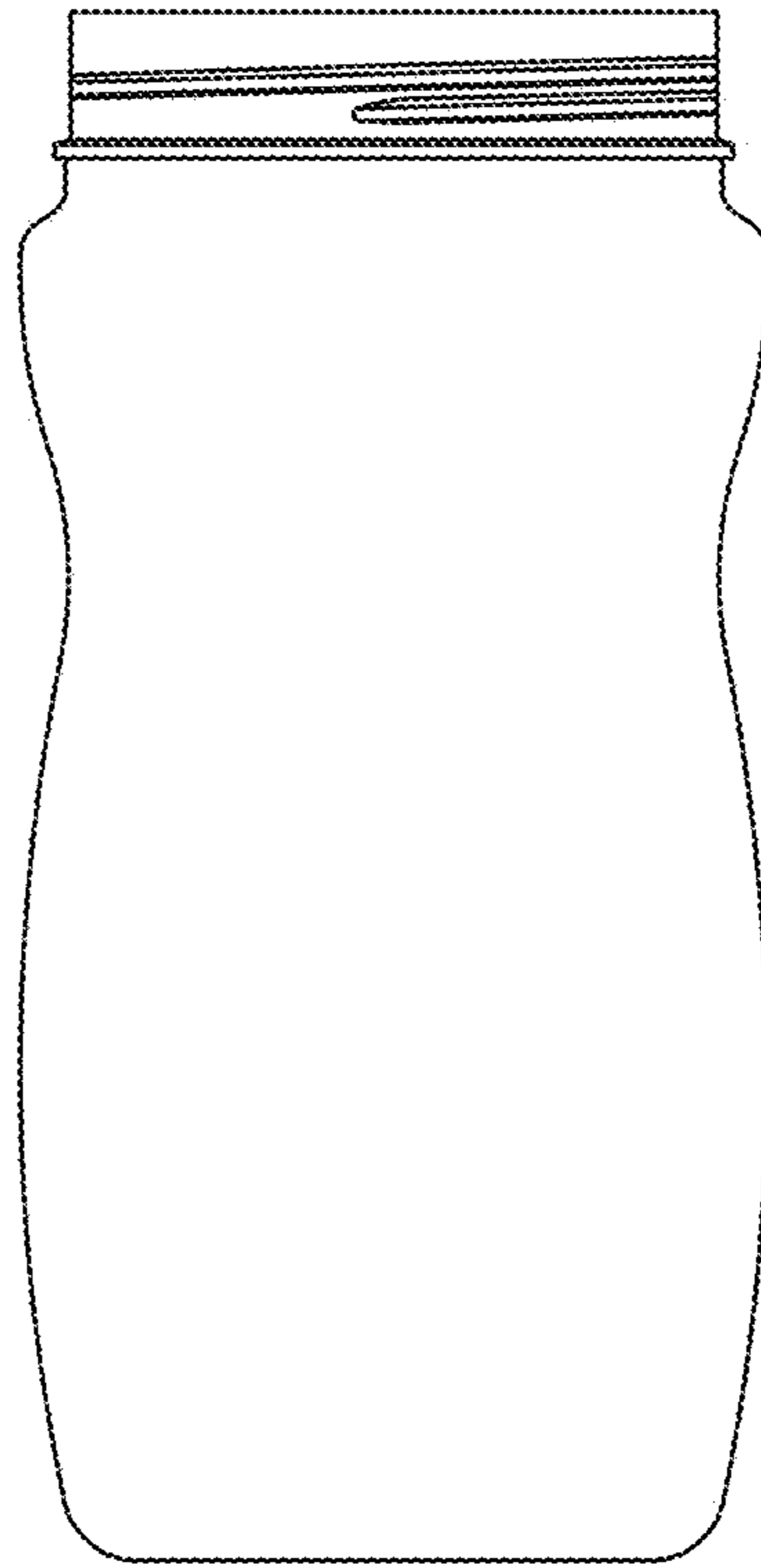

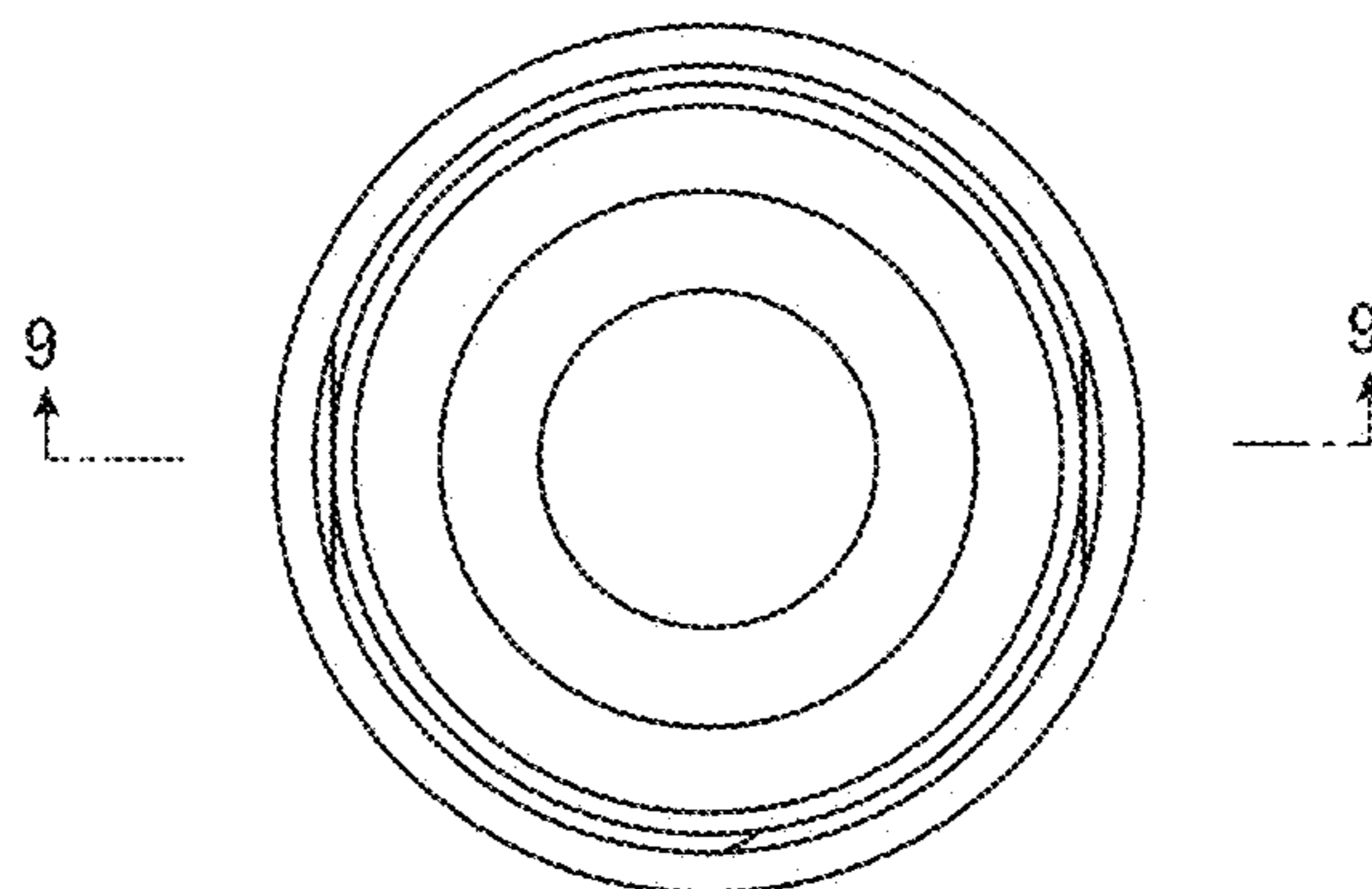

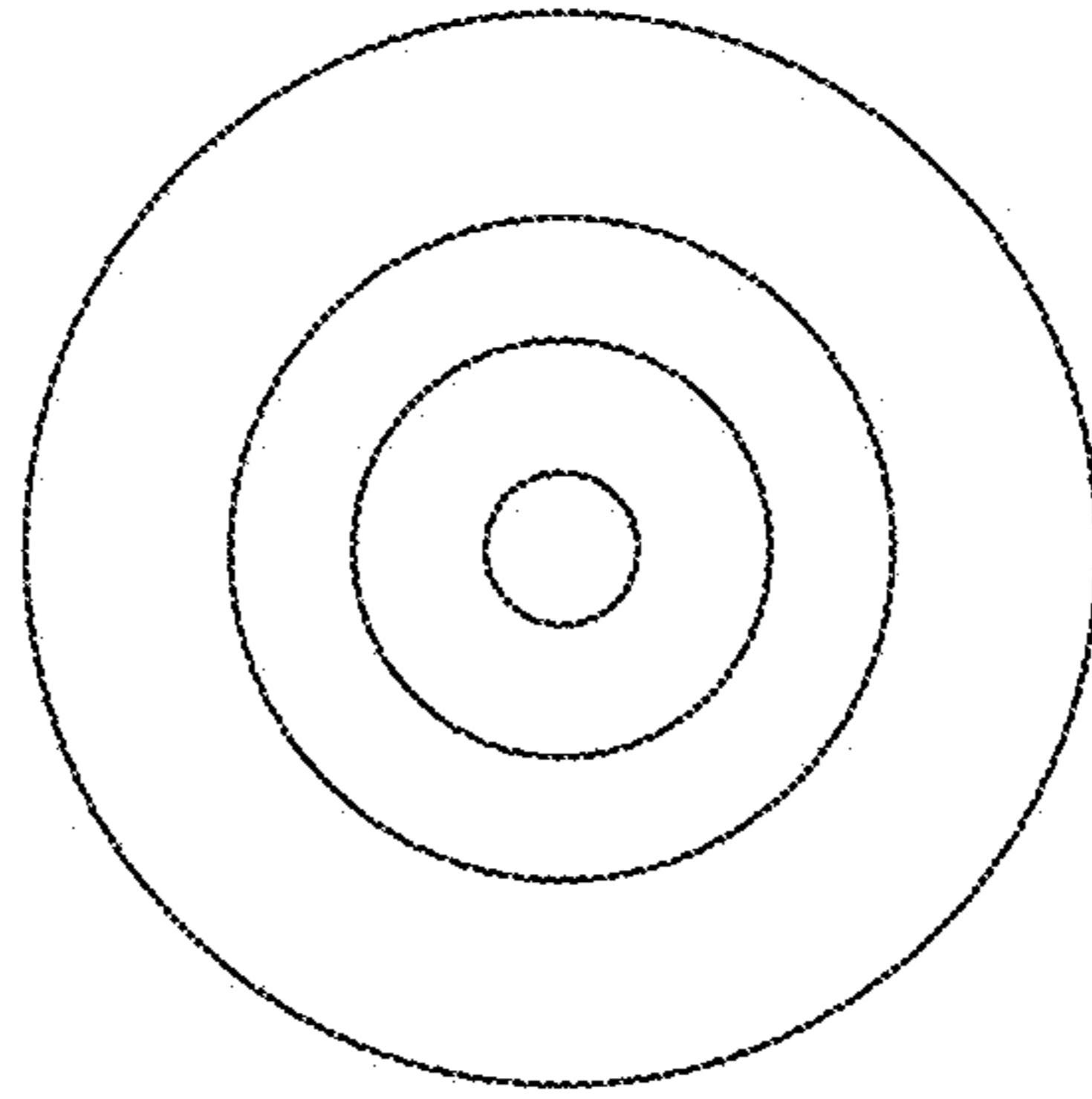

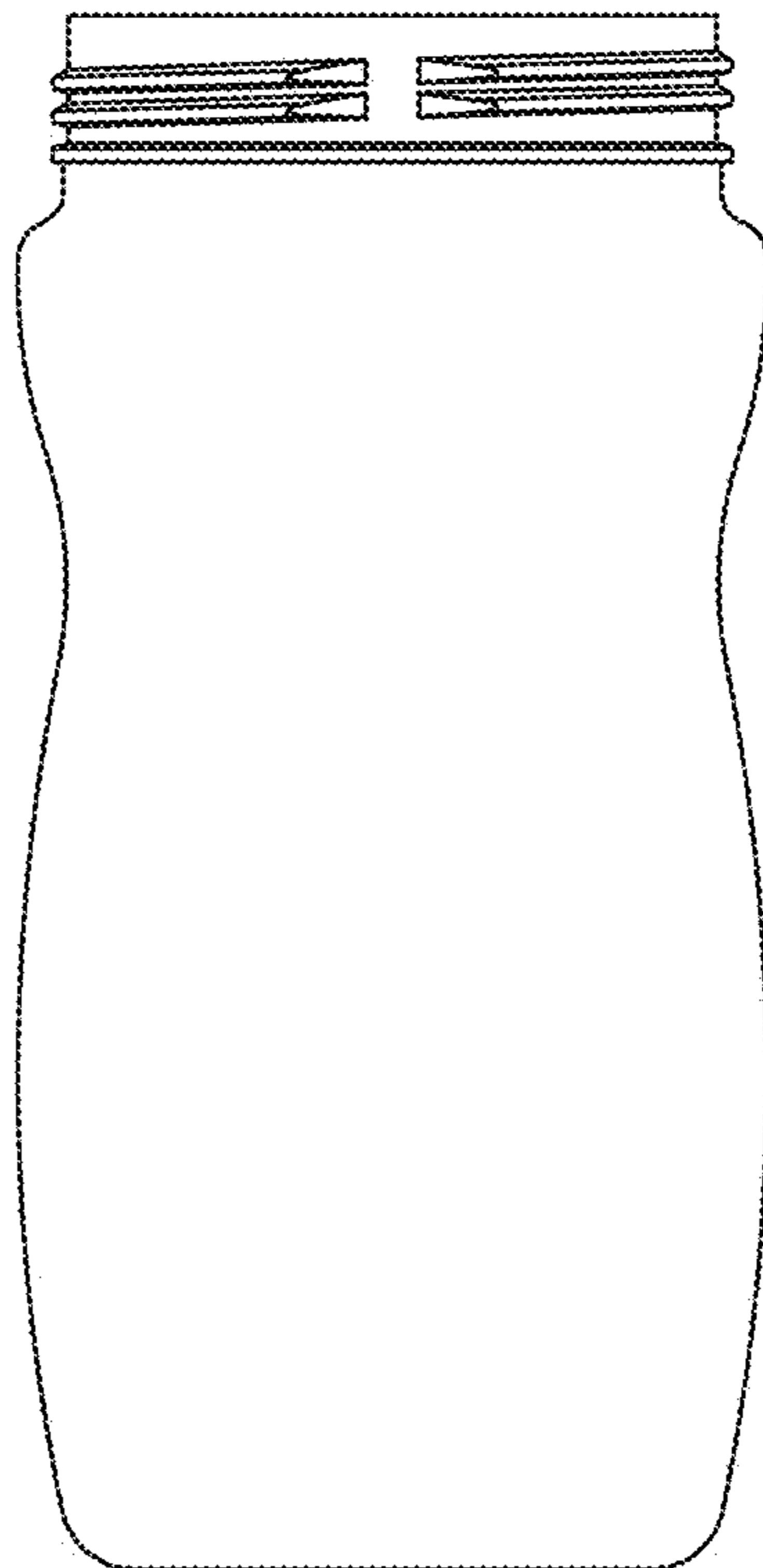

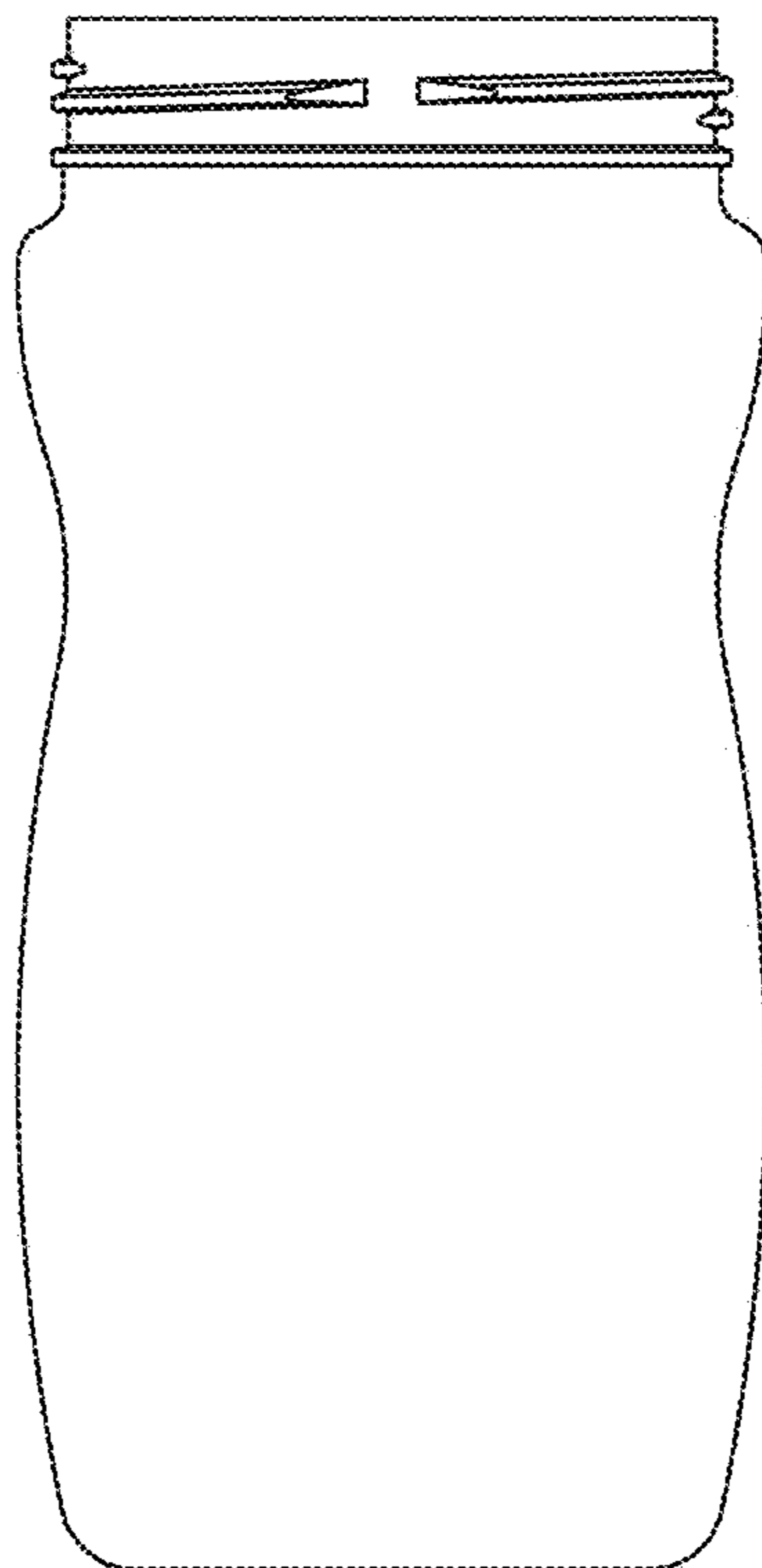

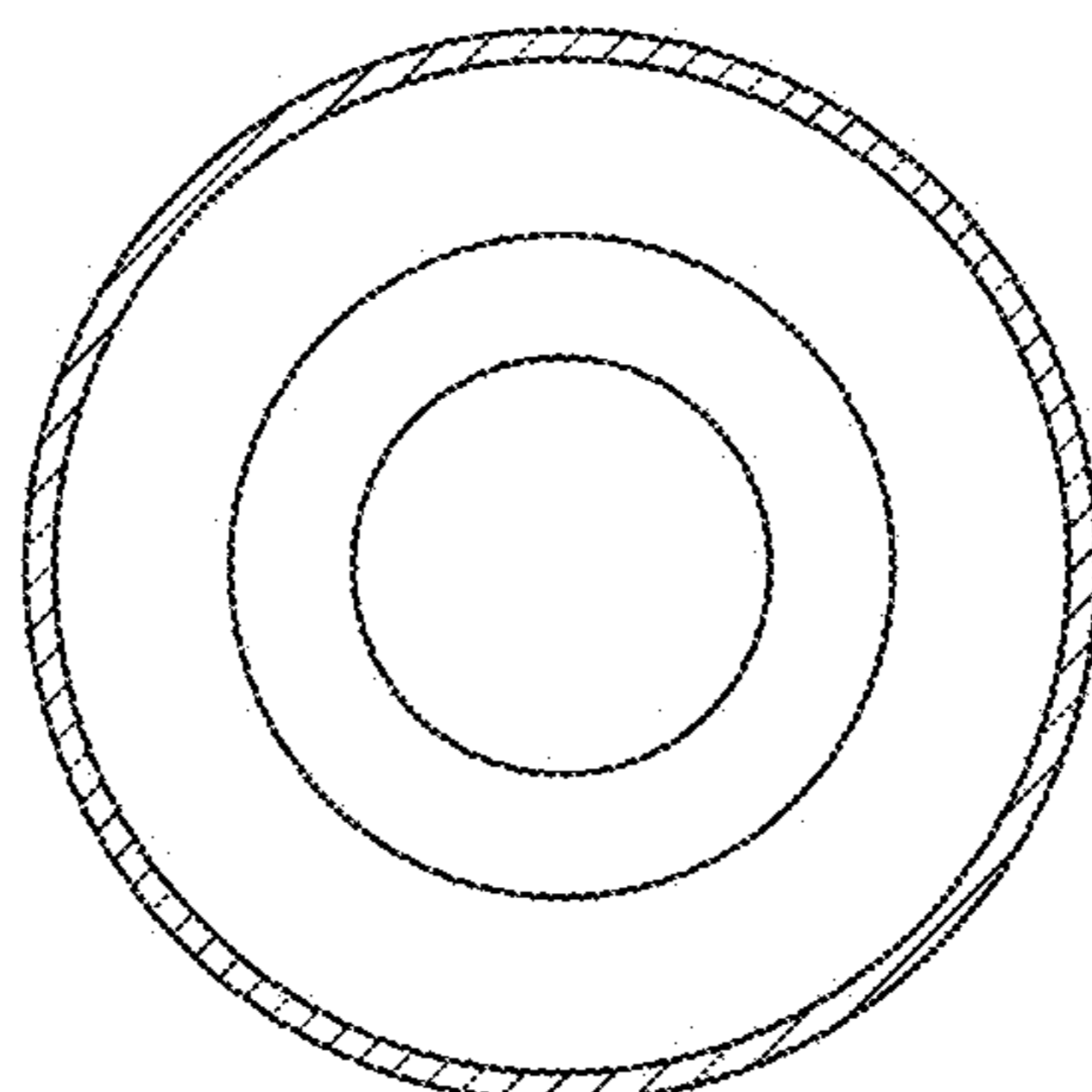
