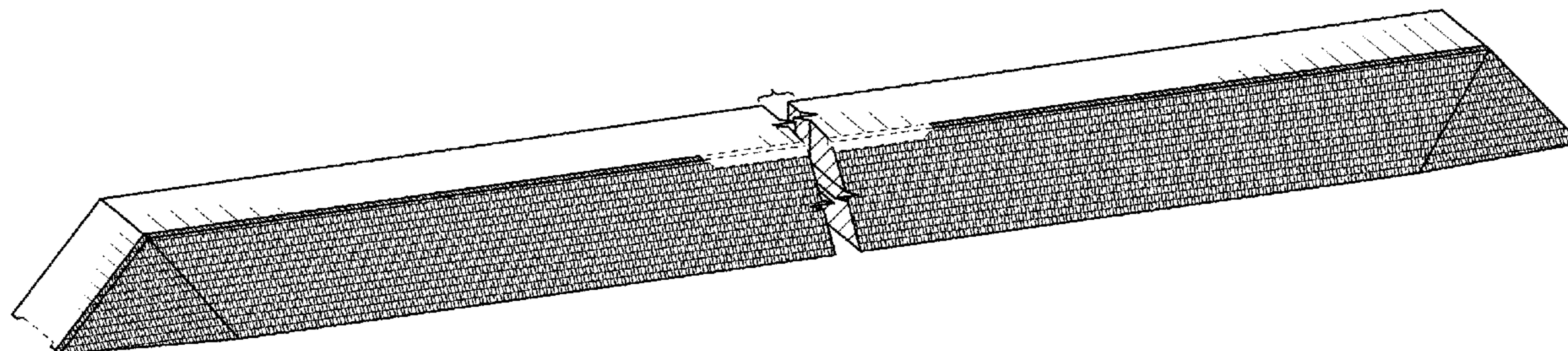
(57) **CLAIM**

The ornamental design for a sound bar, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a sound bar showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines in the figures illustrate the portions of the design that form no part of the claimed design.
The sound bar has been shown with symbolic breaks. The appearance of any portion of the article between the break lines forms no part of the claimed design.

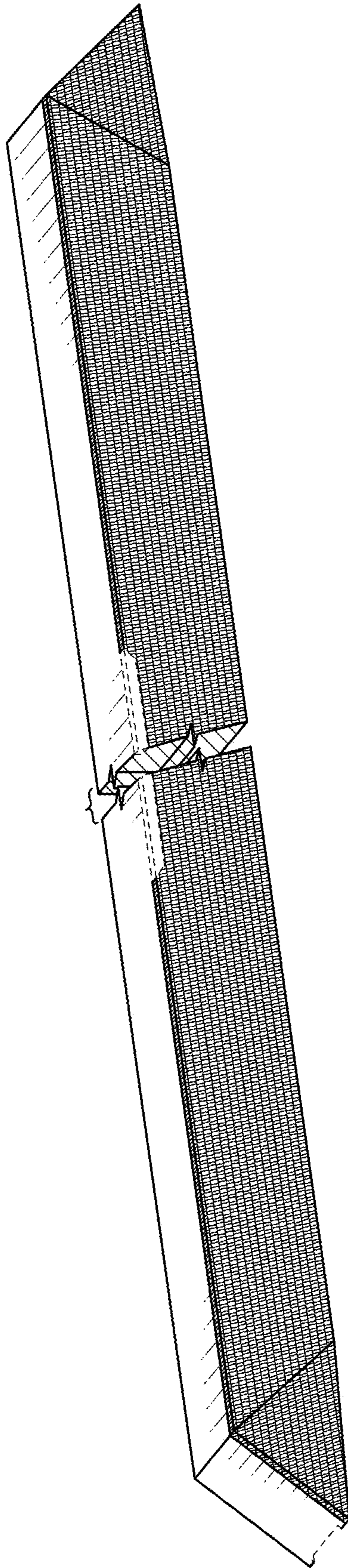

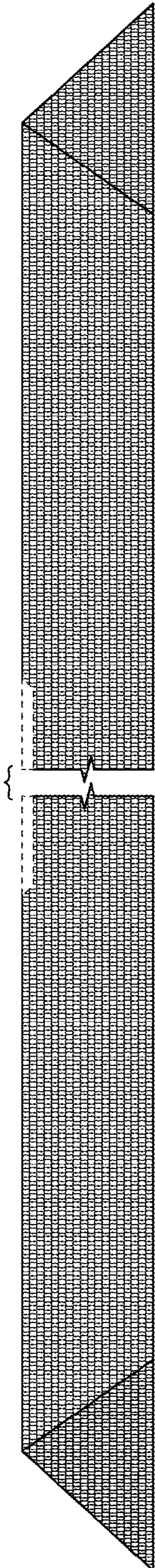

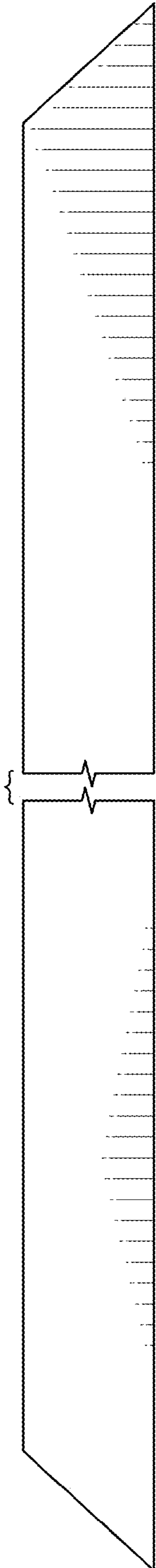

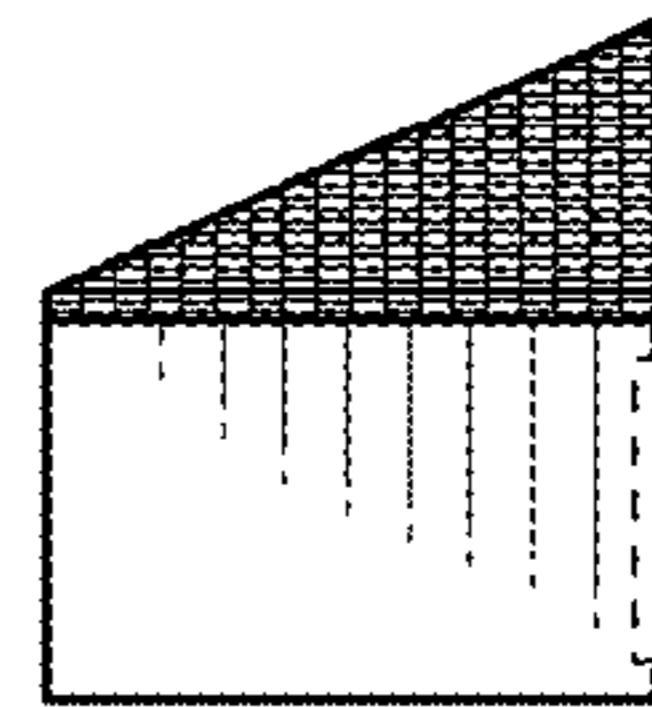

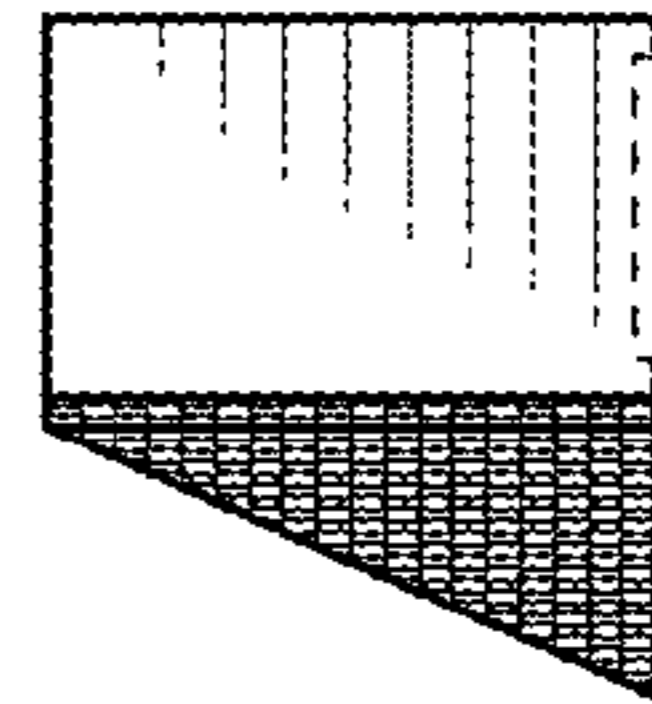

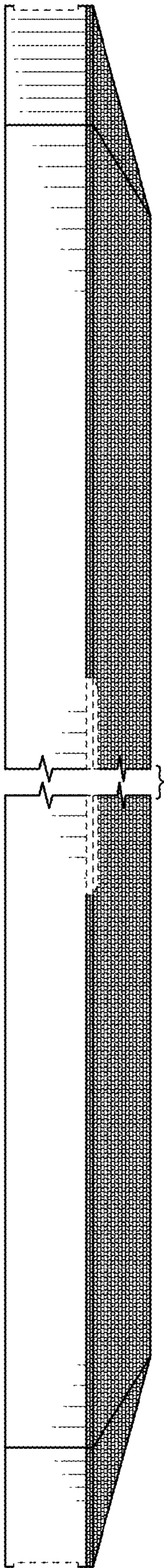

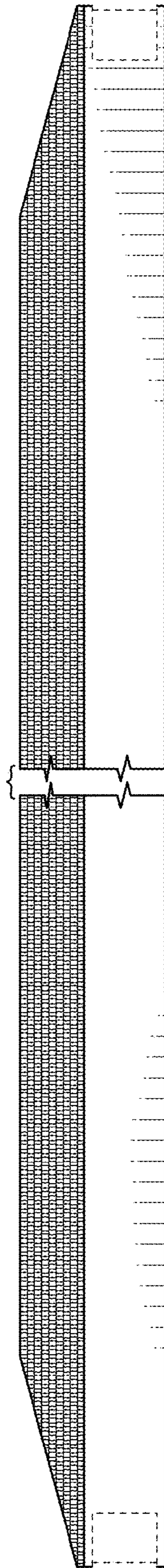
