The dashed broken lines in the figures depict portions of the bumper case for mobile phone that form no part of the claimed design.

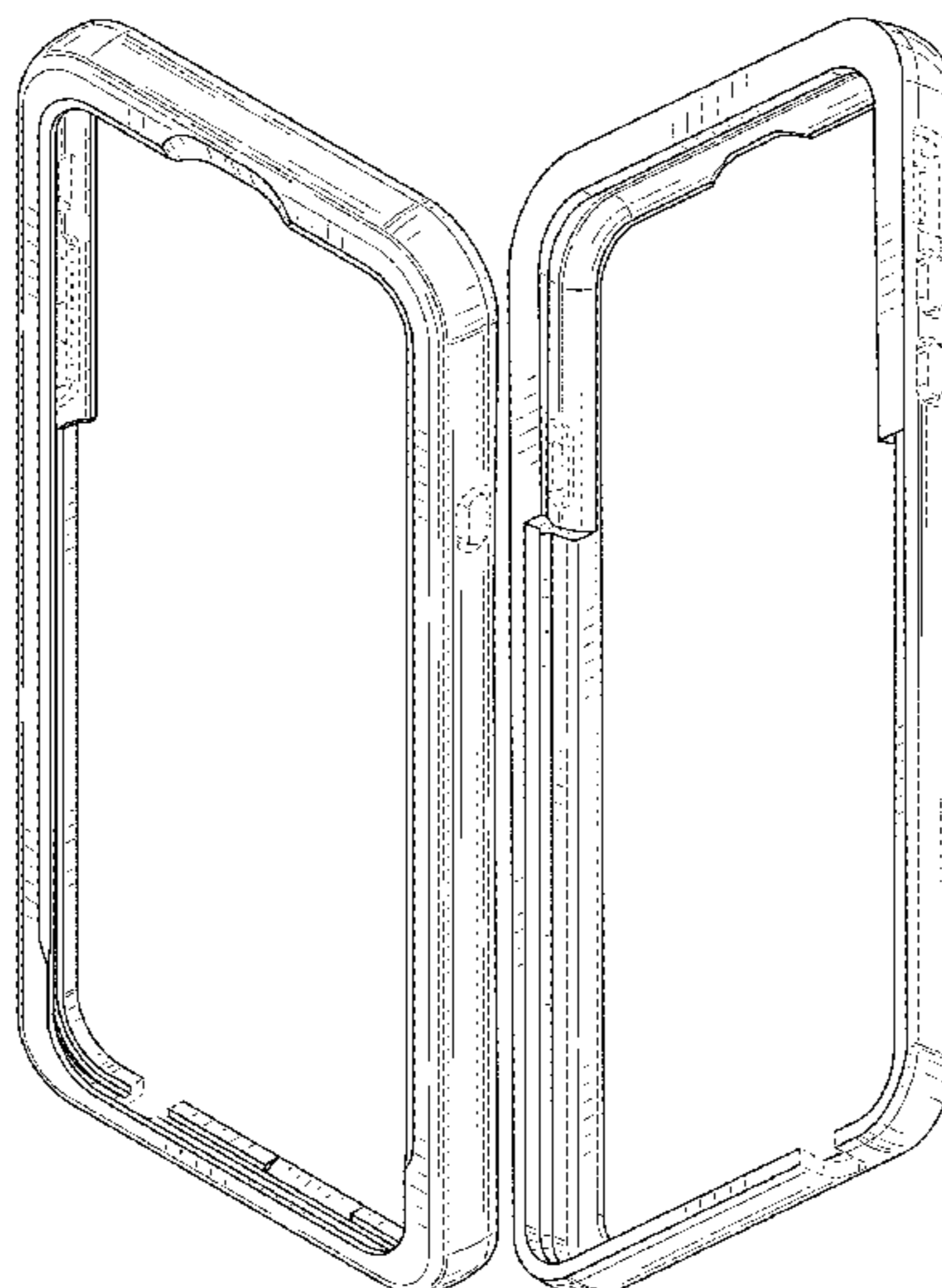

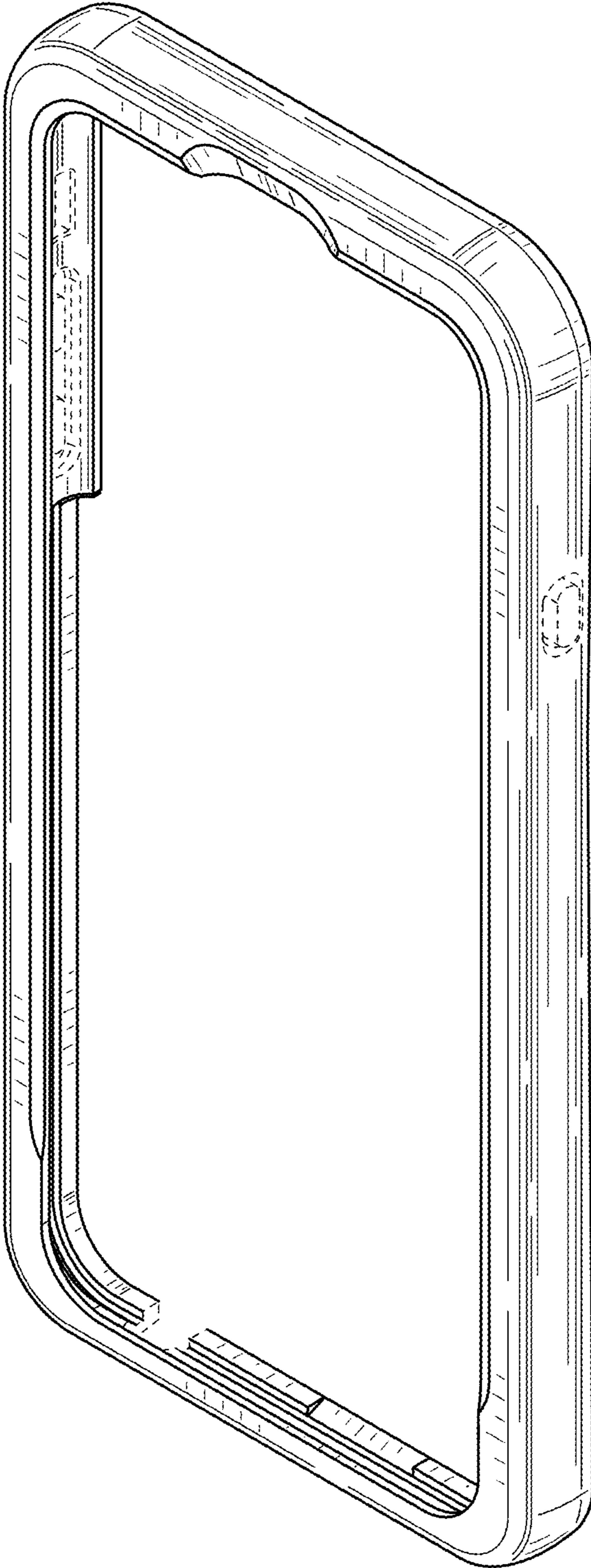

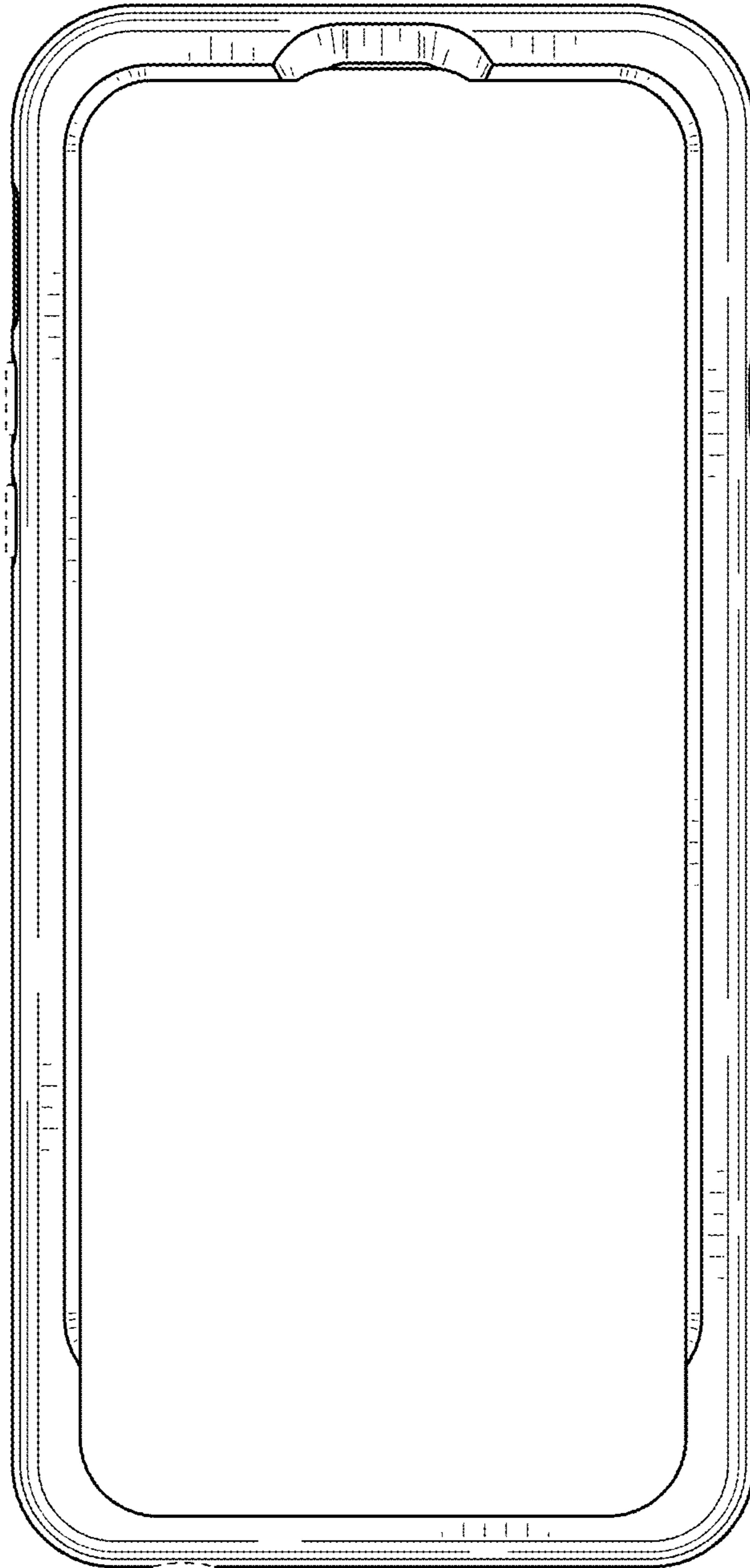

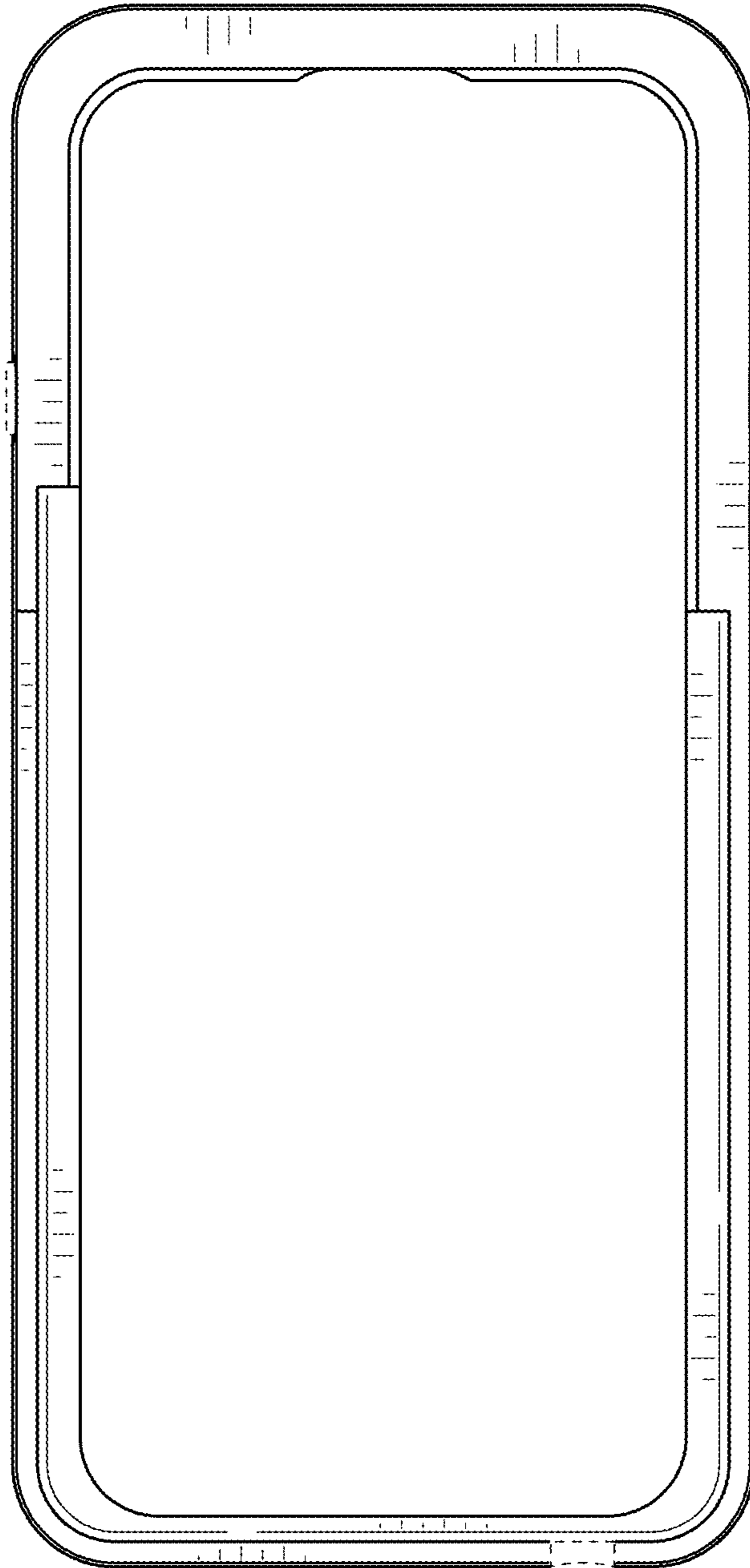

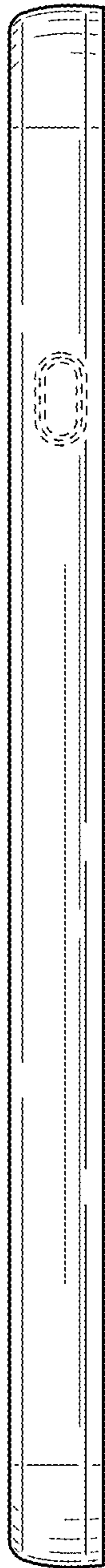

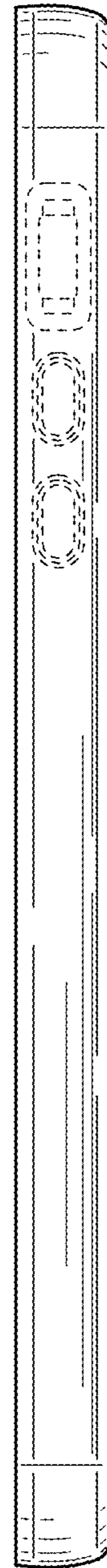

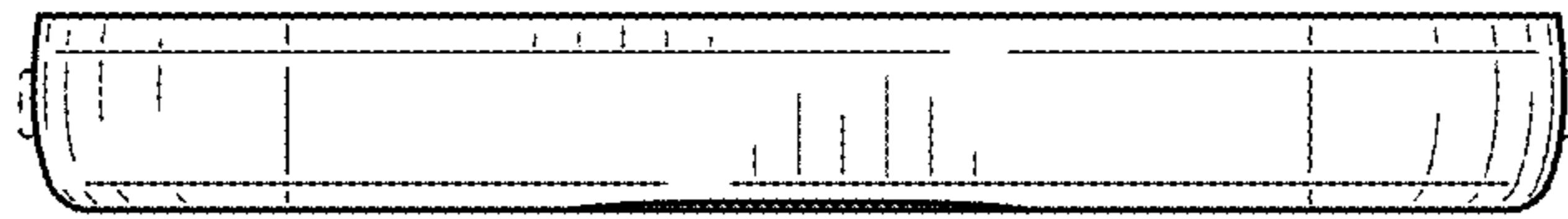

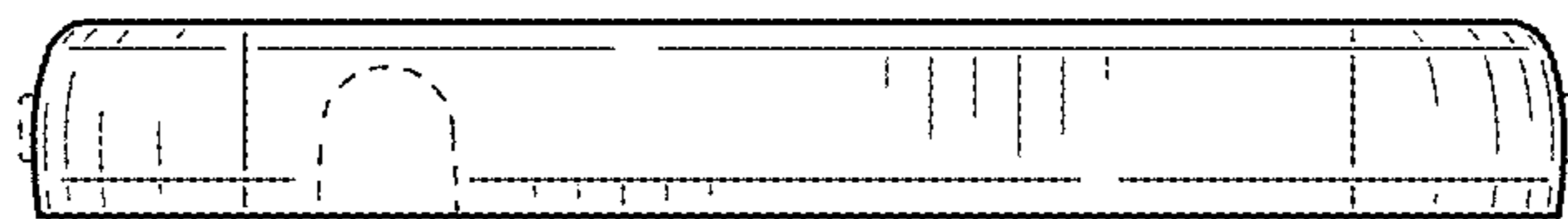

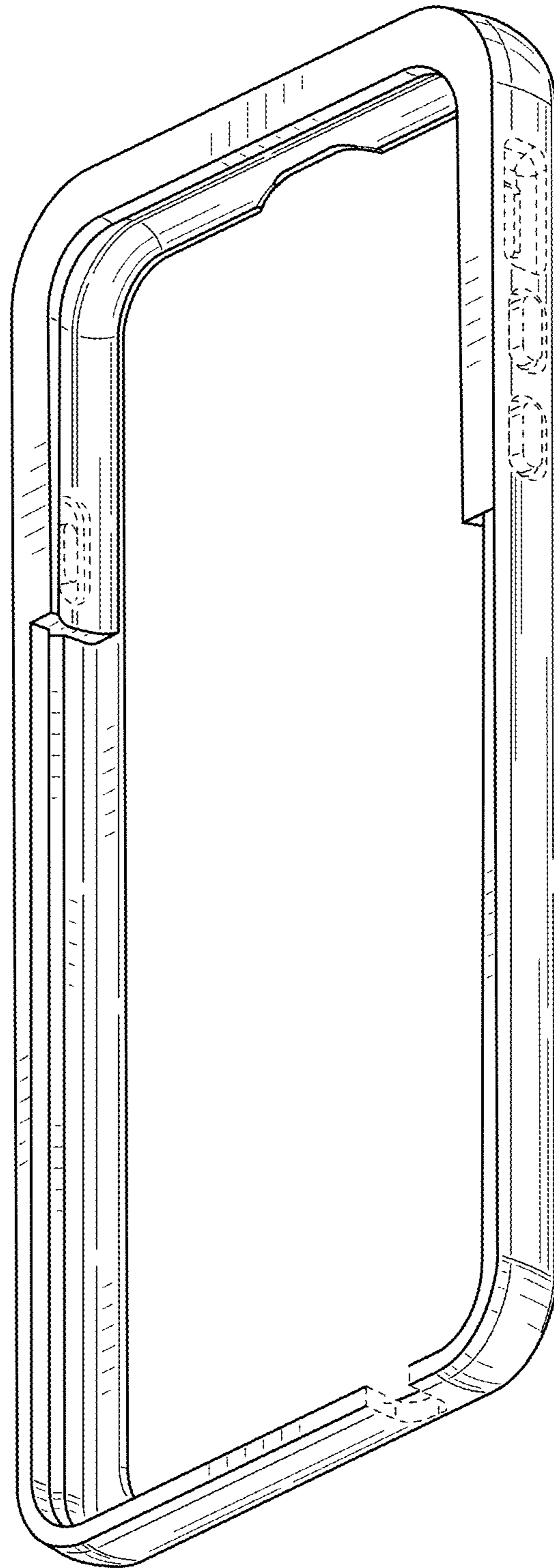

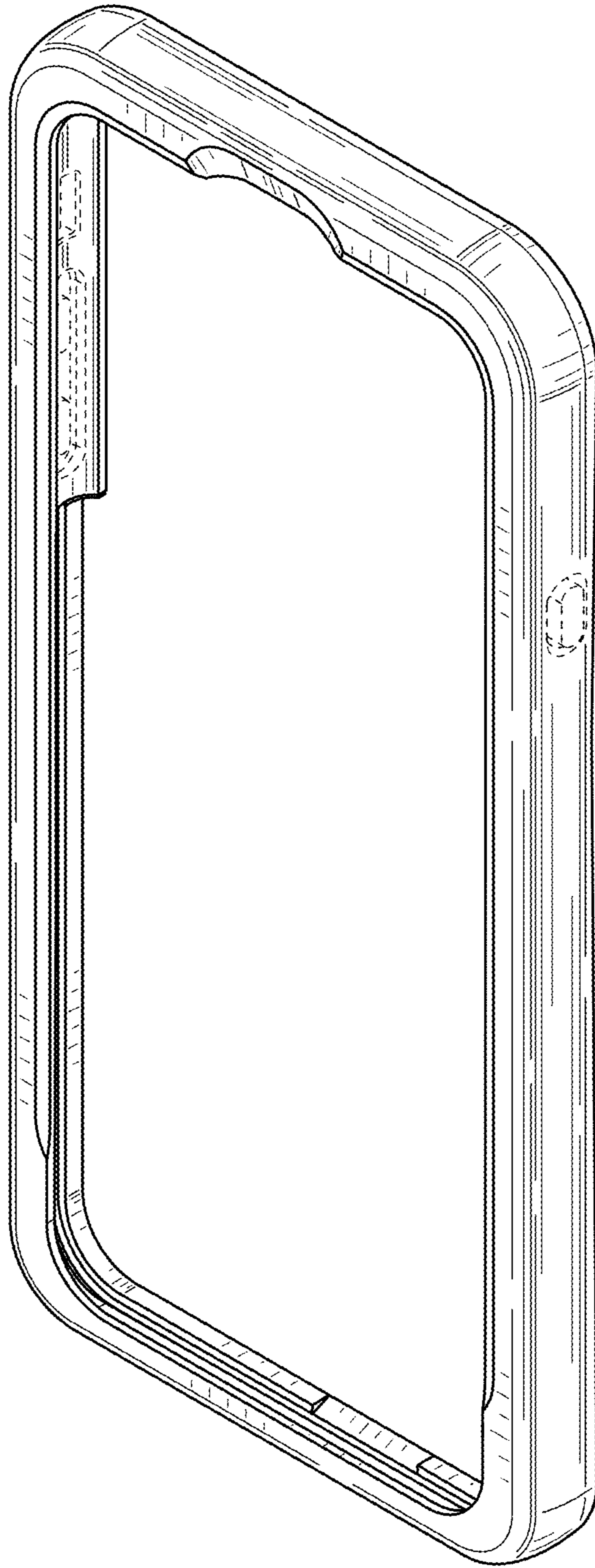

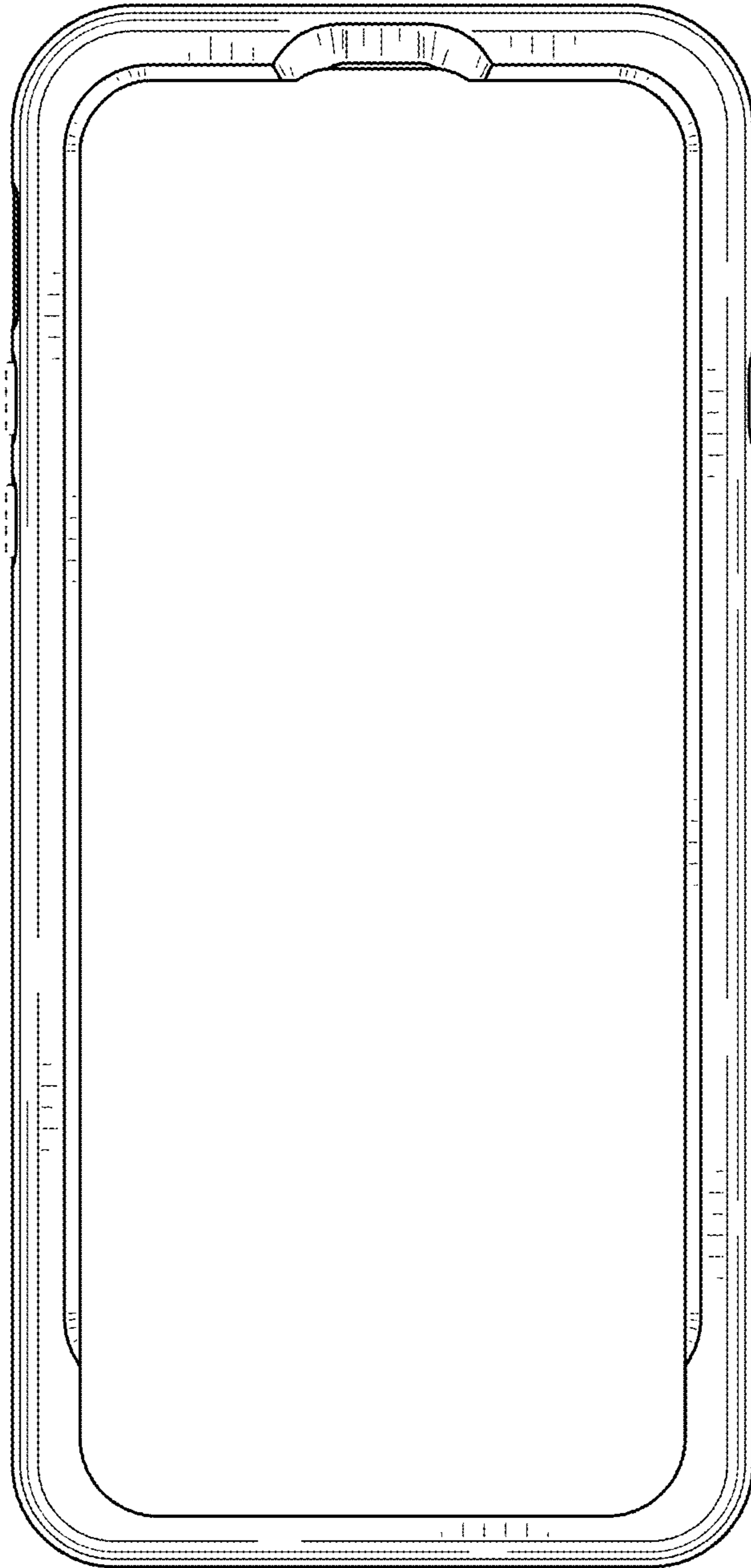

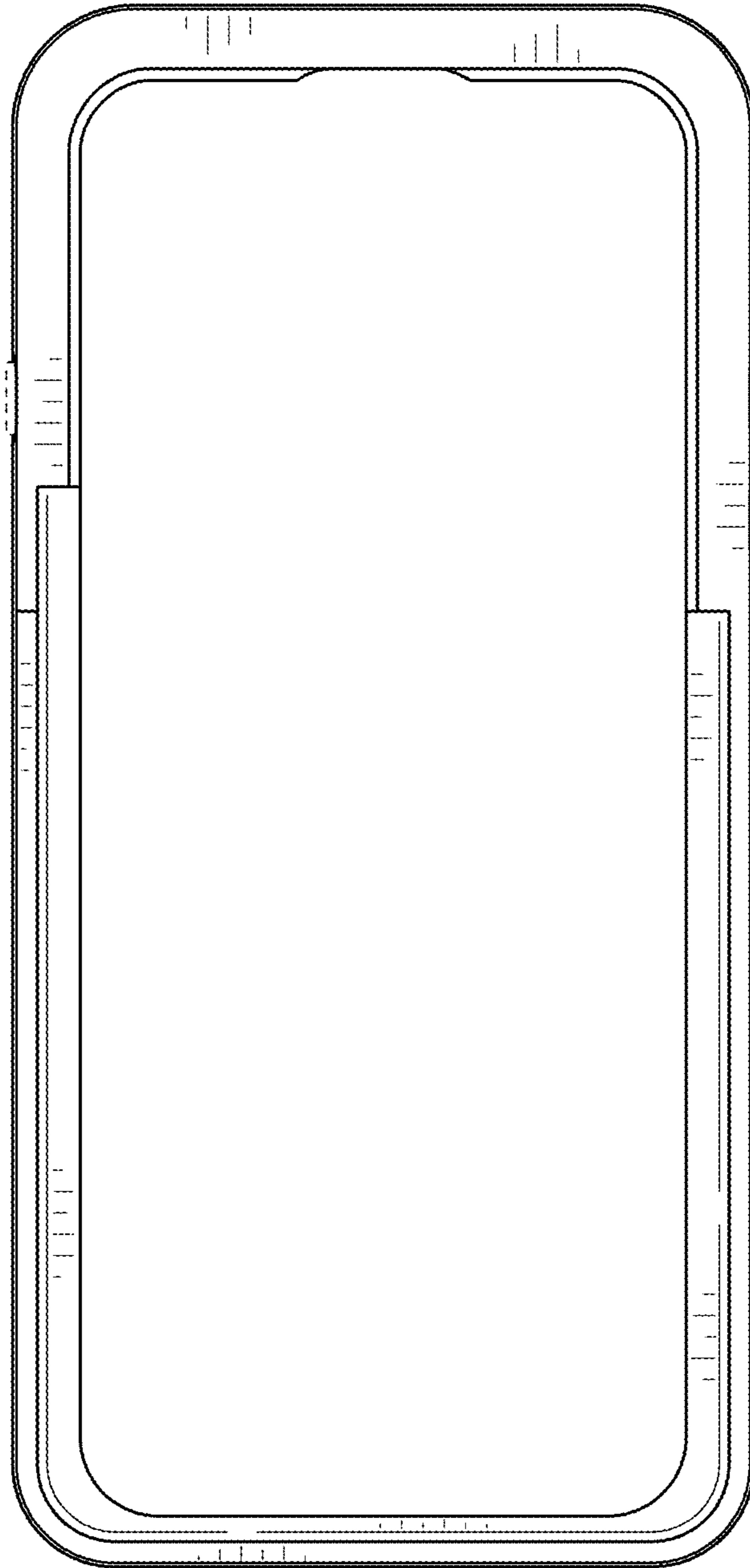

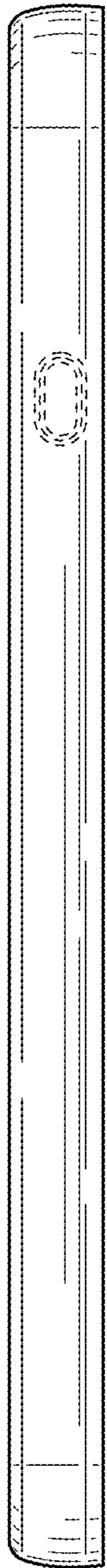

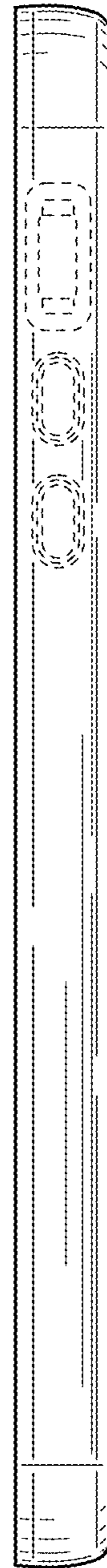

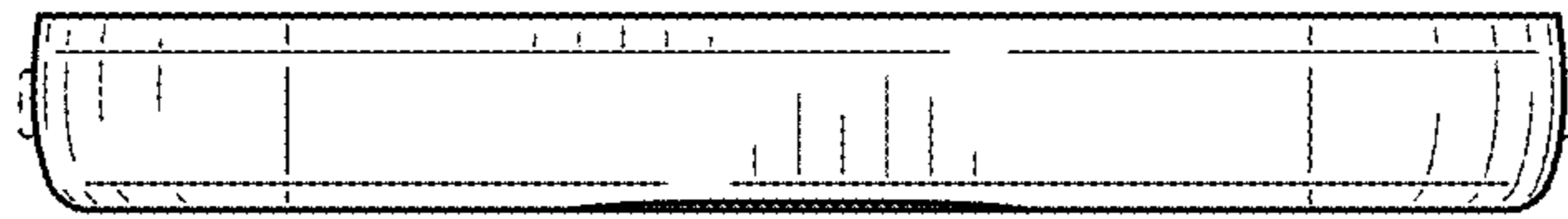

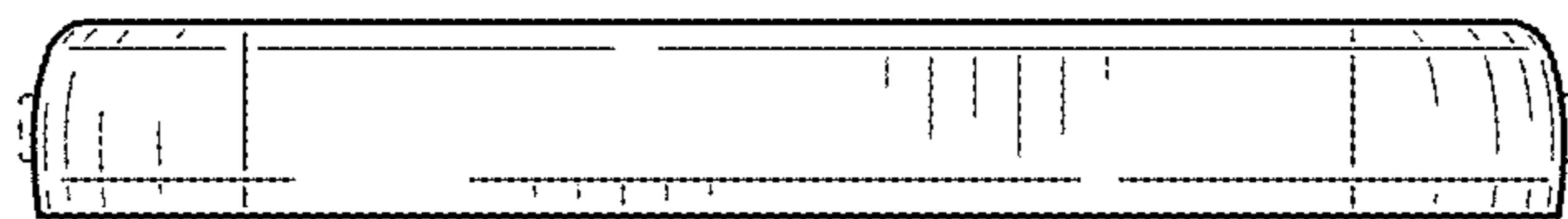

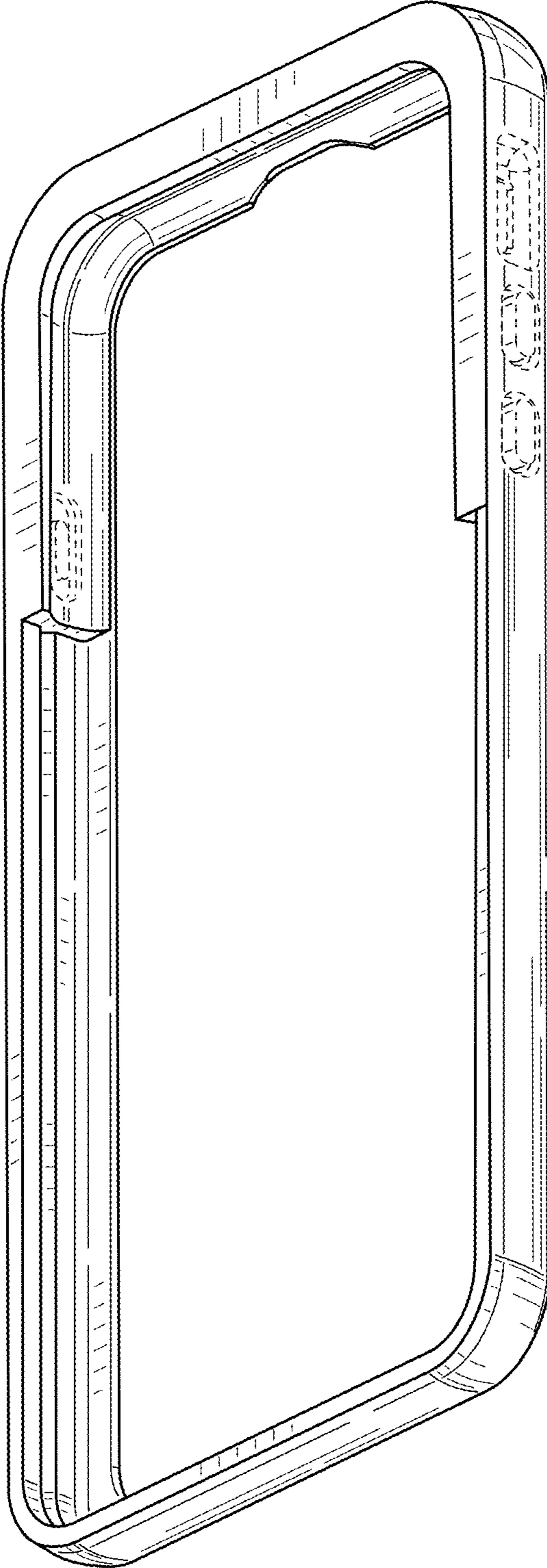
