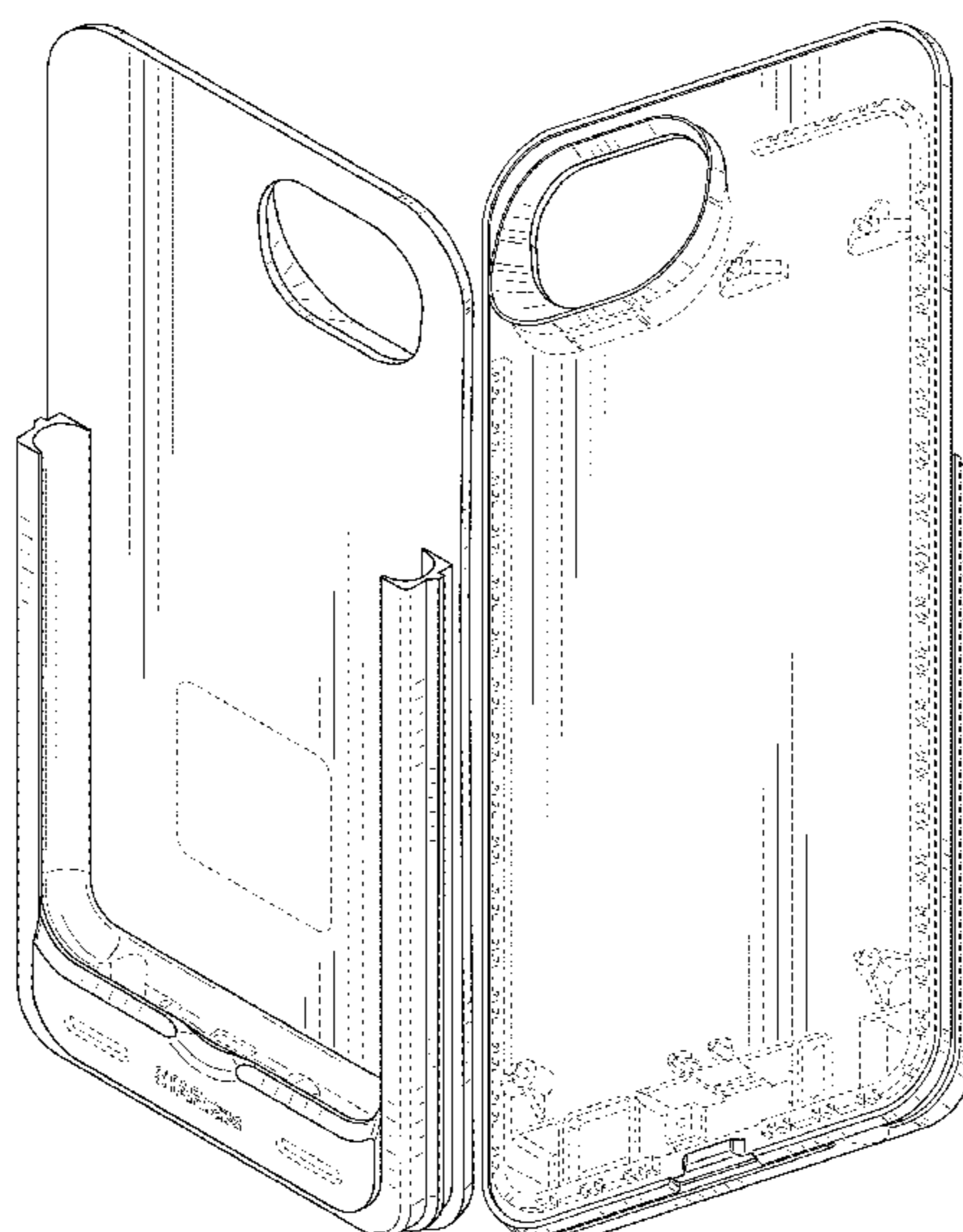
(57) **CLAIM**

The ornamental design for a case for mobile phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a case for mobile phone showing our new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a left side elevation view thereof;  
FIG. 6 is a top plan view thereof;

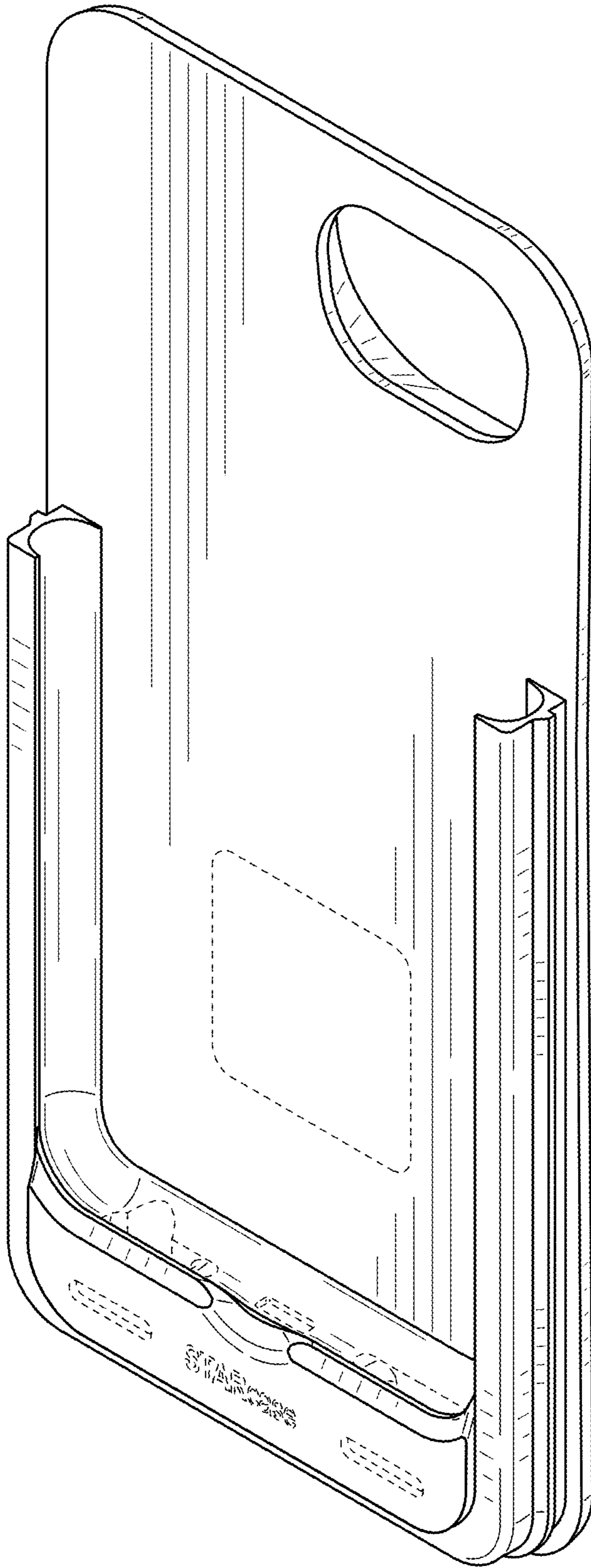

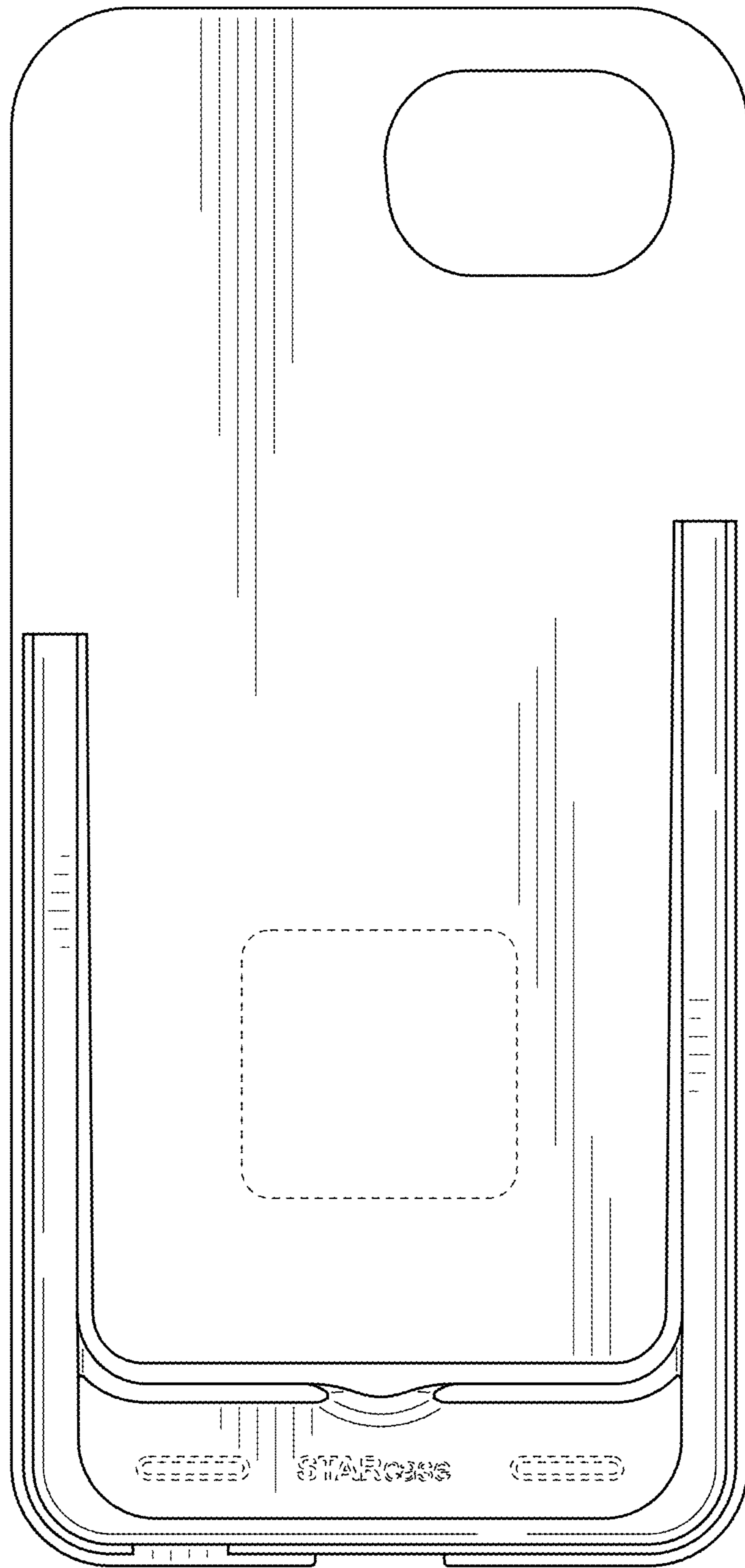

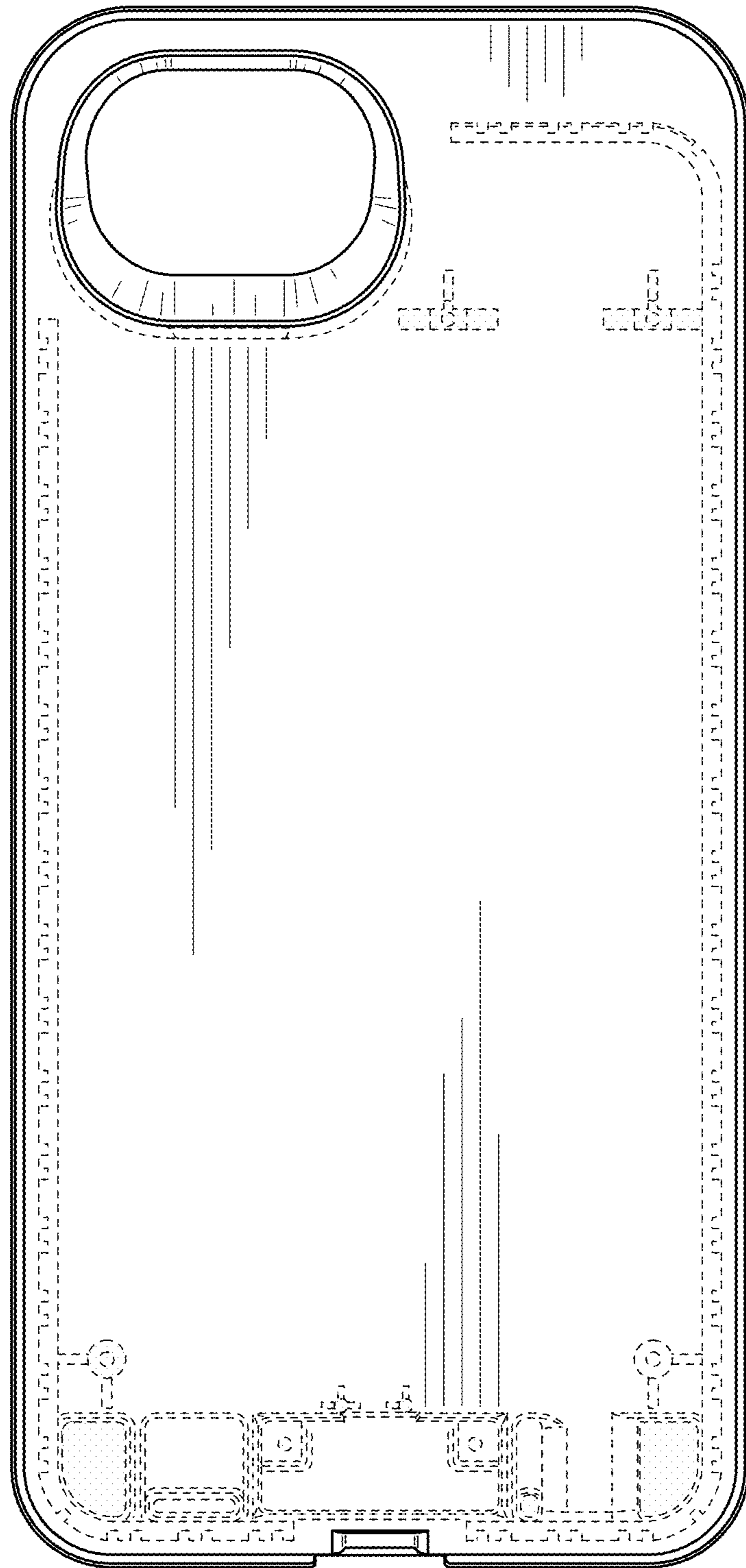

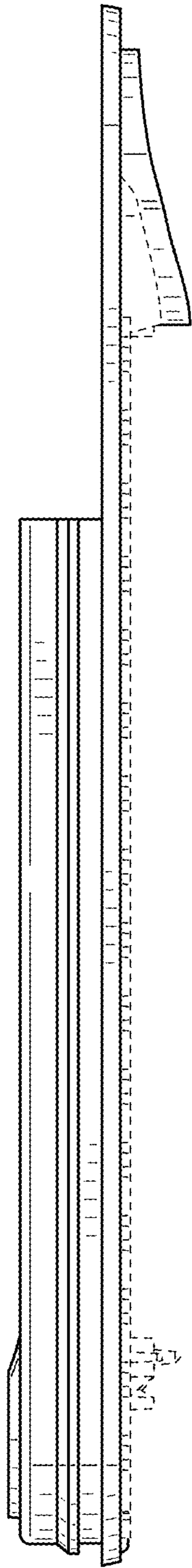

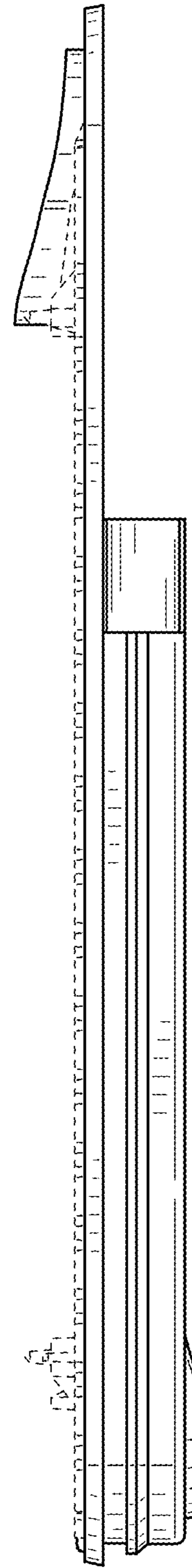

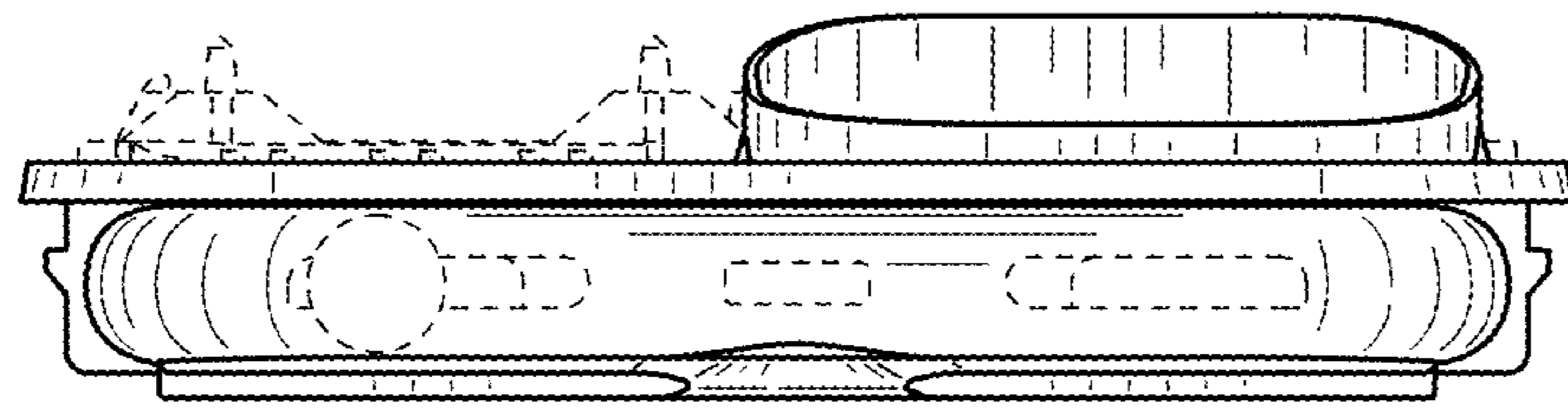

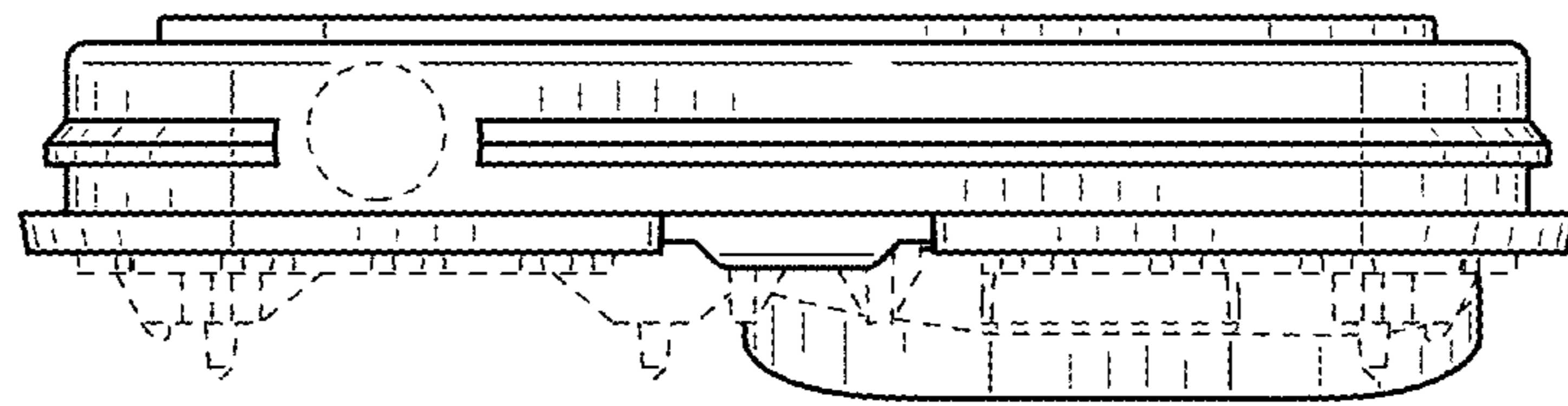

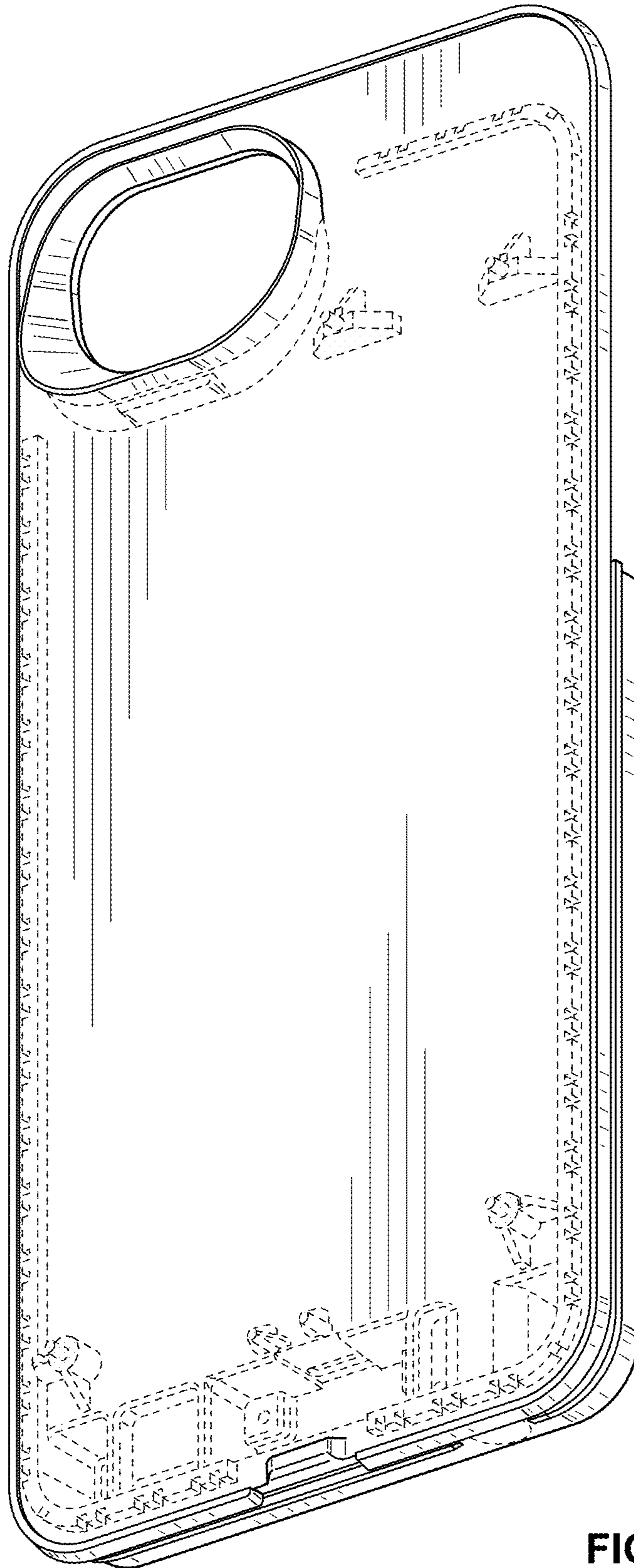
