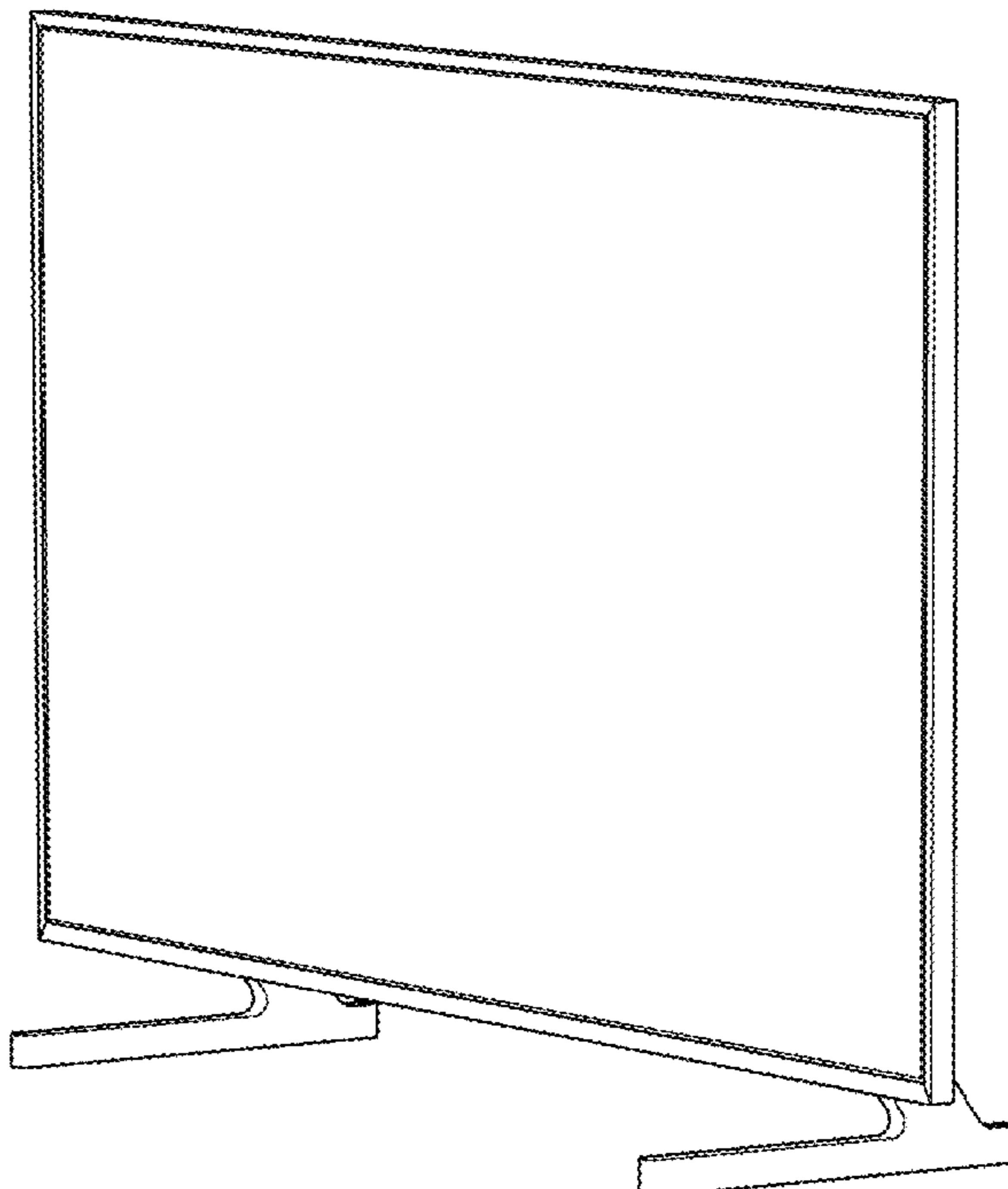
The ornamental design for a monitor for digital signage, as shown and described.

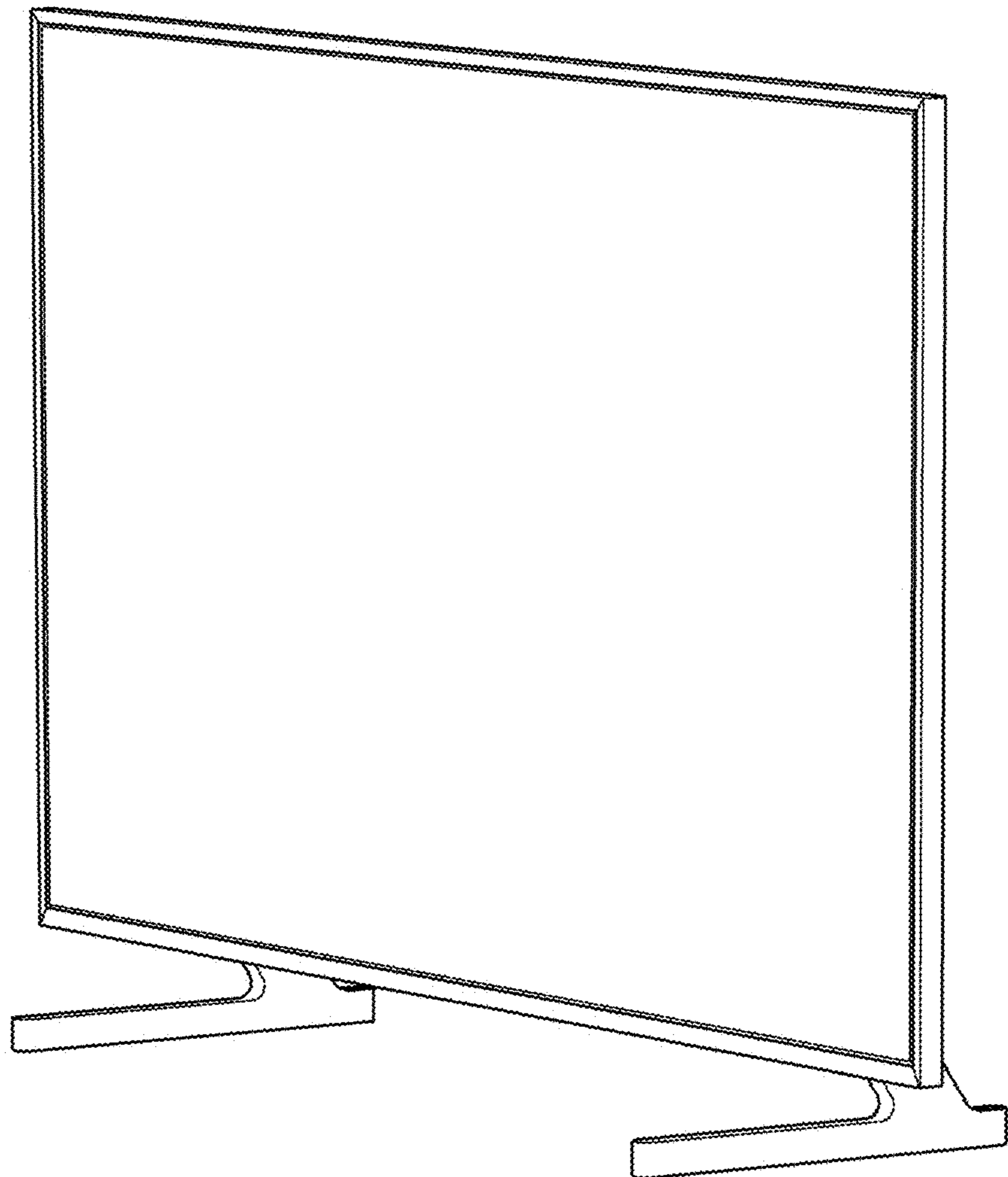

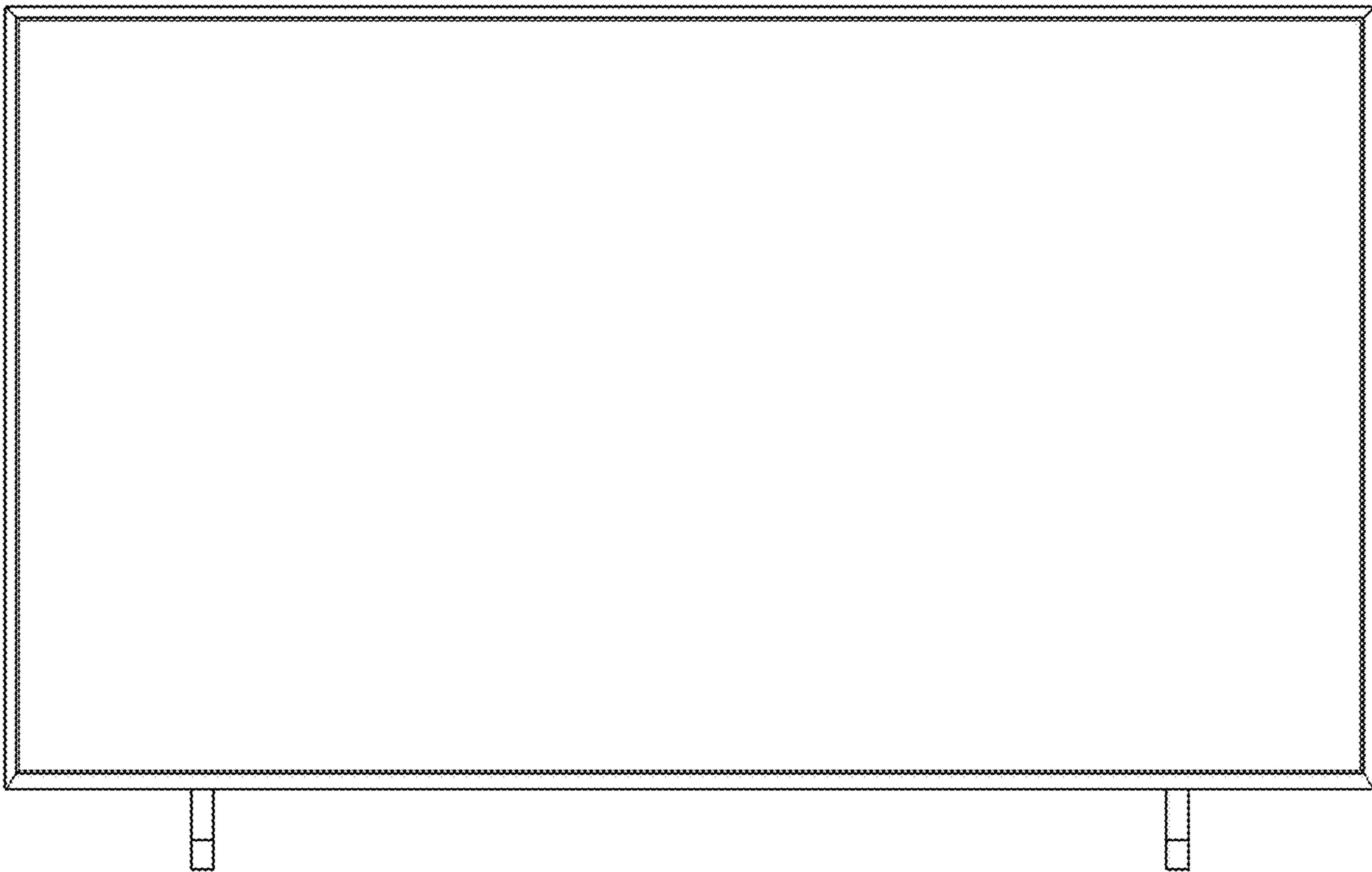

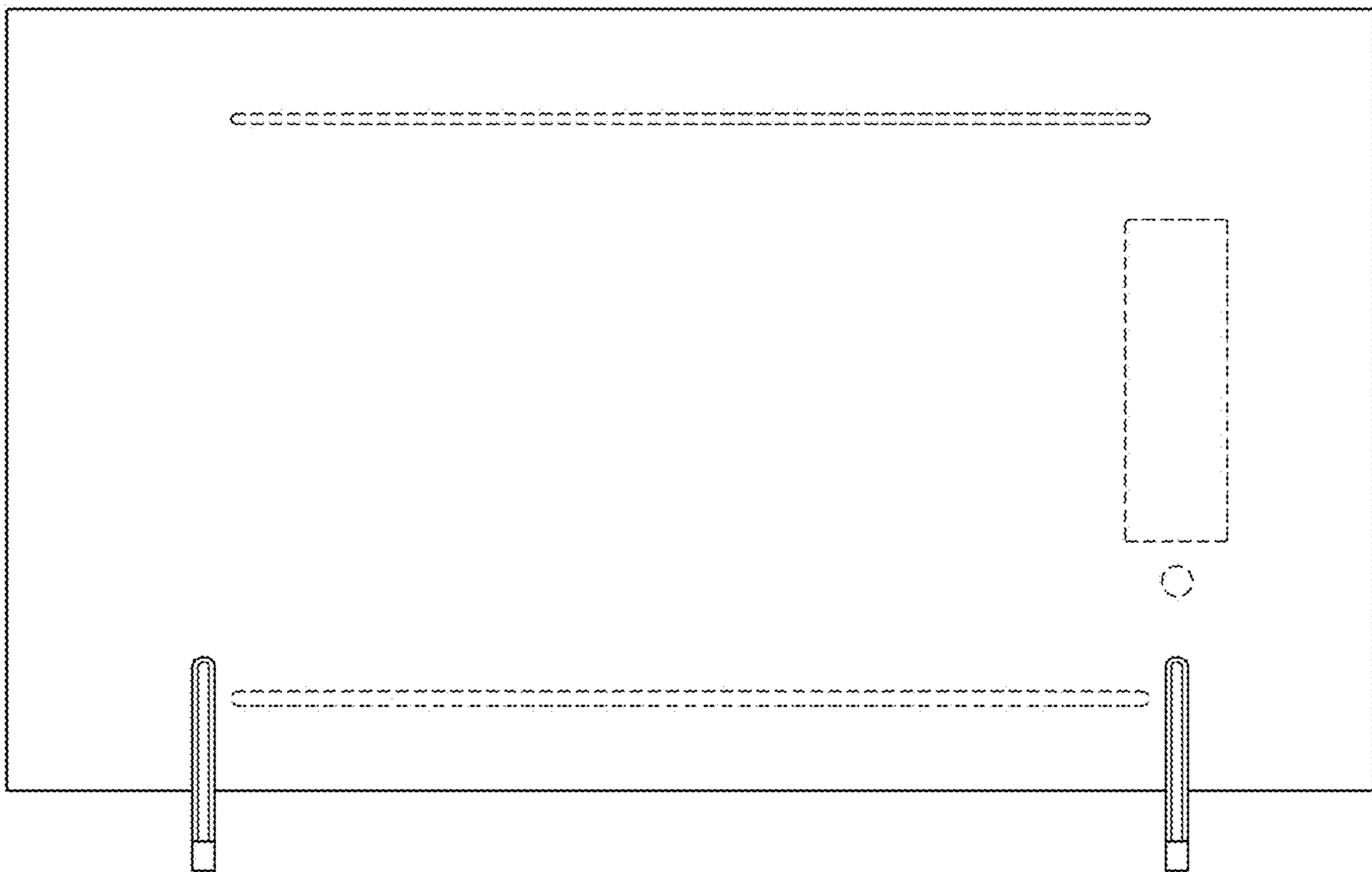

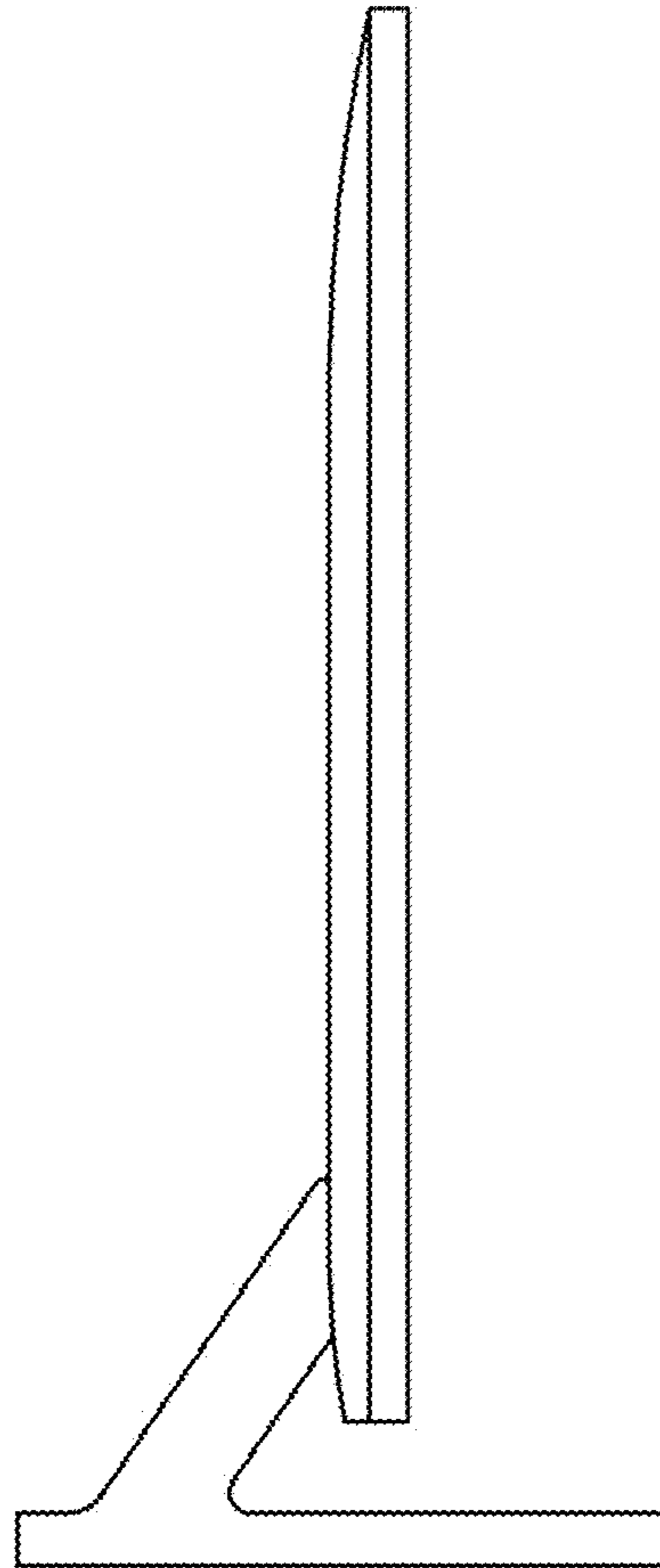

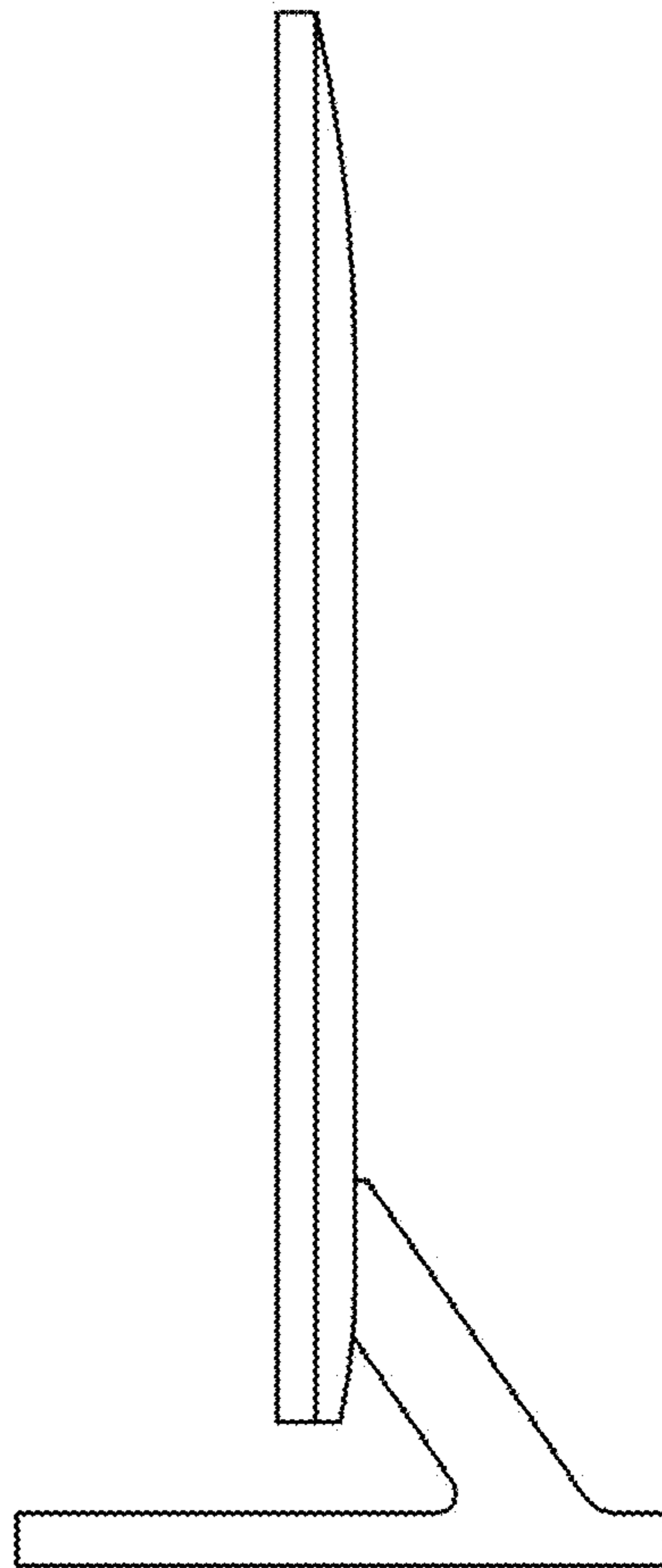

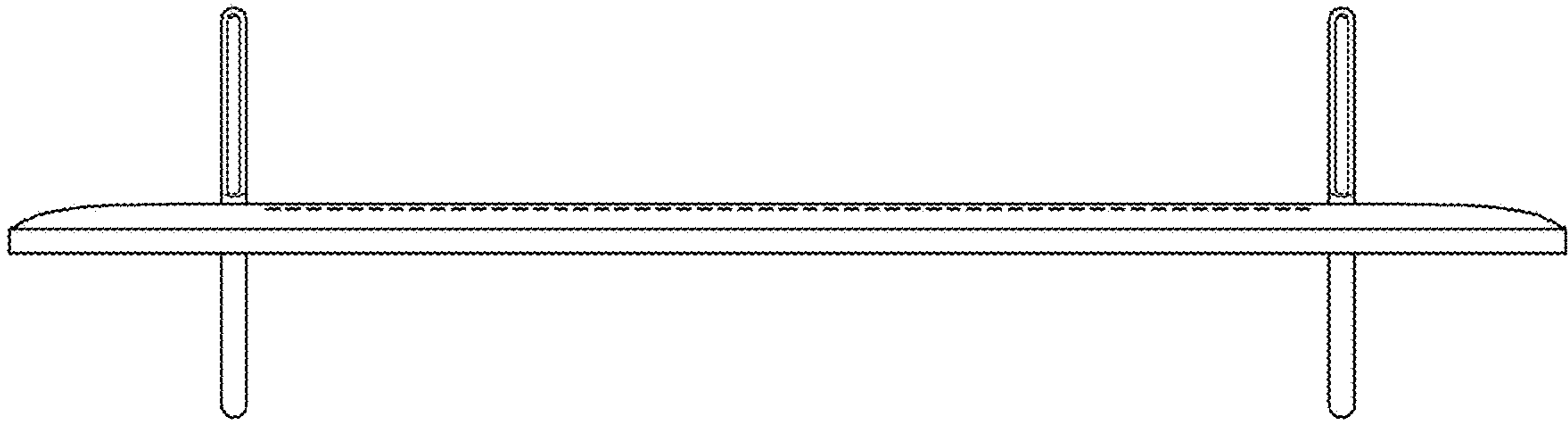
