The ornamental design for a stretching apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of a stretching apparatus showing my new design, shown in a condition of use;  
 FIG. 2 is perspective view thereof;  
 FIG. 3 is a front view thereof, the rear view being a mirror image thereof;  
 FIG. 4 is a left side view thereof, the right-side view being a mirror image thereof;  
 FIG. 5 is a bottom view thereof;  
 FIG. 6 is a top view thereof;  
 FIG. 7 is a perspective view of another embodiment of a stretching apparatus, in a condition of use thereof;  
 FIG. 8 is a perspective view thereof;  
 FIG. 9 is a front view thereof, the rear view being a mirror image thereof;  
 FIG. 10 is a left side view thereof, the right-side view being a mirror image thereof;  
 FIG. 11 is a bottom view thereof; and,  
 FIG. 12 is a top view thereof.

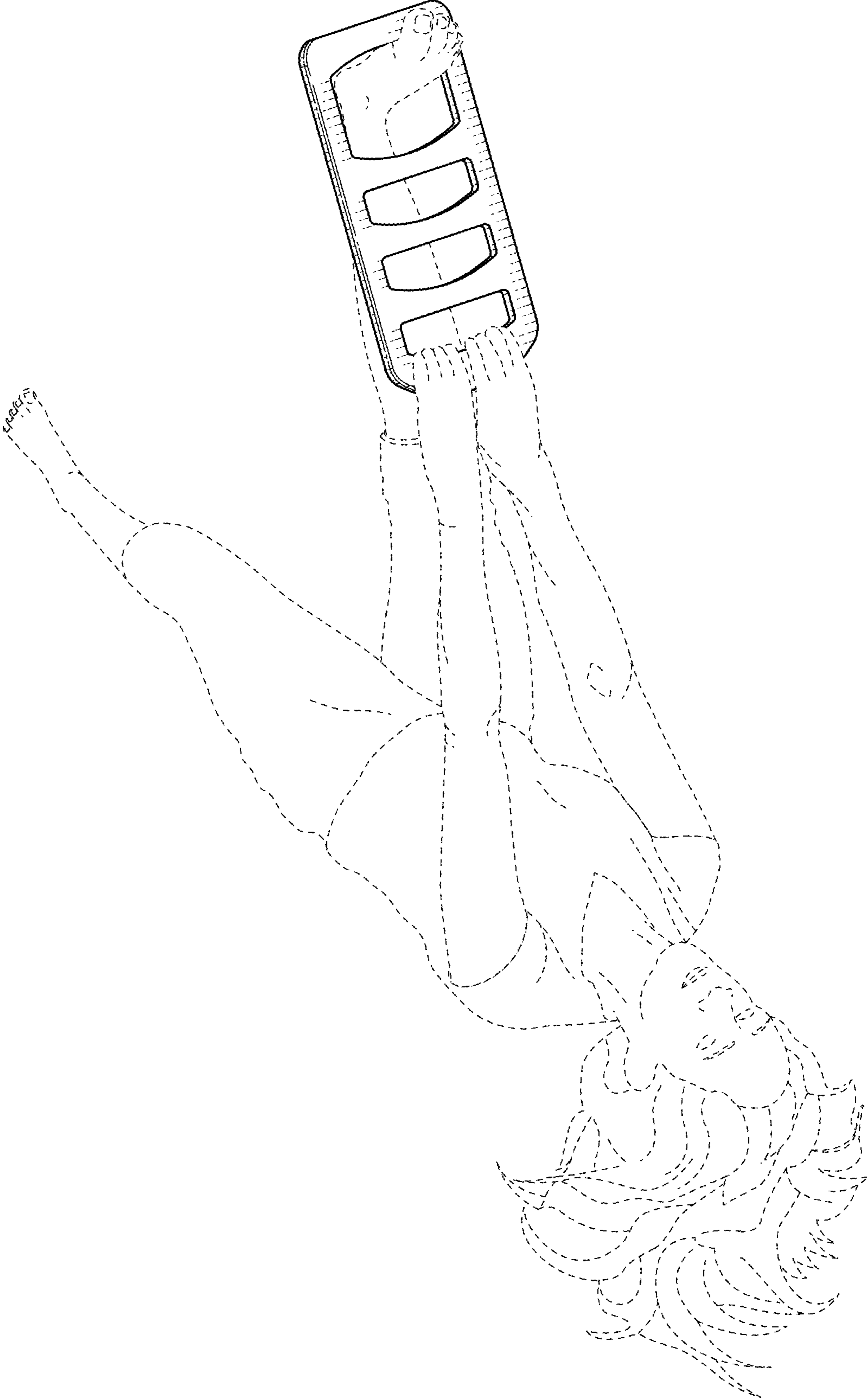

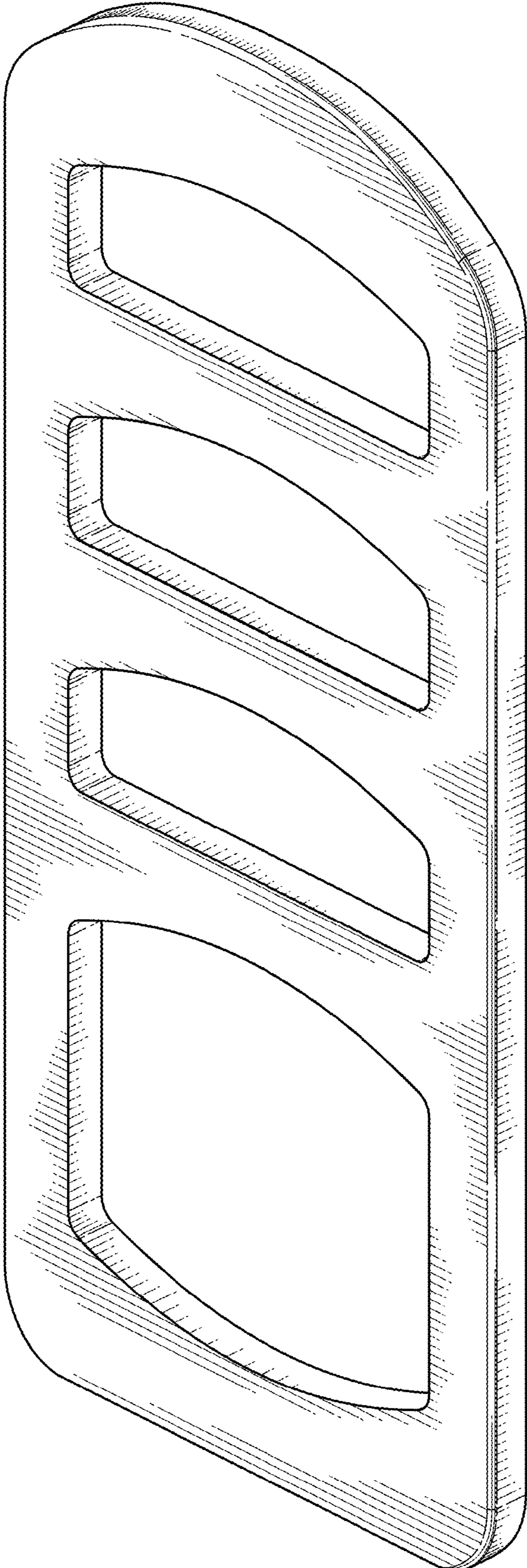

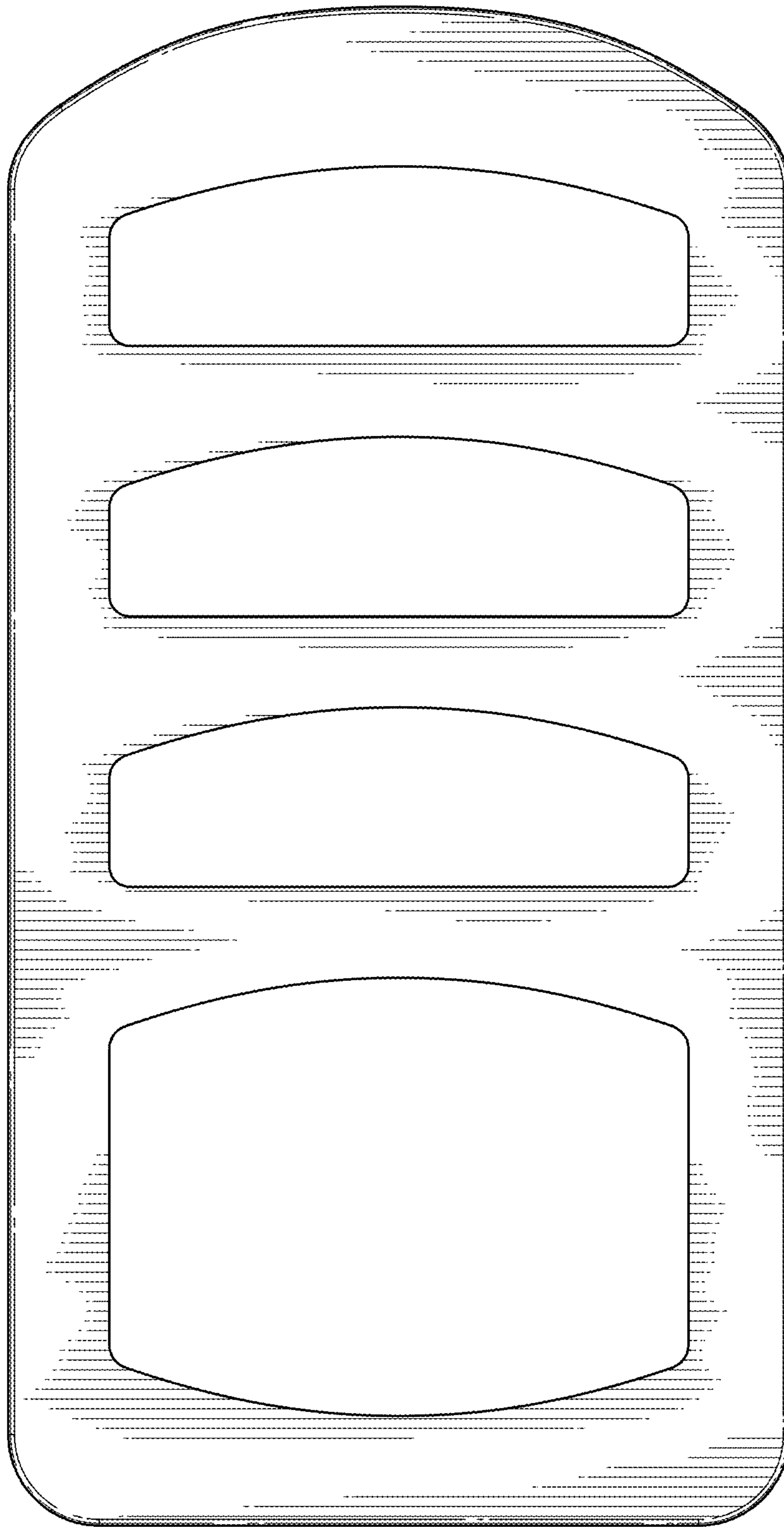

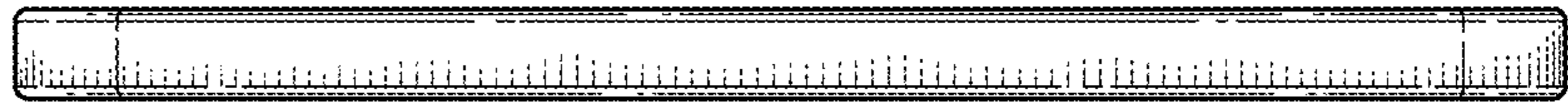

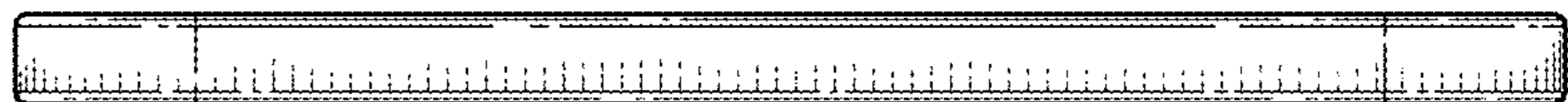

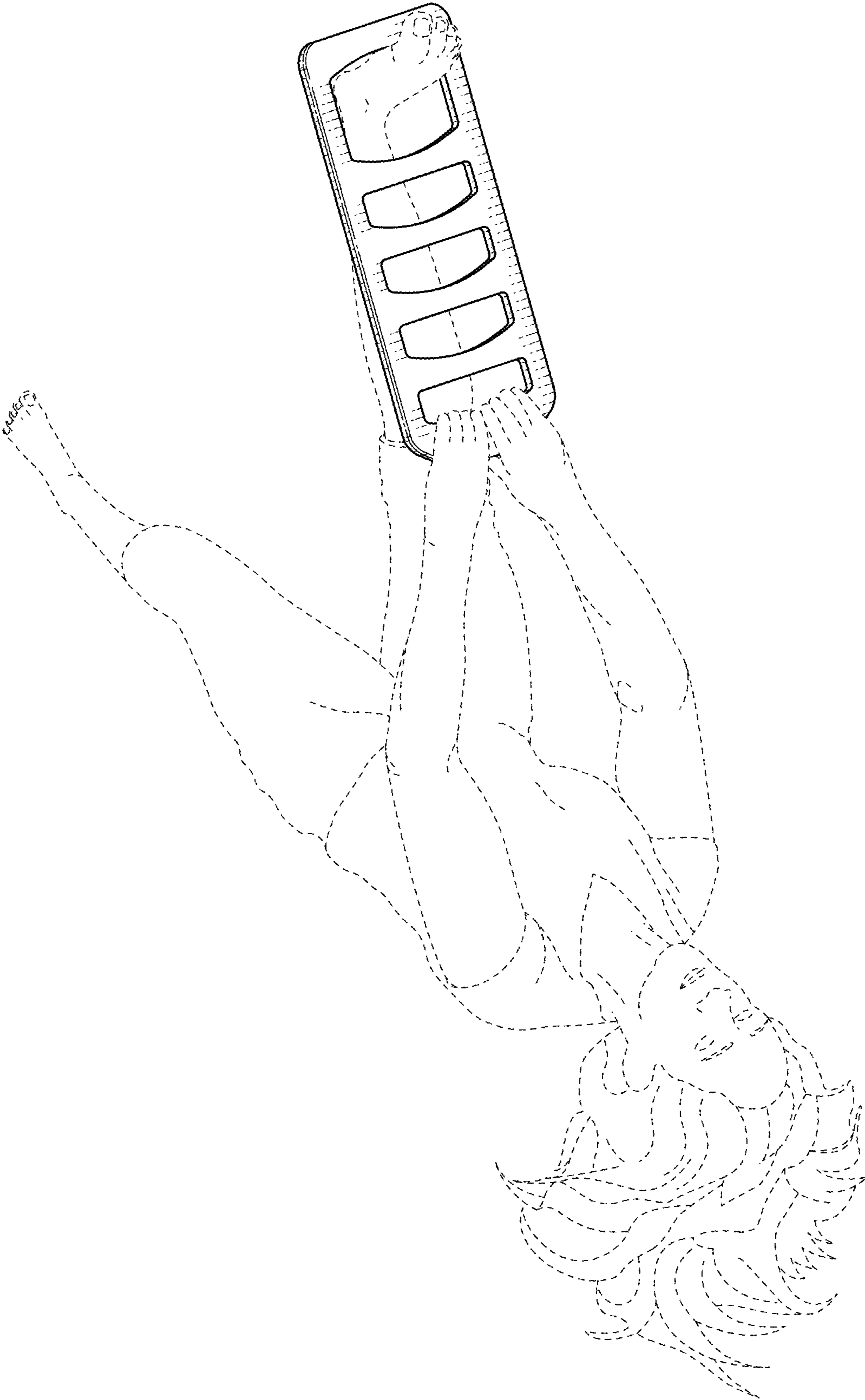

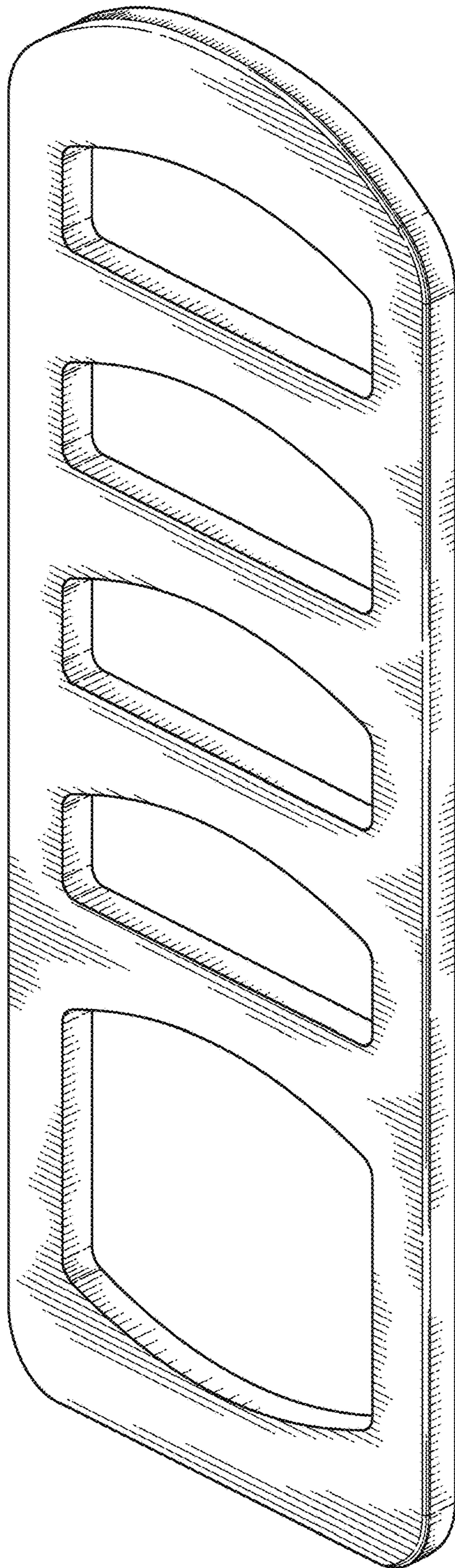

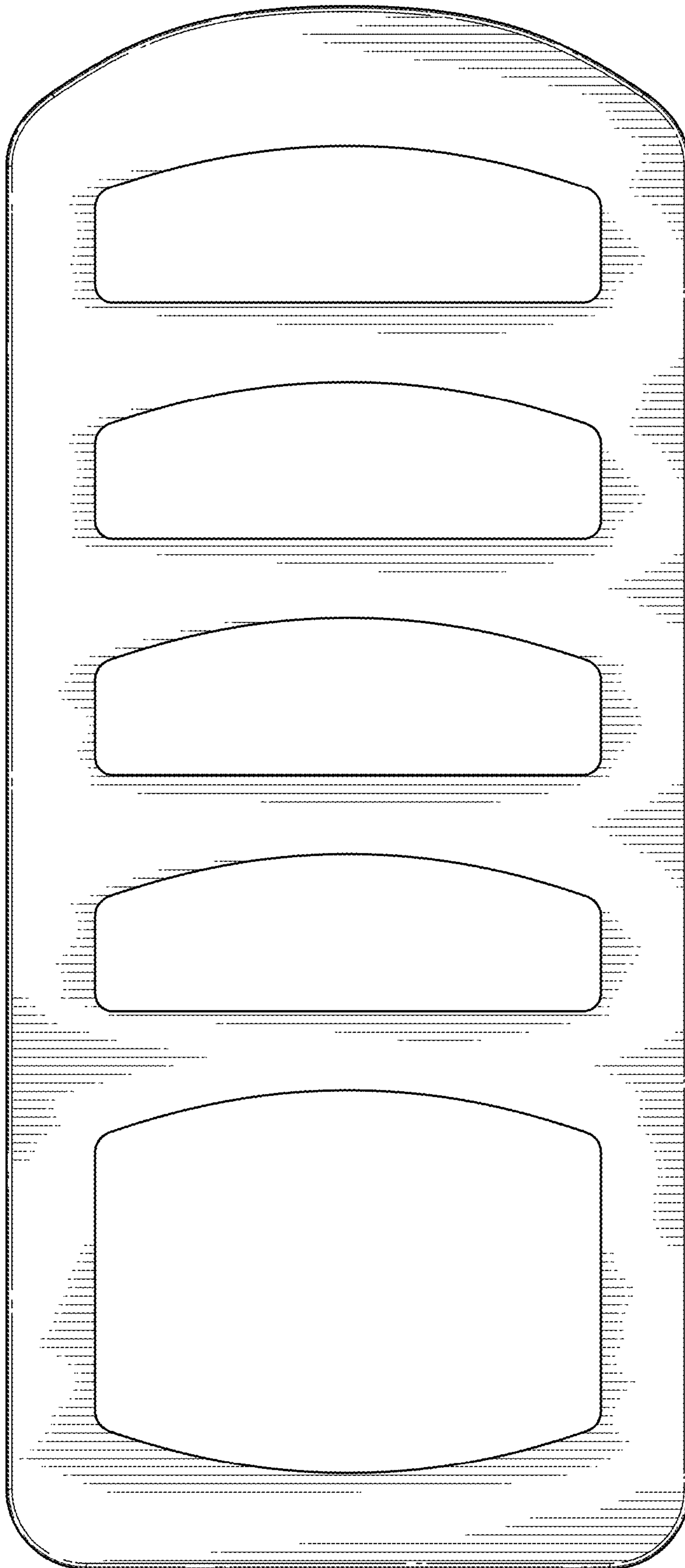

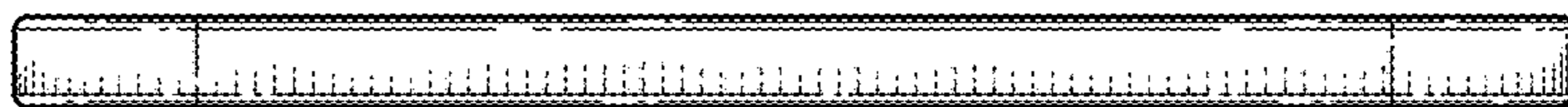
