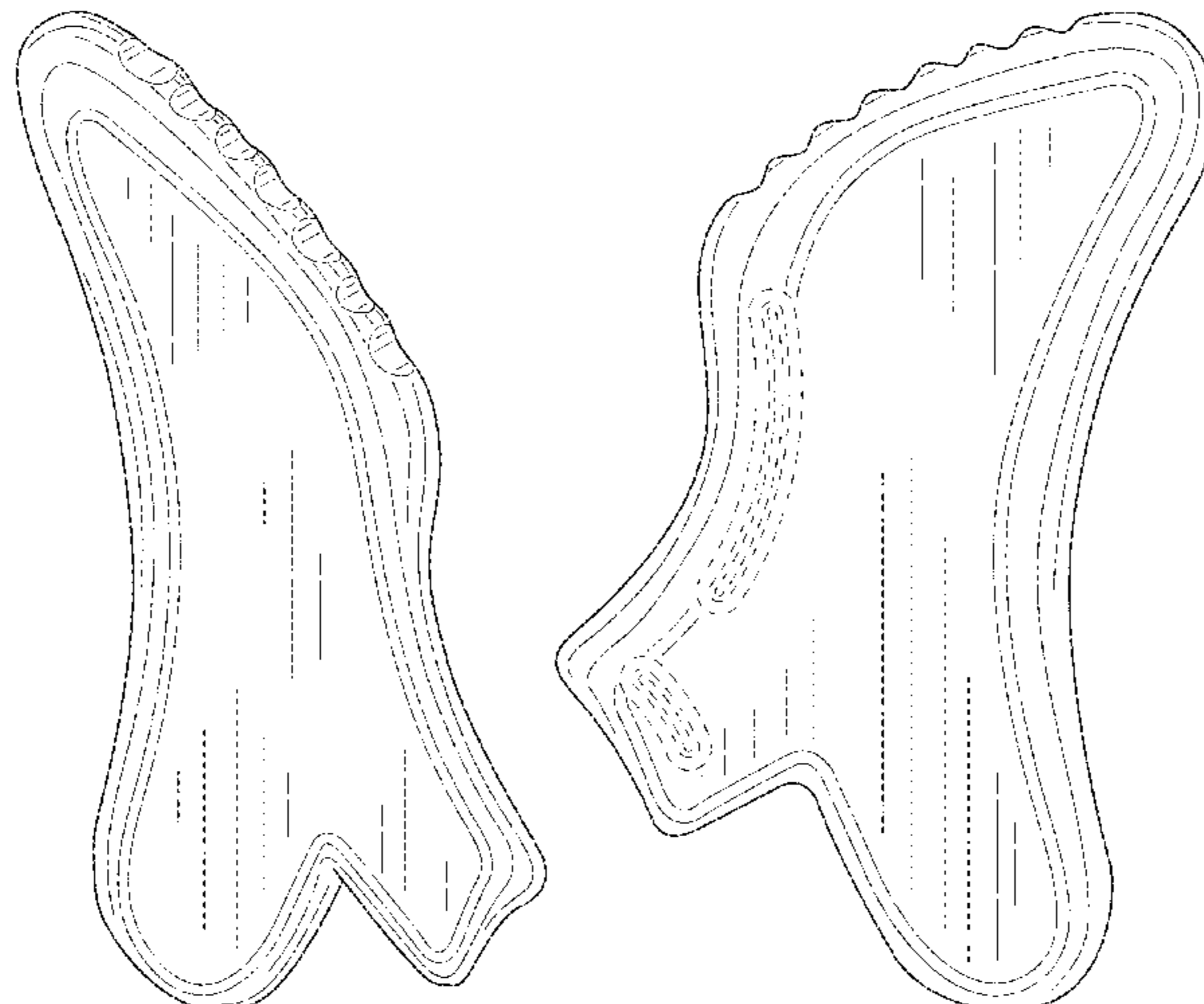
(57) **CLAIM**

The ornamental design for a massage device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a massage device according to the claimed design;

FIG. 4 is a right elevation view of the massage device of FIG. 1;

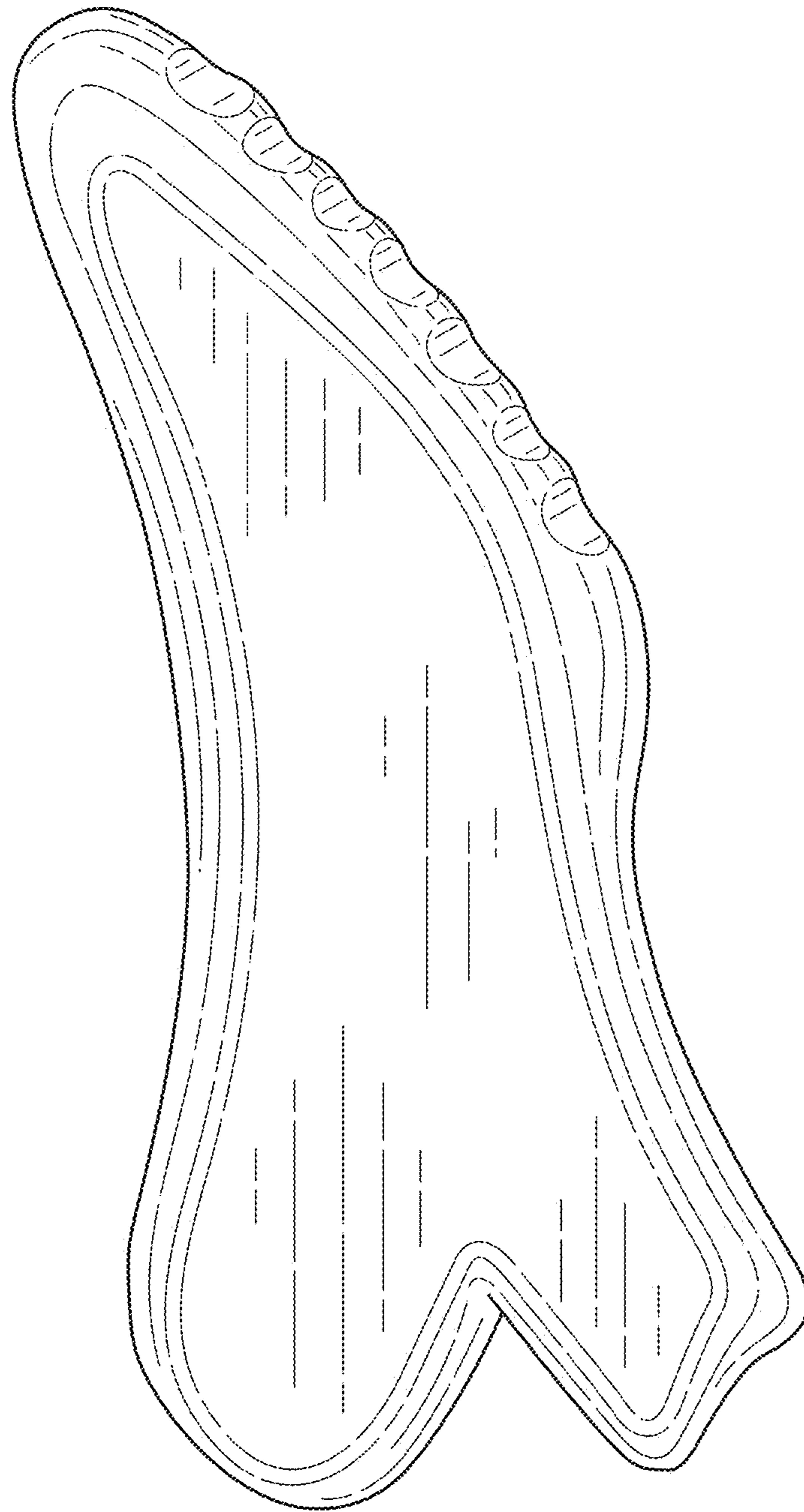

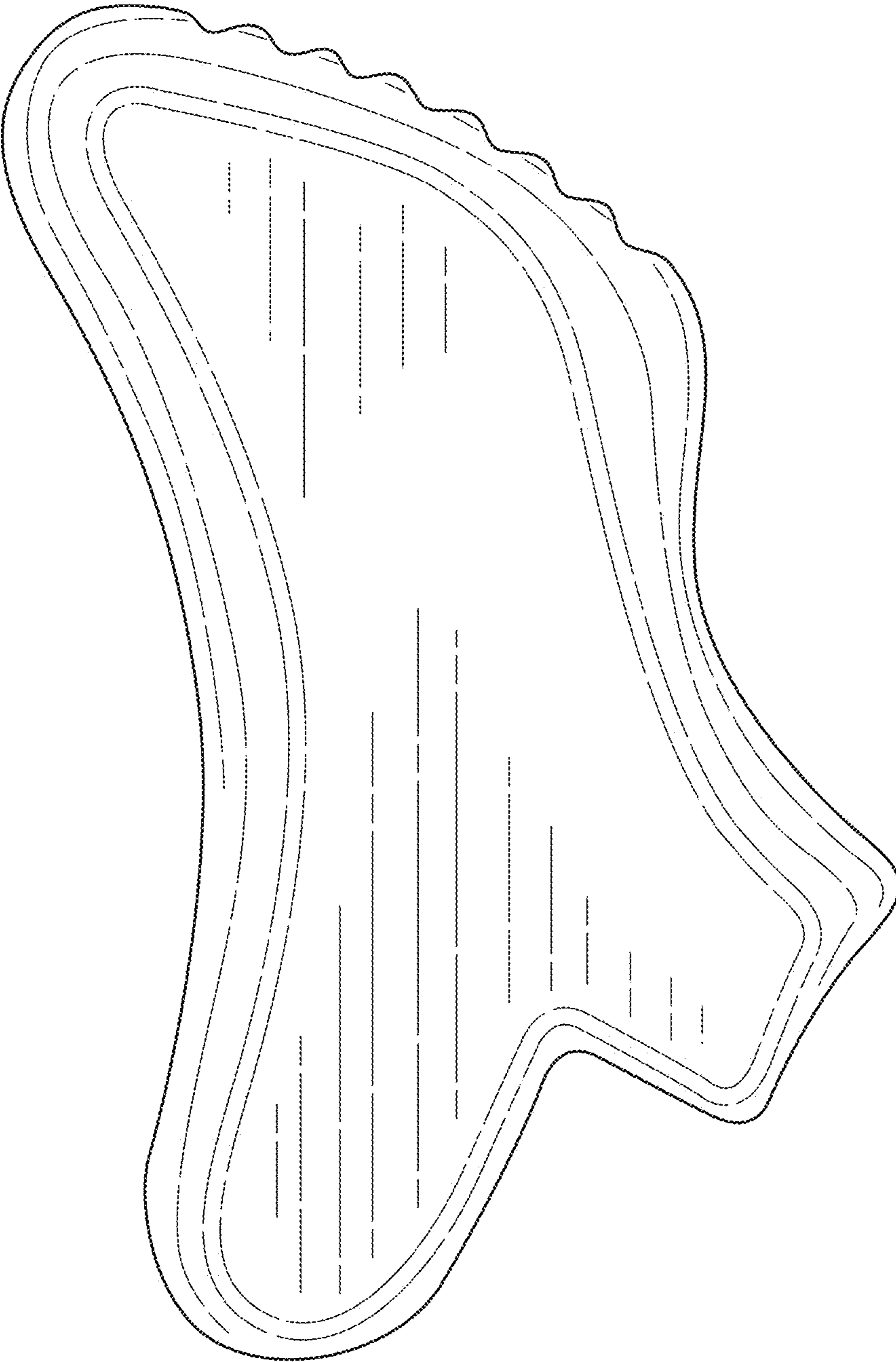

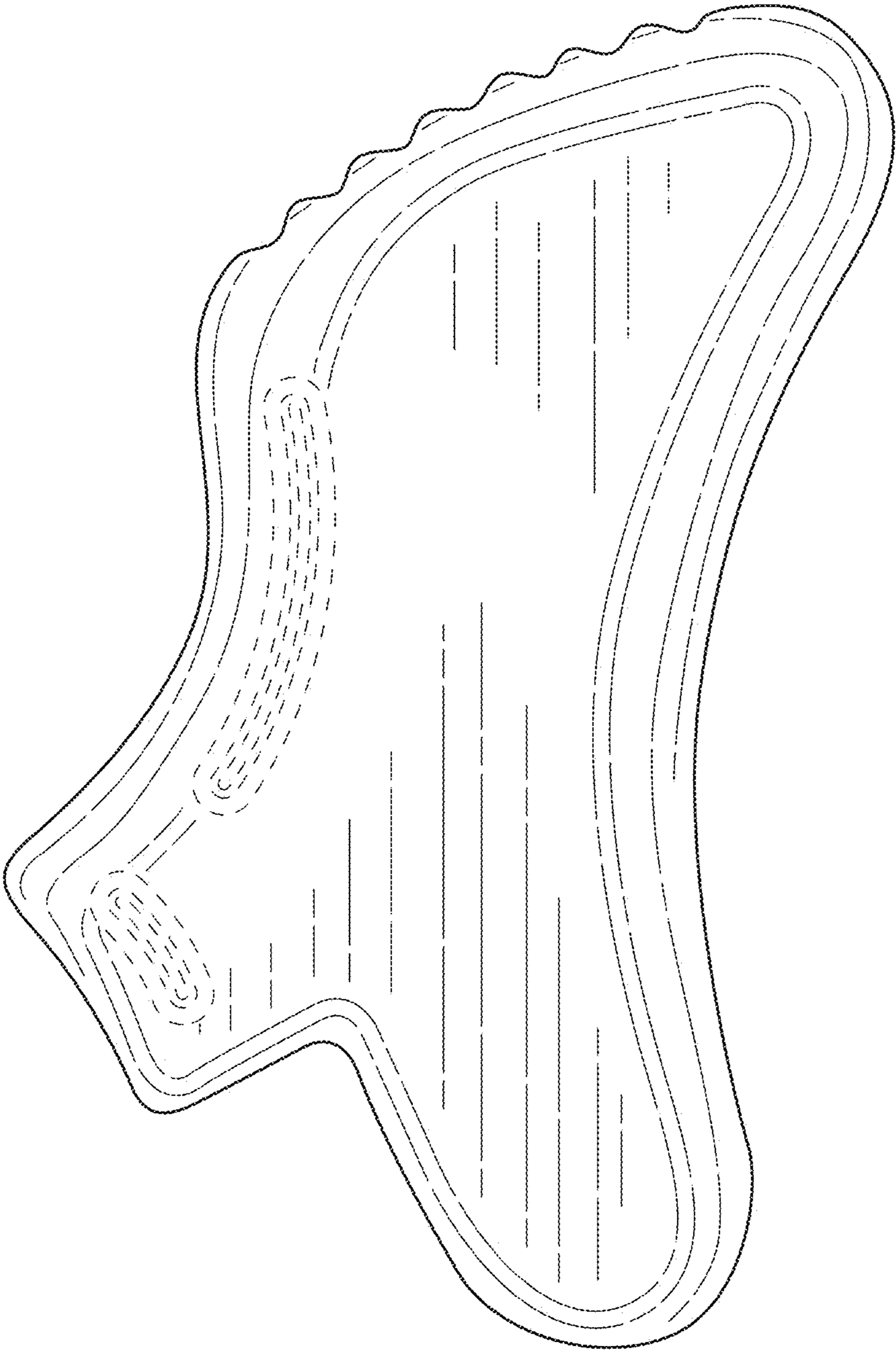

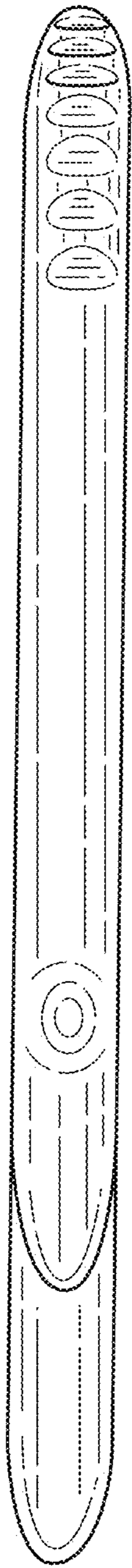

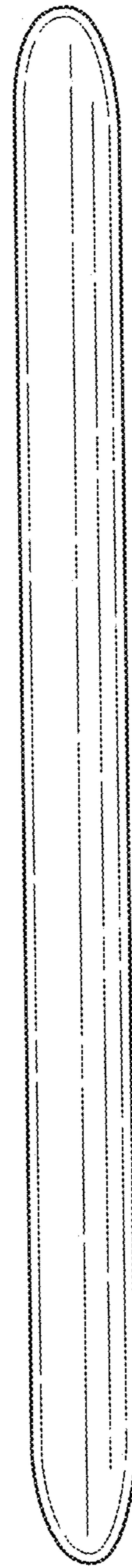

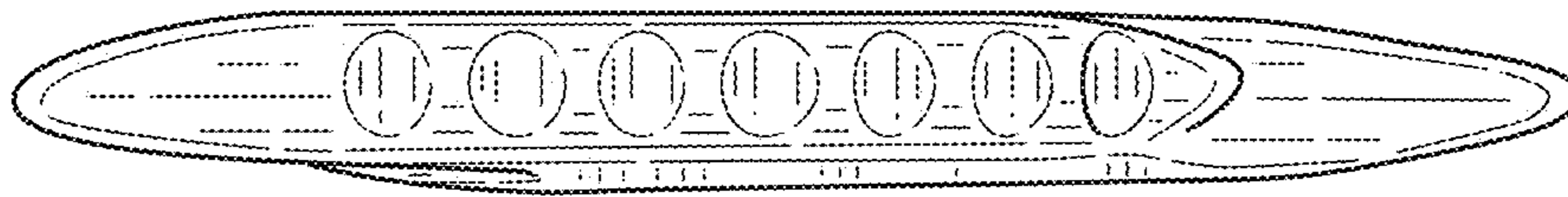

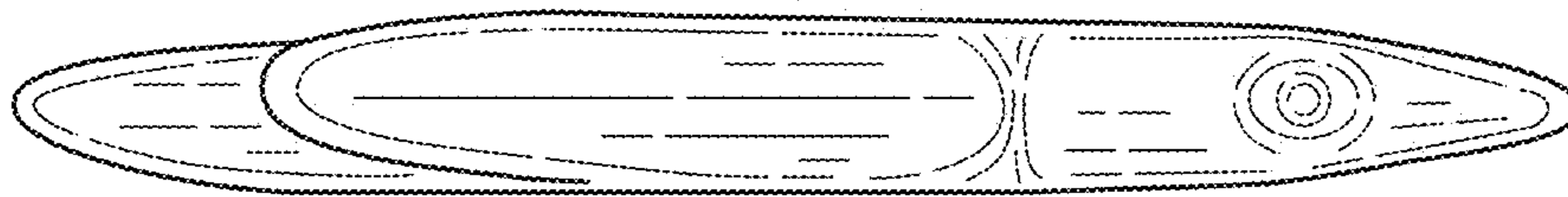
