DESCRIPTION

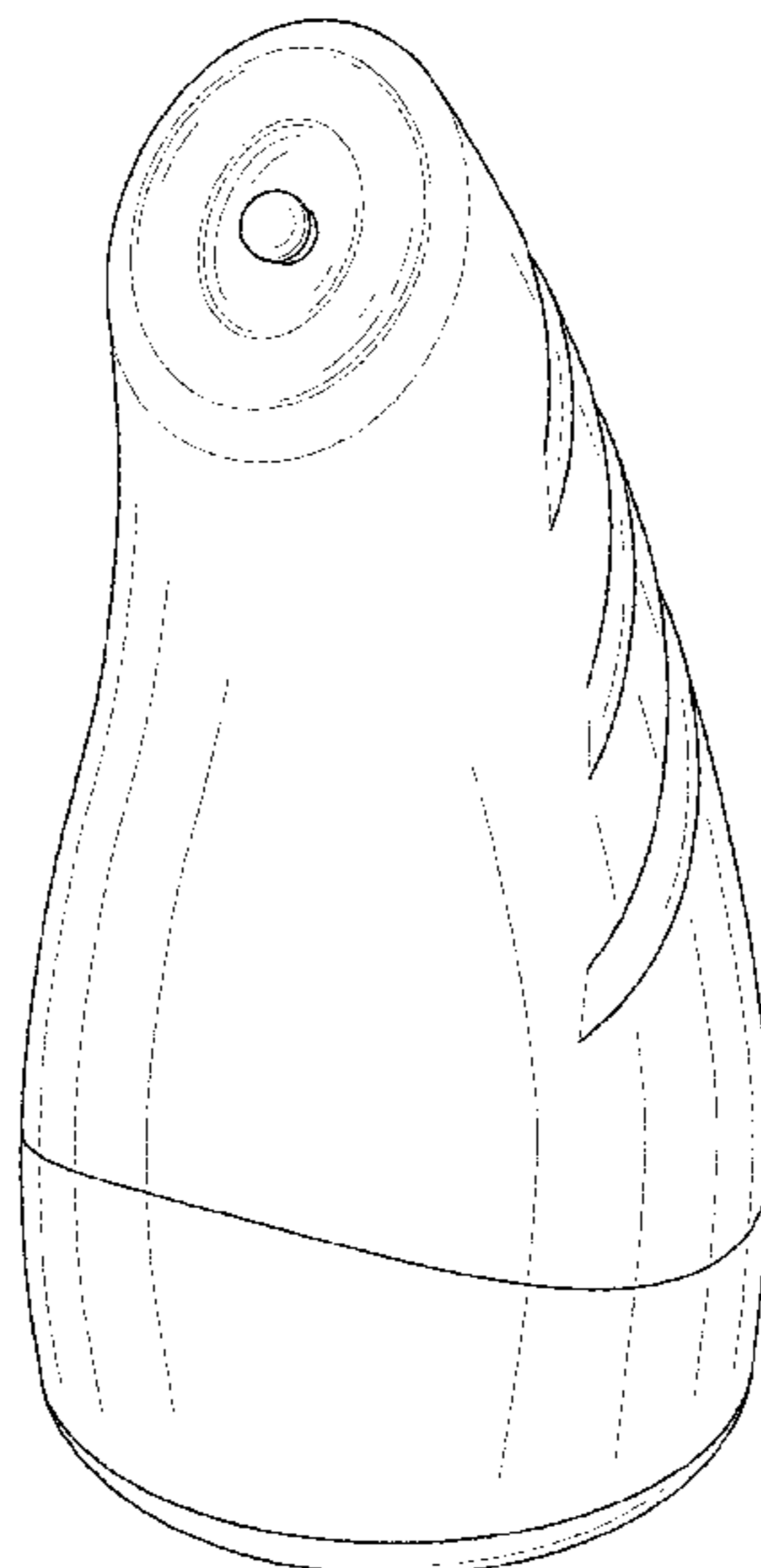
FIG. 1 is a front, right side, top perspective view of a sex toy showing my new design;

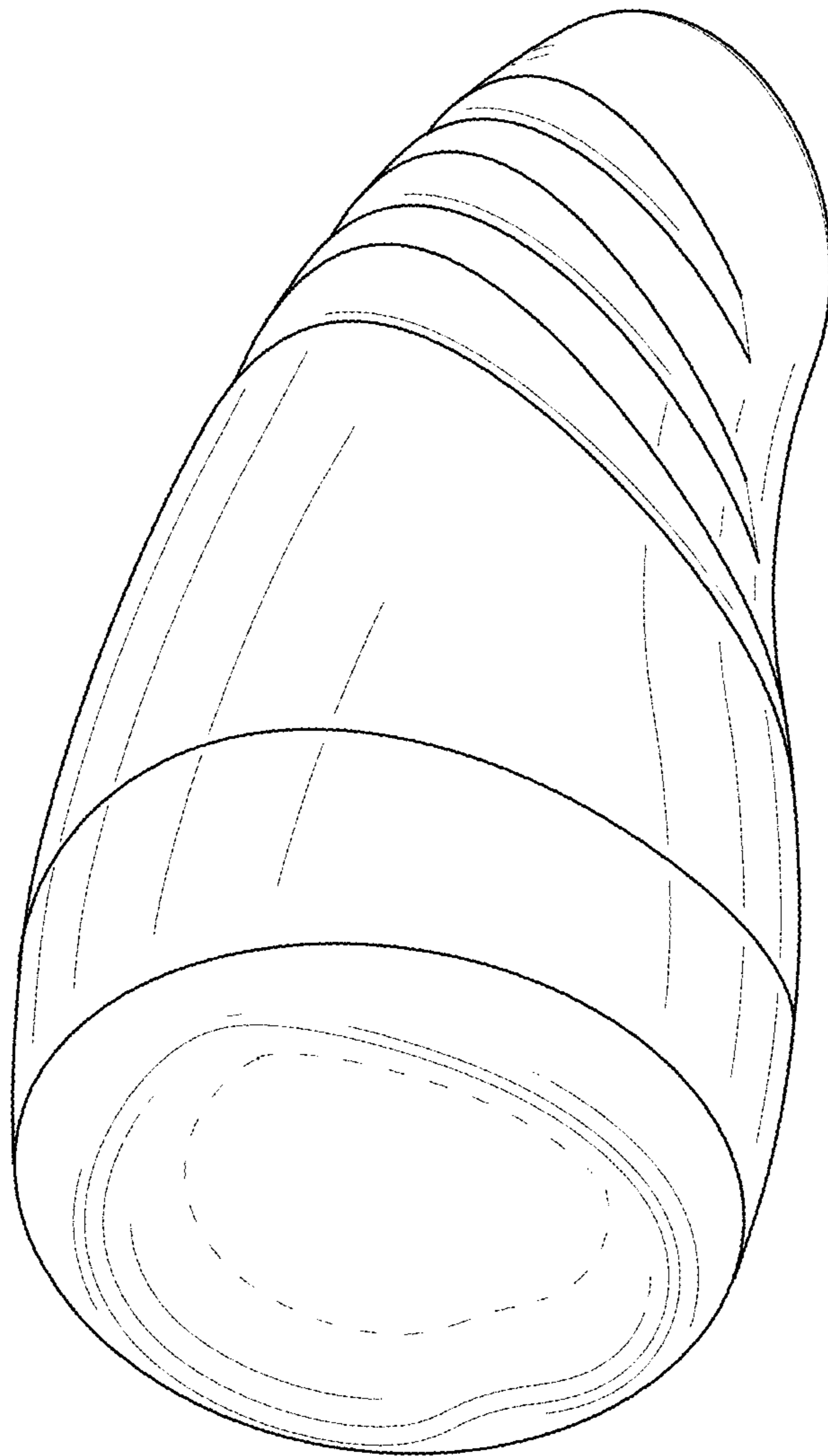

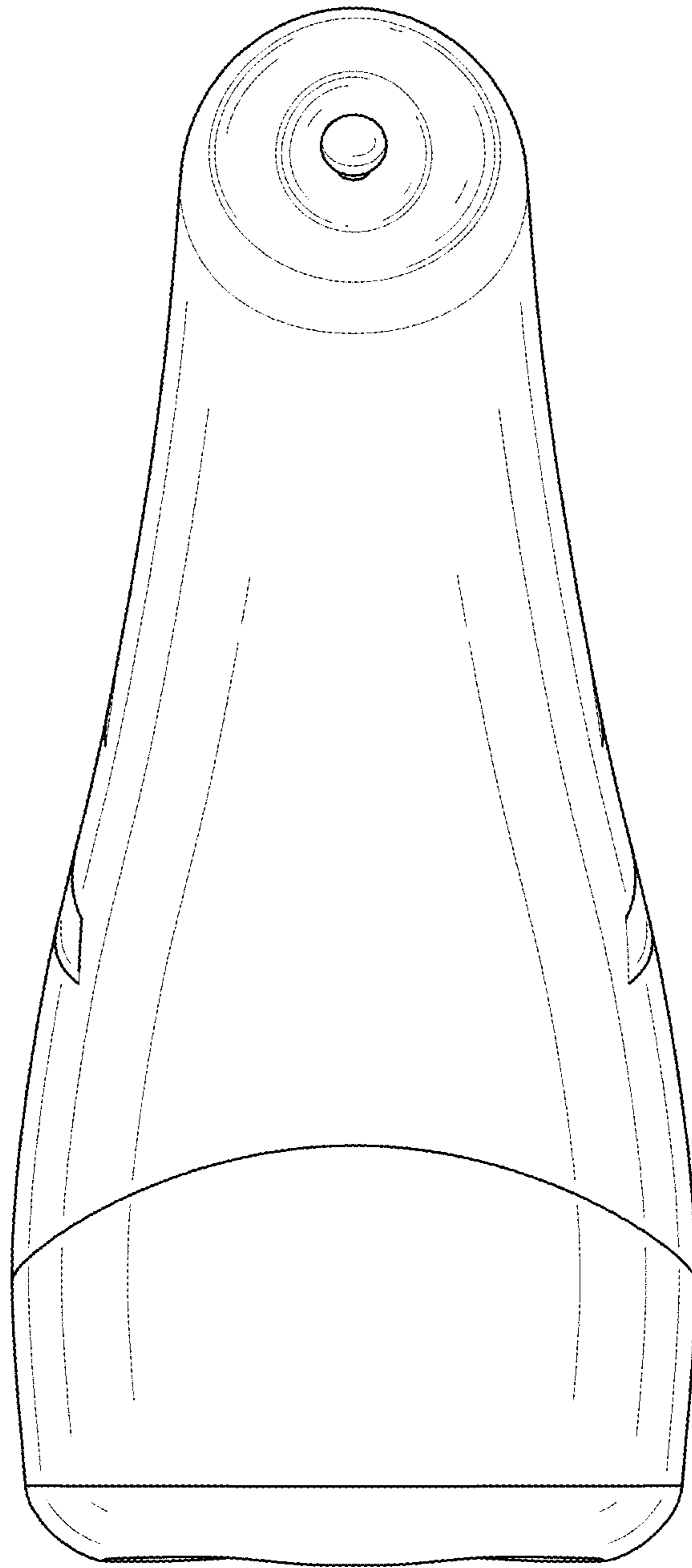

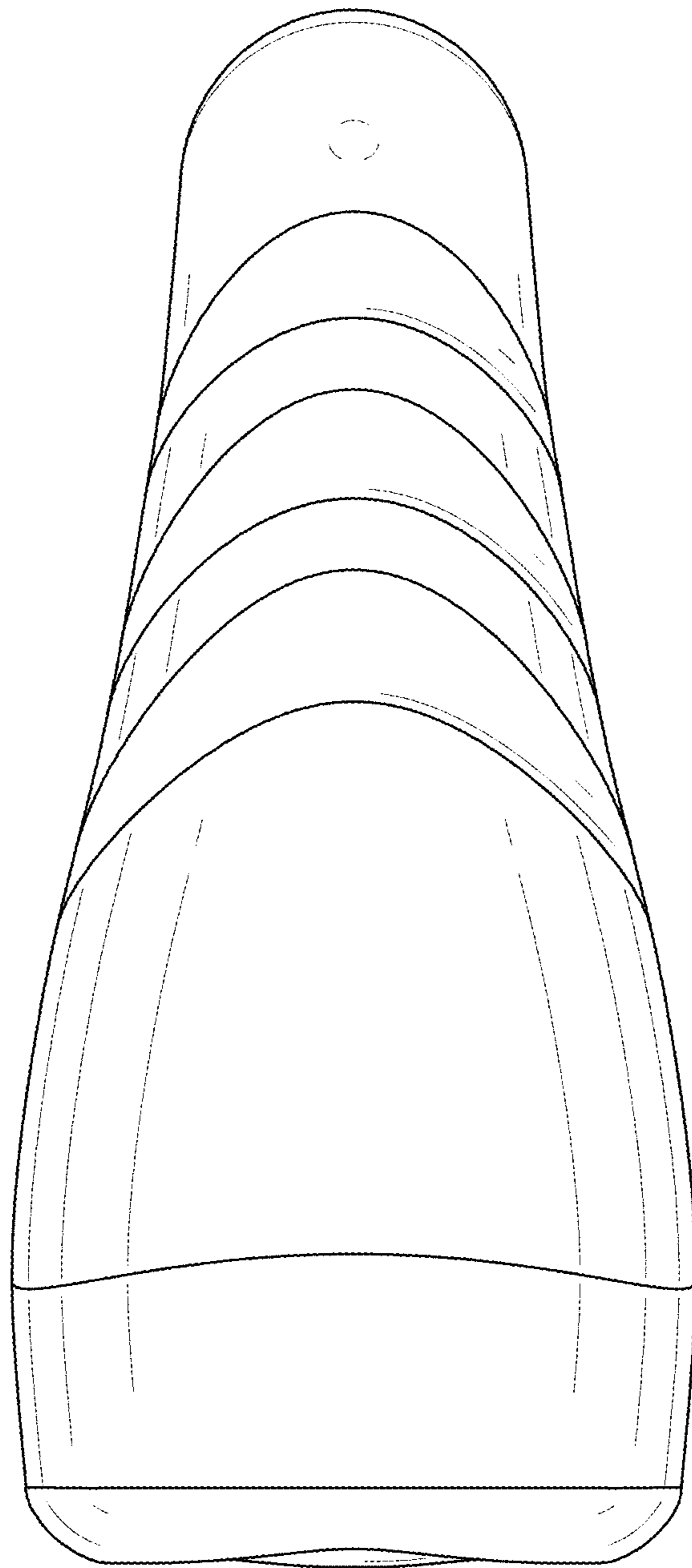

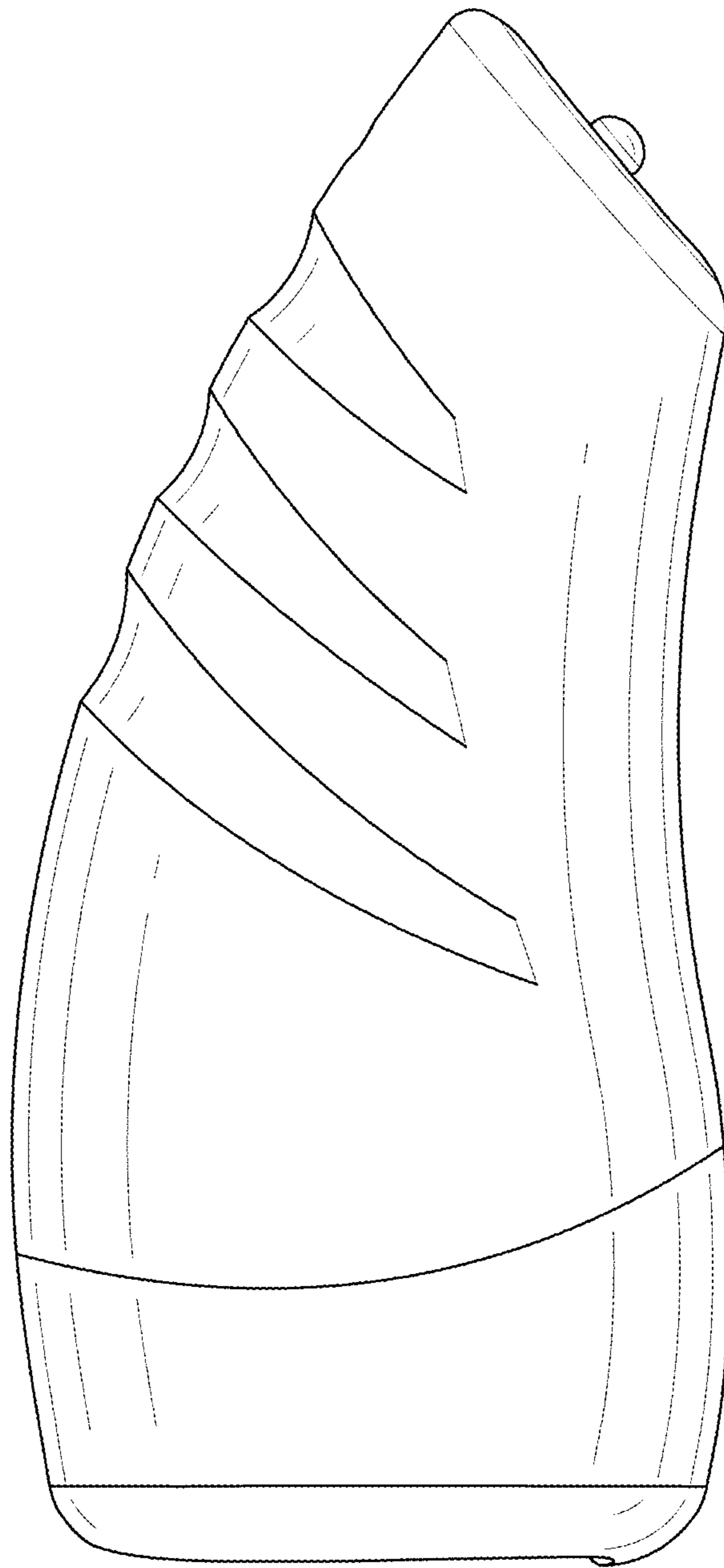

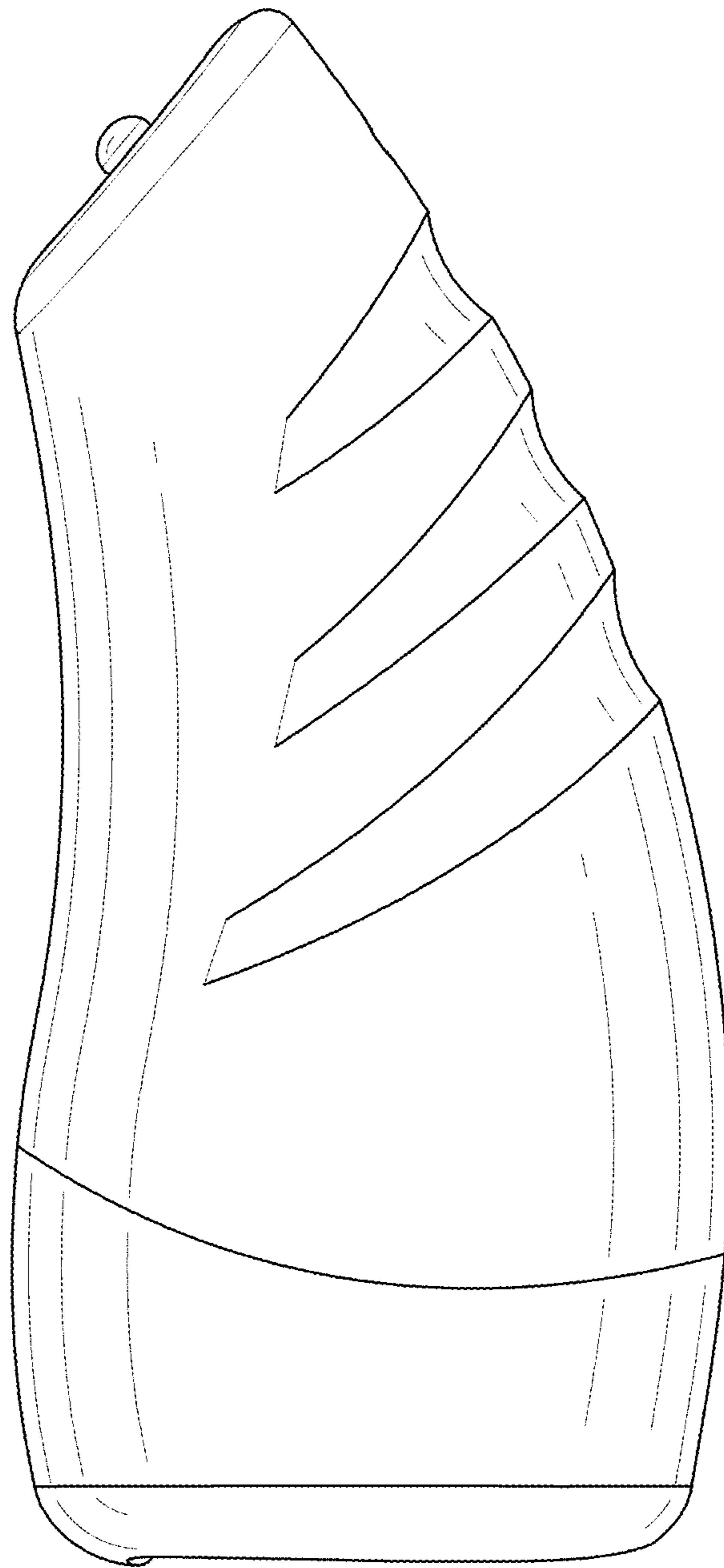

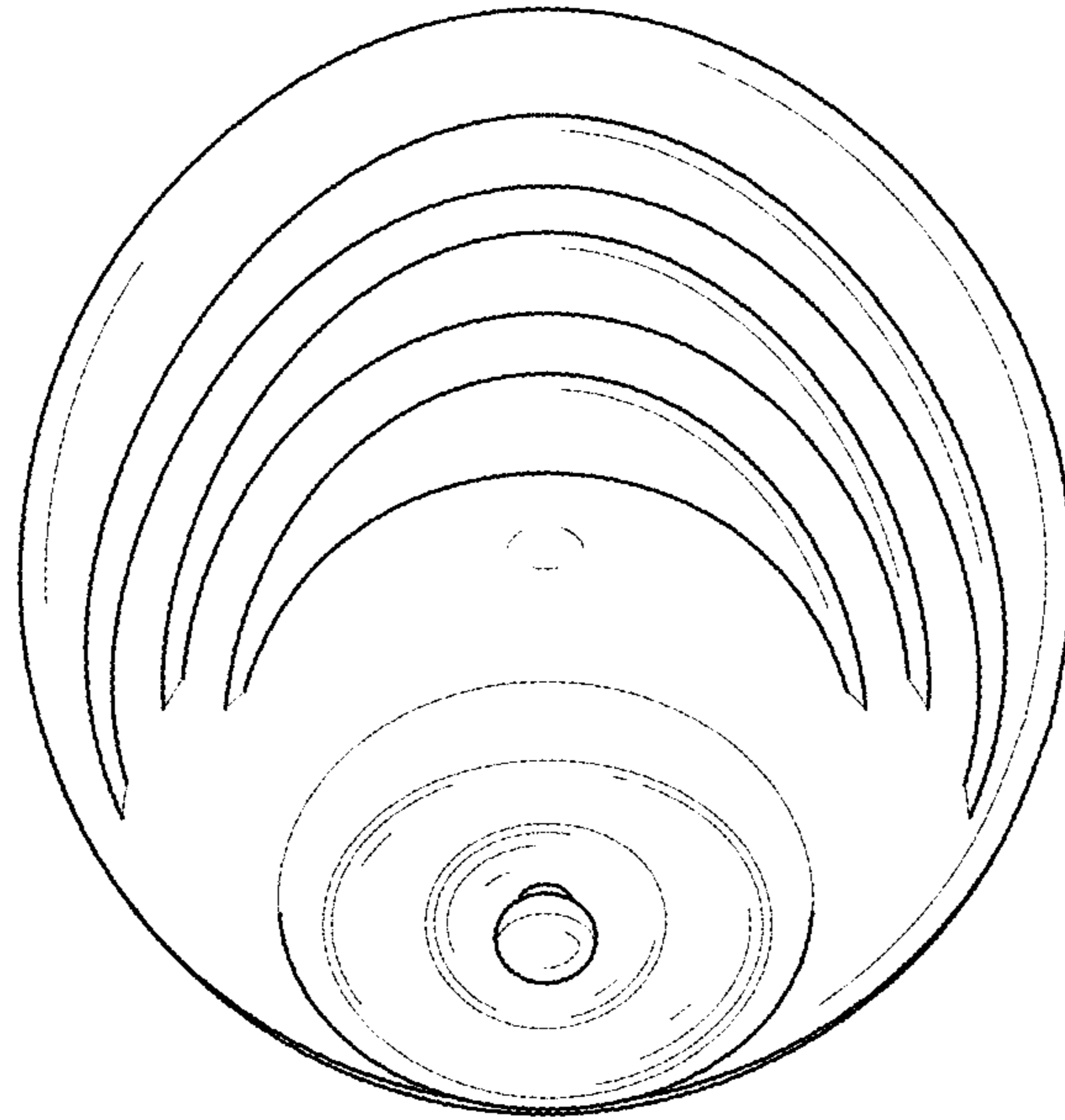

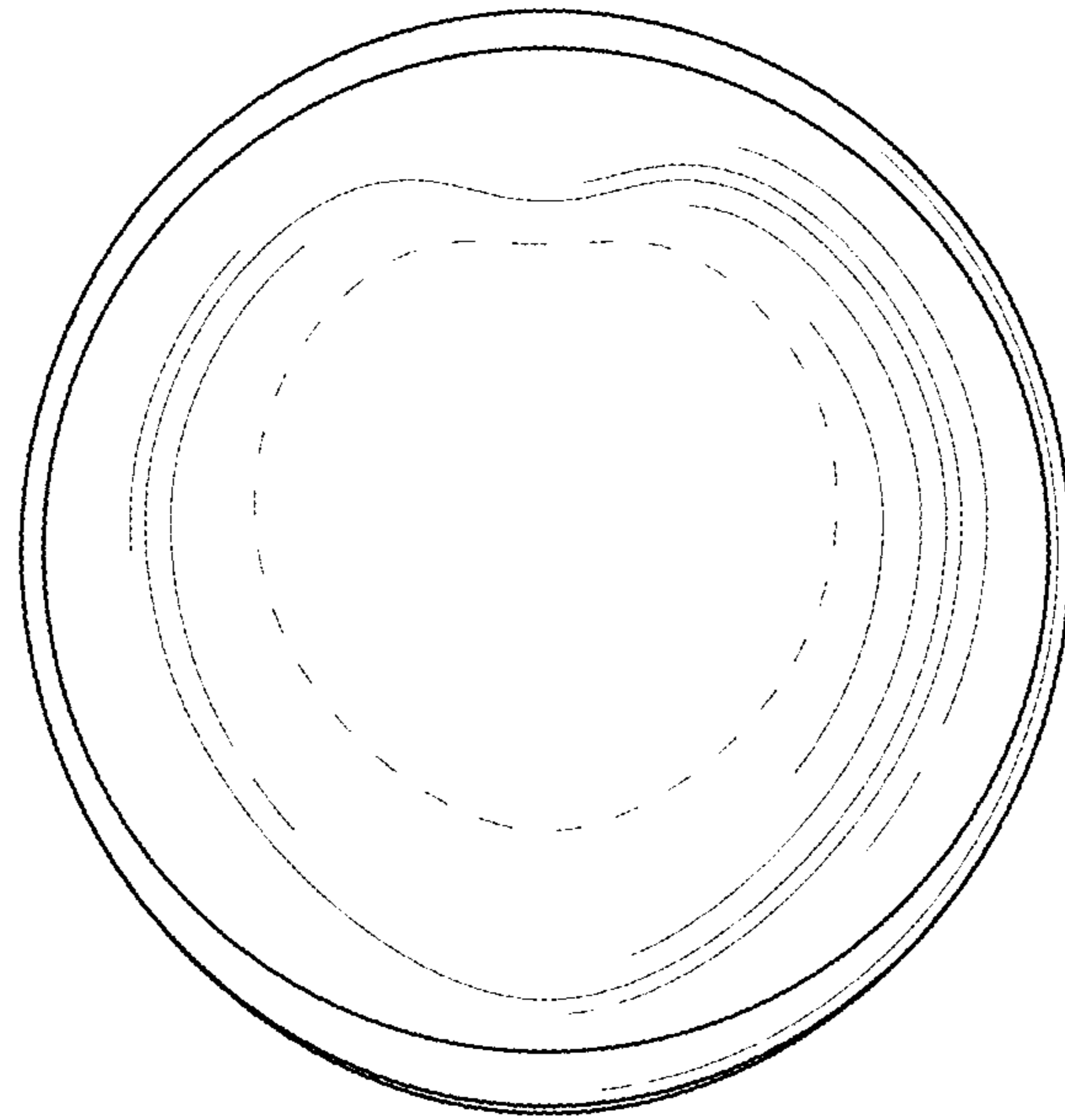
