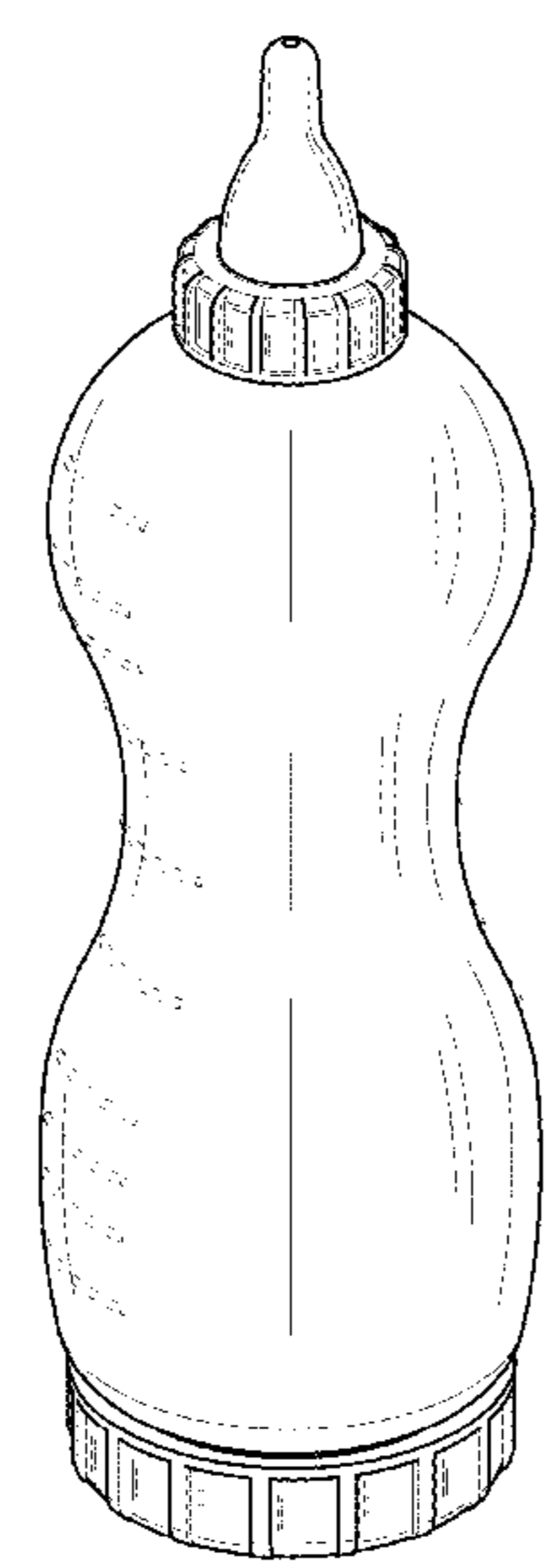

(57) **CLAIM**
The ornamental design for a feeding bottle for a mammal, as shown and described.

DESCRIPTION
FIG. 1 is a front perspective, exploded view of the first embodiment of a feeding bottle for a mammal;

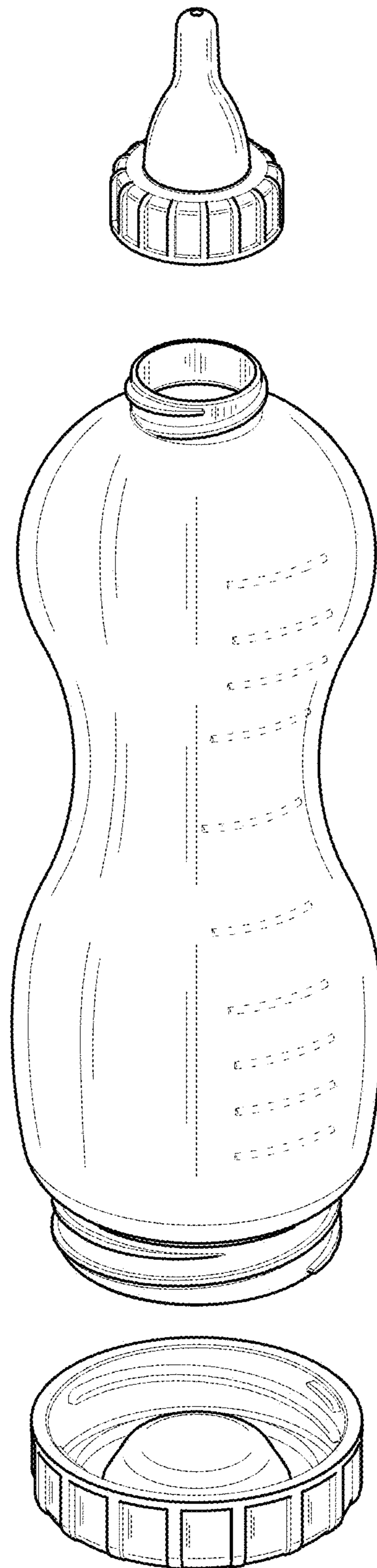

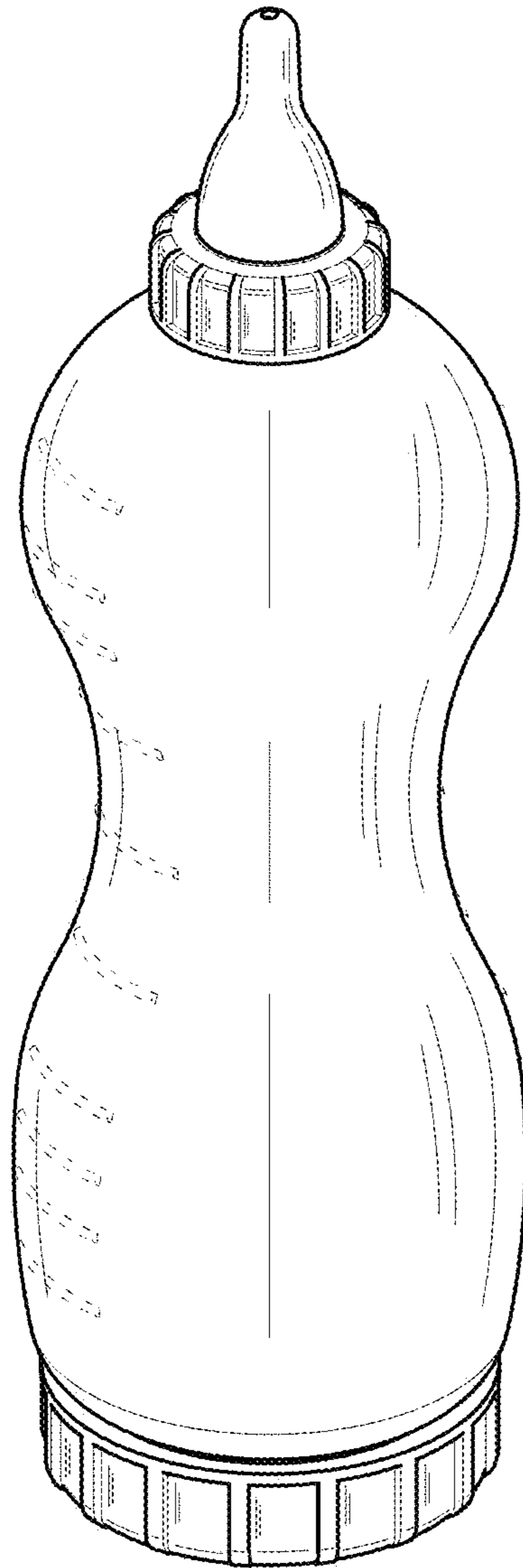

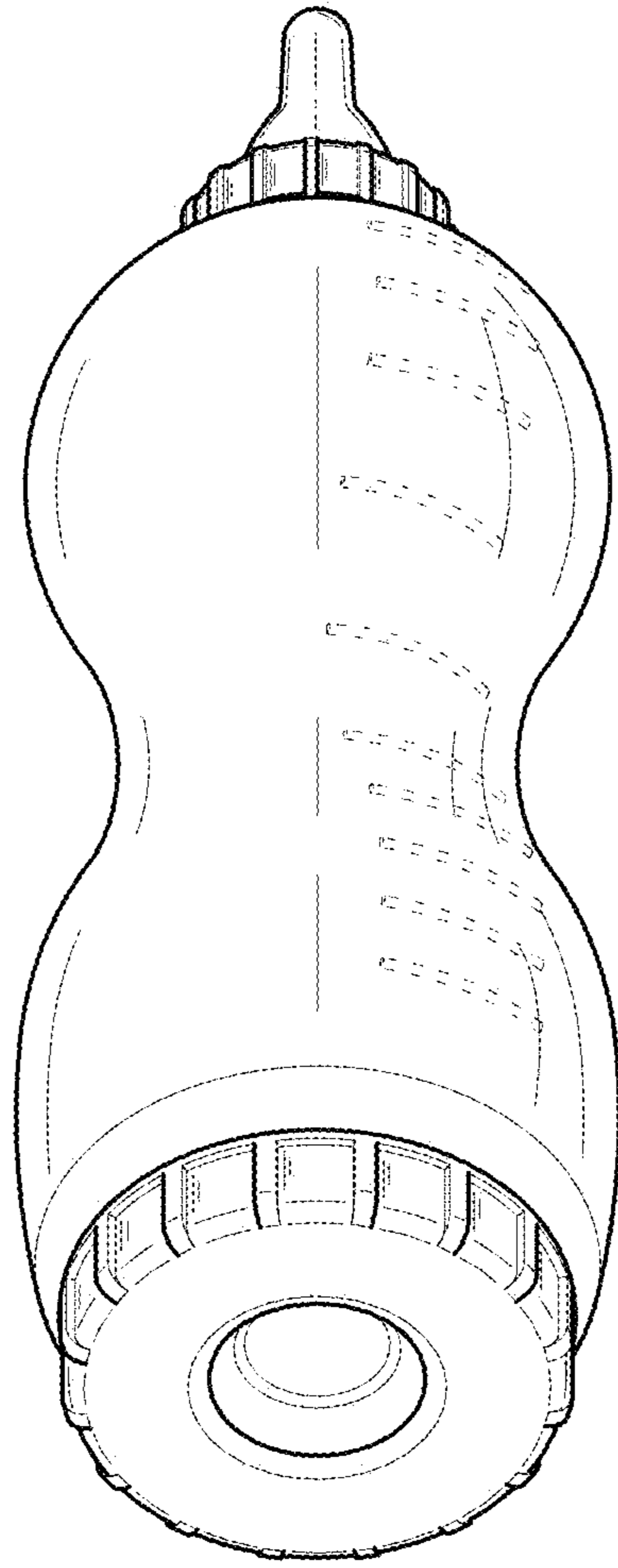

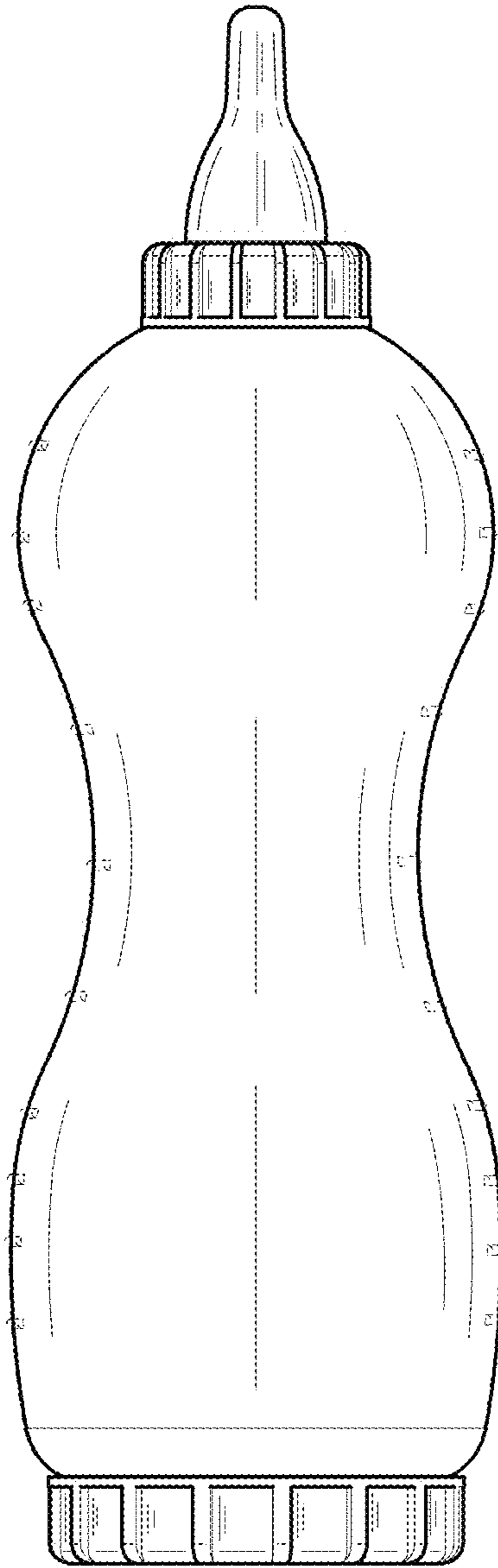

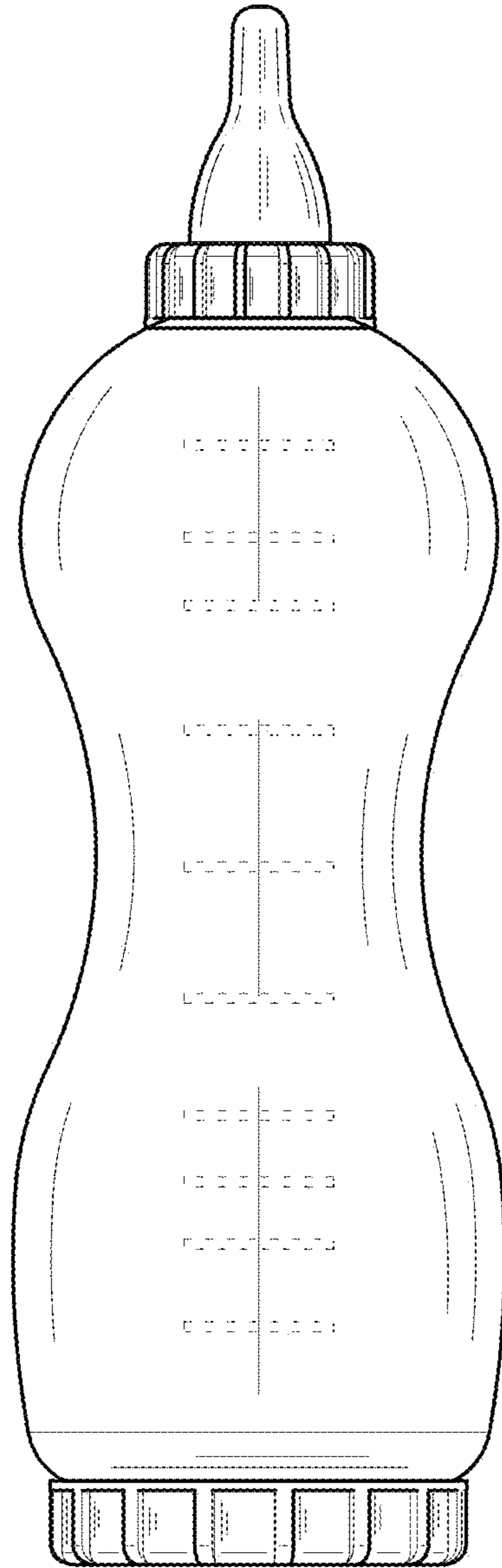

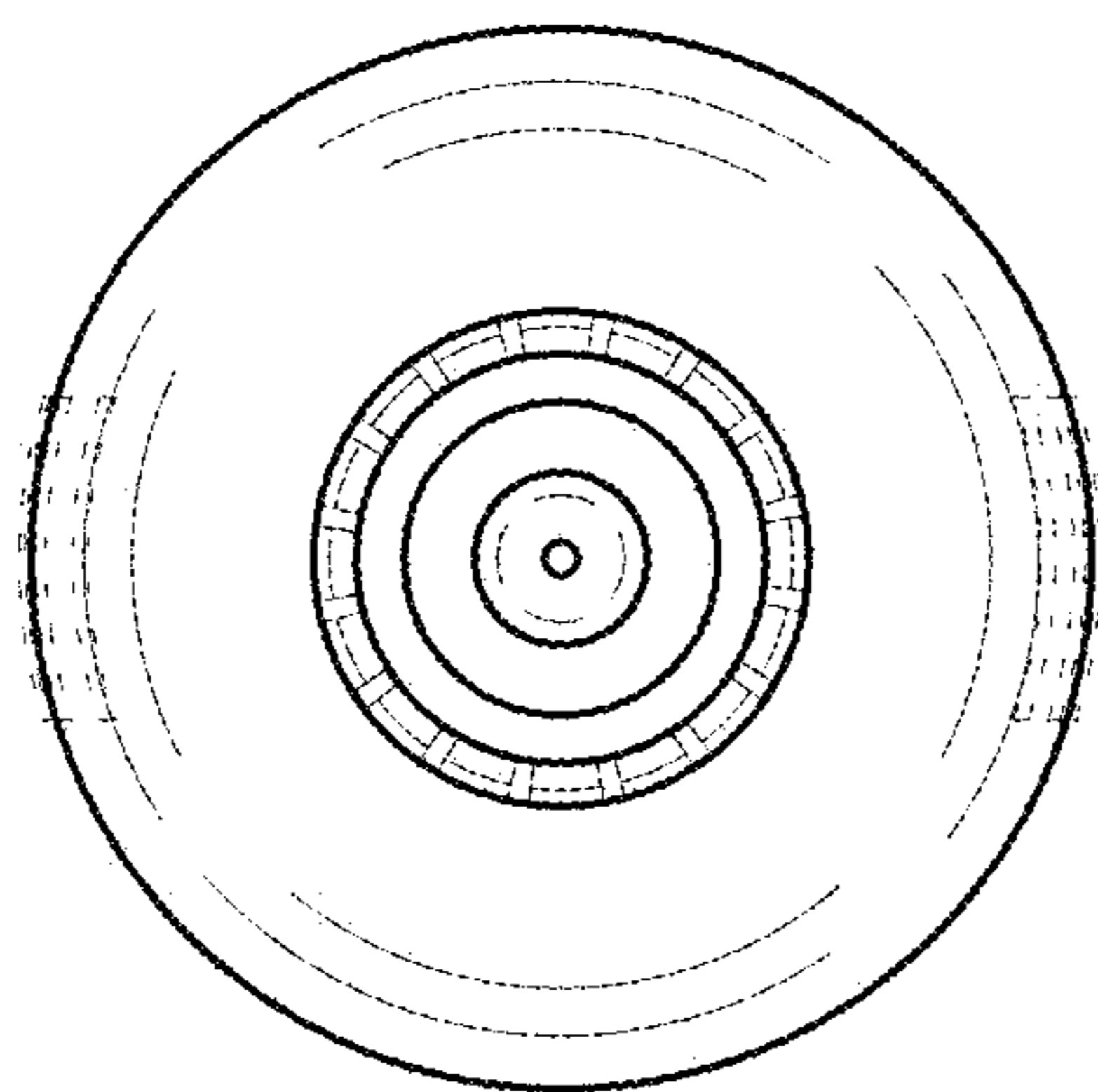

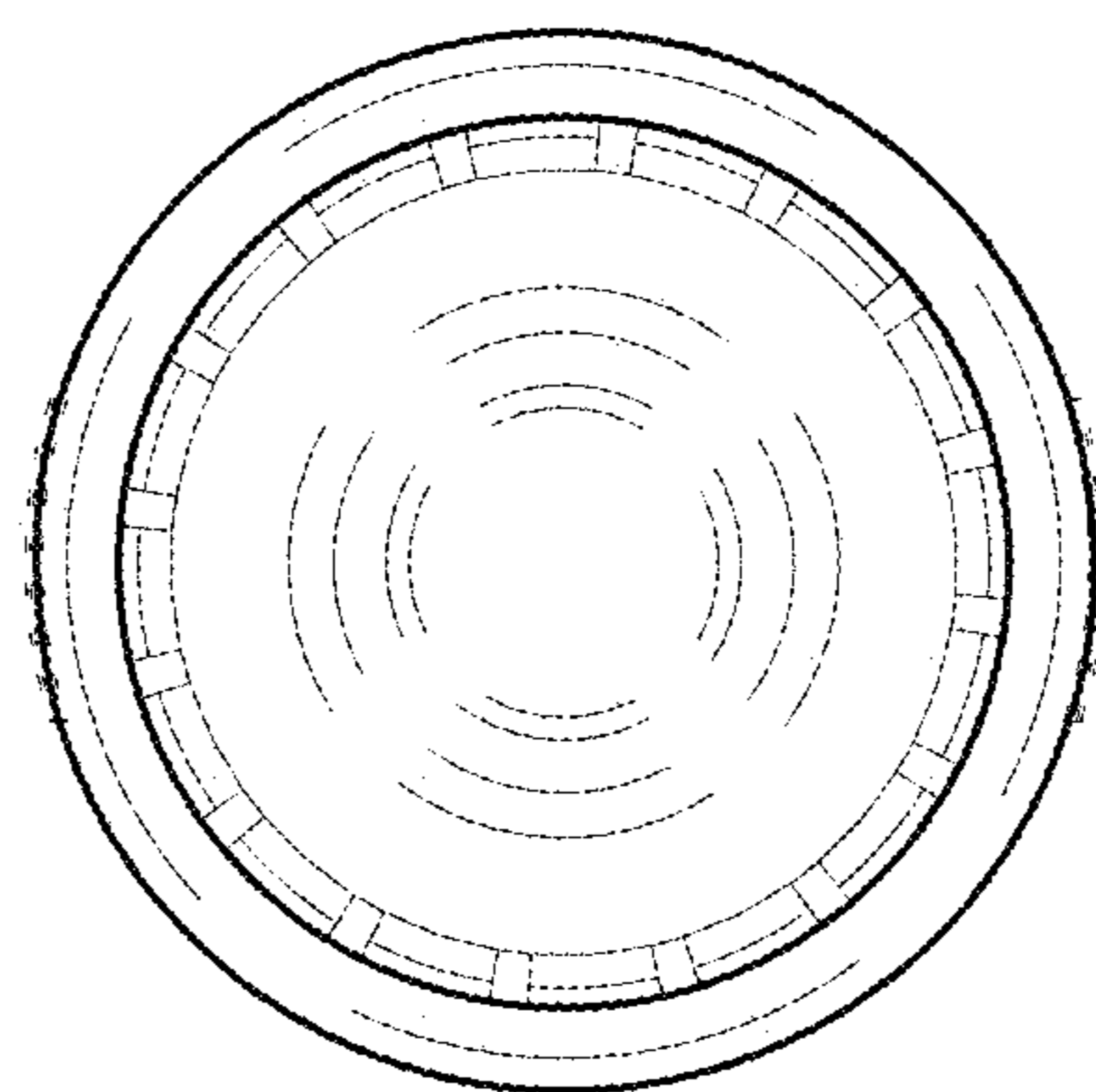

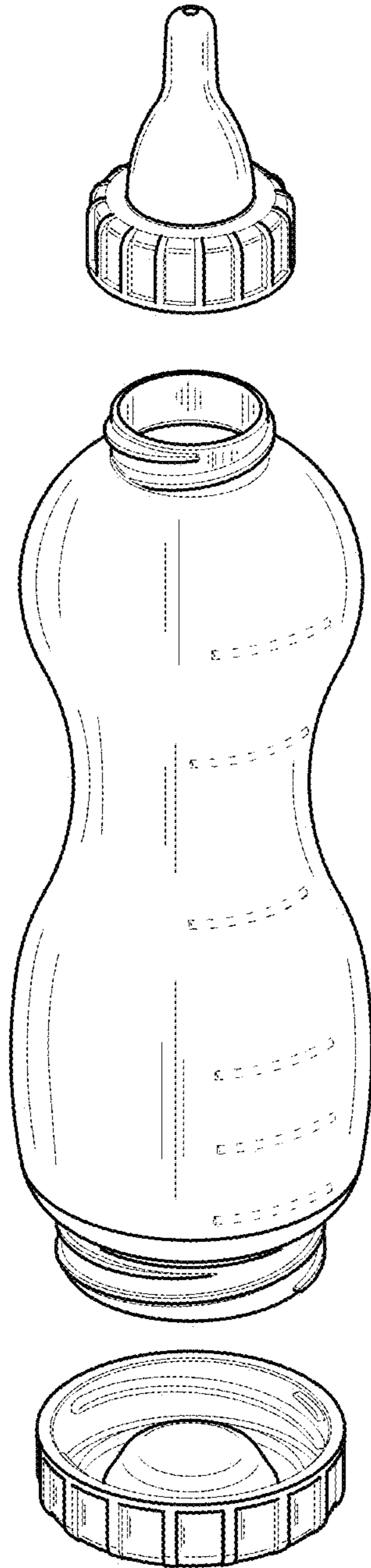

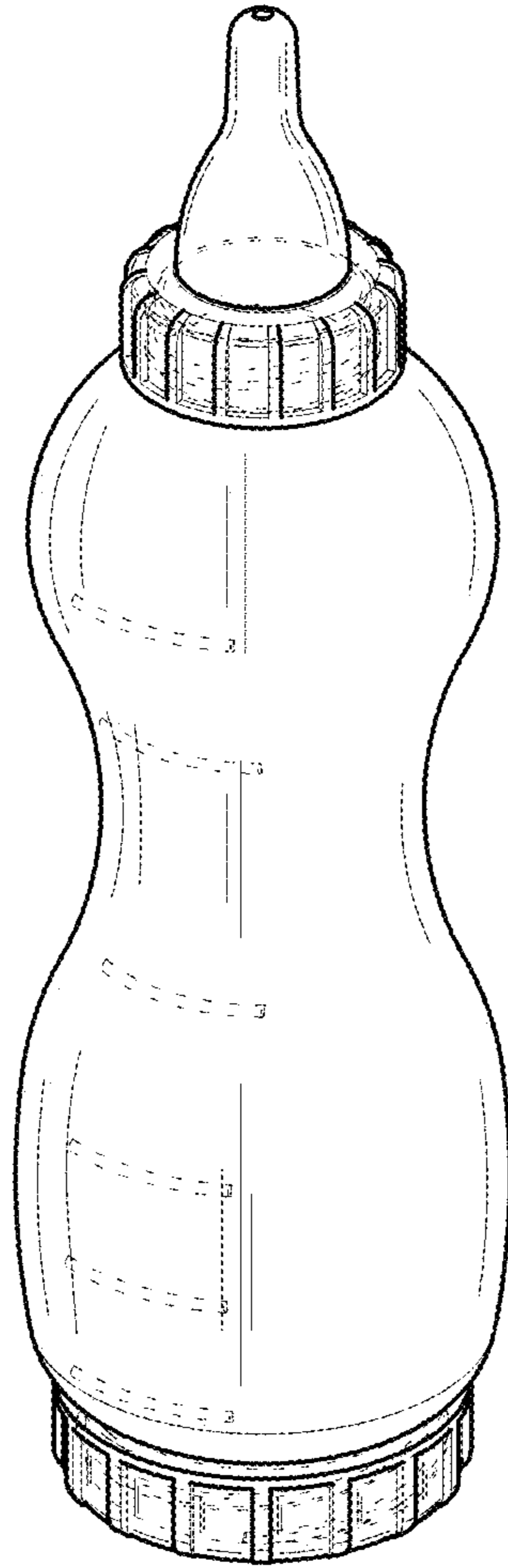

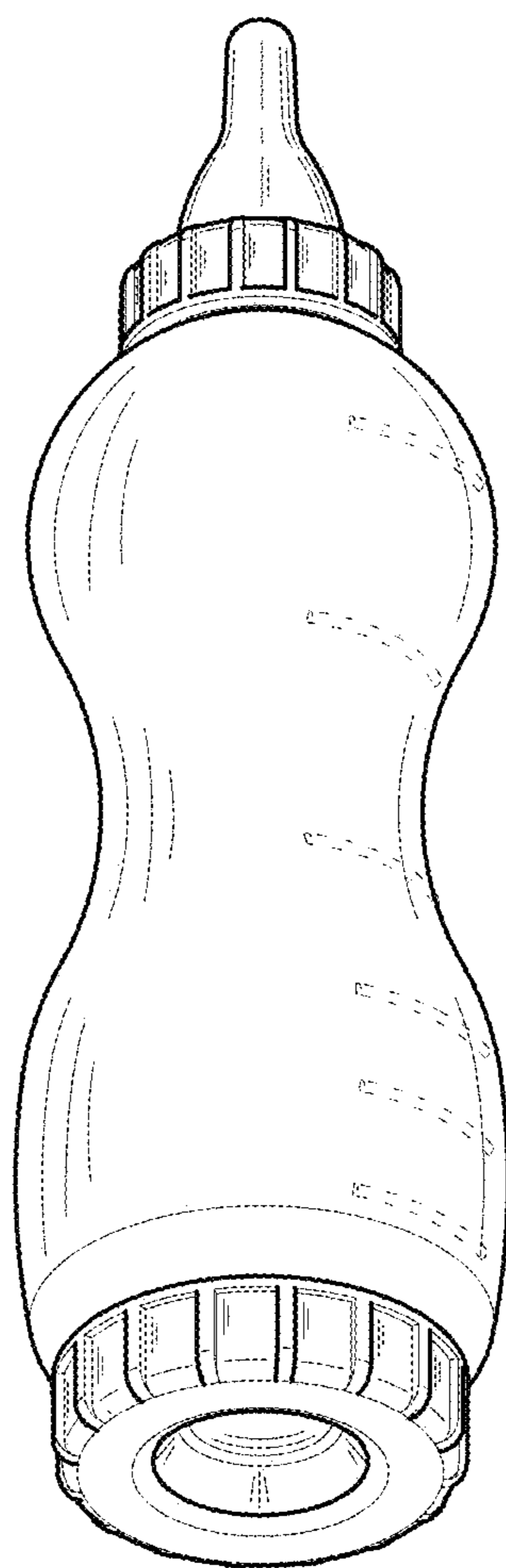

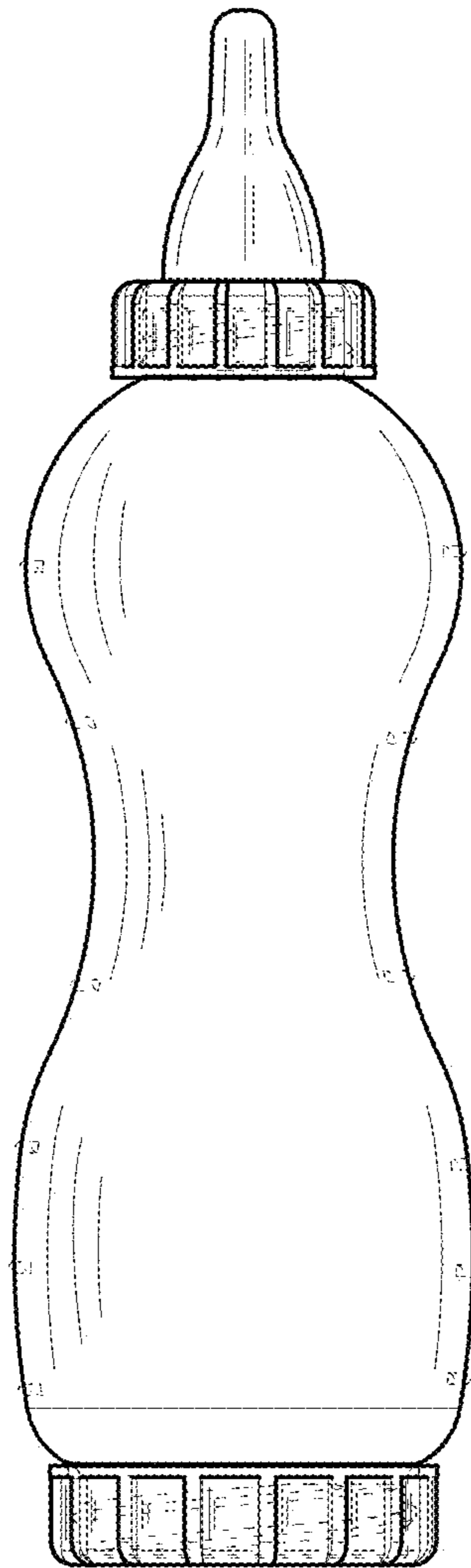

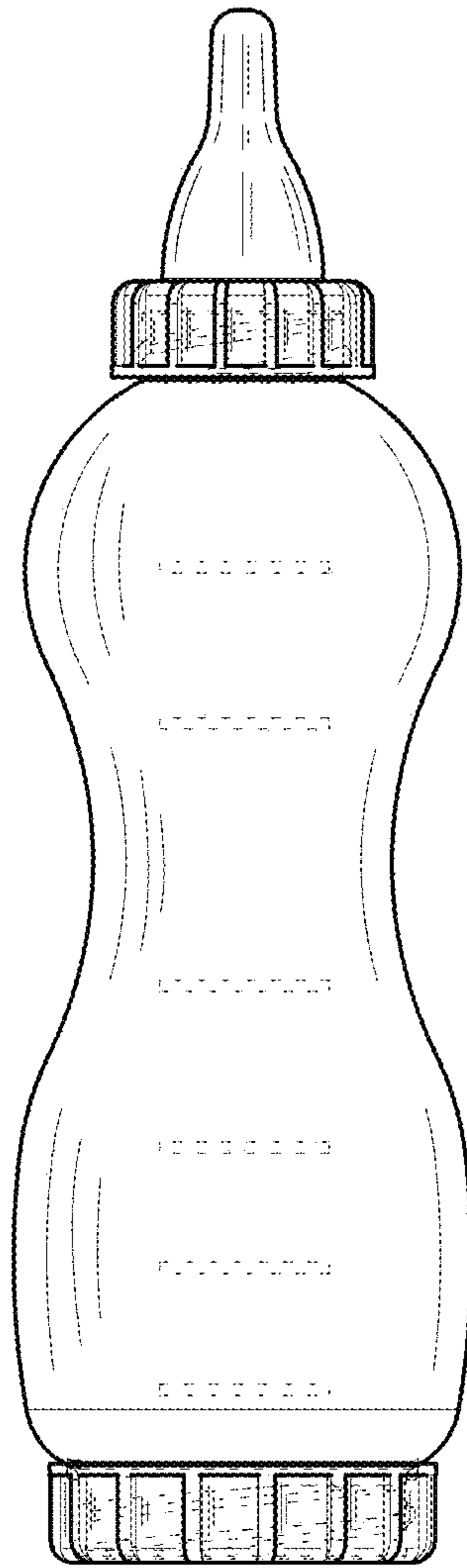

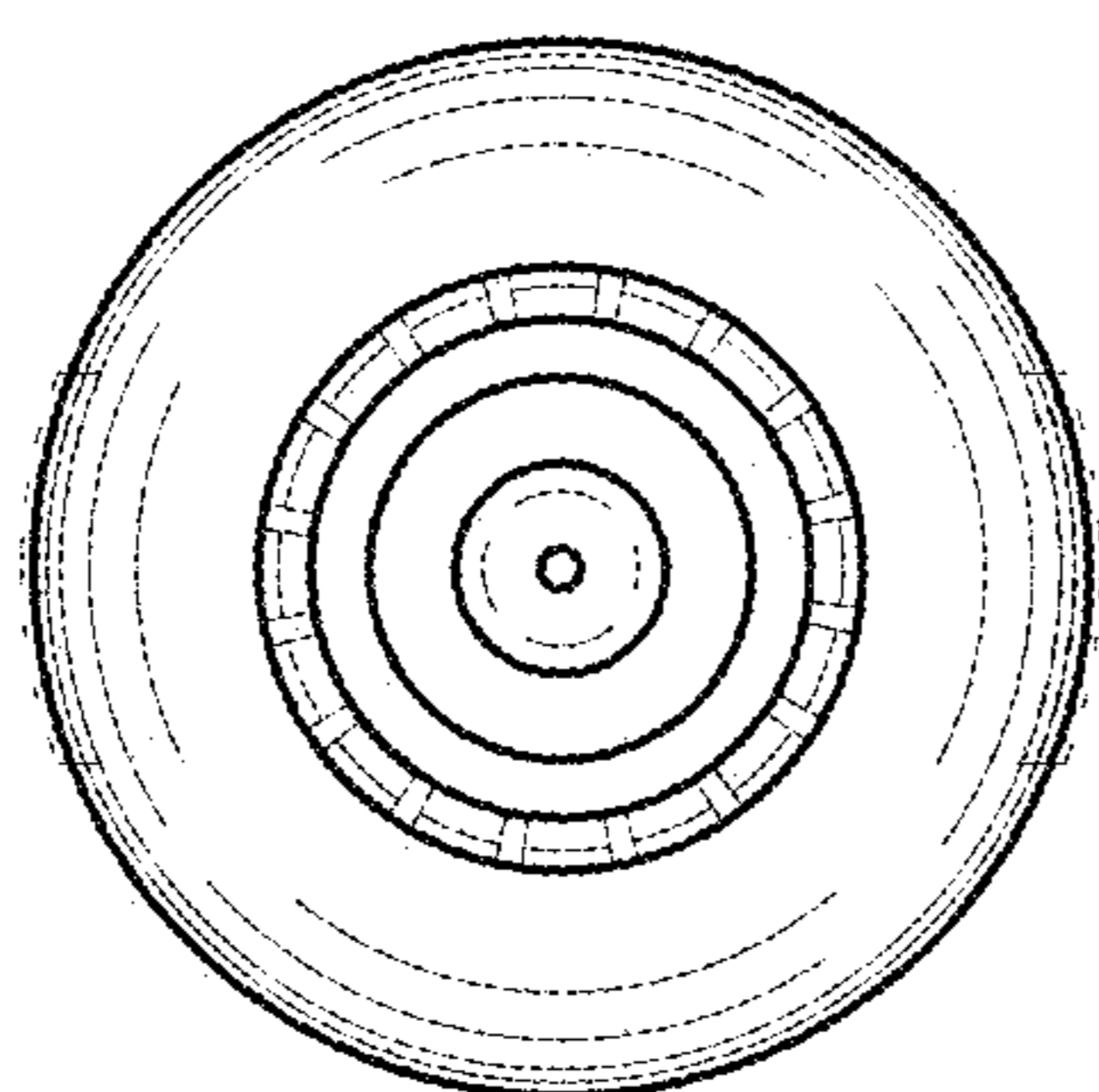

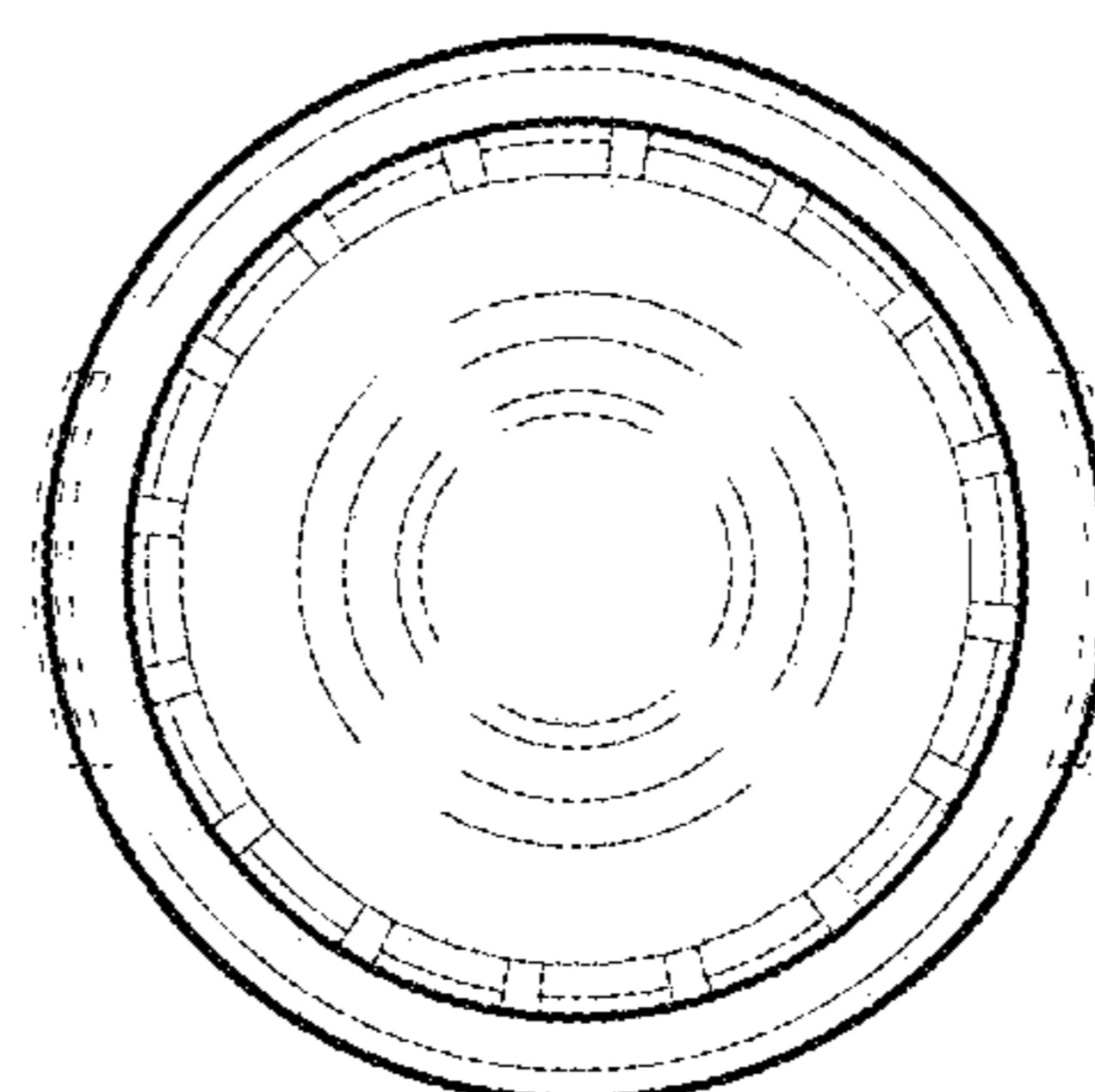

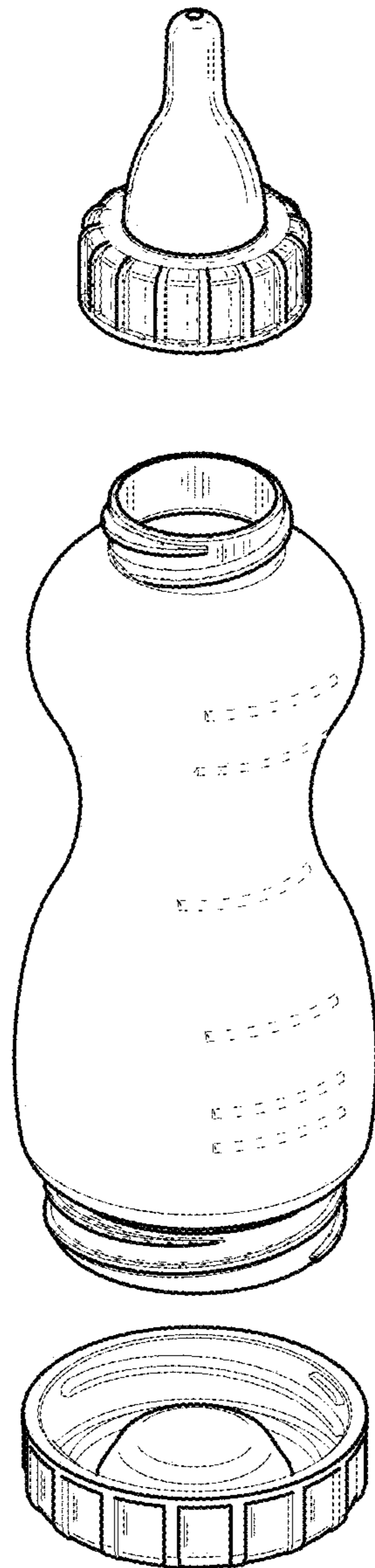

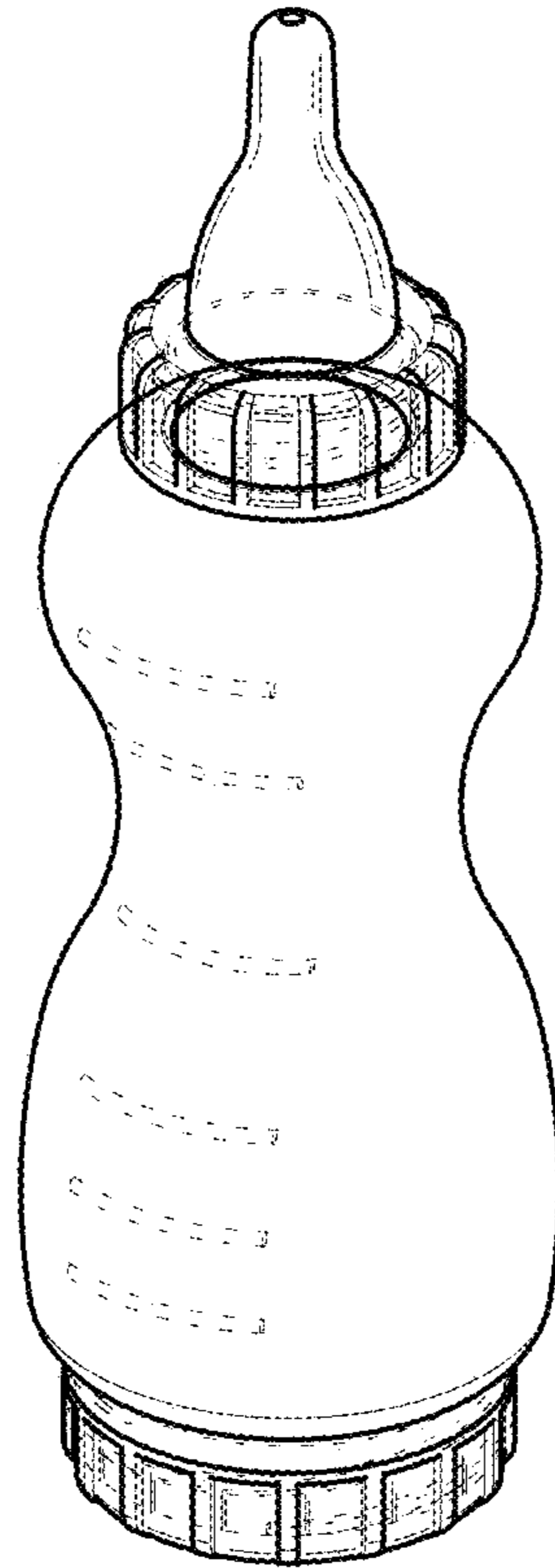

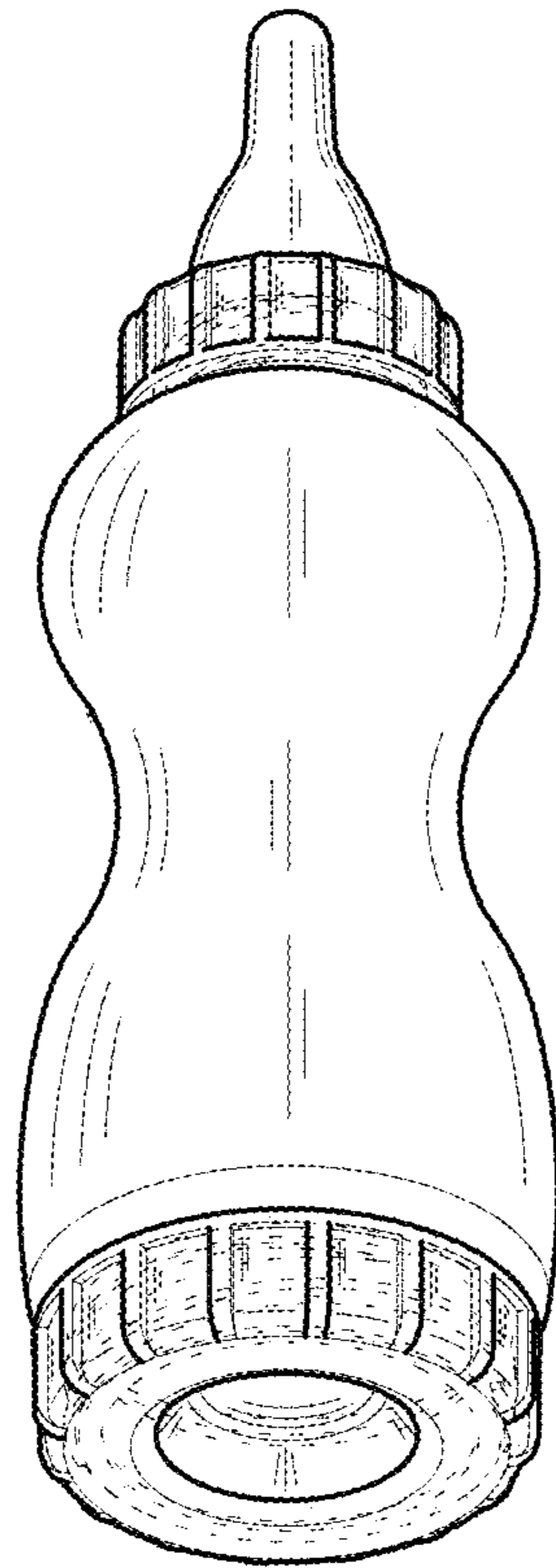

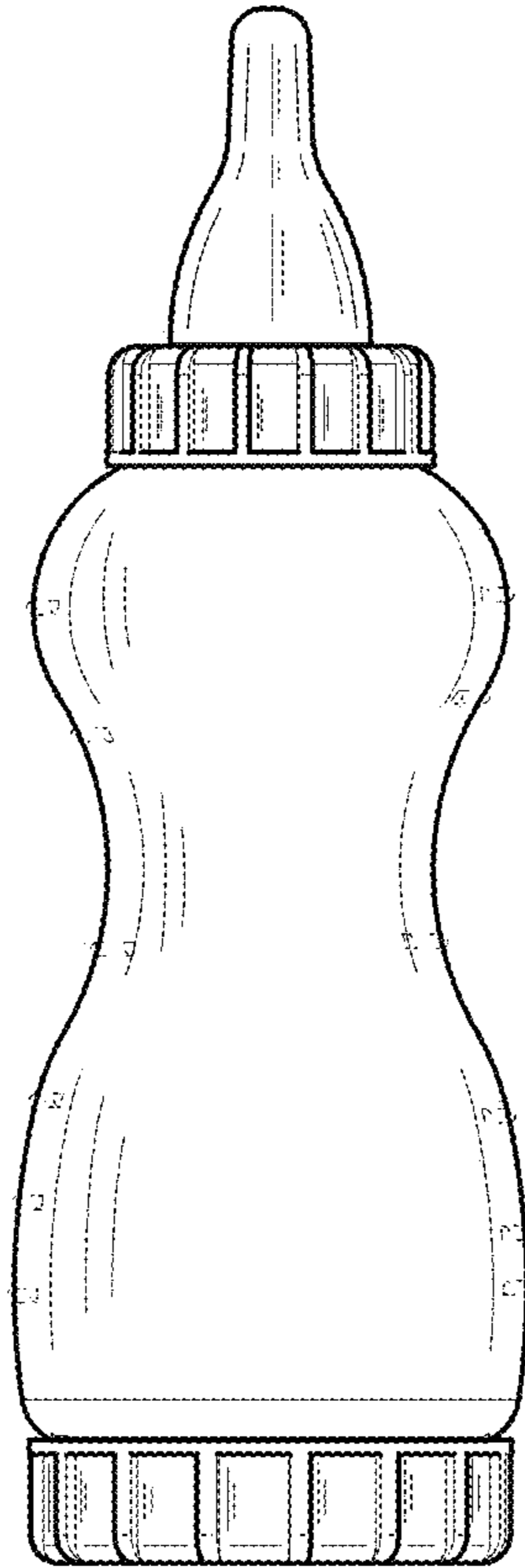

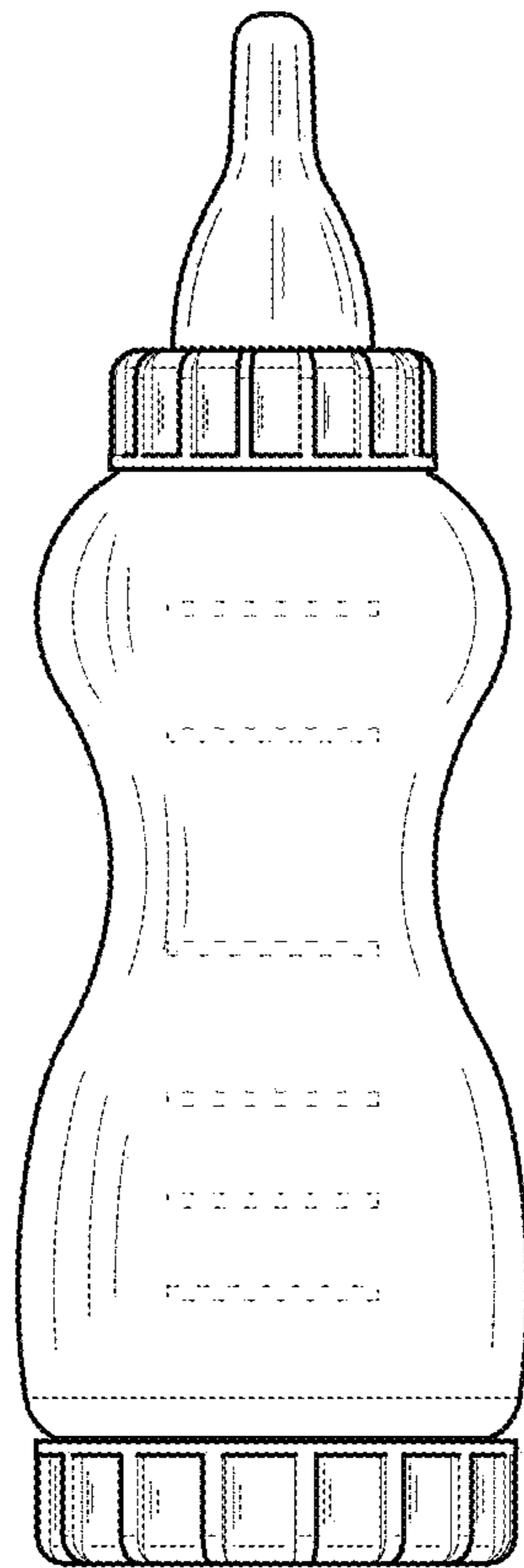

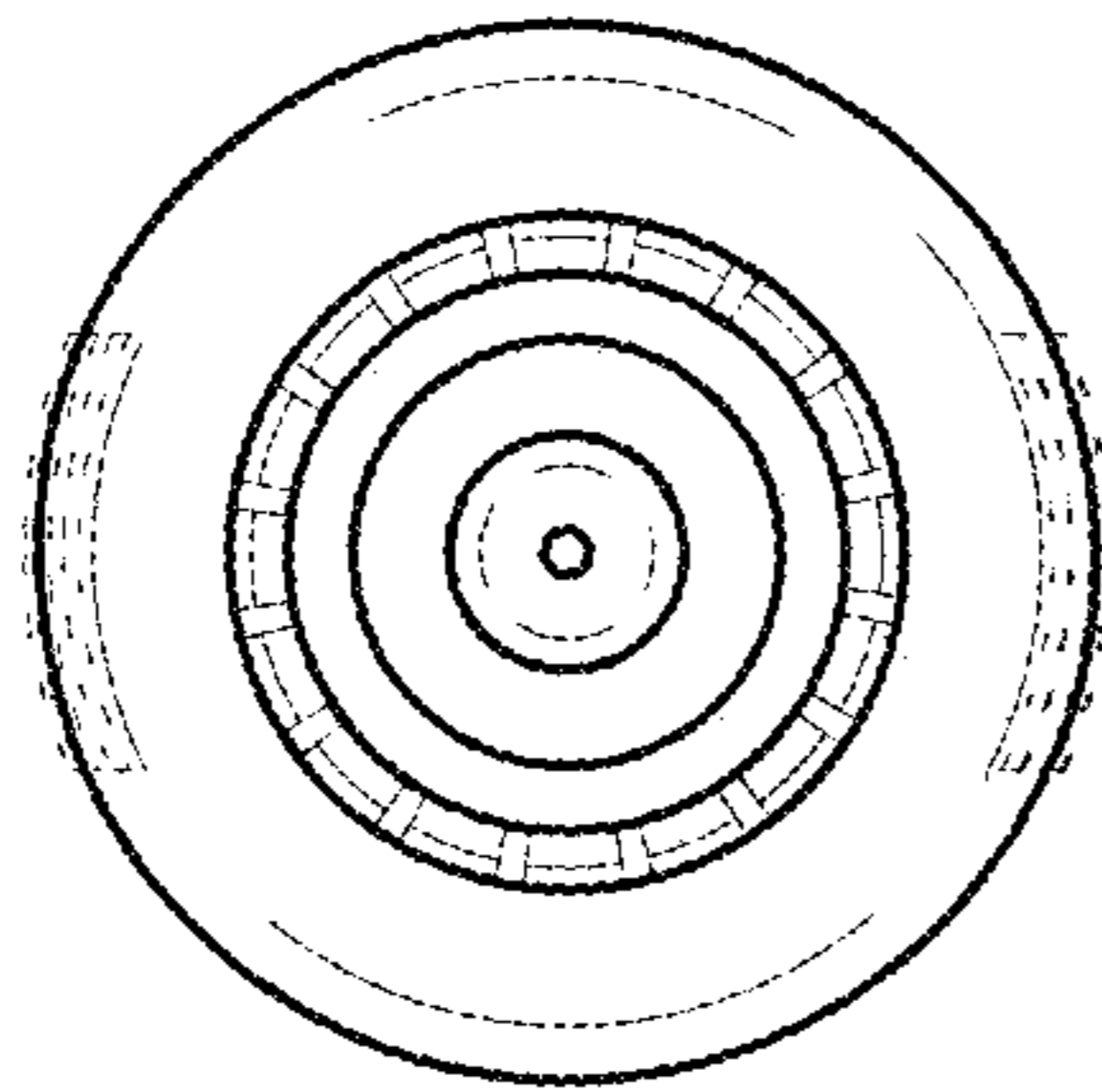

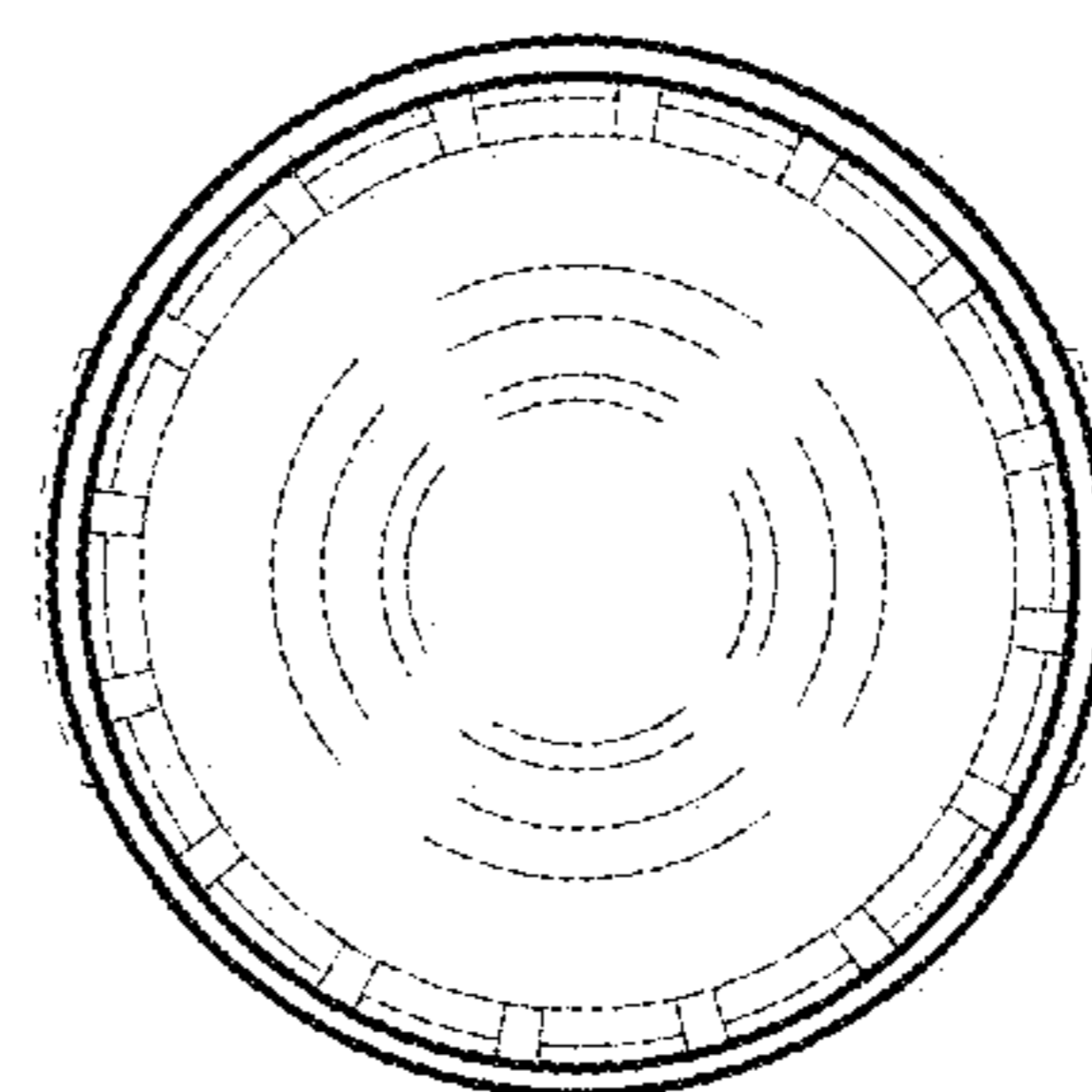
